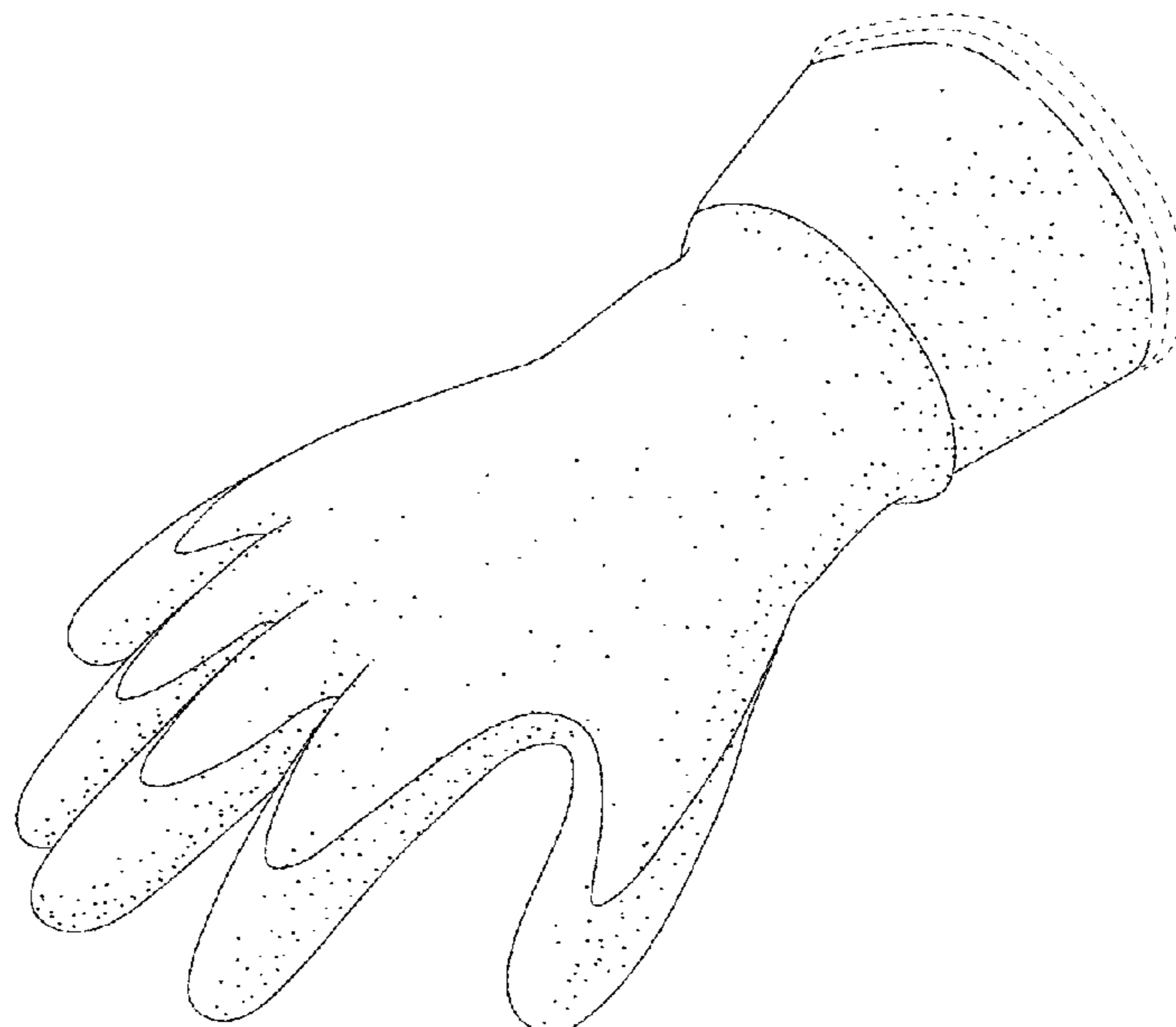
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper perspective view of a glove, showing our new design;
FIG. 2 is a front elevation view thereof;

FIG. 5 is a bottom view thereof;
FIG. 6 is a right side elevation view thereof; and,

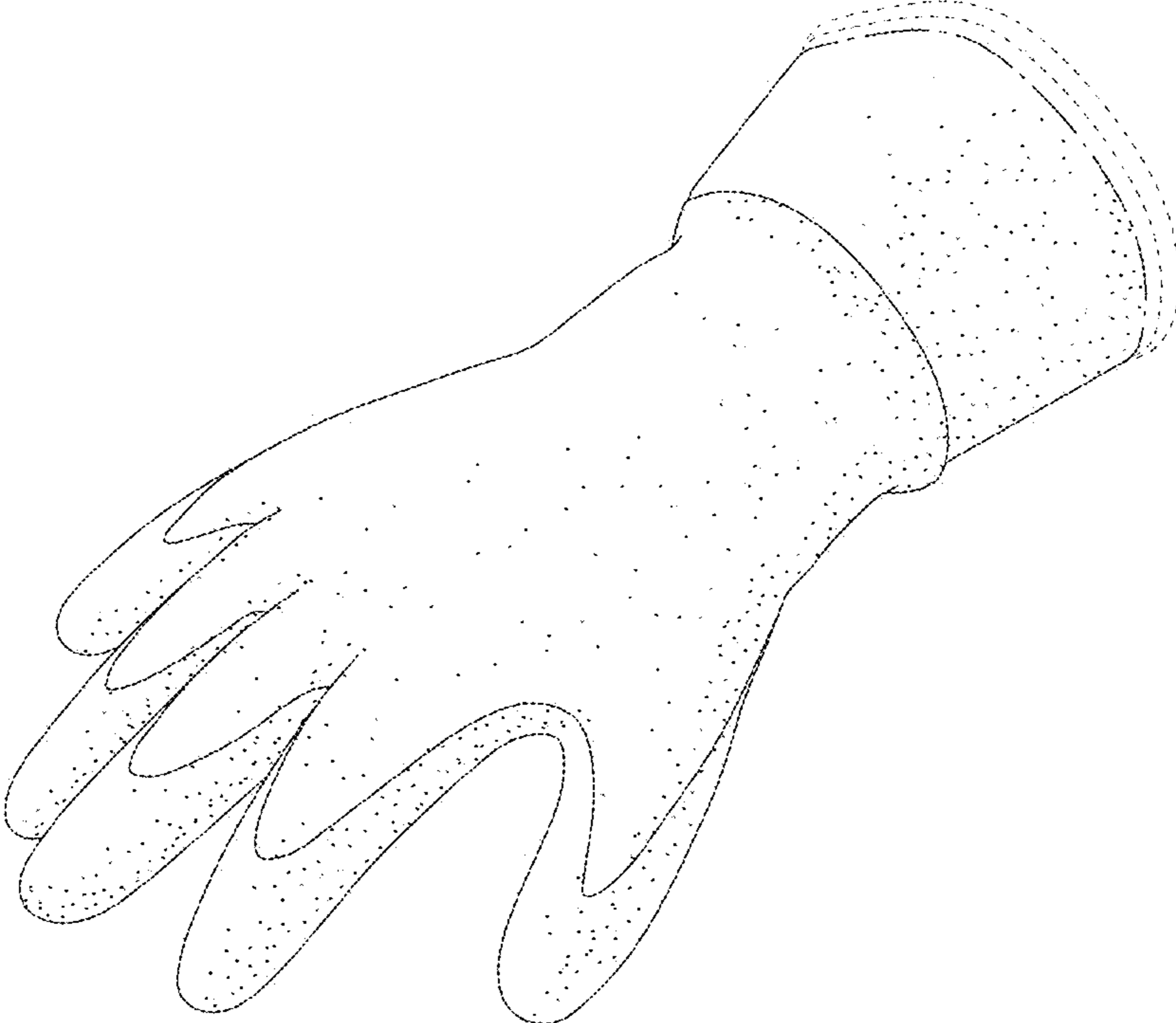

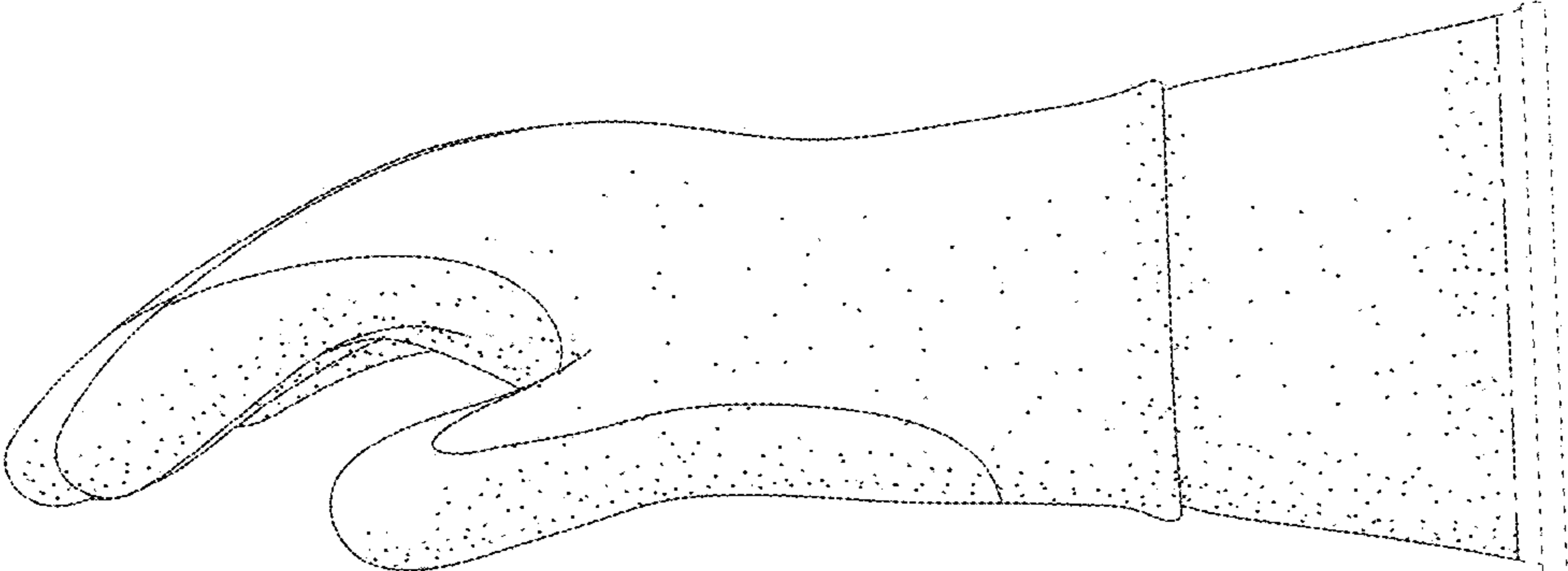

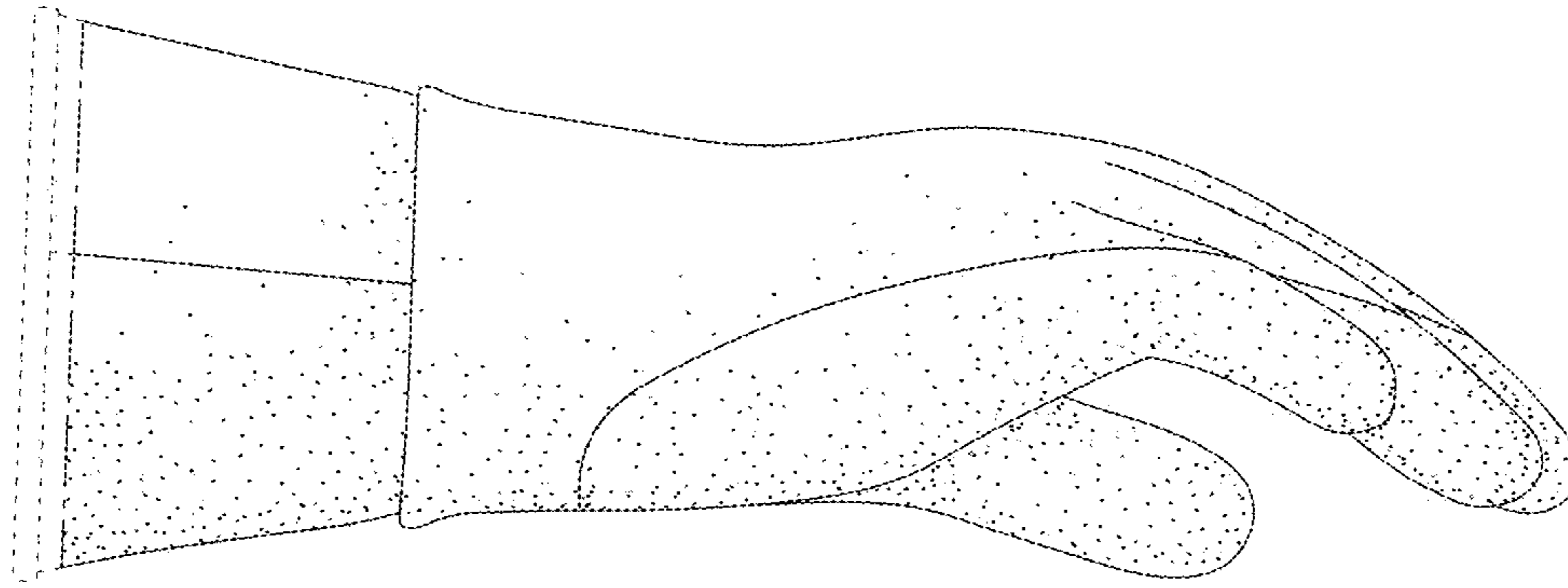

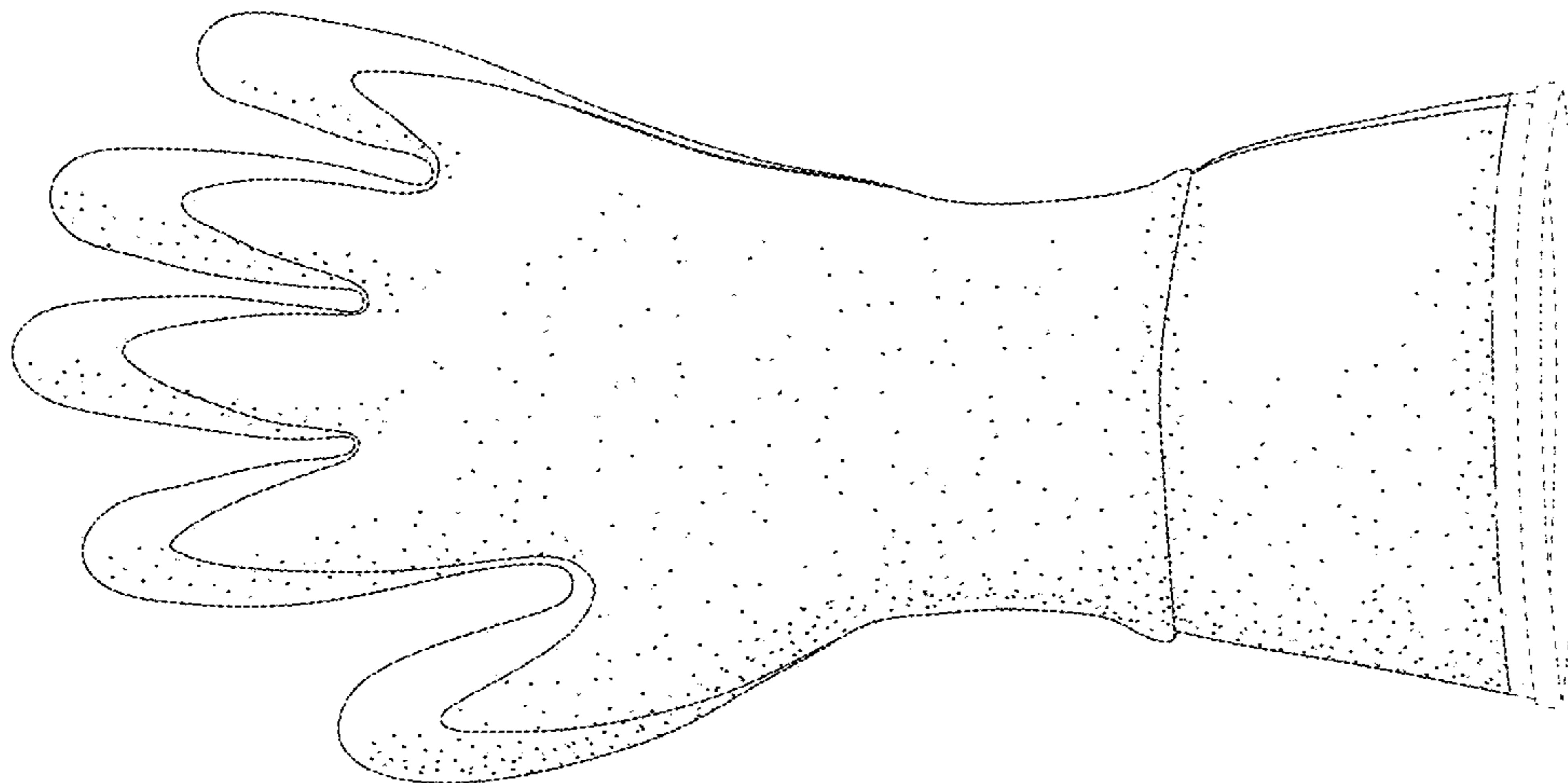

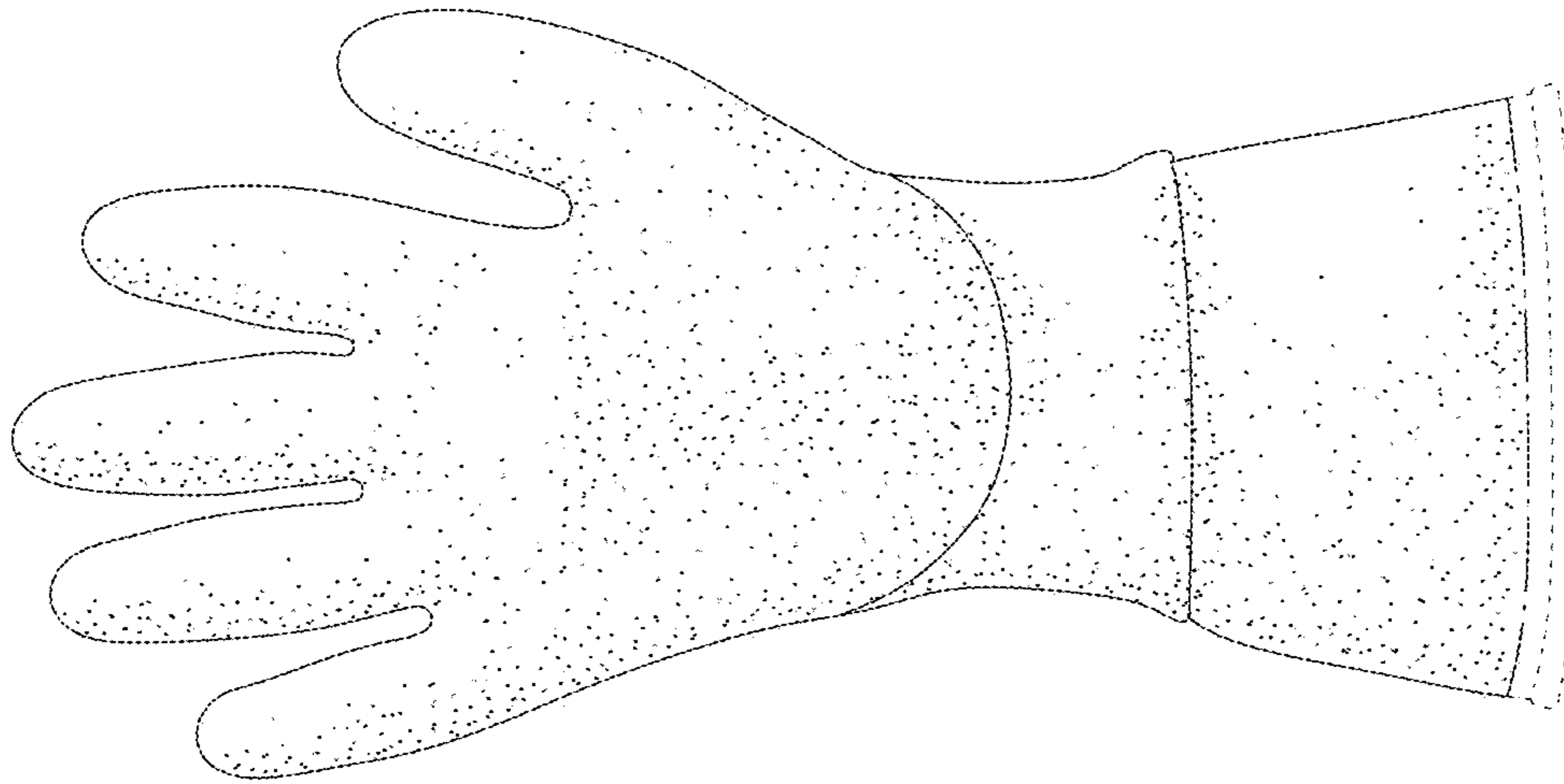

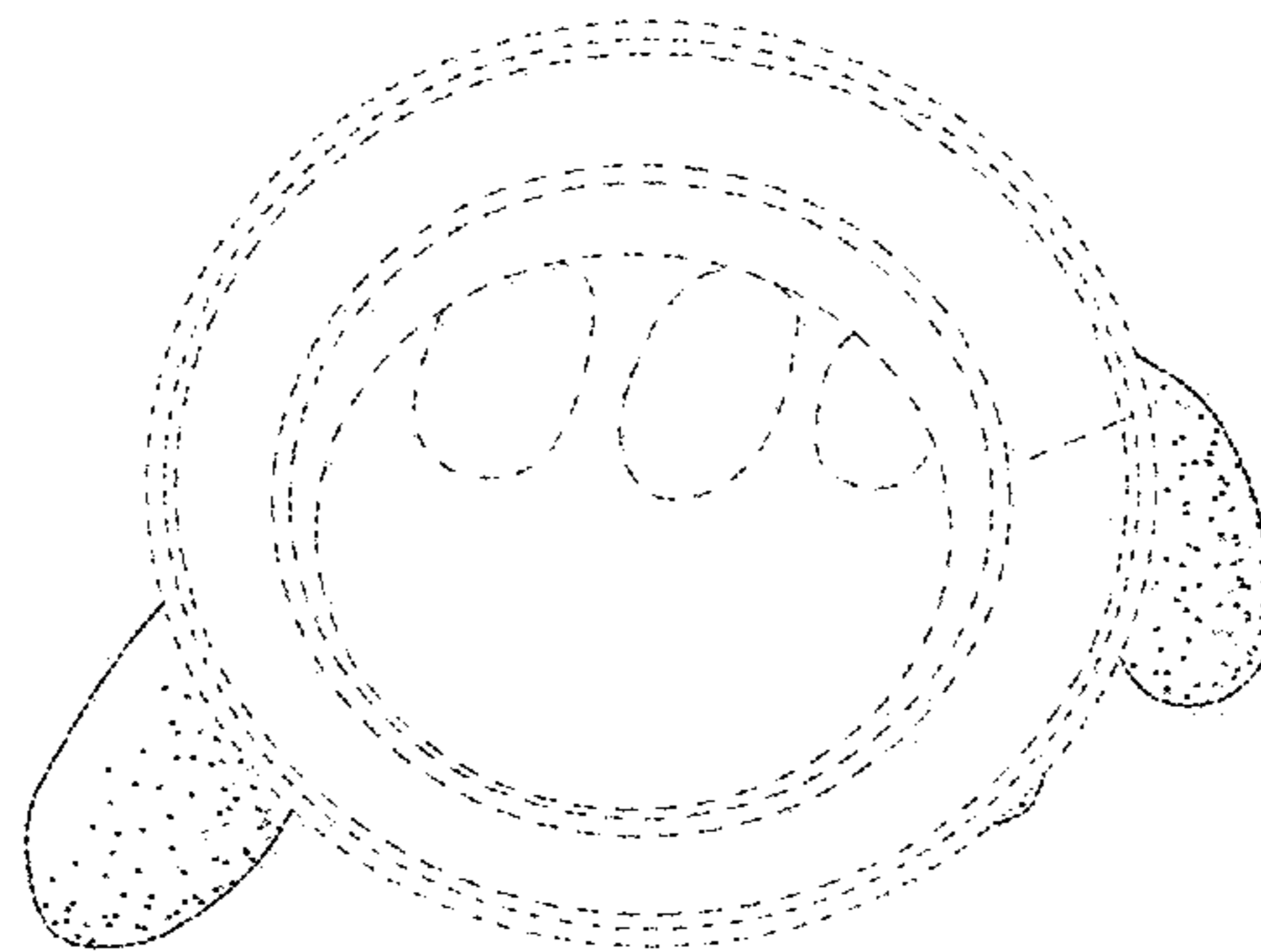

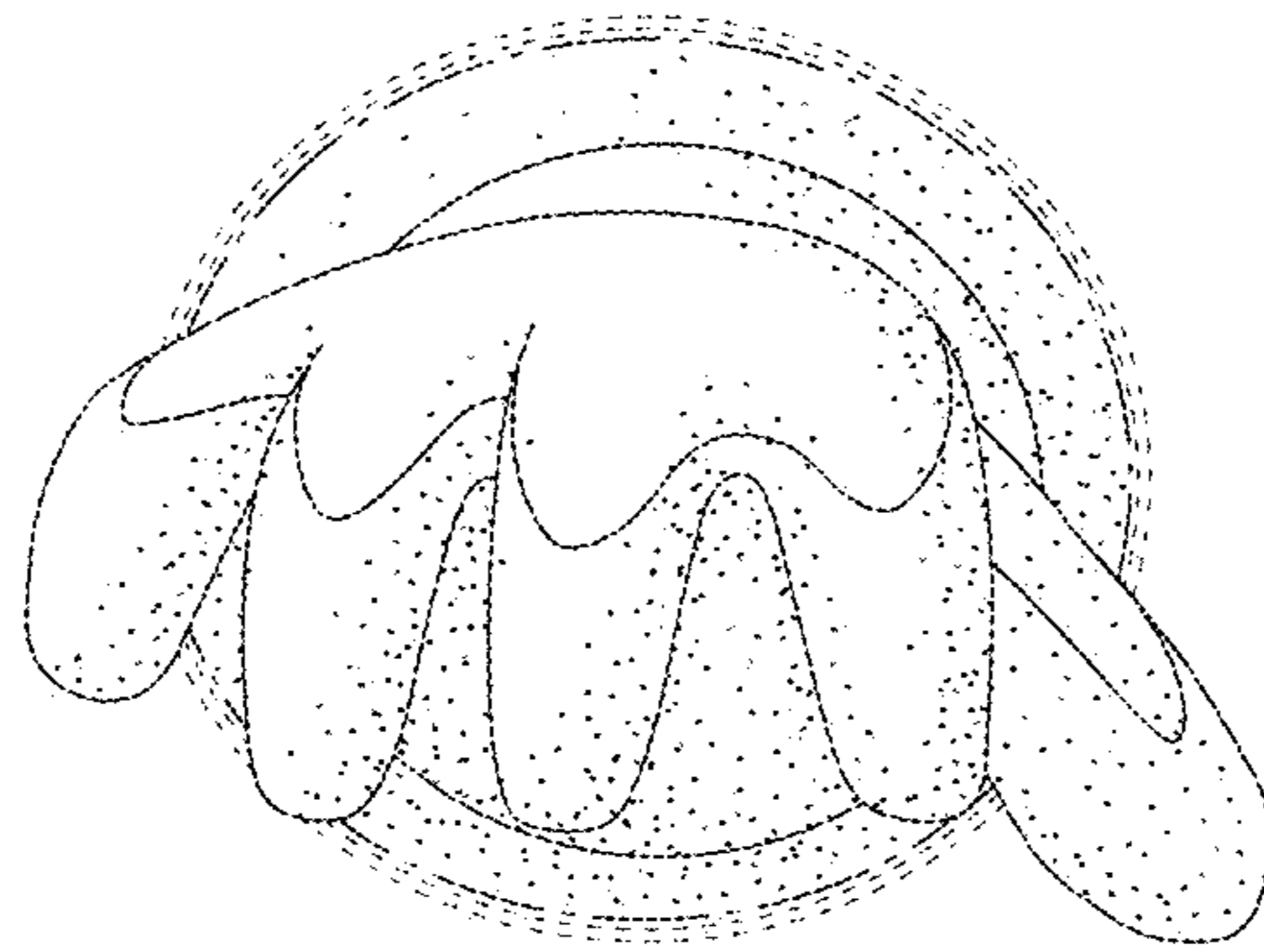
