DESCRIPTION

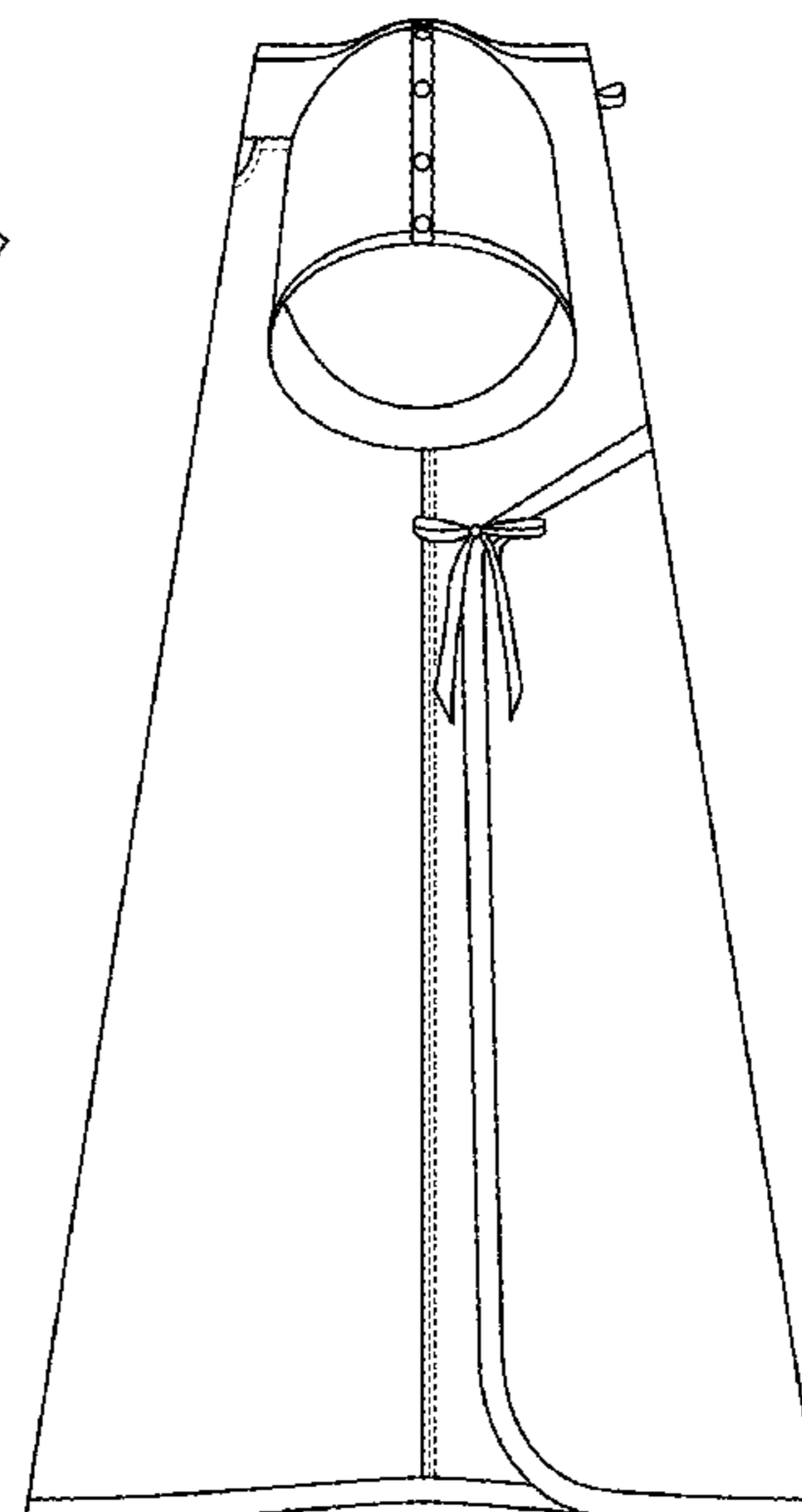
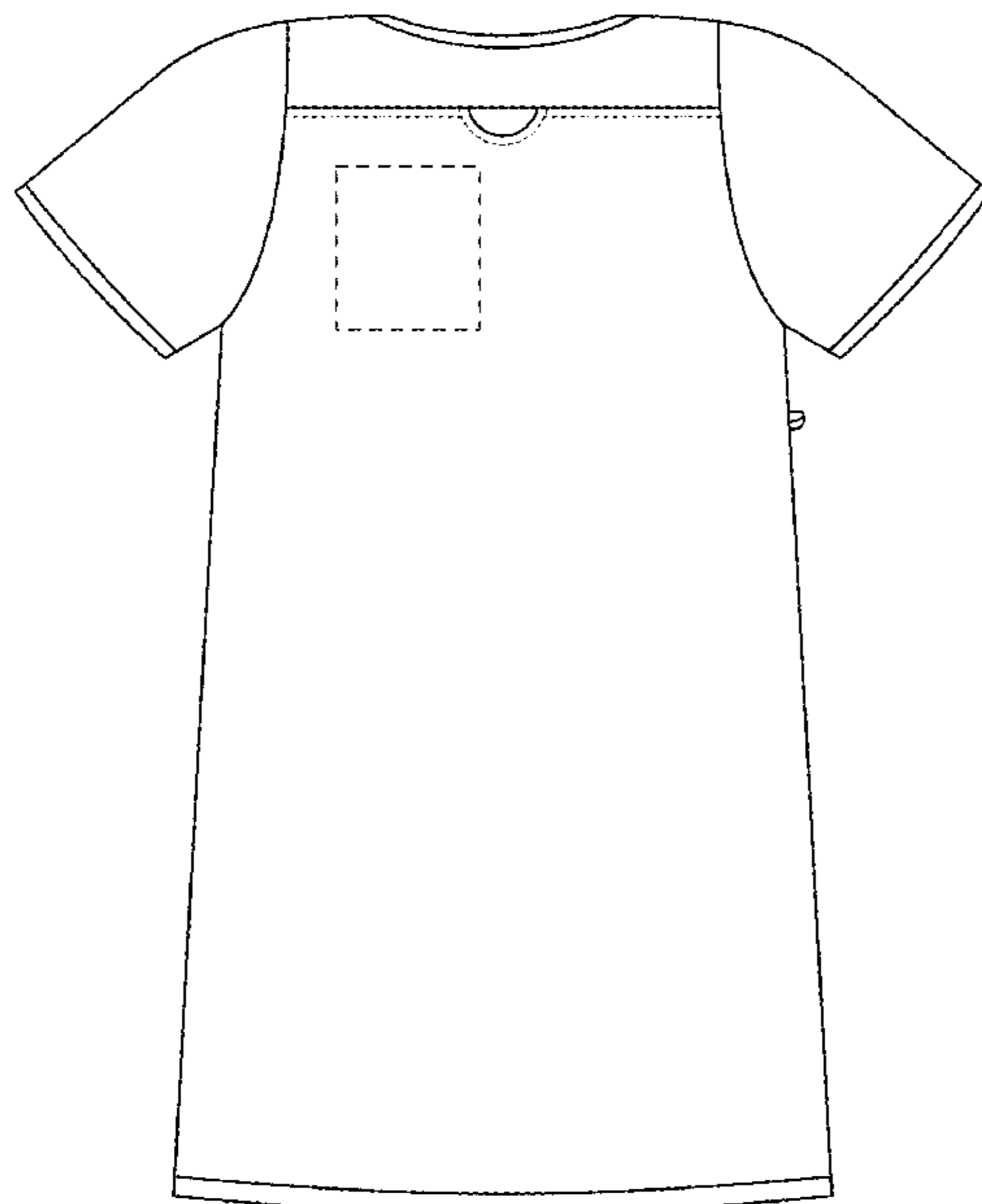
FIG. 1 is a front view of a hospital gown showing our new design;

FIG. 2 is a back view of the hospital gown shown in FIG. 1; FIG. 3 is a right side view of the hospital gown shown in FIG. 1; and,

The short evenly spaced broken lines depict stitching, and form part of the claimed design. The long evenly spaced broken lines depict the bounds of the claimed design.

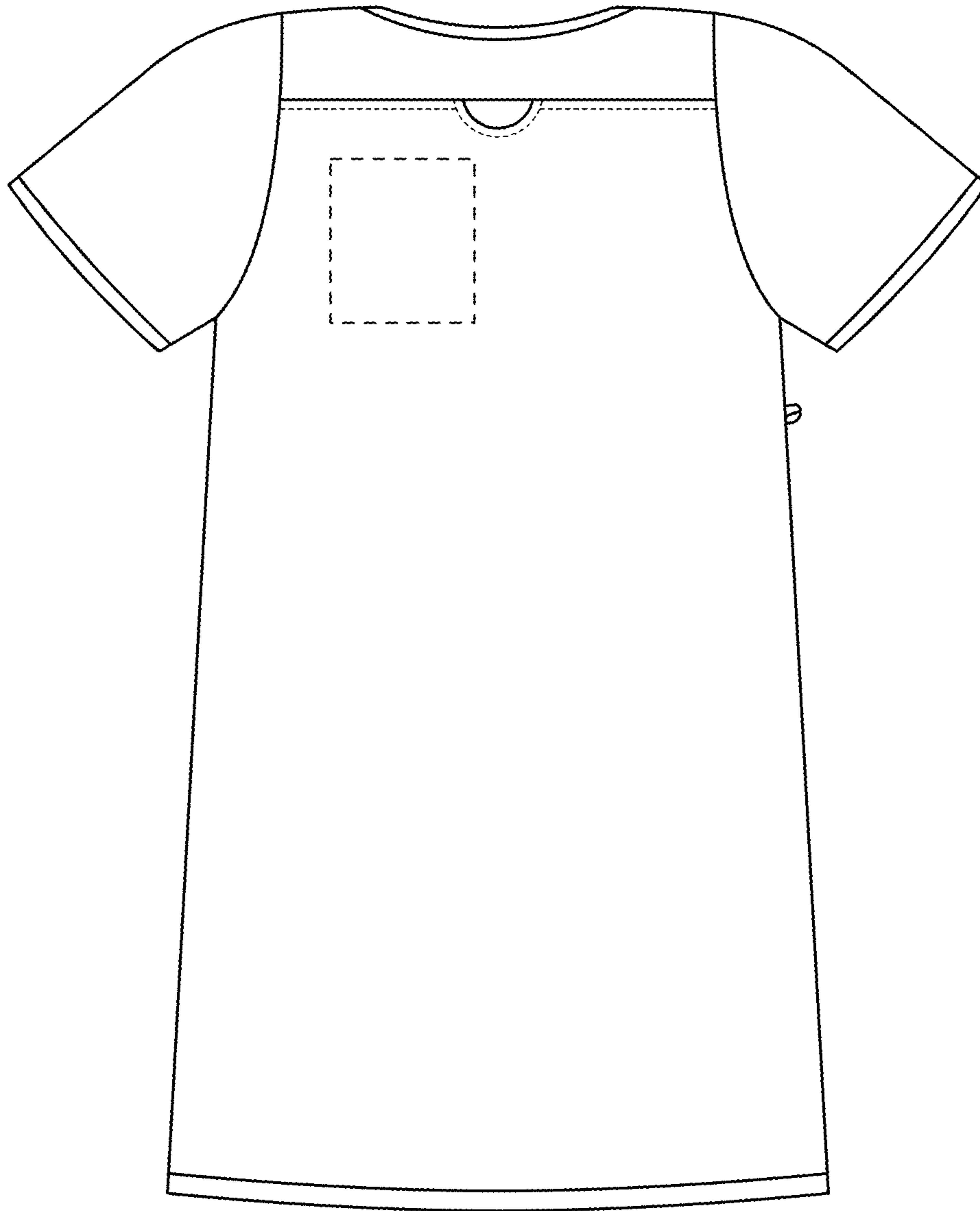

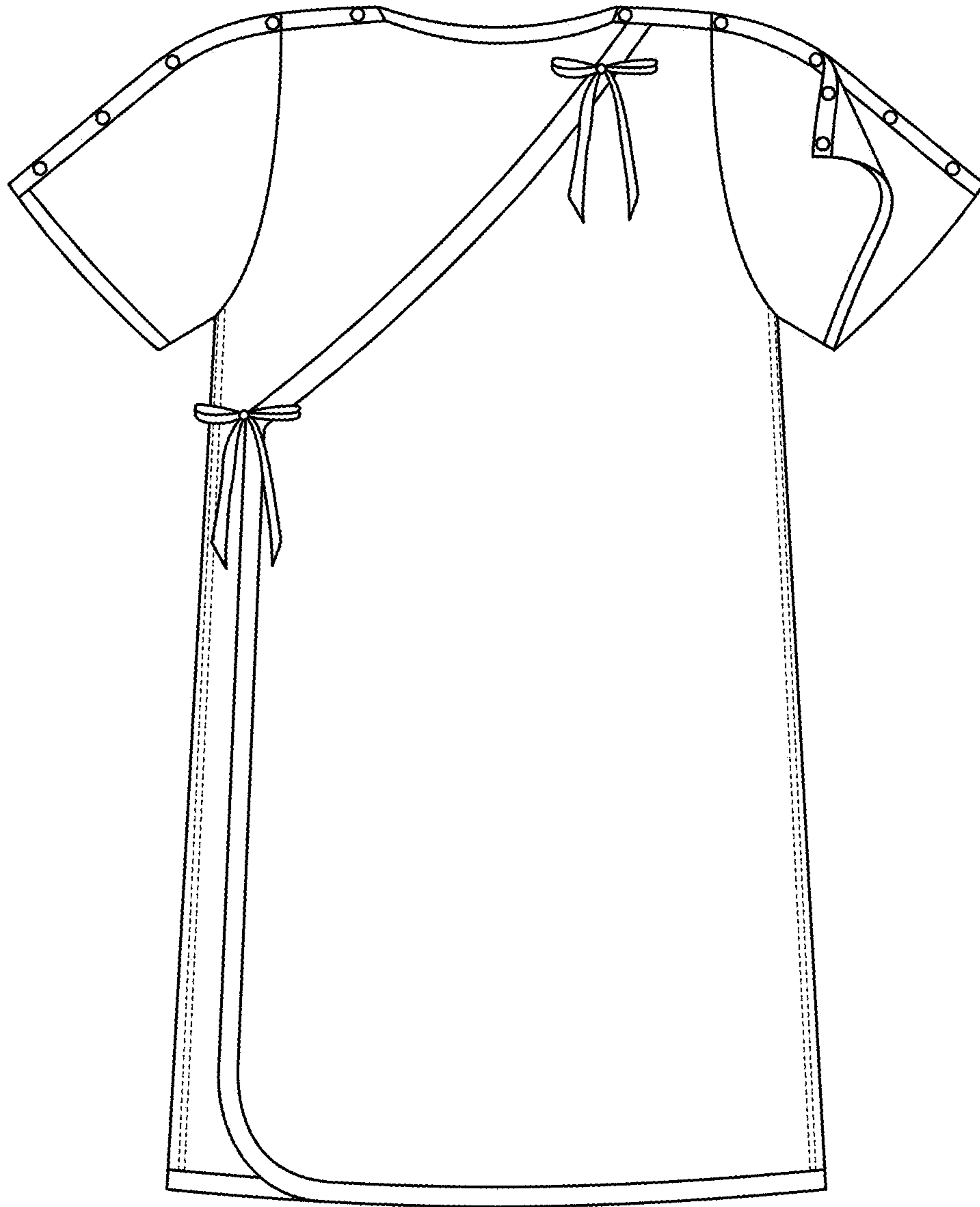

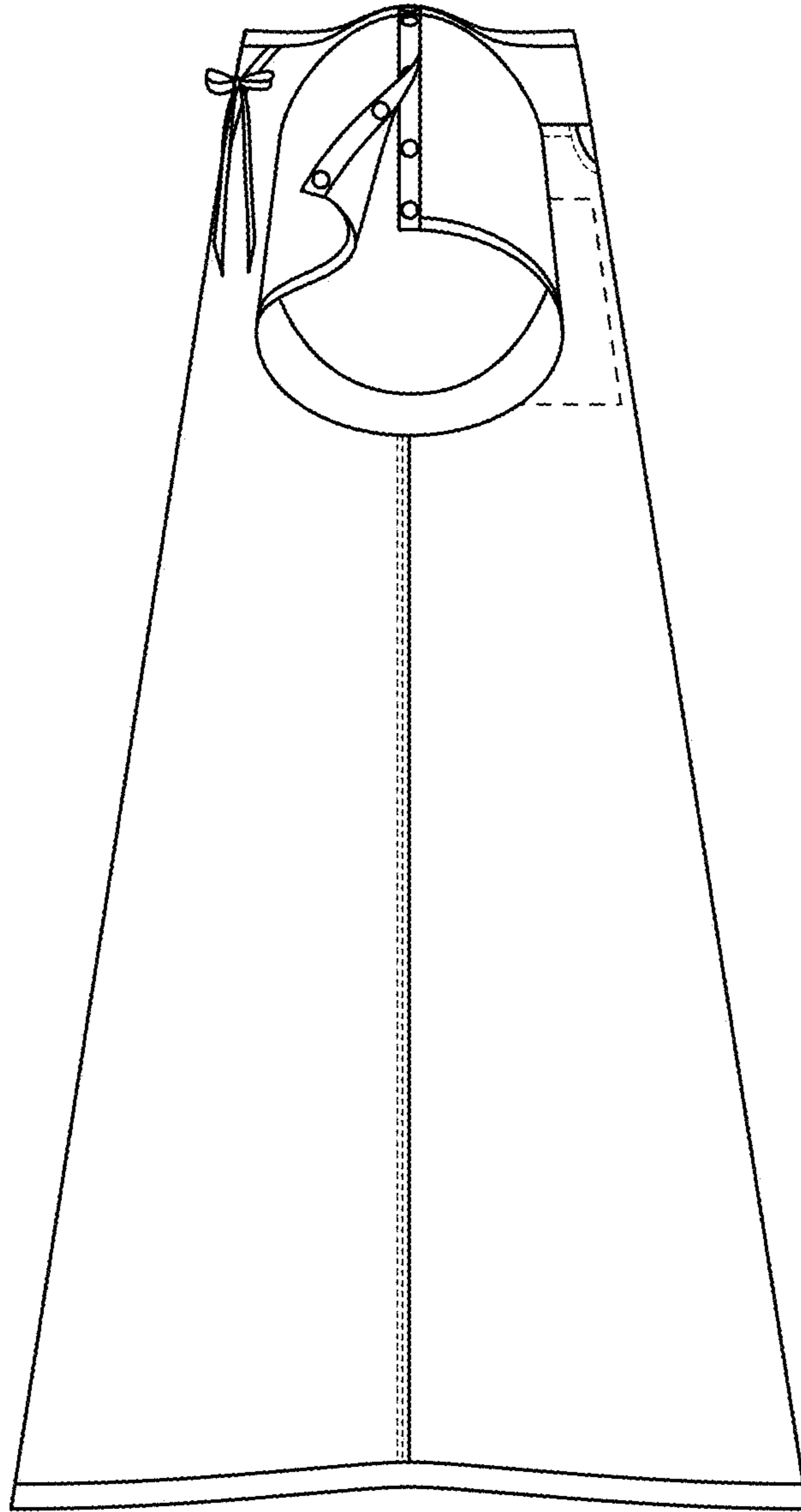

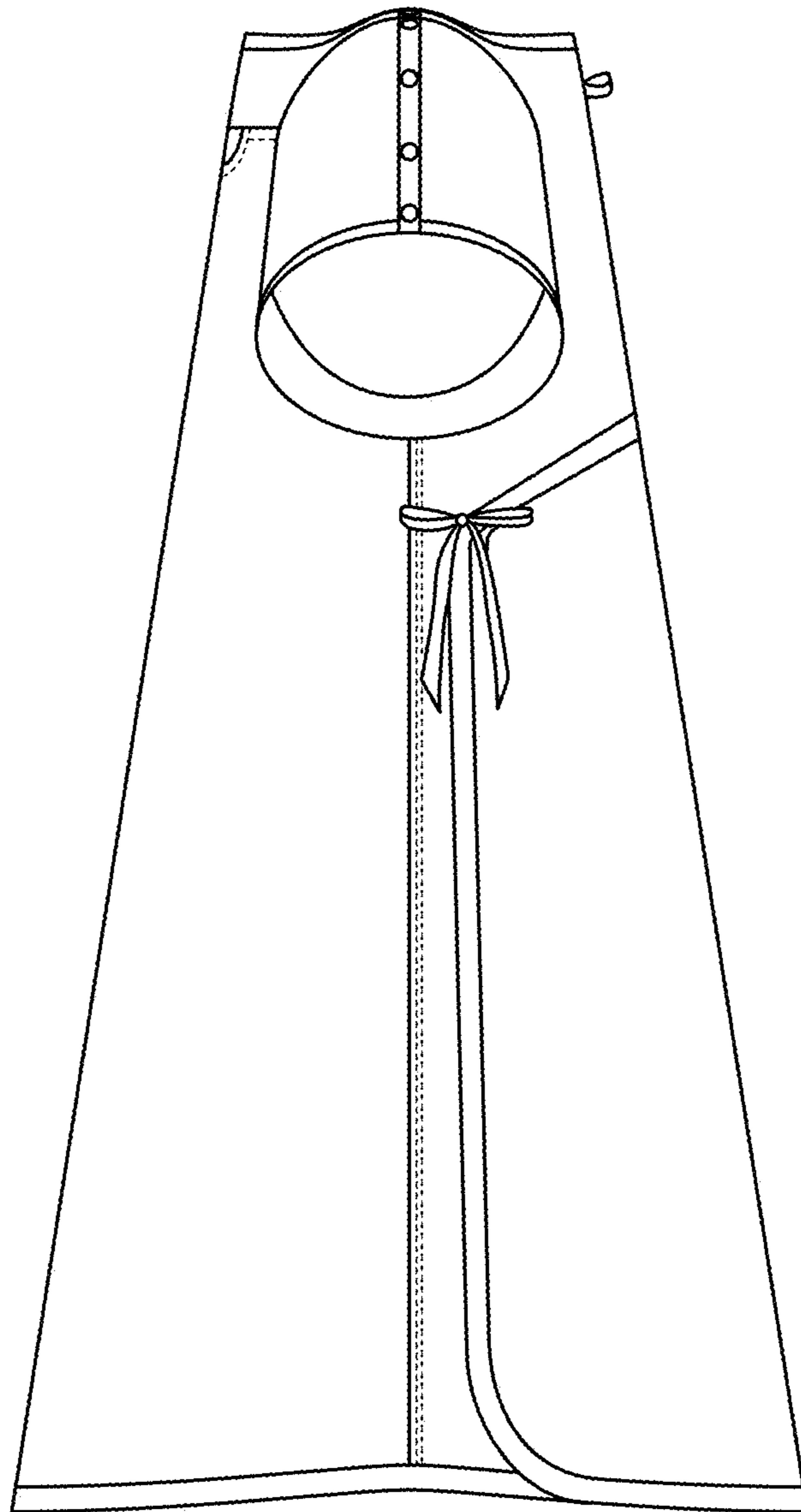
