FIG. 2 is another front view thereof;

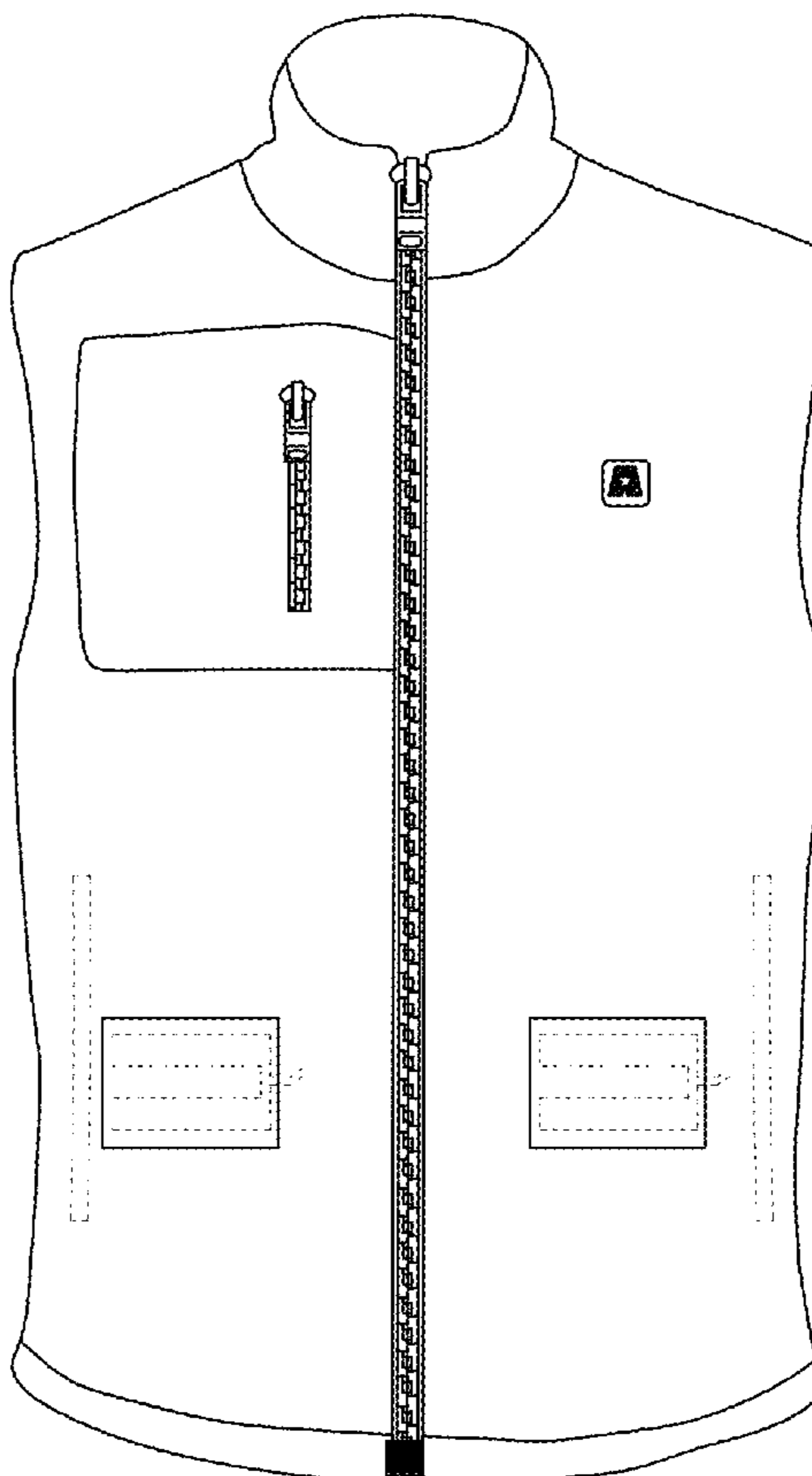
FIG. 3 is a back view thereof;

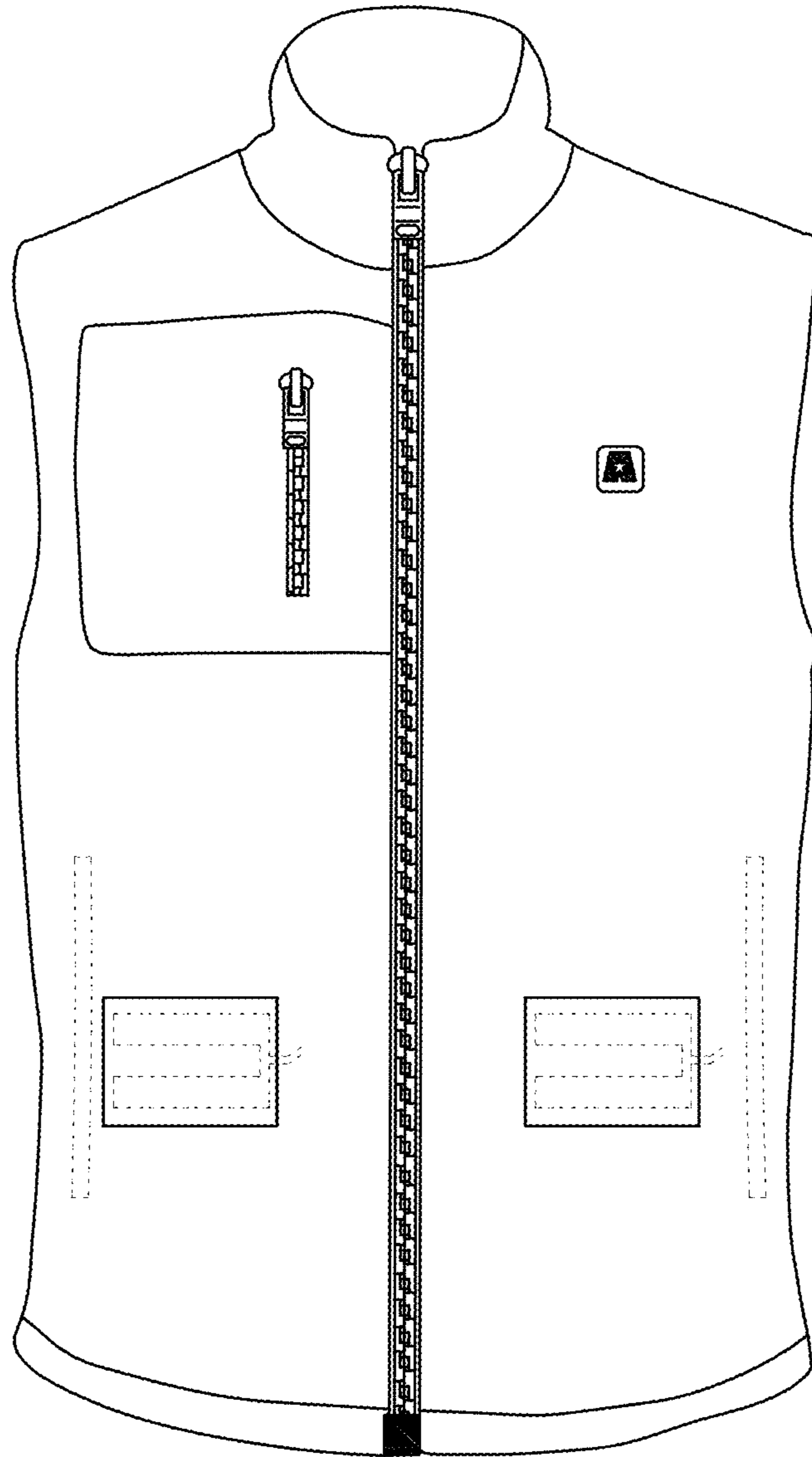

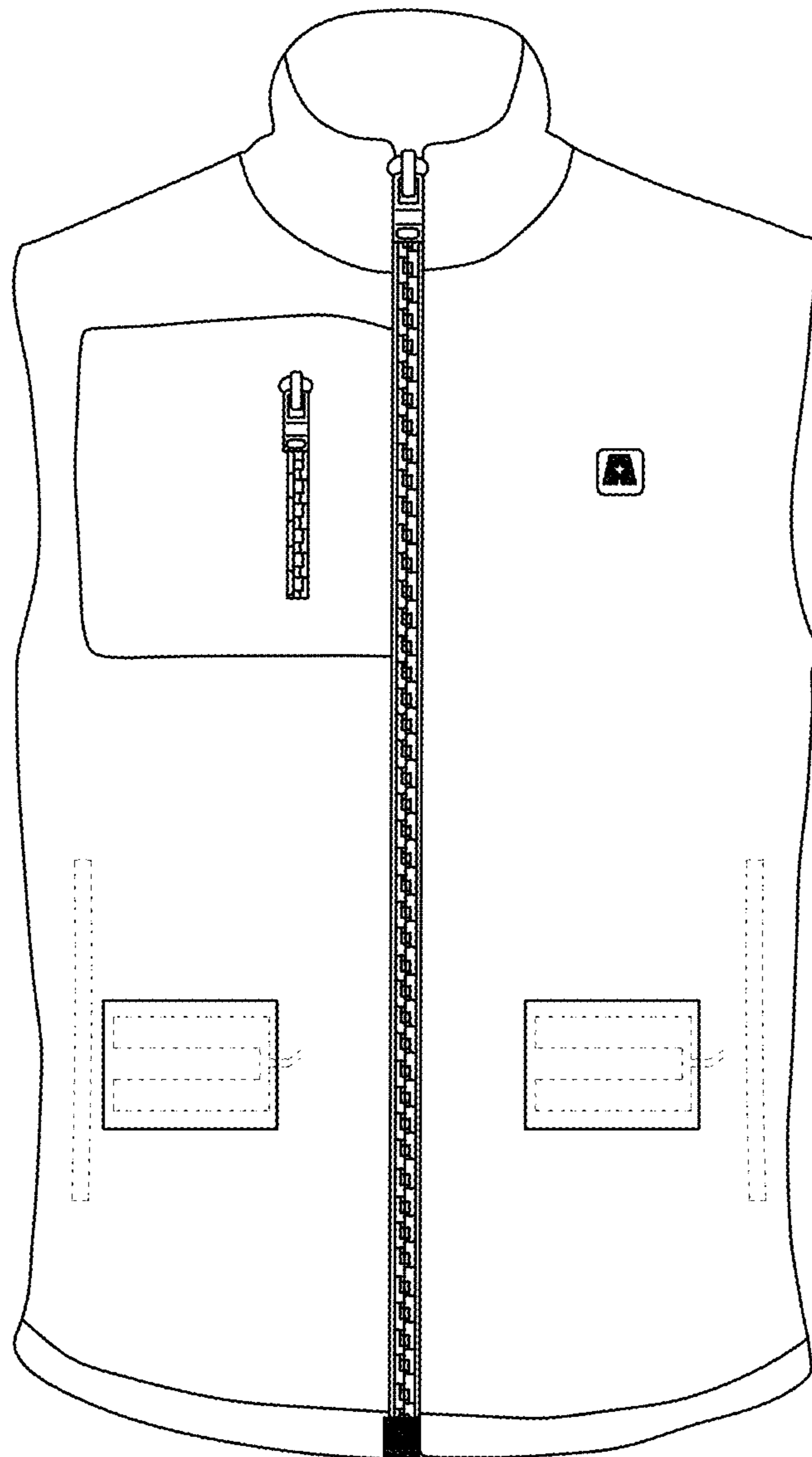

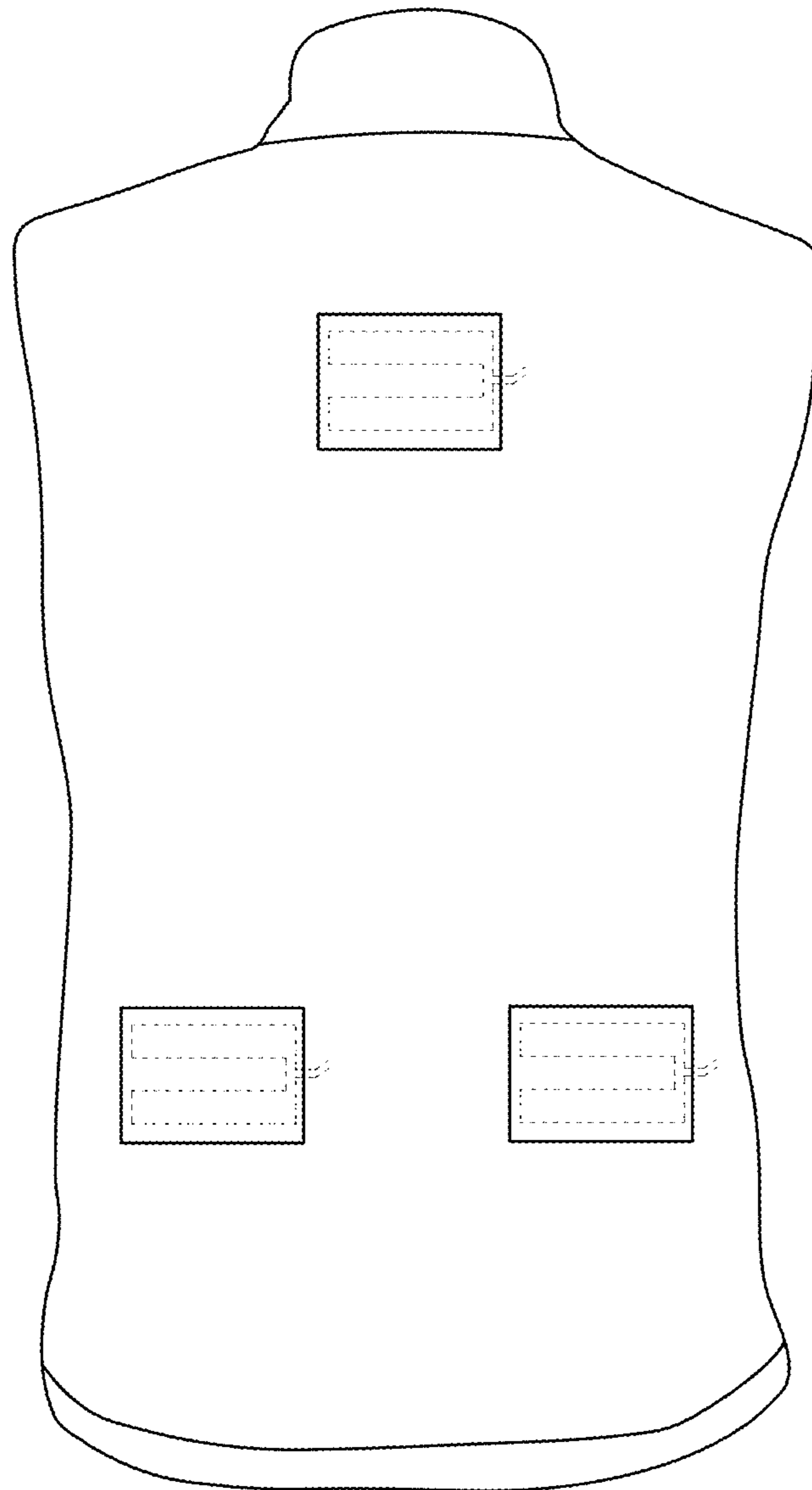

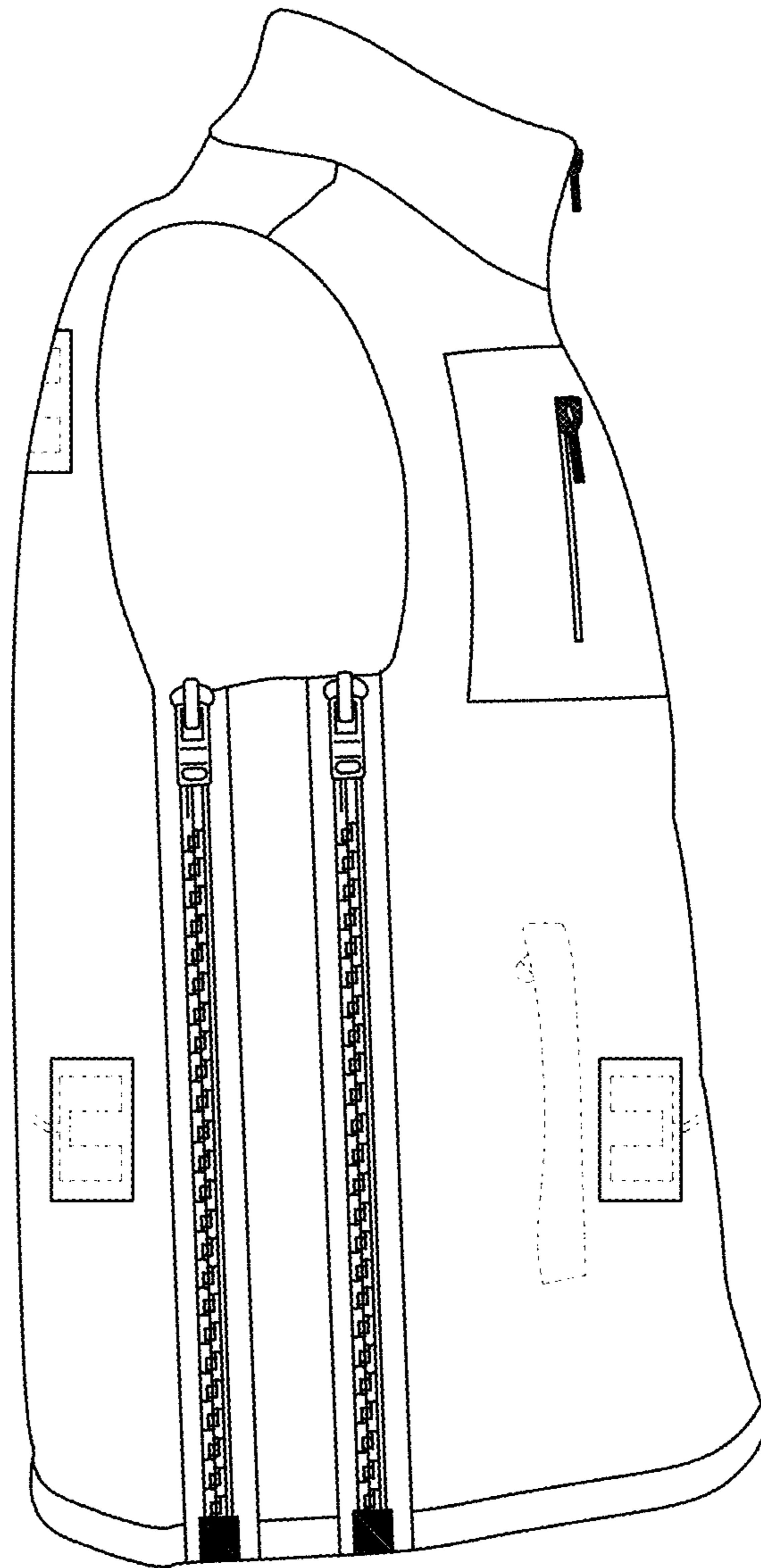

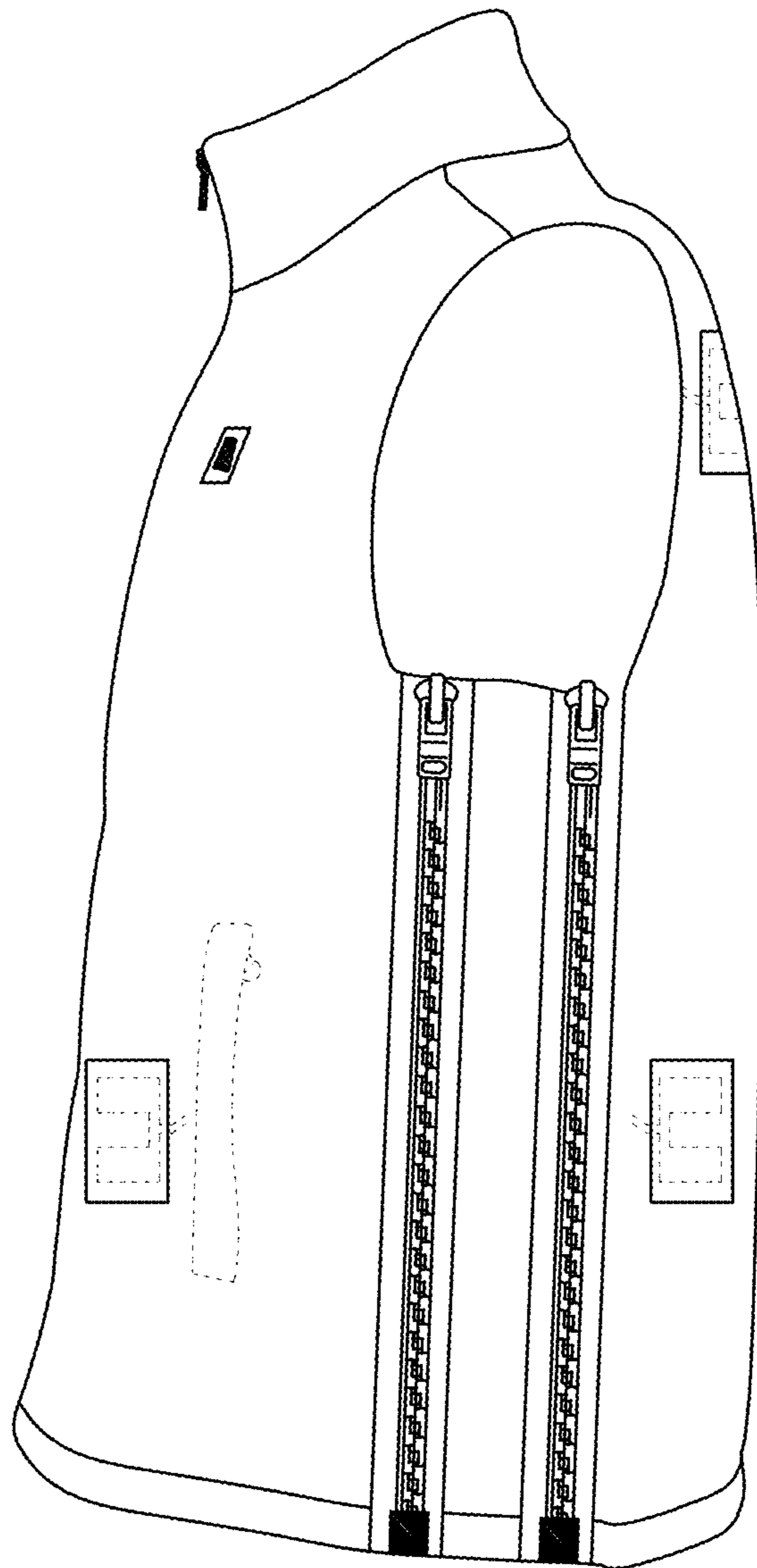
