(57) **CLAIM**

The ornamental design for a sock strap, as shown and described.

DESCRIPTION

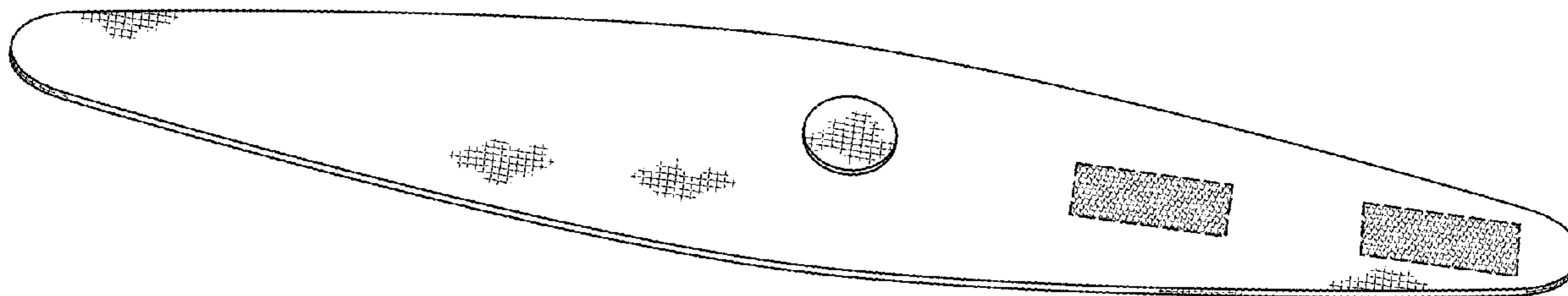


FIG. 39 is a top plan view thereof;

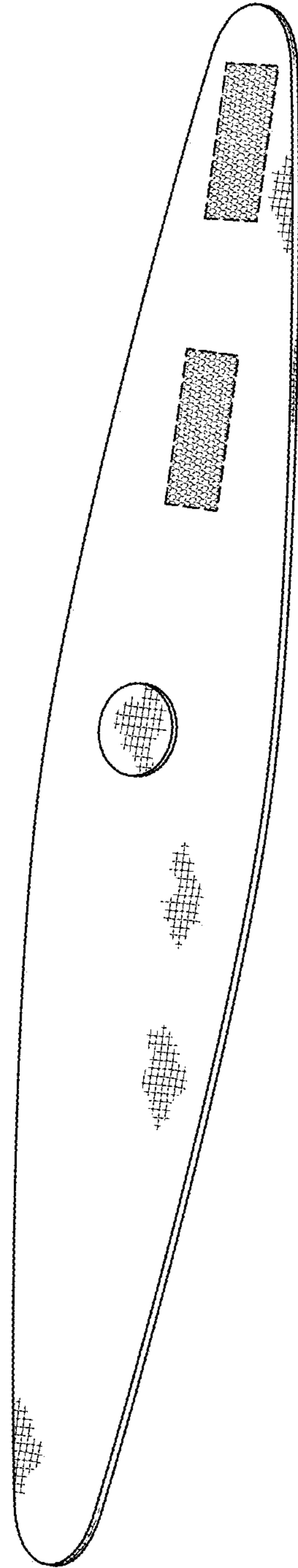

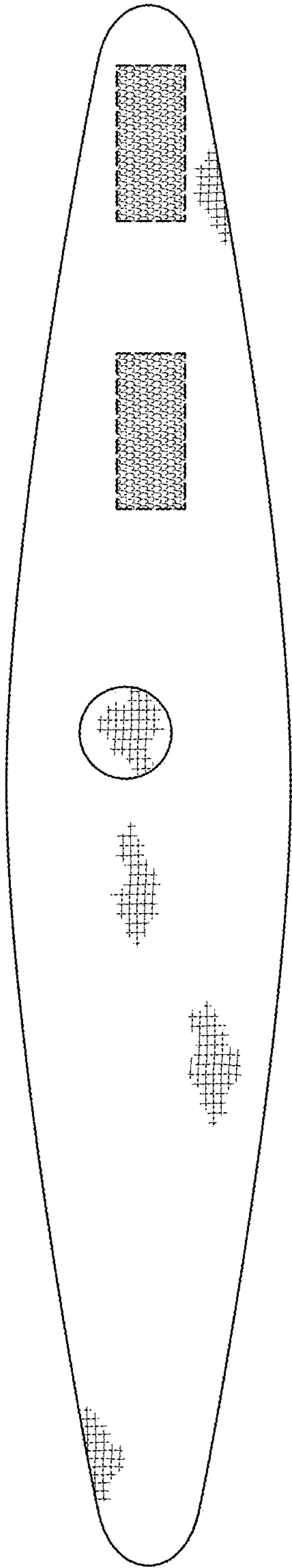

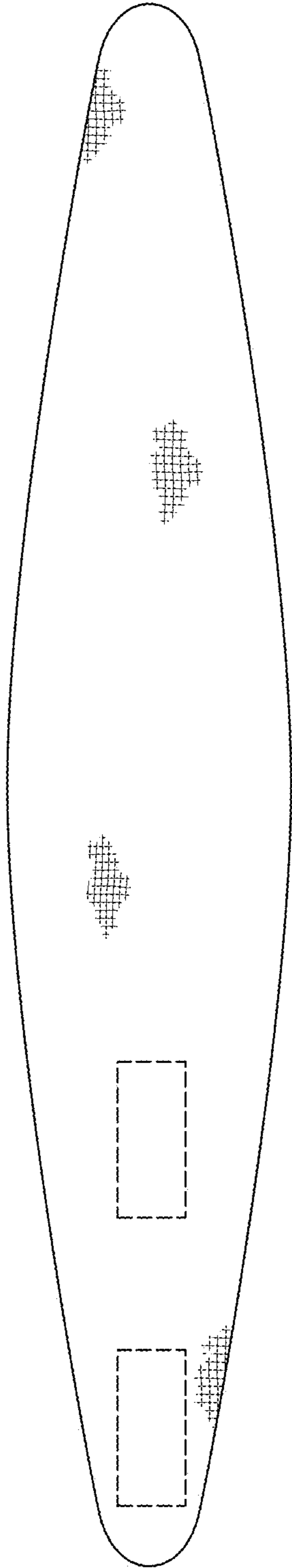

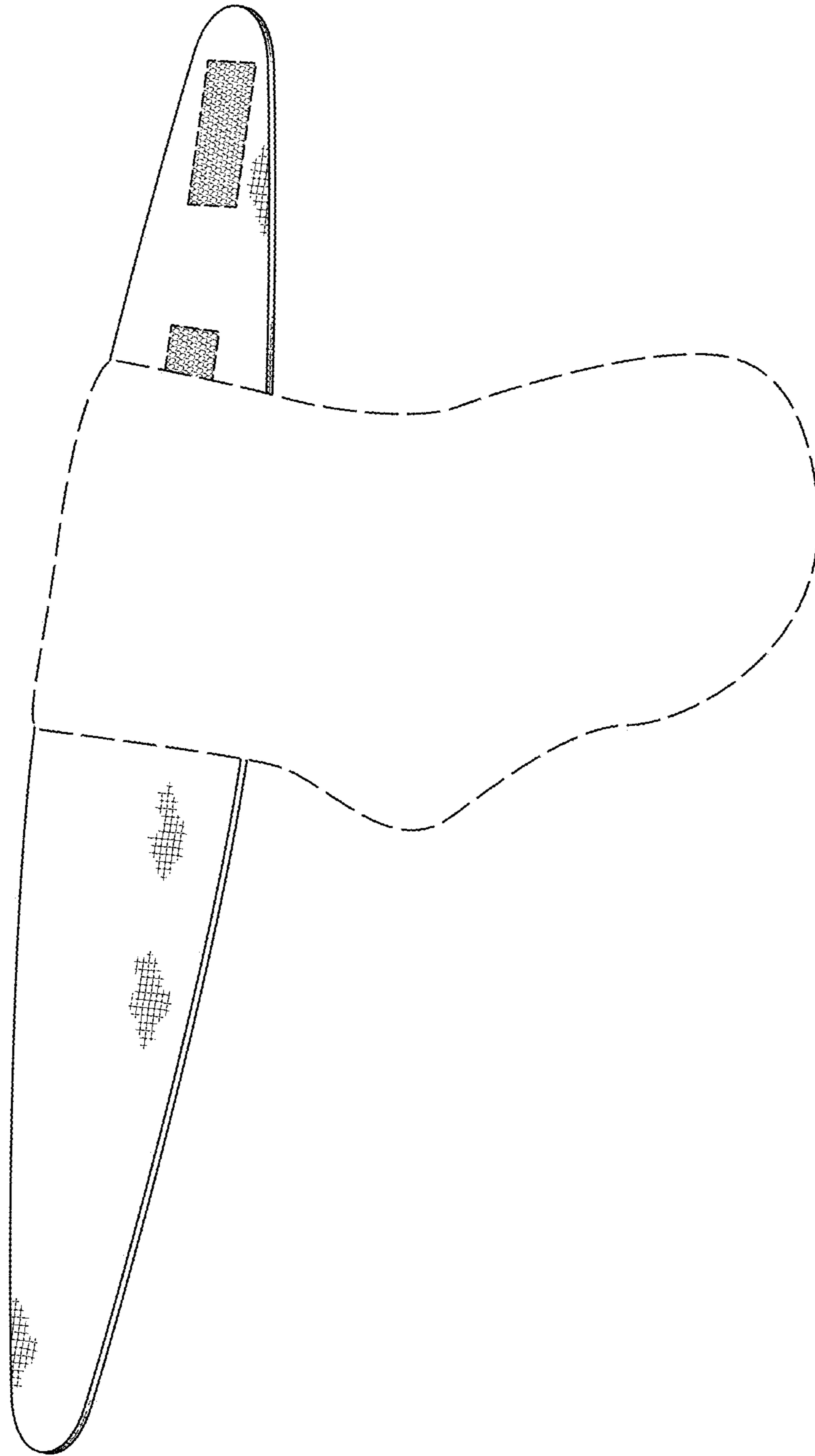

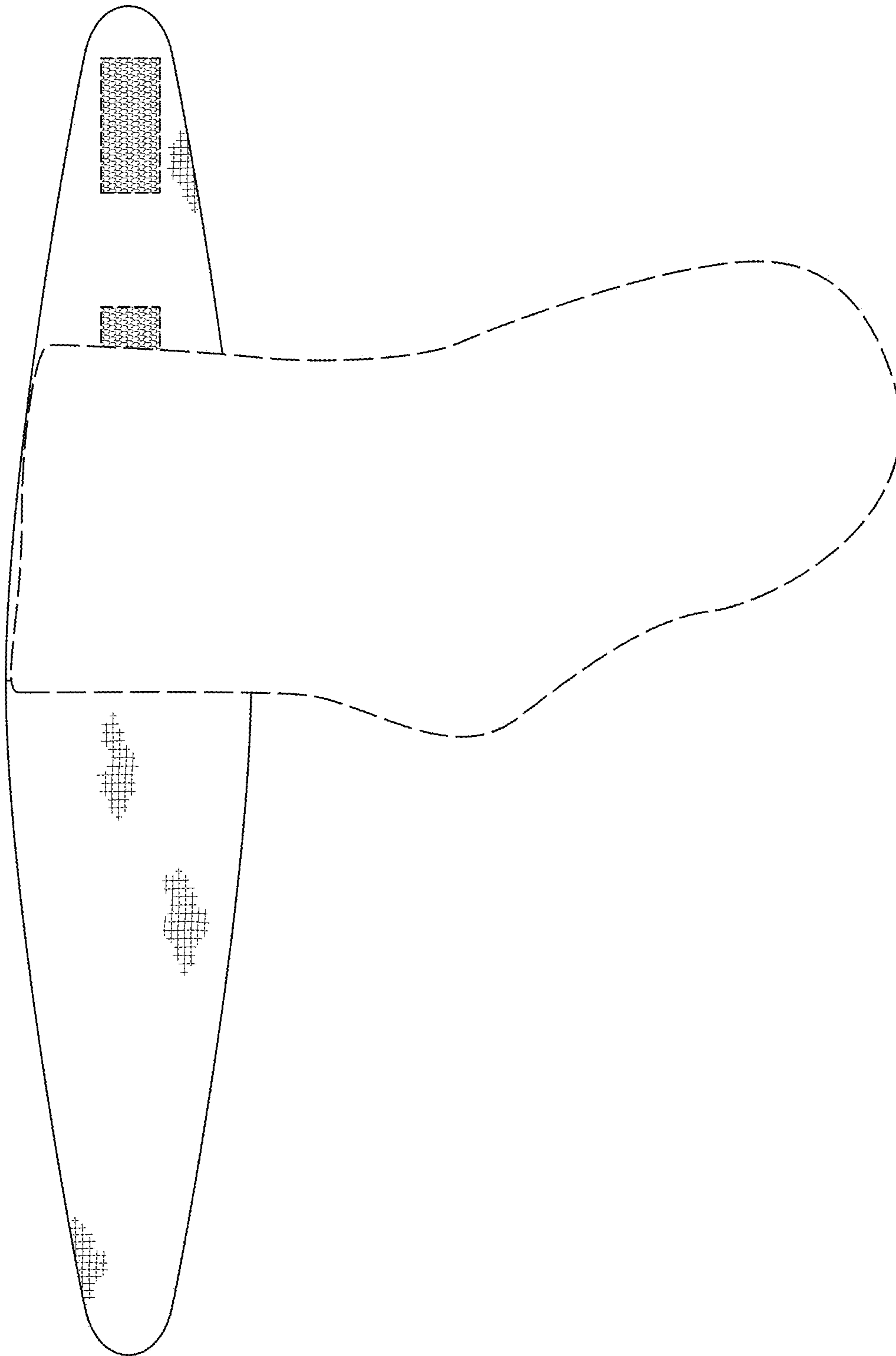

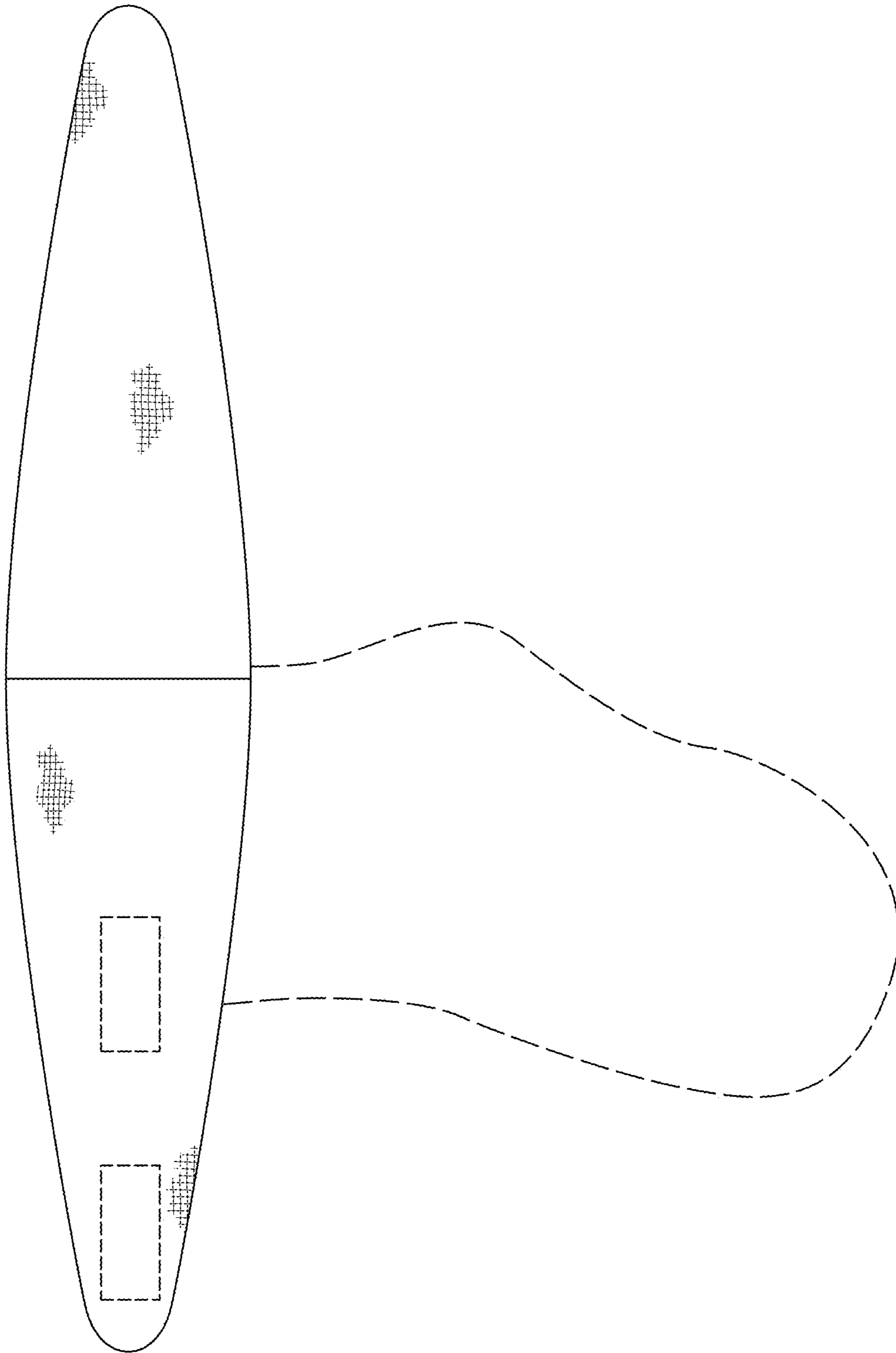

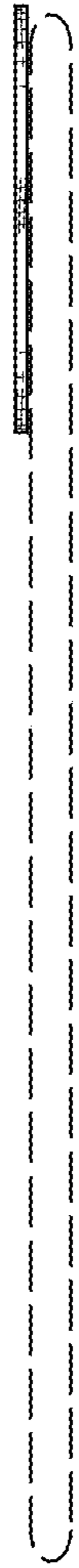

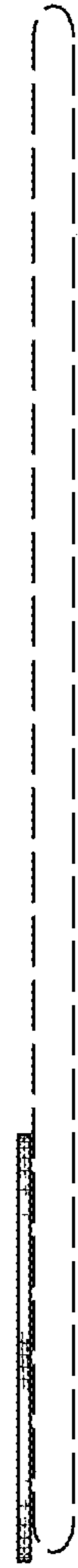

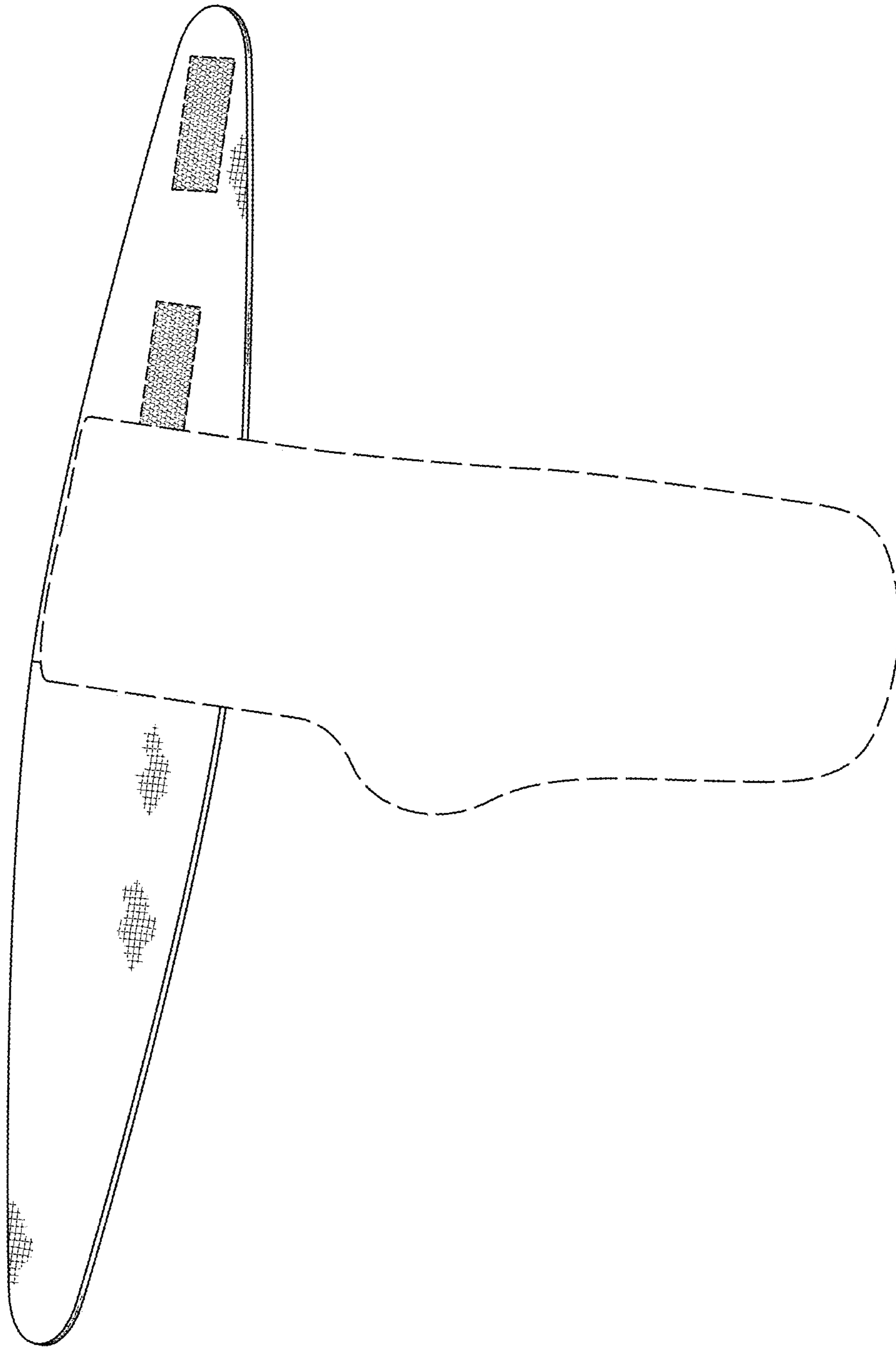

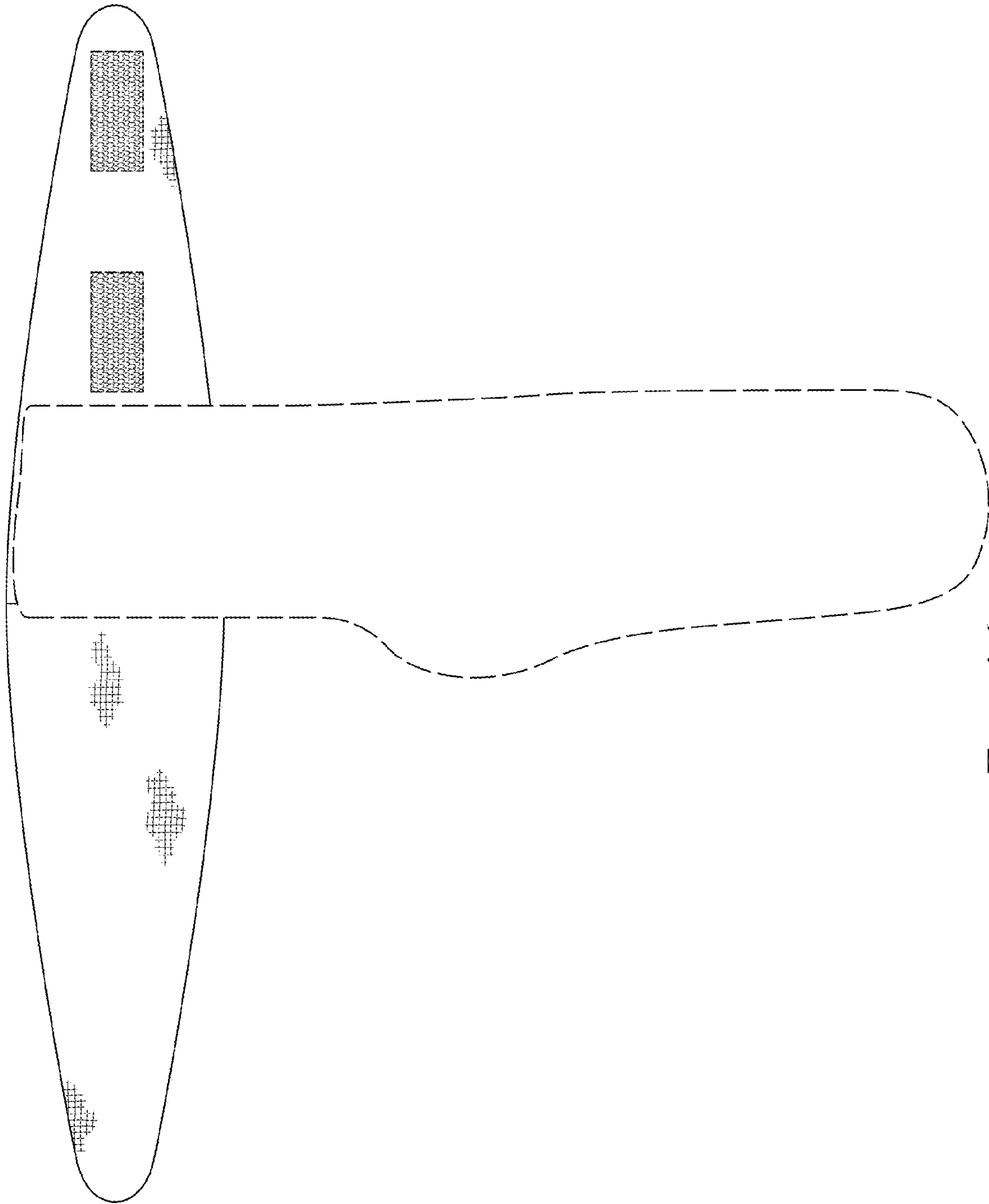

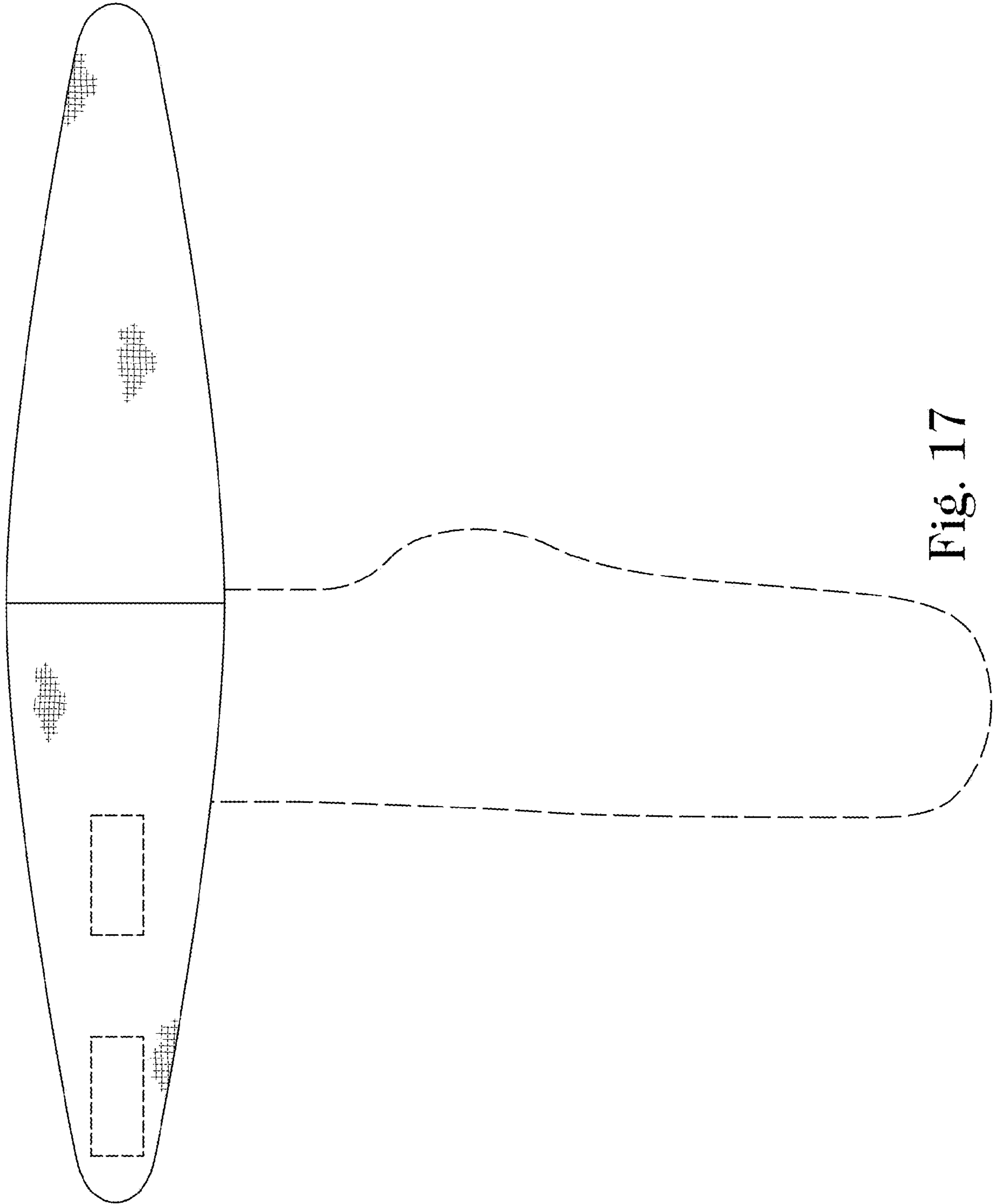

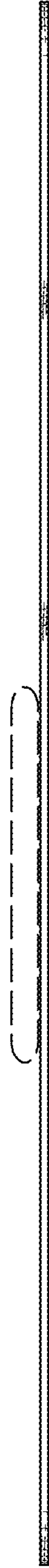

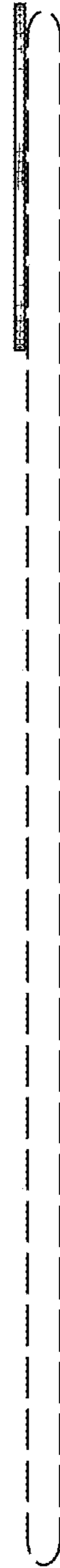

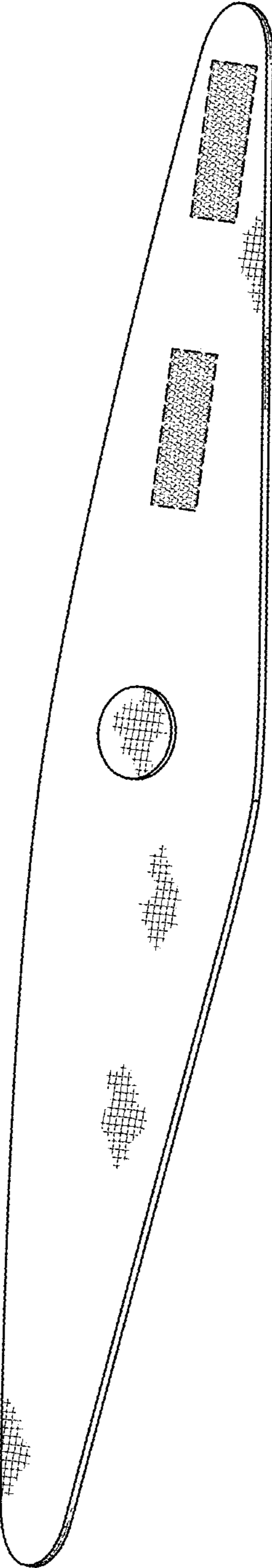

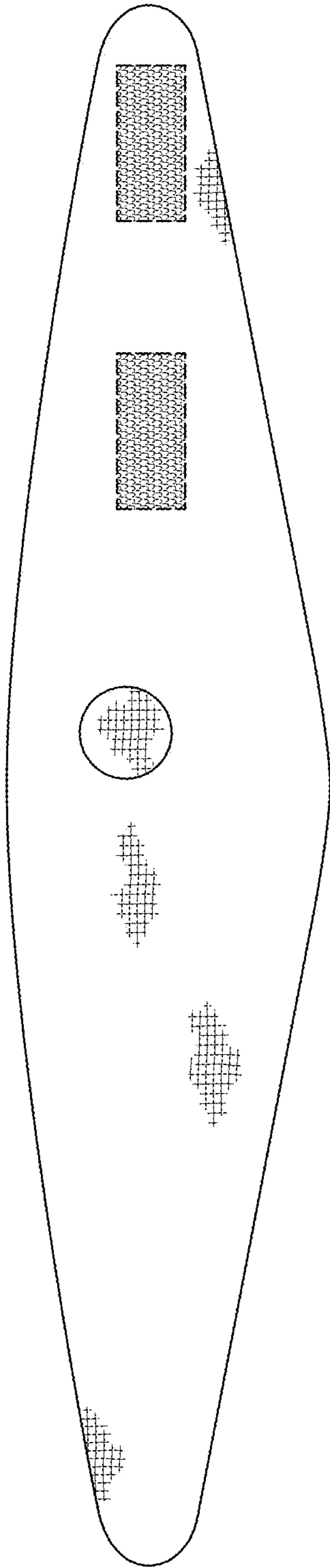

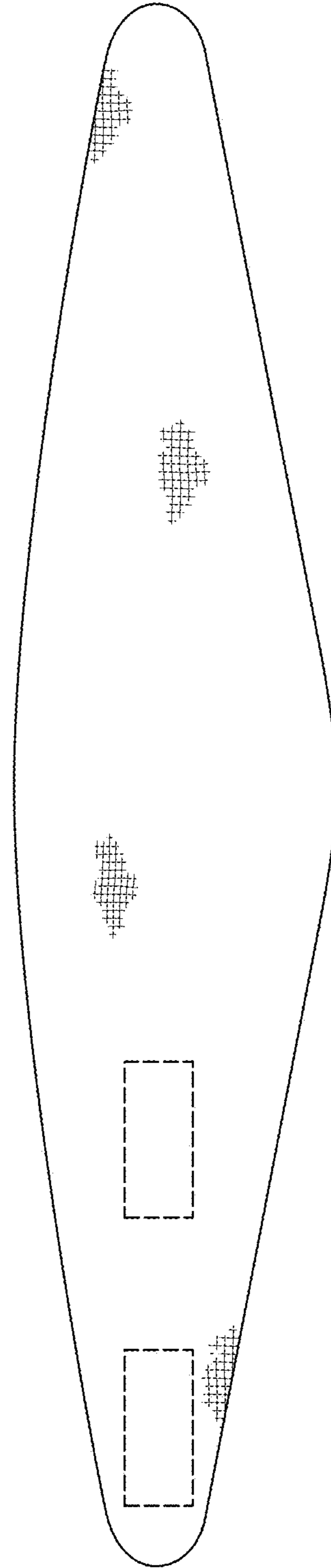

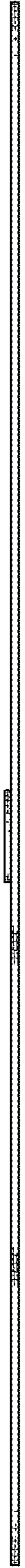

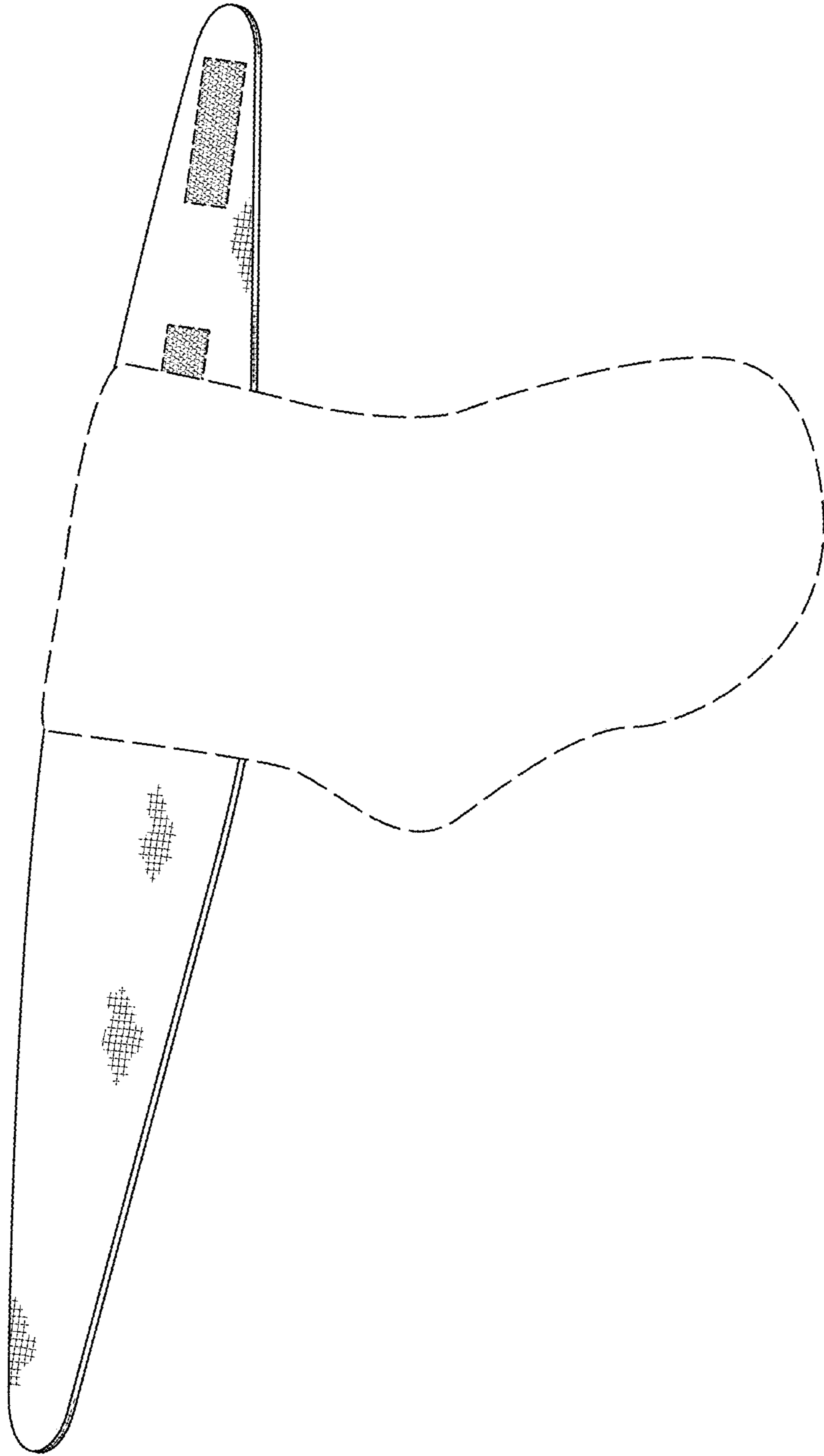

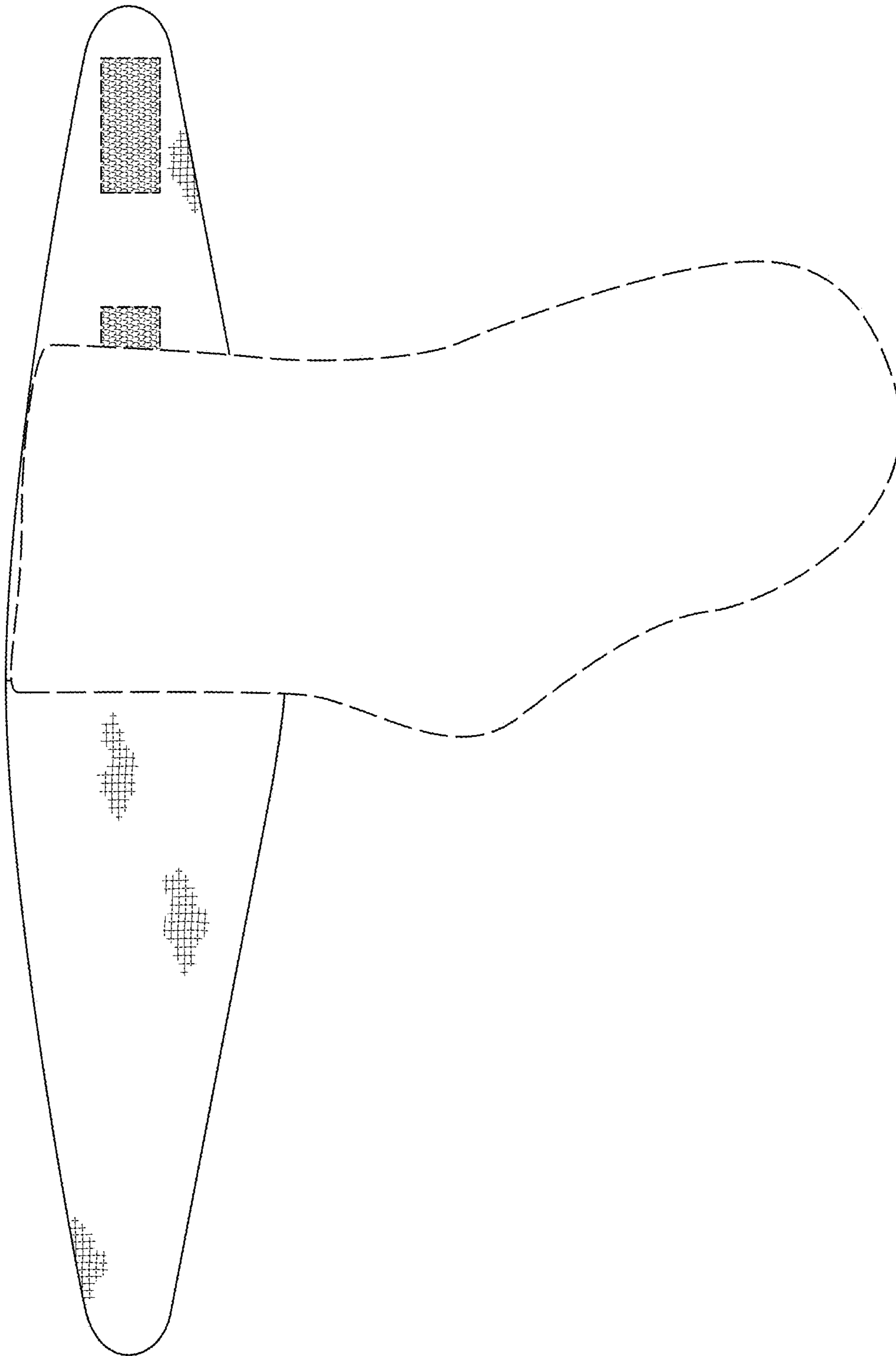

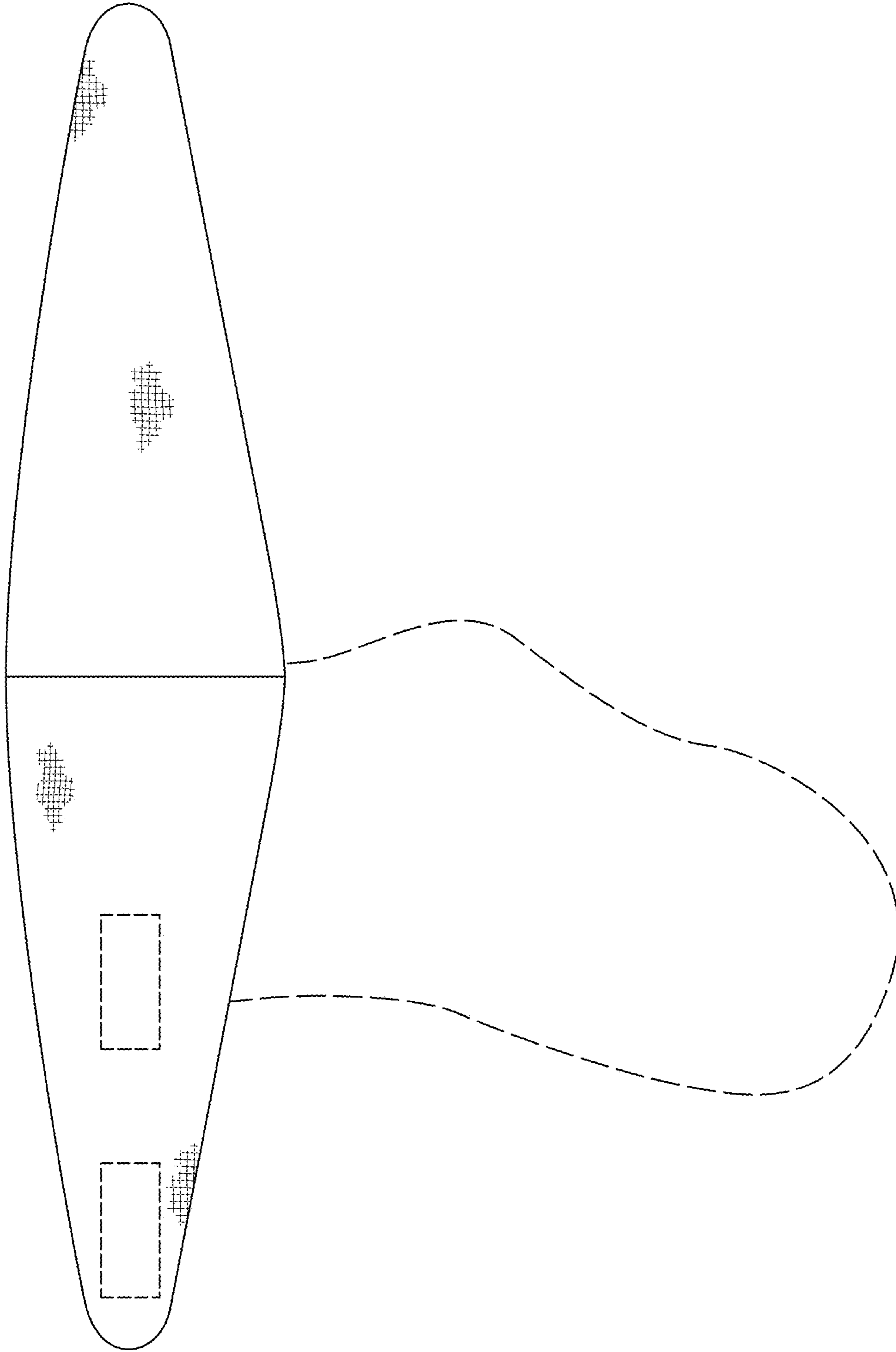

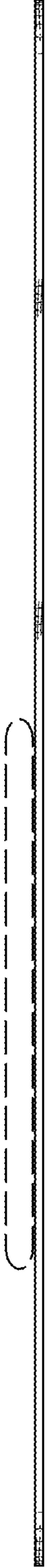

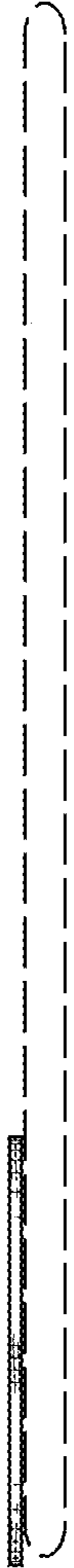

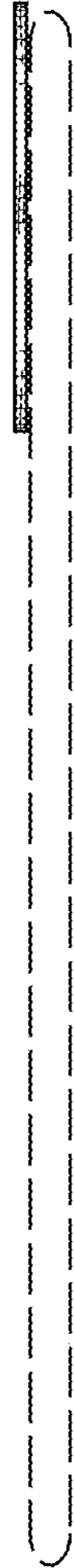

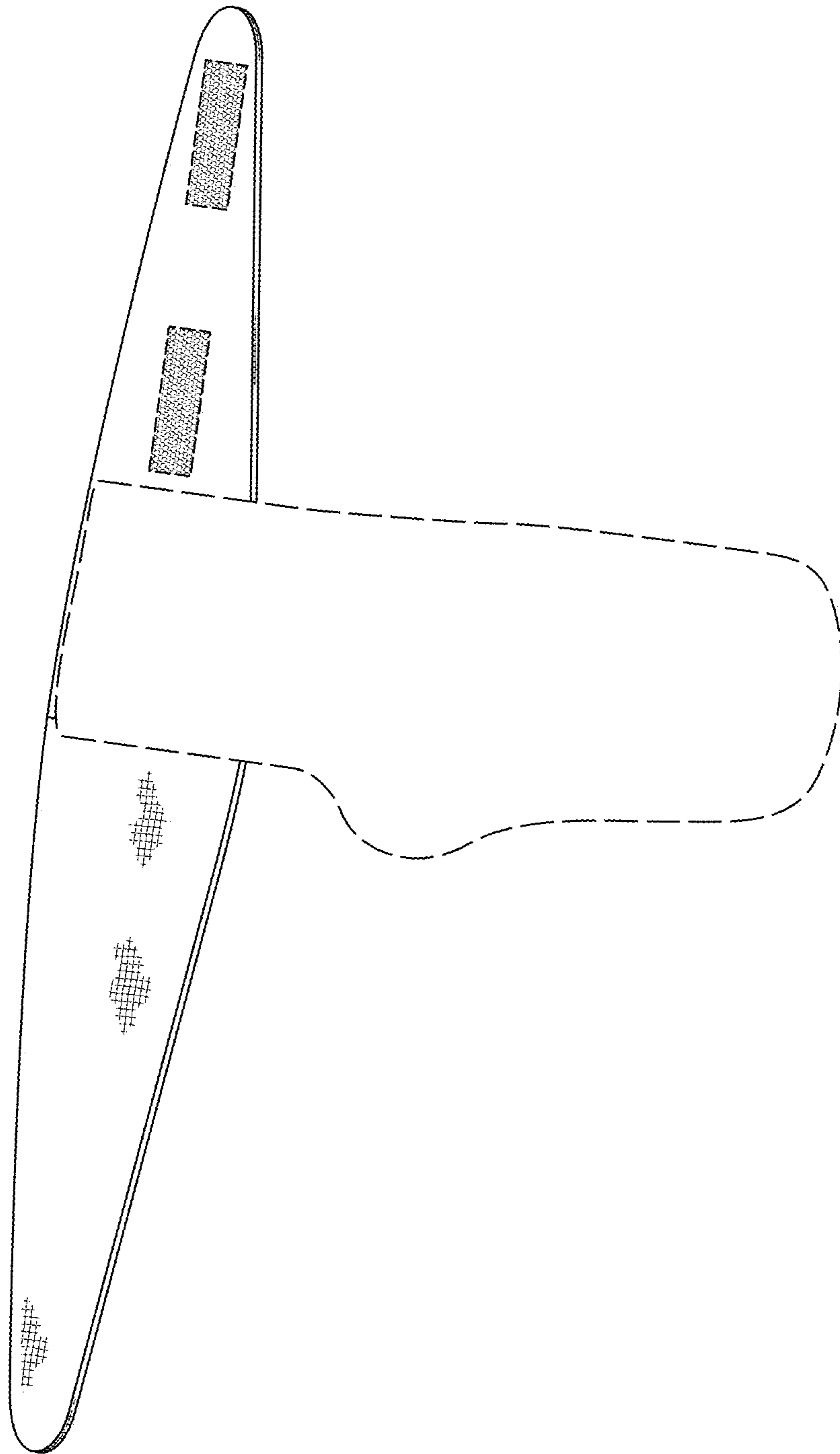

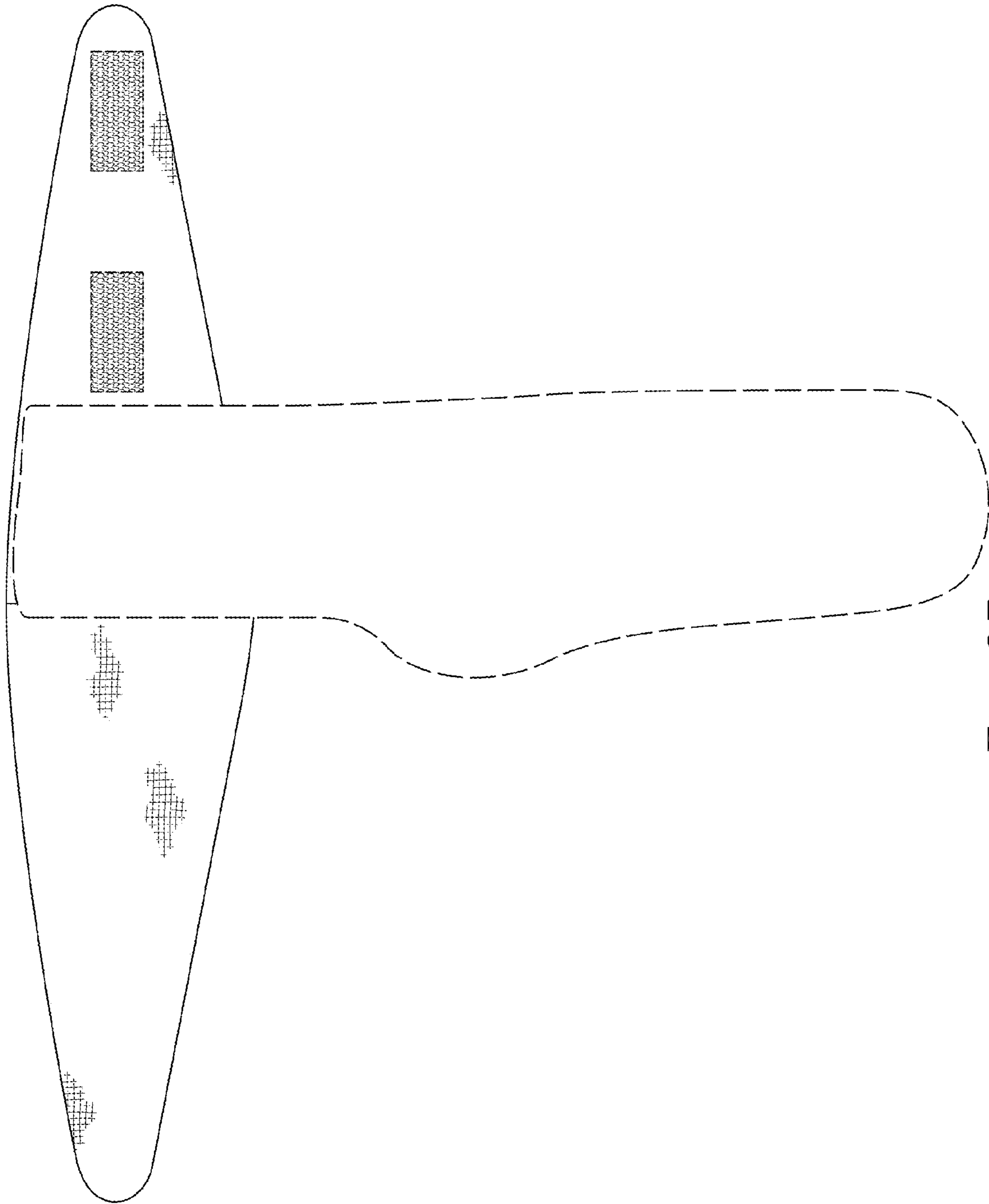

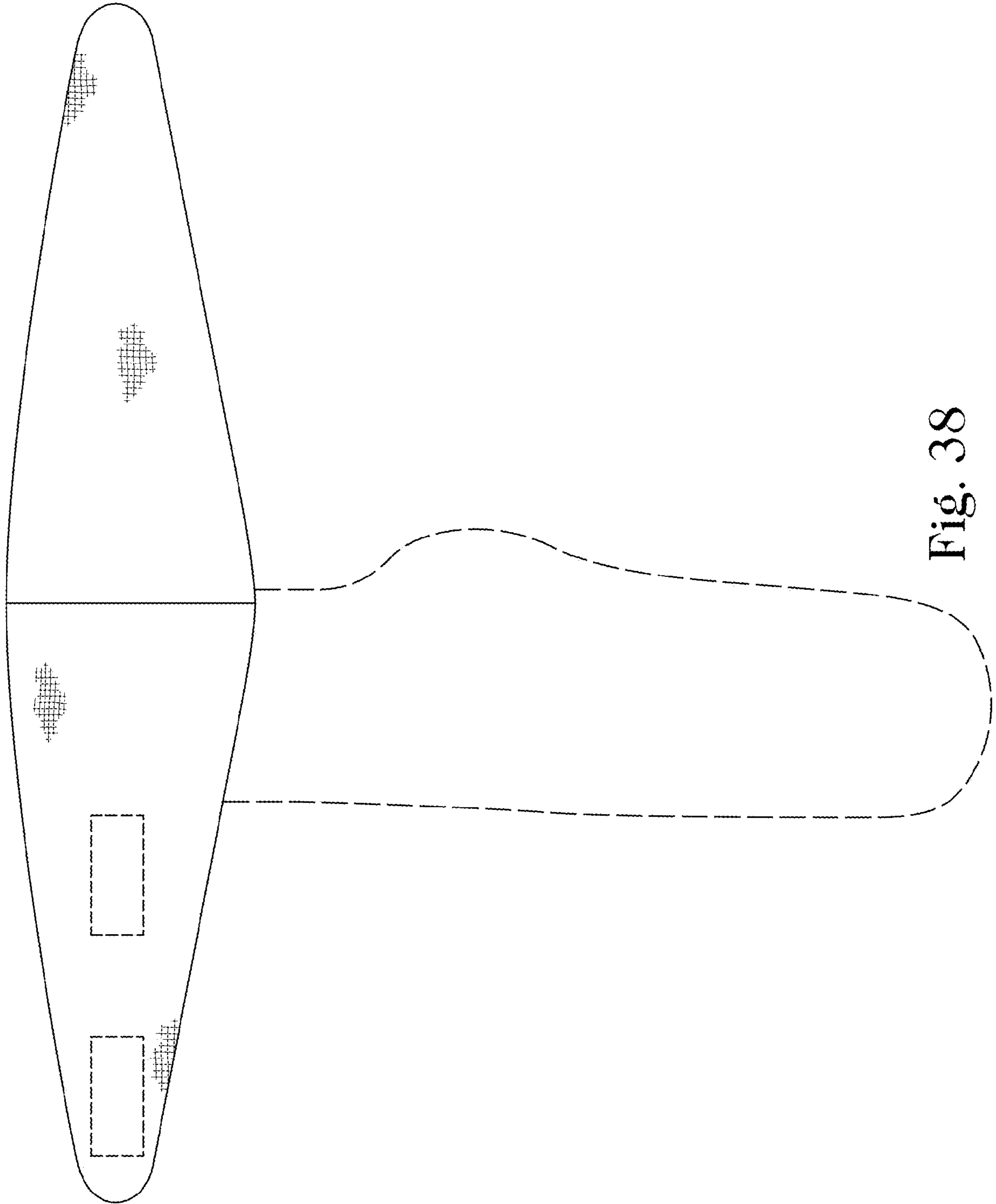

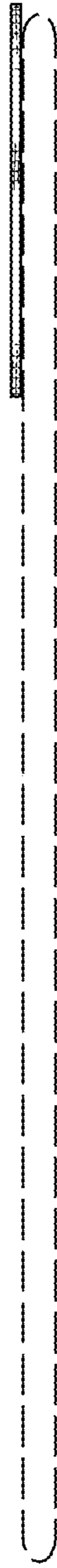
