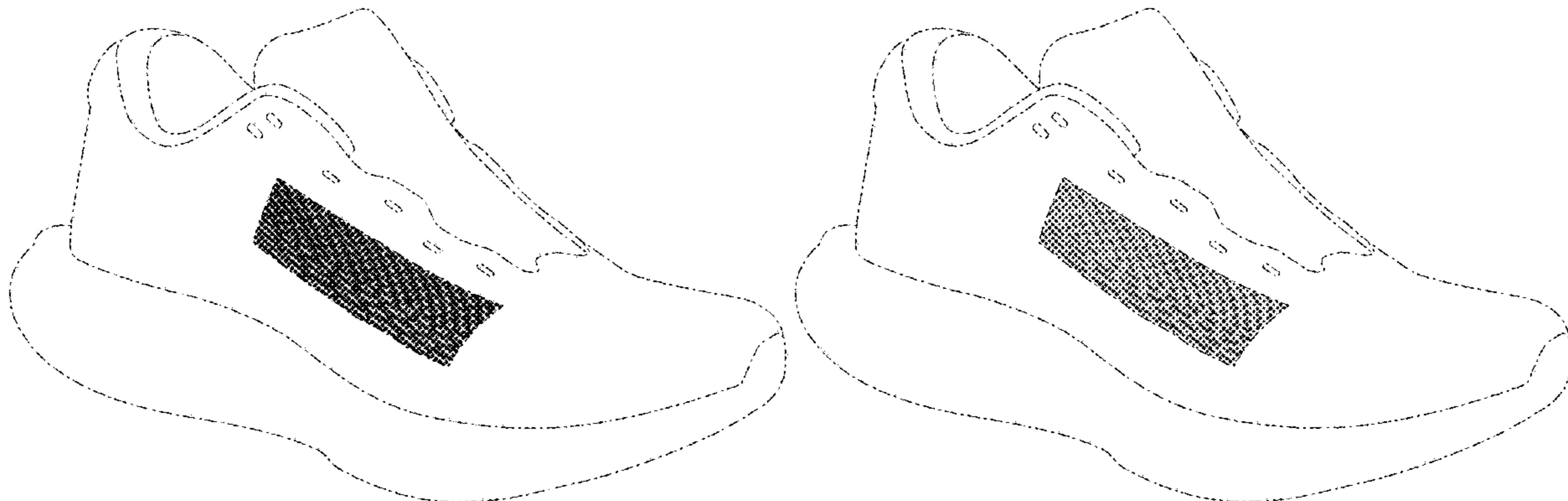
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing our new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front perspective view showing an alternative embodiment of my new design that is the inverse greyscale of the design of FIGS. 1-3;
FIG. 5 is a side view thereof; and,
FIG. 6 is a rear perspective view thereof.
The broken line immediately adjacent to and surrounding the photographic area defines the peripheral bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

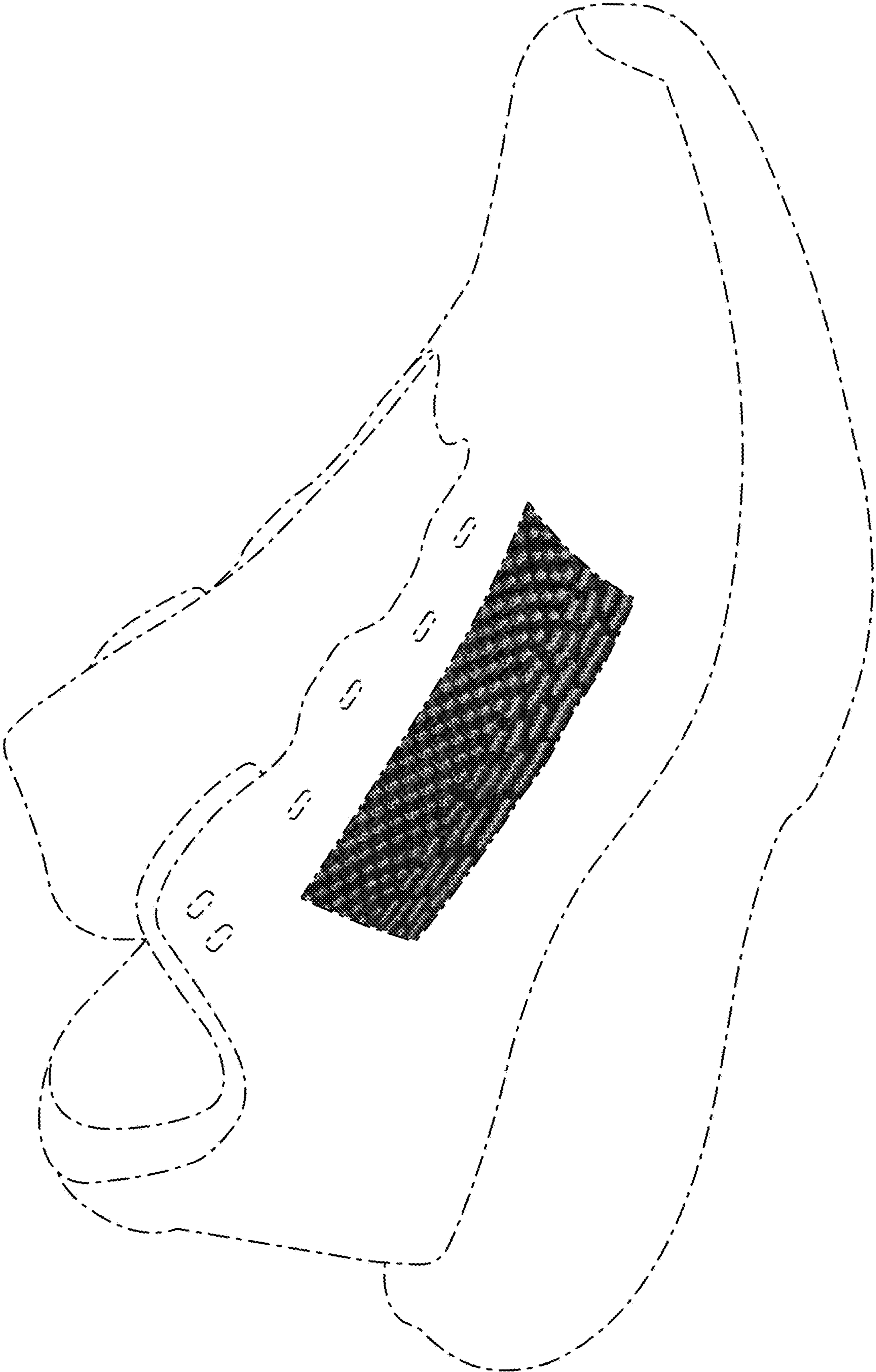

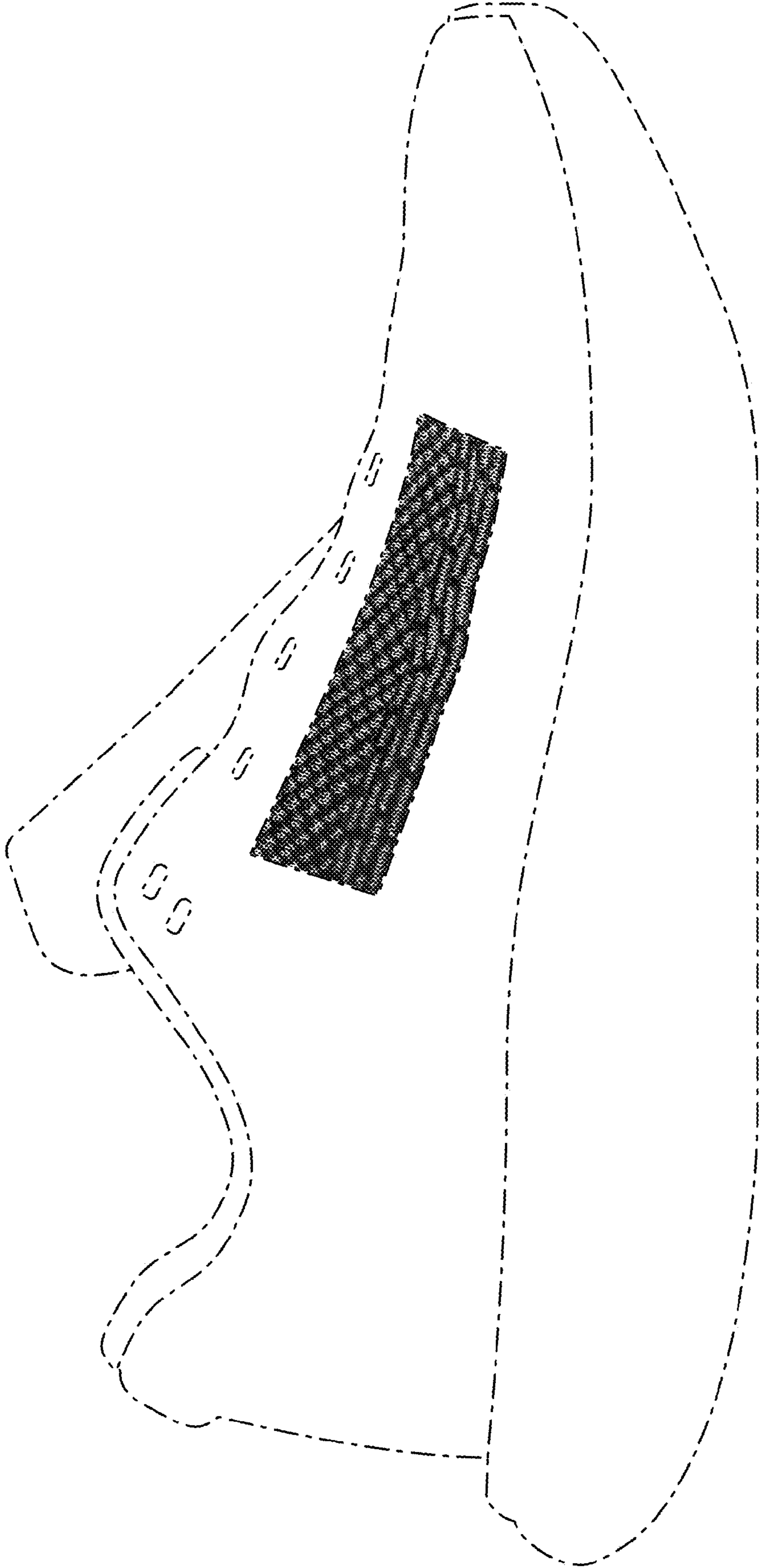

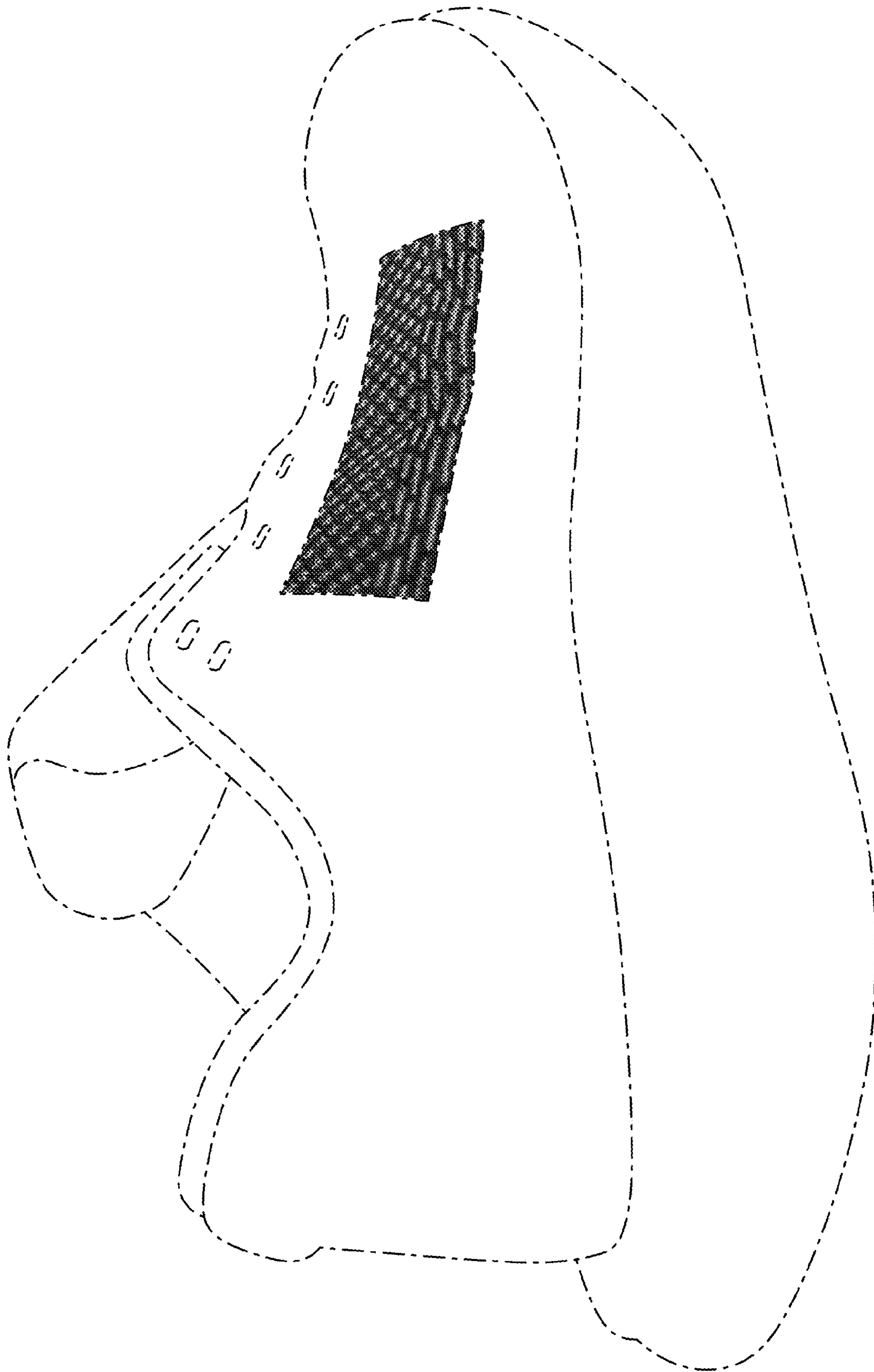

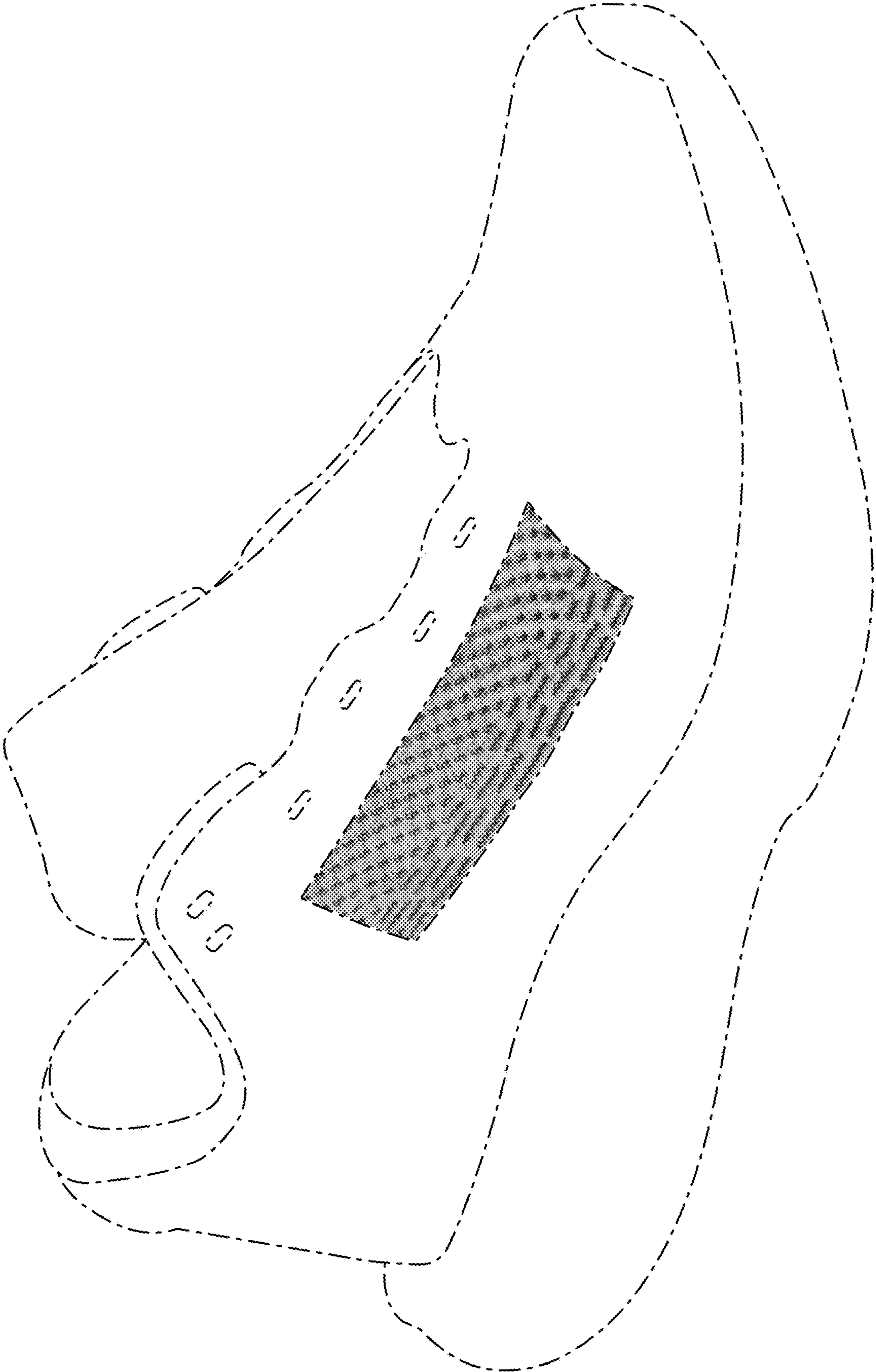

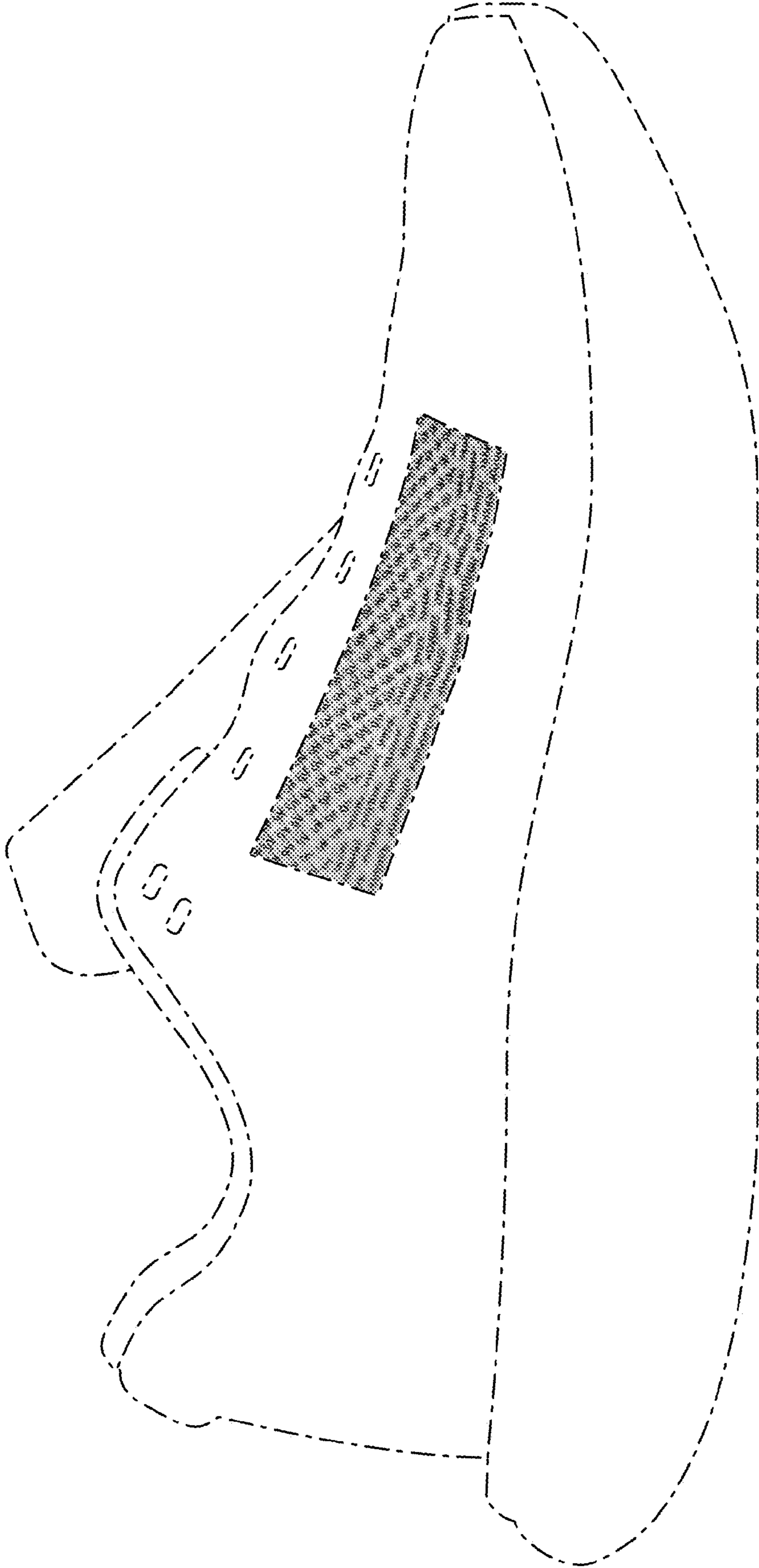

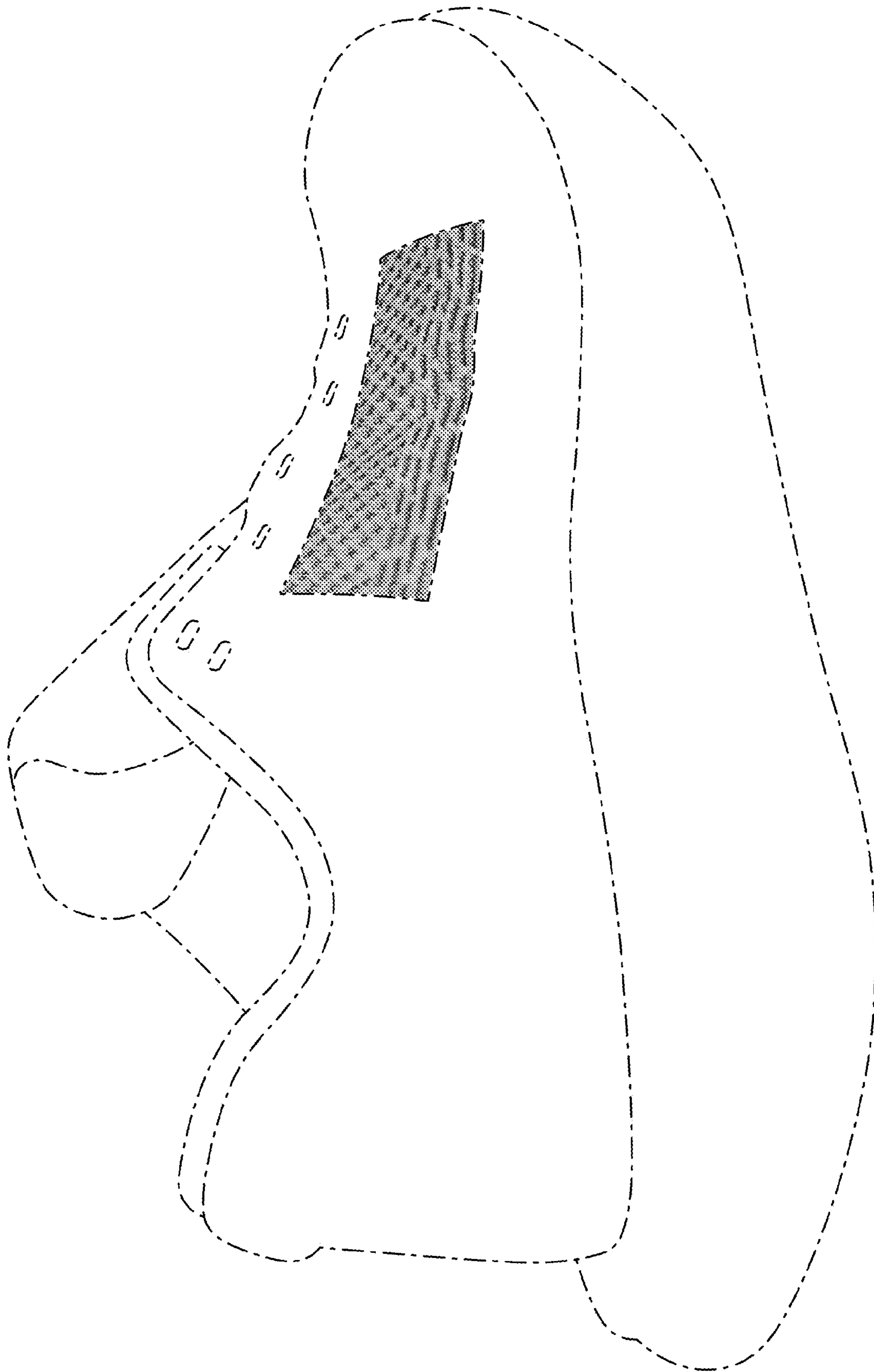
