The ornamental design for a shoe, as shown and described.

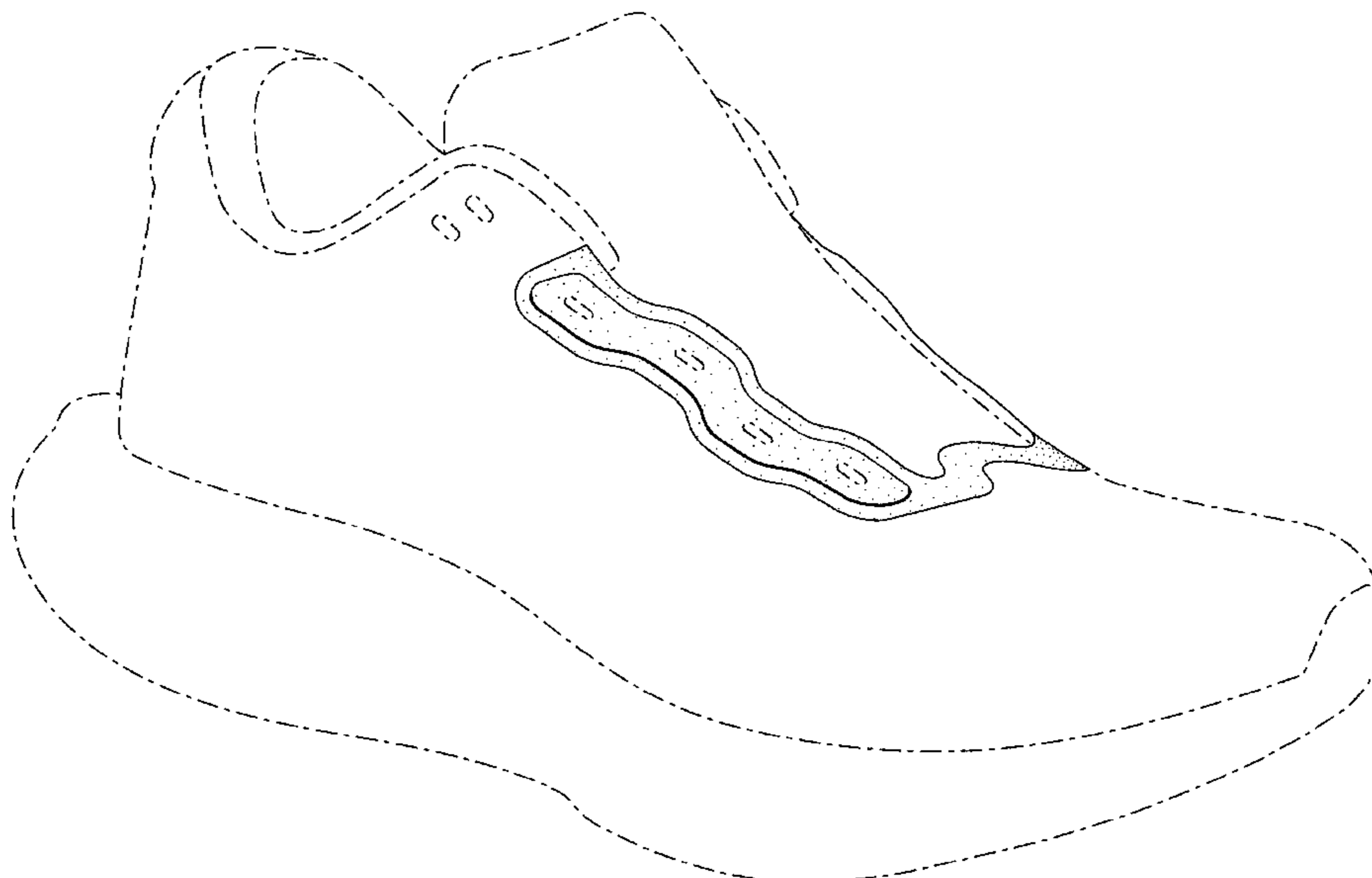
DESCRIPTION

FIG. 1 is a side view of a shoe showing our new design; FIG. 2 is a front perspective view thereof; FIG. 3 is an opposite side front perspective view thereof; and, FIG. 4 is an opposite side view thereof. The broken lines showing of the eight racetrack shaped elements represent eyelets that form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

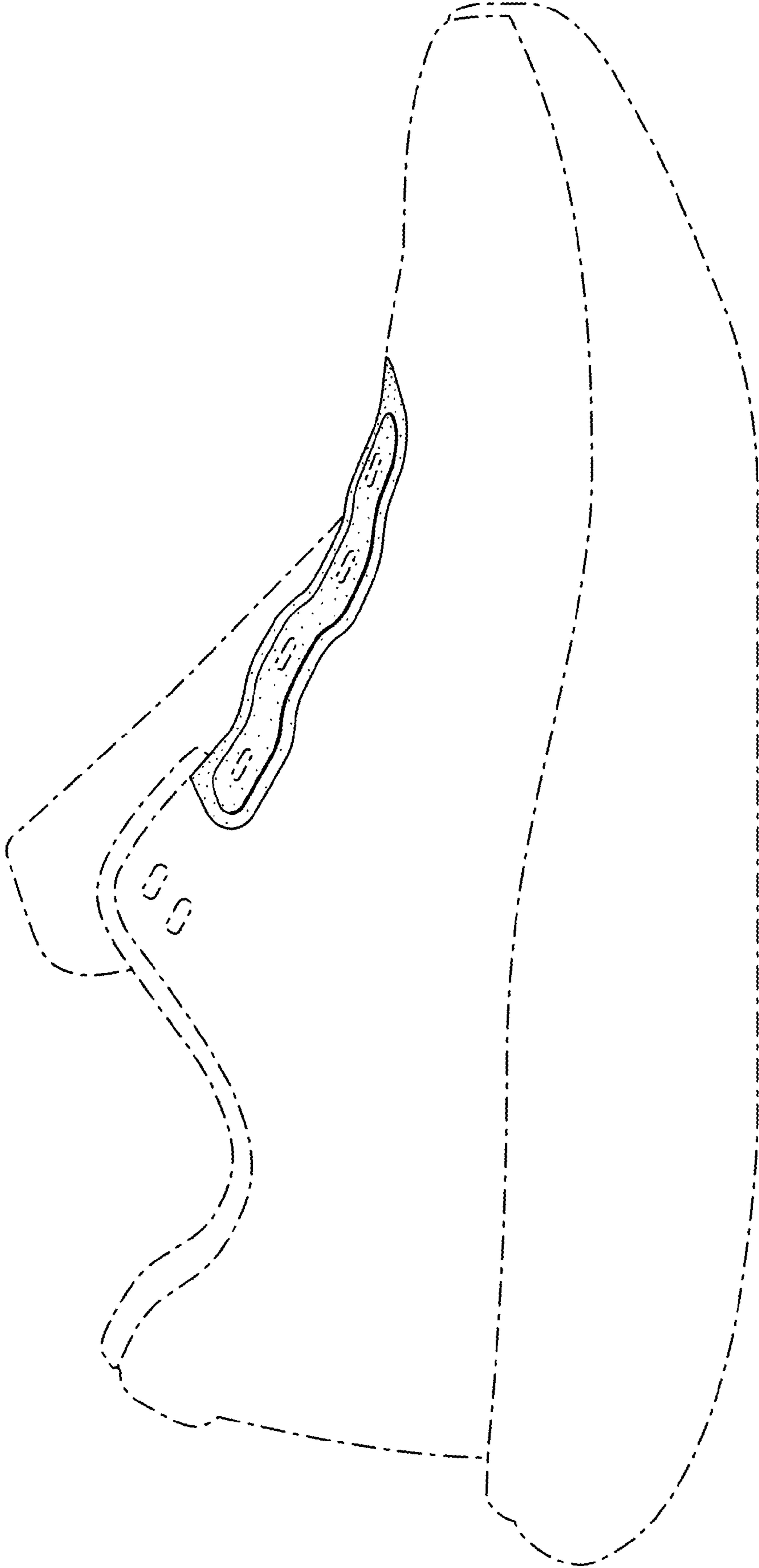

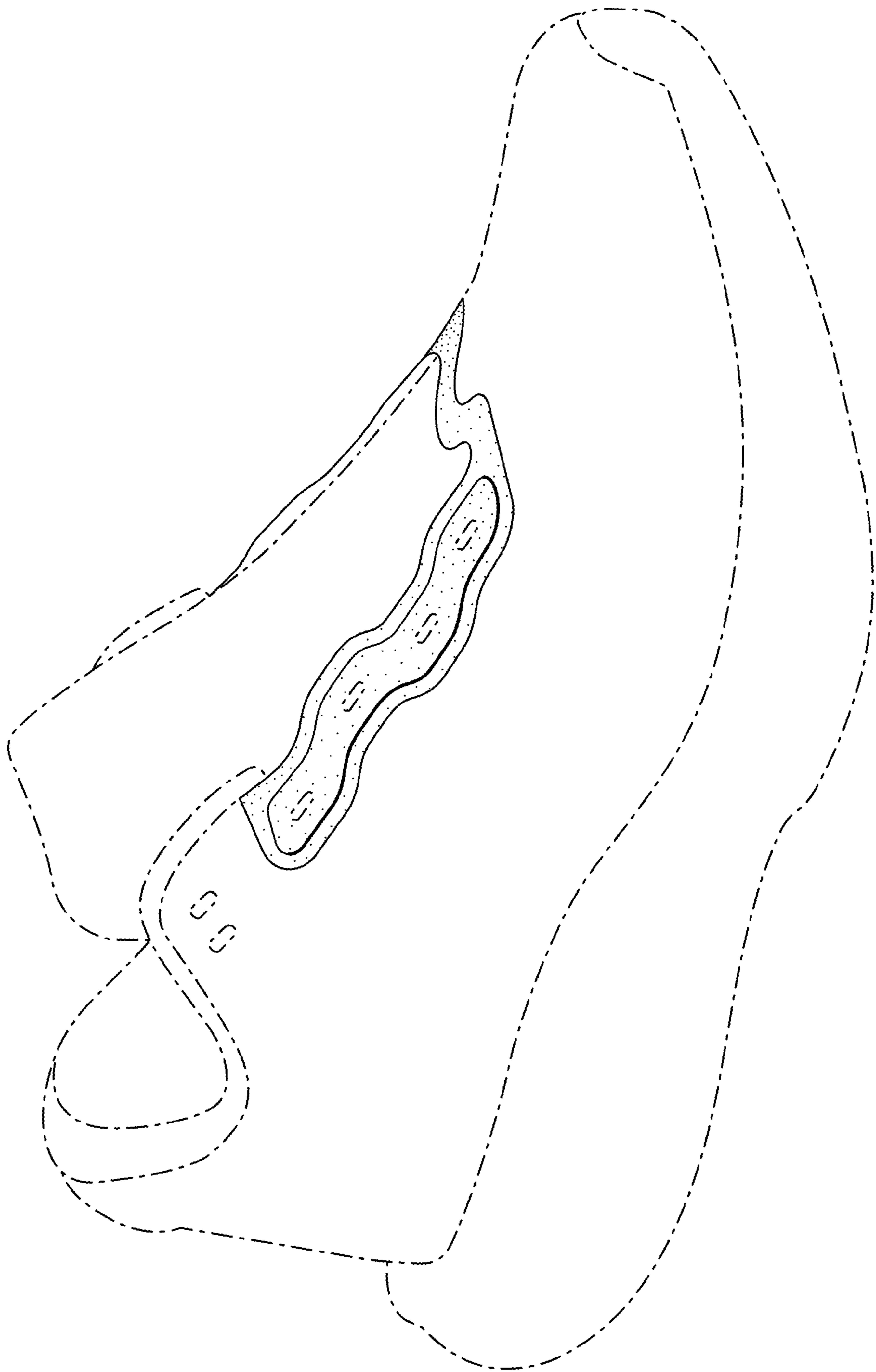

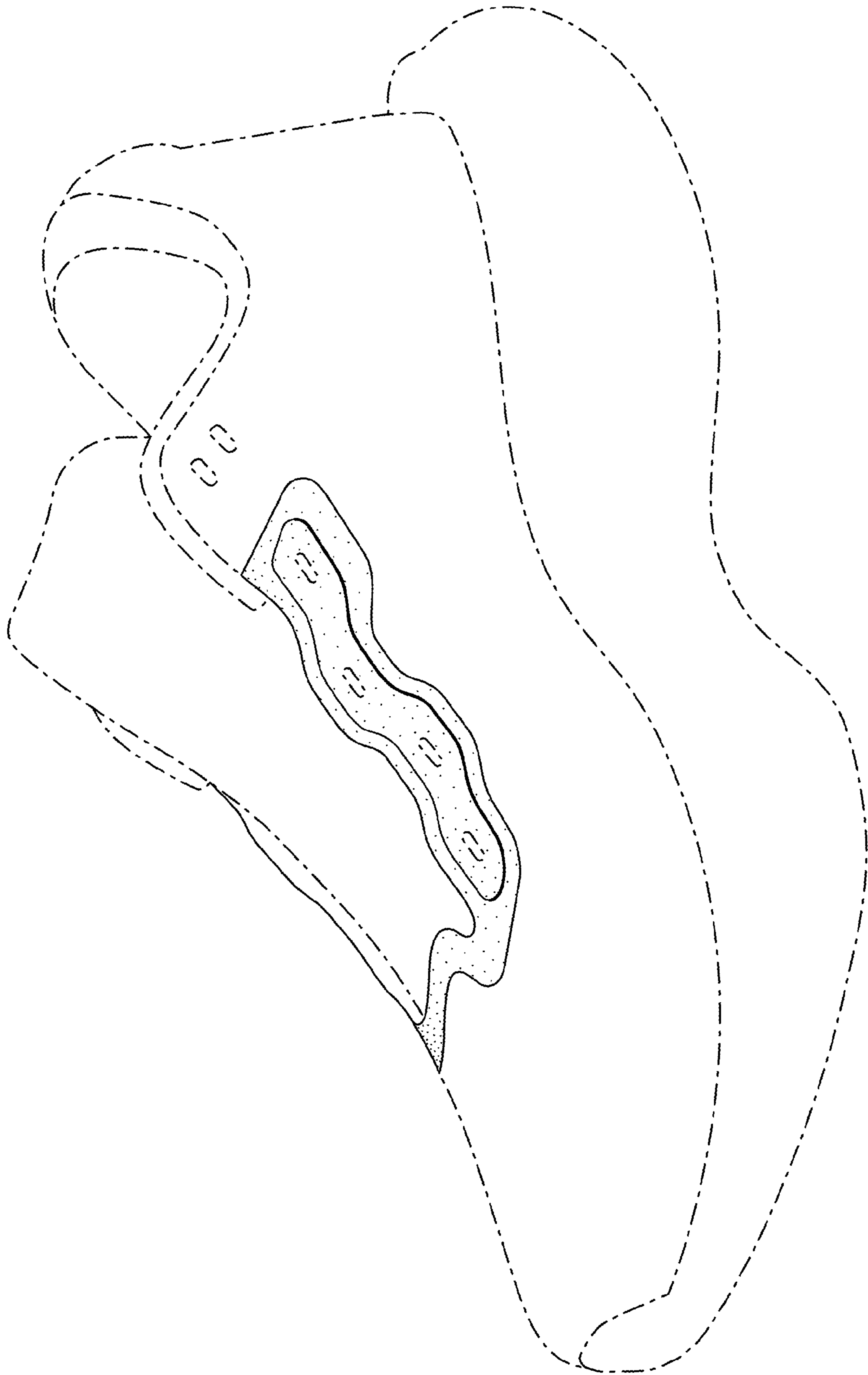

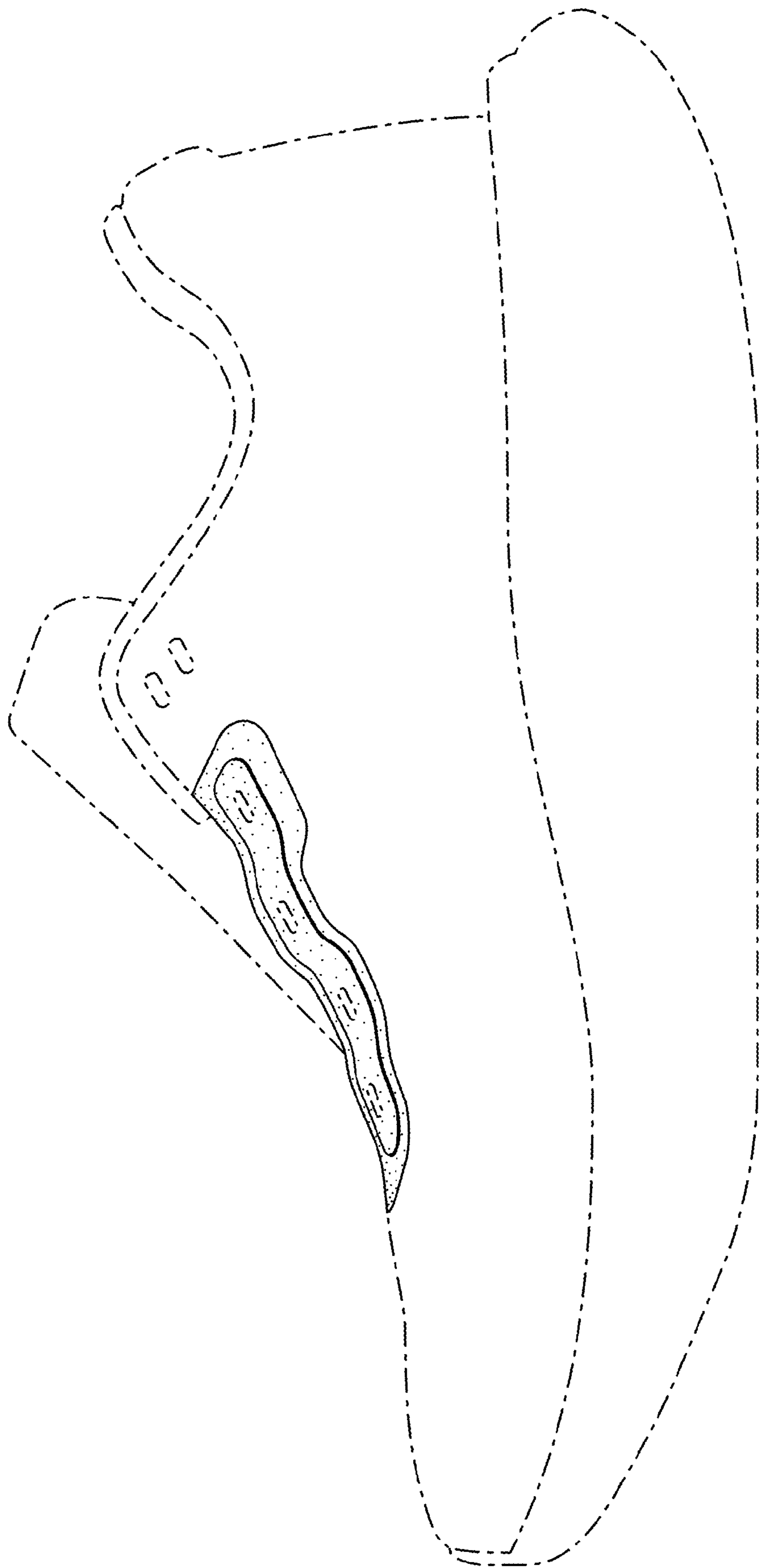
