I claim the ornamental design for a backpack, as shown and described.

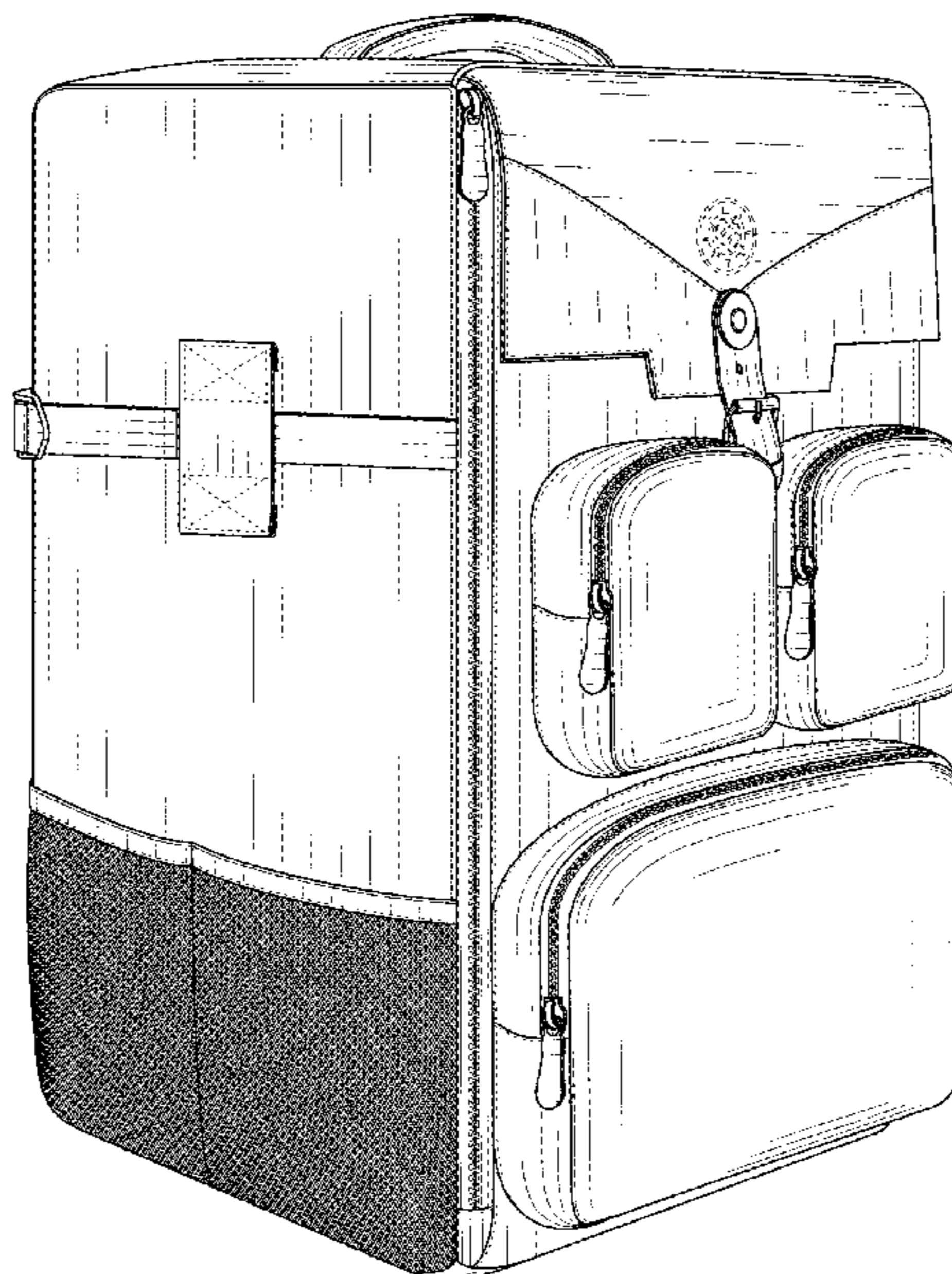
DESCRIPTION

FIG. 1 is a front perspective view of the backpack, showing the new design in a closed position;
 FIG. 2 is a front elevational view of FIG. 1;
 FIG. 3 is a rear elevational view of FIG. 1;
 FIG. 4 is a left-side elevational view of FIG. 1;
 FIG. 5 is a right-side elevational view of FIG. 1;
 FIG. 6 is a top plan view of FIG. 1;
 FIG. 7 is a bottom plan view of FIG. 1;
 FIG. 8 is a perspective view thereof, illustrated in an open position; and,
 FIG. 9 is a rear perspective view of FIG. 1.
 The broken lines representing a logo in the FIGS. 1 and 2, circular hardware in FIG. 6, and internal portions of the backpack in FIG. 8 depict portions of the article and form no part of the claimed design. The remaining broken lines represent stitching and do form part of the claimed design.

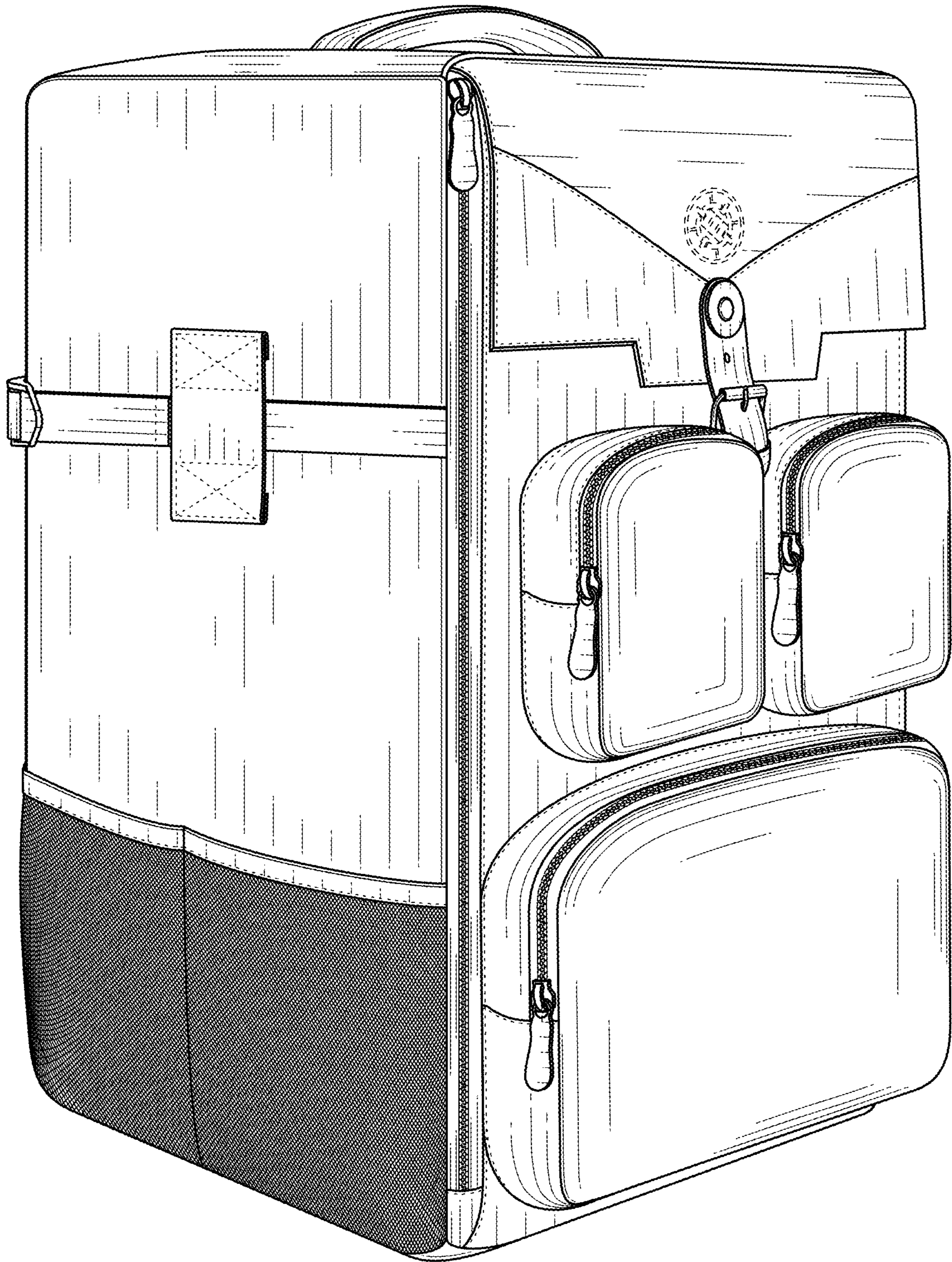

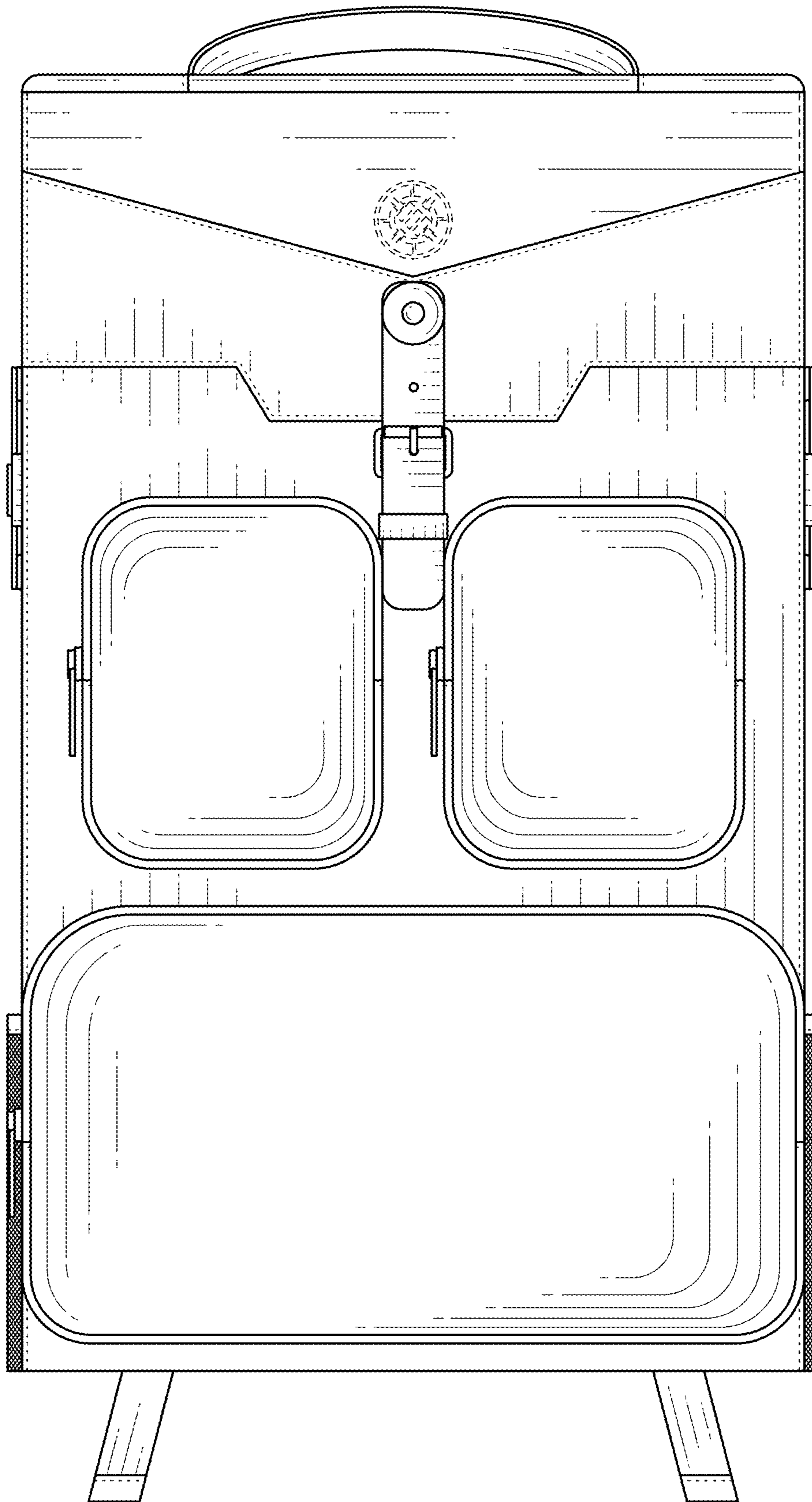

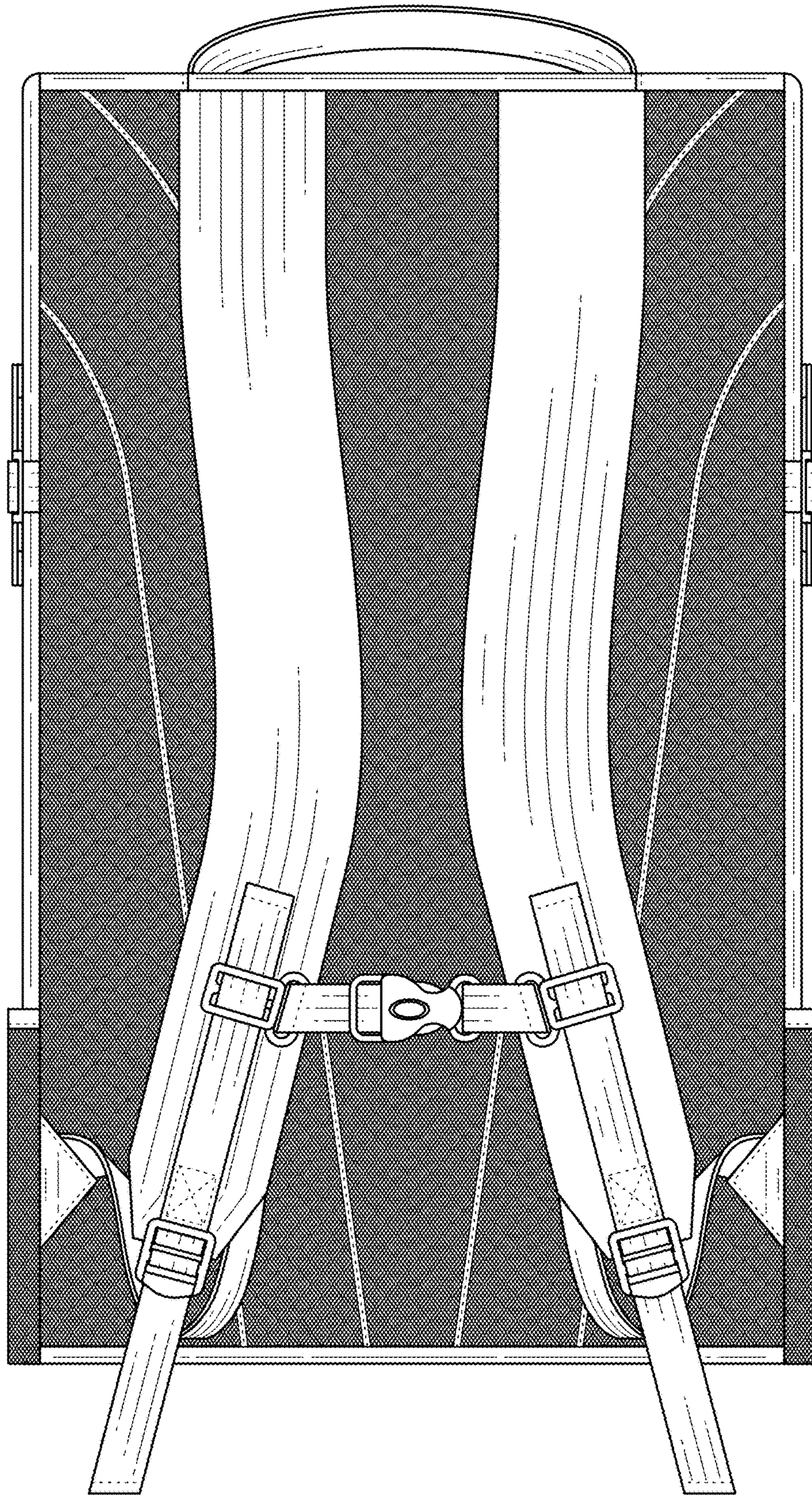

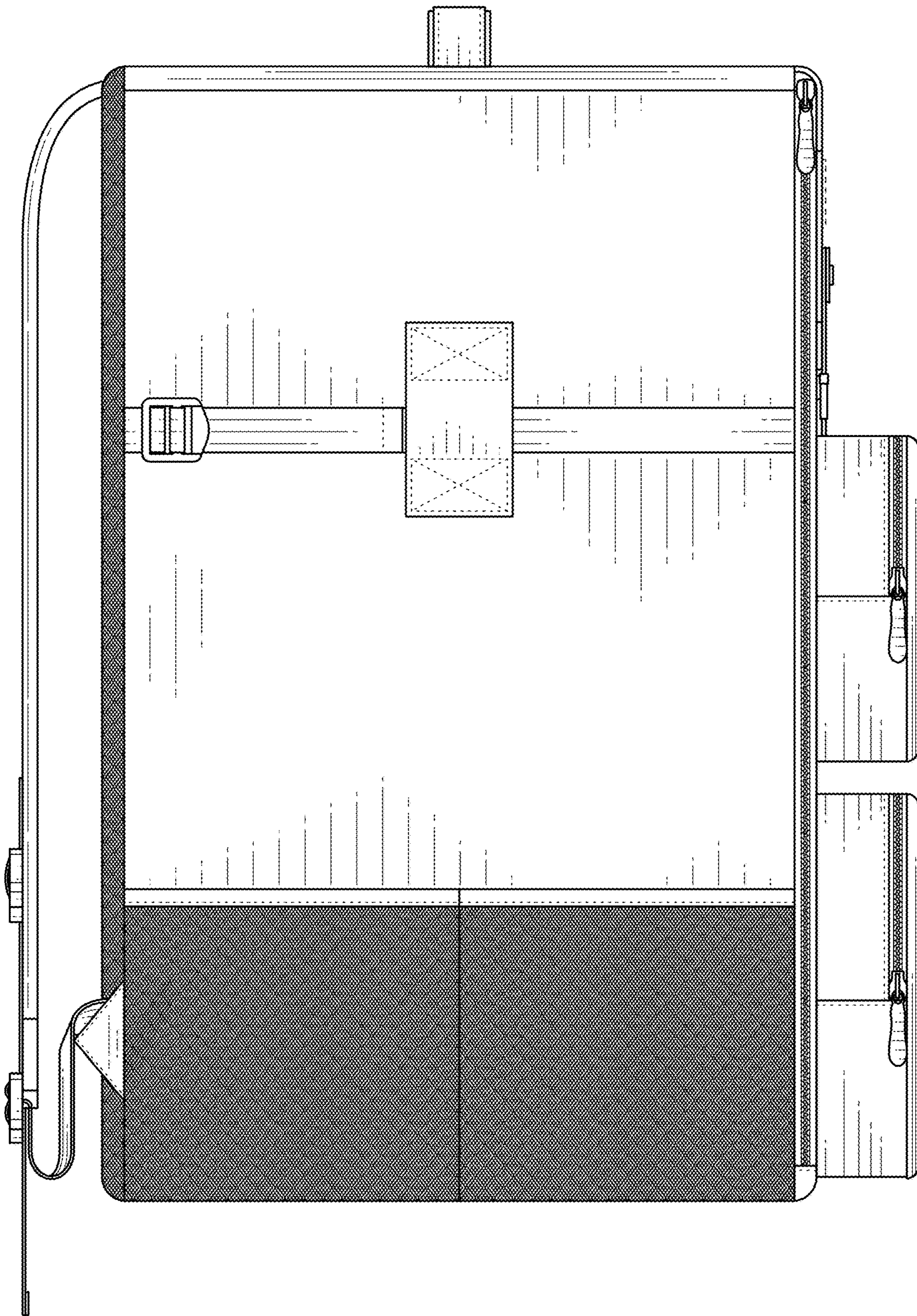

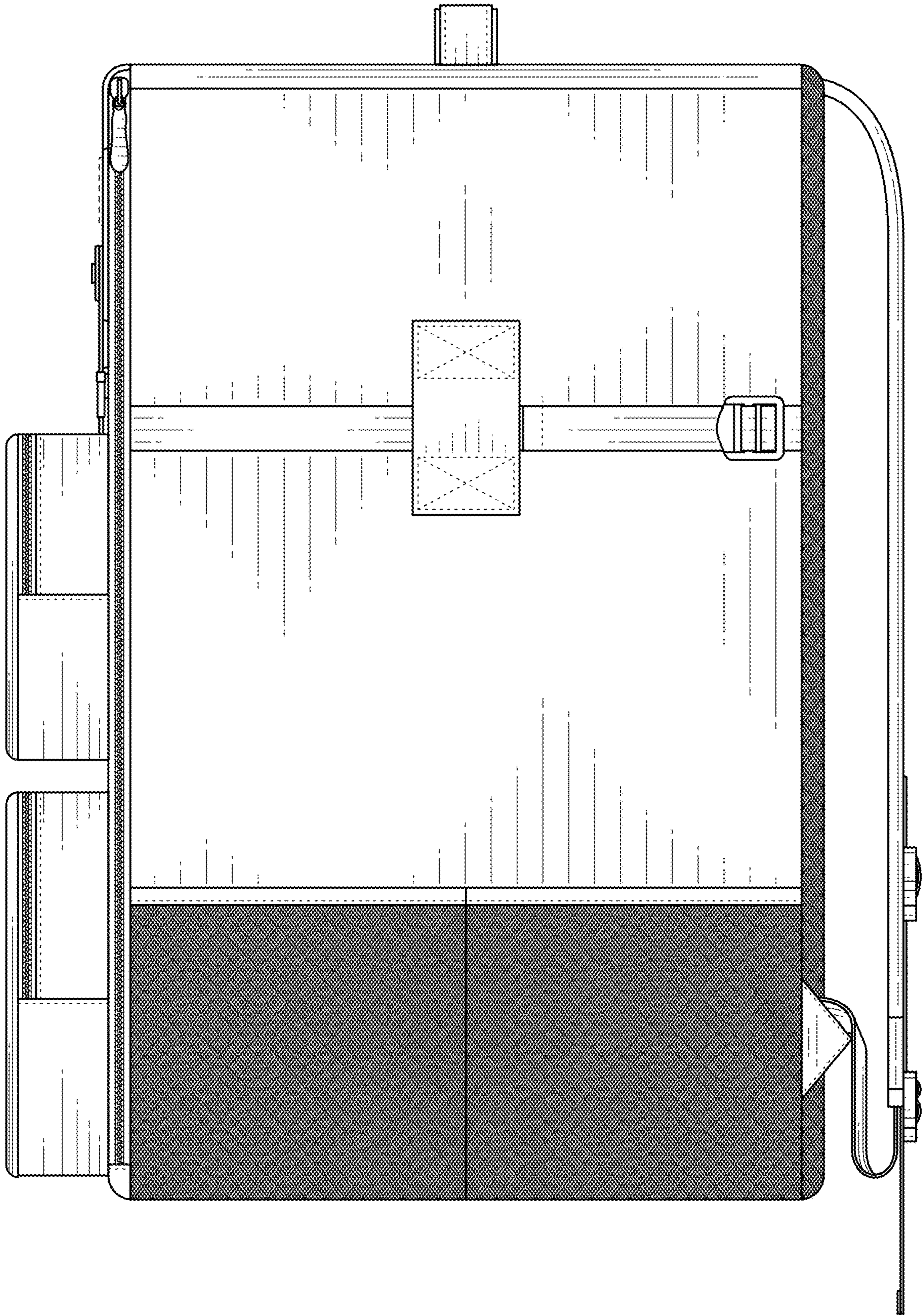

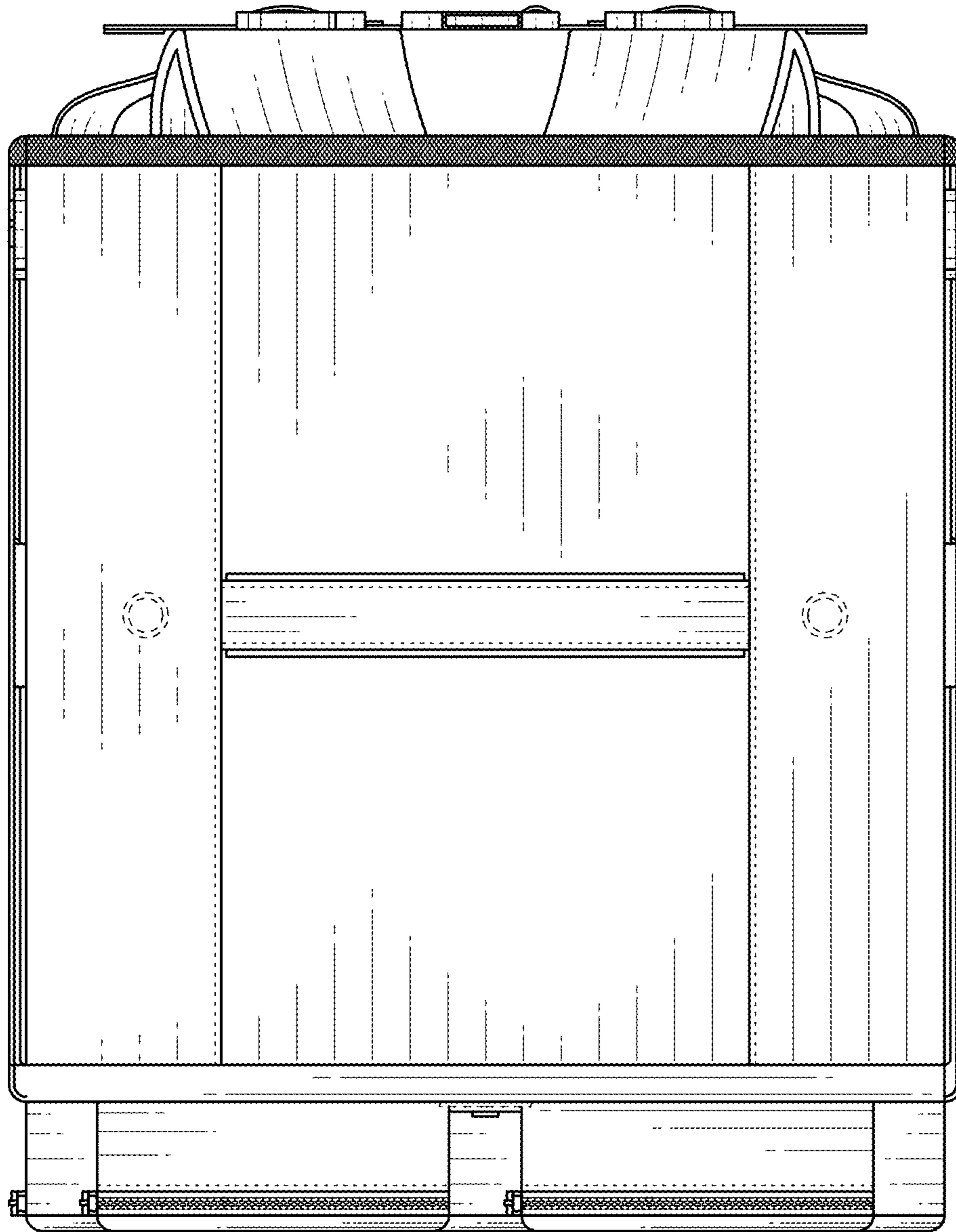

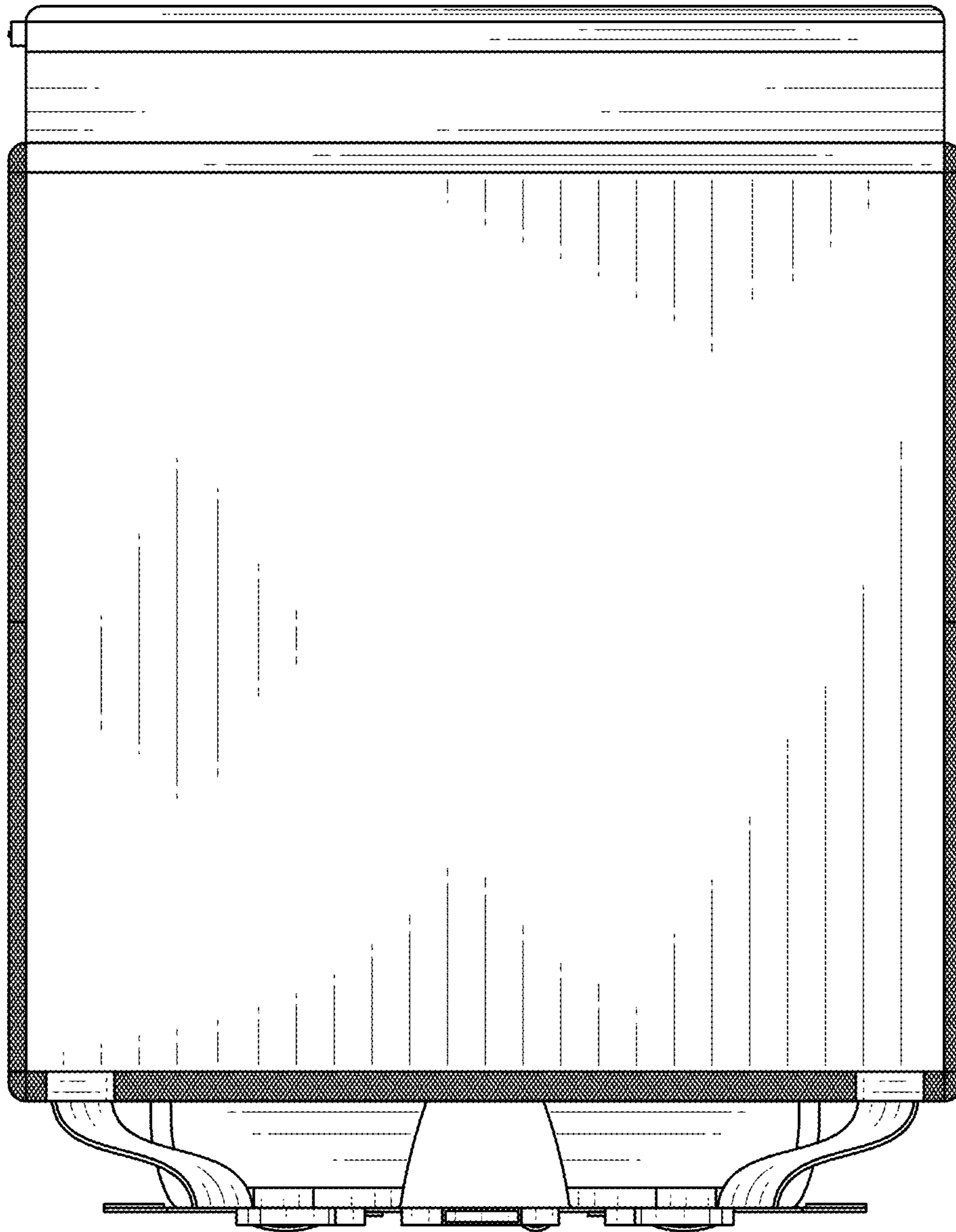

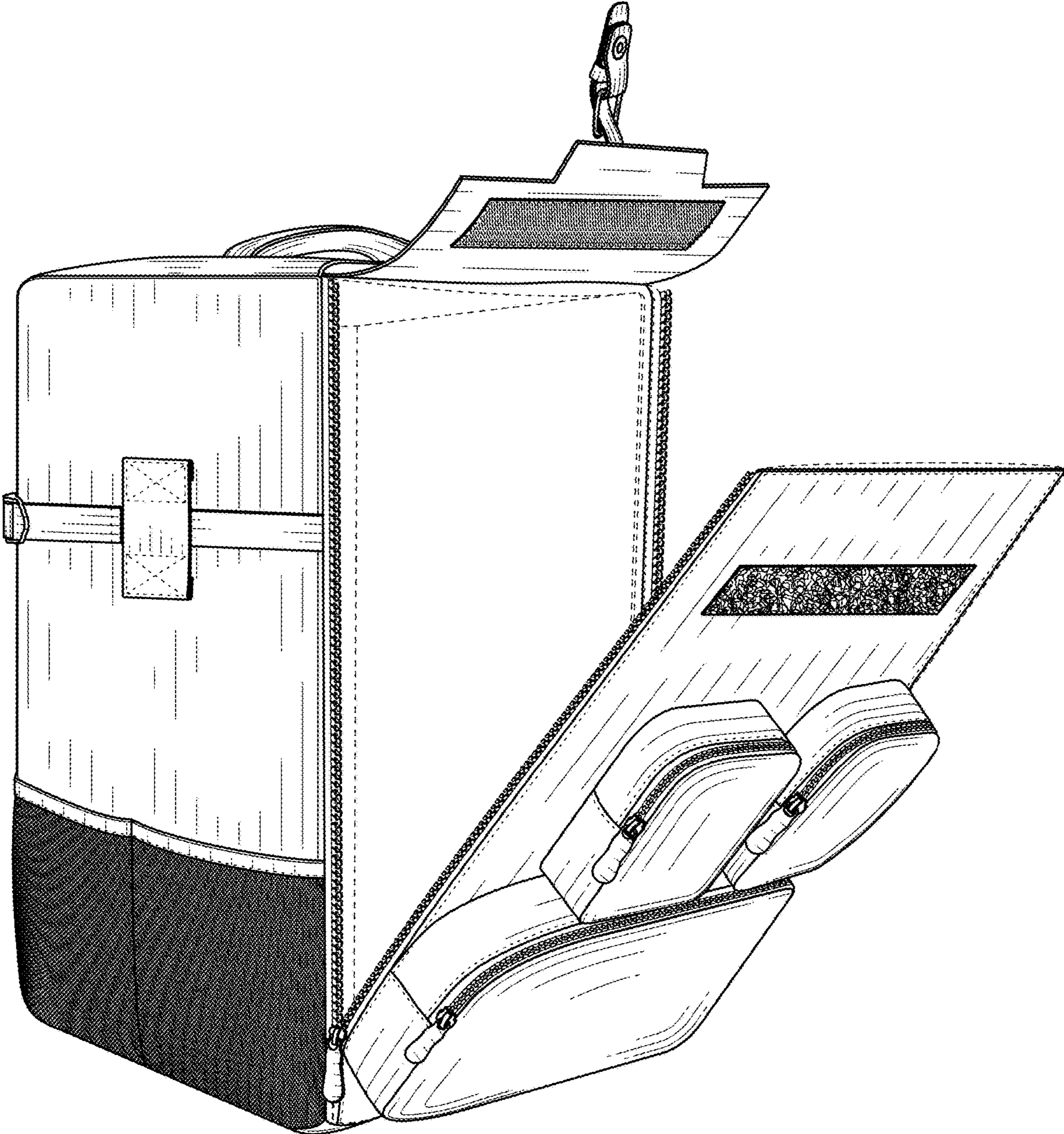
