(57) **CLAIM**

I claim the ornamental design for a dispenser, as shown and described.

**DESCRIPTION**

The single FIGURE is a front/left/top perspective view of a dispenser (a front/right/top perspective view would be a mirror image thereof). The broken lines immediately adjacent to the shaded areas in the FIGURE represent the boundaries of the claimed design. The broken lines in the FIGURE illustrate the portions of the design that form no part of the claimed design. None of the broken lines form any part of the claimed design.
