(57) **CLAIM**

The ornamental design for a splash guard for a beverage dispenser holster, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a splash guard according to our invention;

FIG. 2 is a top view of the splash guard of FIG. 1;

FIG. 3 is a bottom view of the splash guard of FIG. 1;

FIG. 4 is a front plan view of the splash guard of FIG. 1;

FIG. 5 is a rear plan view of the splash guard of FIG. 1;

FIG. 6 is a right side view of the splash guard of FIG. 1;

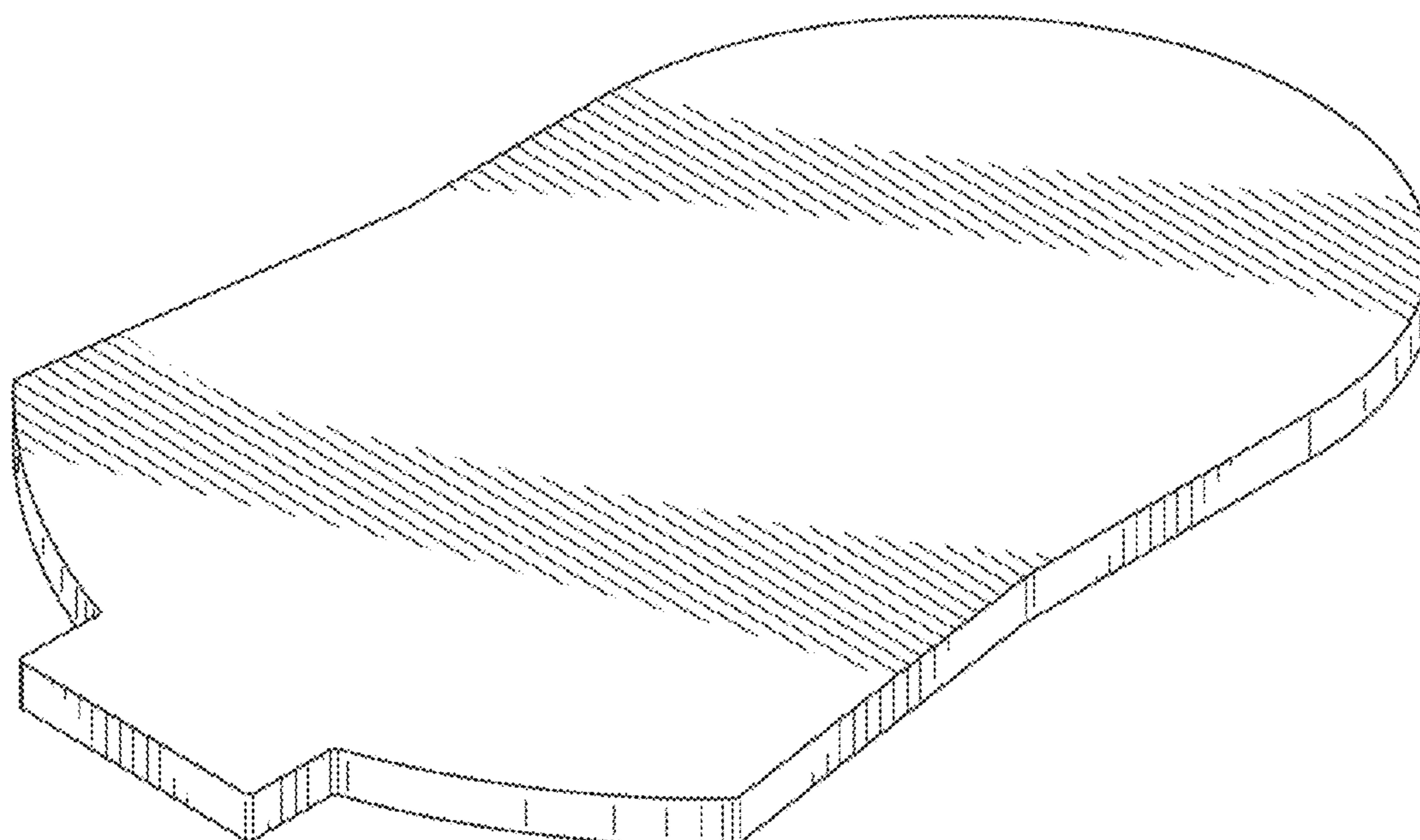
FIG. 7 is a left side view of the splash guard of FIG. 1;

FIG. 8 is a perspective view of the splash guard prior to insertion in a beverage dispenser holster, with the beverage dispenser holster illustrated in broken lines to show environmental features; and,

FIG. 9 is a perspective view of the splash guard inserted in the beverage dispenser holster, with the beverage dispenser holster illustrated in broken lines to show environmental features.

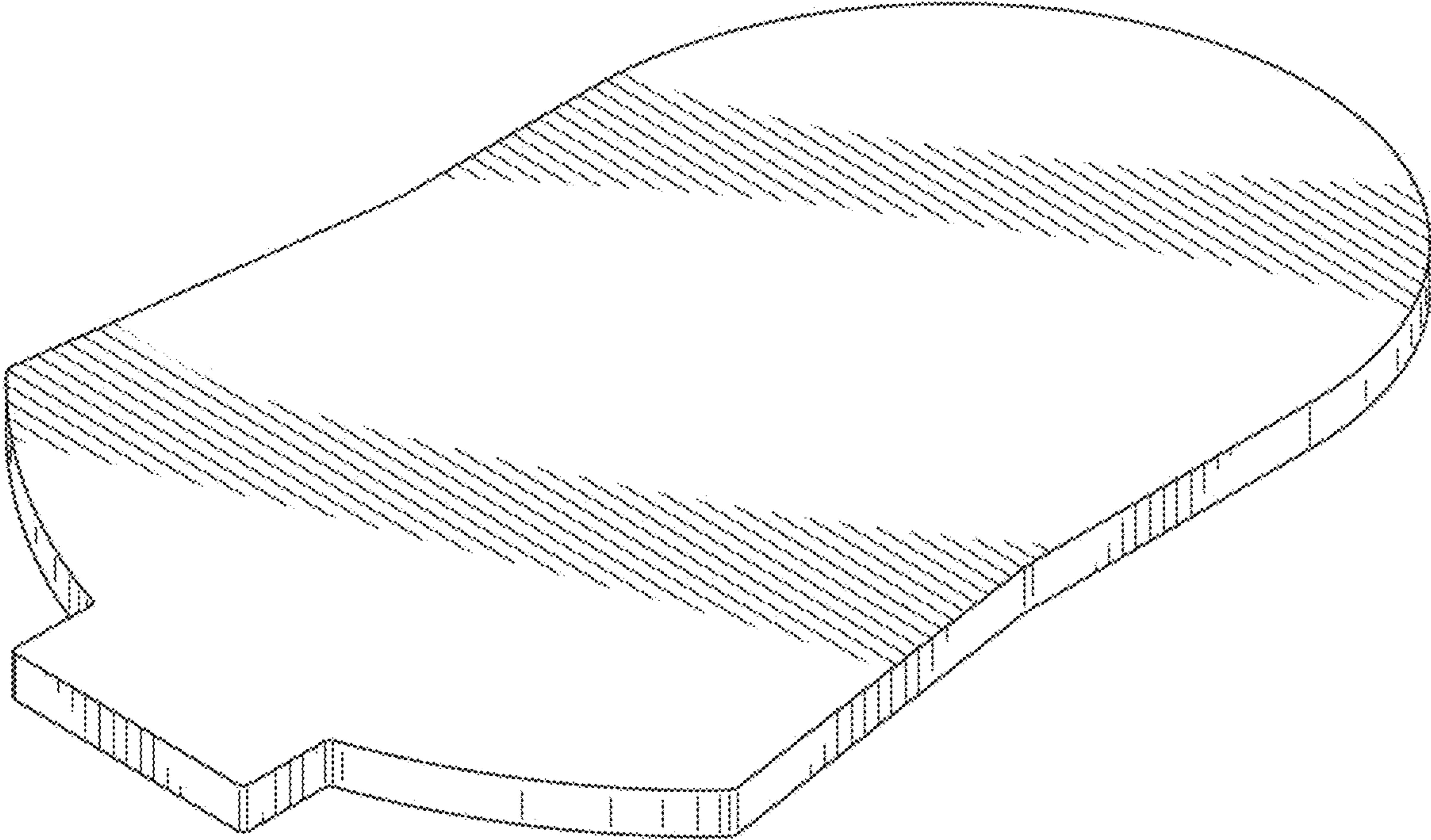

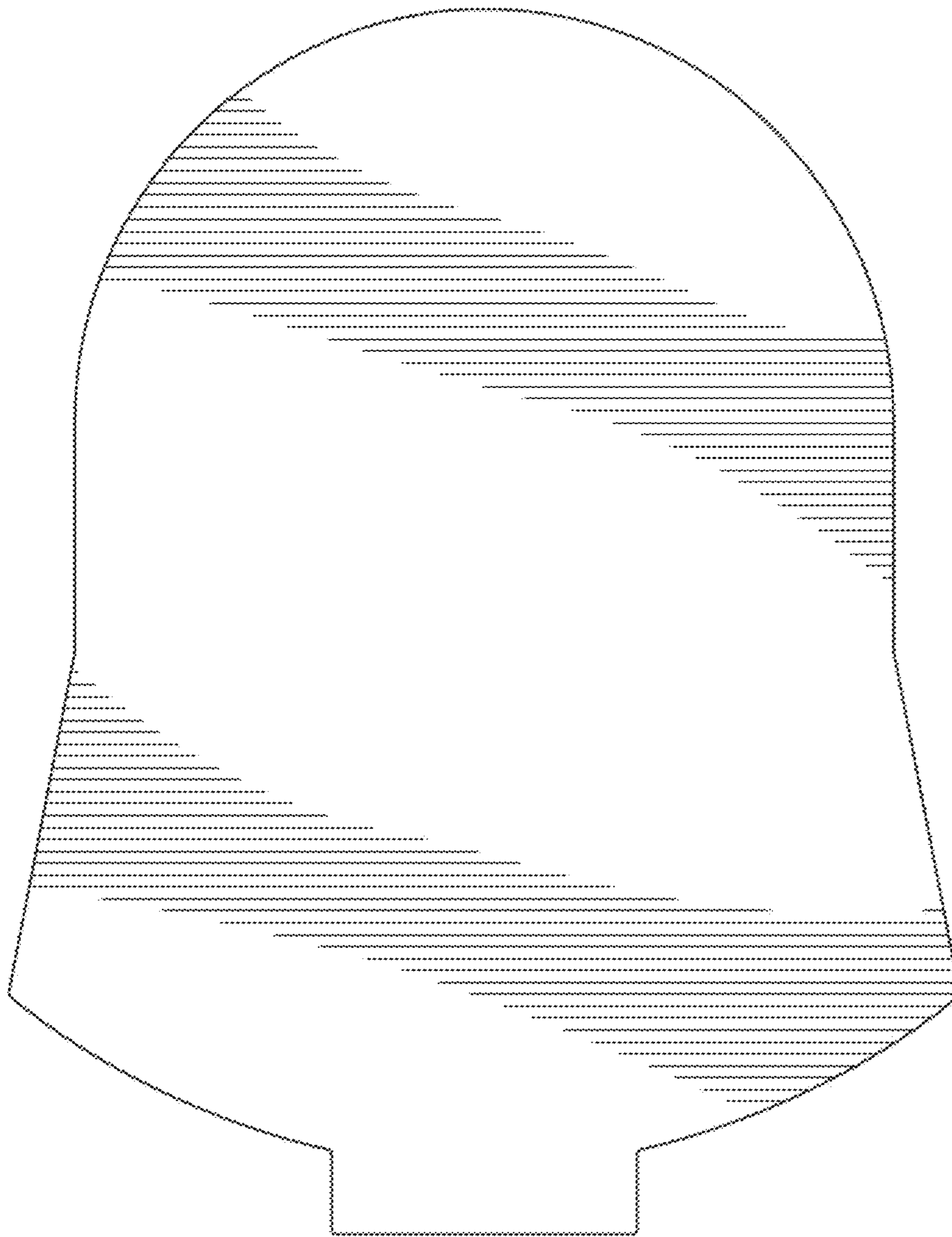

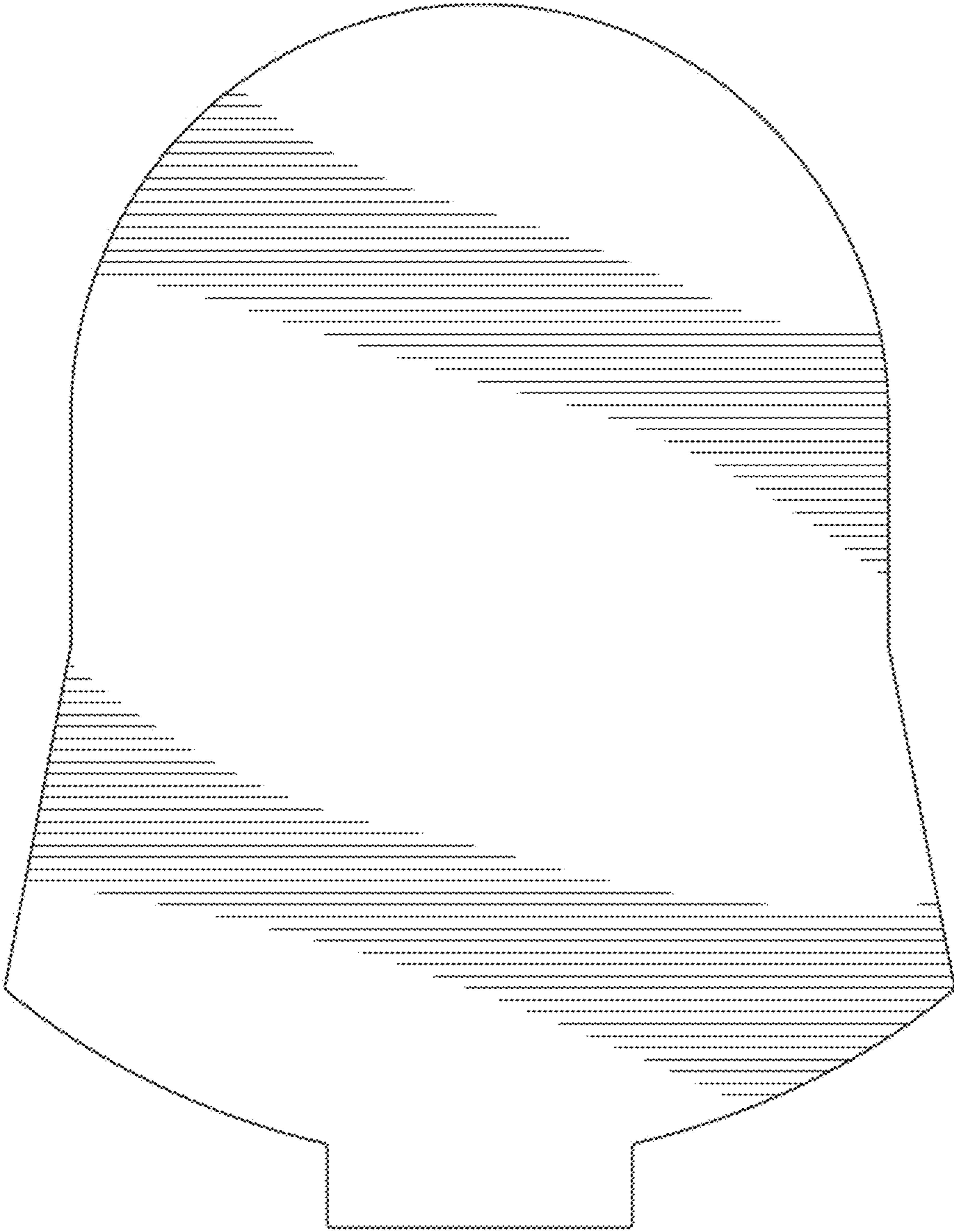

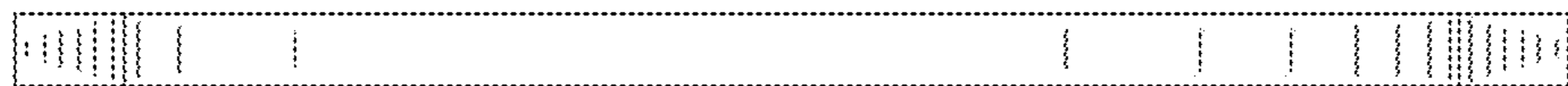

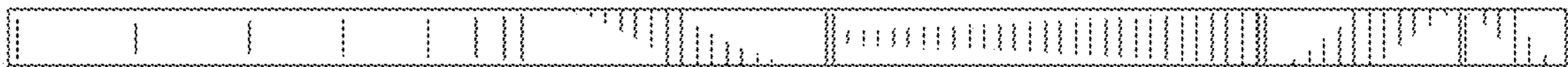

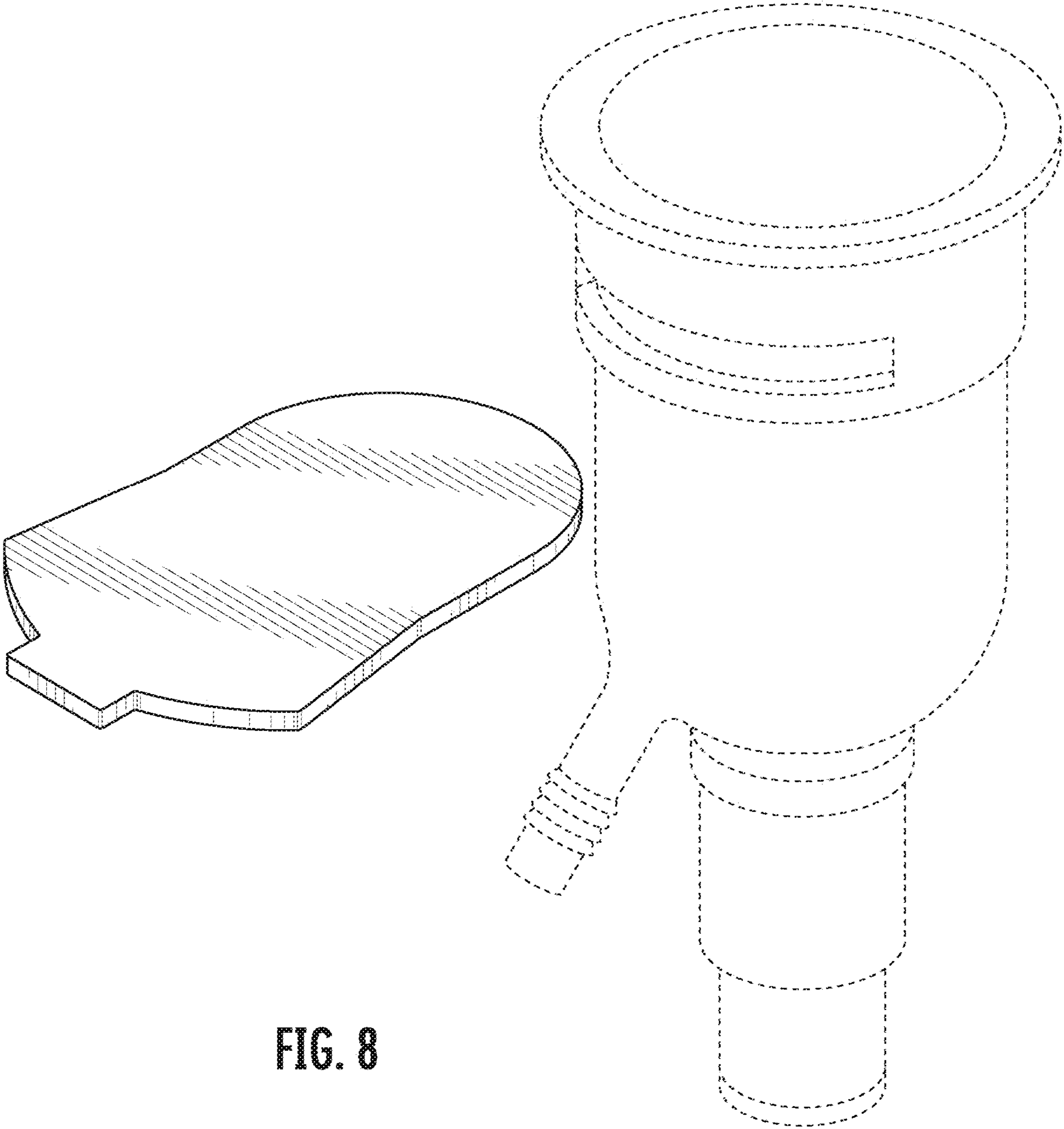

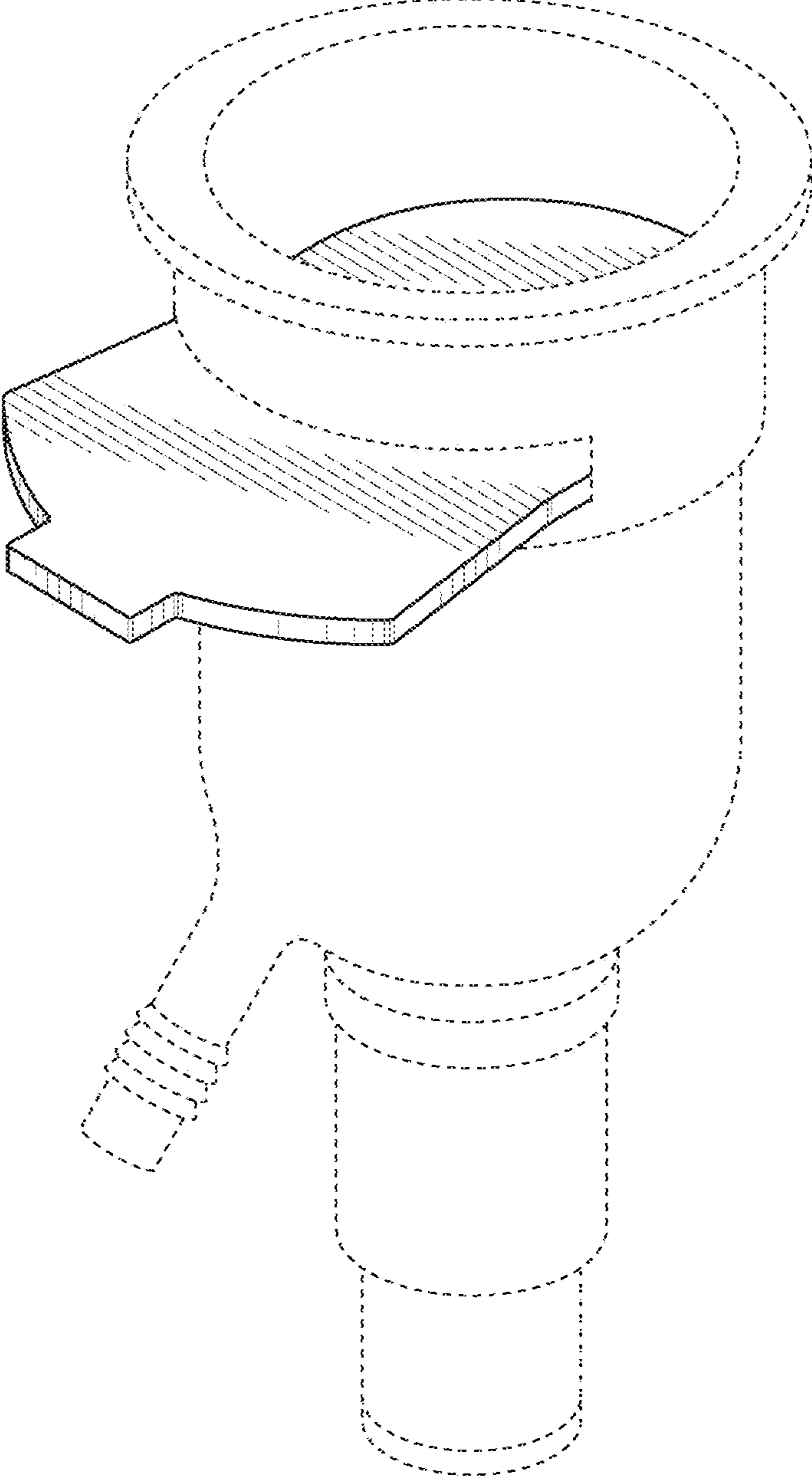
