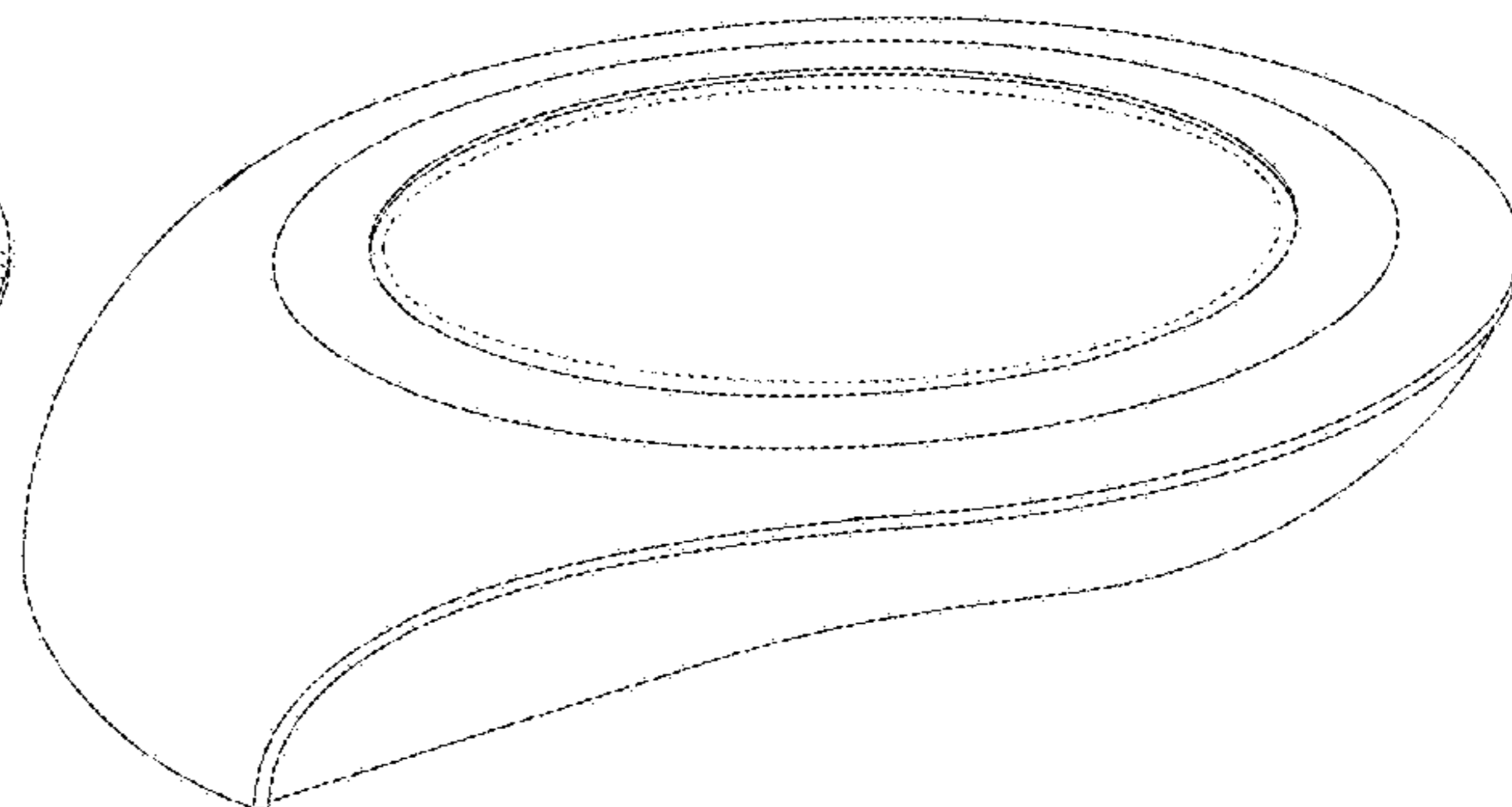
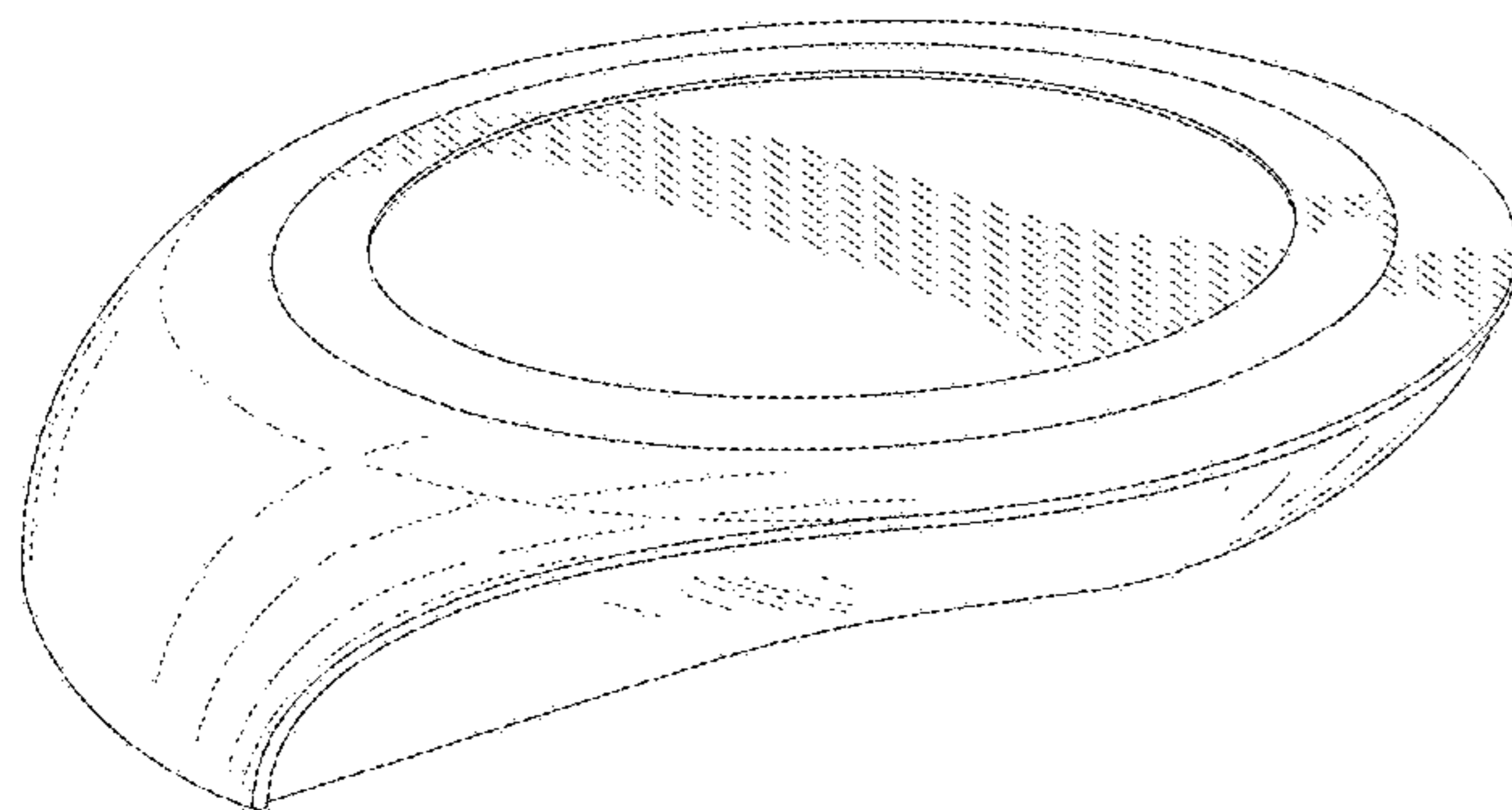
FIG. 1 is a top perspective view of a first embodiment of a wine decanter pedestal;

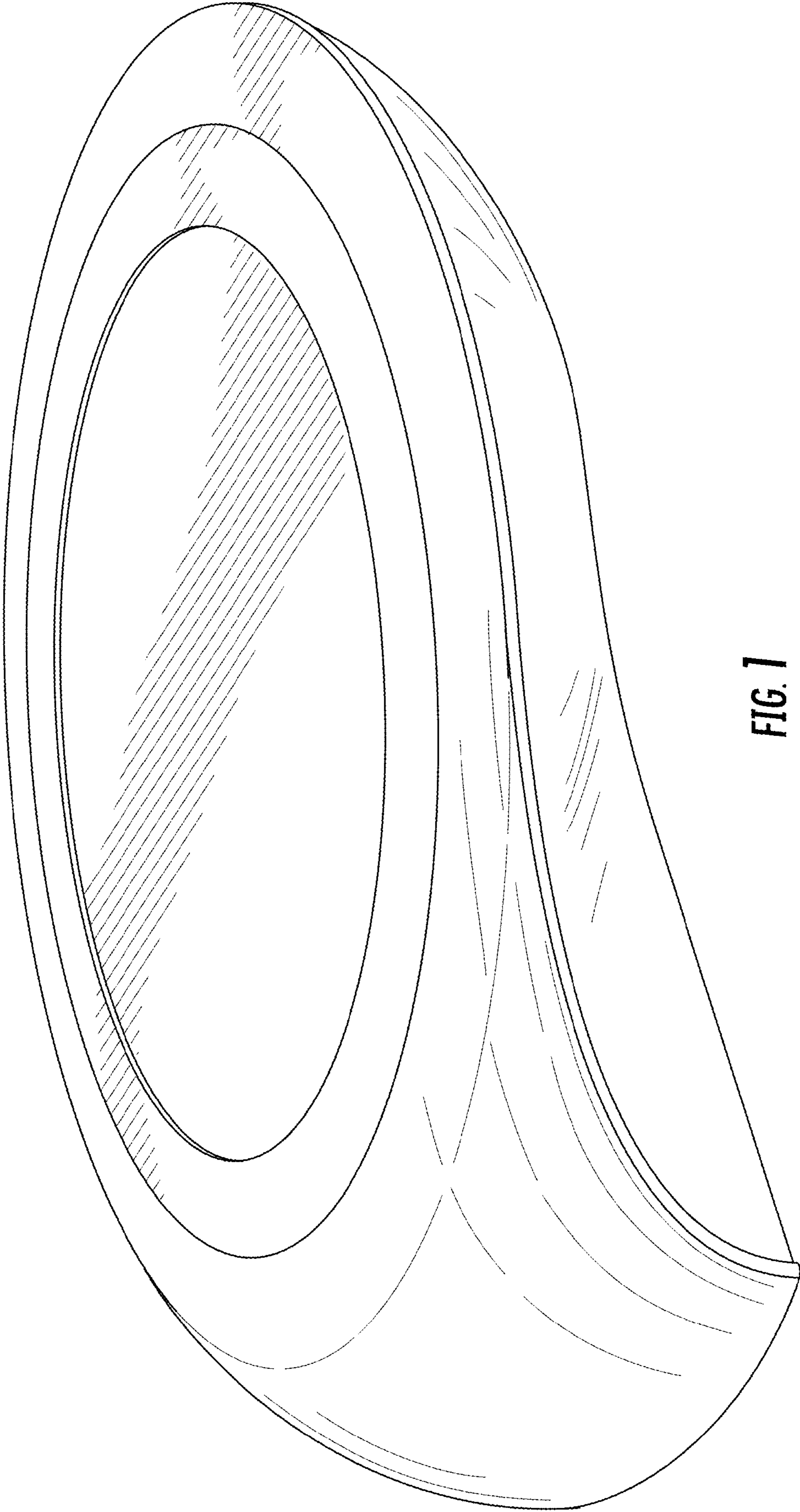

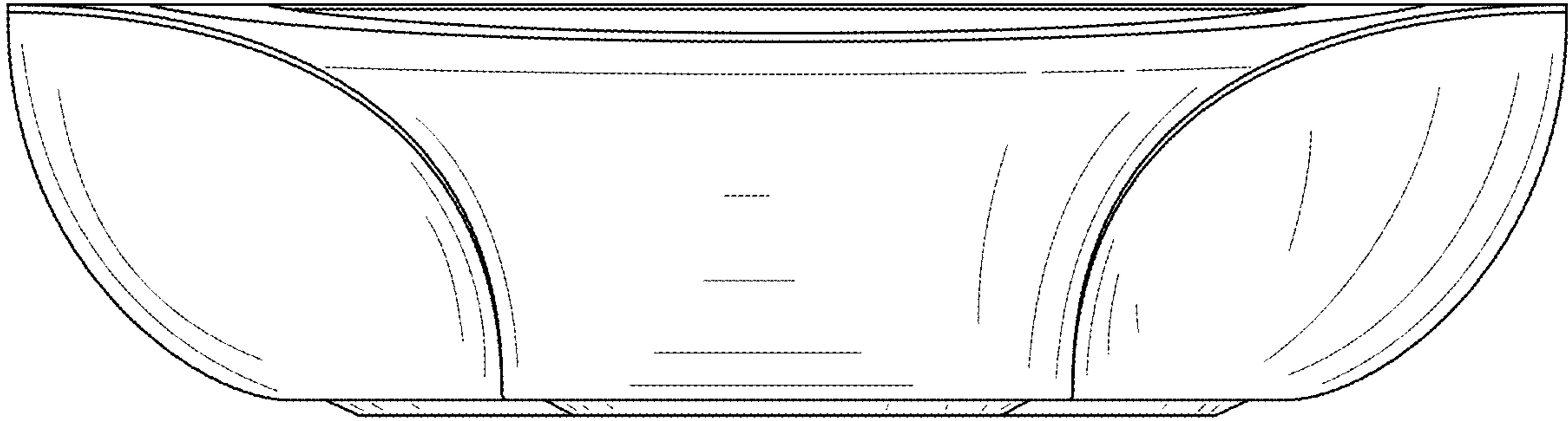

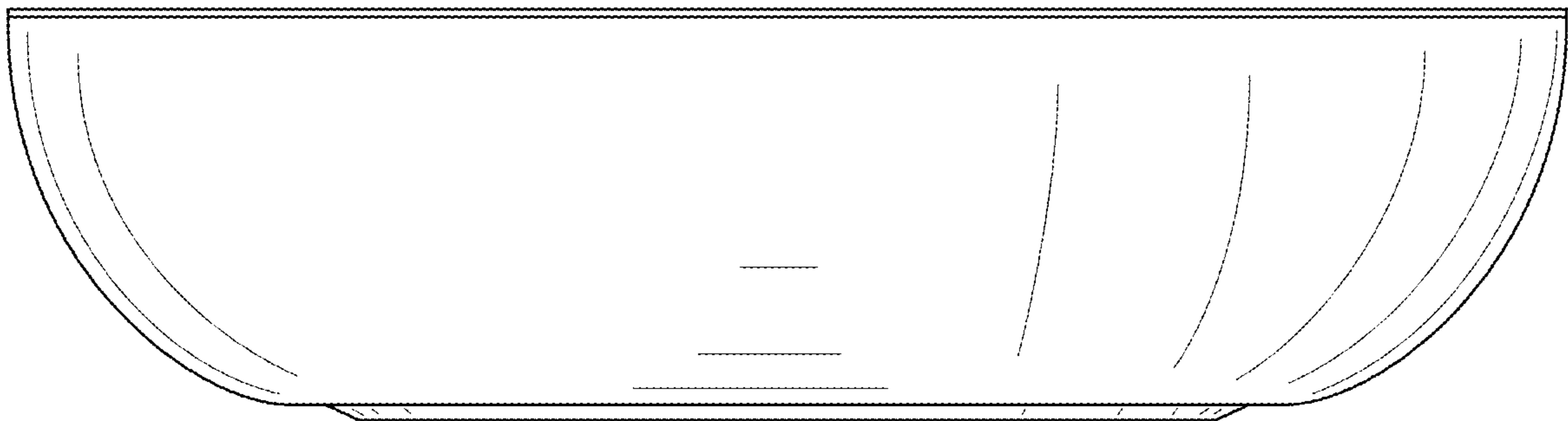

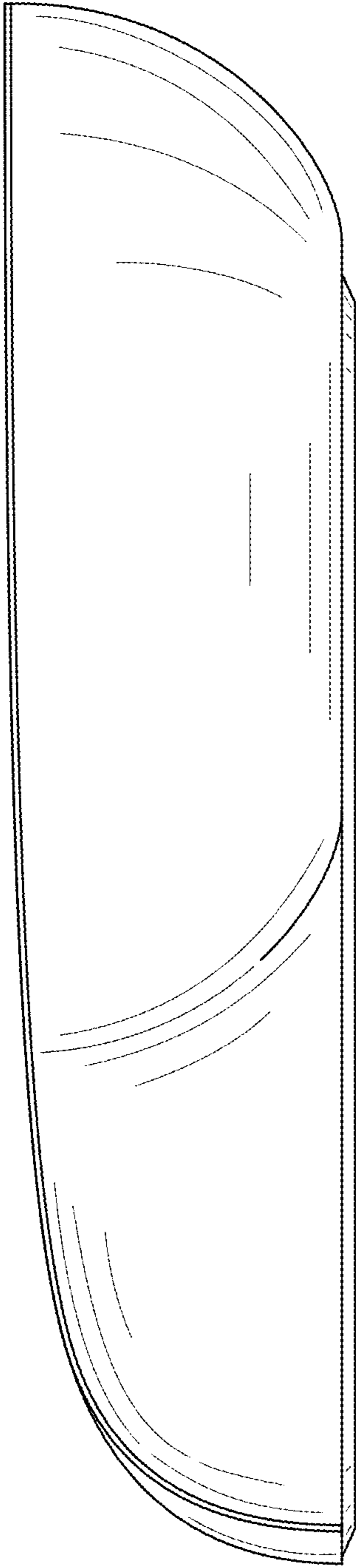

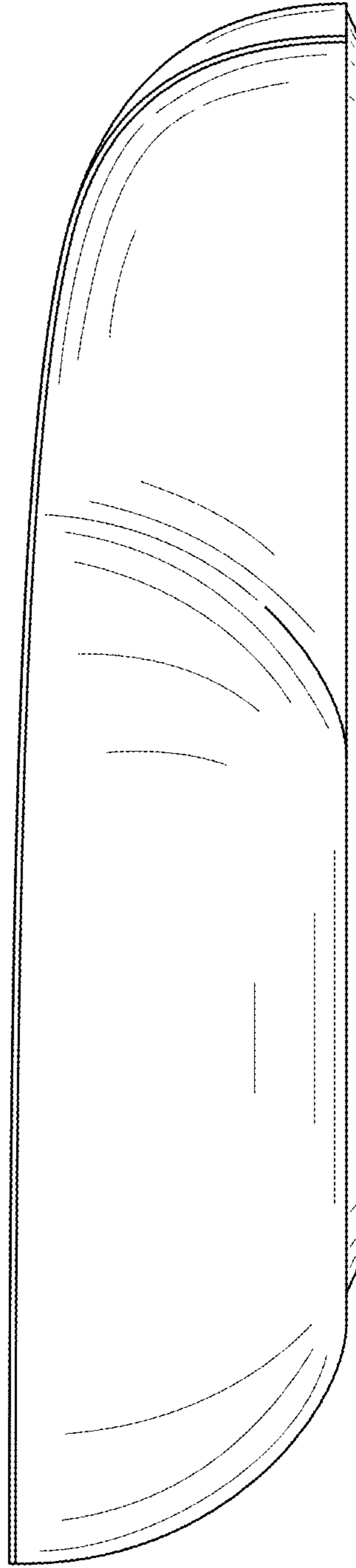

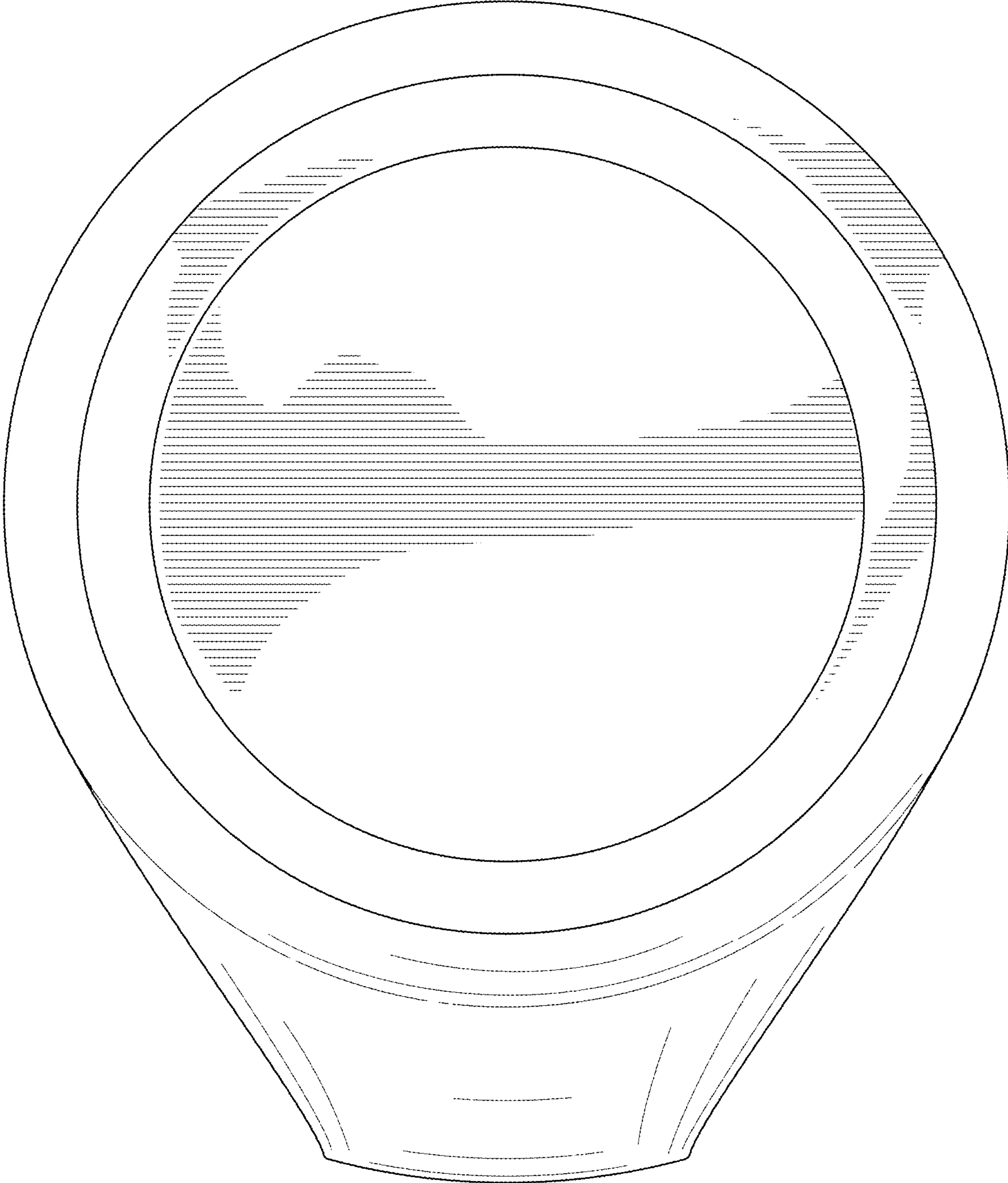

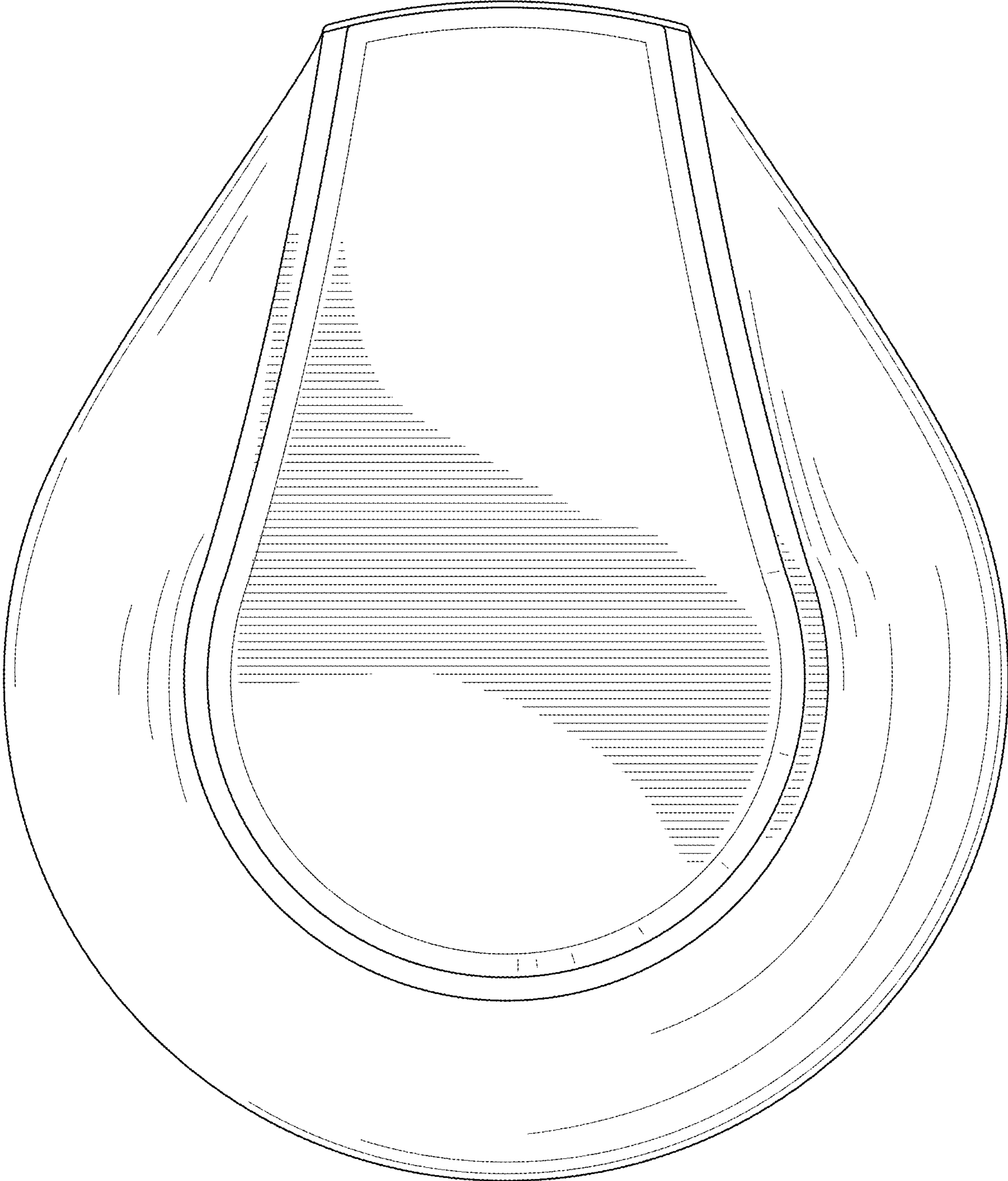

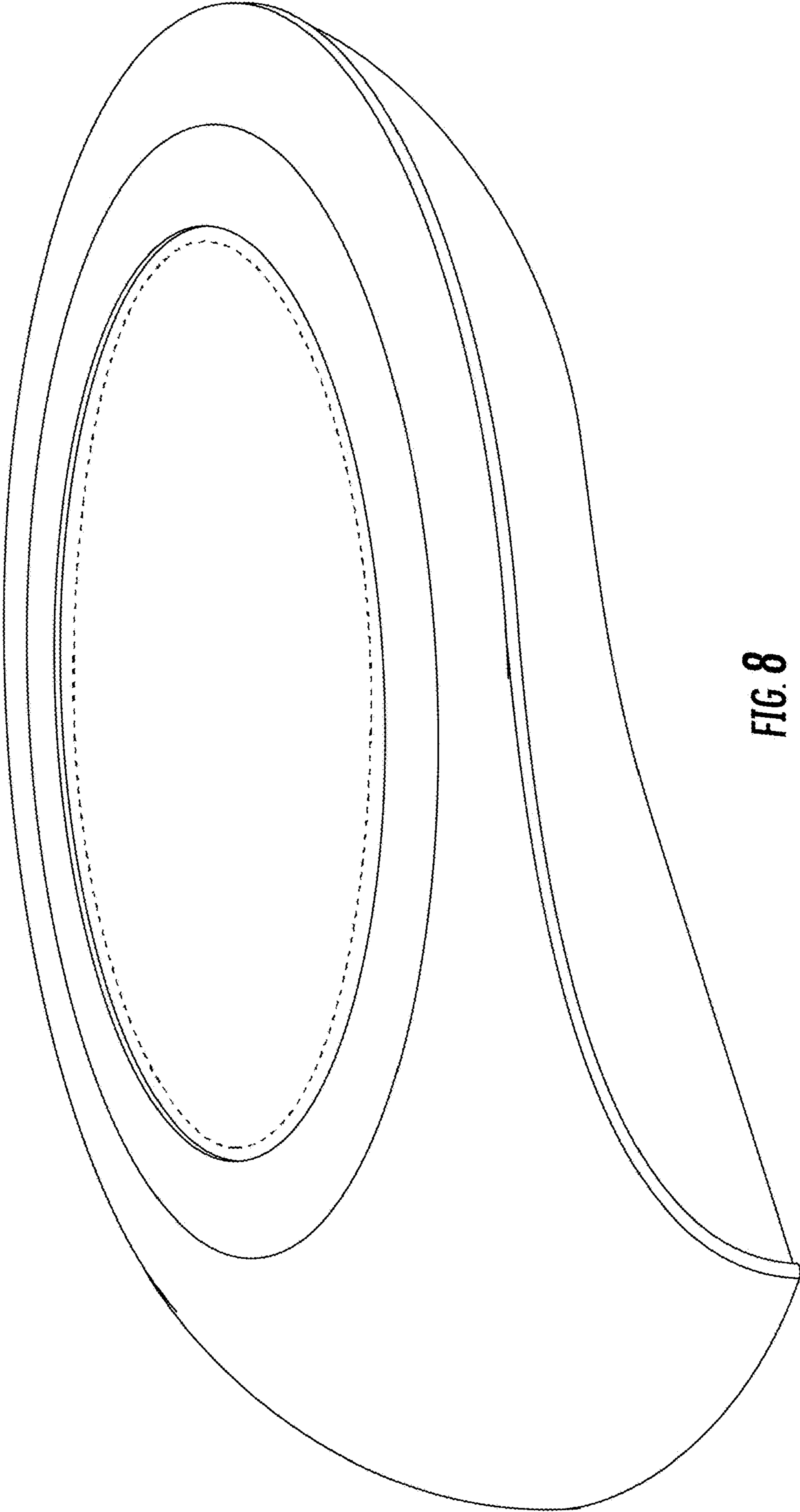

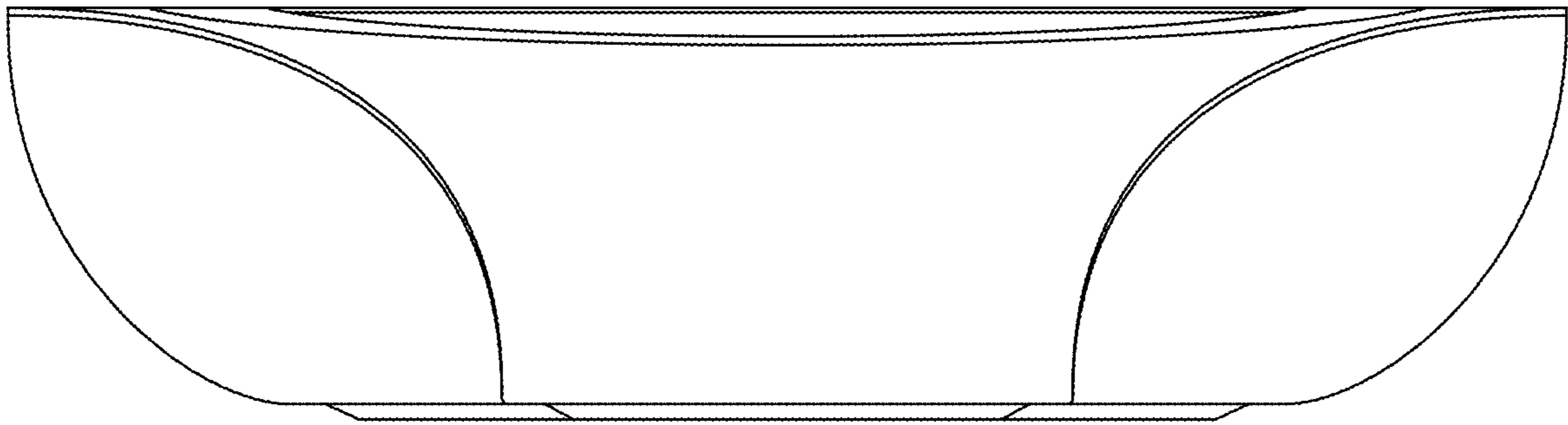

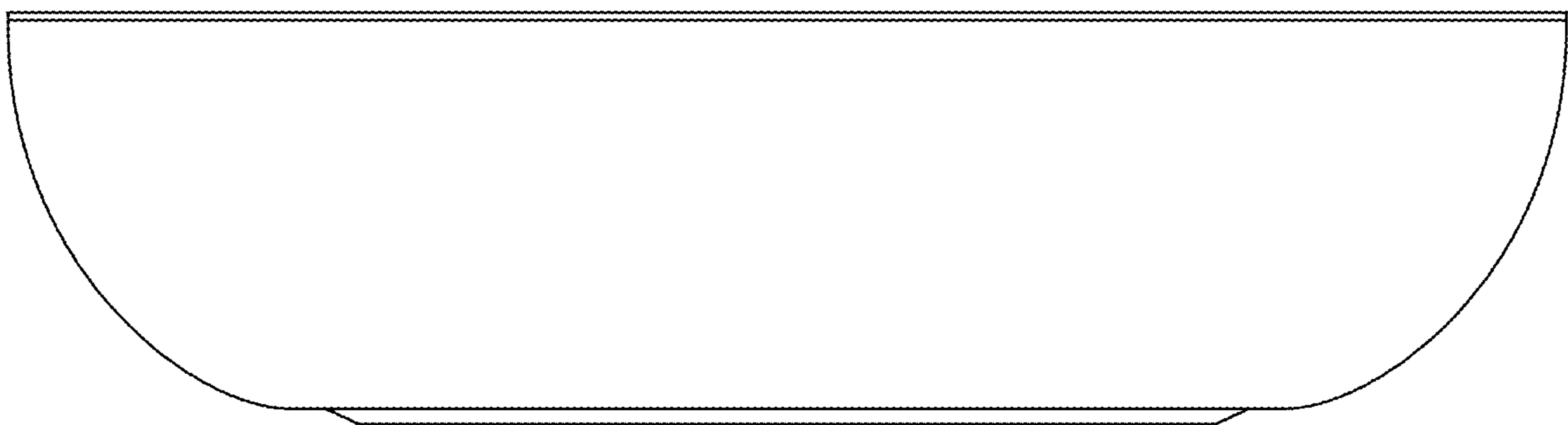

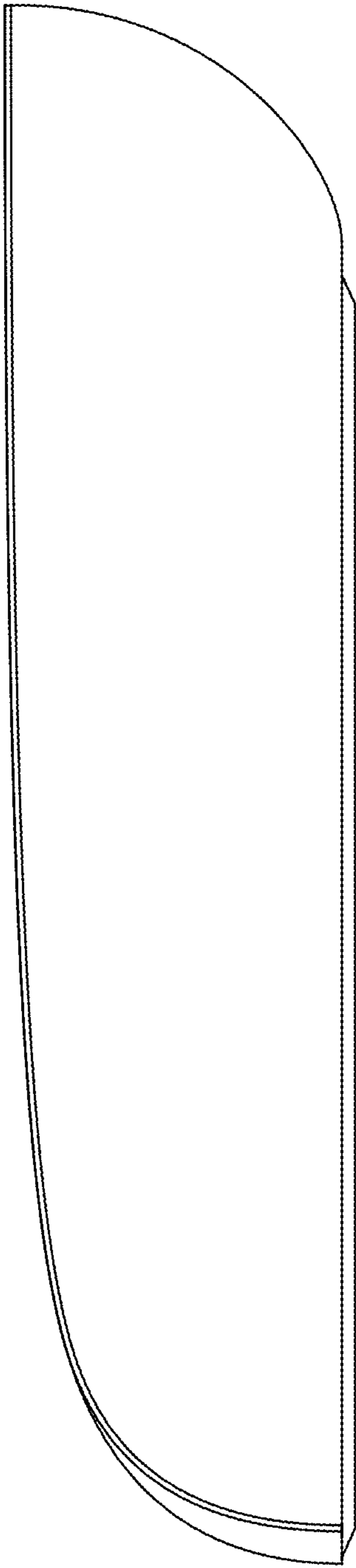

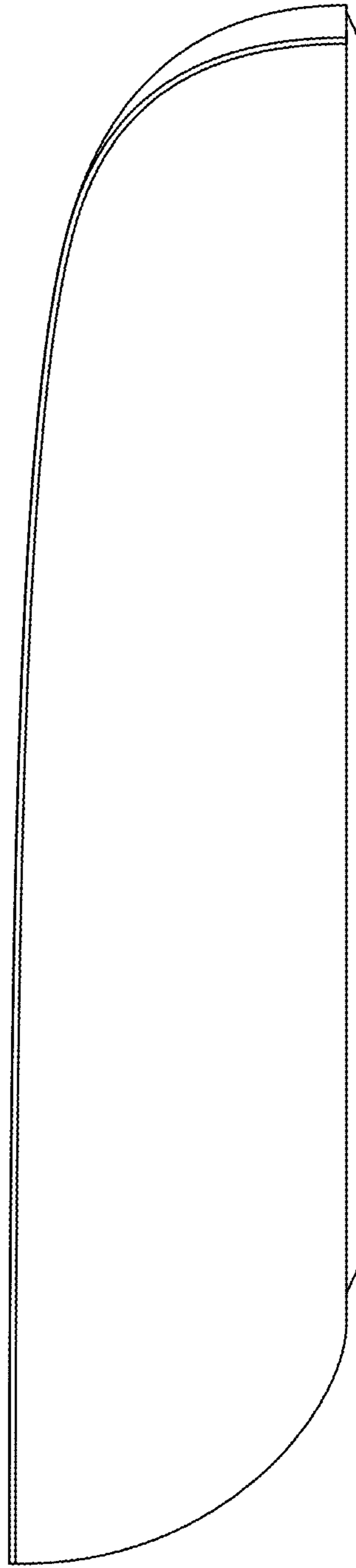

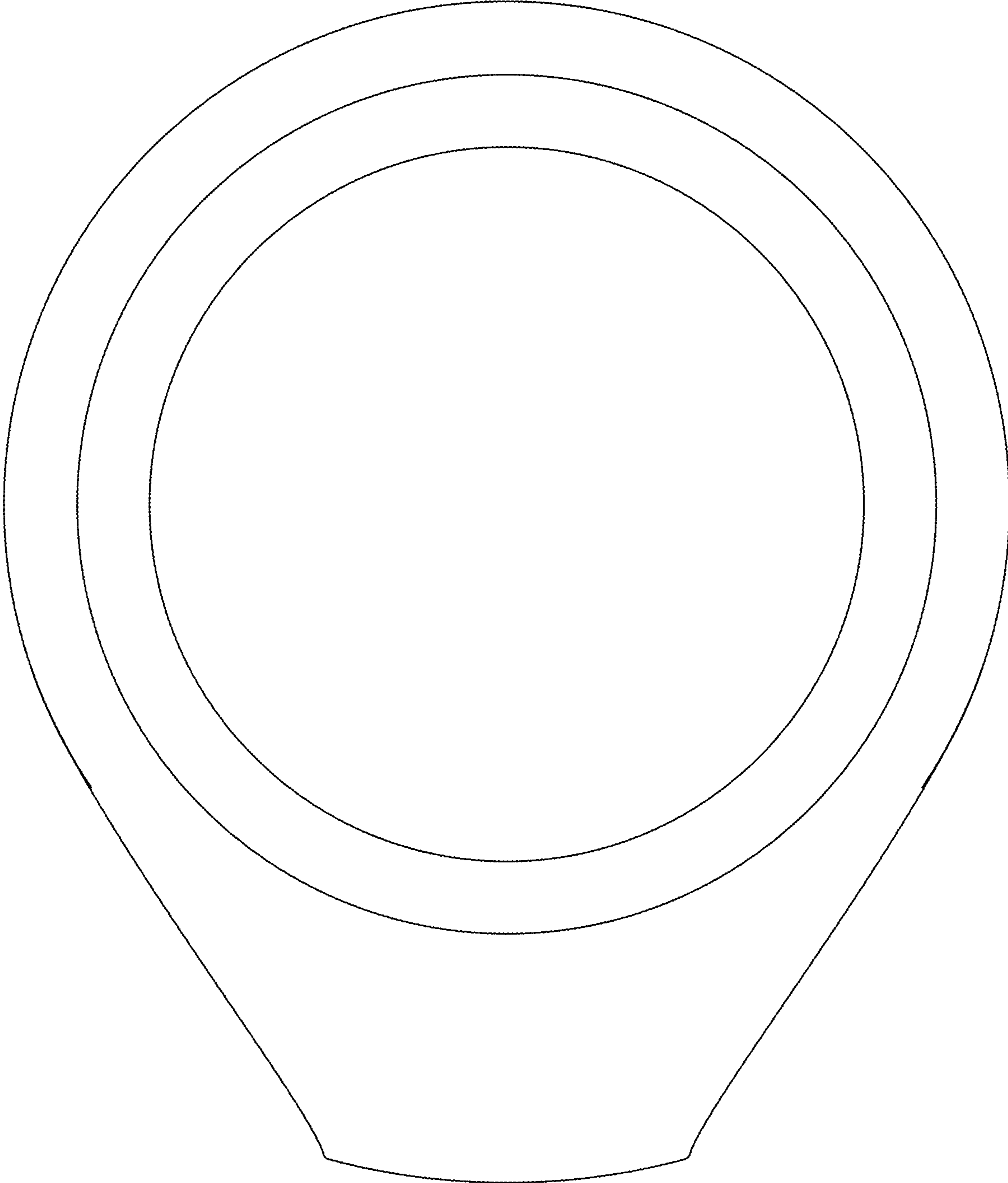

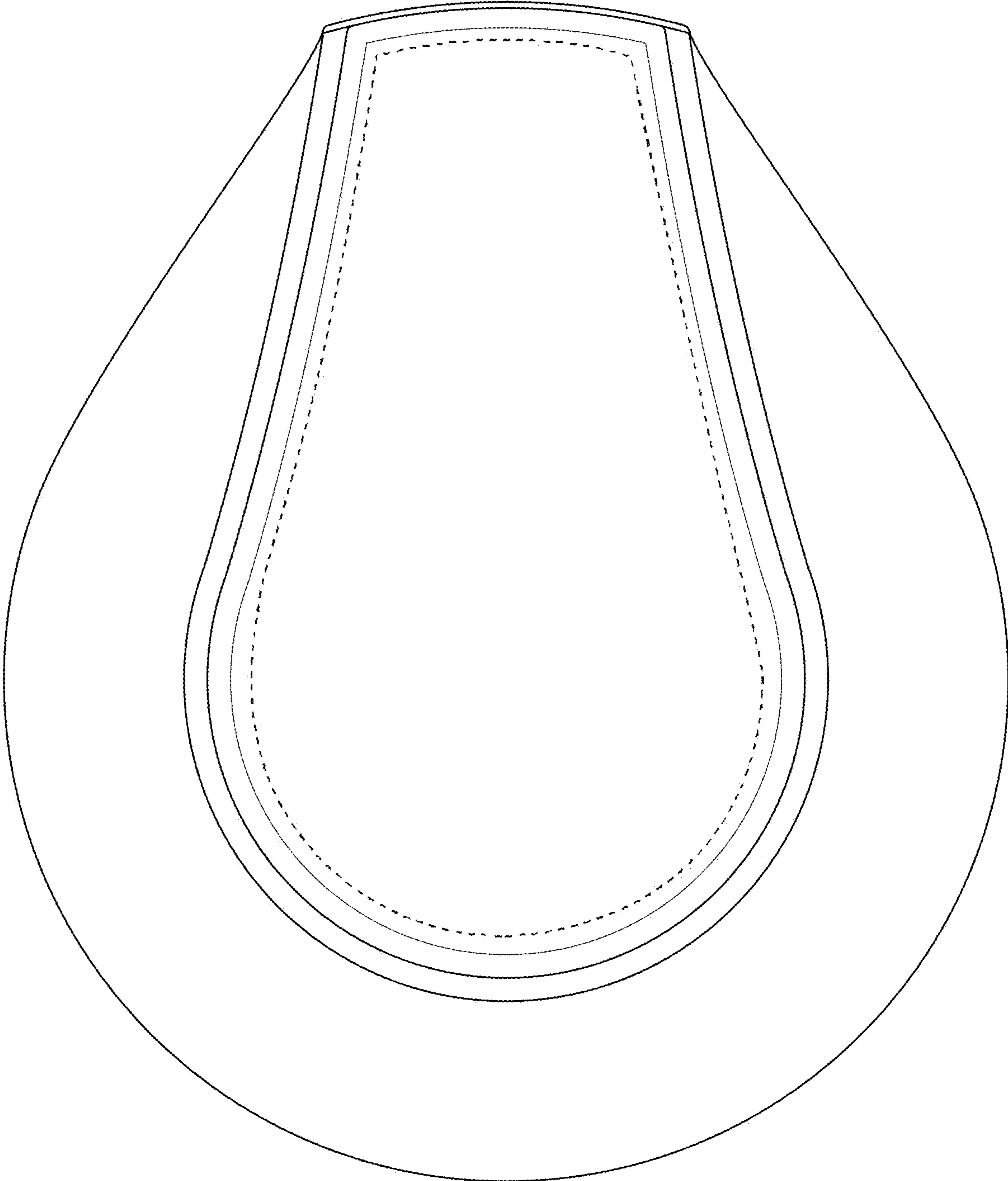
