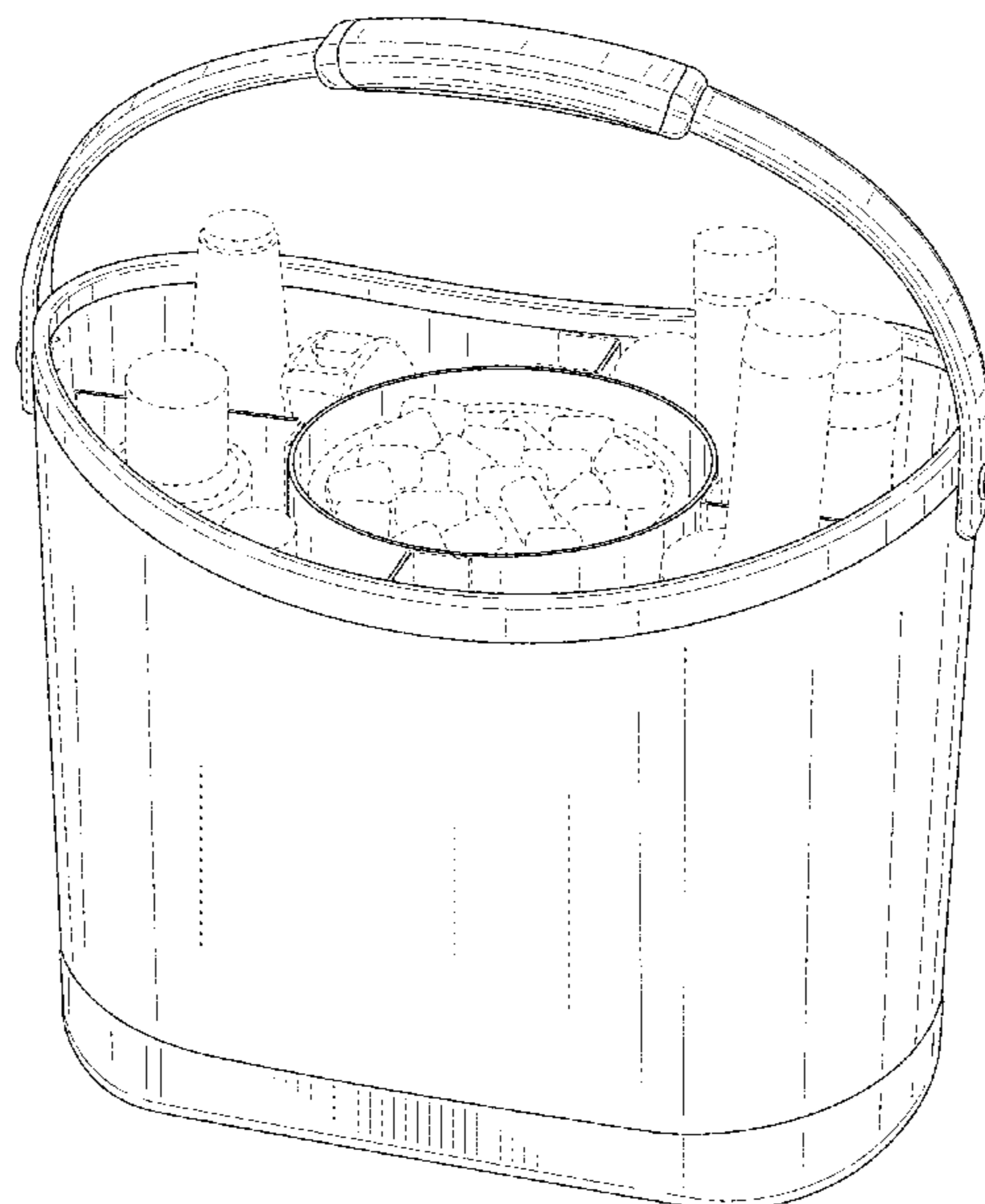
(57) **CLAIM**

The ornamental design for a multi-compartment carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a multi-compartment carrier showing my new design.
 FIG. 2 is a front view thereof.
 FIG. 3 is a rear view thereof.
 FIG. 4 is a left side view thereof.
 FIG. 5 is a right side view thereof.
 FIG. 6 is a top plan view thereof.
 FIG. 7 is a bottom plan view thereof.
 FIG. 8 is a top plan view thereof with a handle of the multi-compartment carrier positioned at the rear of the carrier; and,
 FIG. 9 is a front perspective view thereof.
 The broken lines are included in FIGS. 1, 6, 8, and 9 to represent portions of the multi-compartment carrier that are not considered part of the claimed design. Broken lines in FIG. 9 showing beverages and ice illustrate environmental structure and are for illustrative purposes only. The broken lines form no part of the claimed design.

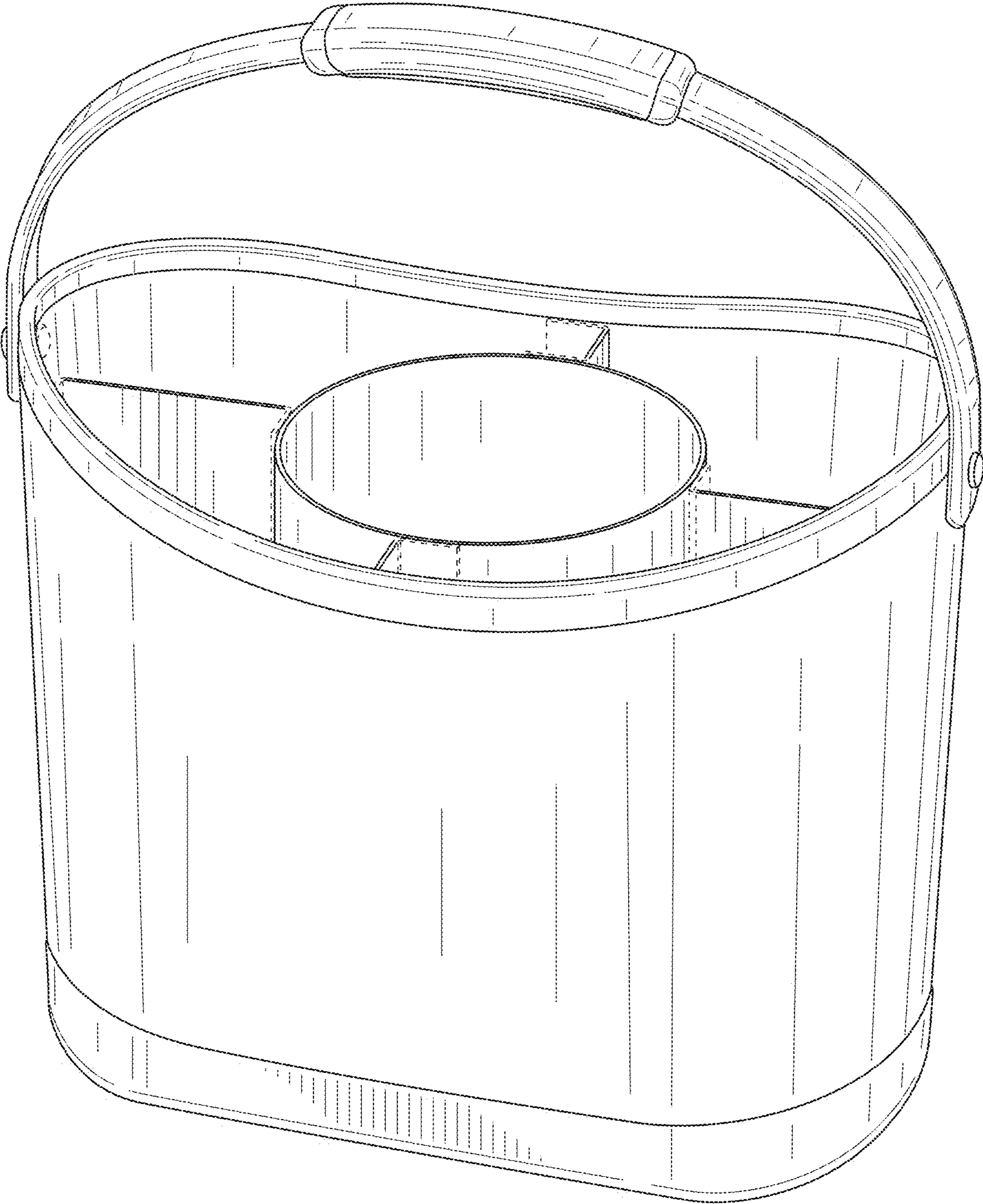

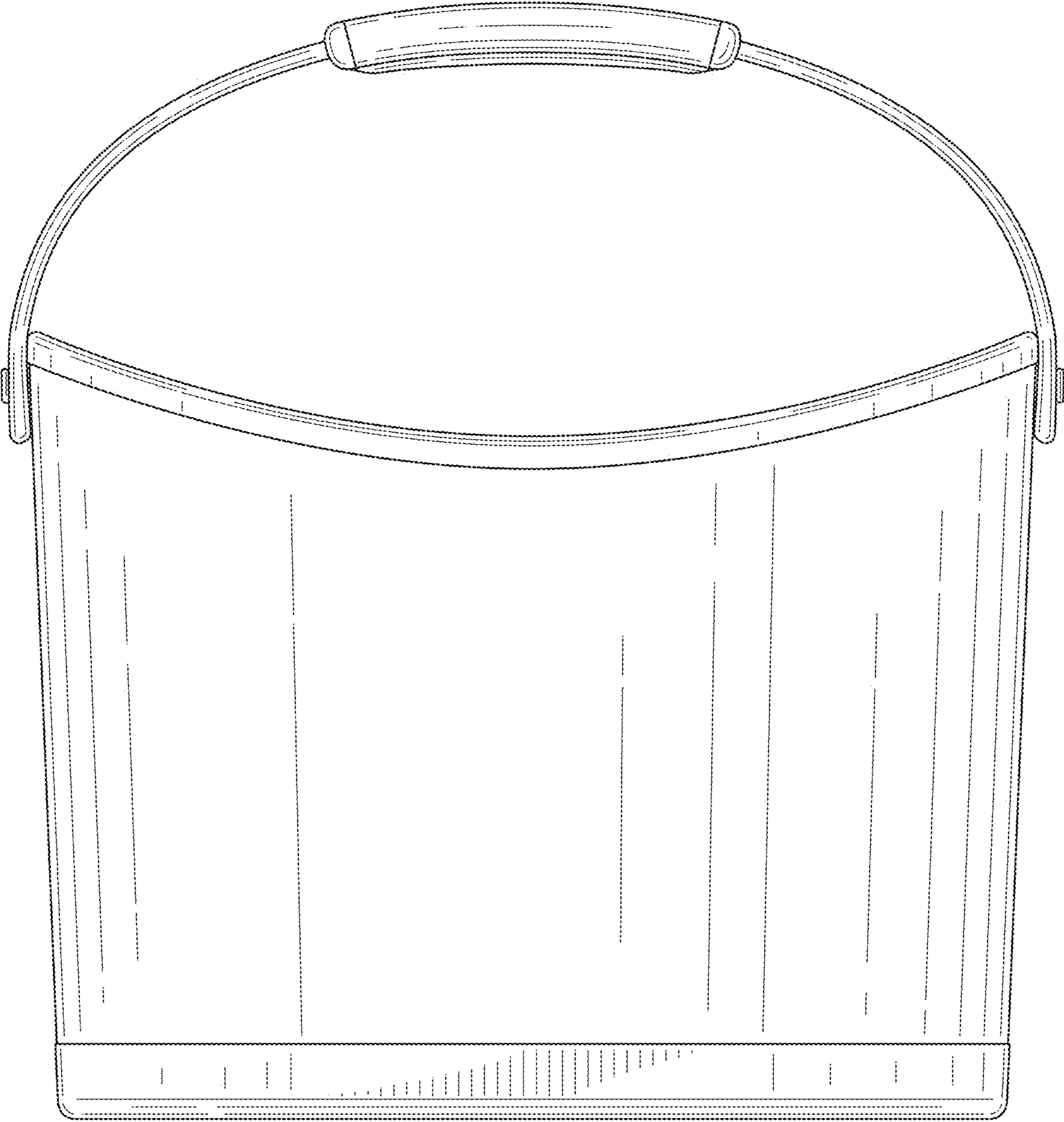

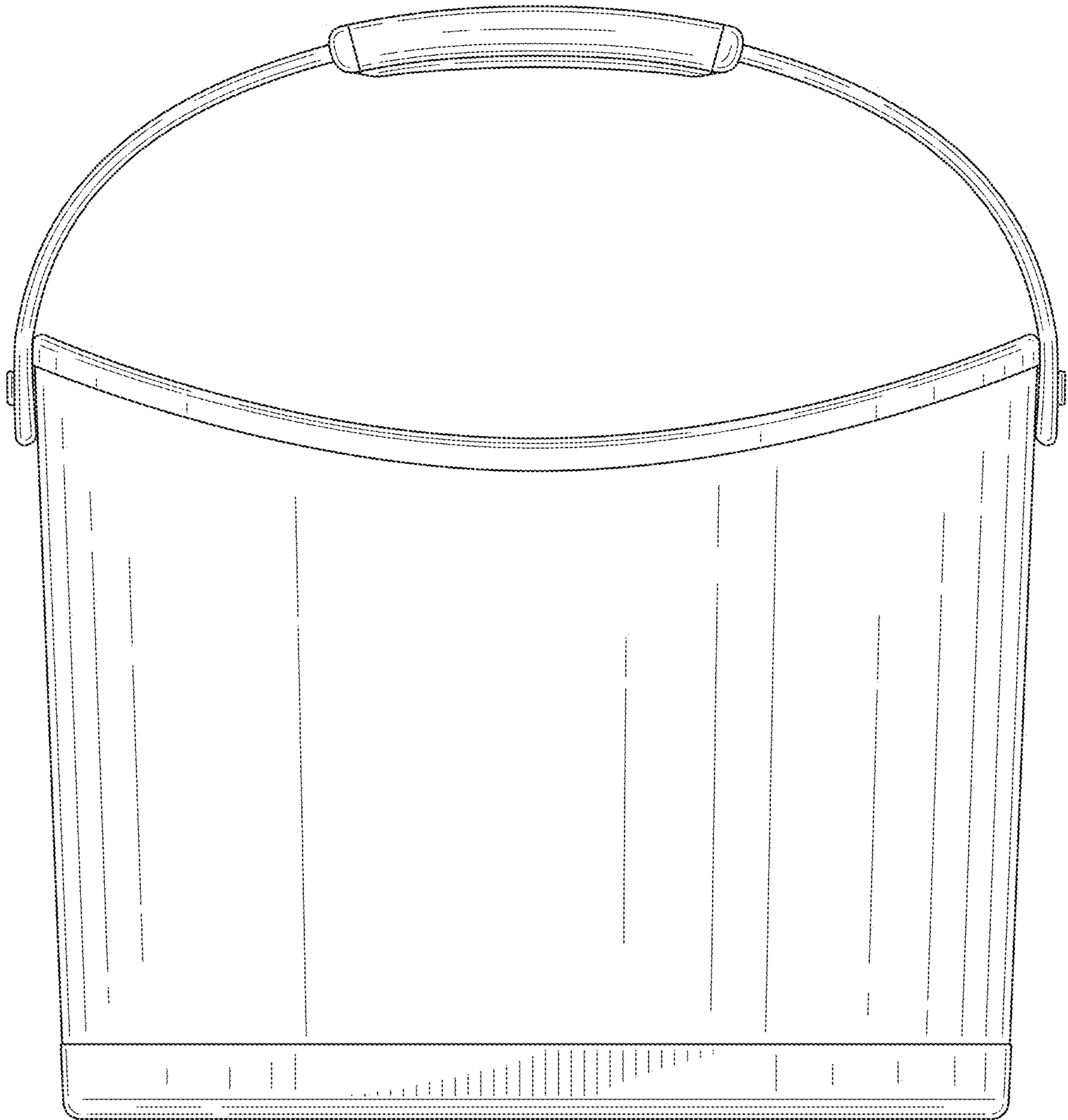

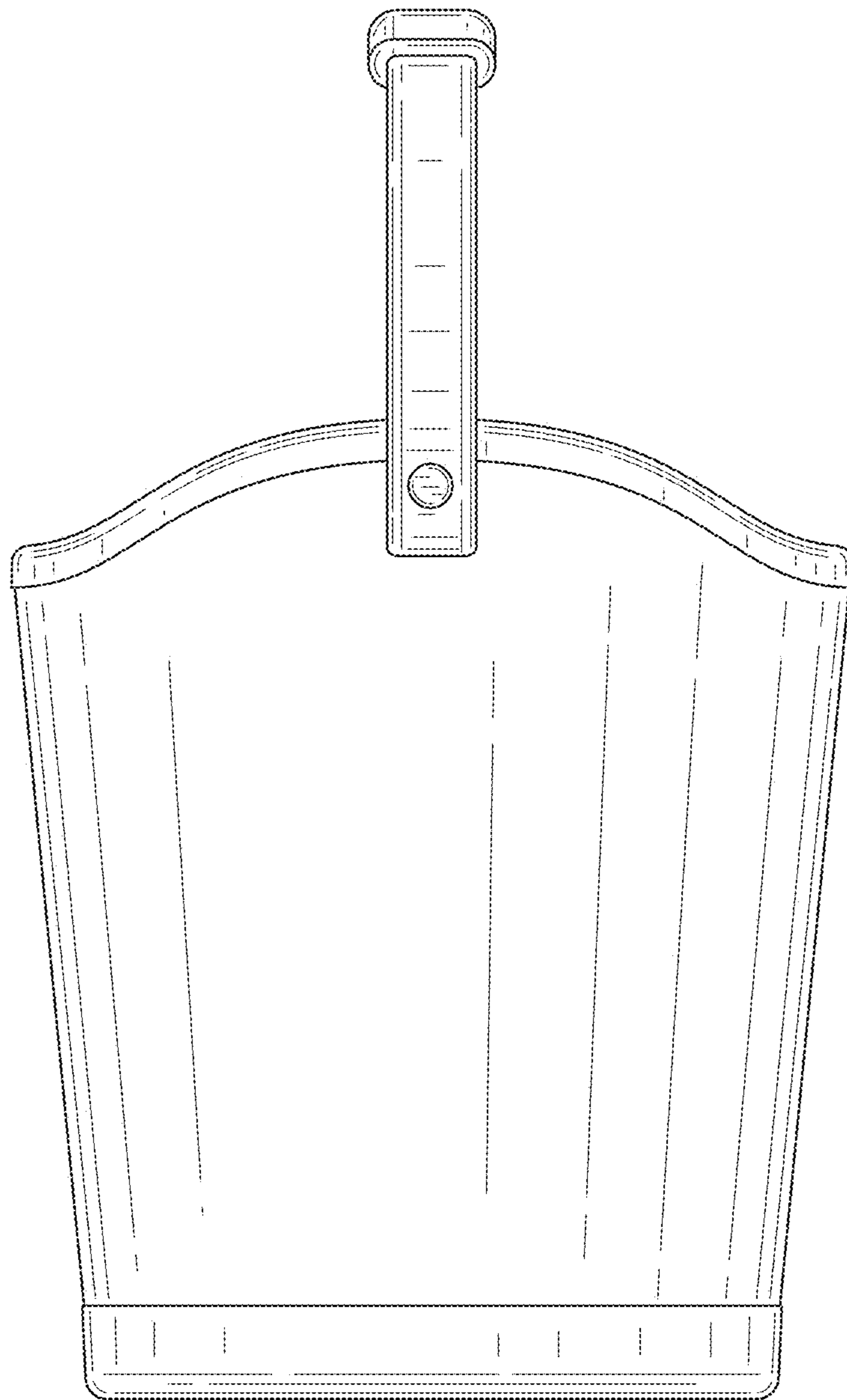

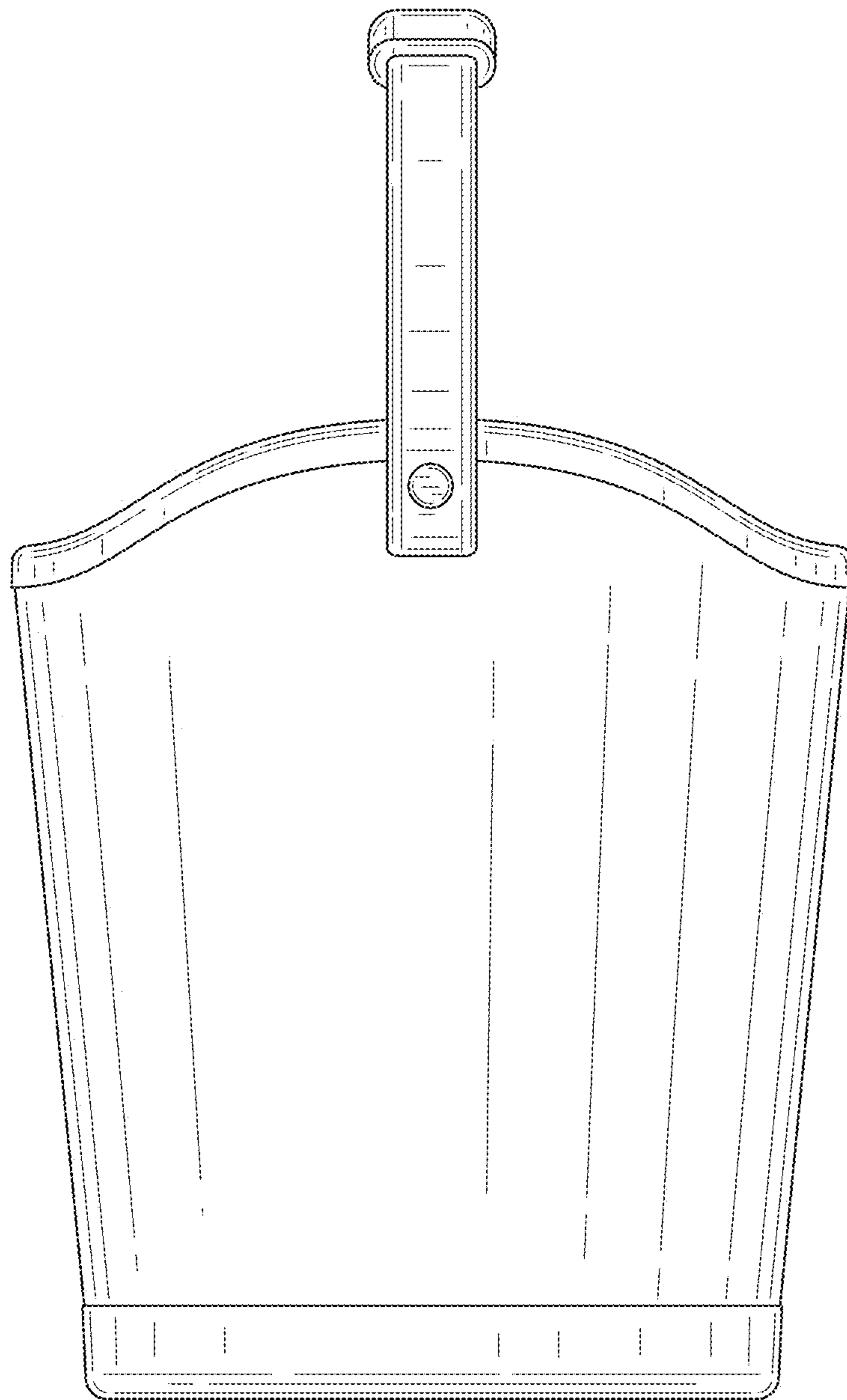

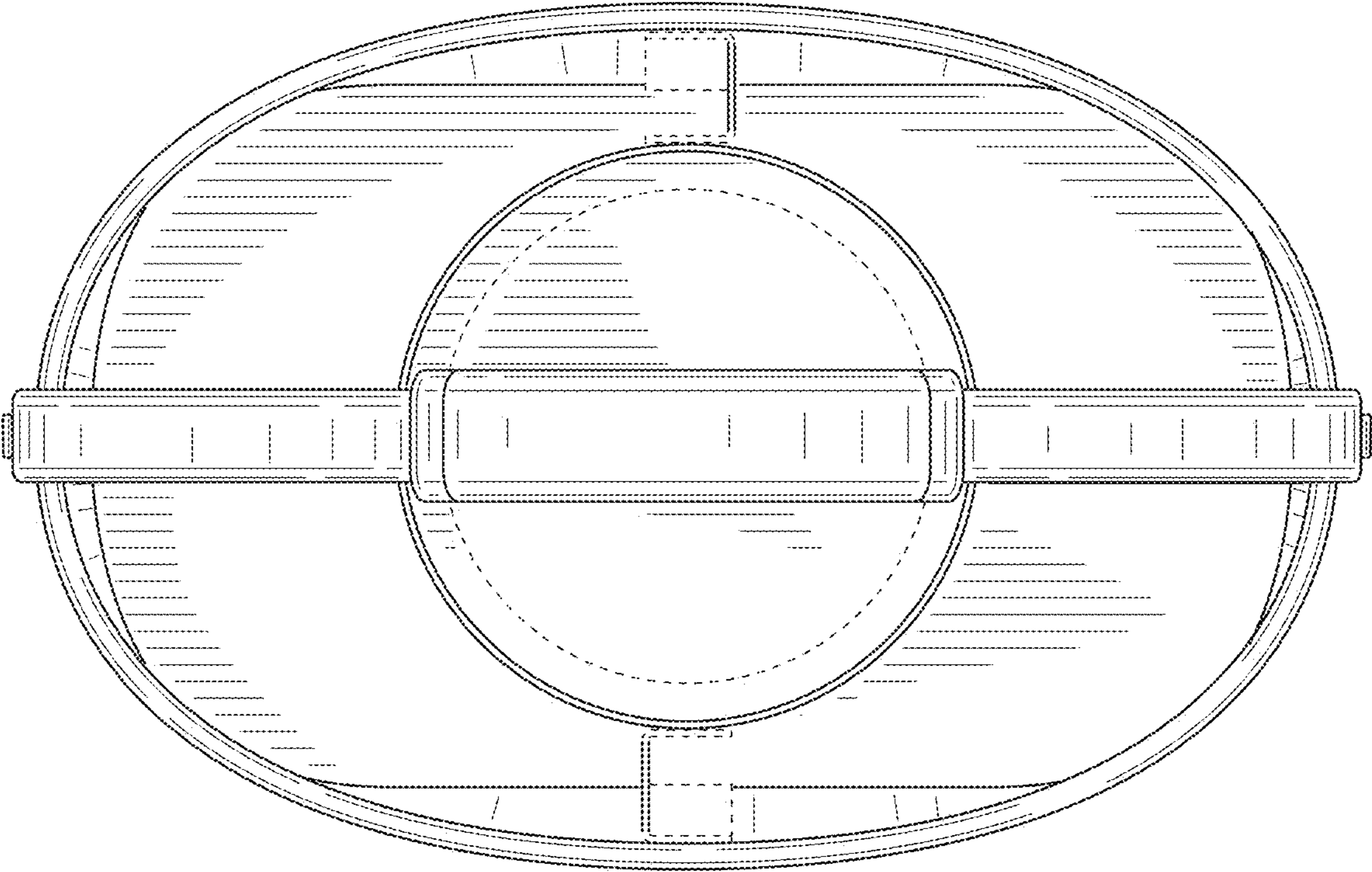

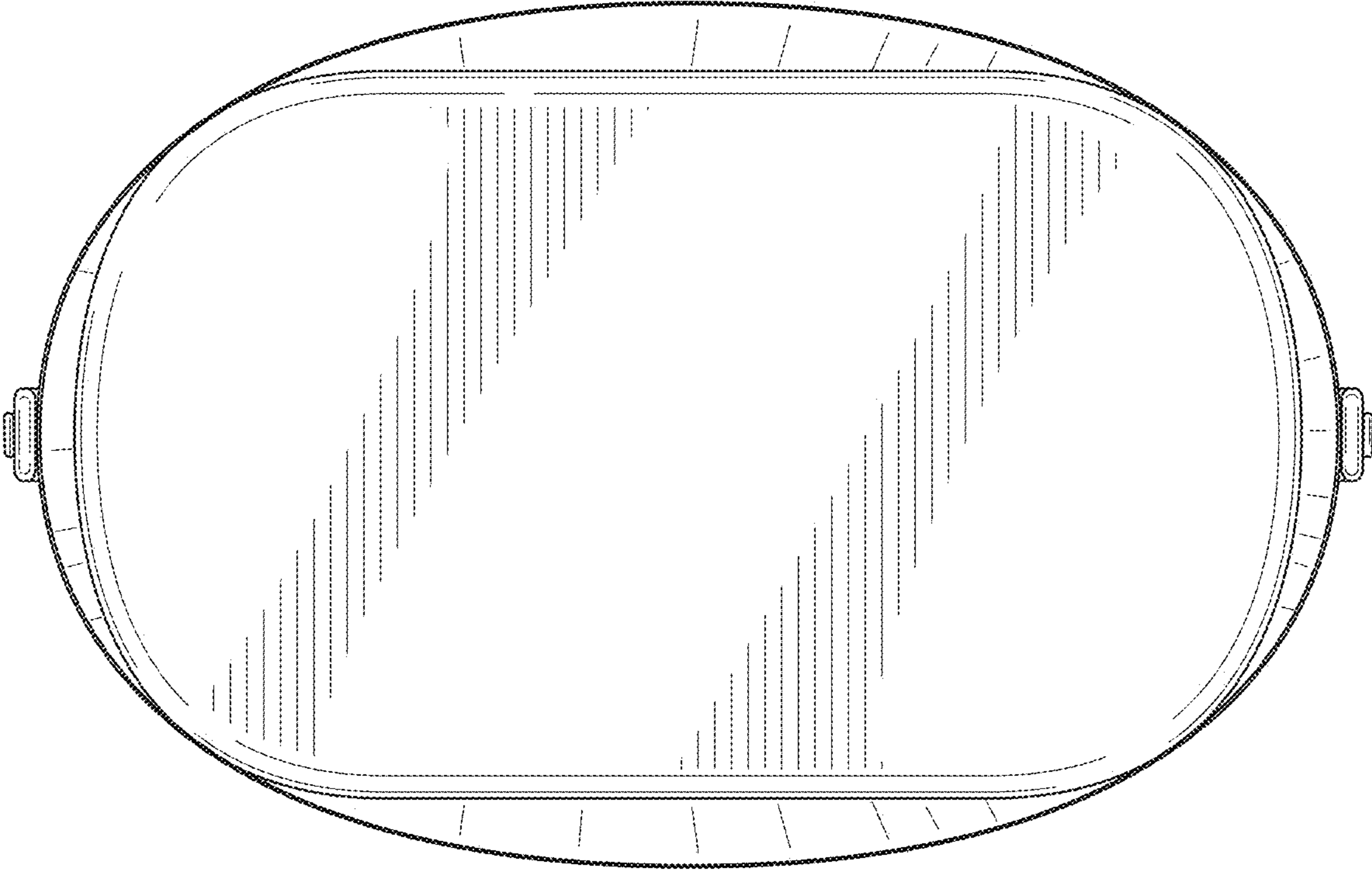

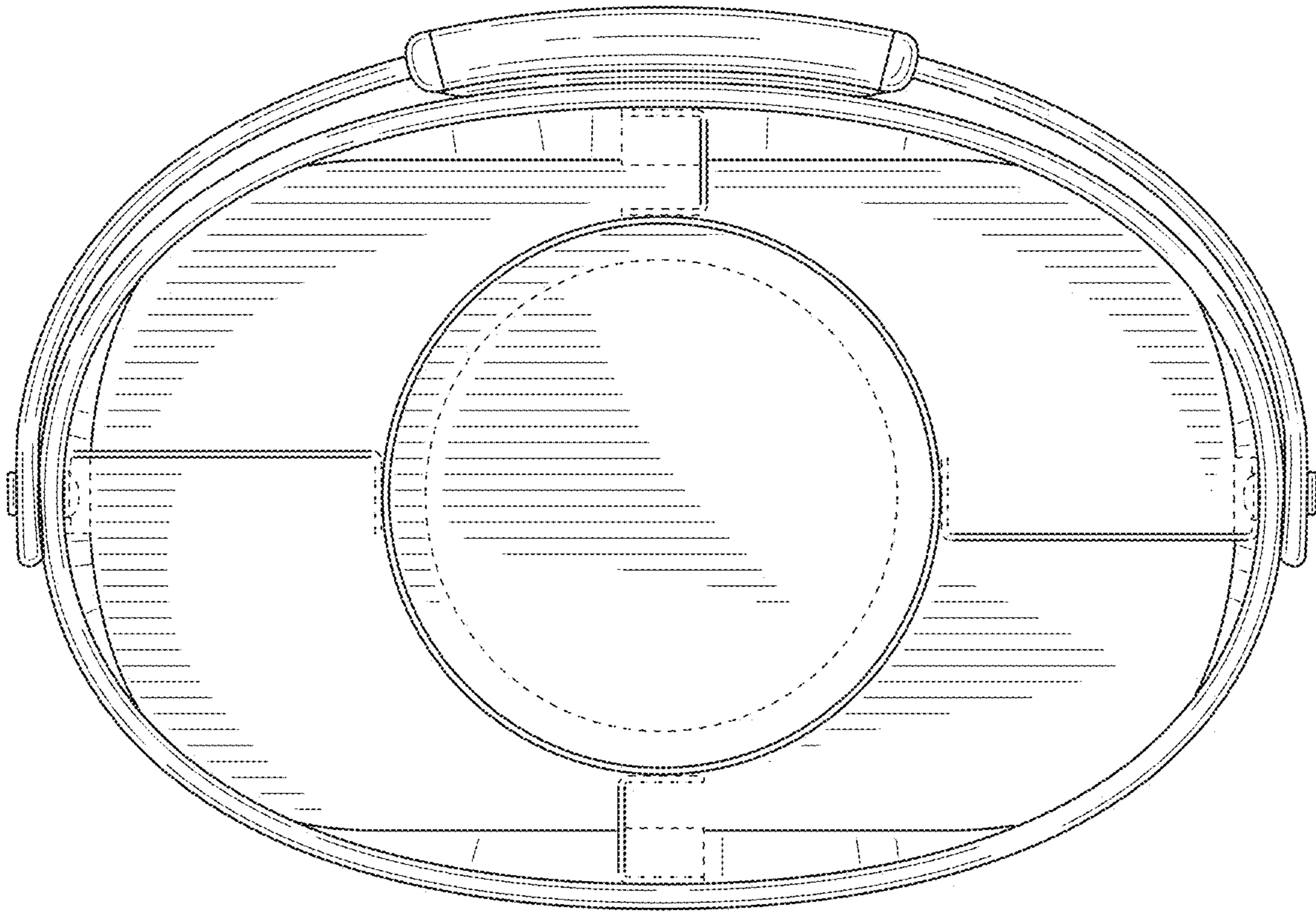

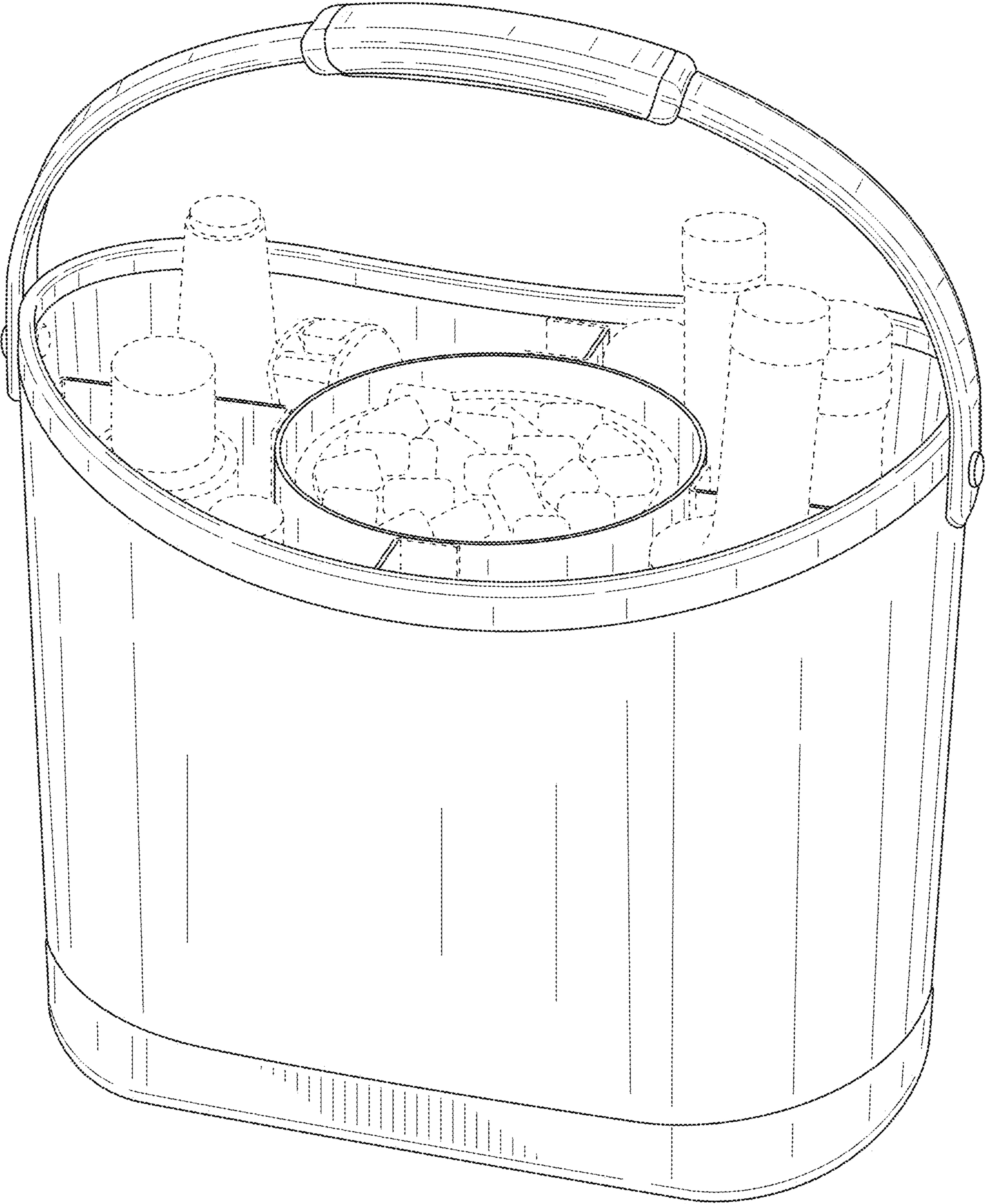
