(57) **CLAIM**

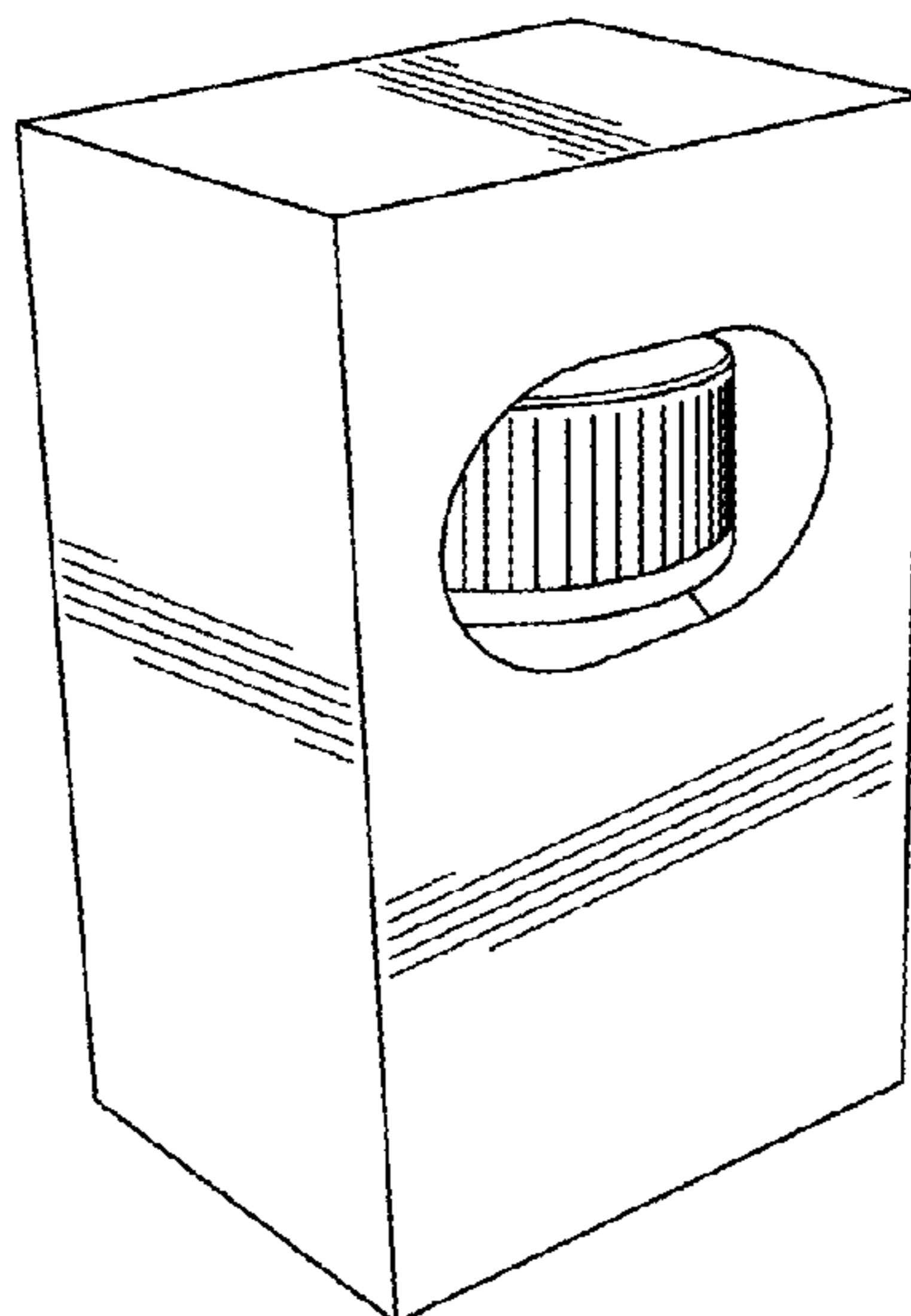
The ornamental design for a carton, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carton of the invention. FIG. 2 is a front view of the carton of FIG. 1. FIG. 3 is a back view of the carton of FIGS. 1 and 7. FIG. 4 is a side view of the carton of FIGS. 1 and 7, the opposite side being the mirror image thereof. FIG. 5 is a bottom view of the carton of FIGS. 1 and 7. FIG. 6 is a top view of the carton of FIGS. 1 and 7. FIG. 7 is a perspective view of a second embodiment of the carton; and, FIG. 8 is a front view of the carton of FIG. 7. The broken lines in the figures form no part of the claimed invention.

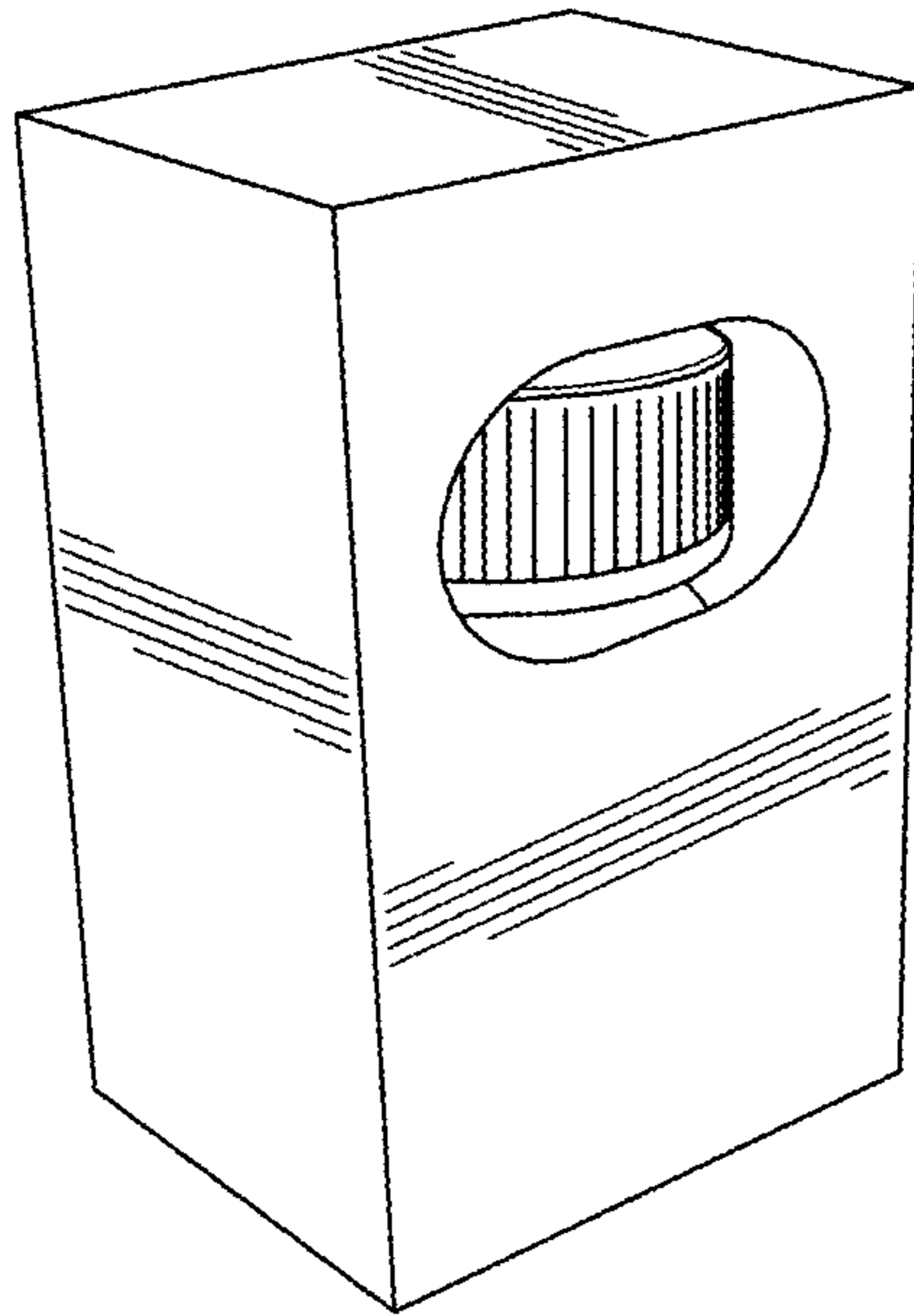

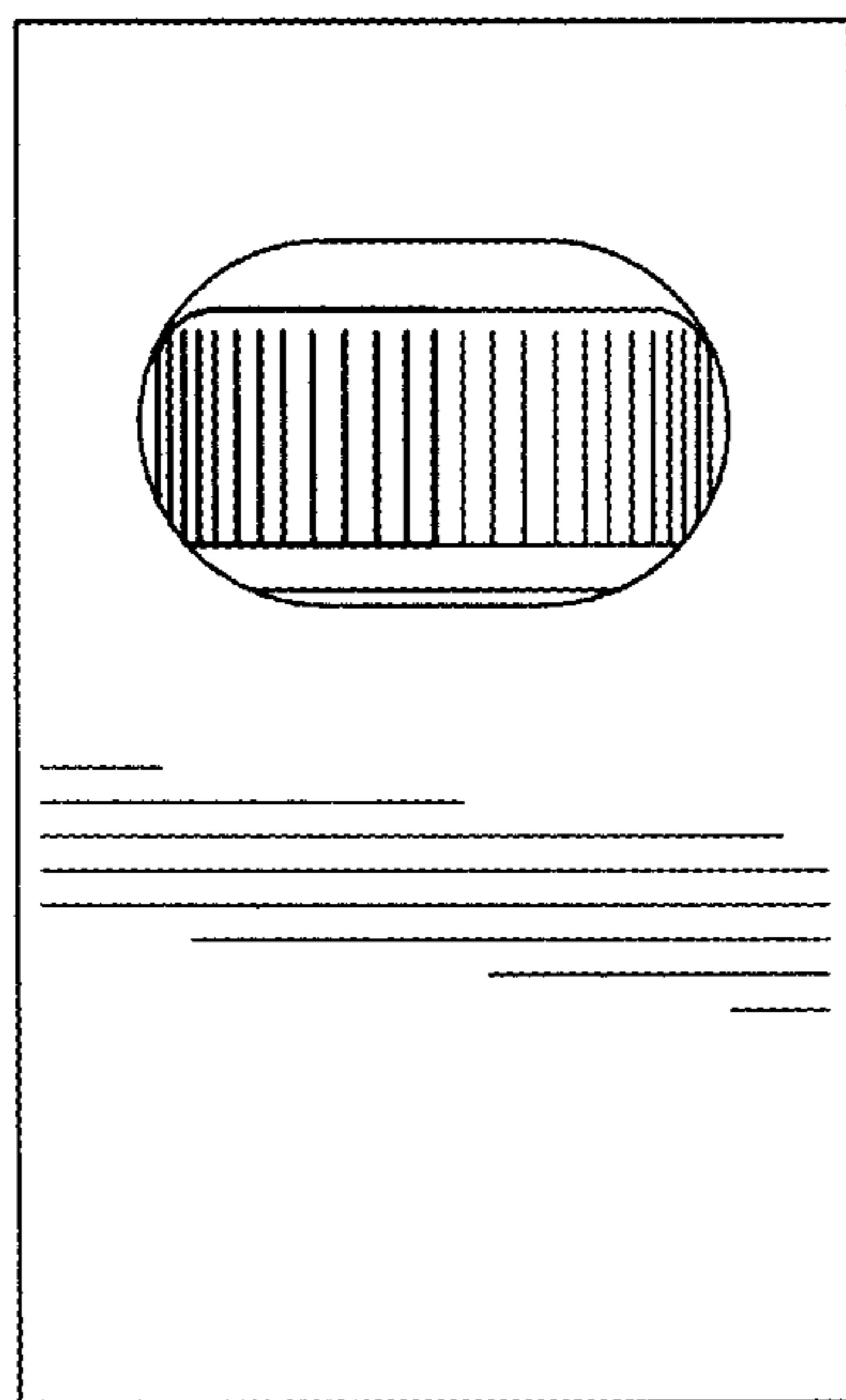

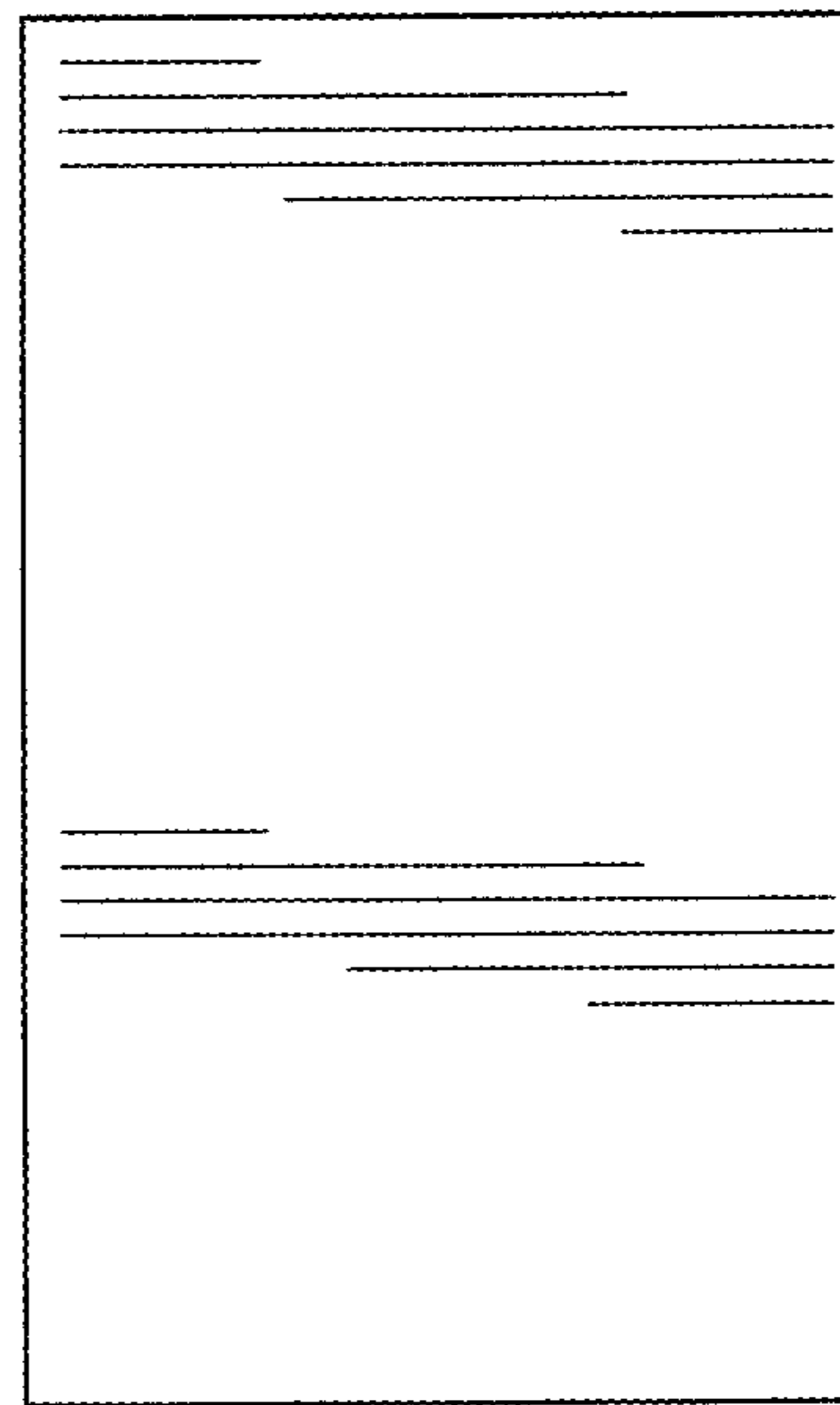

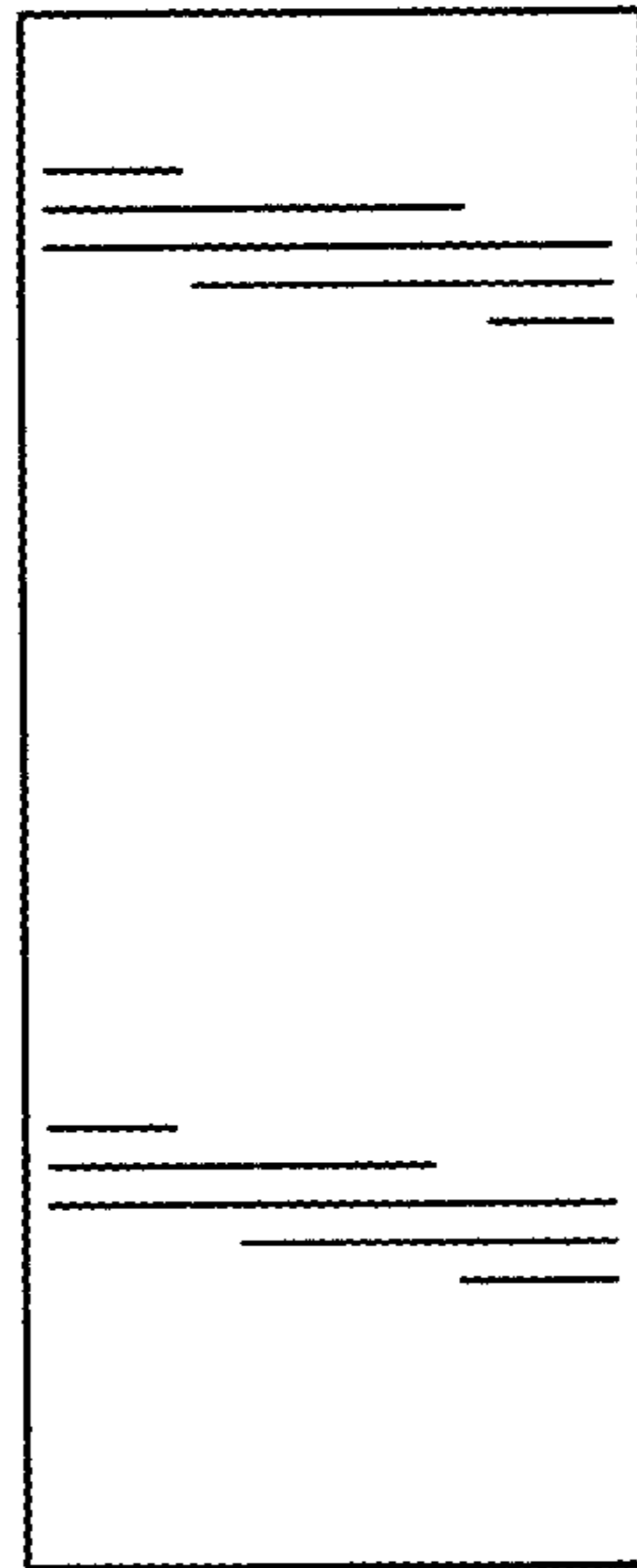

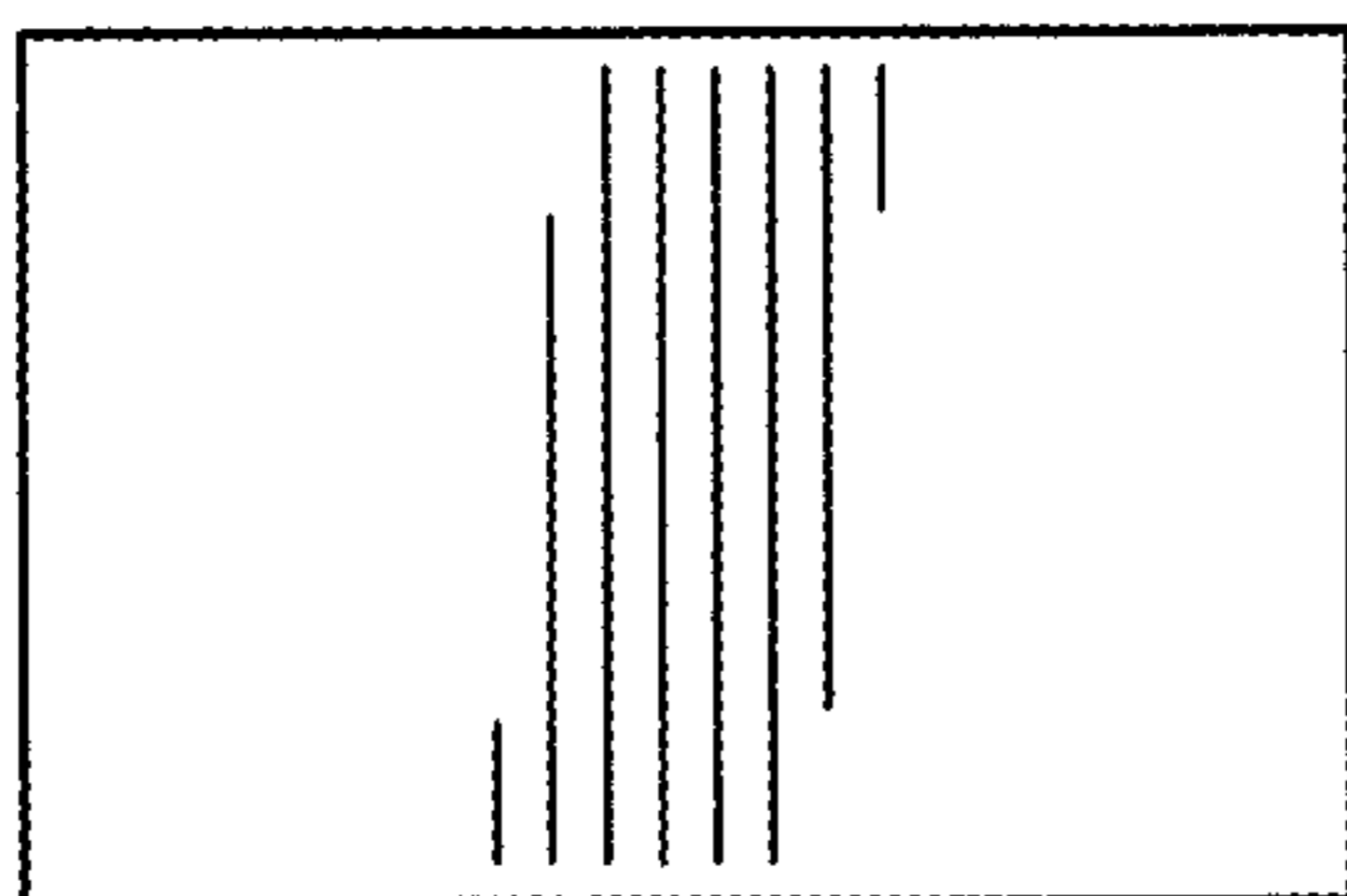

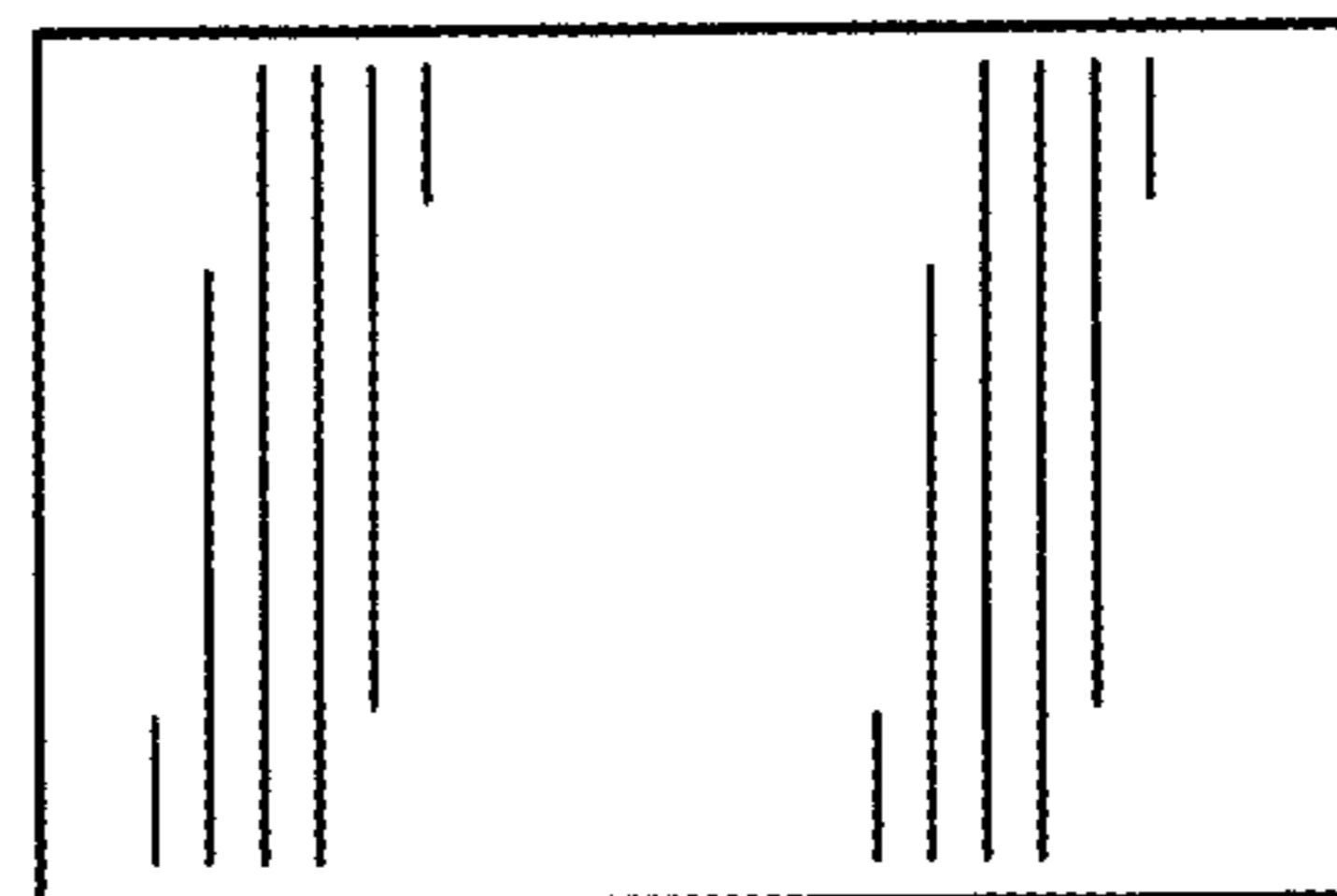

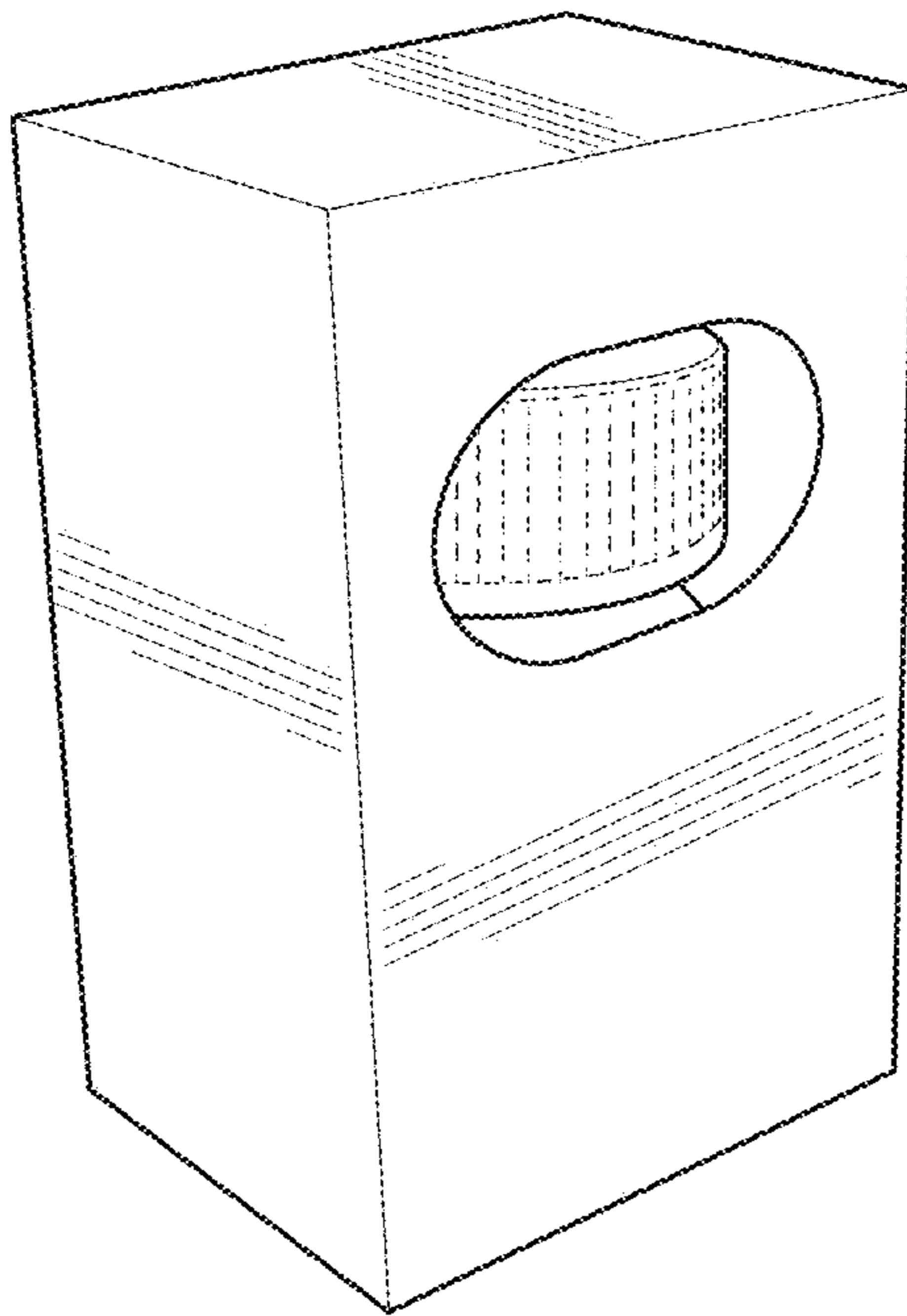

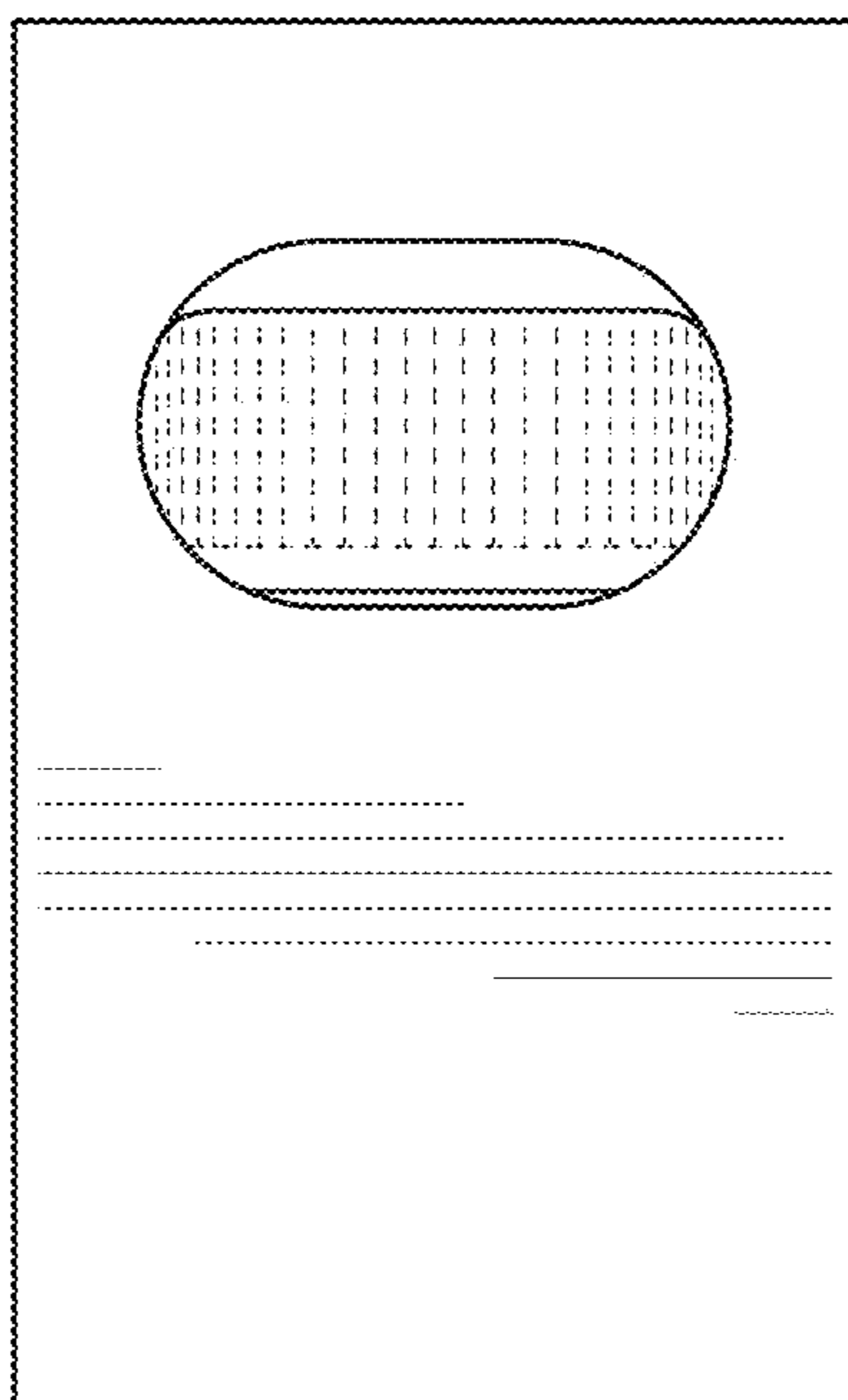
