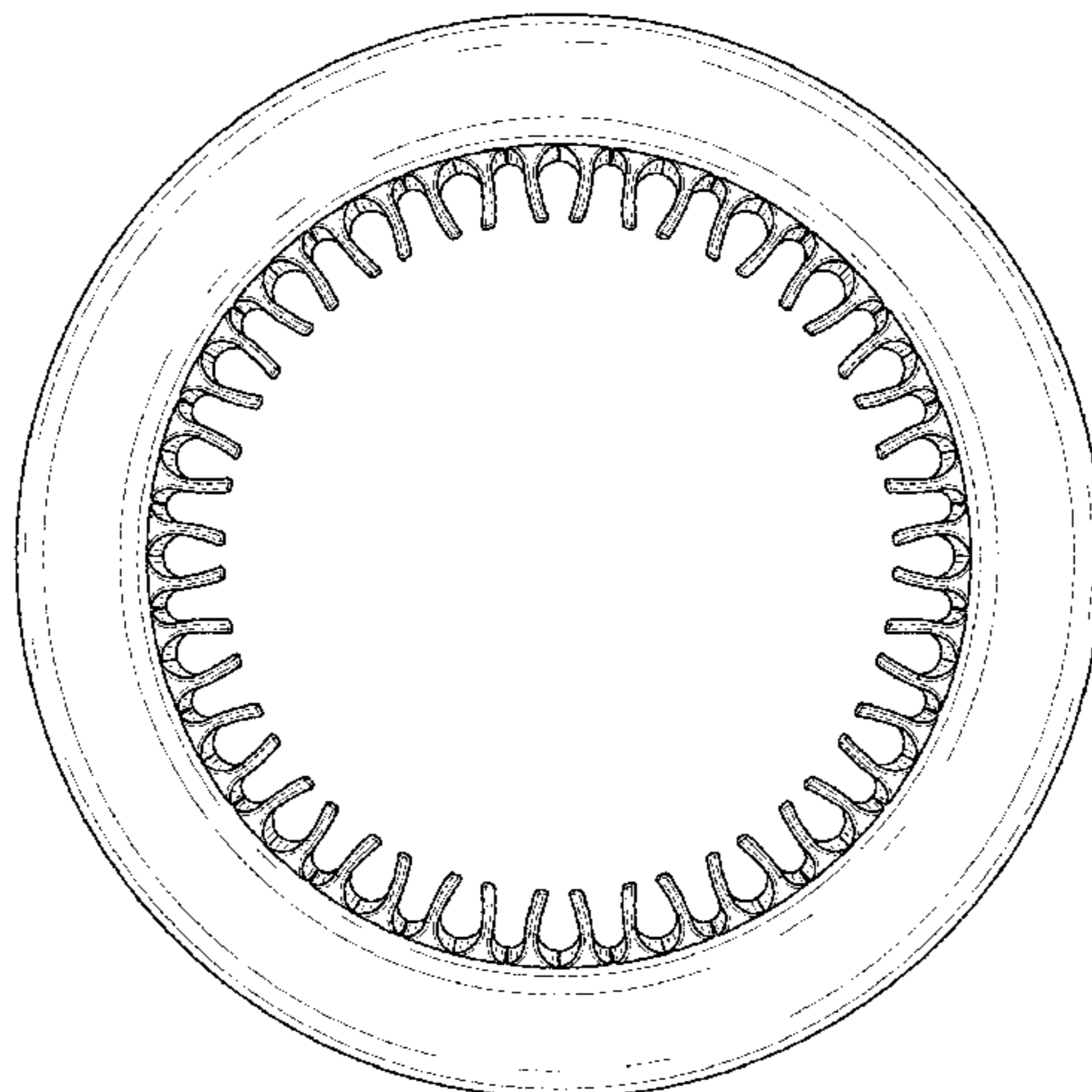


FIG. 8 is a perspective view showing the pendant with environmental features.

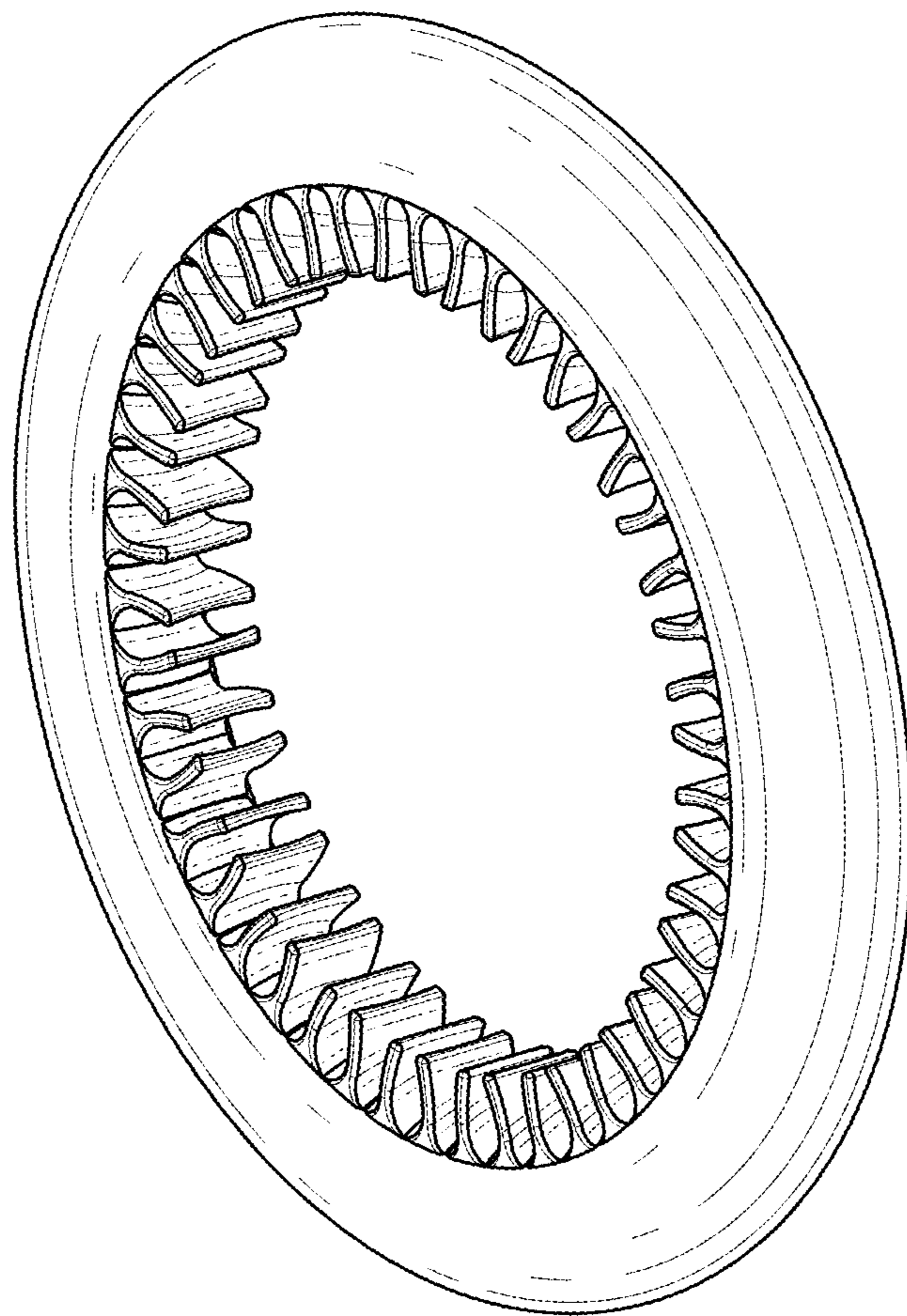

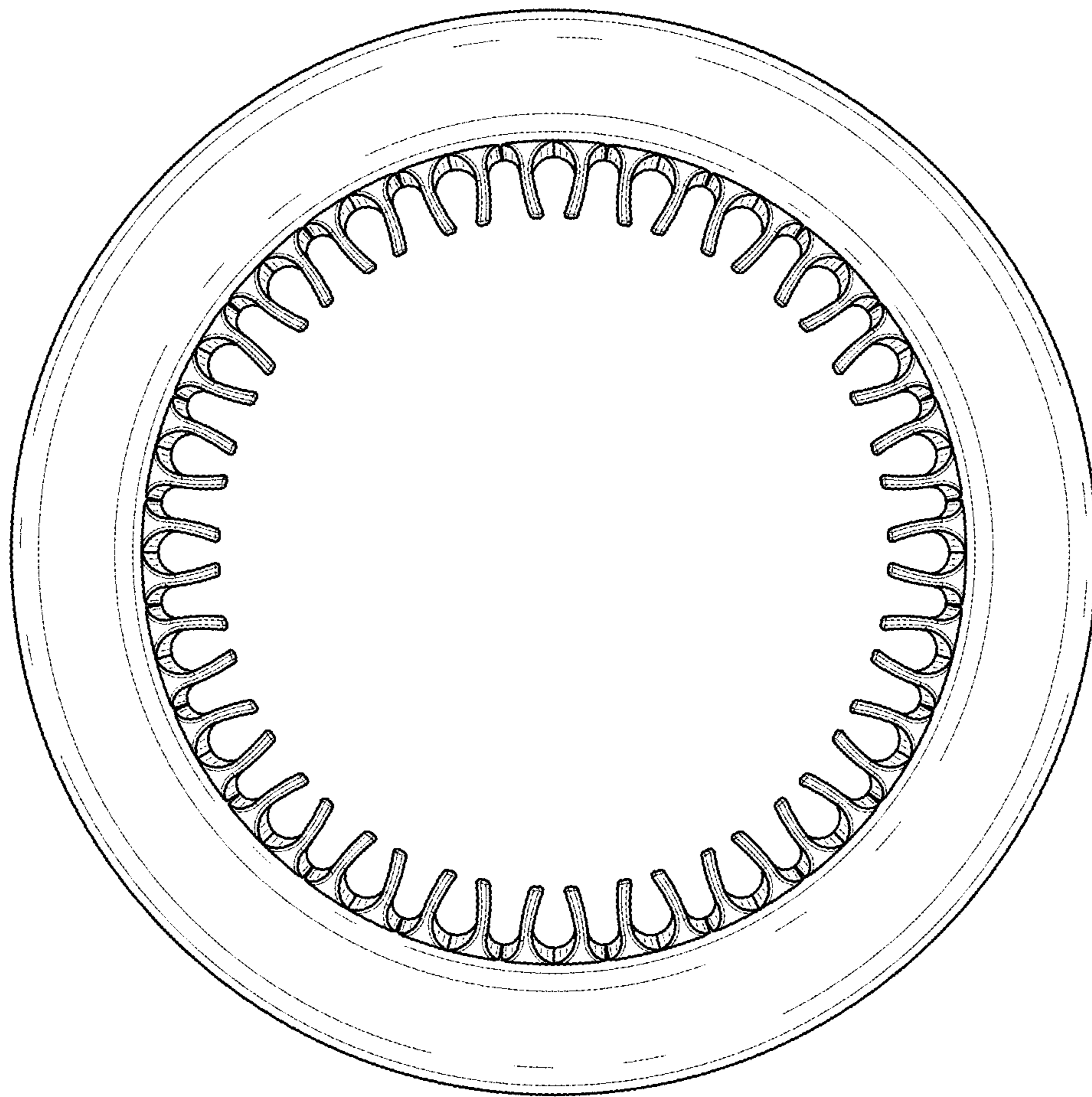

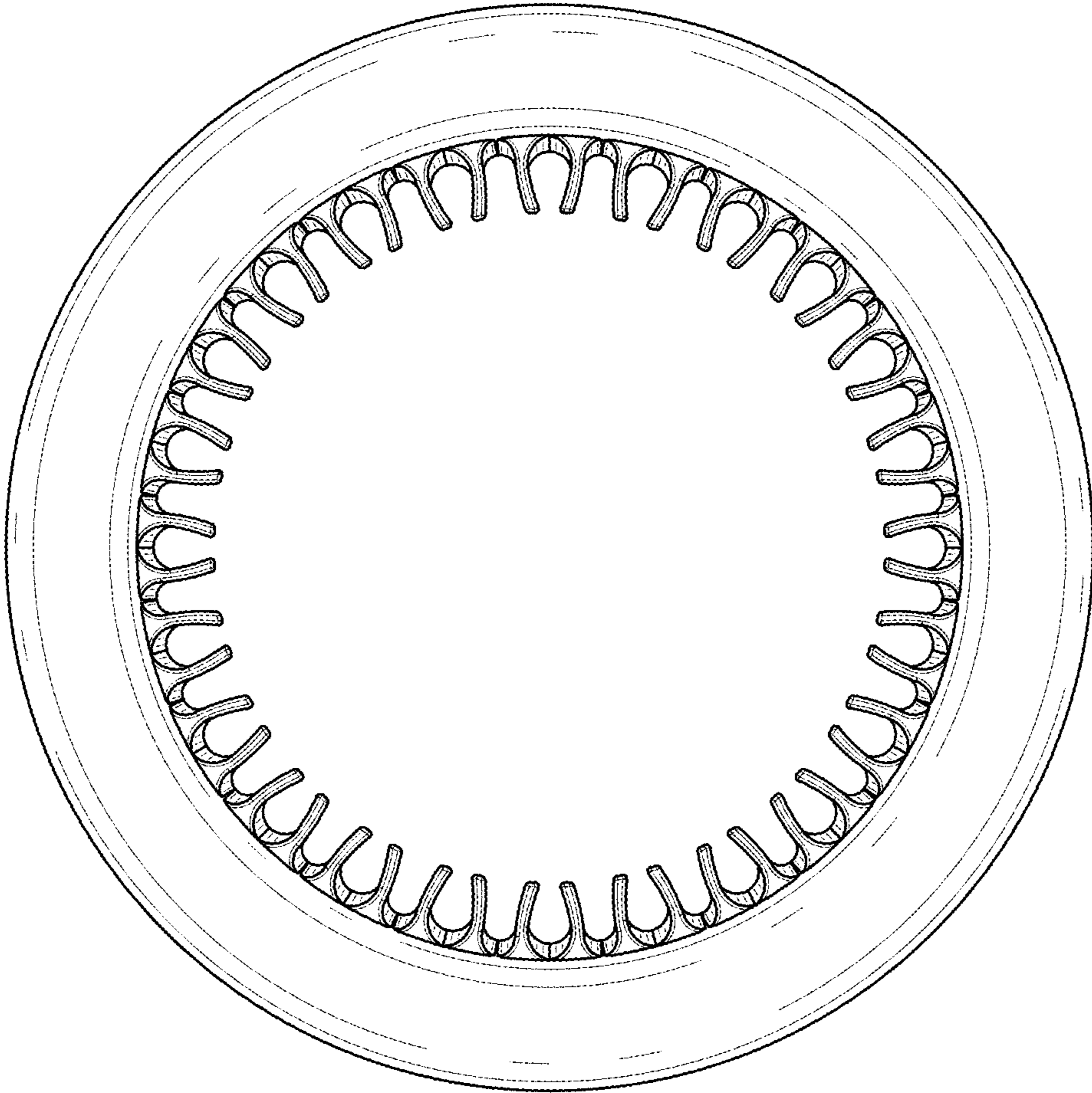

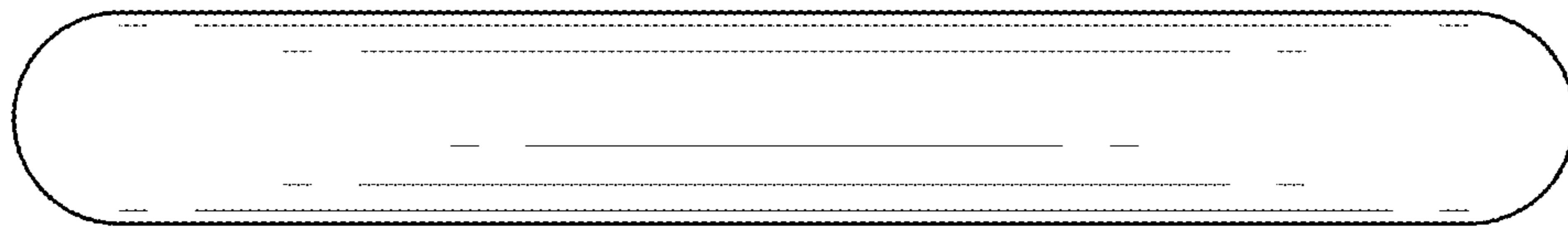

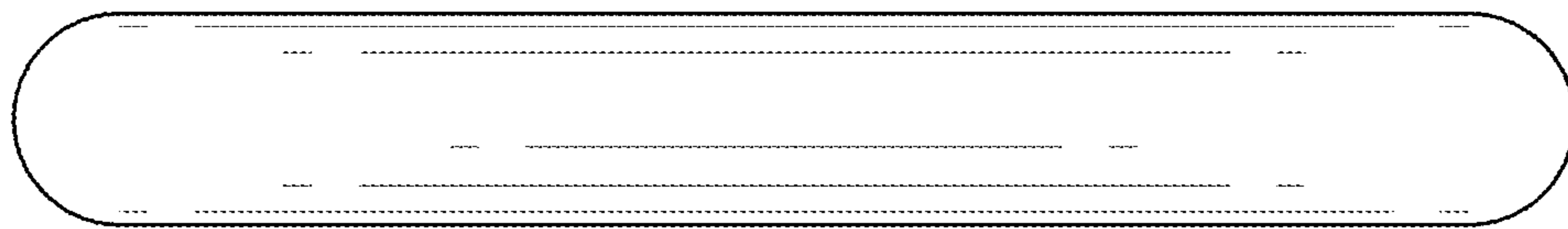

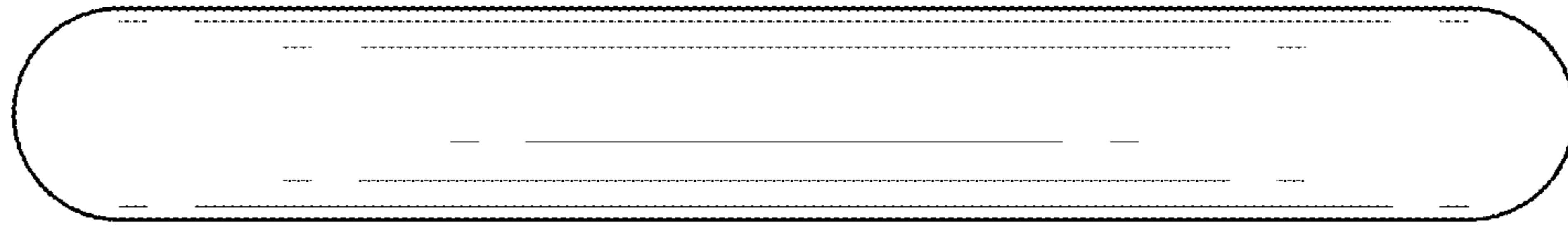

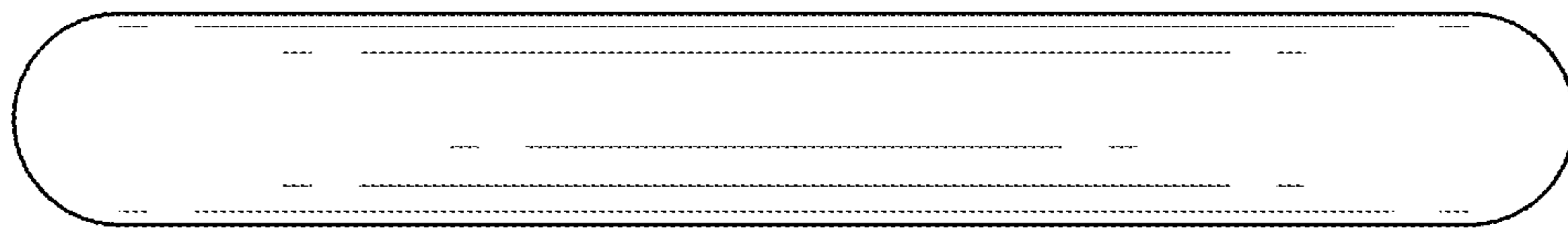

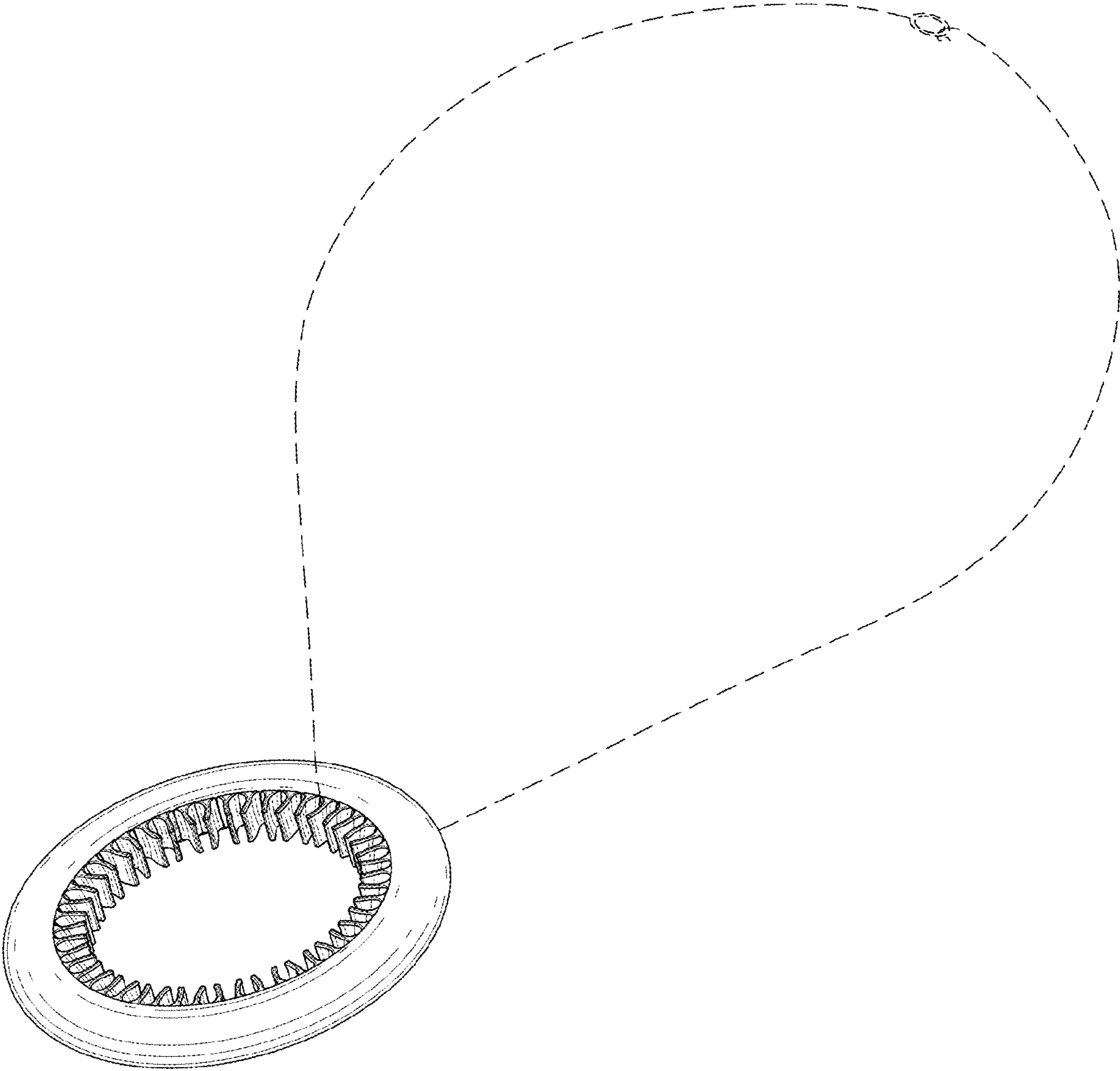
