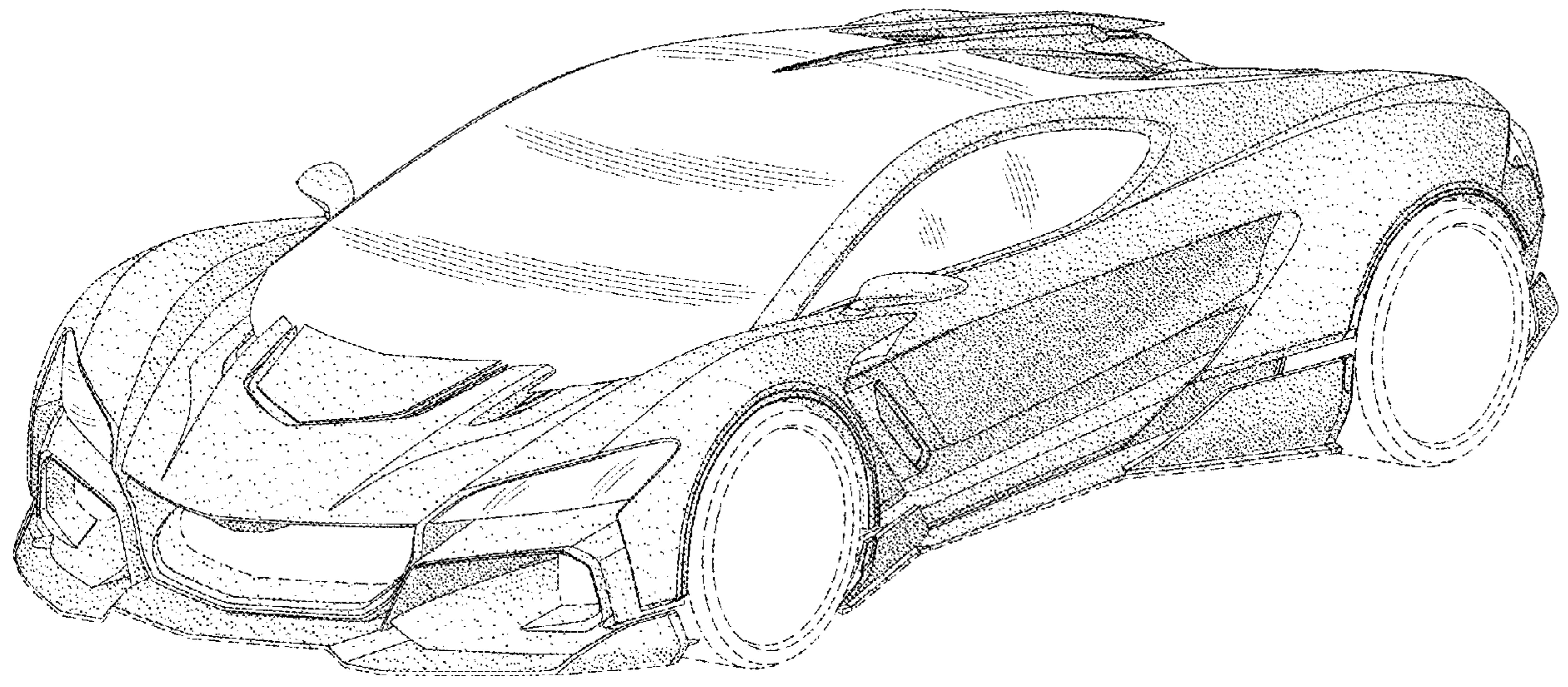
FIG. 1 is a top, front and right side perspective view of an automobile body showing our new design;

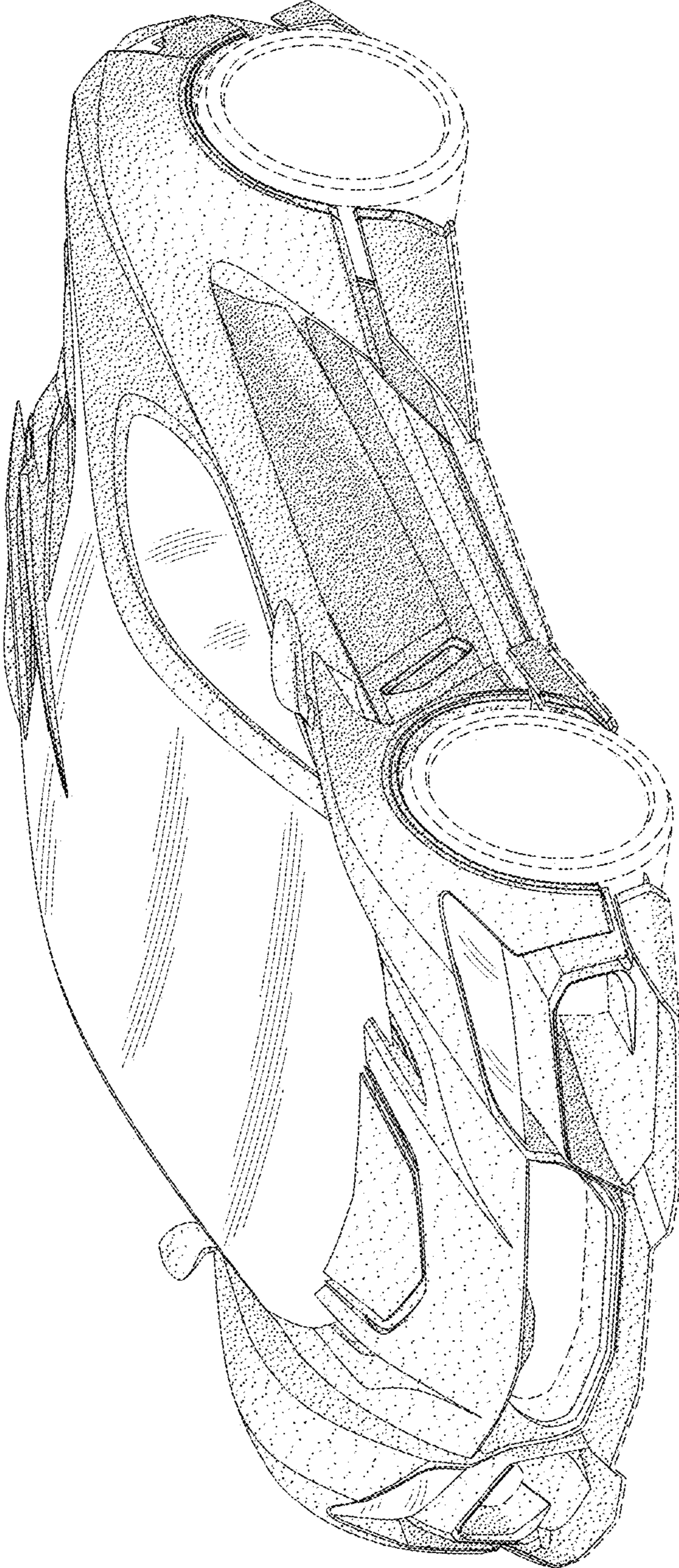

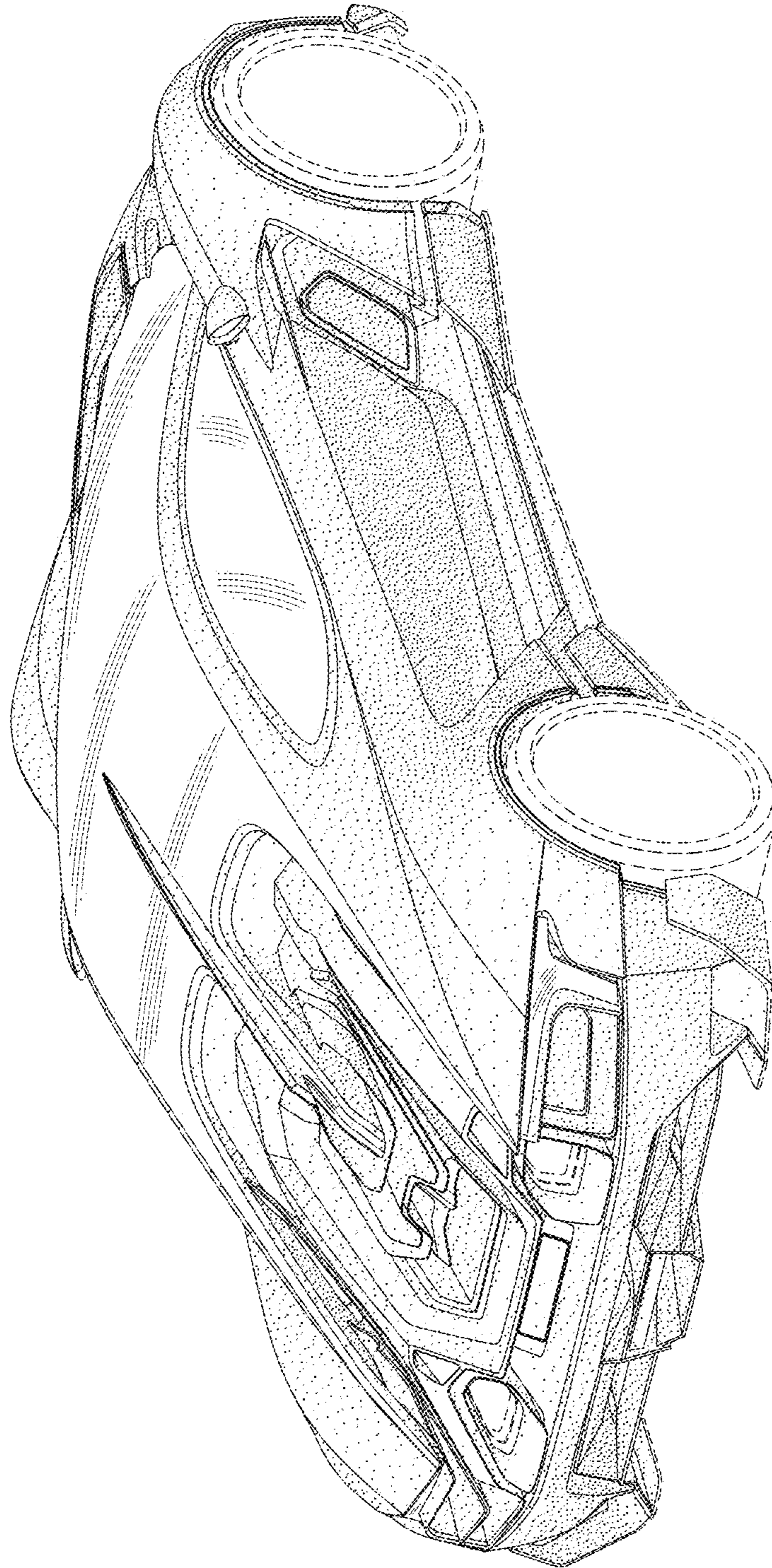

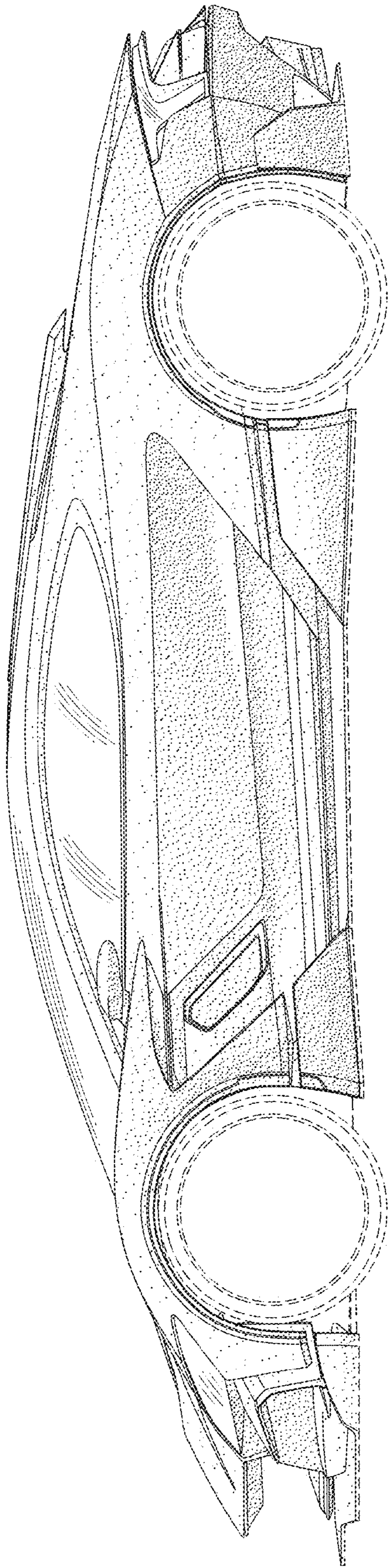

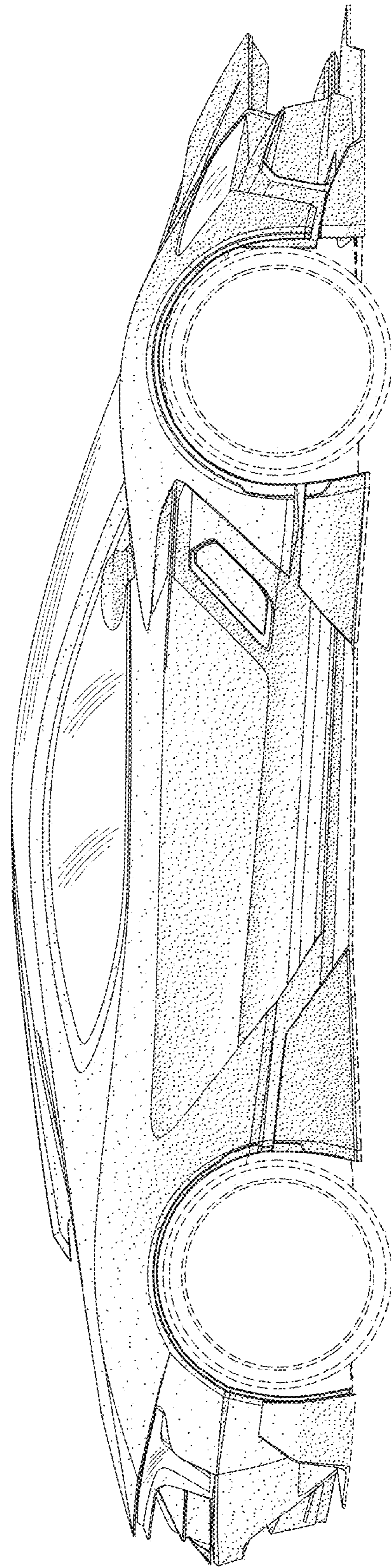

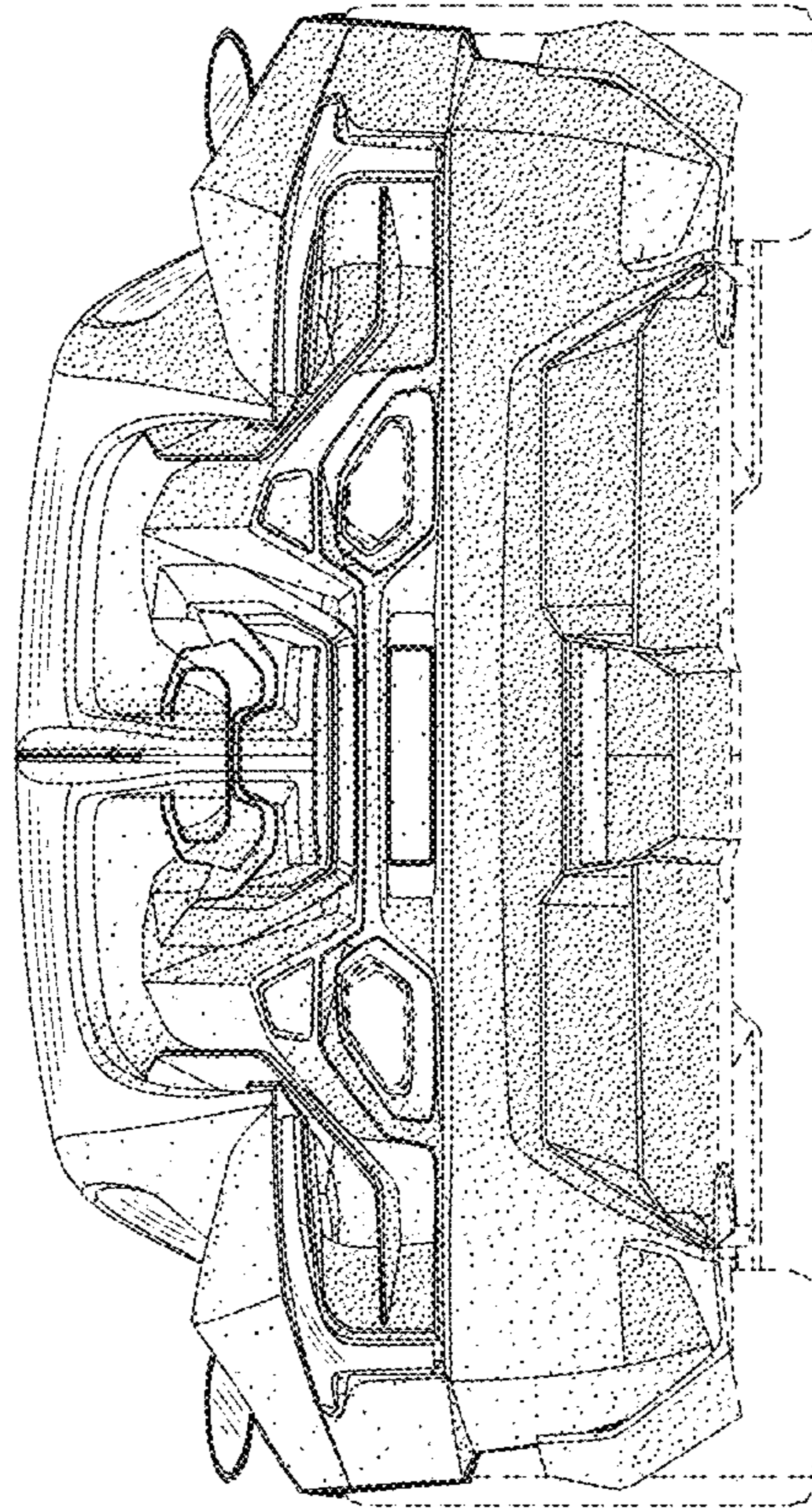

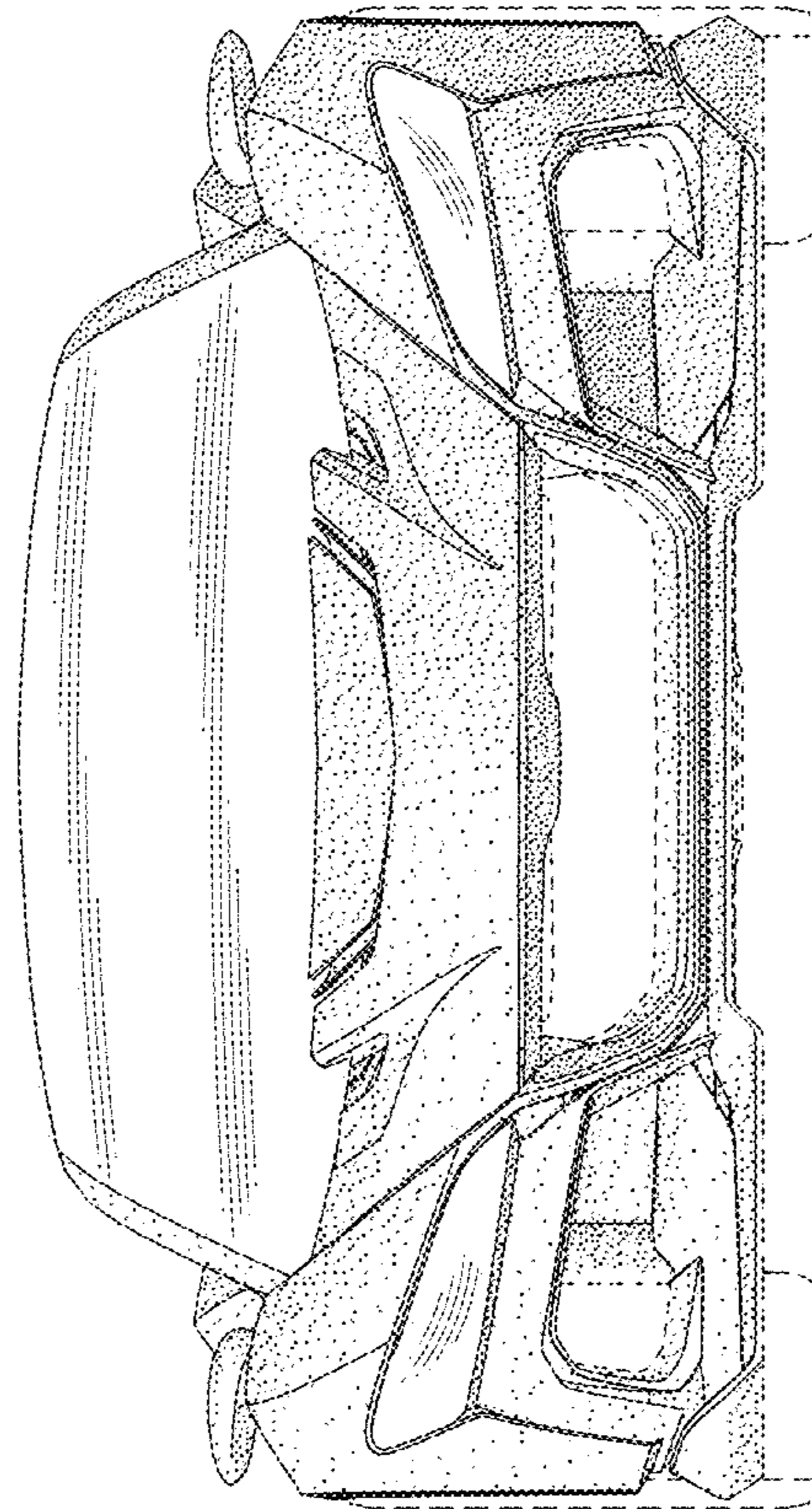

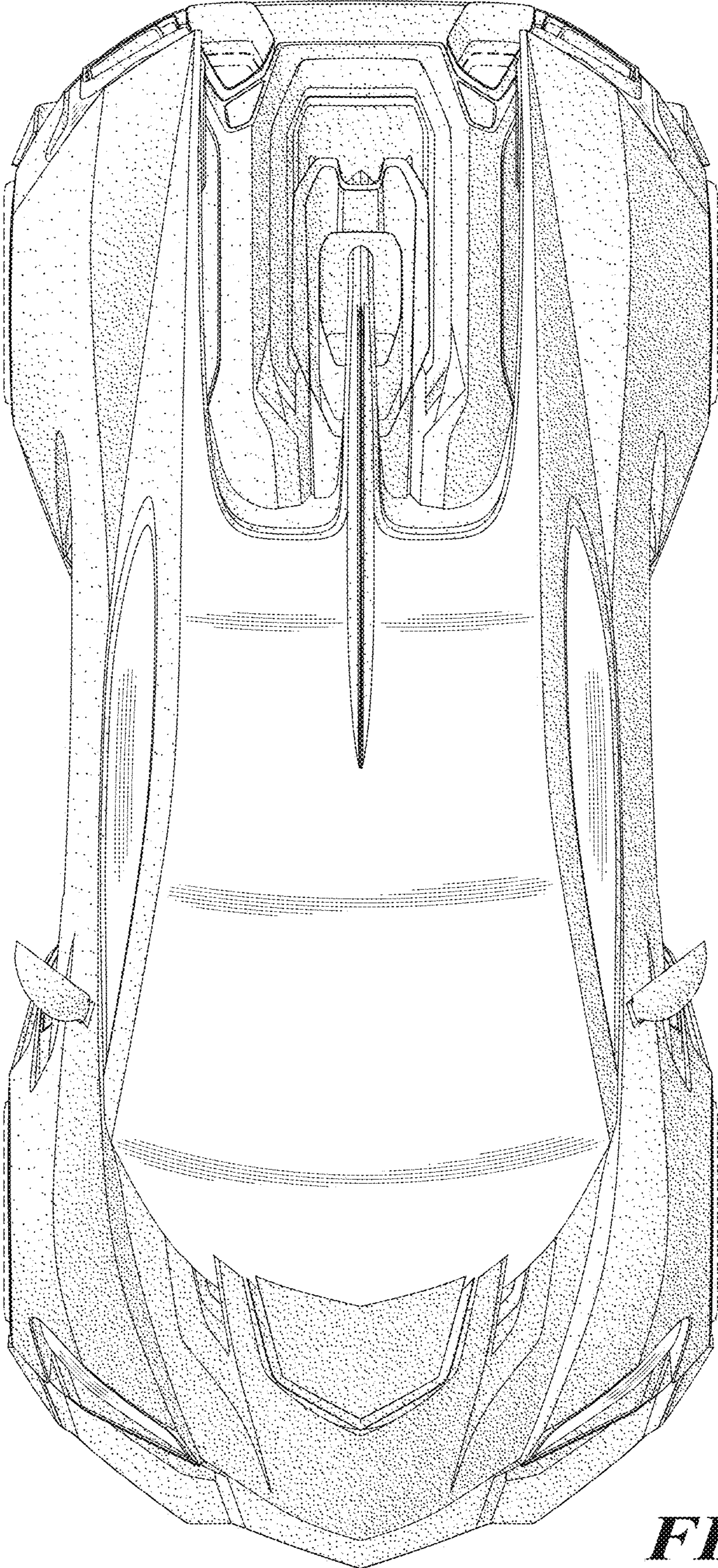
