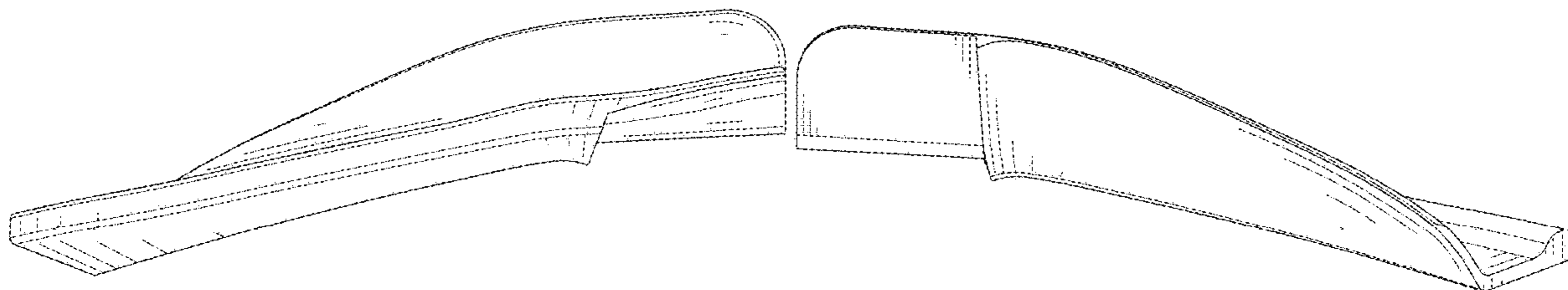
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front/left side, top perspective view of the car drainage guidance slot showing my new design; FIG. 2 is a rear/right side, bottom perspective view thereof; FIG. 3 is a front/left side elevational view thereof; FIG. 4 is a rear/right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

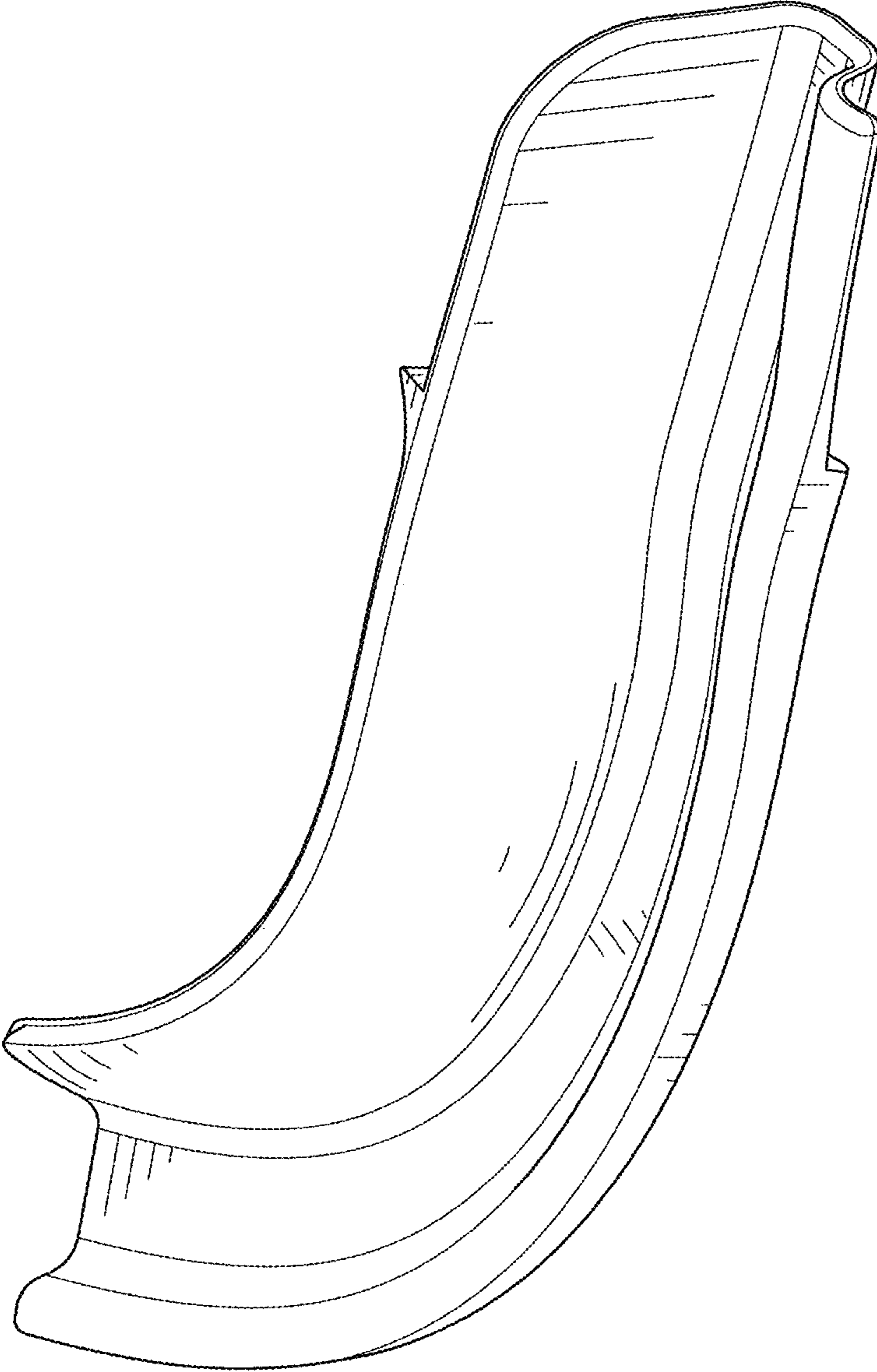

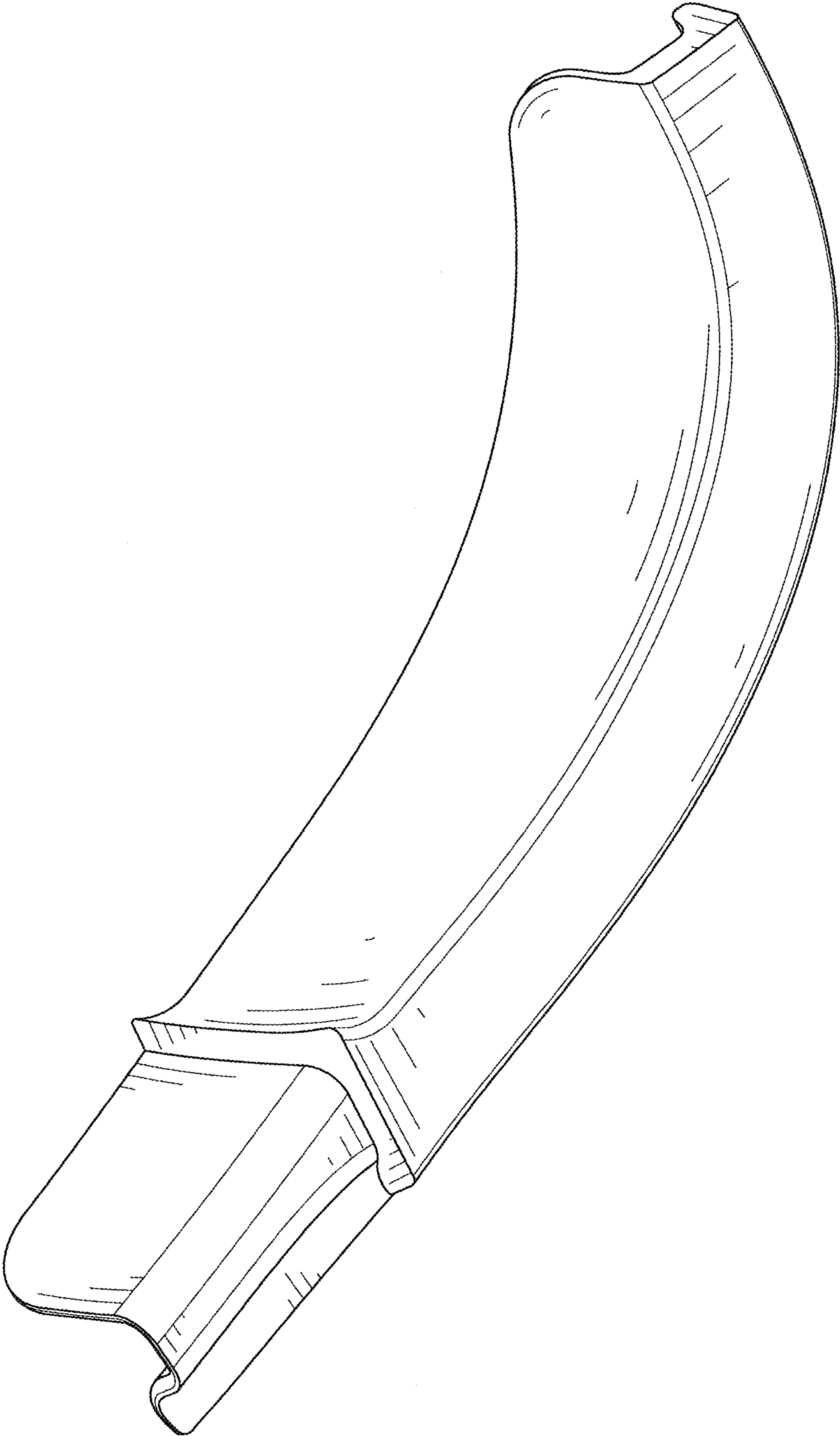

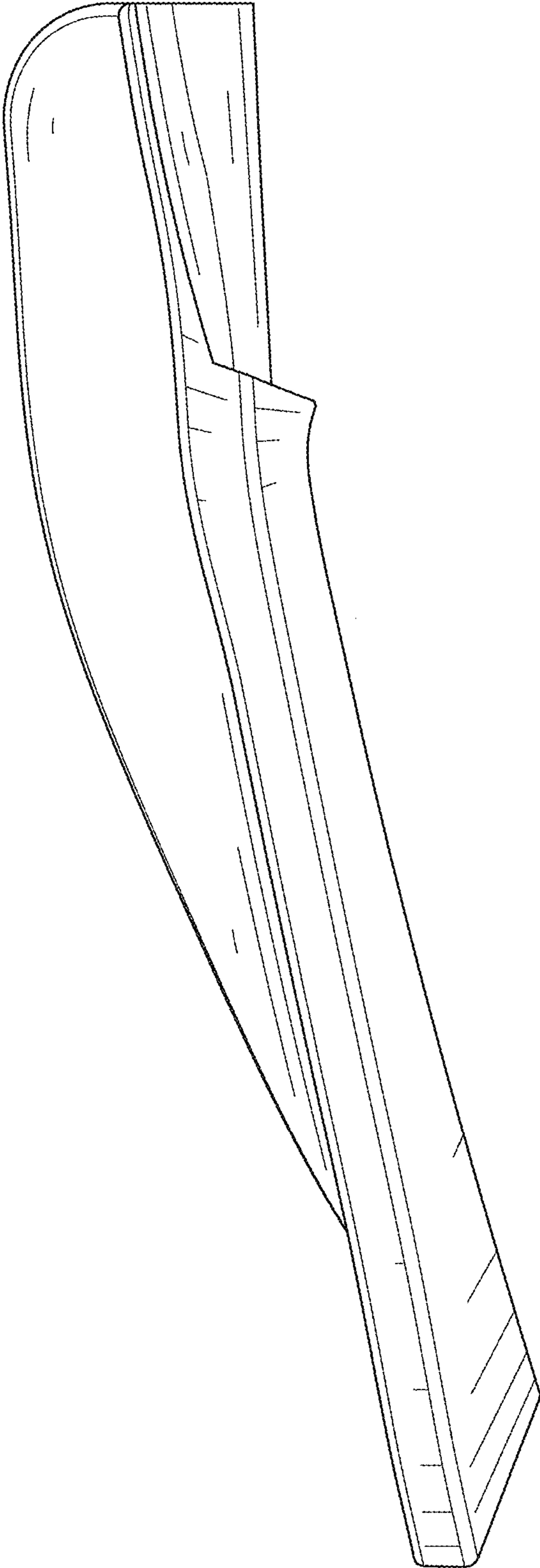

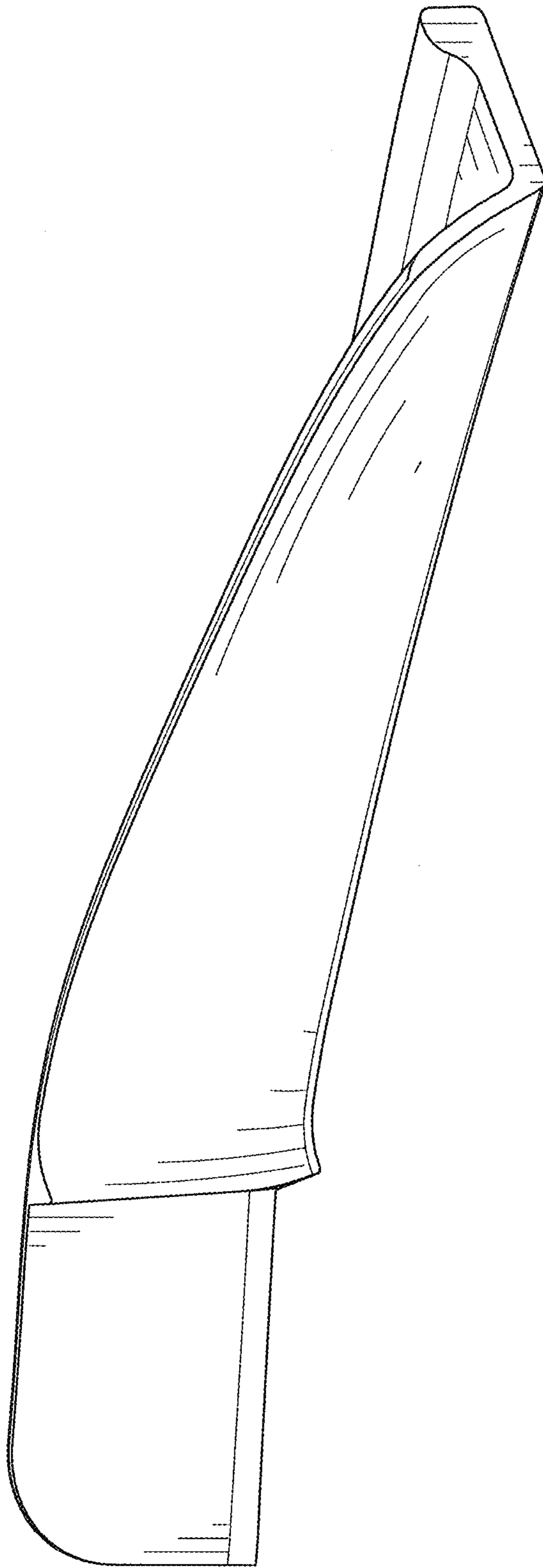

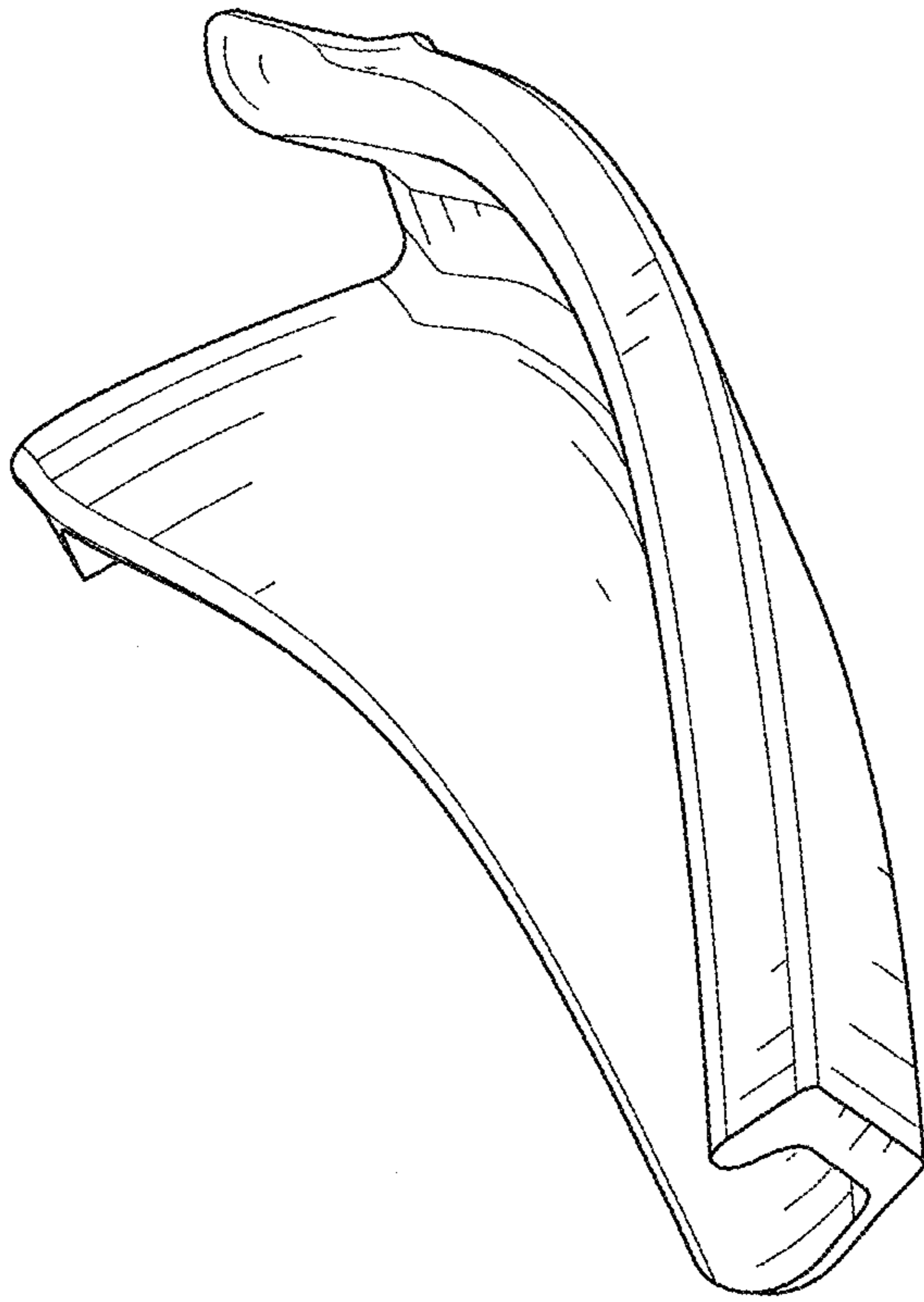

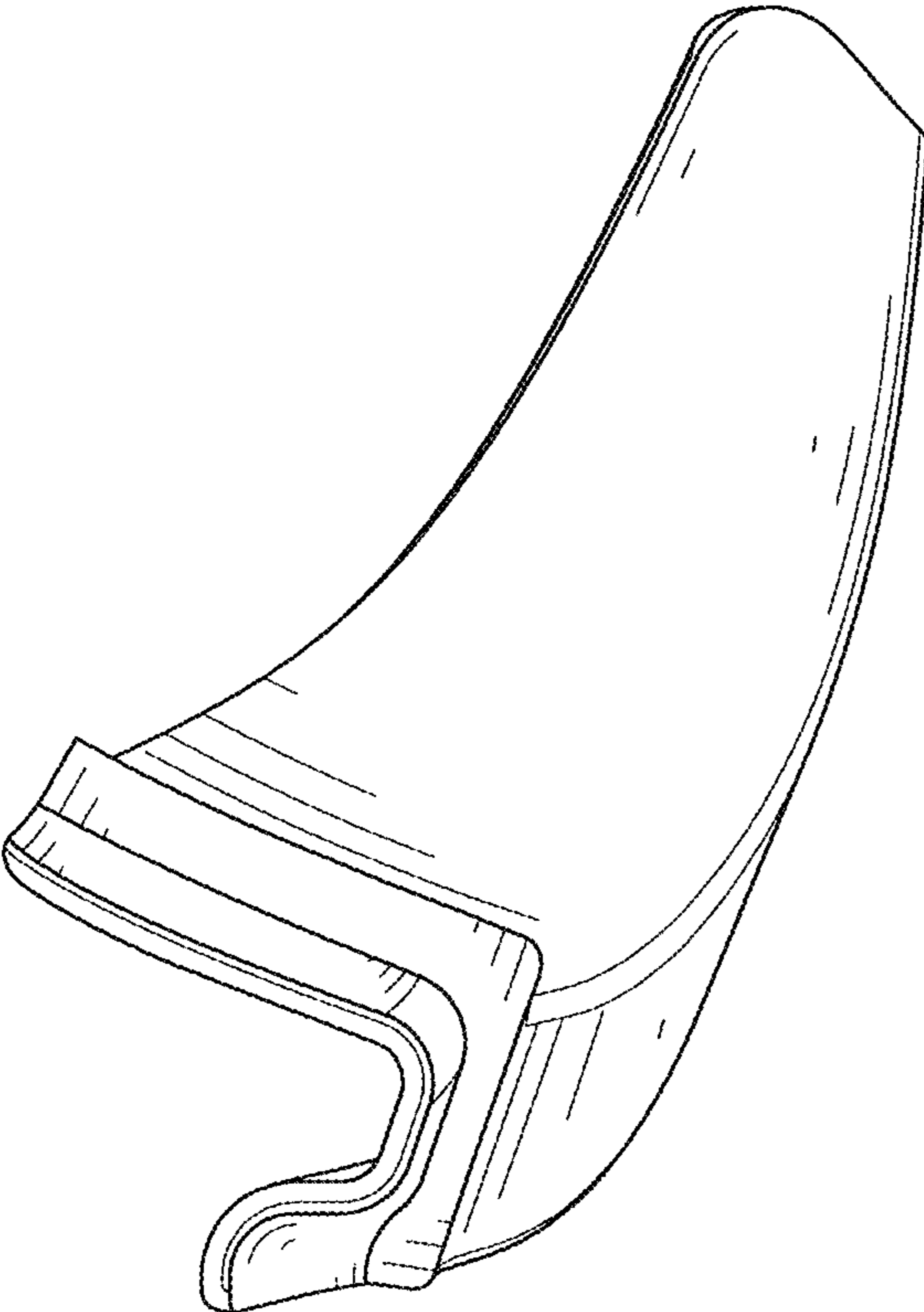
