The ornamental design for a floating platform, as shown and described.

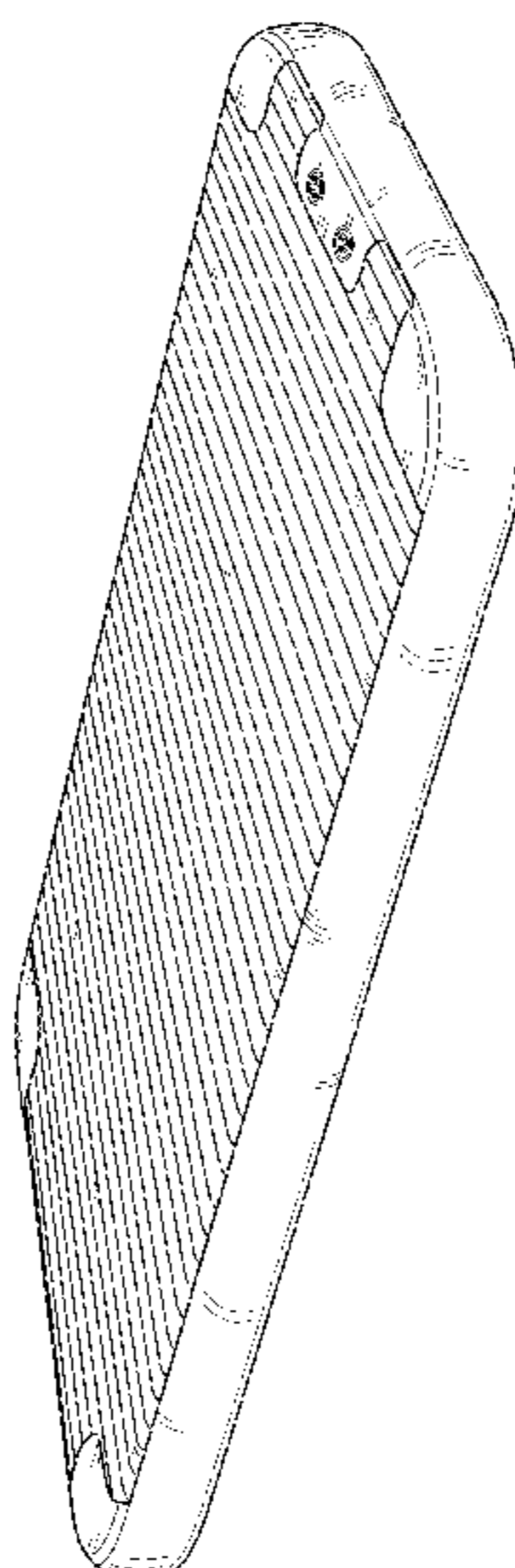
**DESCRIPTION**

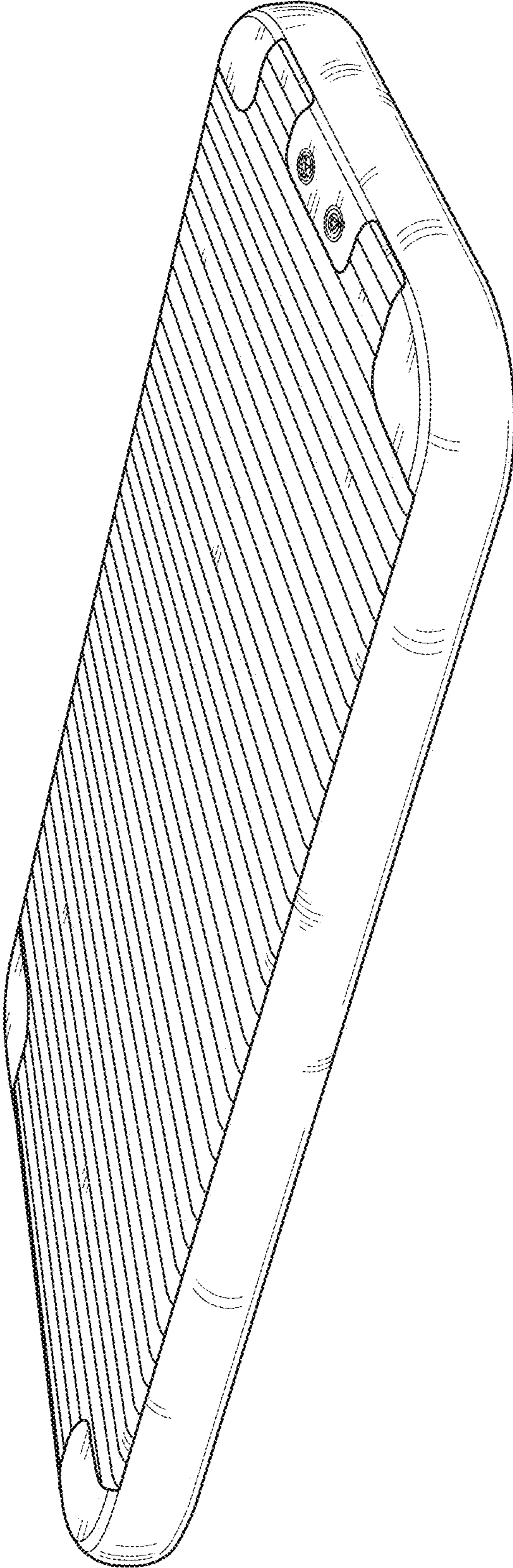

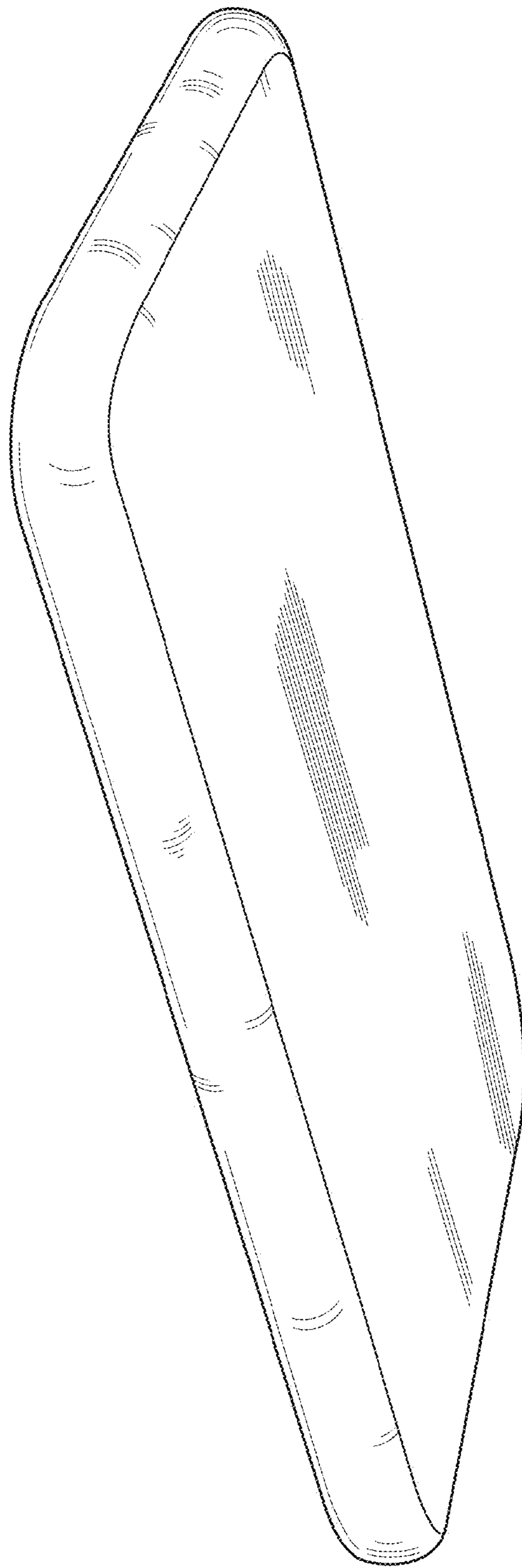

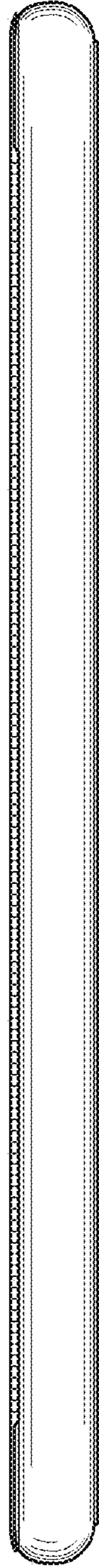

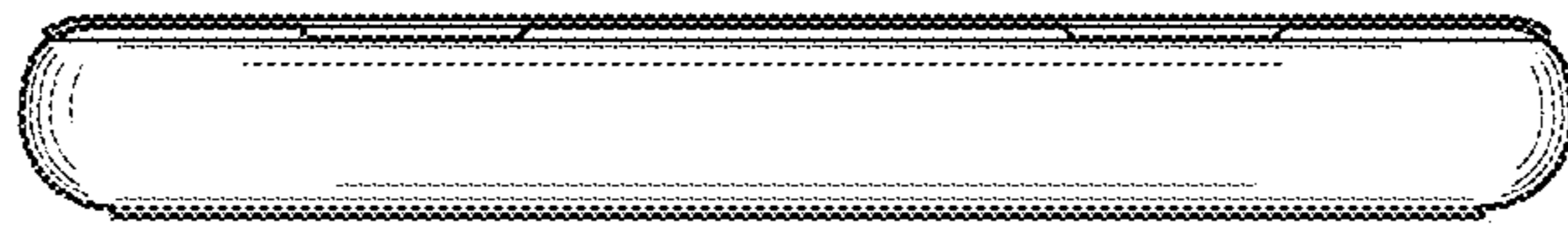

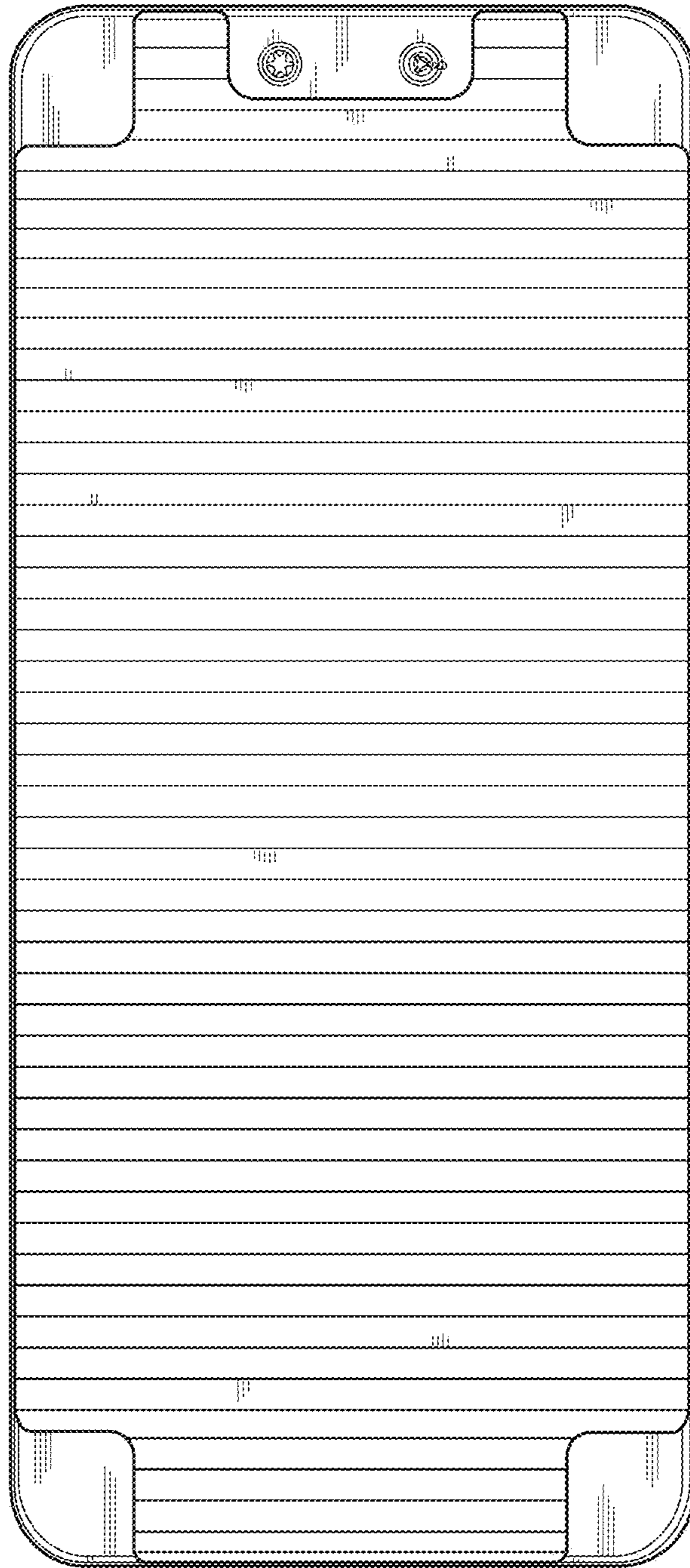

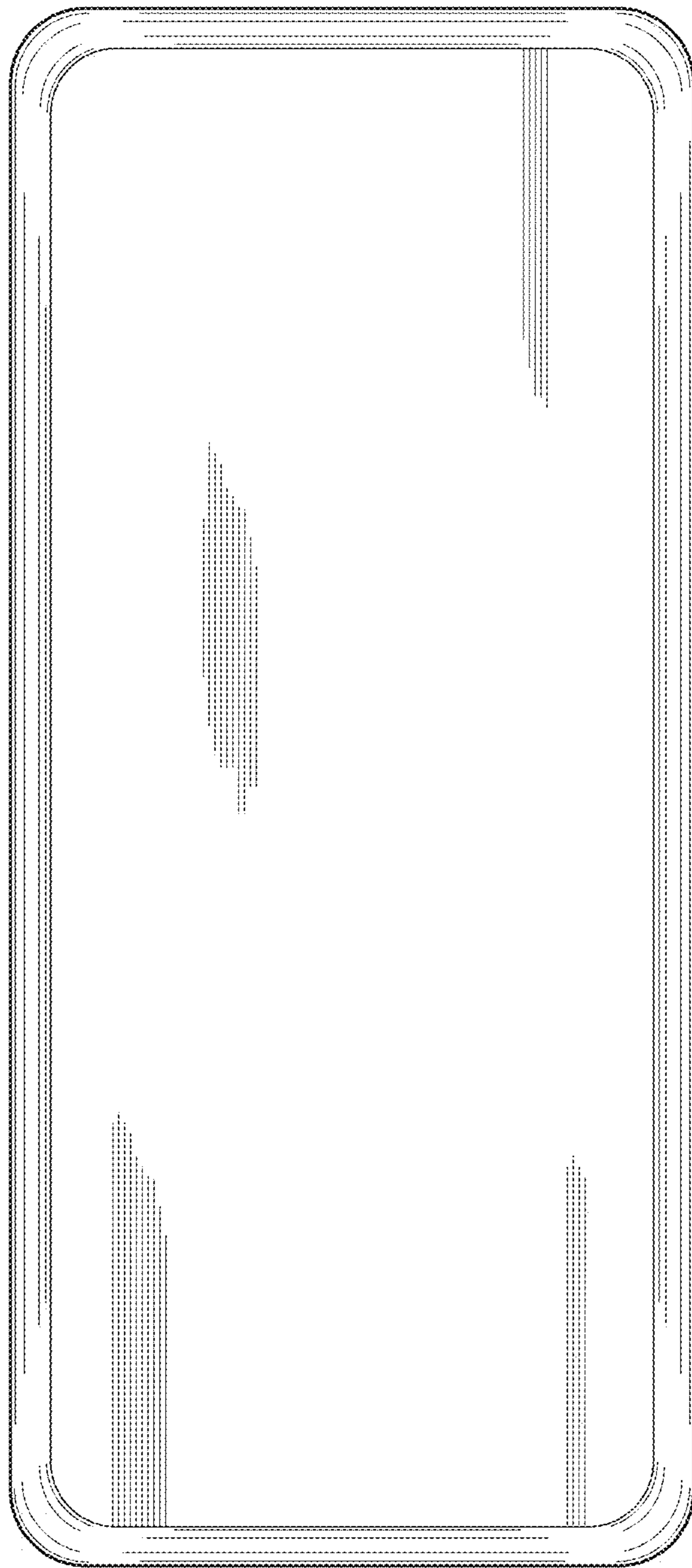
