(57) **CLAIM**

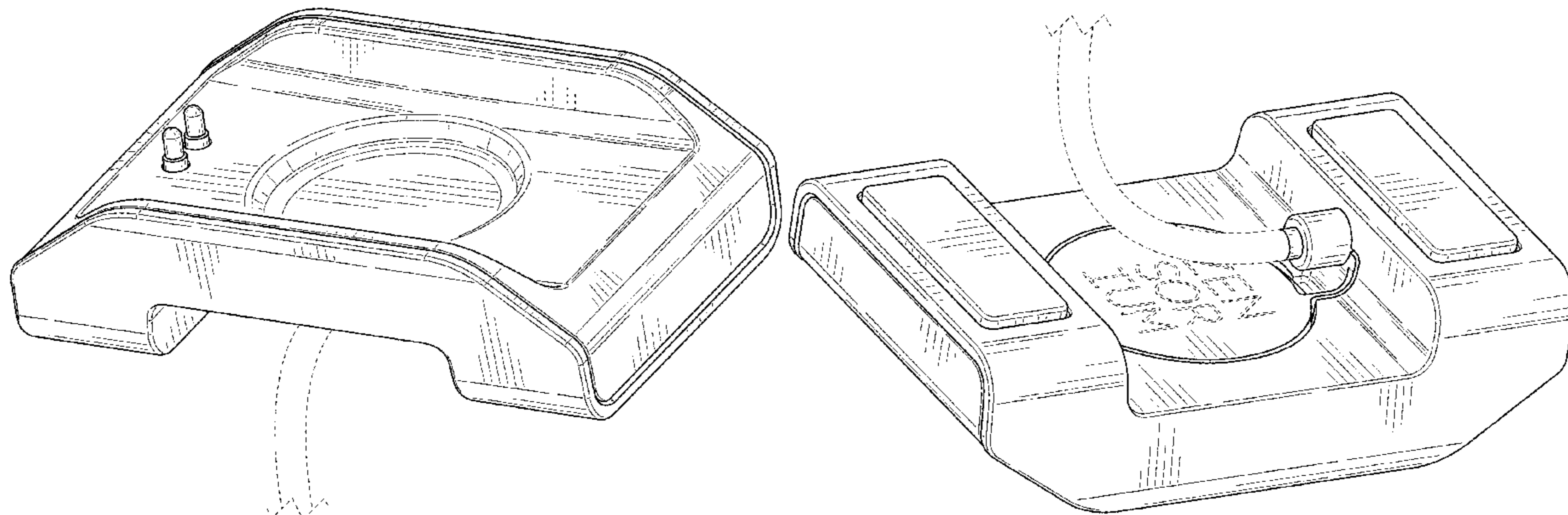
The ornamental design for a charging dock, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a charging dock according to our new design;  
FIG. 2 is a front perspective view of the bottom thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a front elevation view thereof;  
FIG. 8 is a rear elevation view thereof;  
FIG. 9 is a cross-sectional view thereof, taken across line 9-9 of FIG. 6; and,  
FIG. 10 is a cross-sectional view thereof, taken across line 10-10 of FIG. 8.

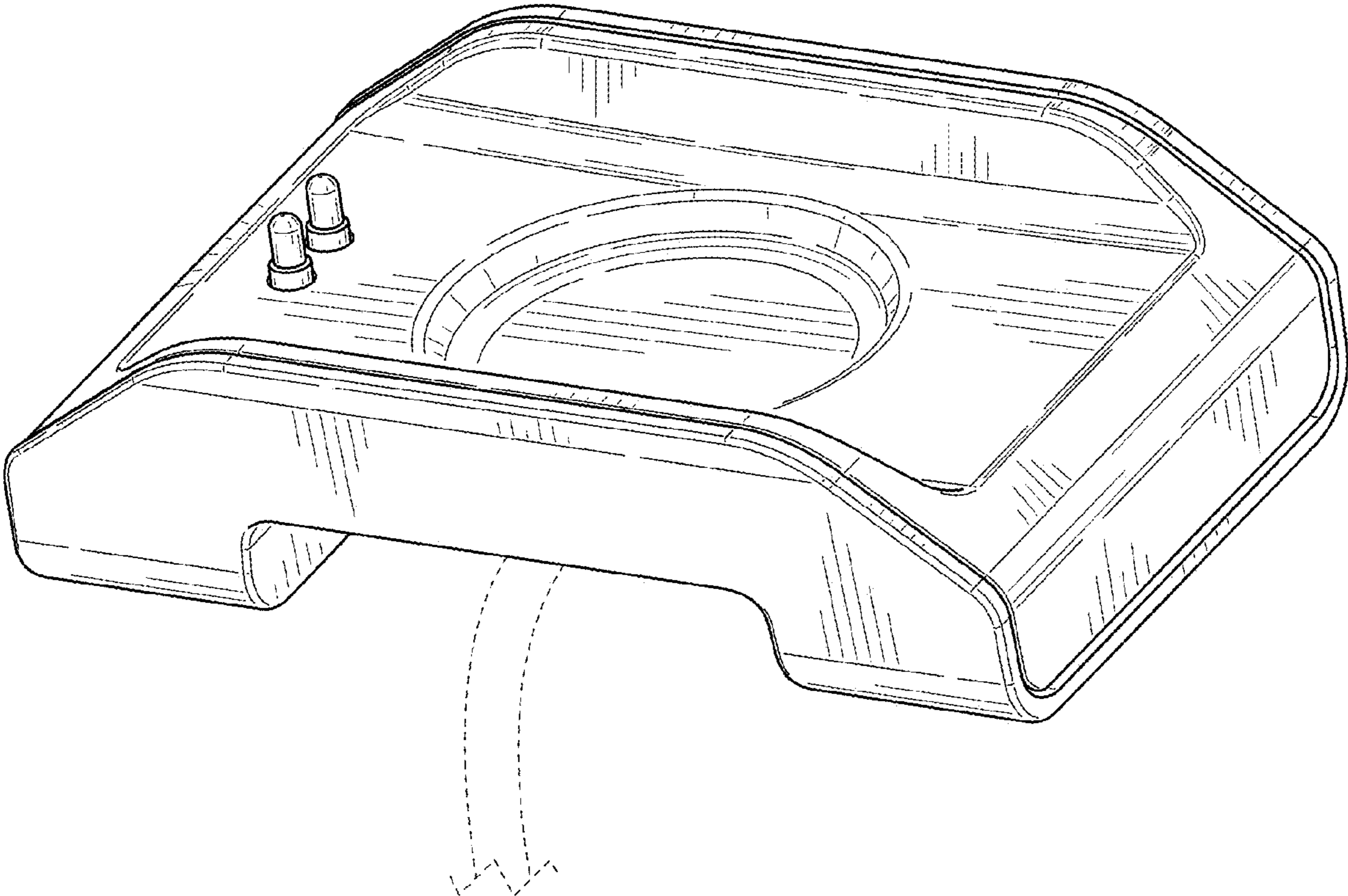

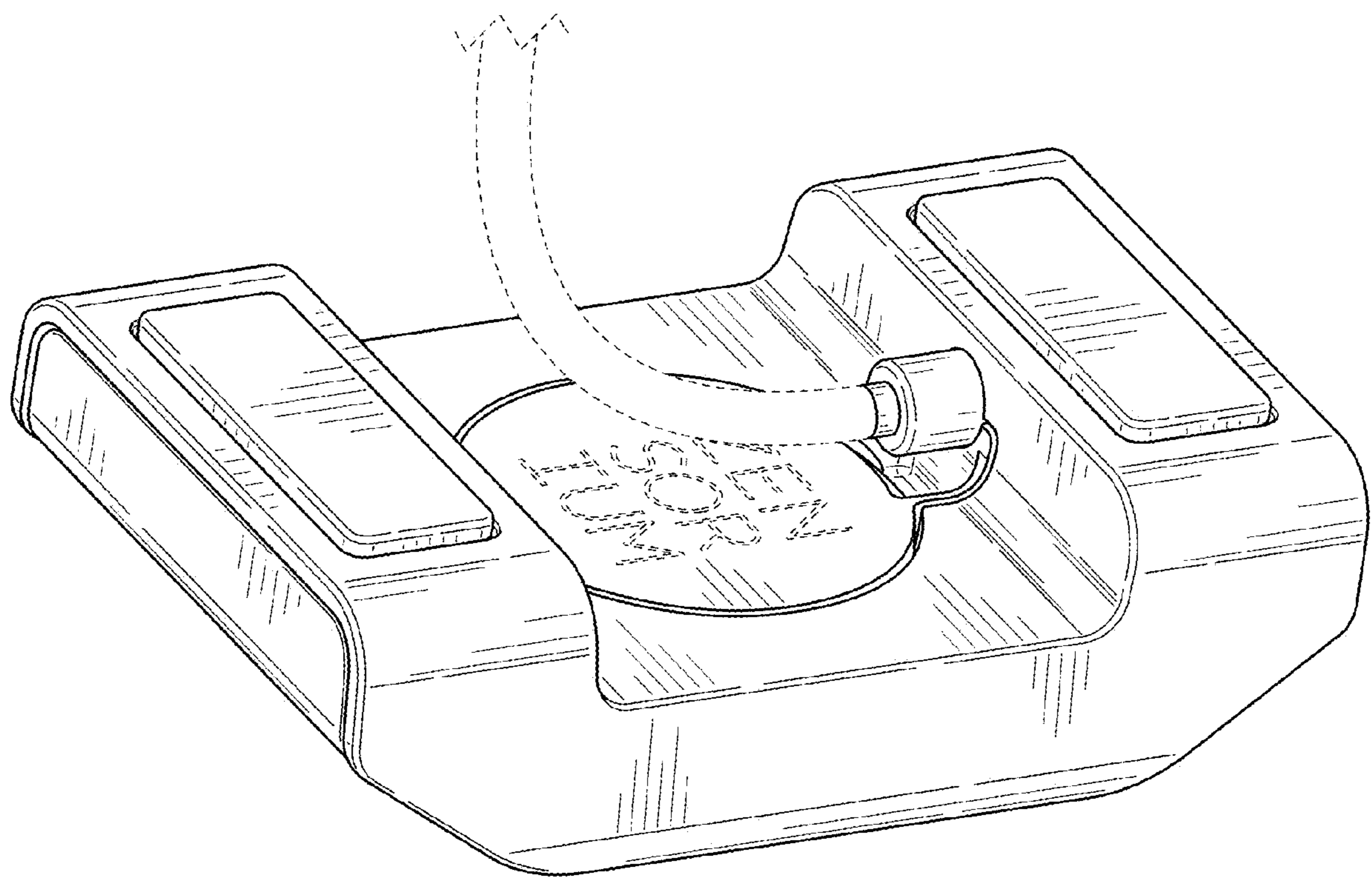

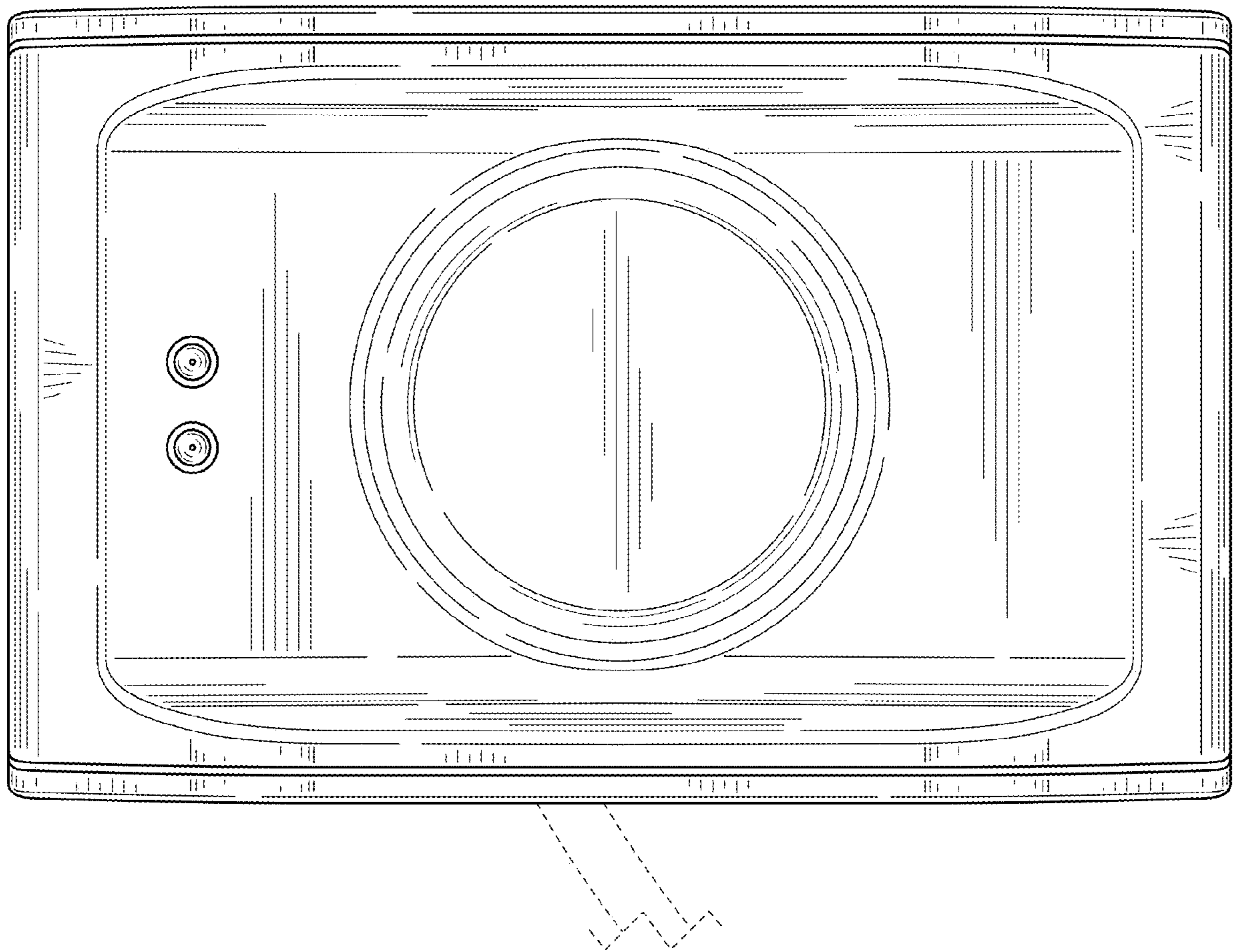

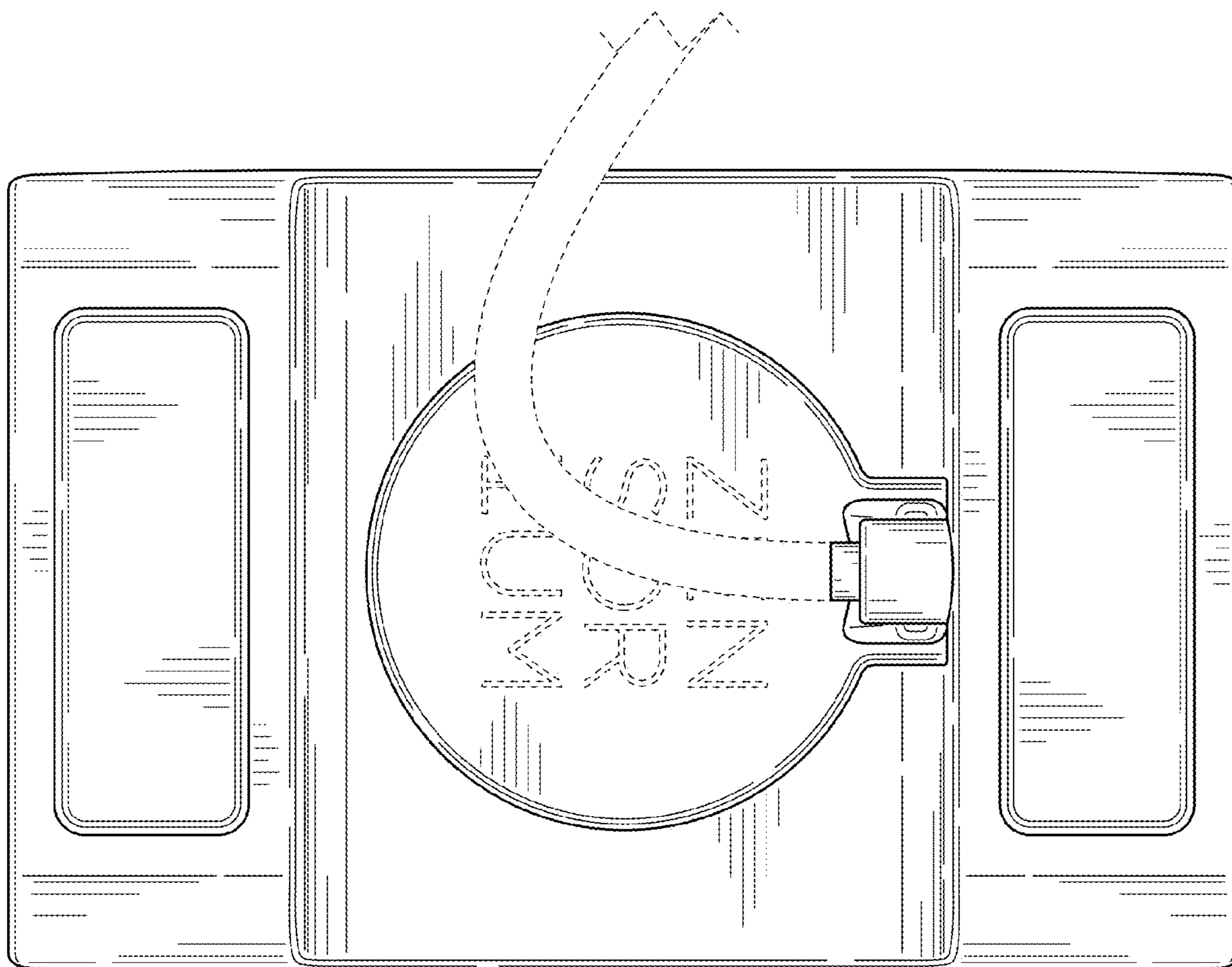

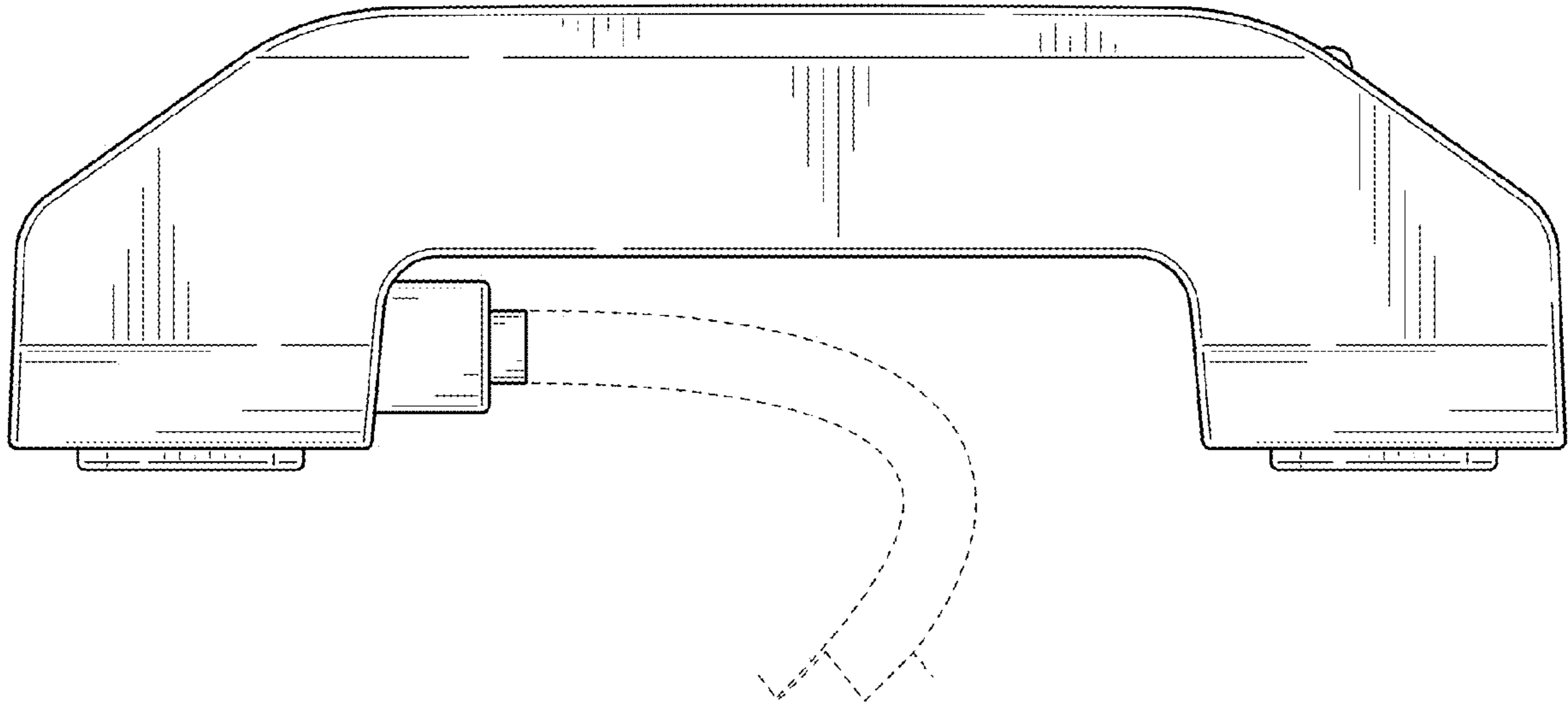

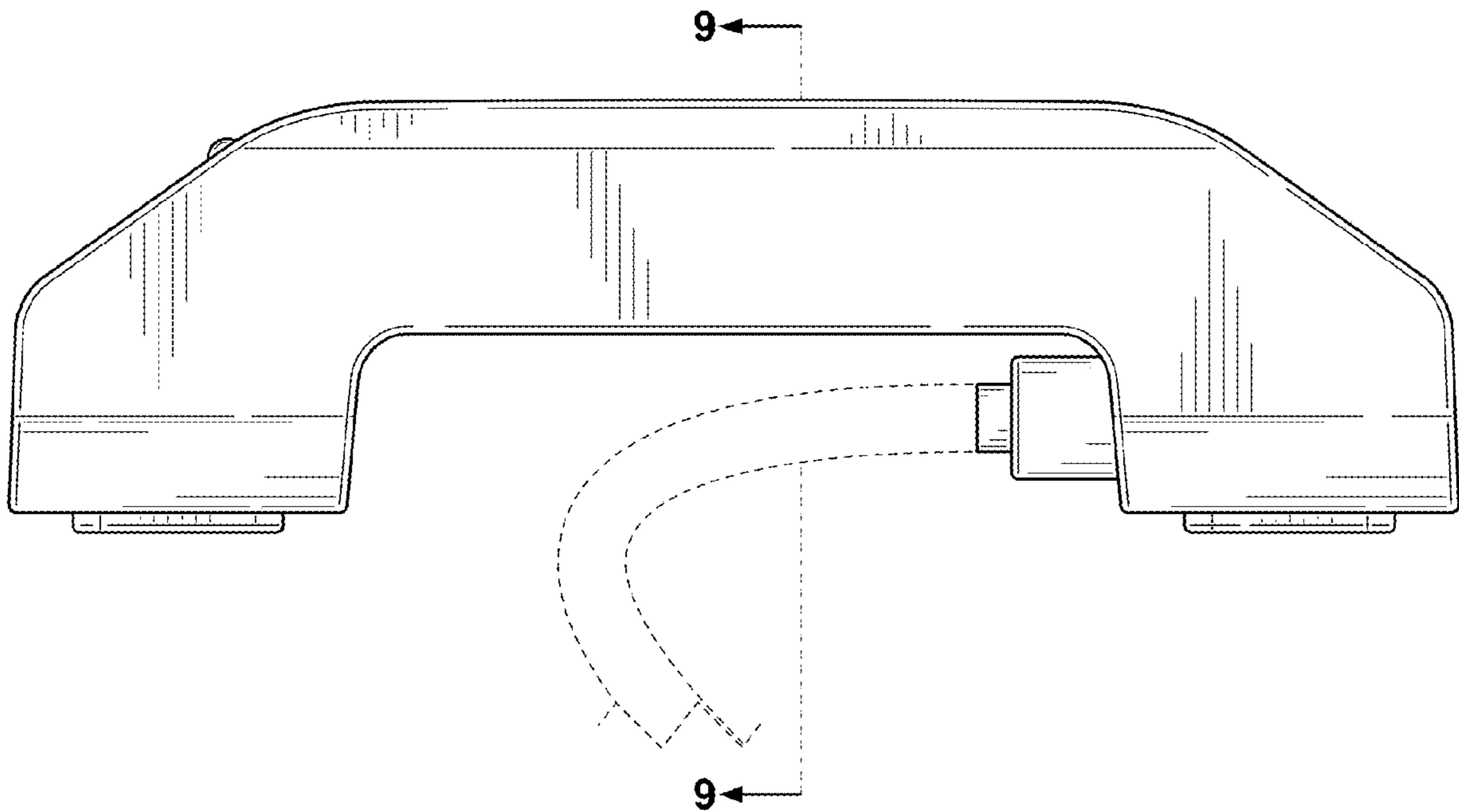

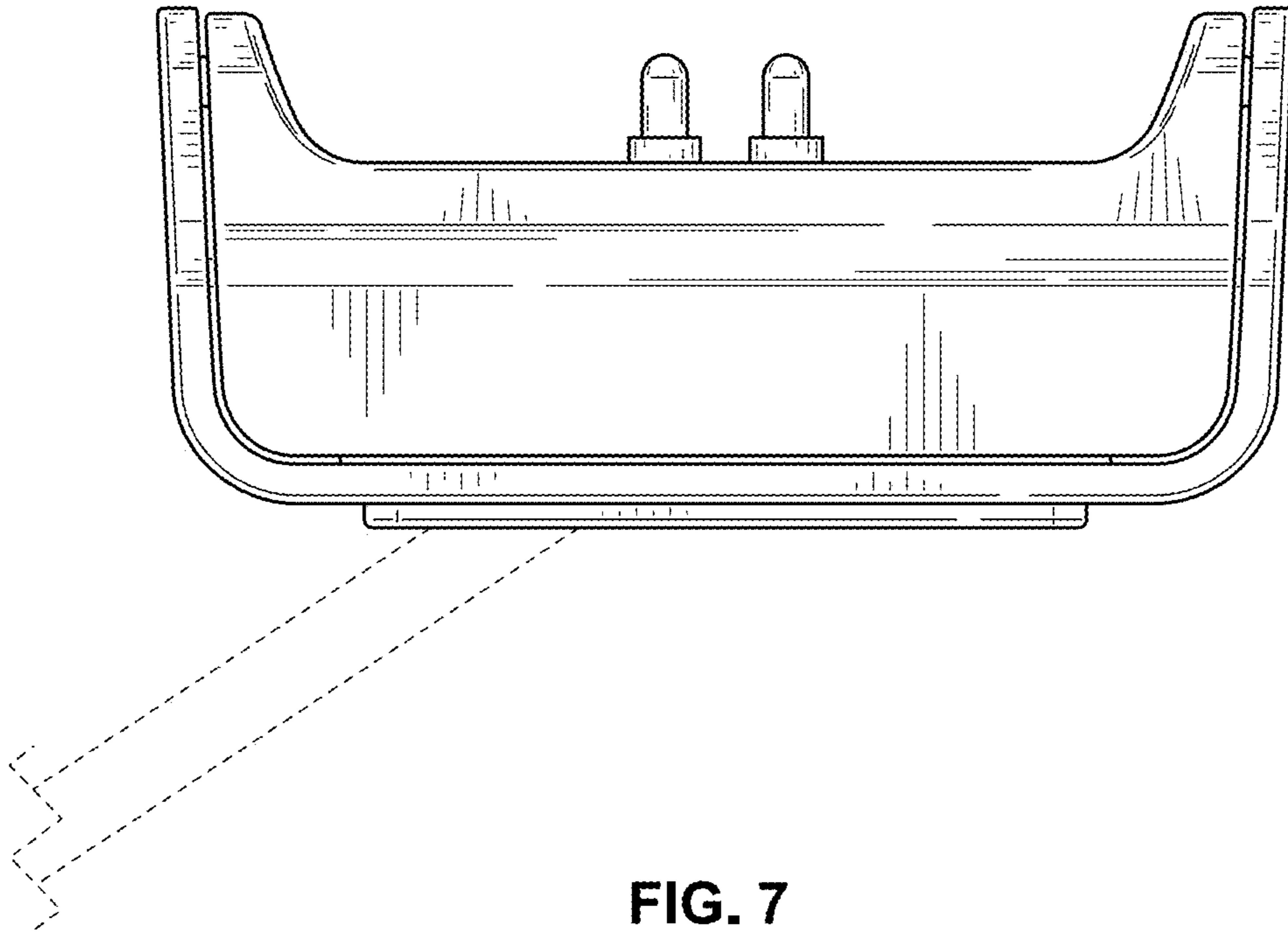

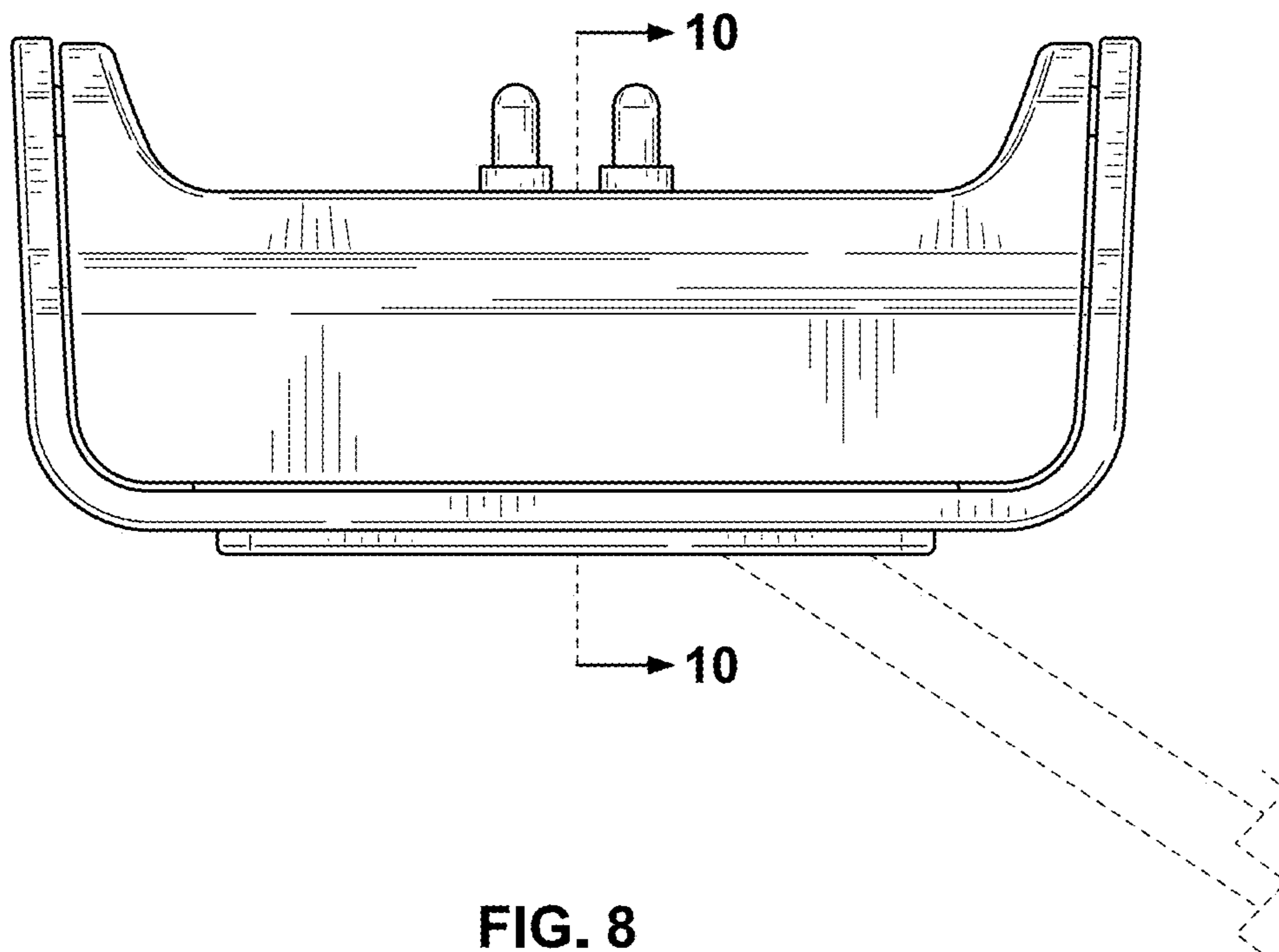

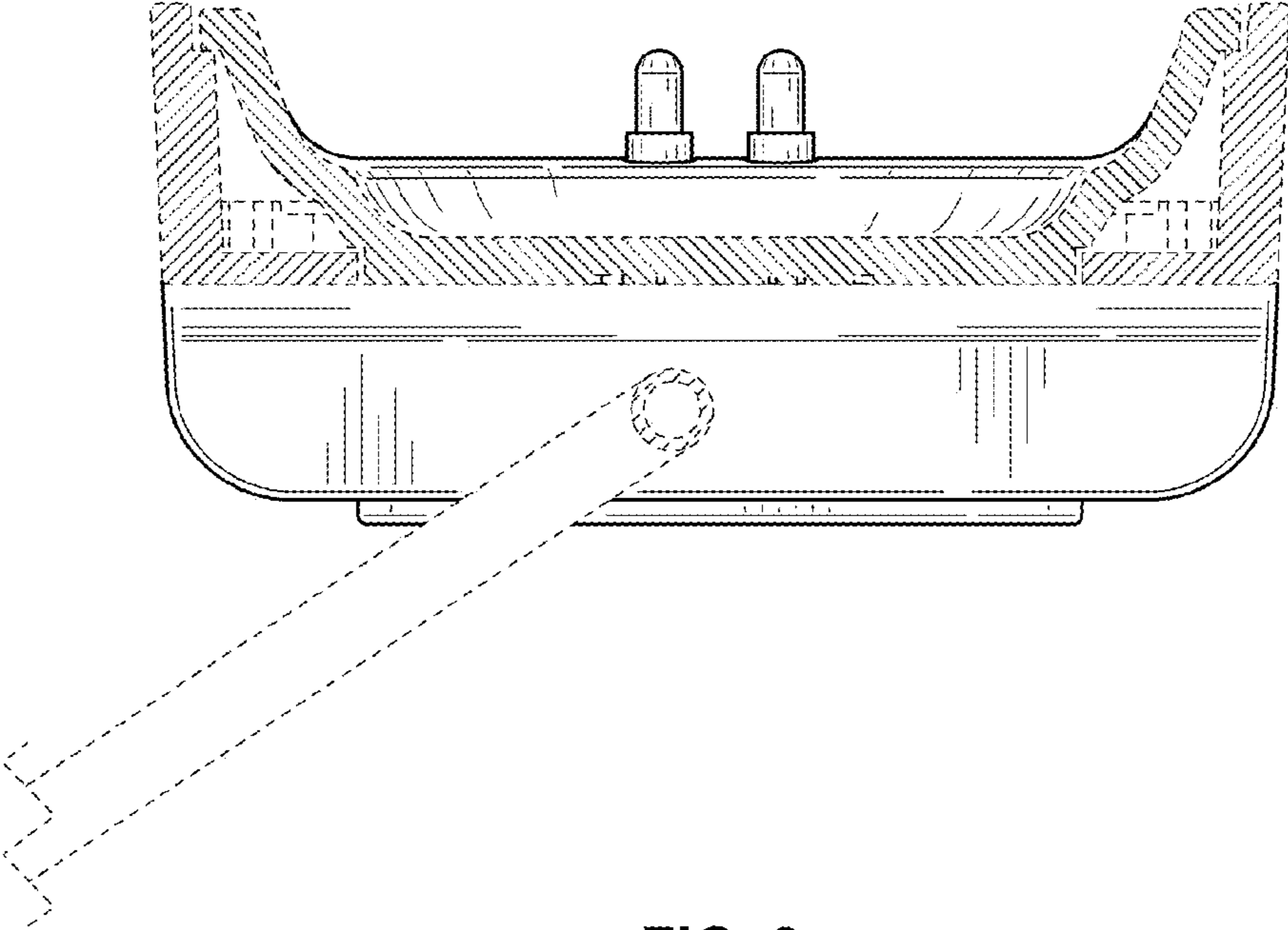

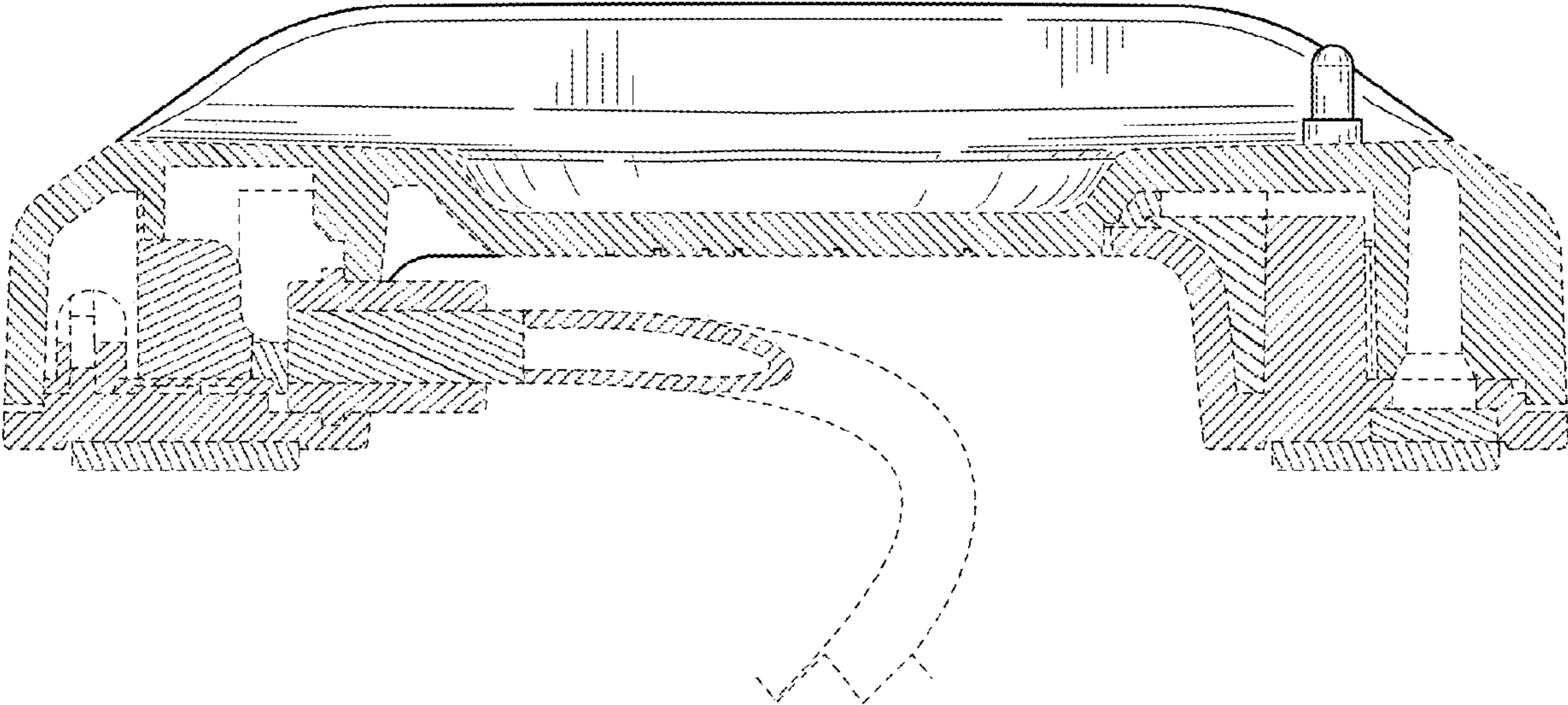
