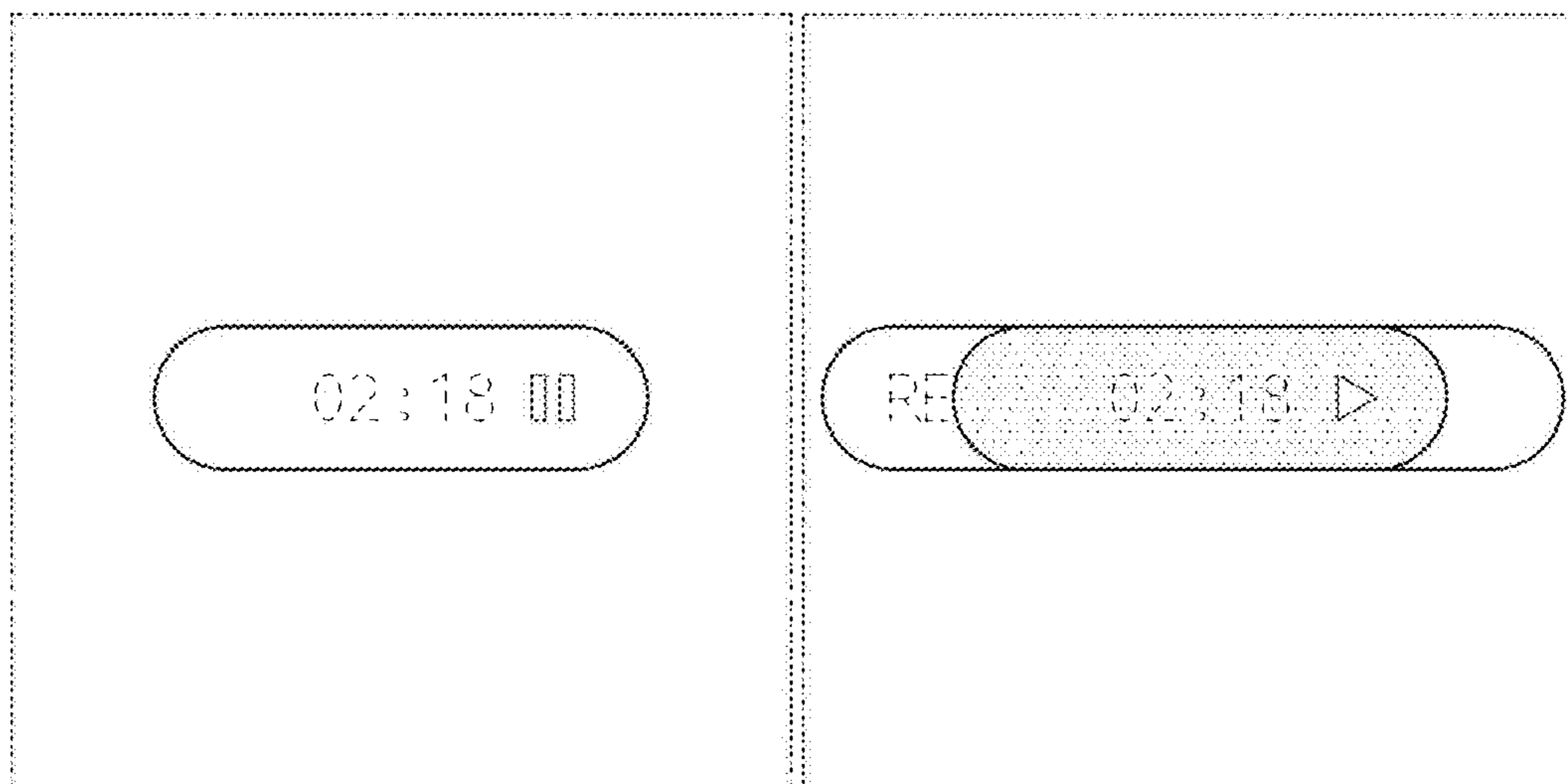
FIG. 1 is a front view of a display screen or portion thereof with a first image in a sequence of an animated graphical user interface, showing the design;

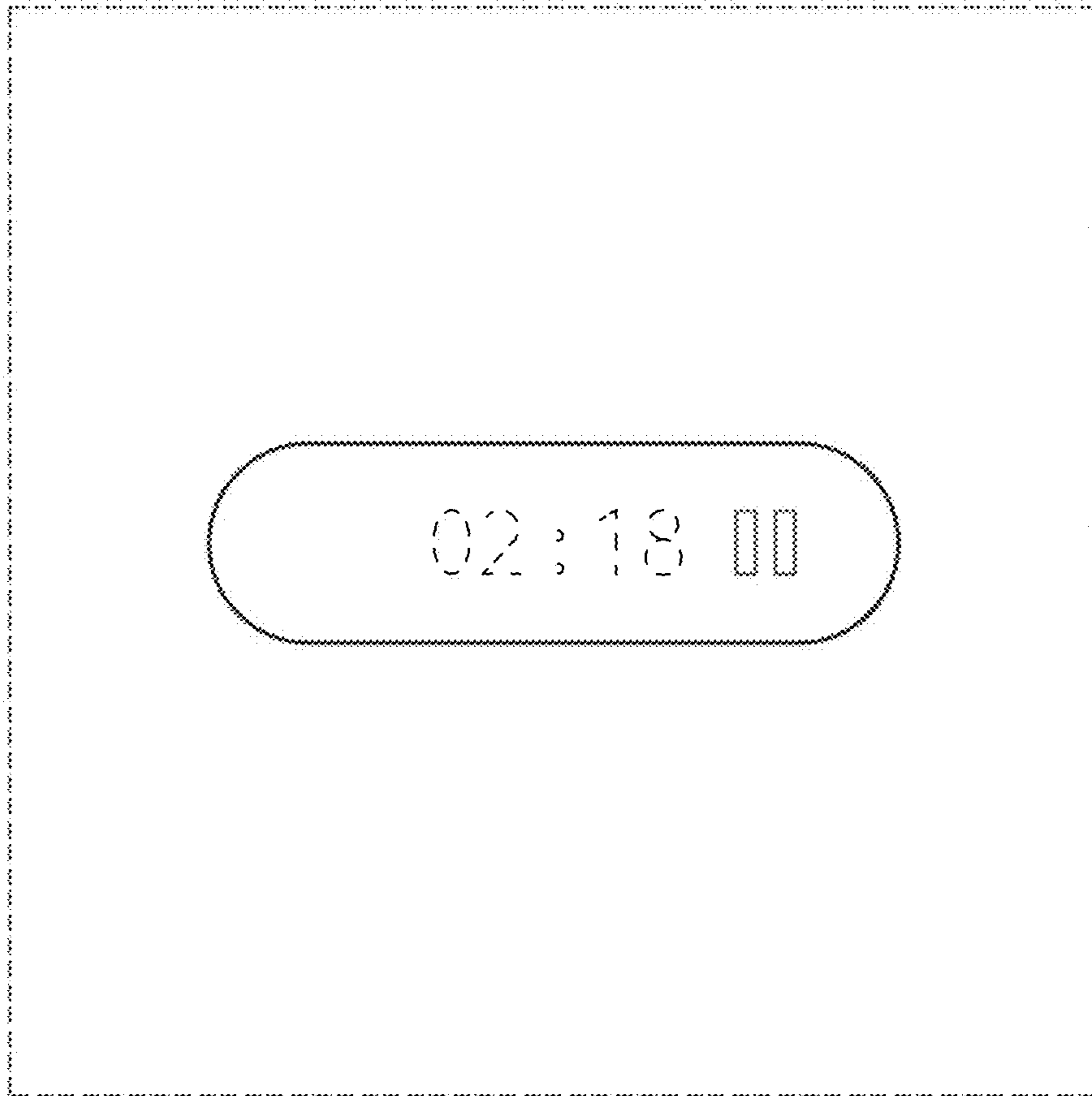

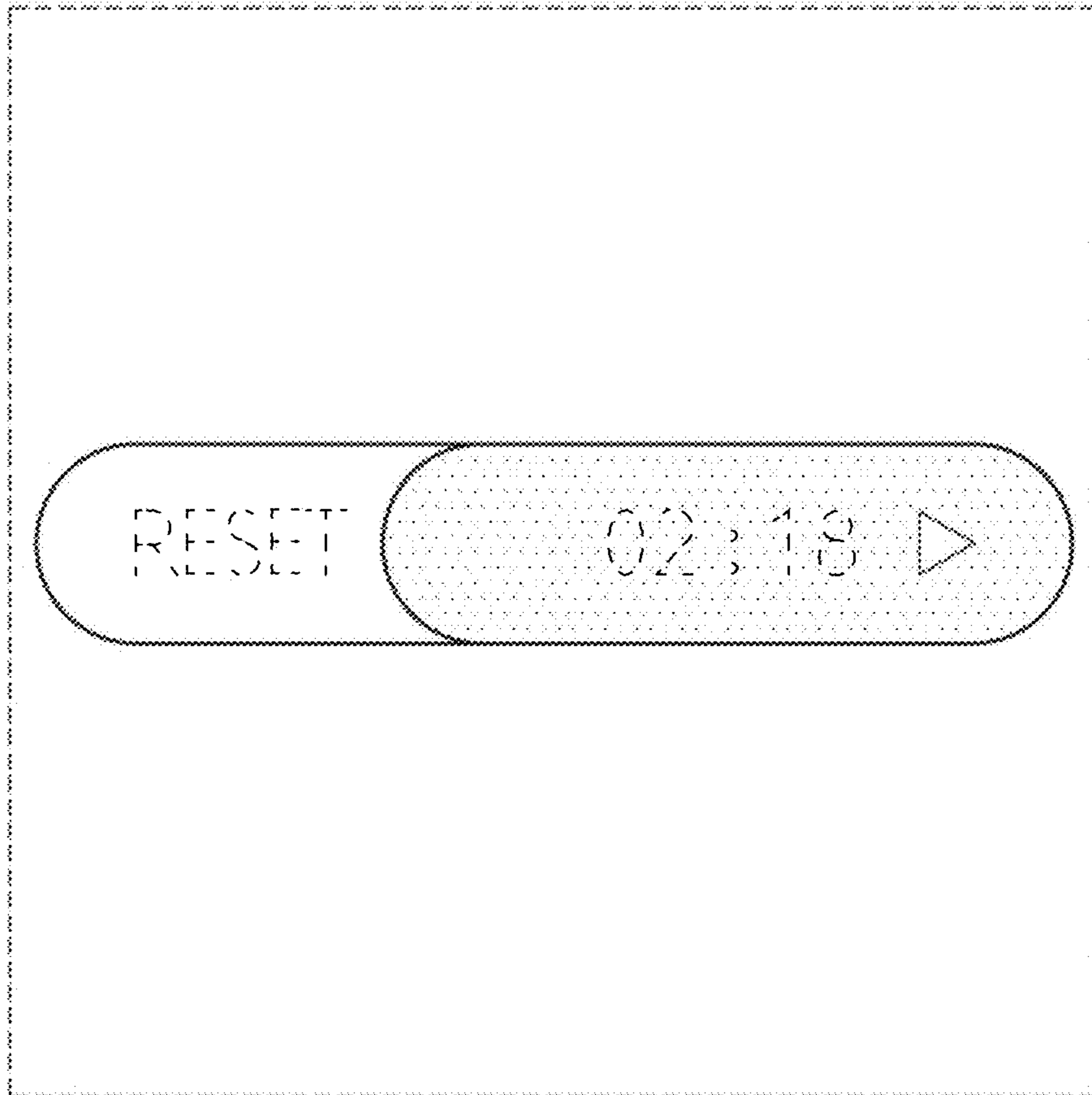

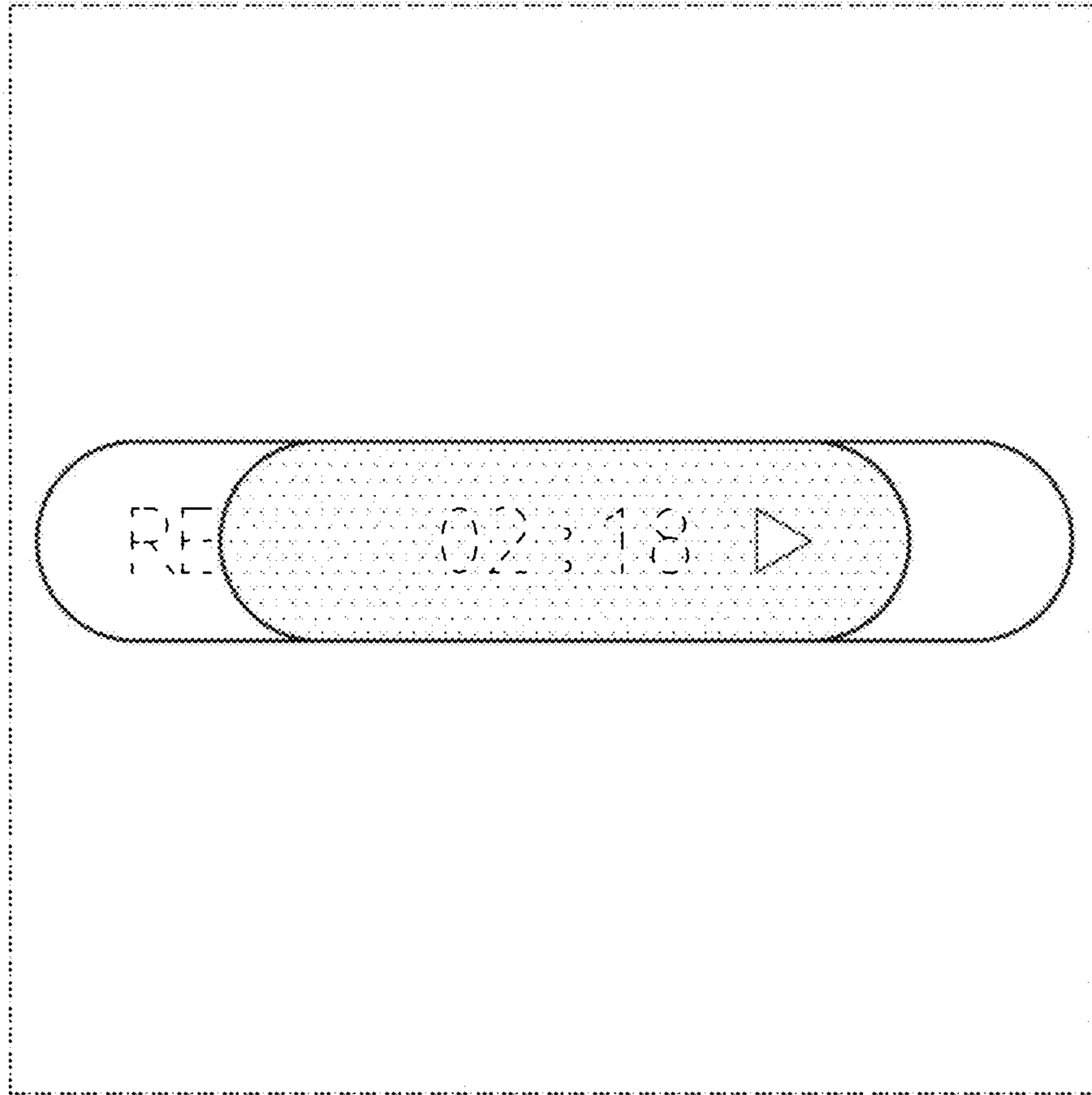

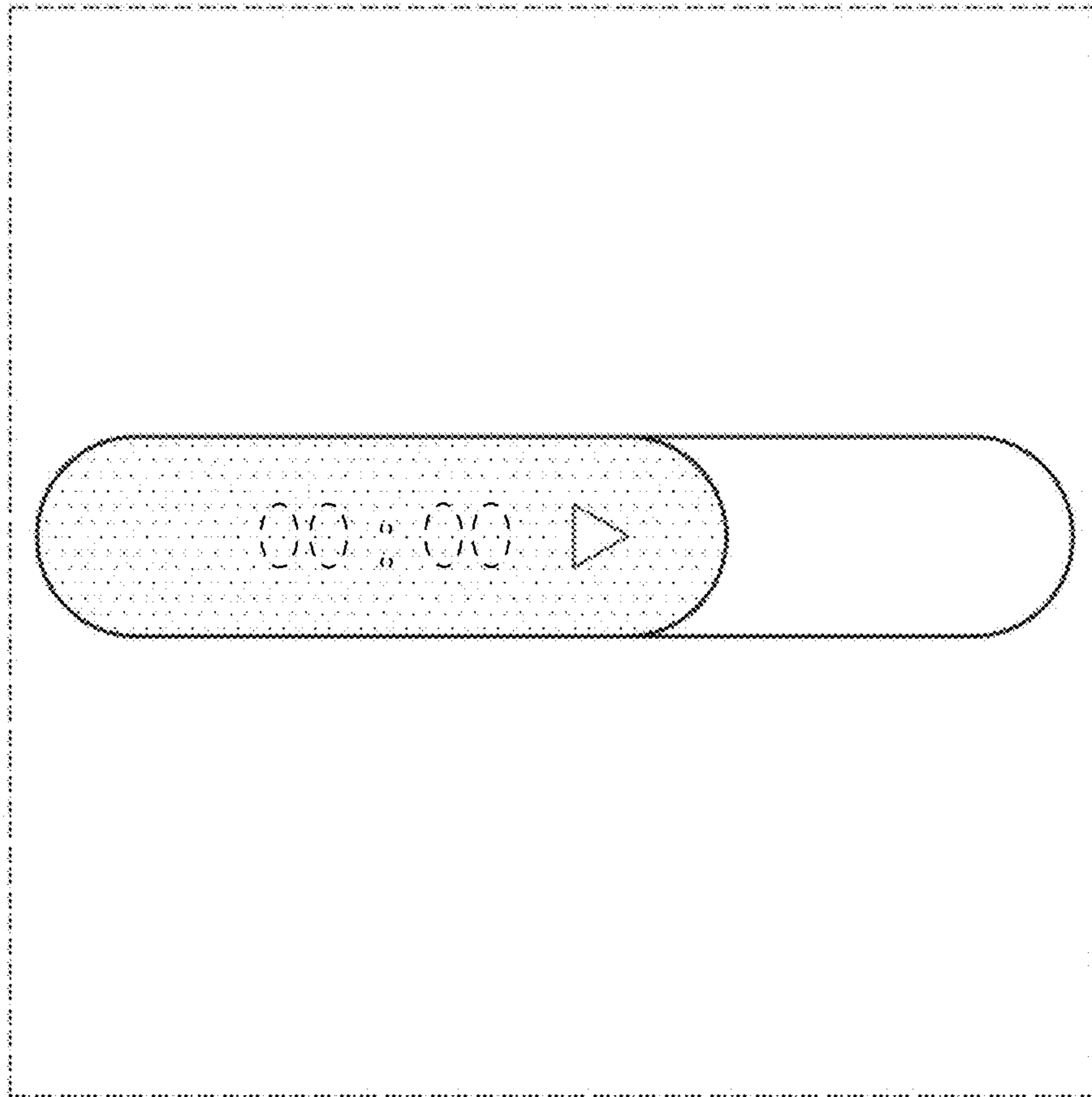

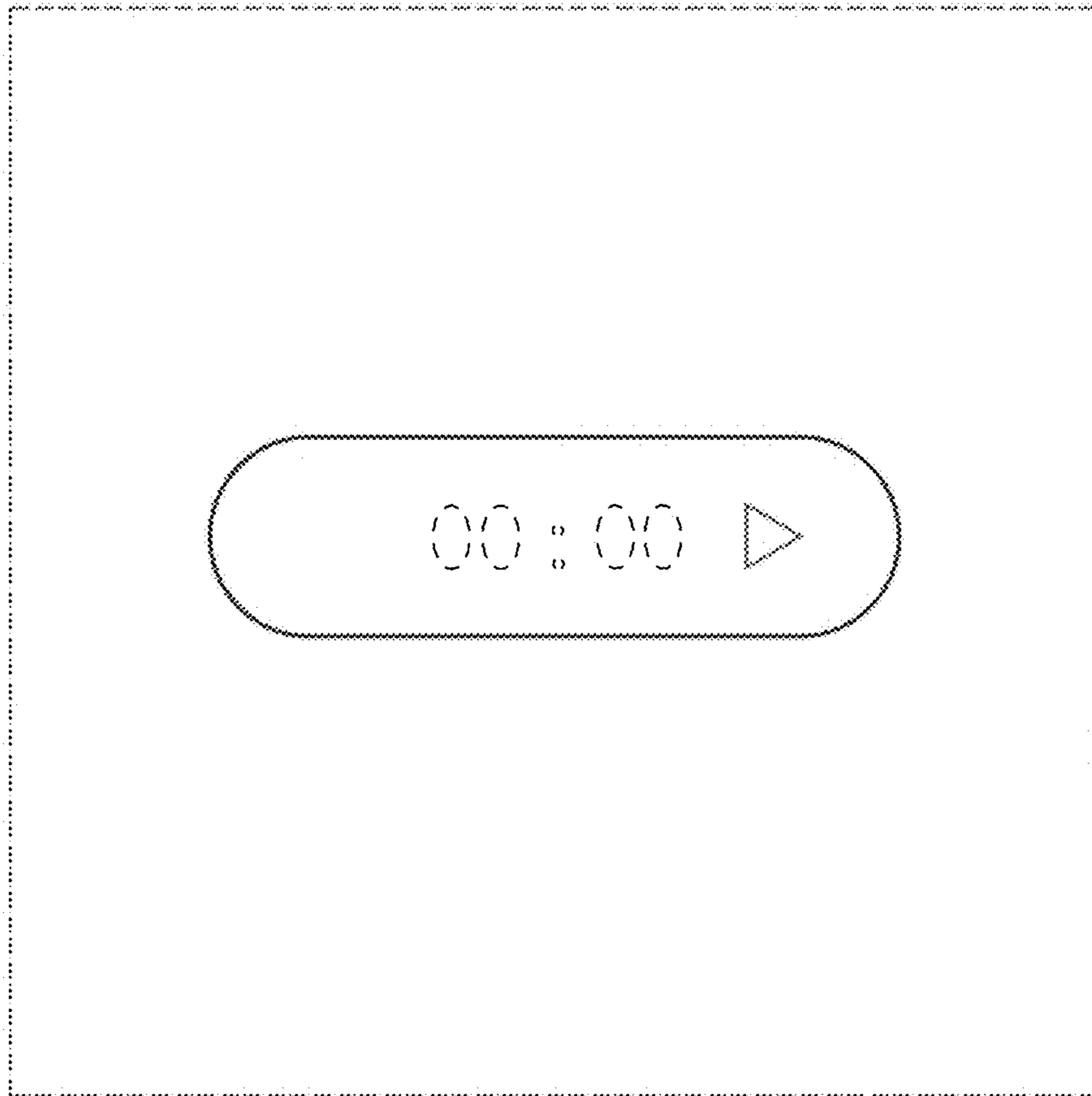
