FIG. 4 is a rear view of the agricultural baler of FIG. 1.

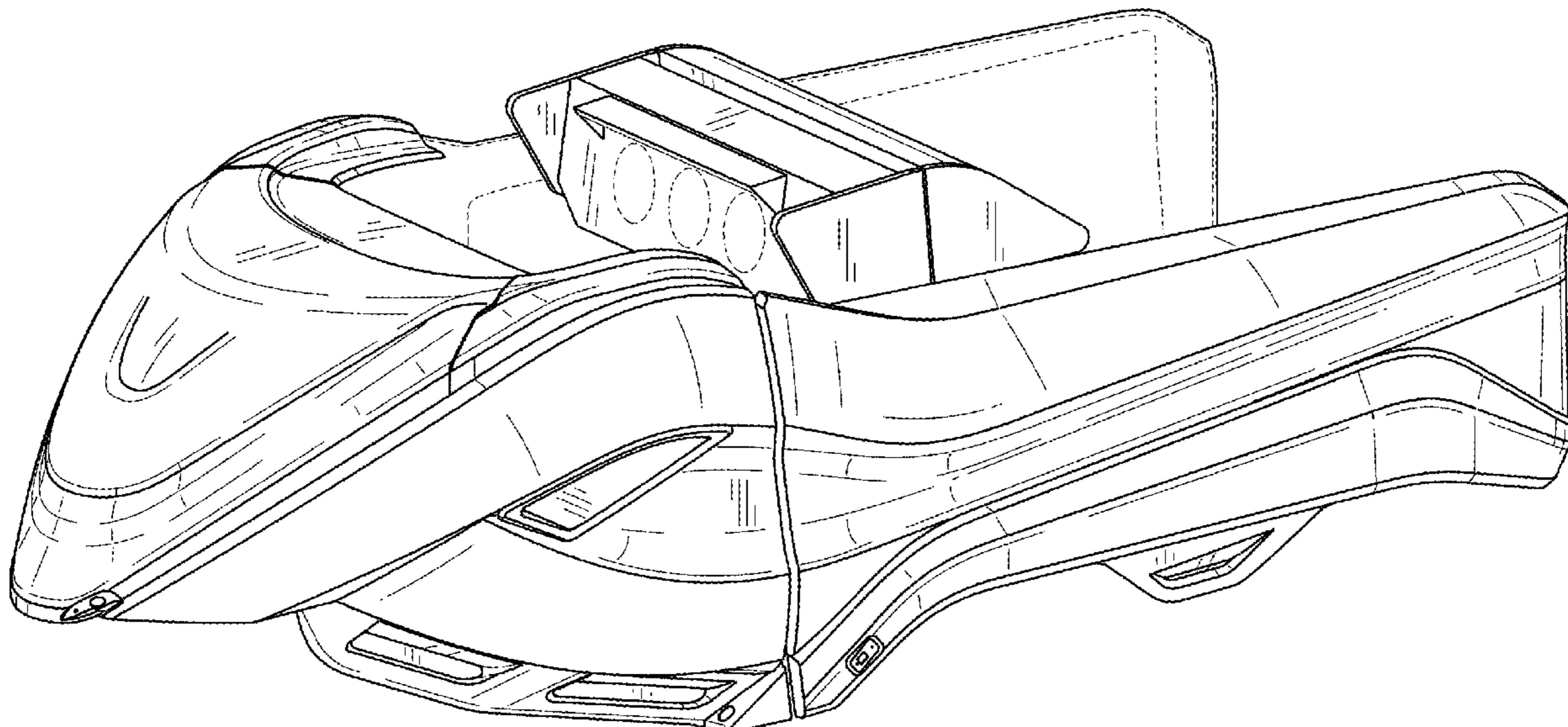
FIG. 5 is a left side view of the agricultural baler of FIG. 1.

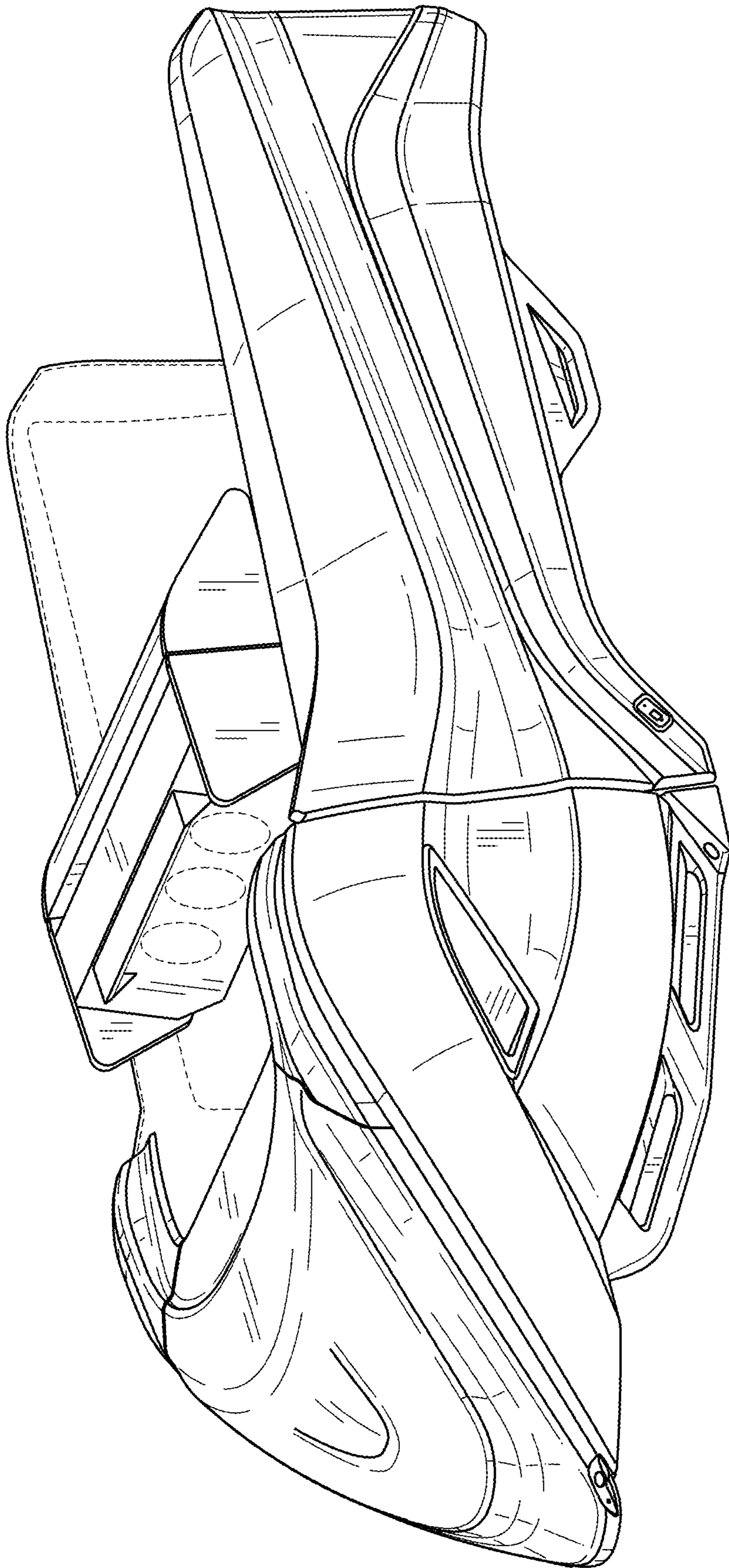

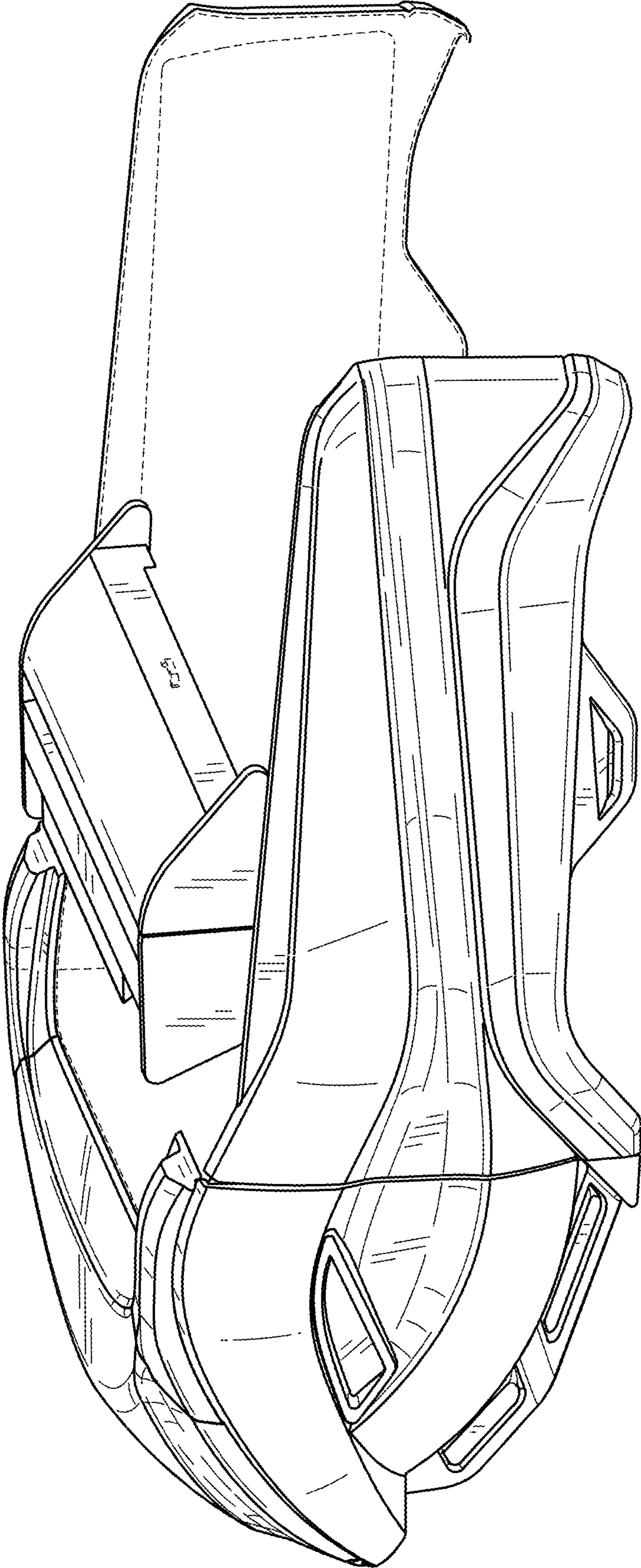

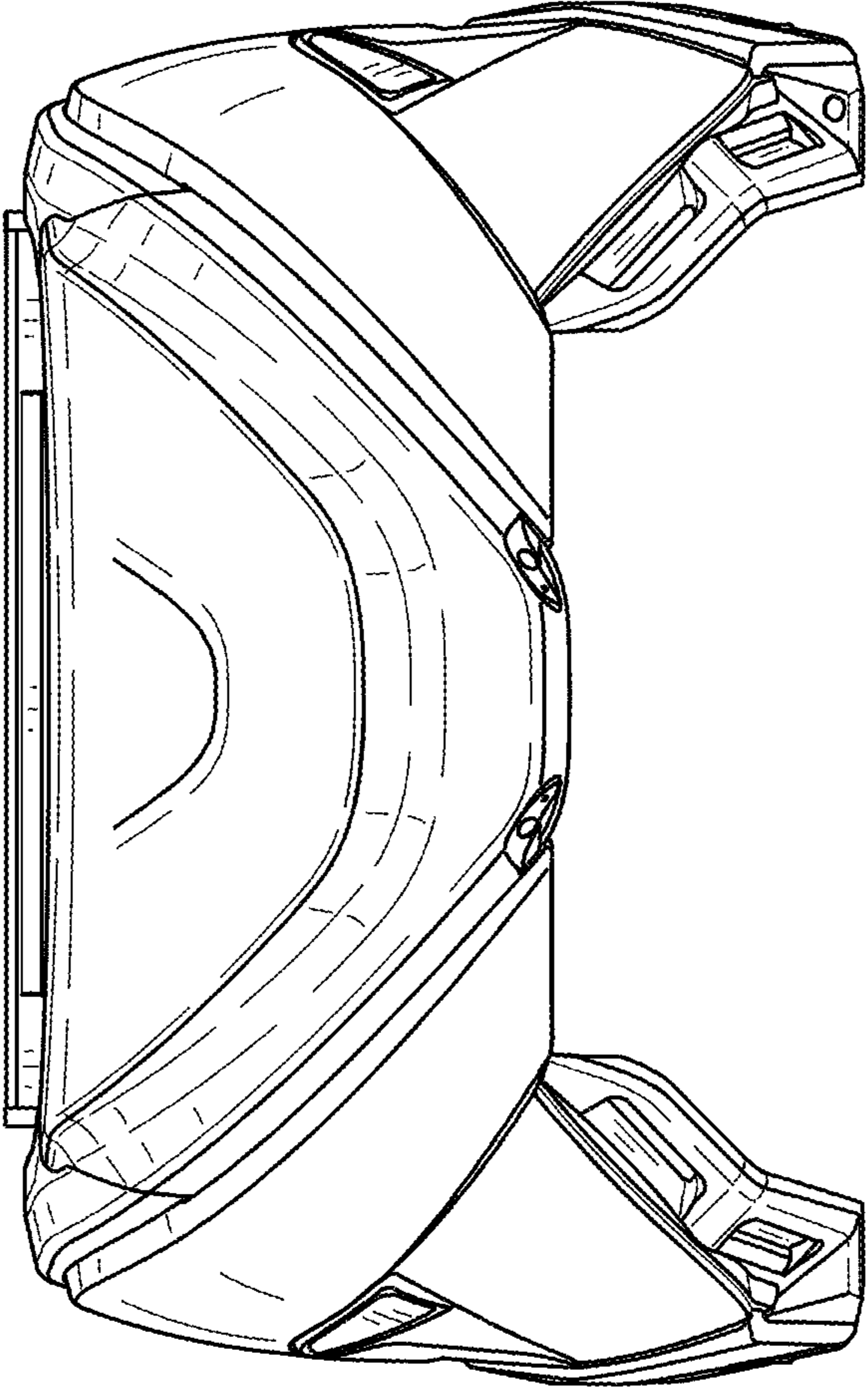

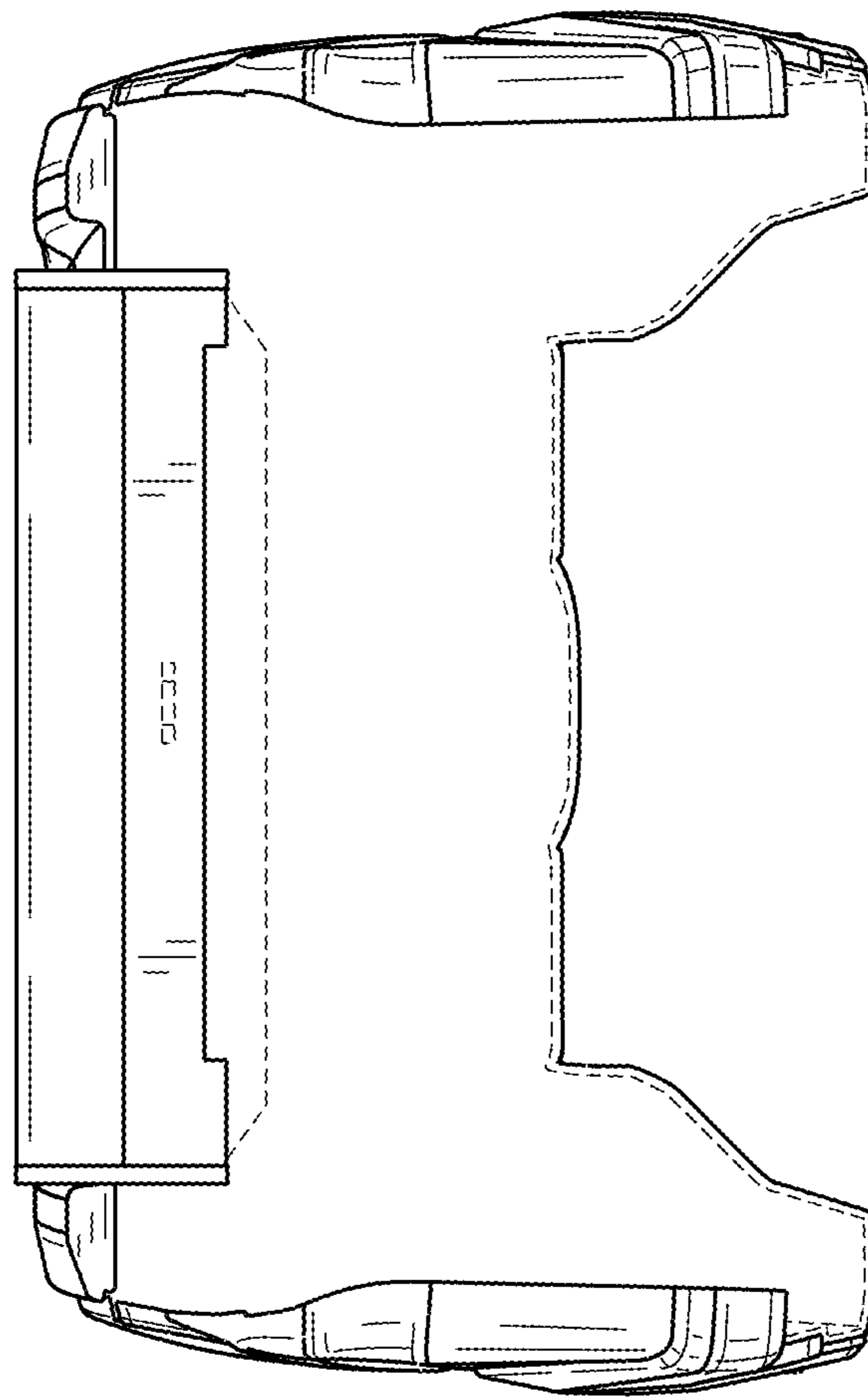

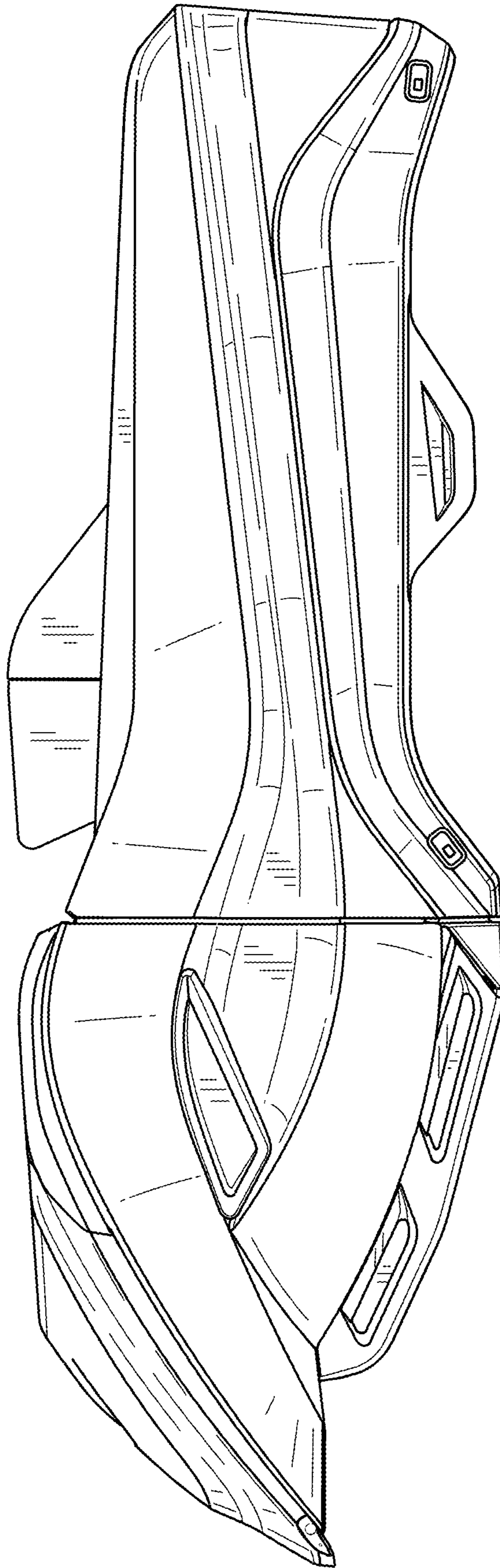

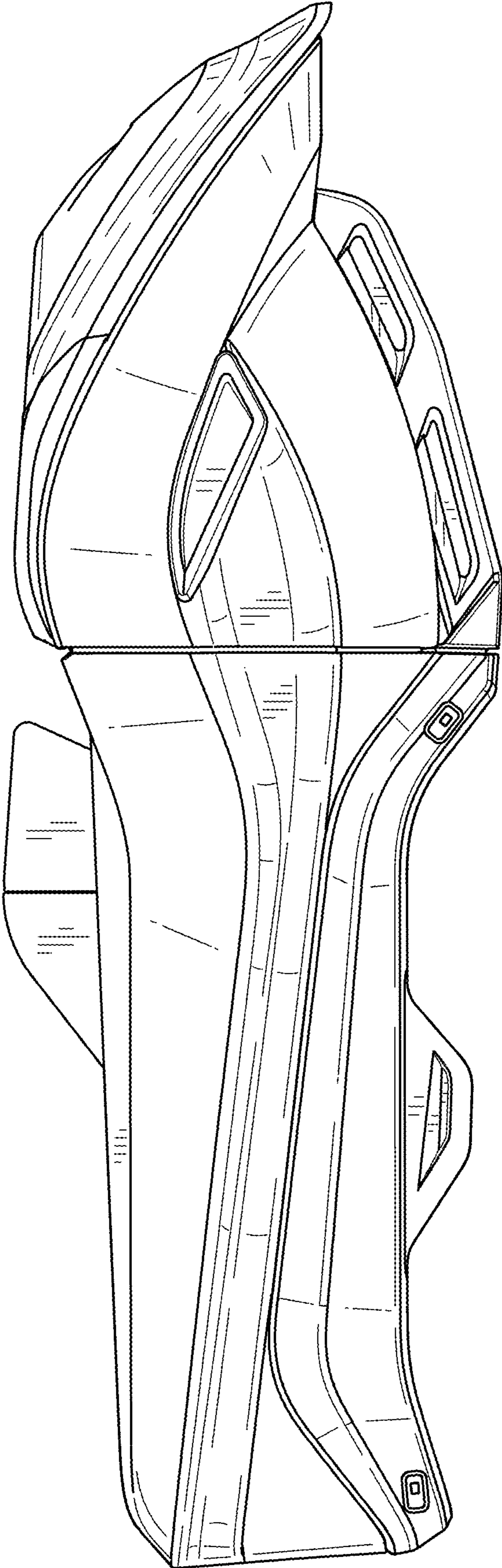

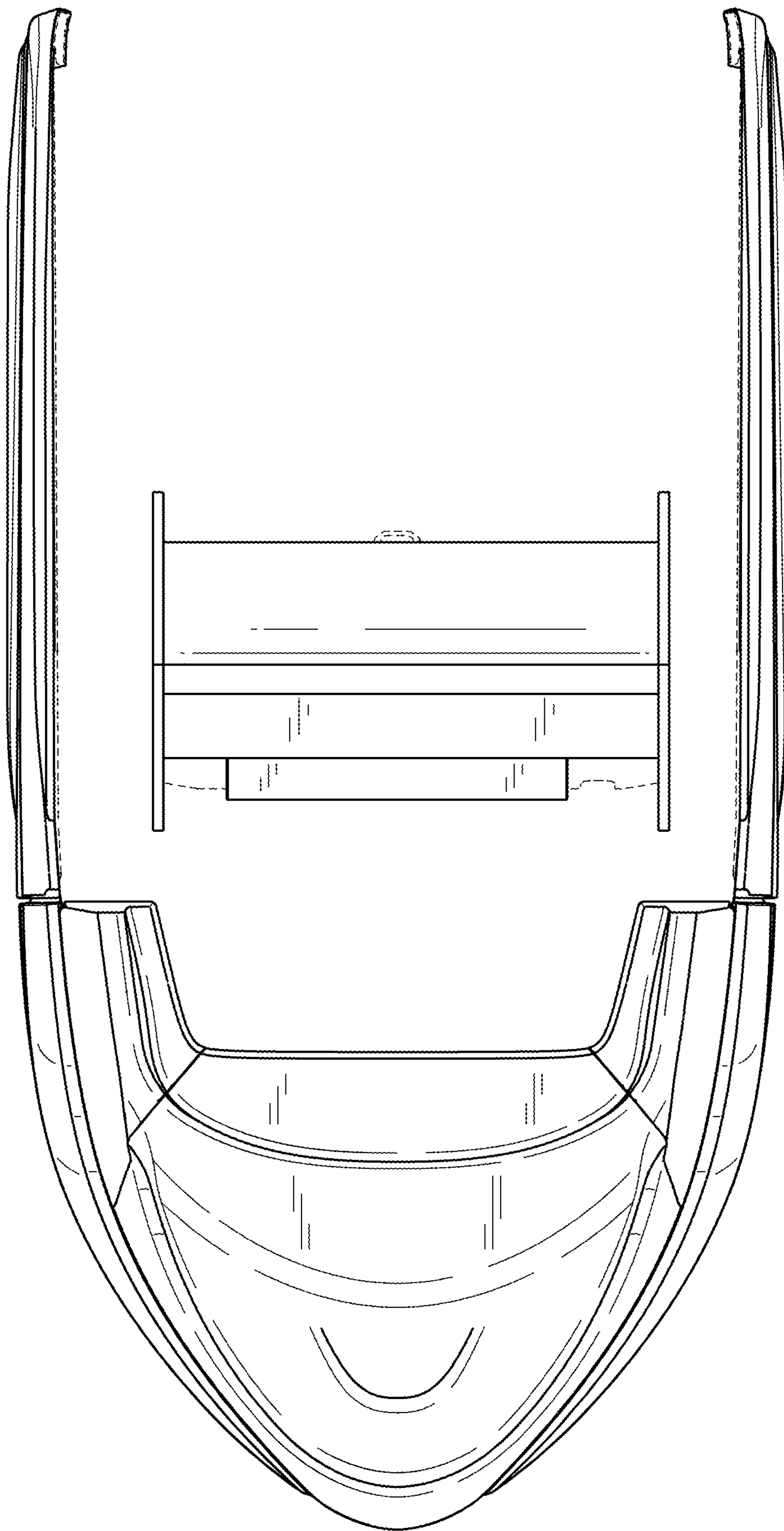
