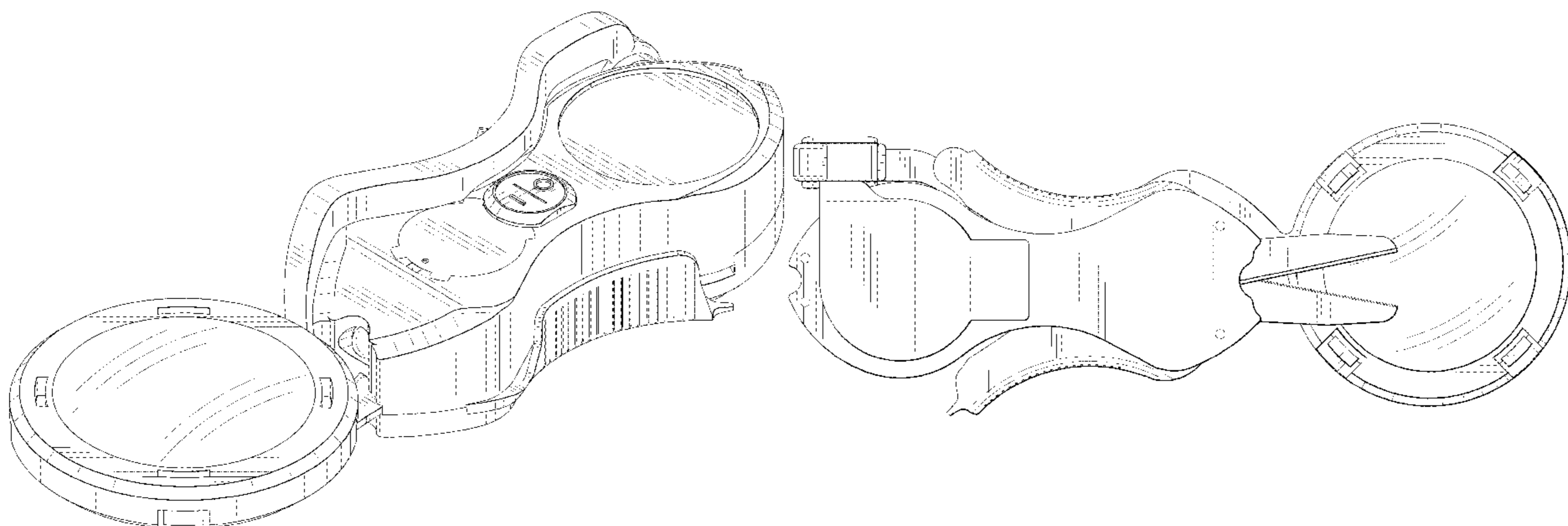
The ornamental design for magnifier tool, as shown and described.

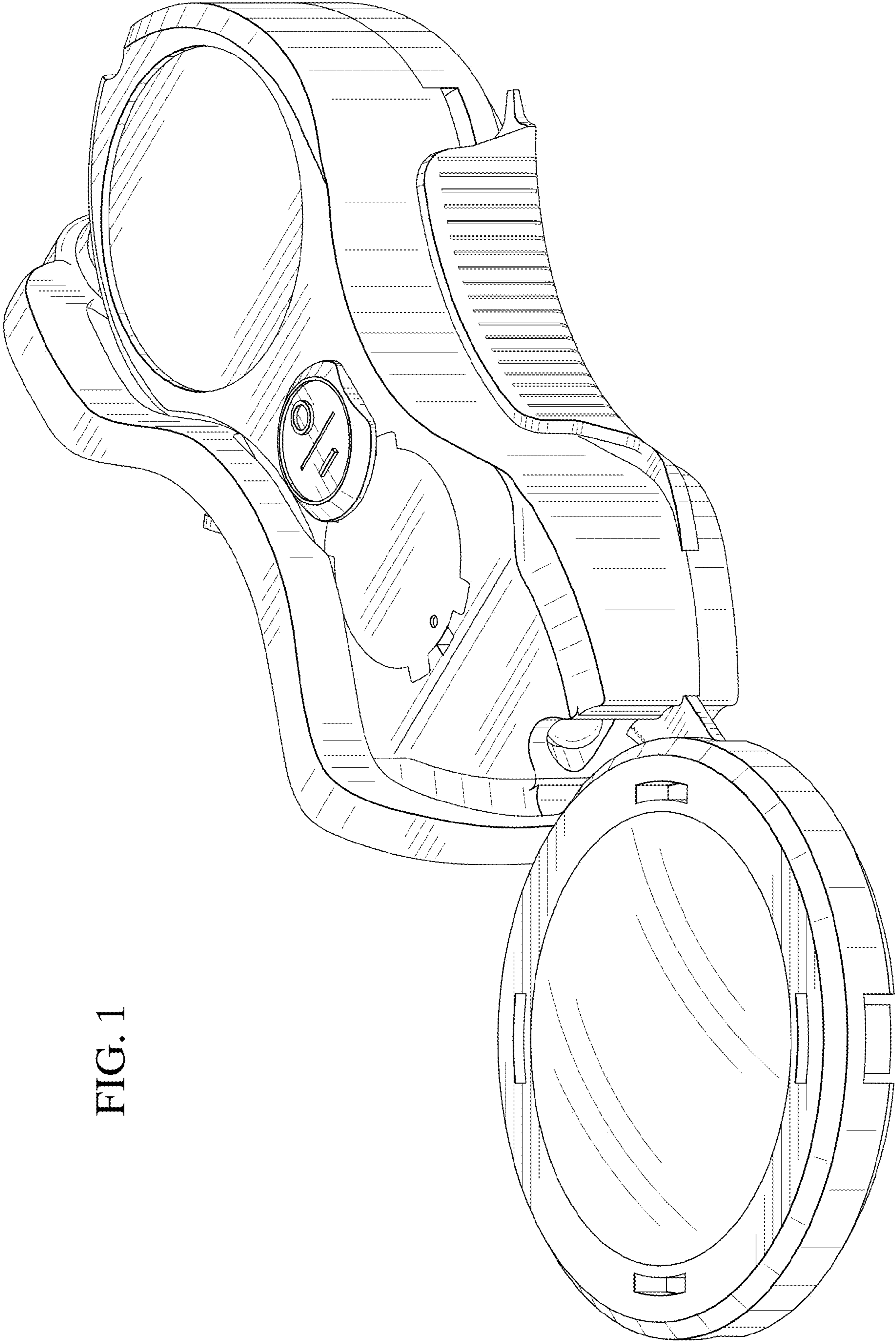

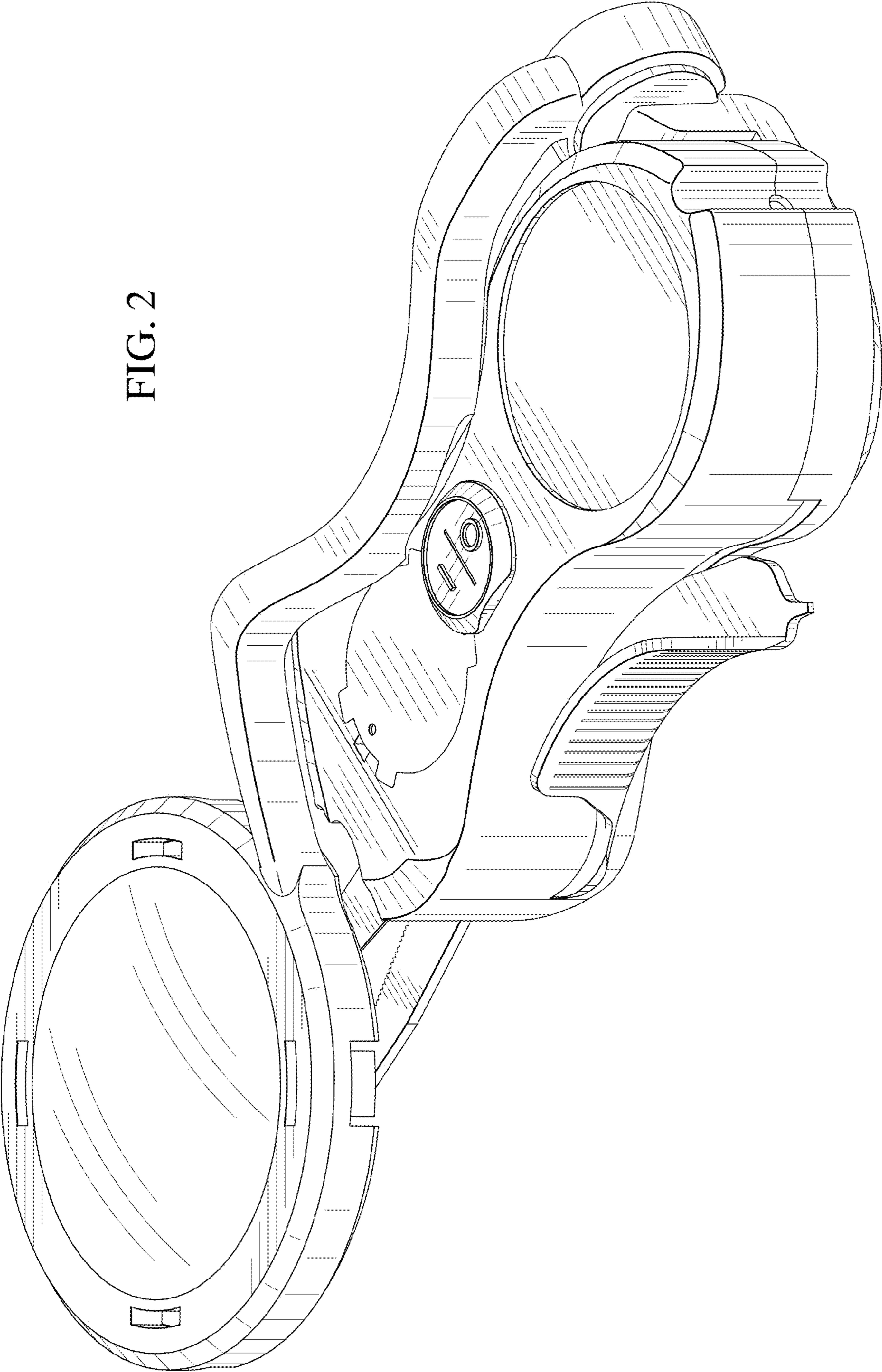

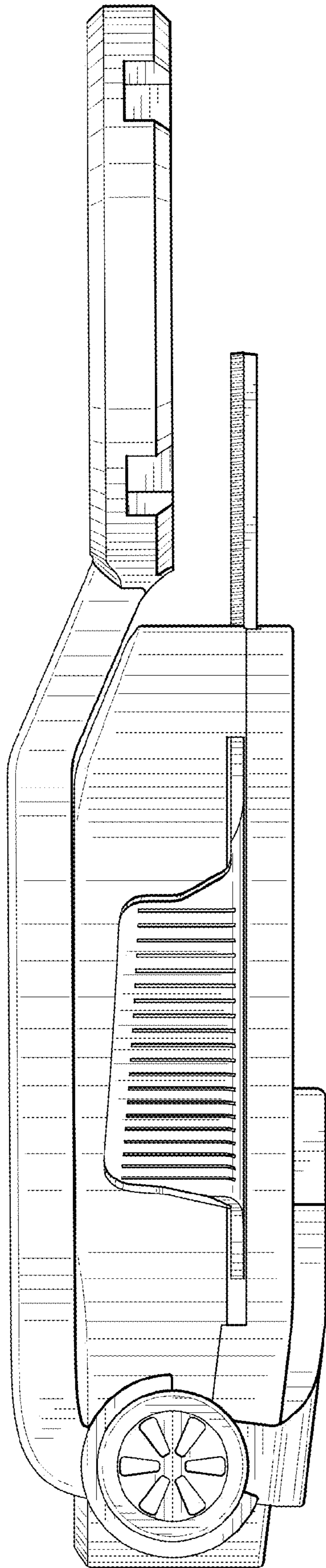

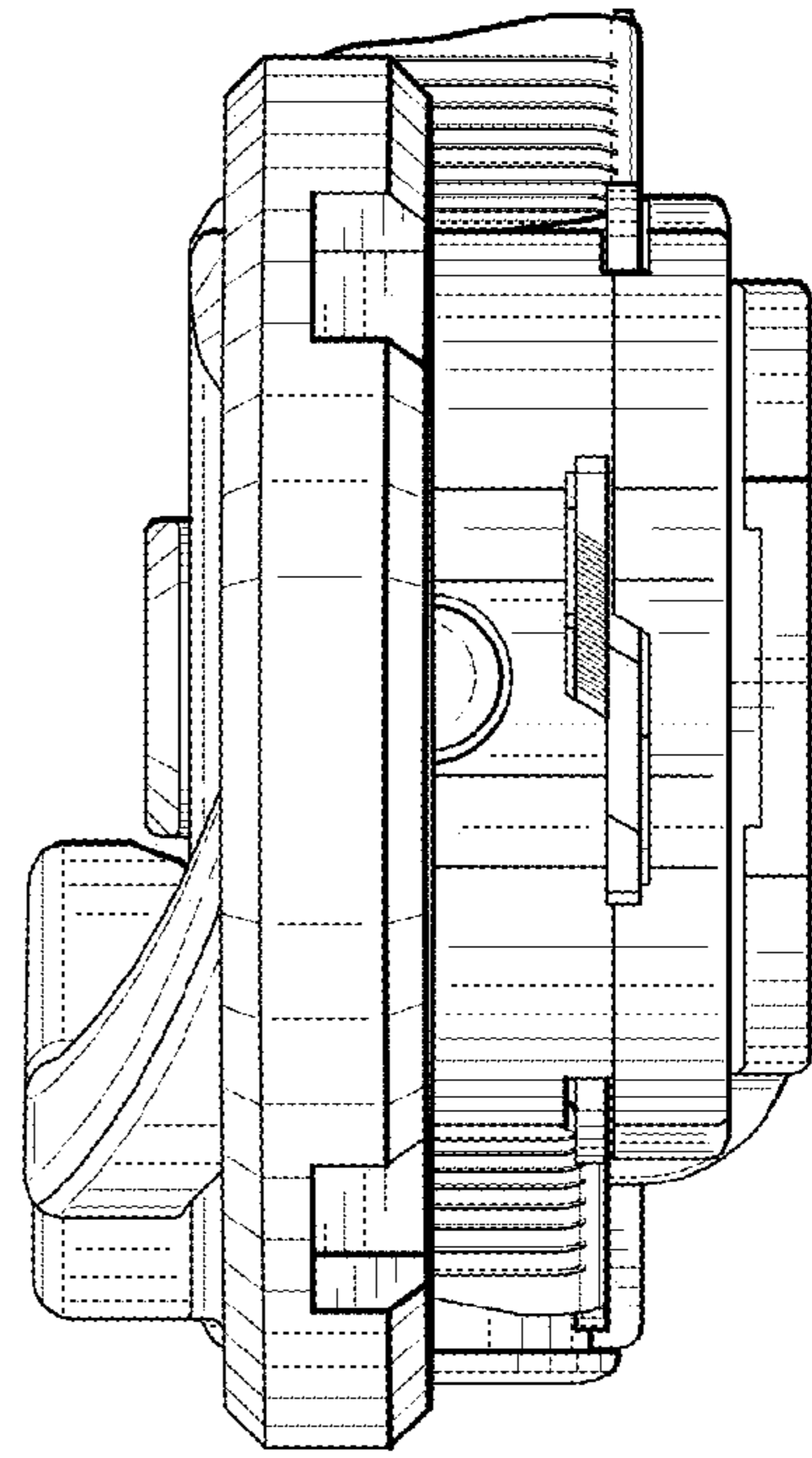

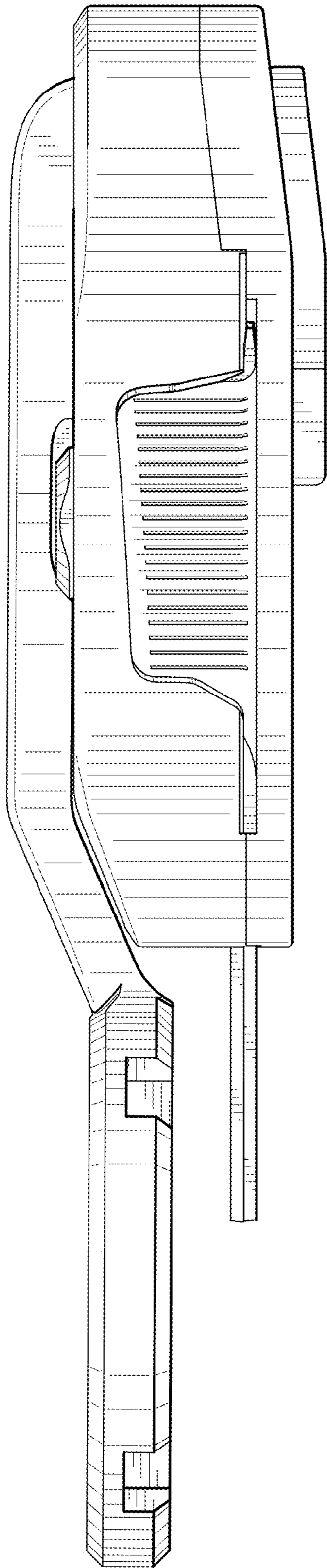

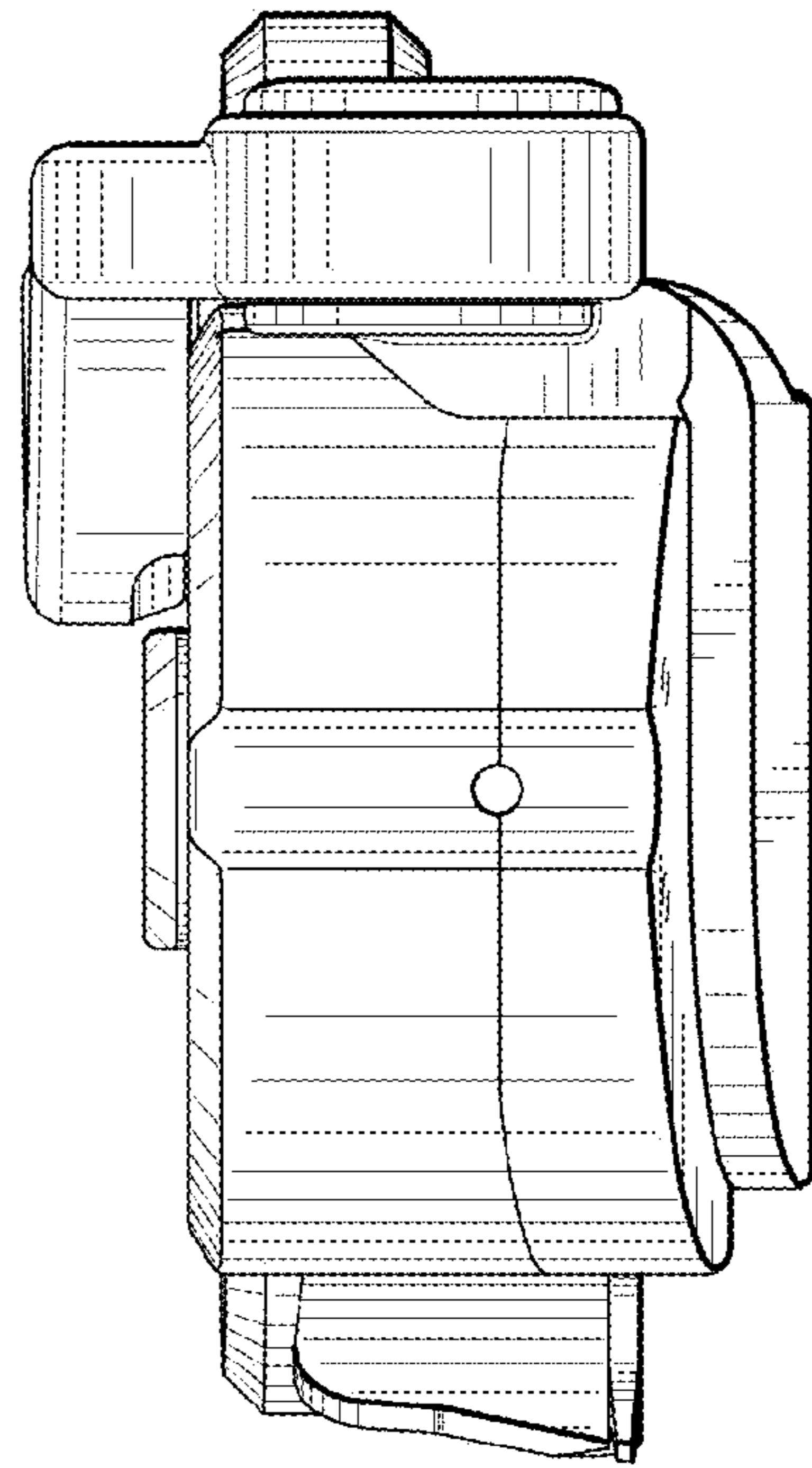

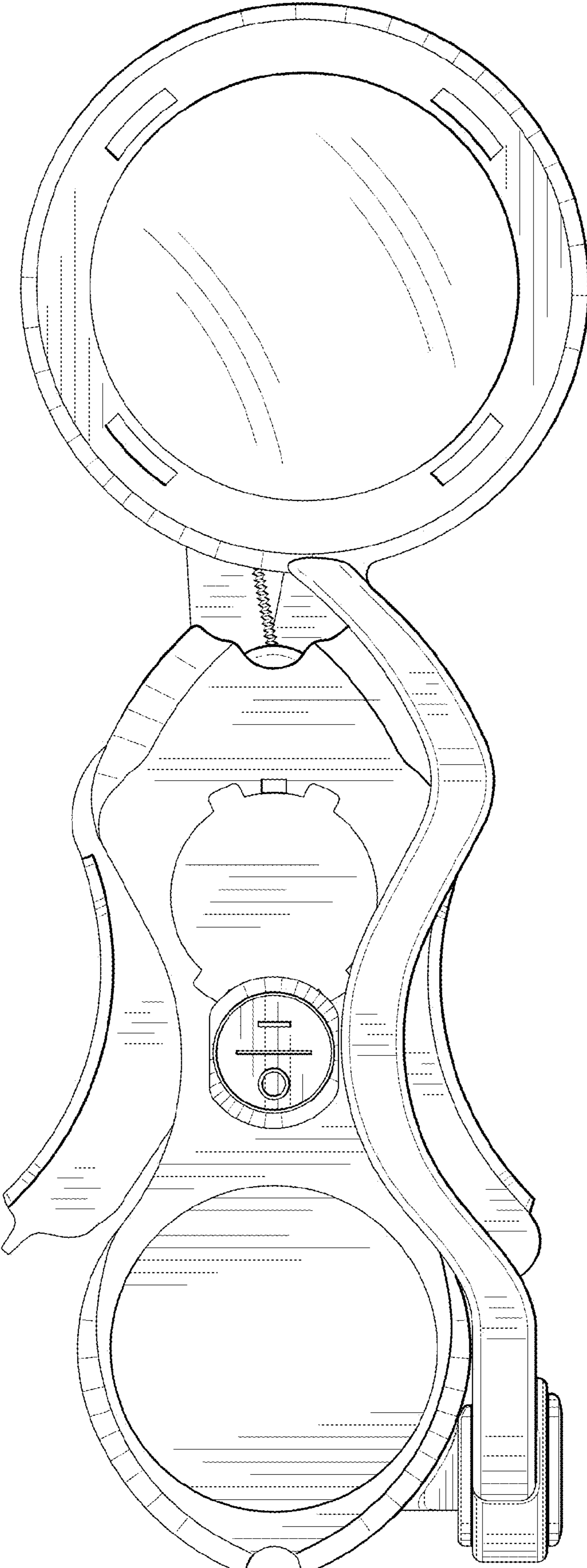
