(57) **CLAIM**

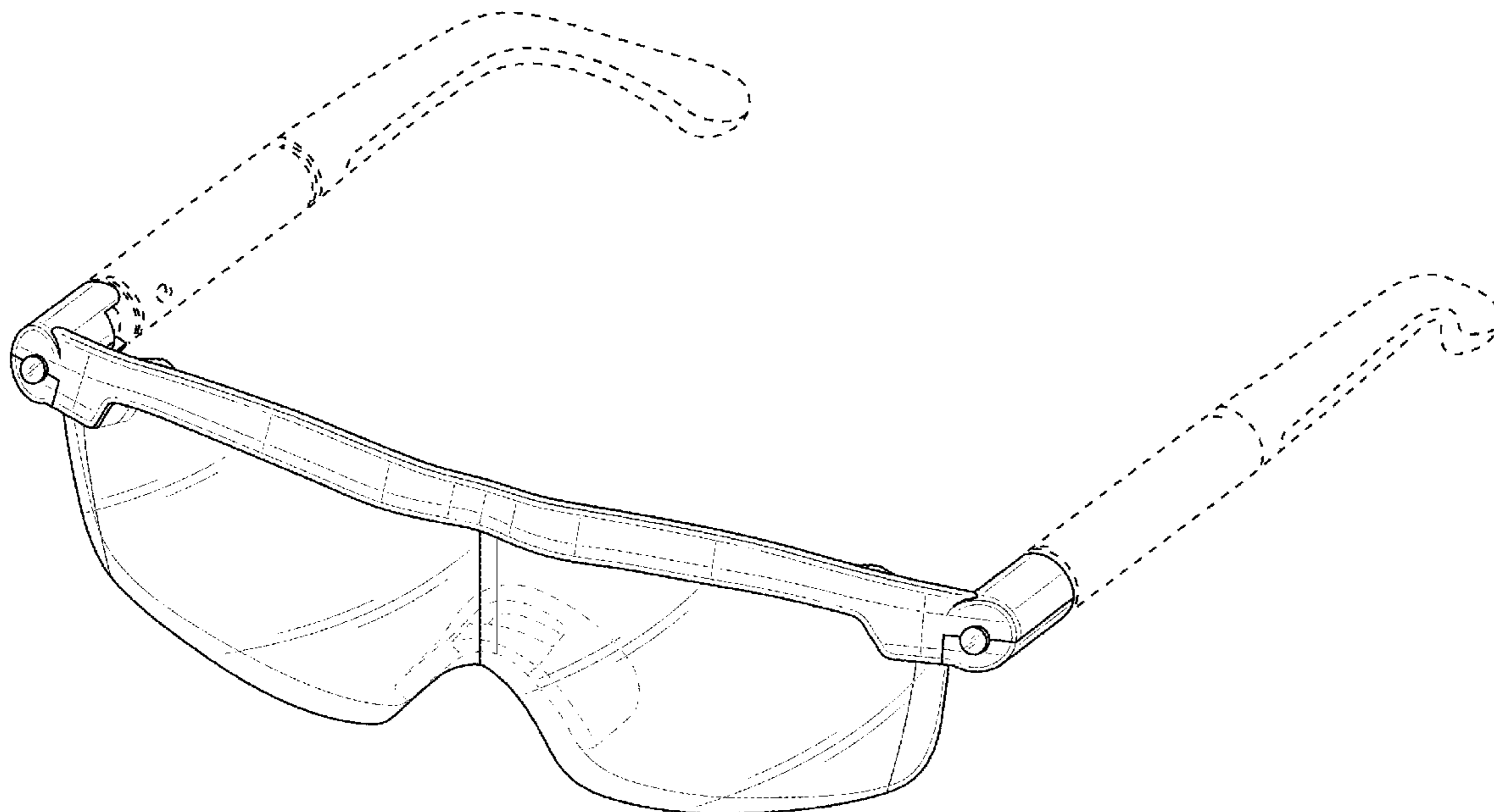
The ornamental design for lighted glasses, as shown and described.

DESCRIPTION

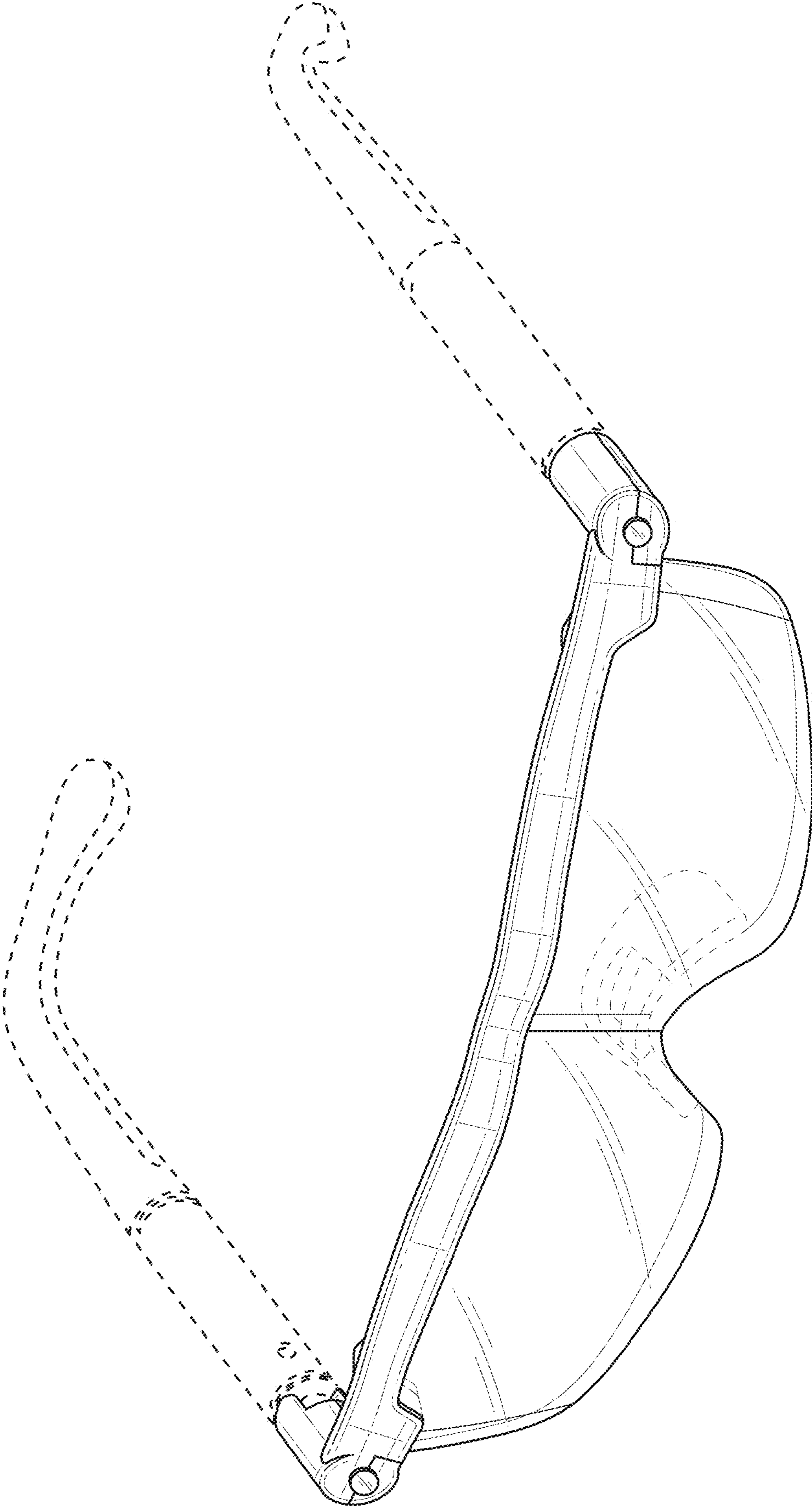

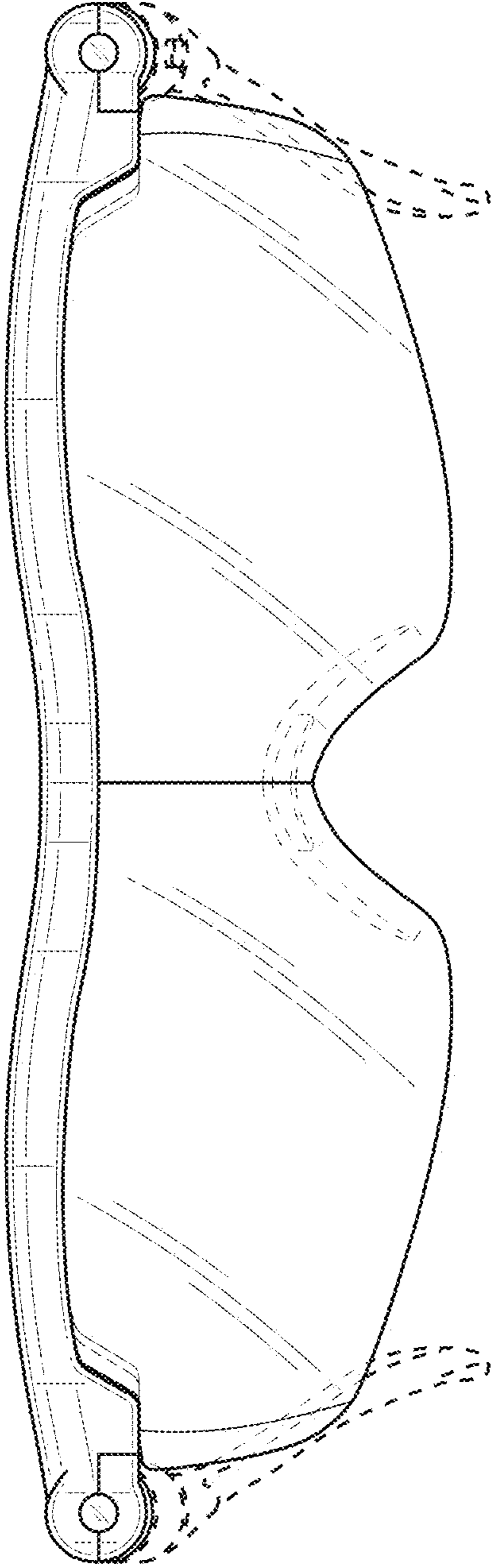

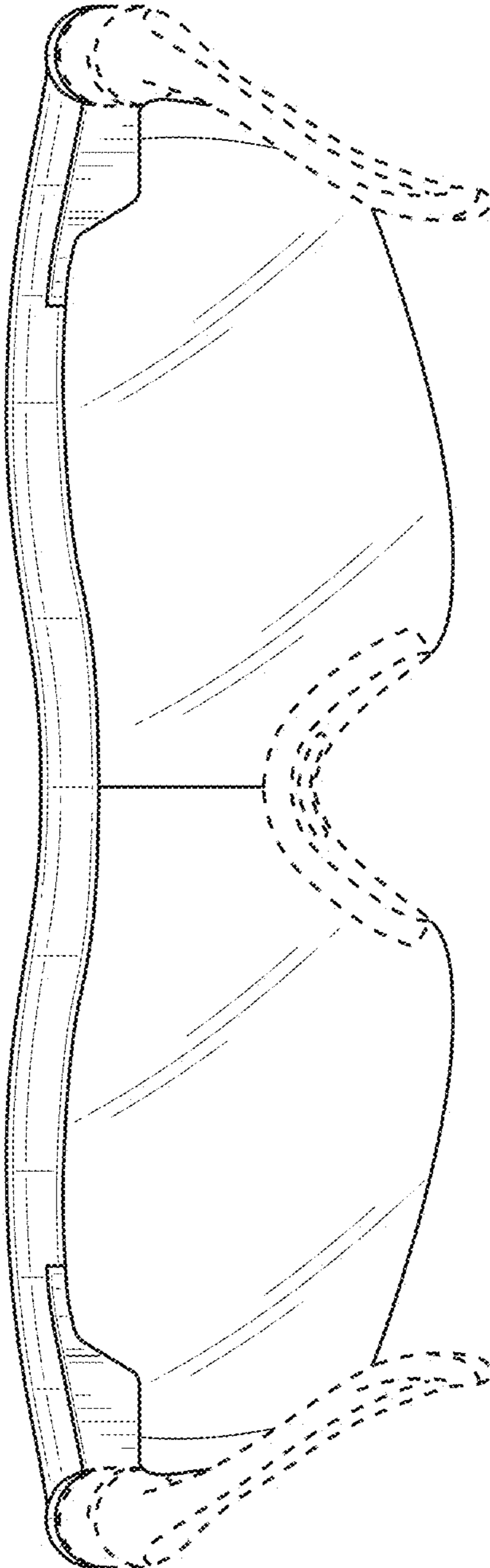

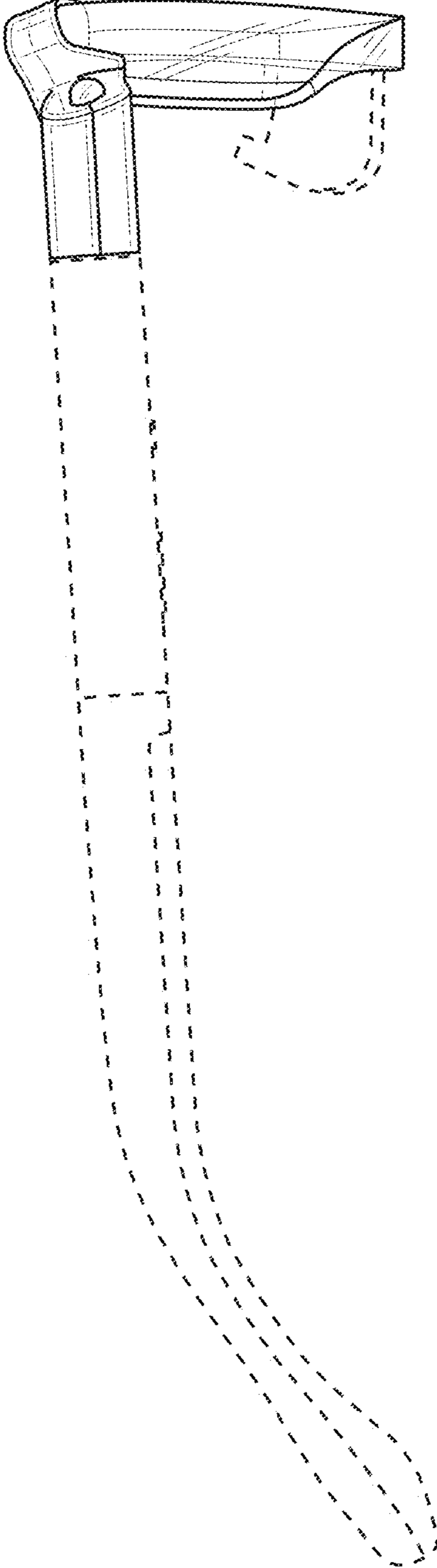

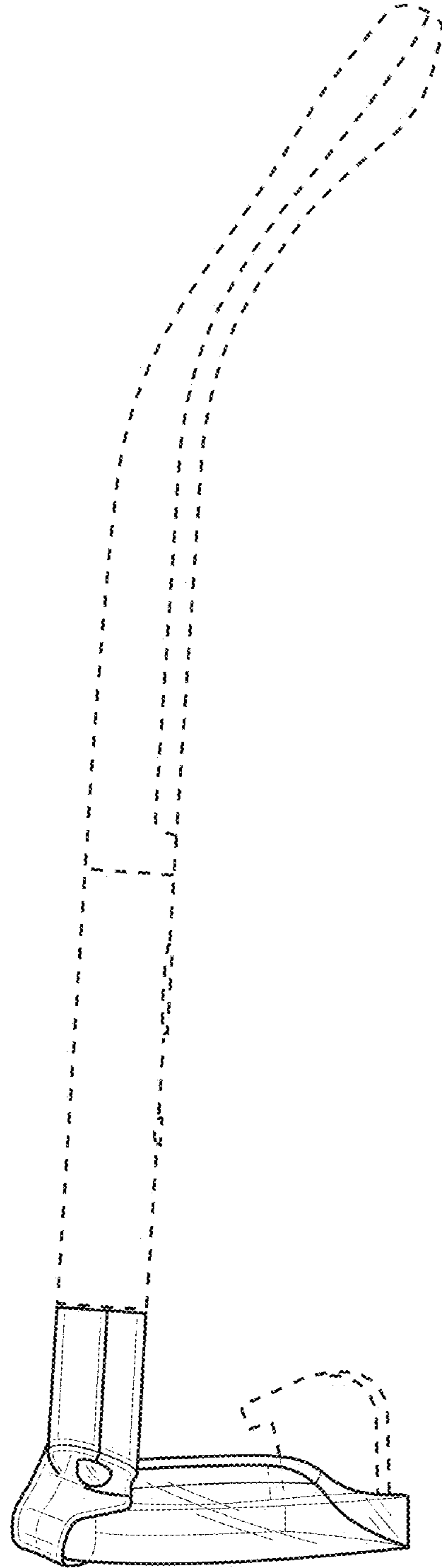

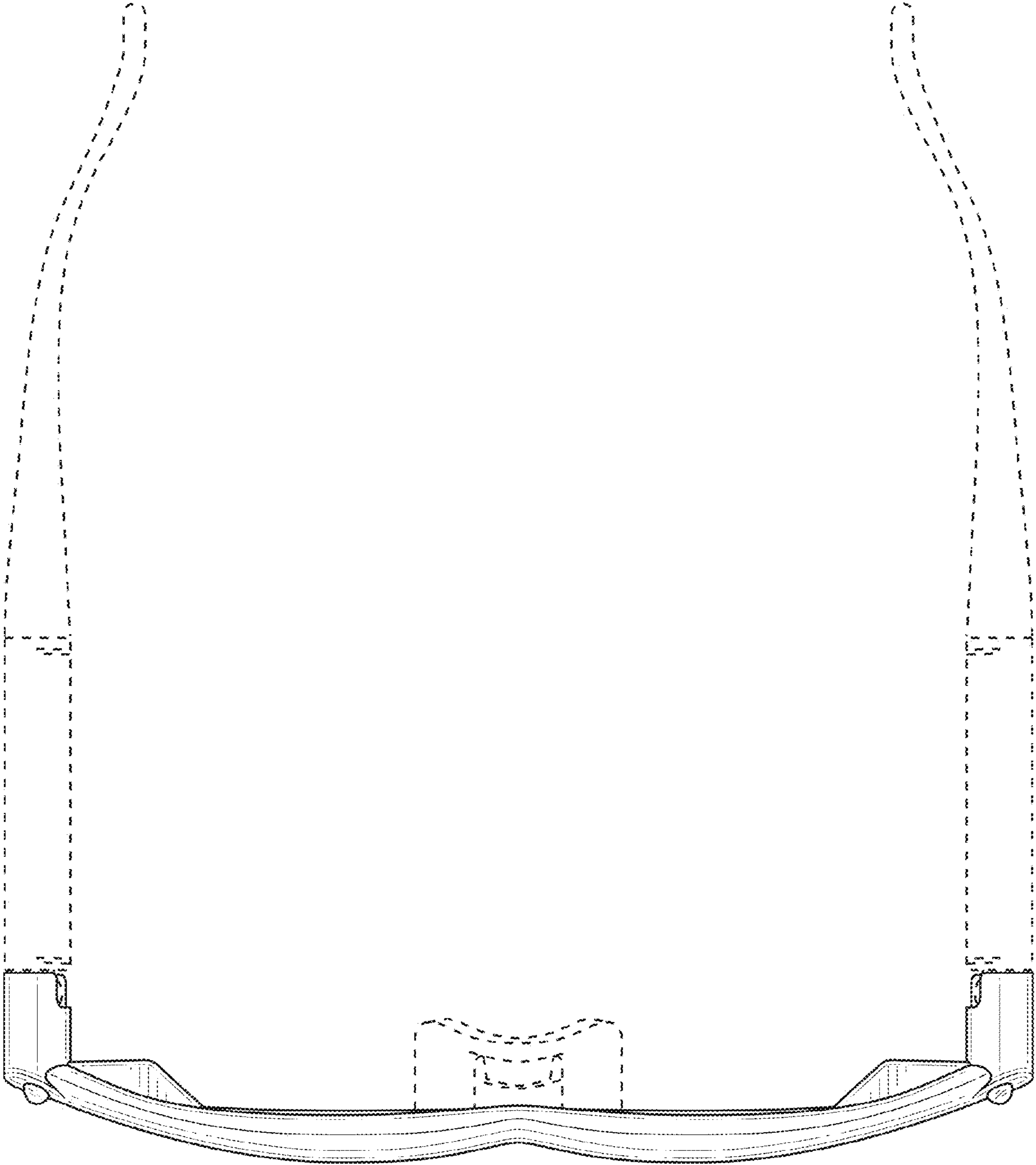

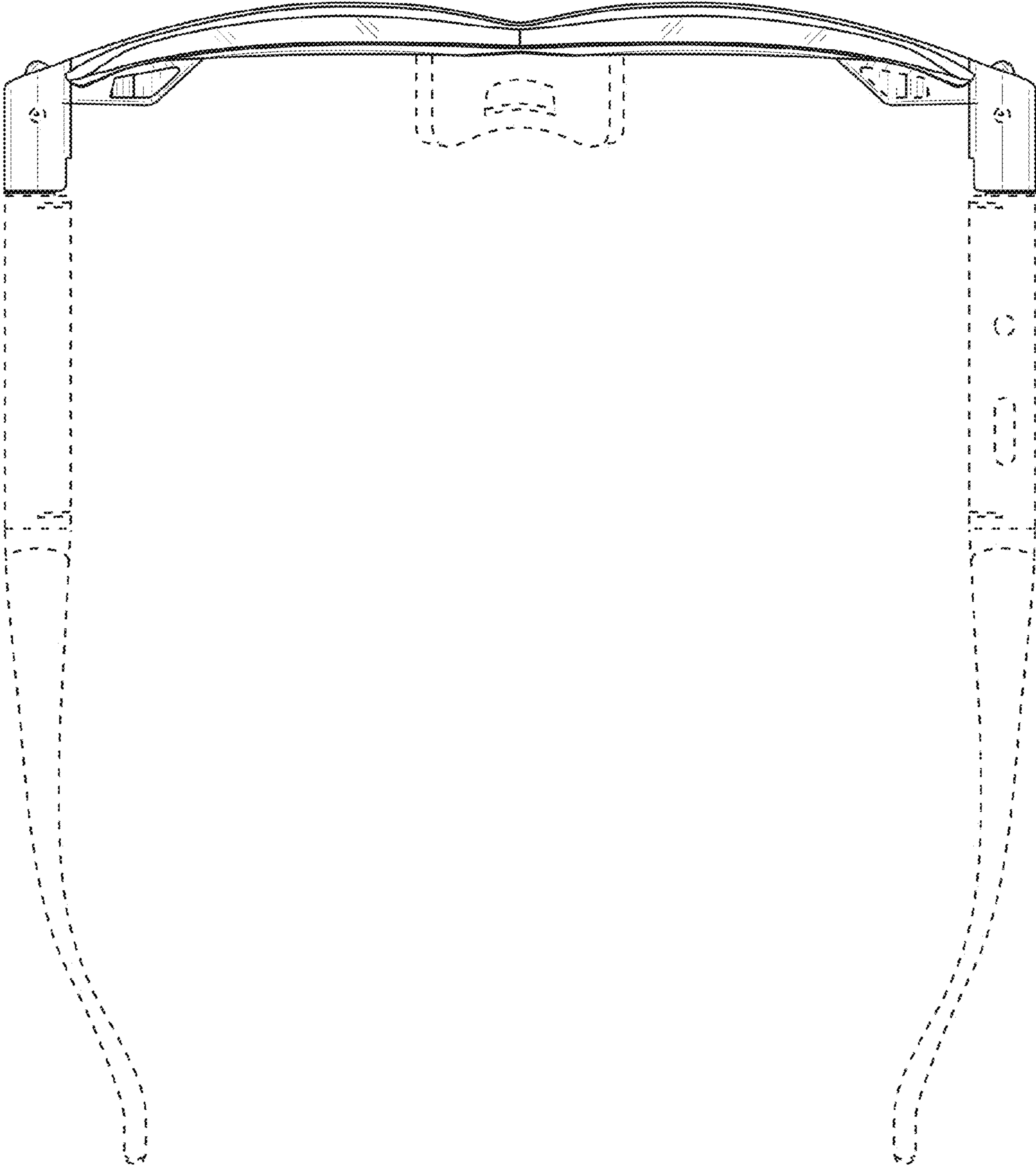
