FIG. 3 is a top view of the water floatation device of FIG. 1.

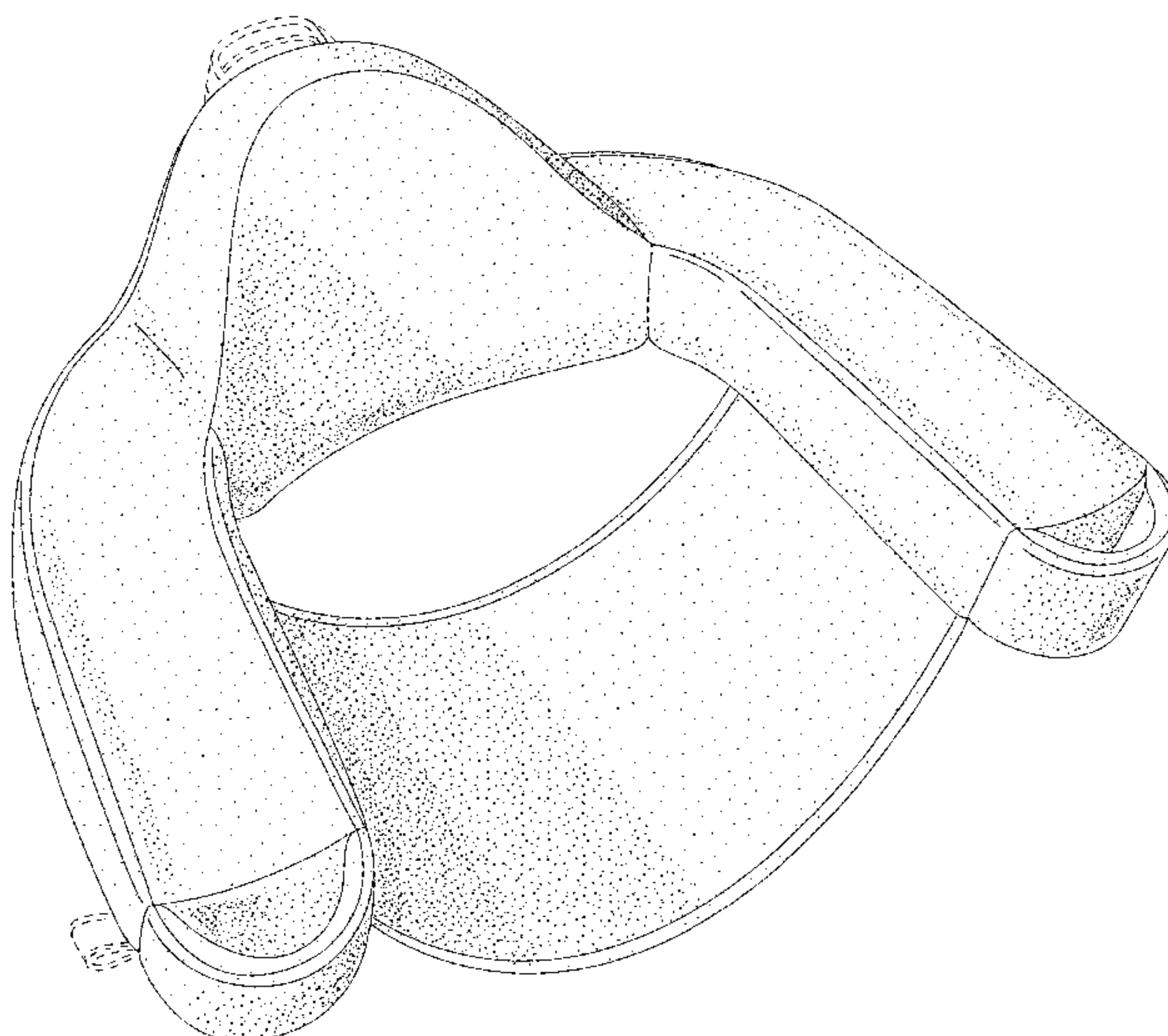
FIG. 4 is a bottom view of the water floatation device of FIG. 1.

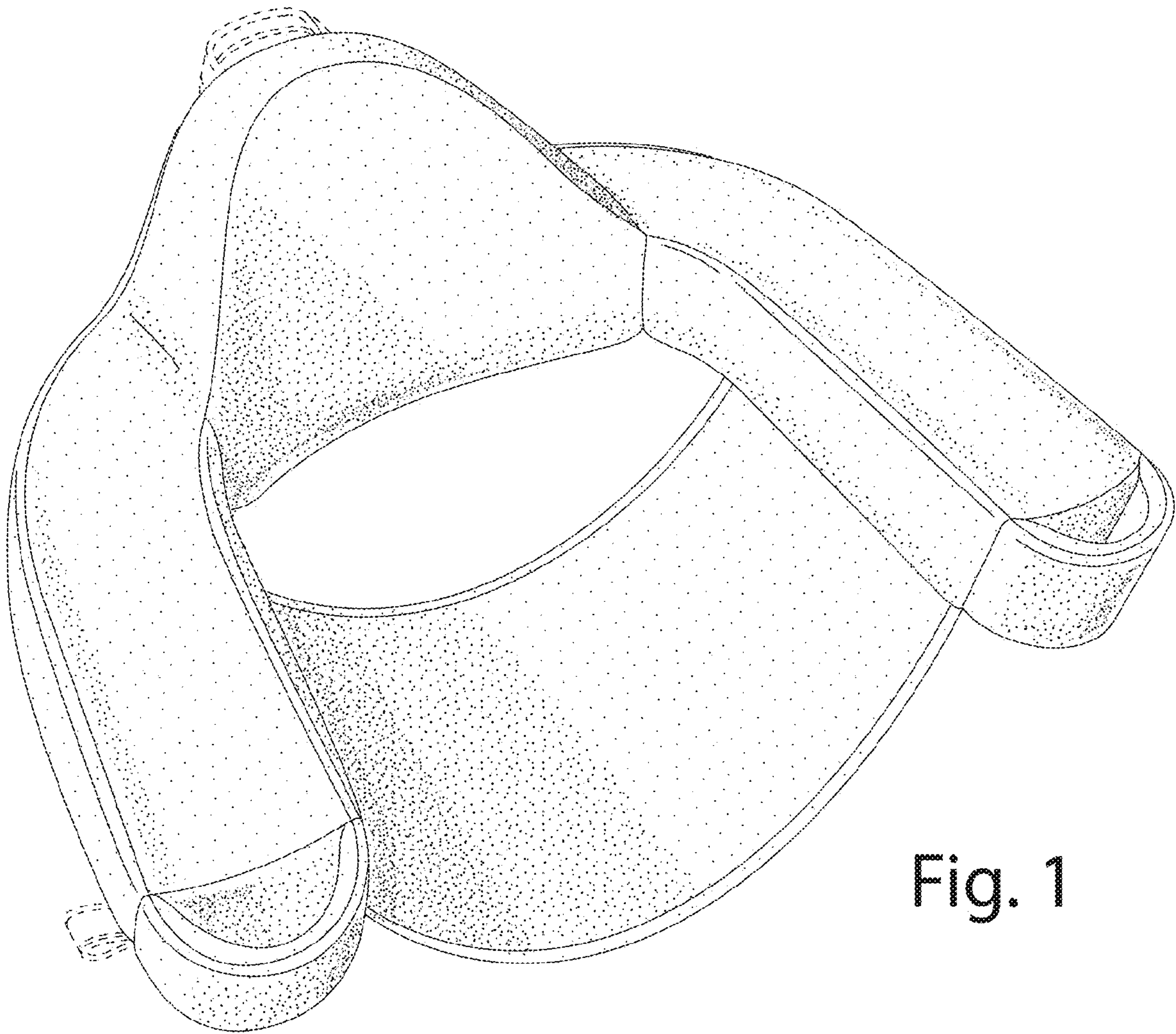

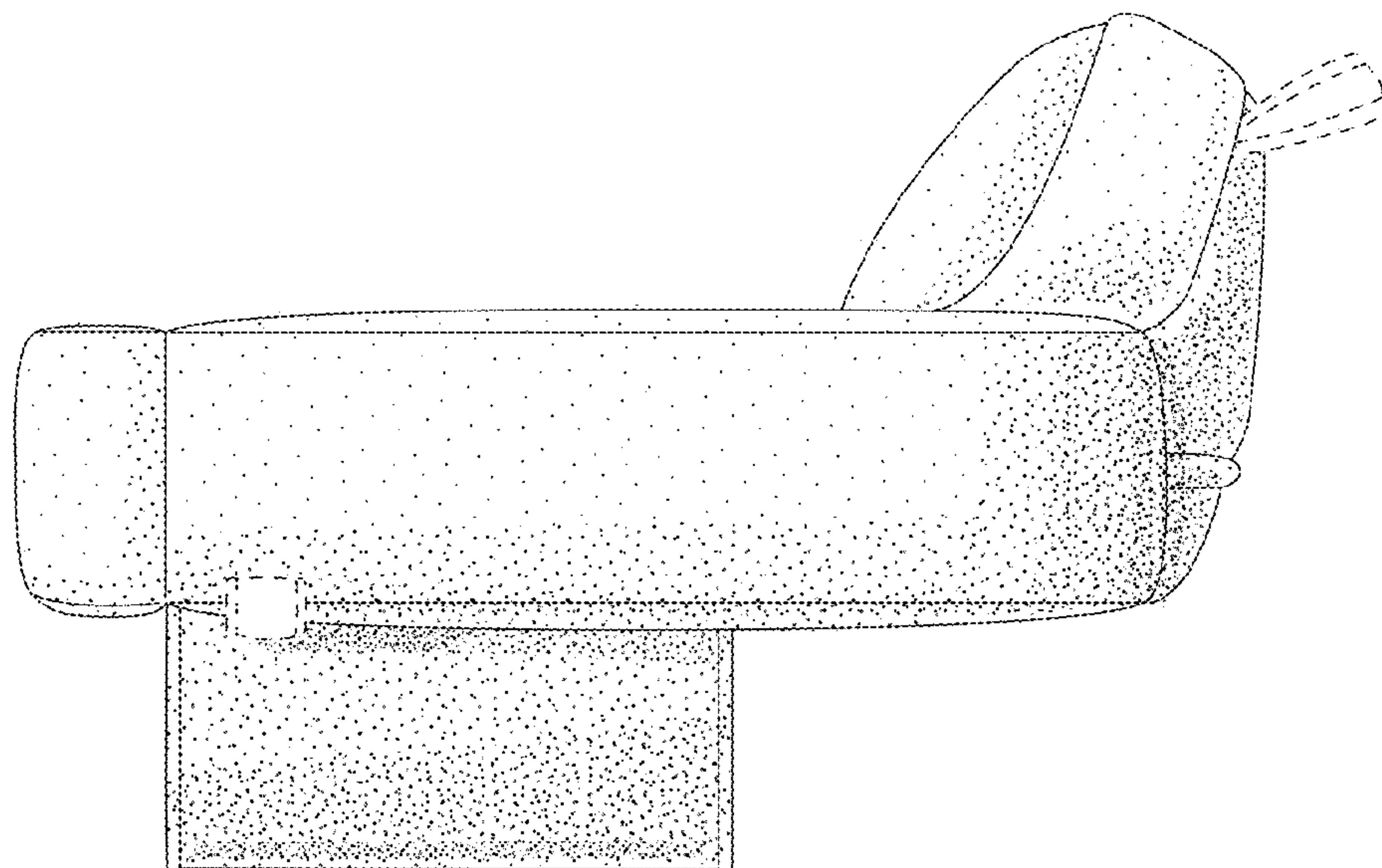

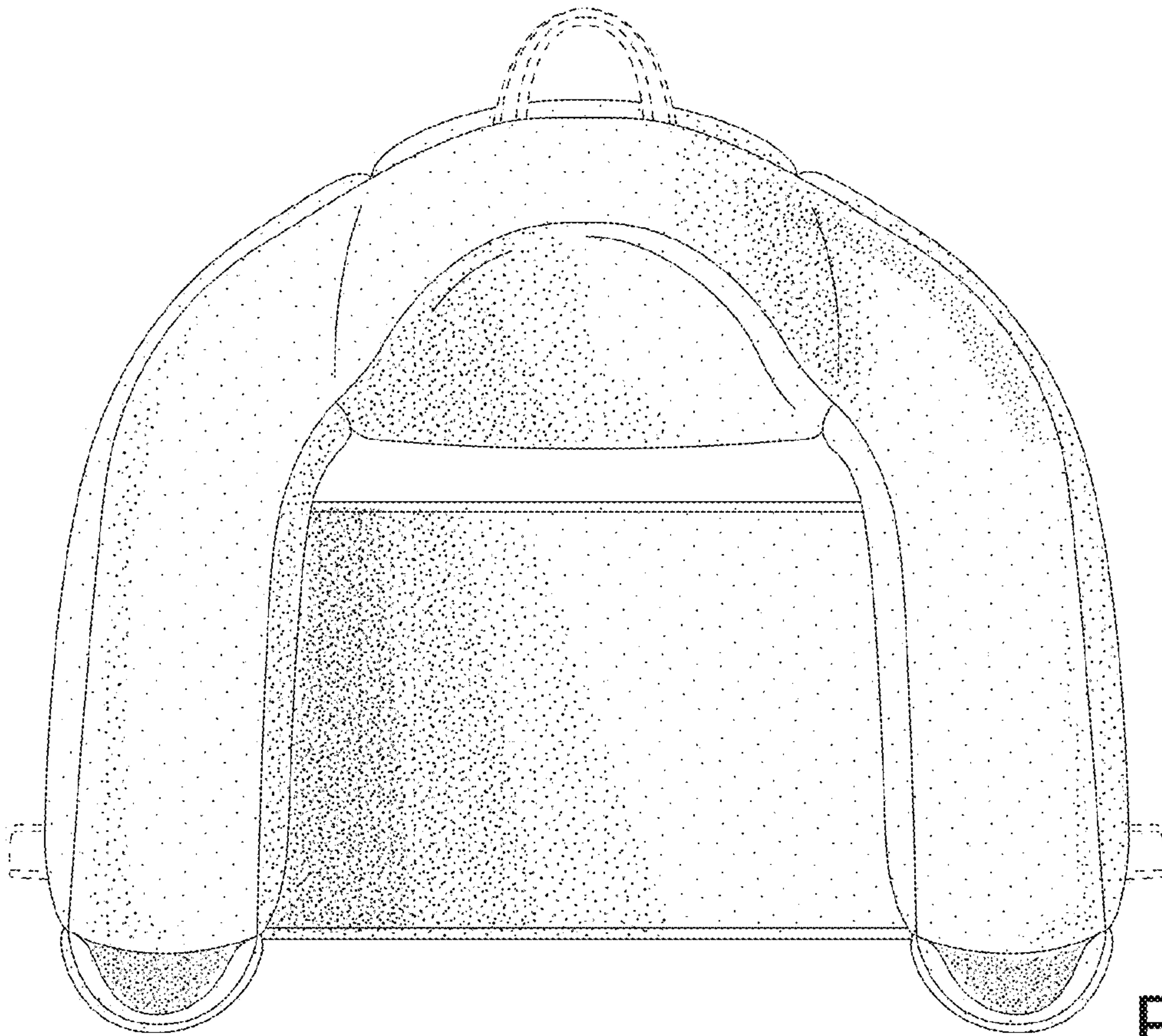

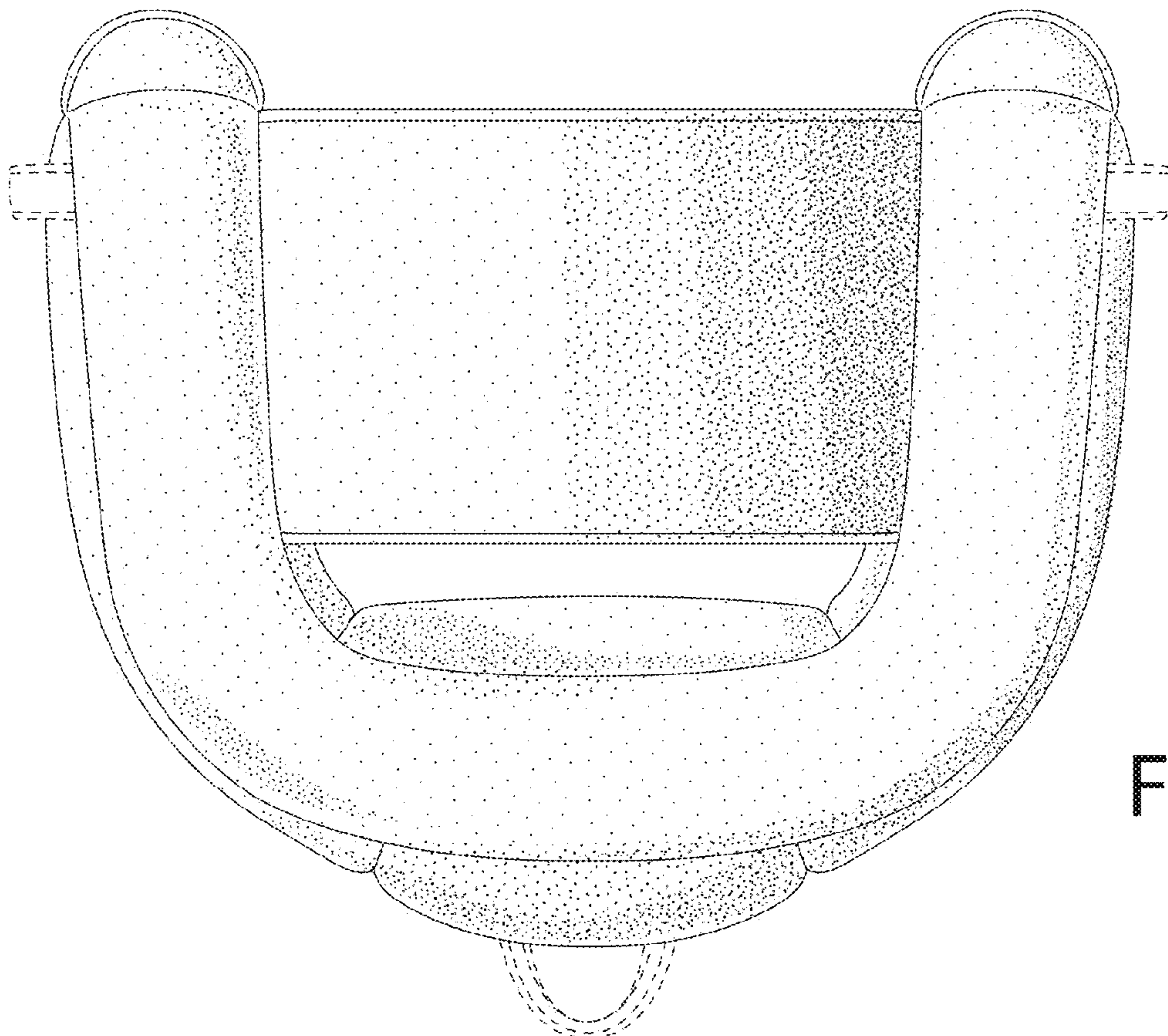

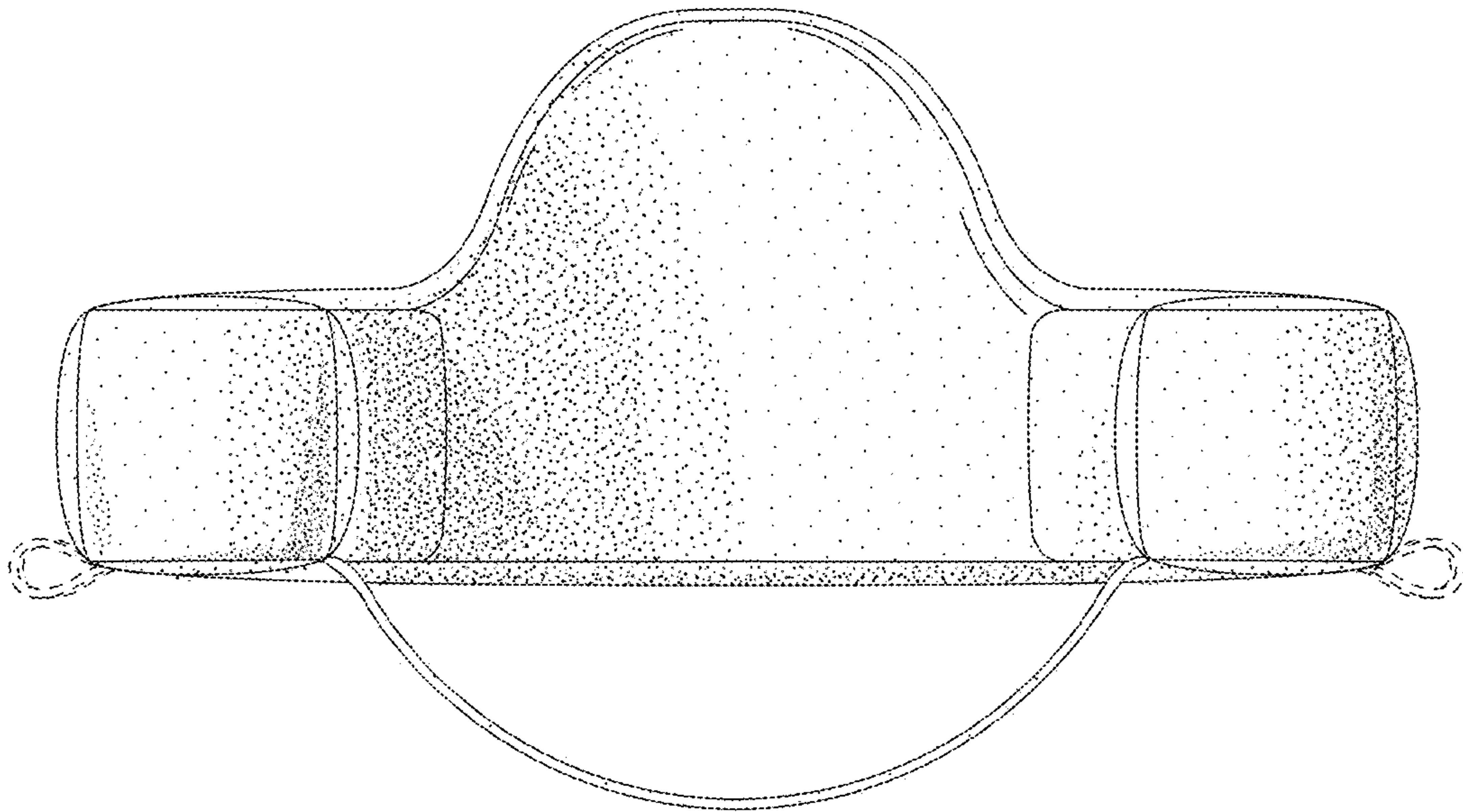

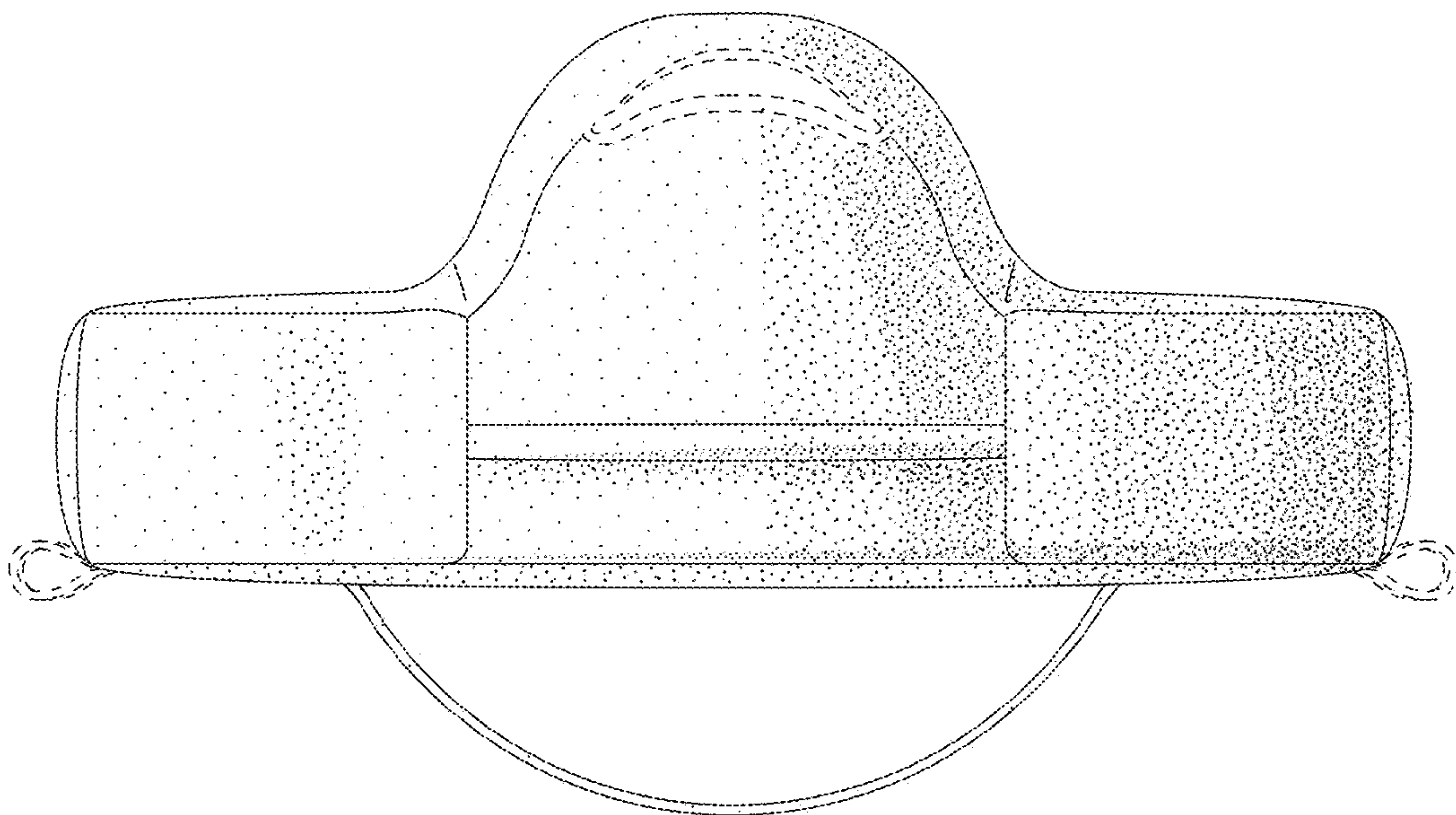
