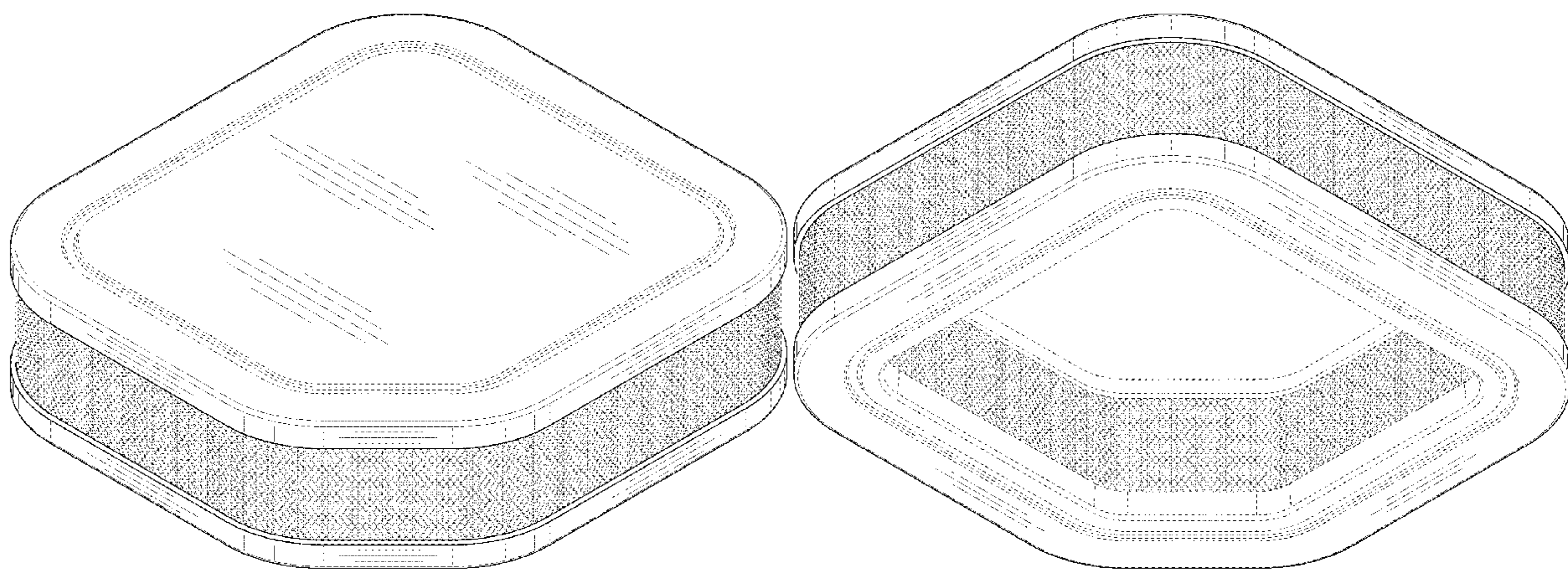
(57) **CLAIM**

The ornamental design for an air cleaner filter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-right elevated view of an air cleaner filter according the new design;  
FIG. 2 is a rear-left elevated view thereof;  
FIG. 3 is a rear-left depressed view thereof;  
FIG. 4 is a front-right depressed view thereof;  
FIG. 5 is a front plan view thereof;  
FIG. 6 is a rear plan view thereof;

FIG. 9 is a top plan view thereof; and,

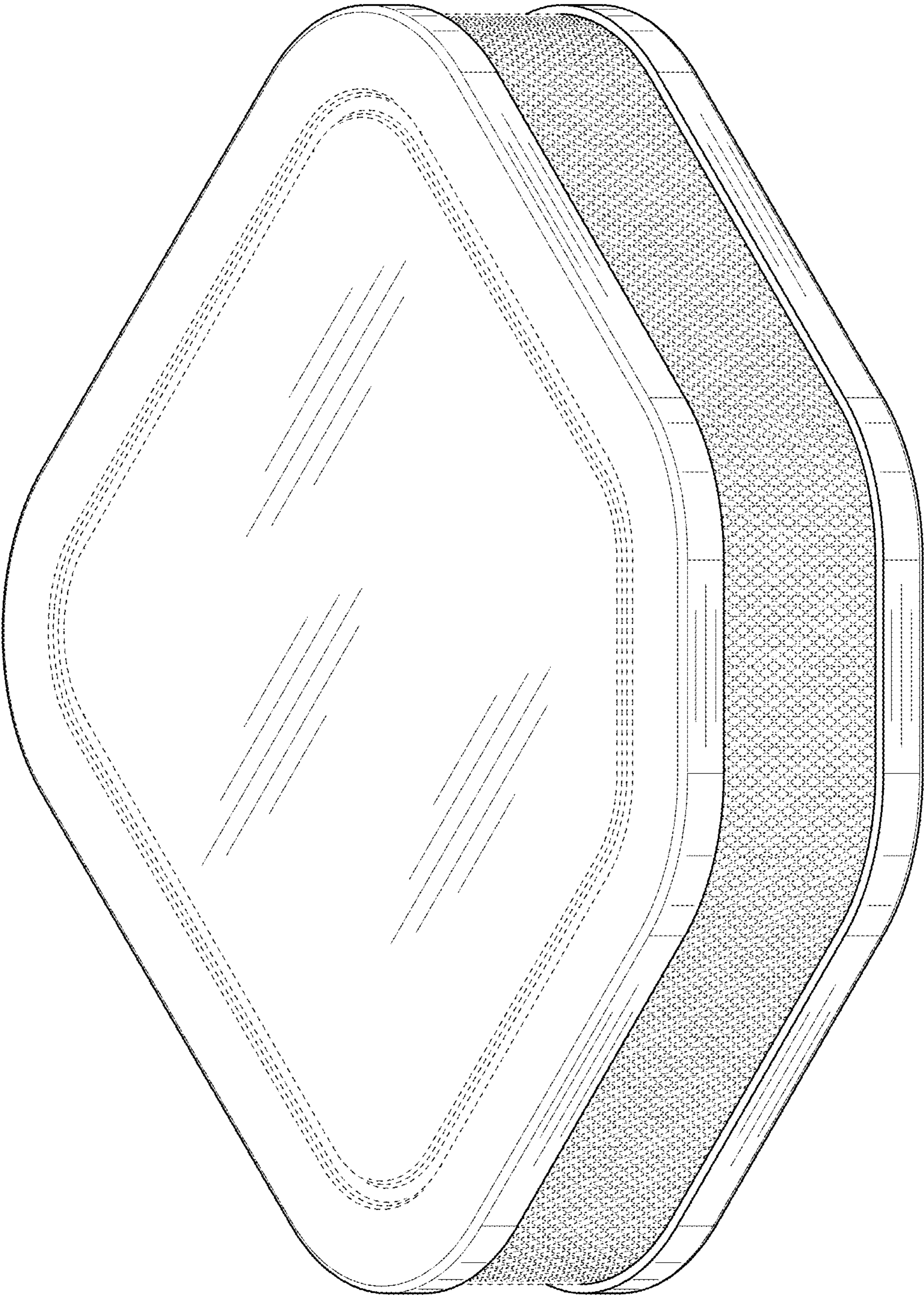

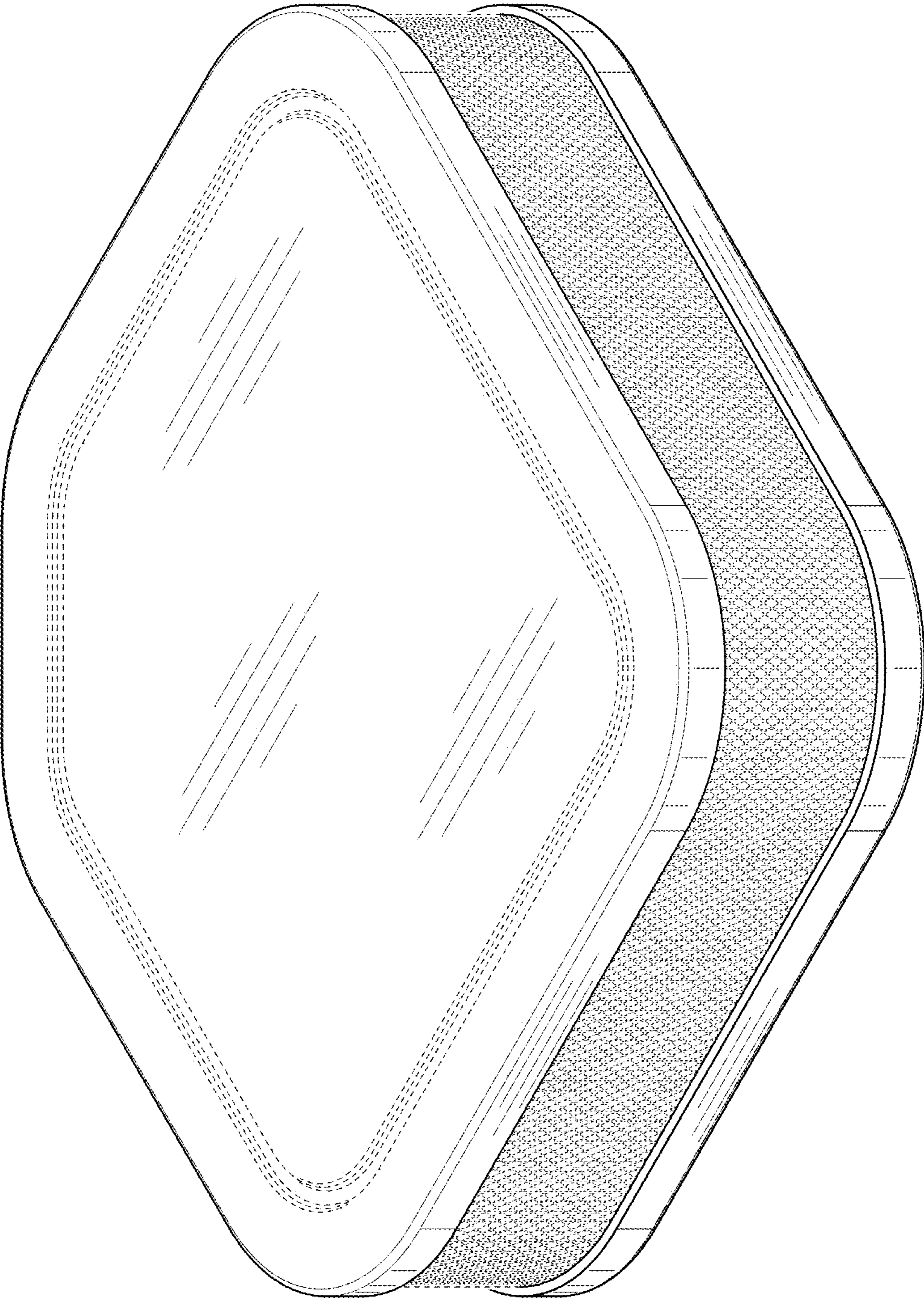

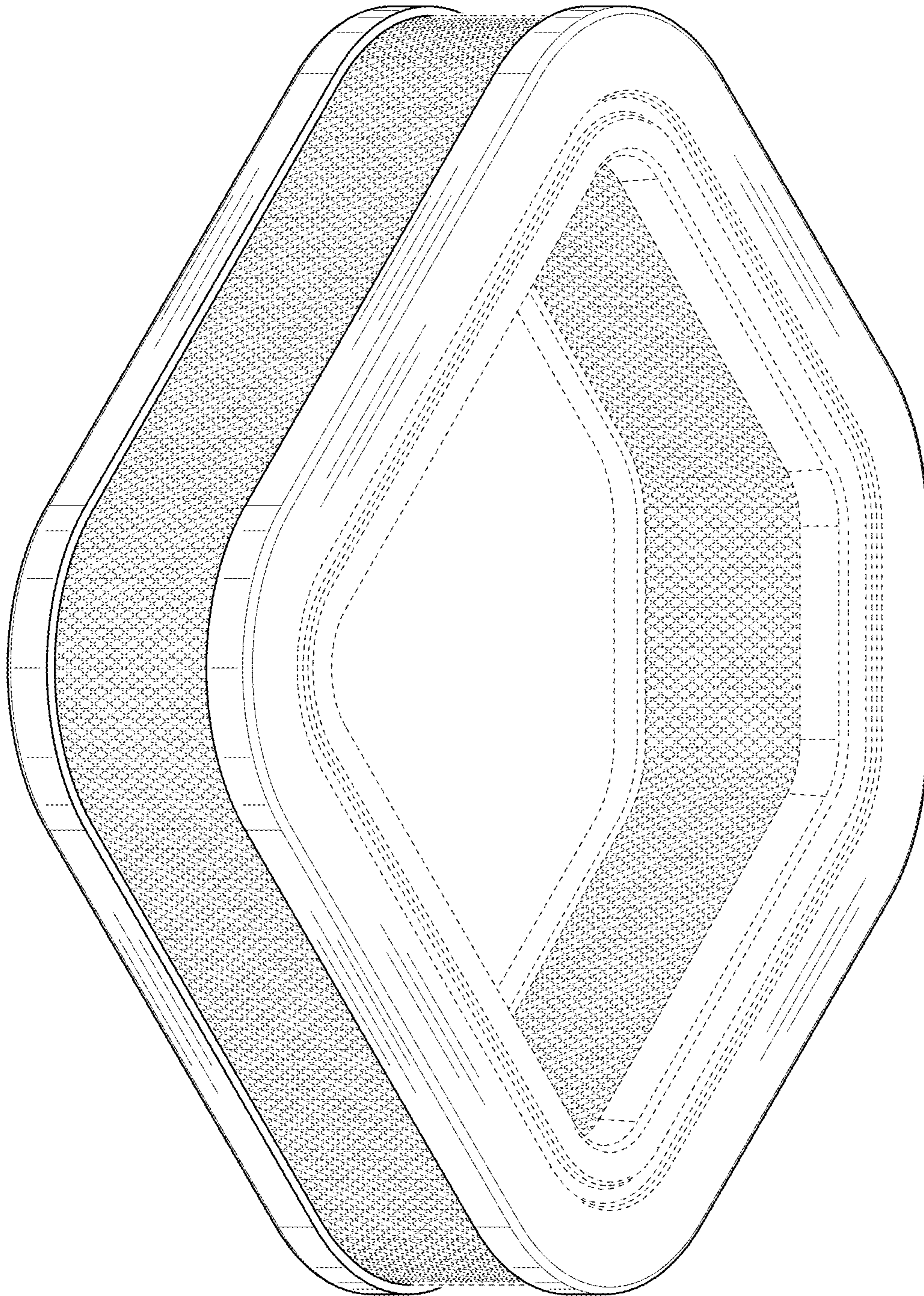

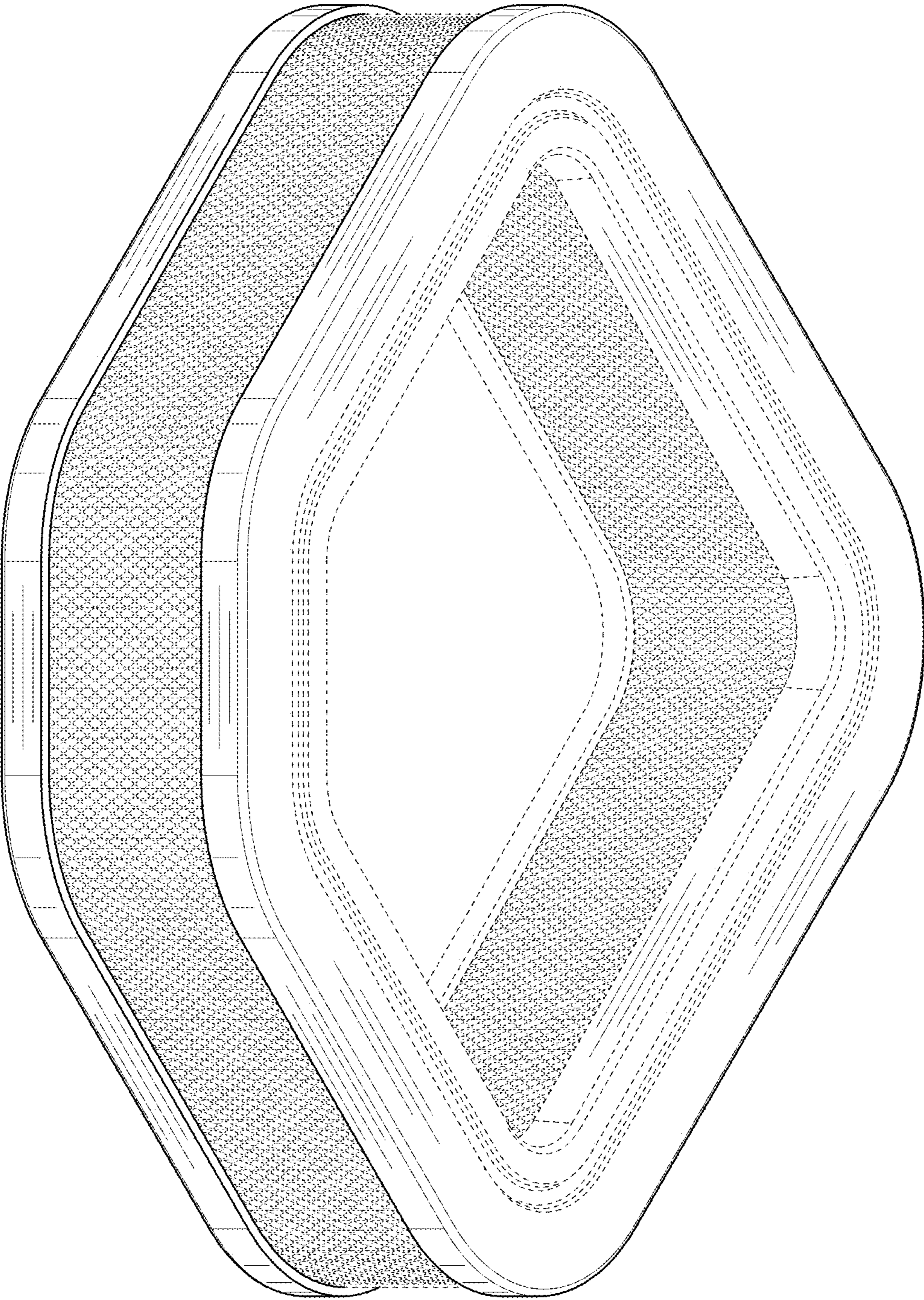

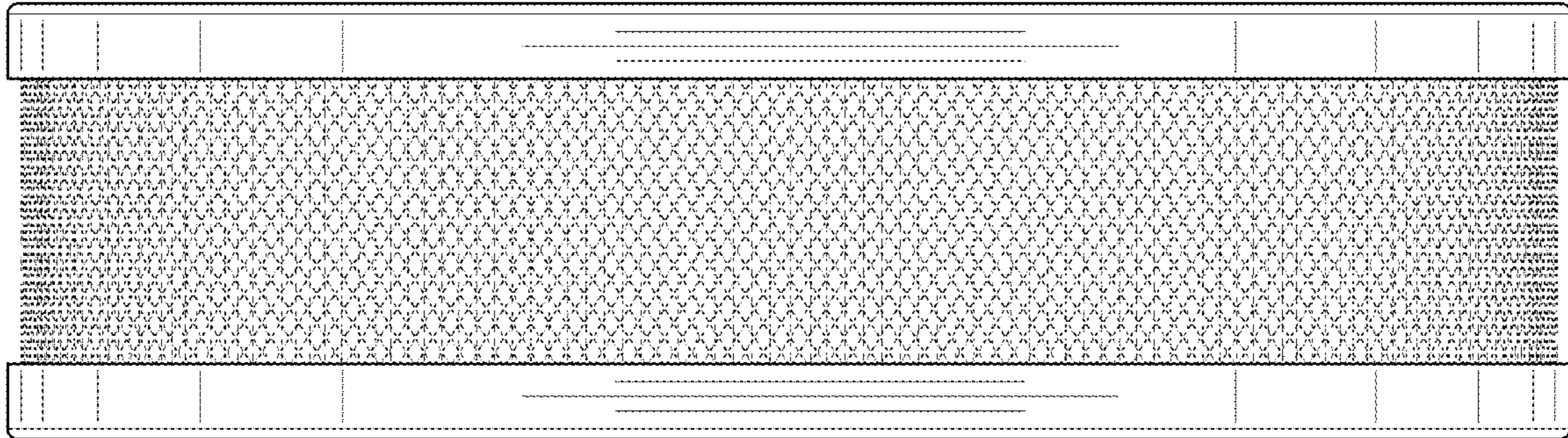

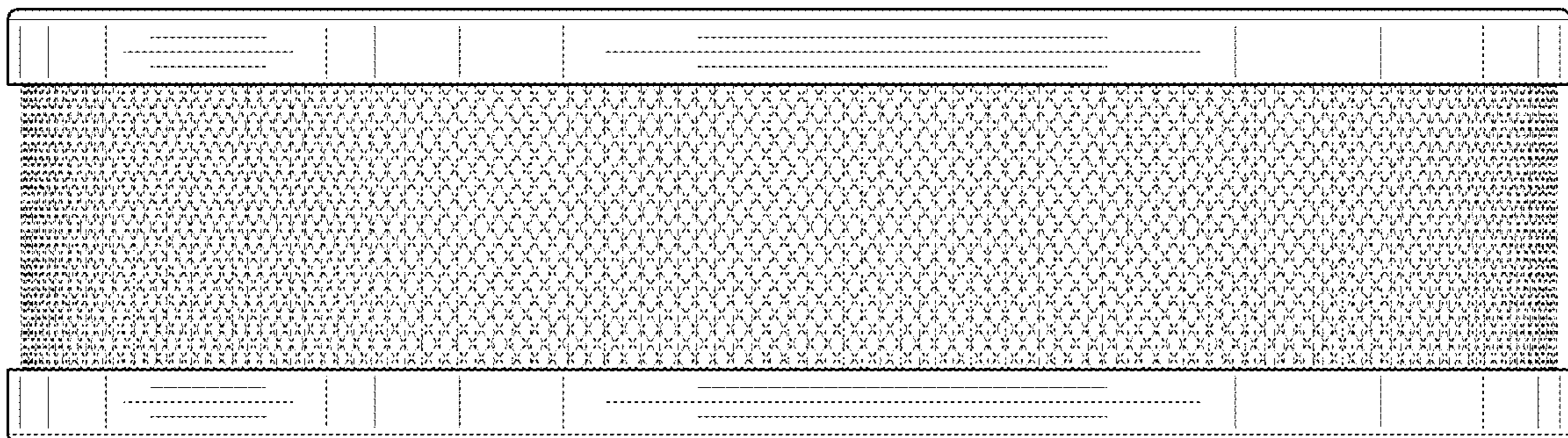

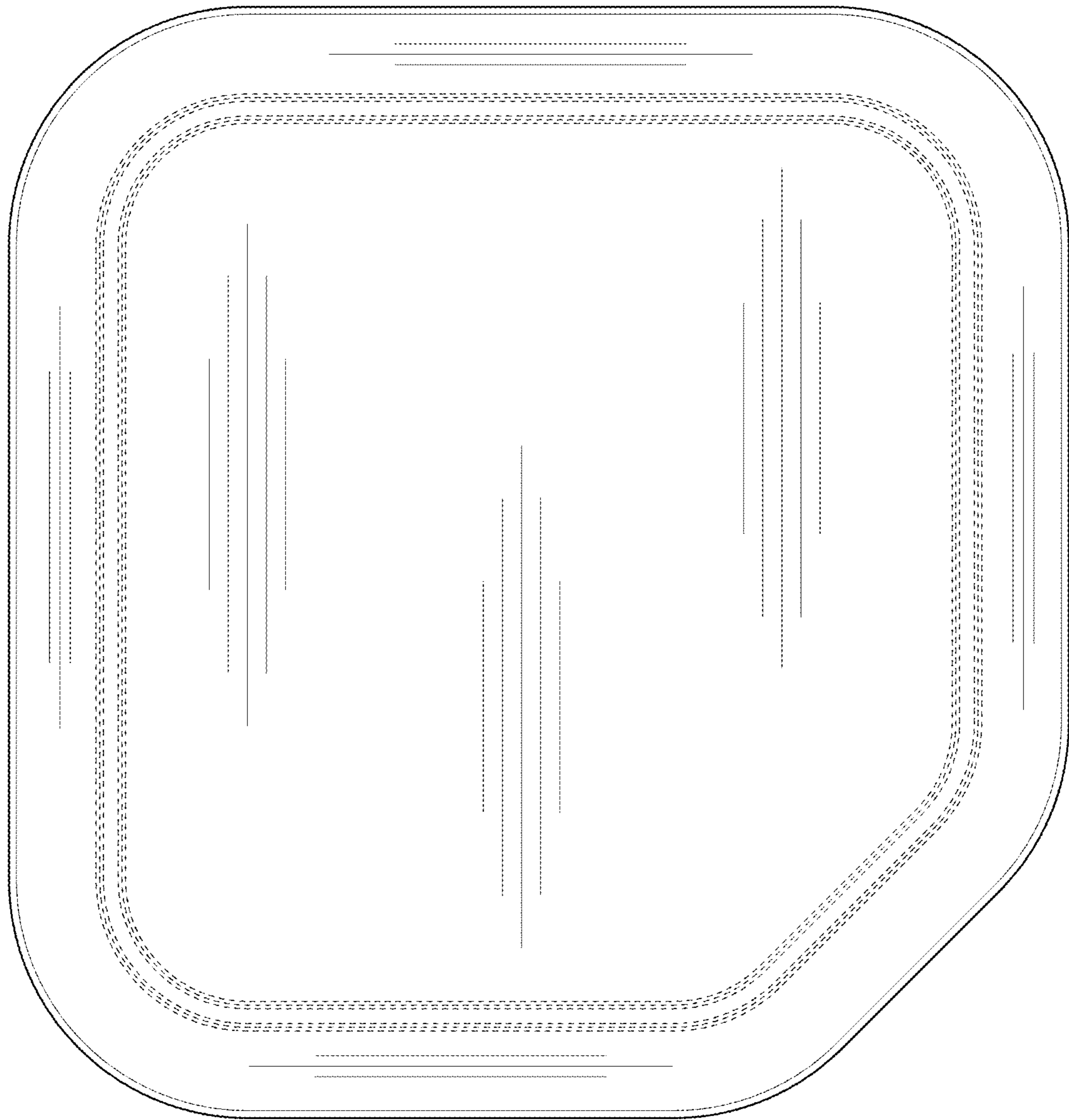

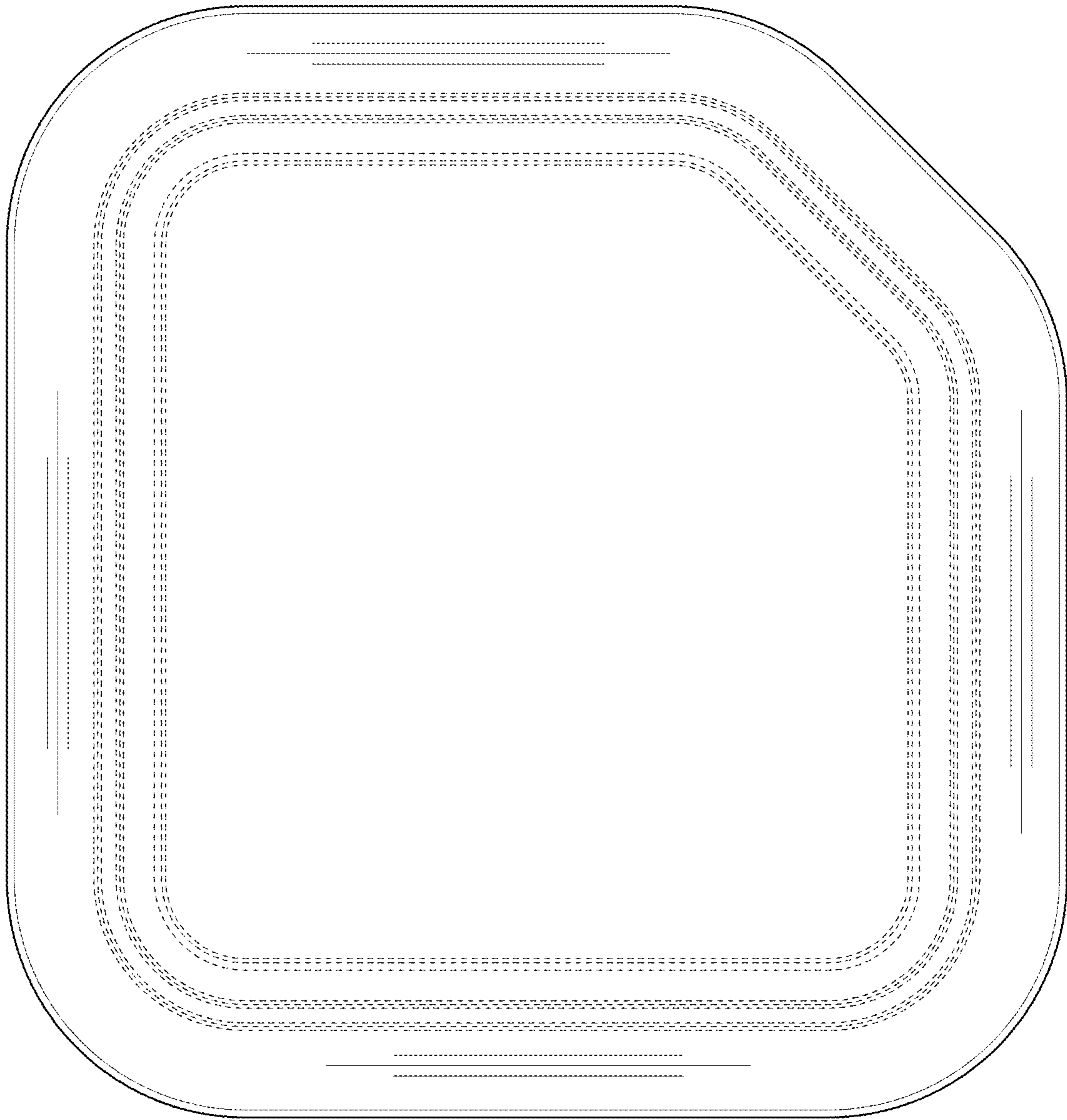

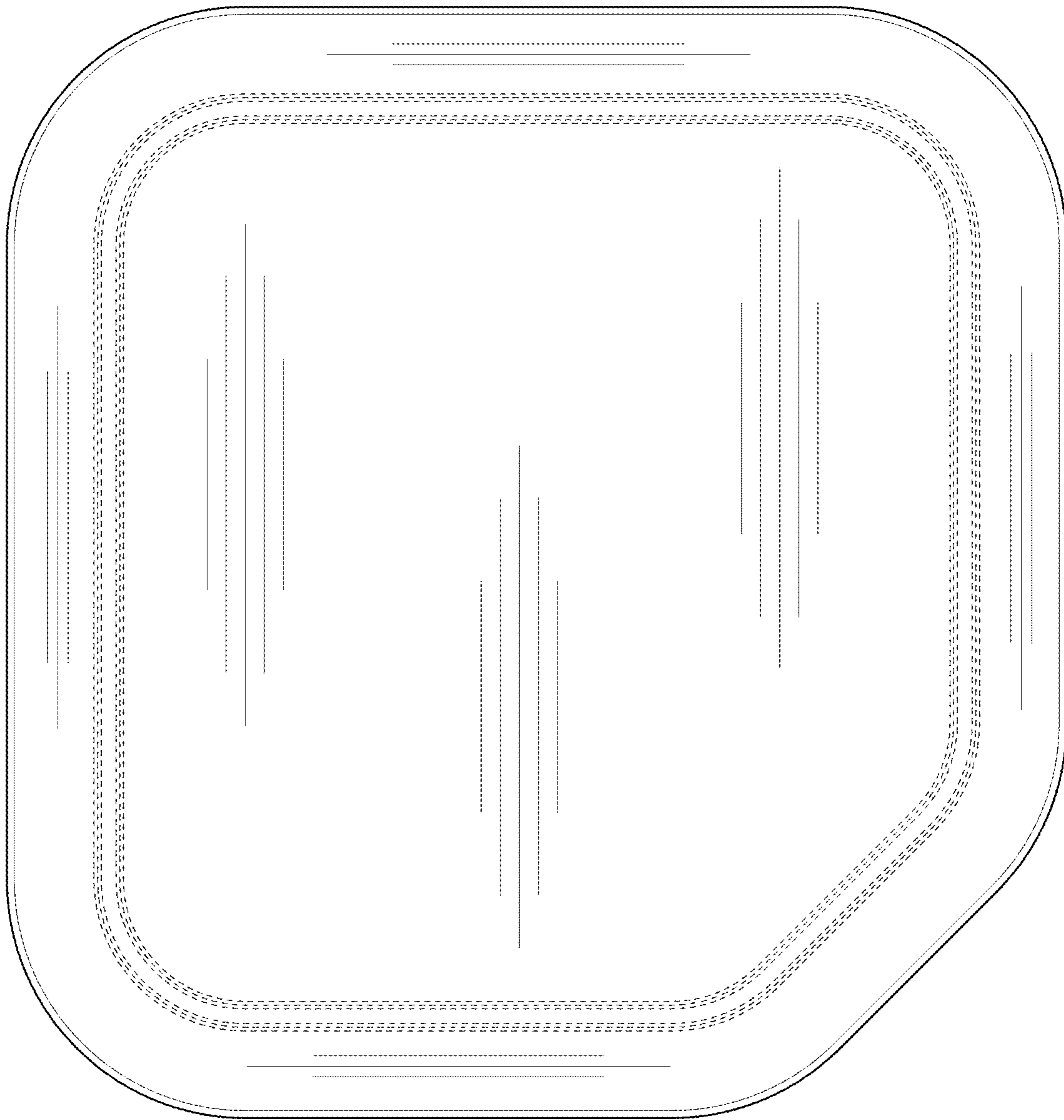

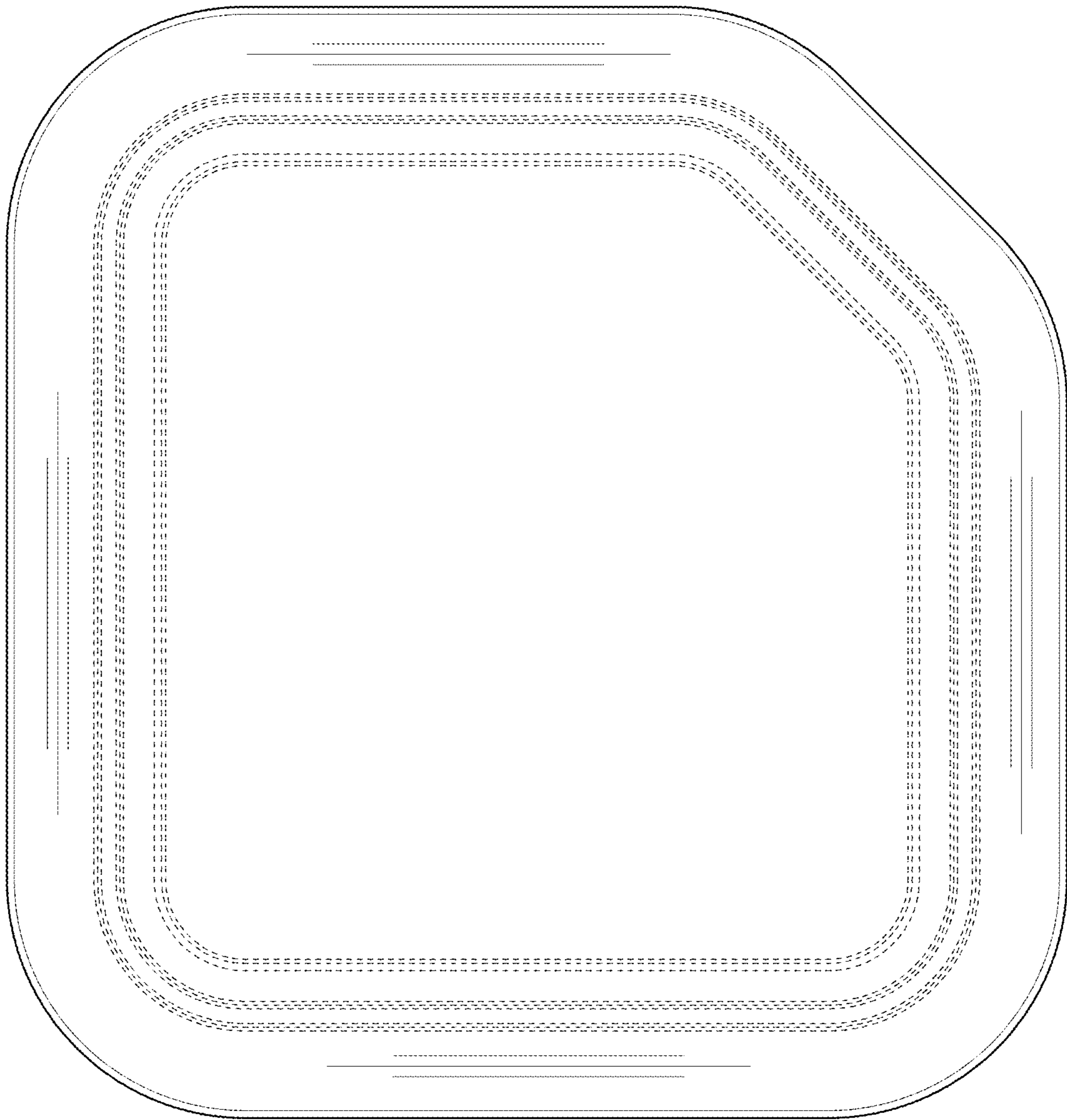
