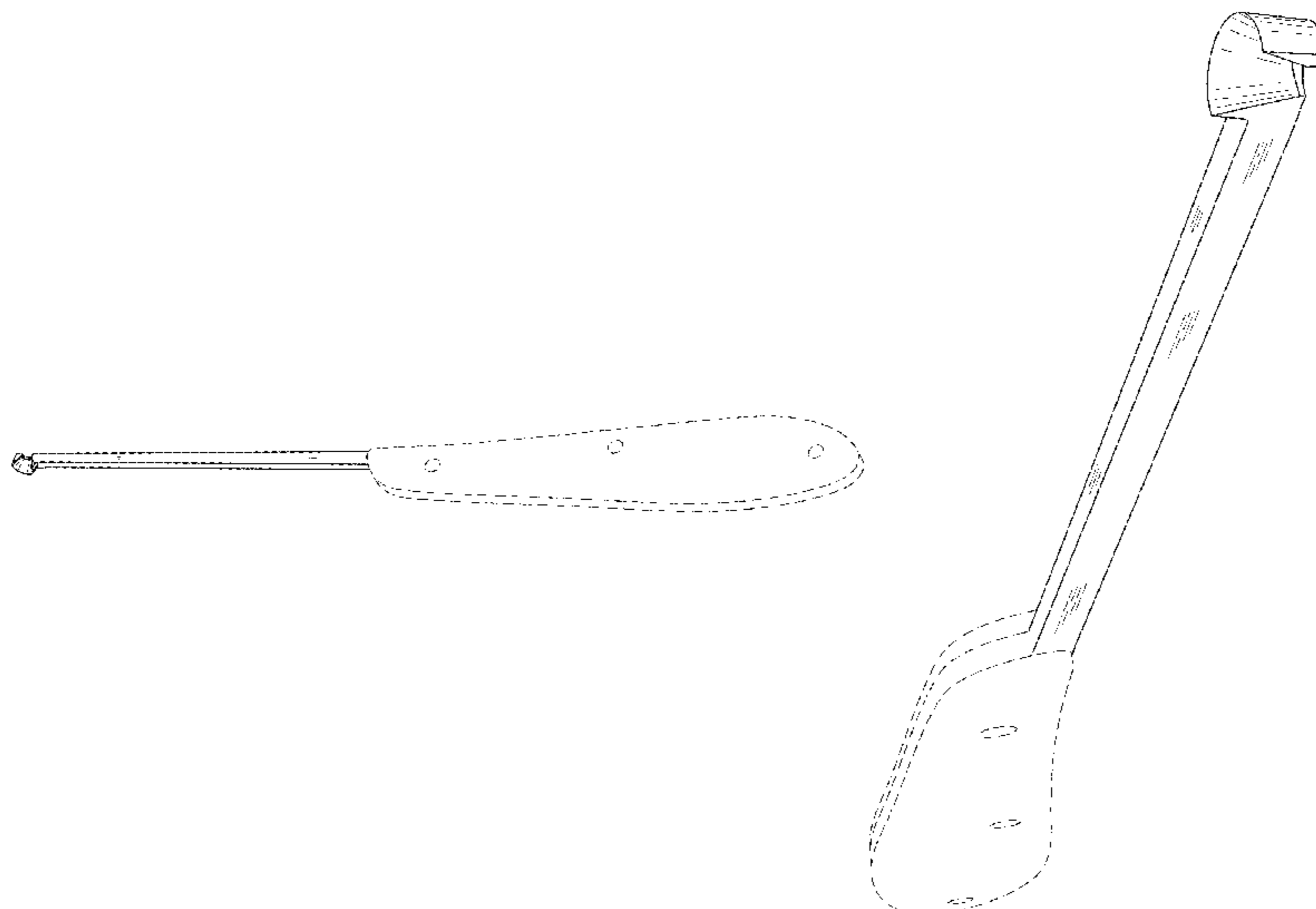
CLAIM

The ornamental design for a medical device for chondrectomy, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a medical device for chondrectomy showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a right side perspective view thereof; and,
FIG. 6 is a top, right side perspective view thereof.

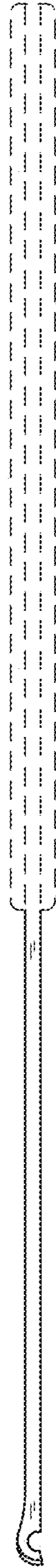

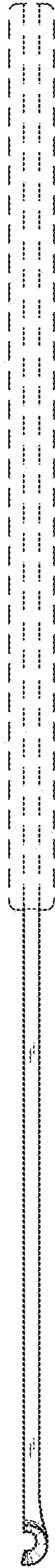

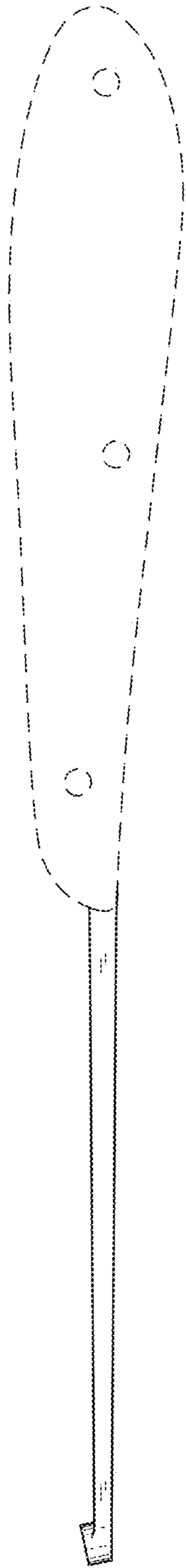

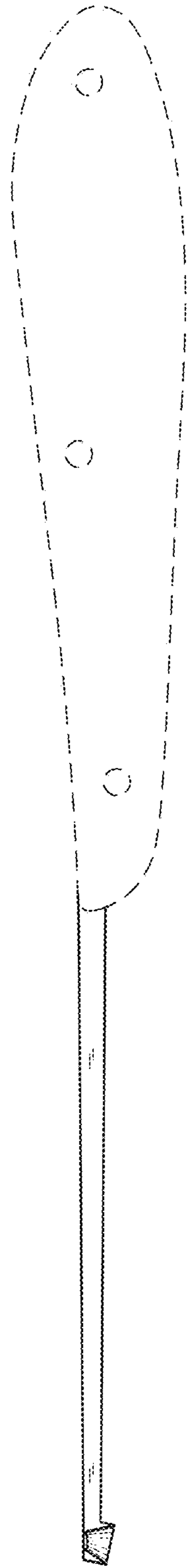

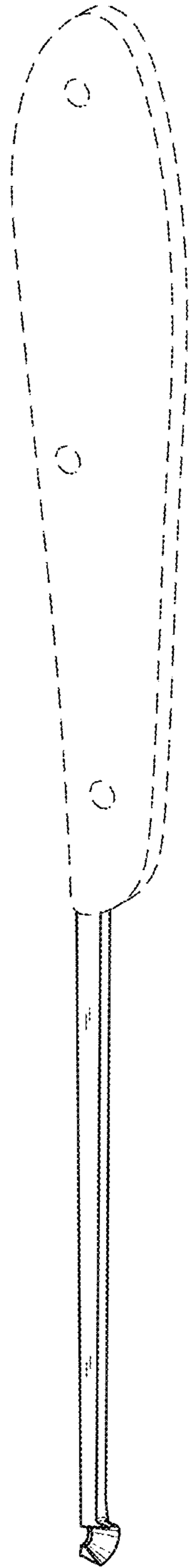

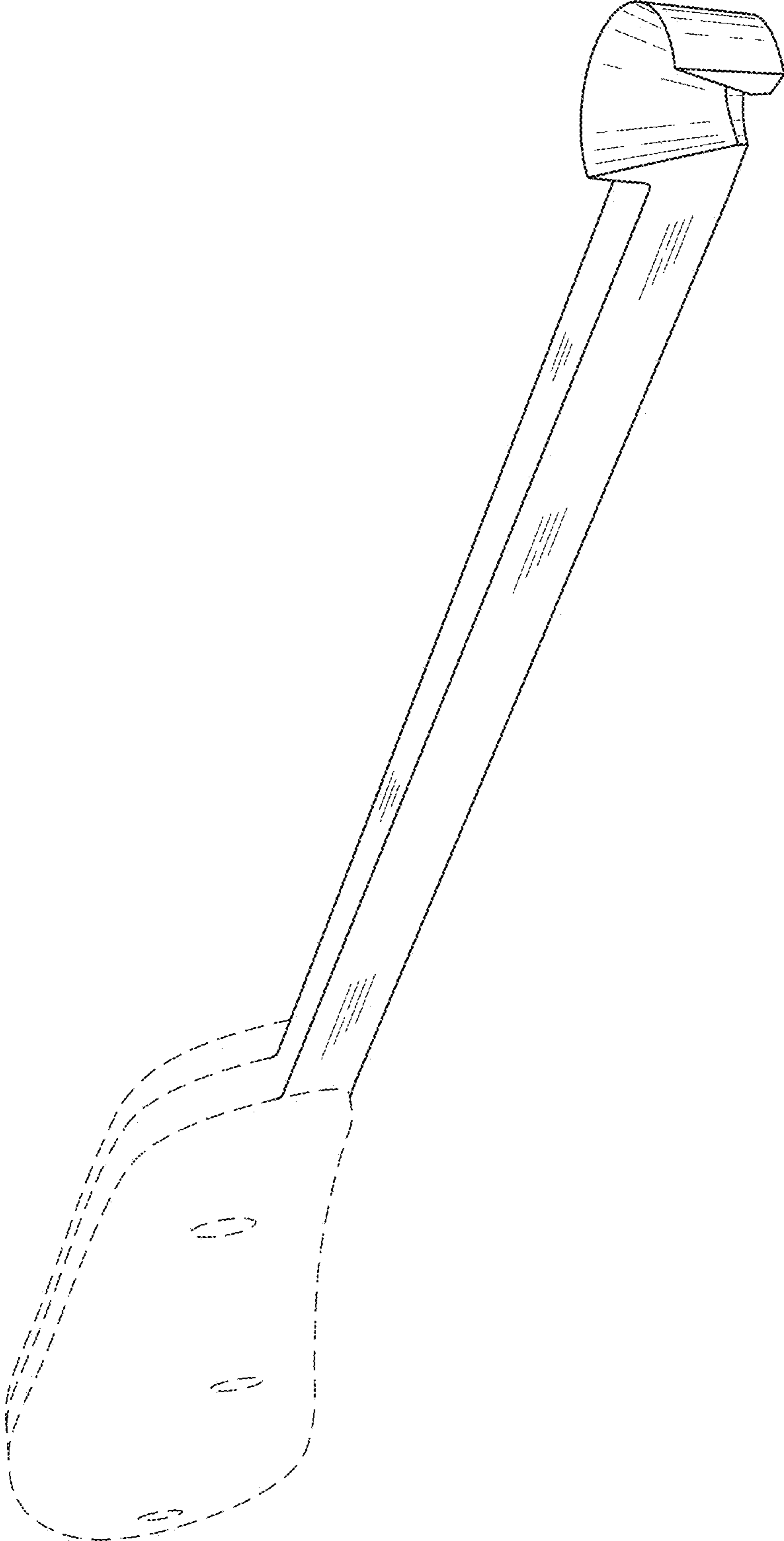
