(57) **CLAIM**
The ornamental design for a headlamp, as shown and described.

DESCRIPTION
FIG. 1 is a front left perspective view of a headlamp according to the present invention.
FIG. 2 is a rear right perspective view of the headlamp shown in FIG. 1.
FIG. 3 is a front right perspective view thereof.
FIG. 4 is a rear left perspective view thereof.
FIG. 5 is a front view thereof.
FIG. 6 is a rear view thereof.
FIG. 7 is a left side view thereof.
FIG. 8 is a right side view thereof.
FIG. 9 is a top view thereof.
FIG. 10 is a bottom view thereof; and,
FIG. 11 is another front view thereof, but with the headlamp mounted on a vehicle, the rest of which is shown in lighter tones. More particularly, in FIG. 11, the inventive headlamp design is shown inside the broken line. The broken line itself serves as an unclaimed boundary, and the vehicle portions located outside the broken line are also unclaimed, but included to show environment.


















