DESCRIPTION

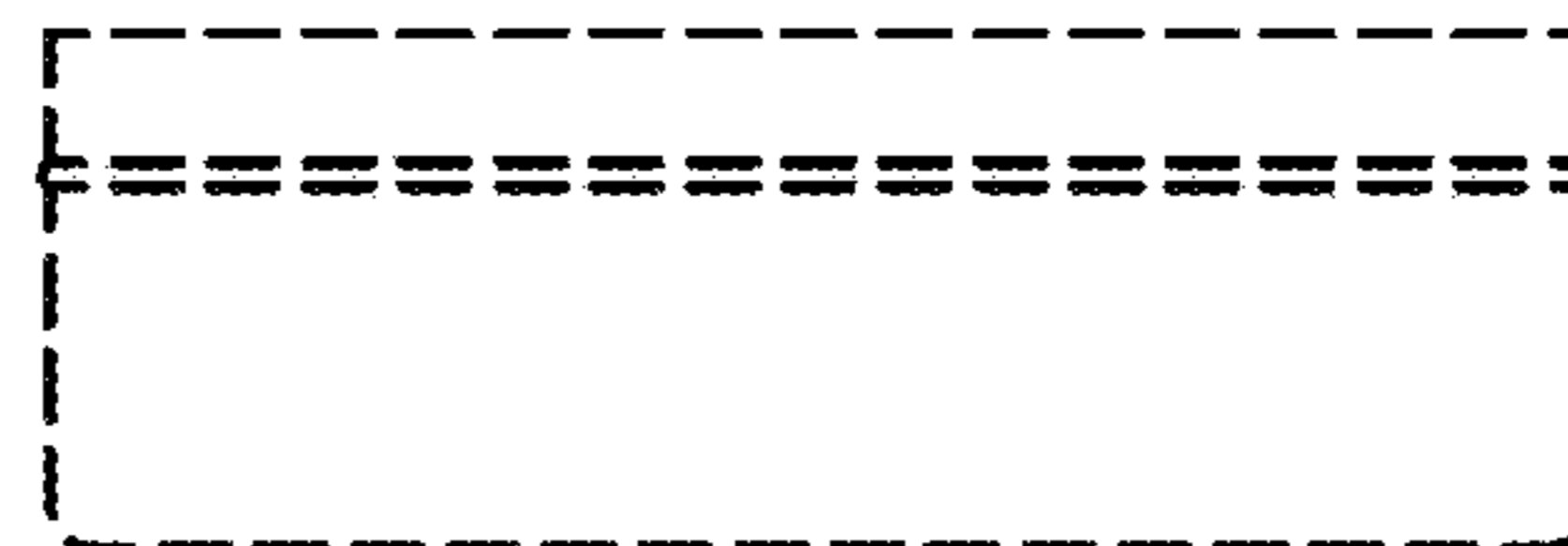
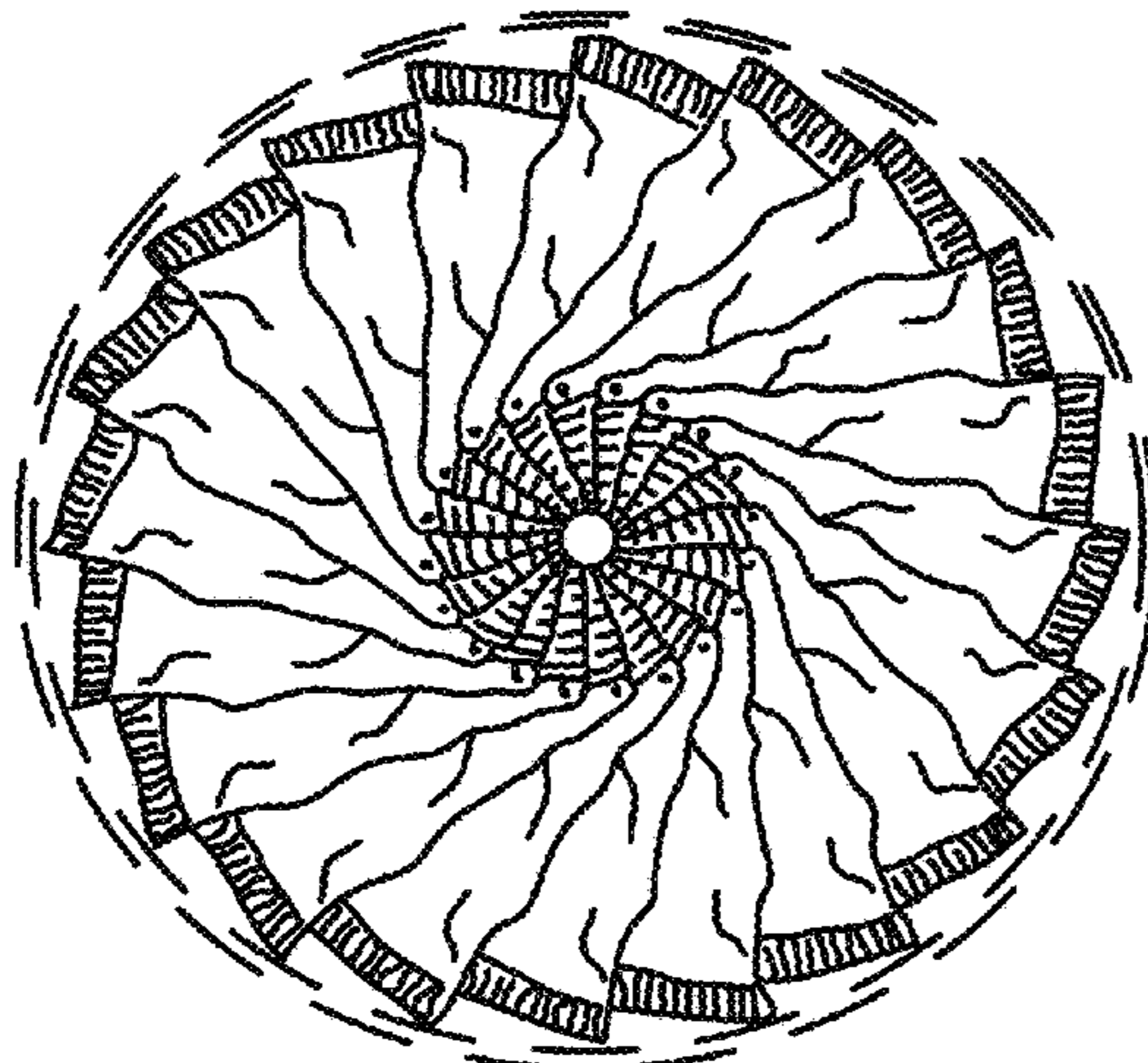
FIG. 1 is a top view of a configuration of snuff bags in a snuff box.

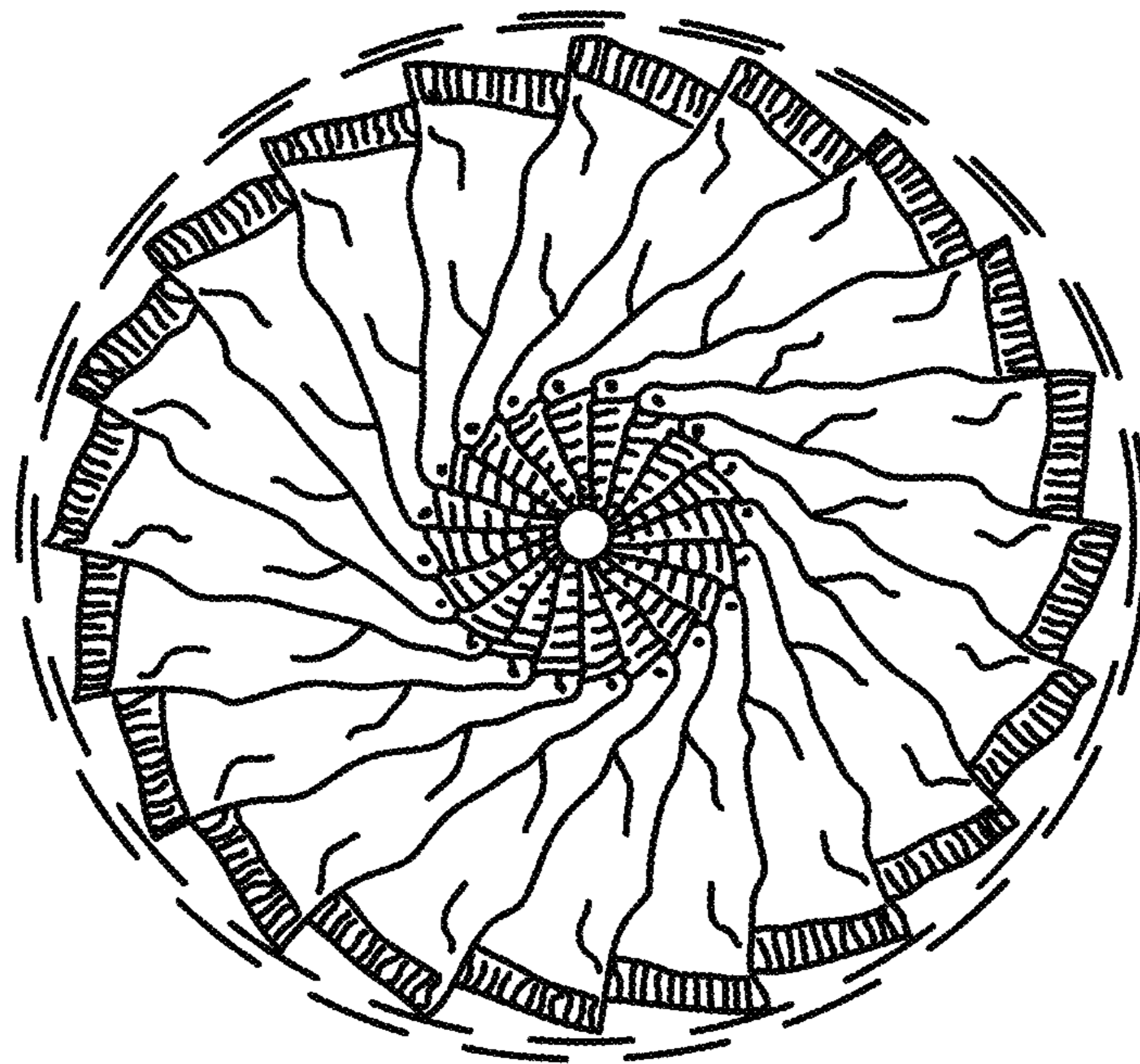

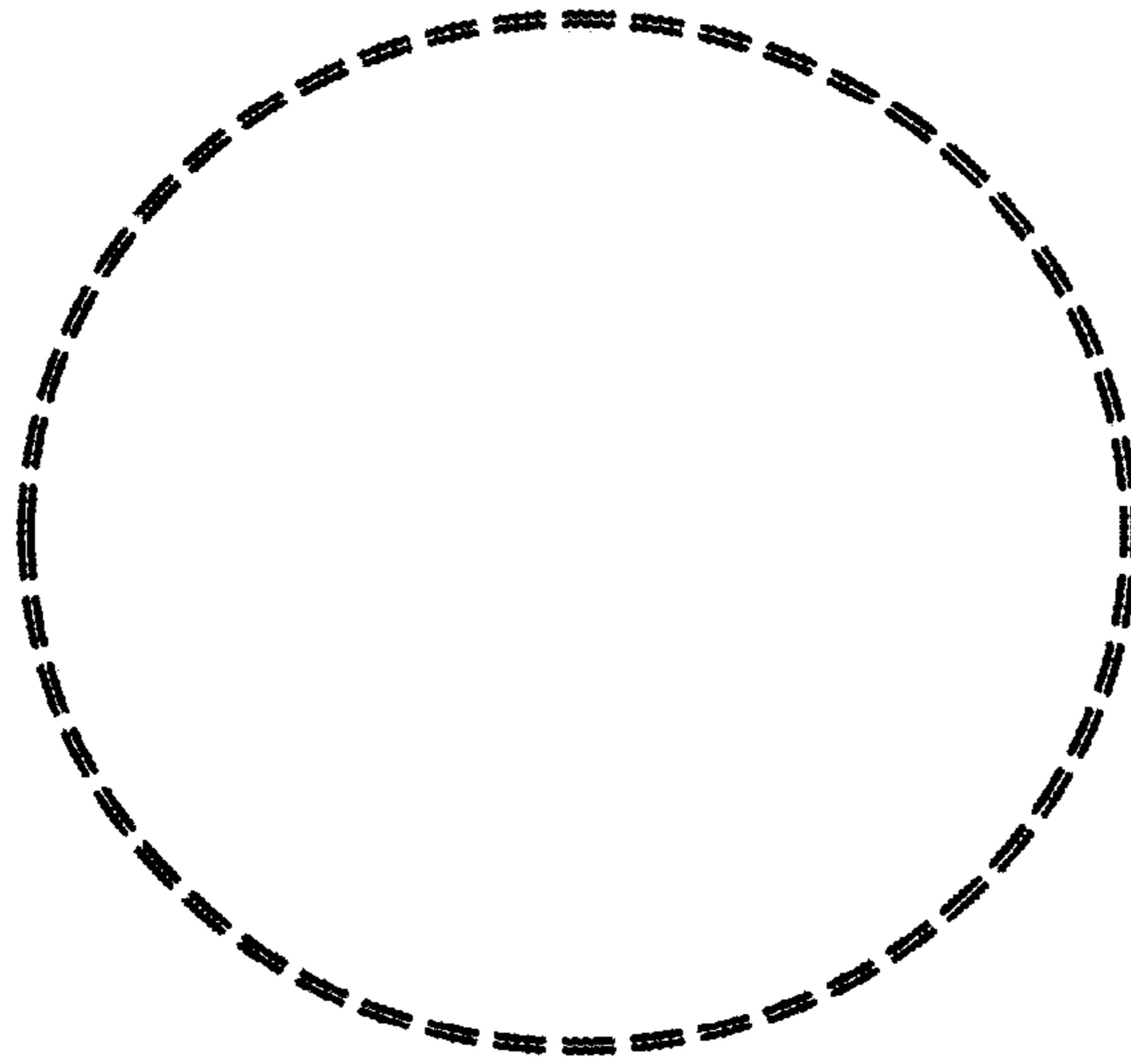

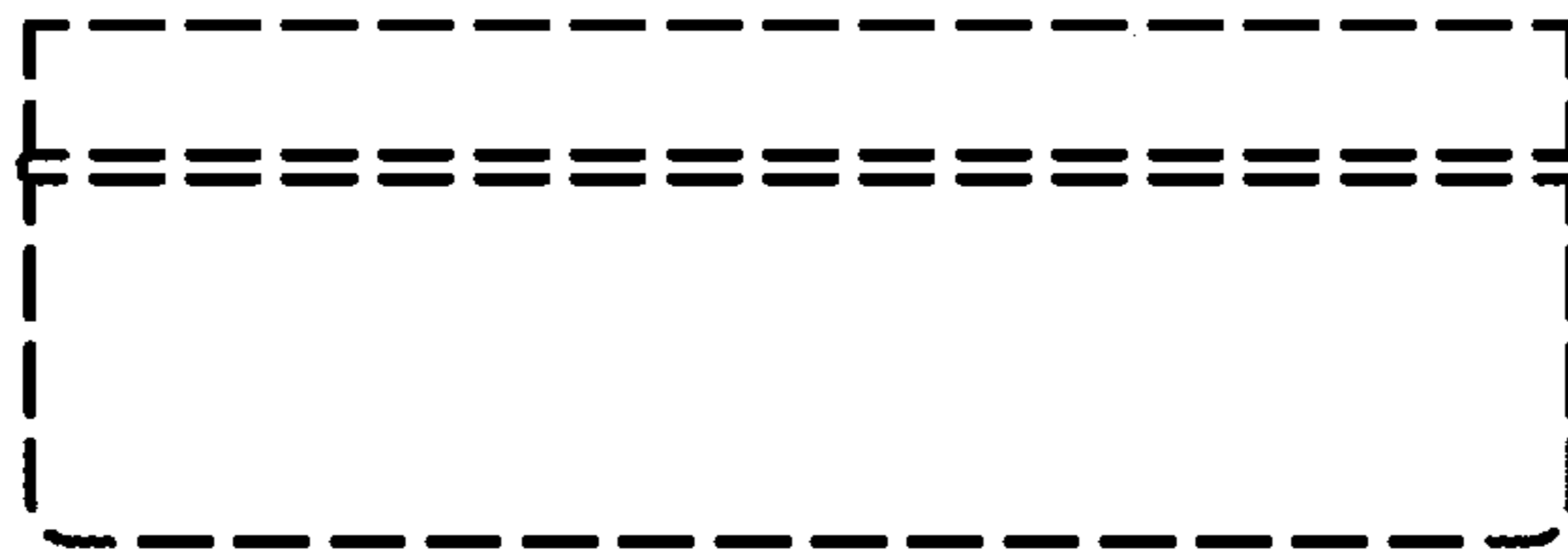
