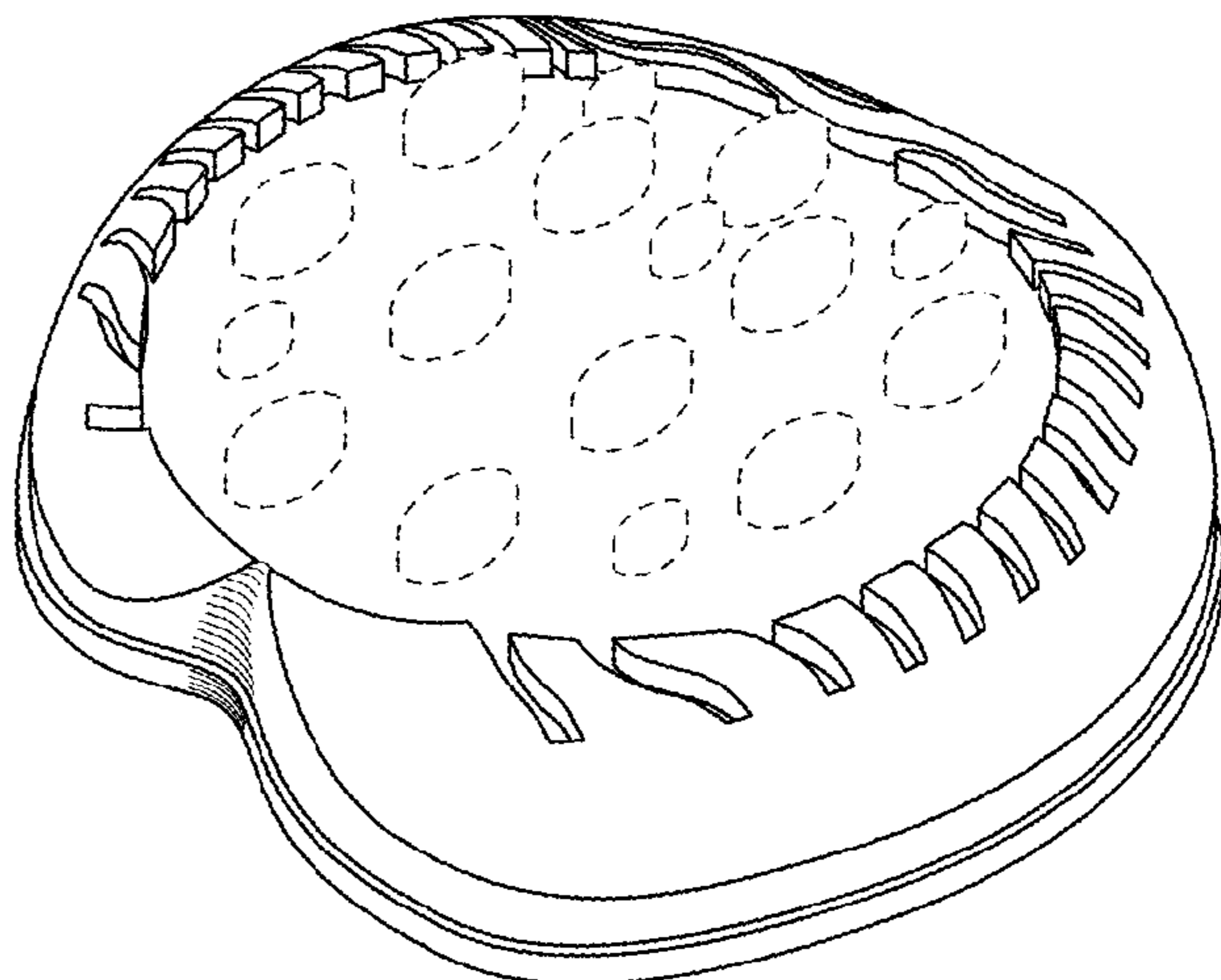
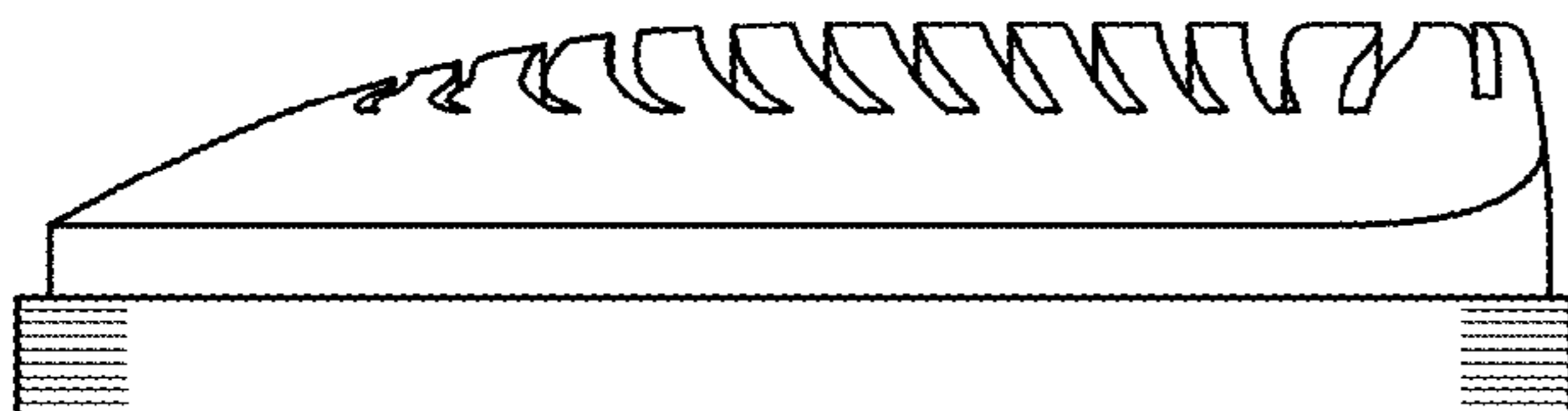
(57) **CLAIM**

The ornamental design for an equine rocker shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top elevational view of an equine rocker shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a sectional view taken in the direction of 3, 3 thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a top perspective view thereof.
The broken lines showing oblong patterns in FIGS. 1, 3, 4, 5, and 7 depict portions of the equine rocker shoe that form no part of the claimed design.

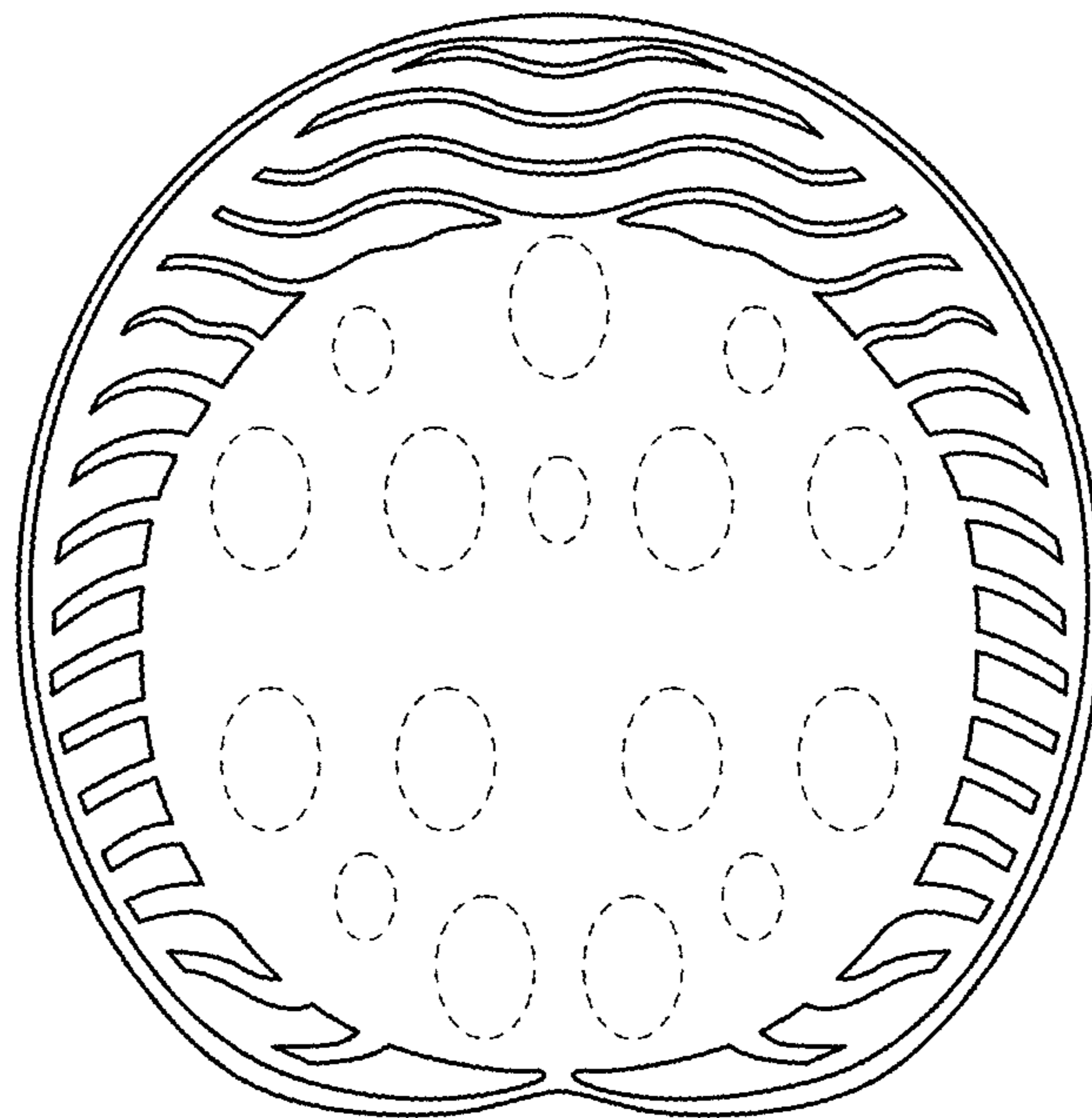

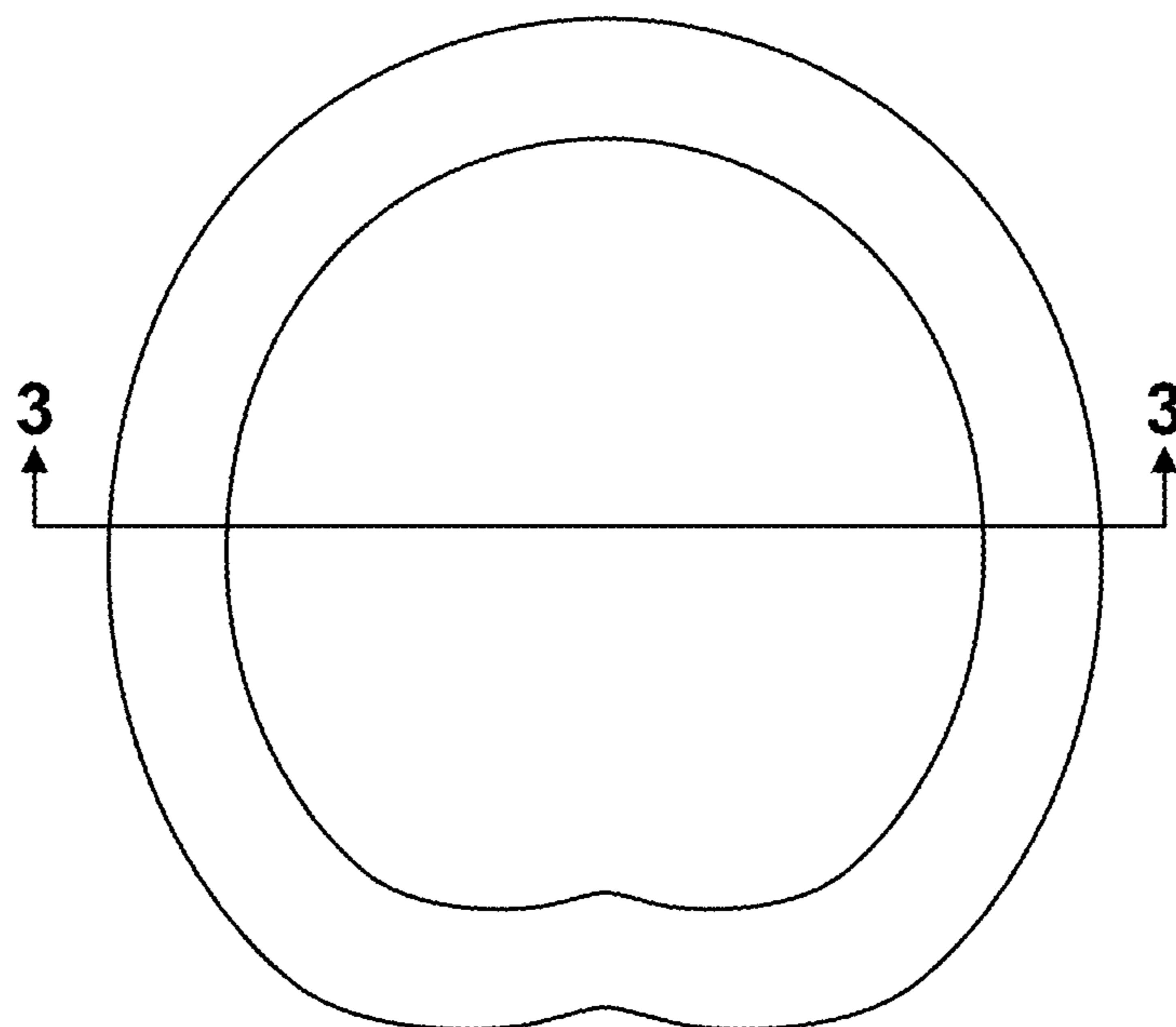

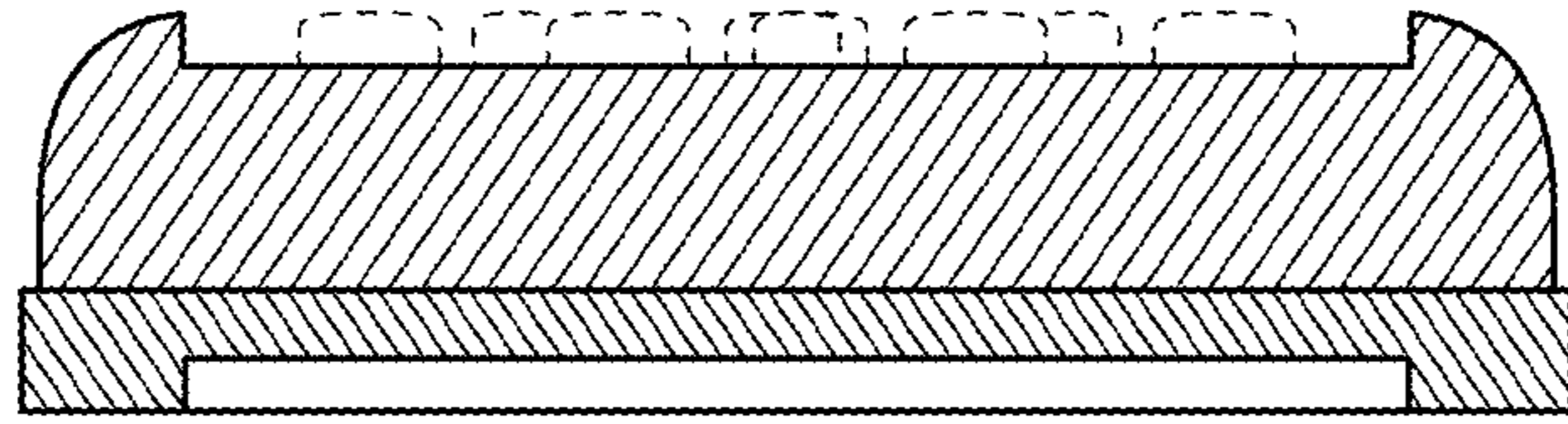

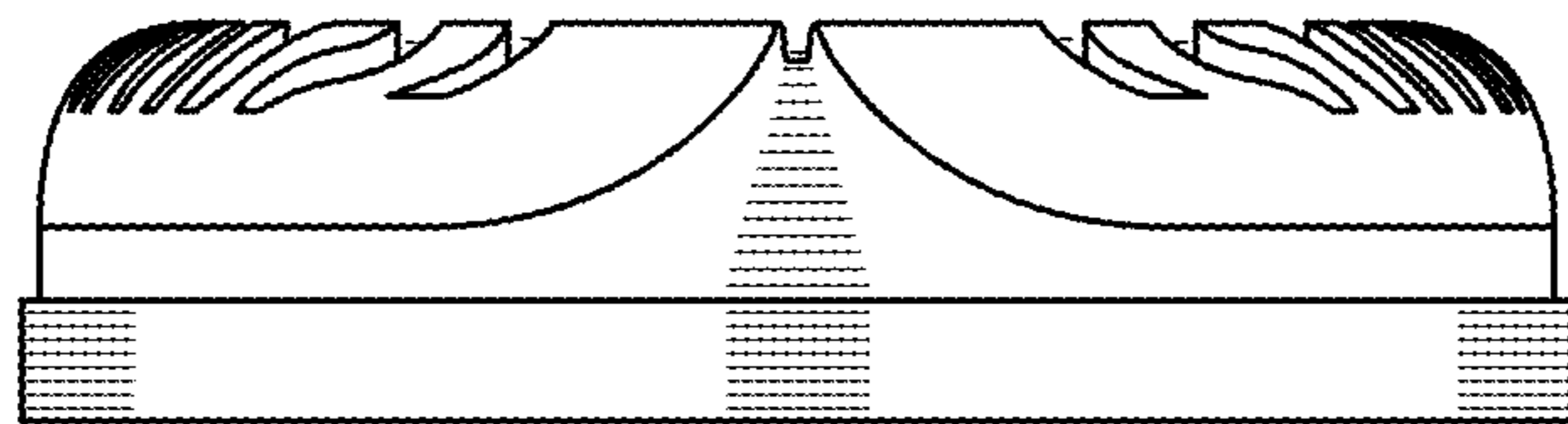

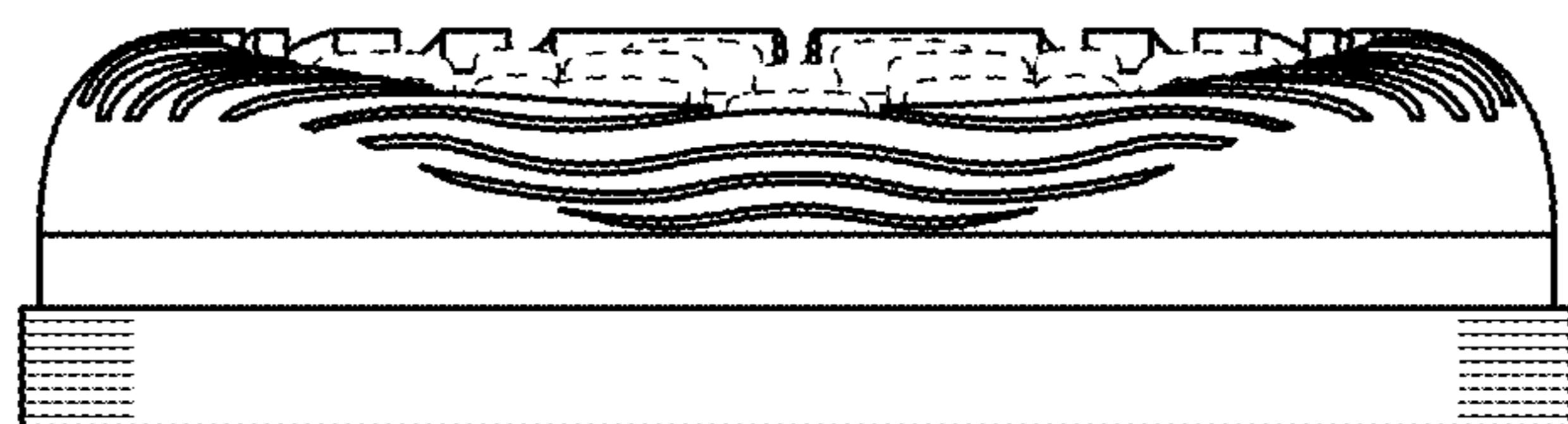

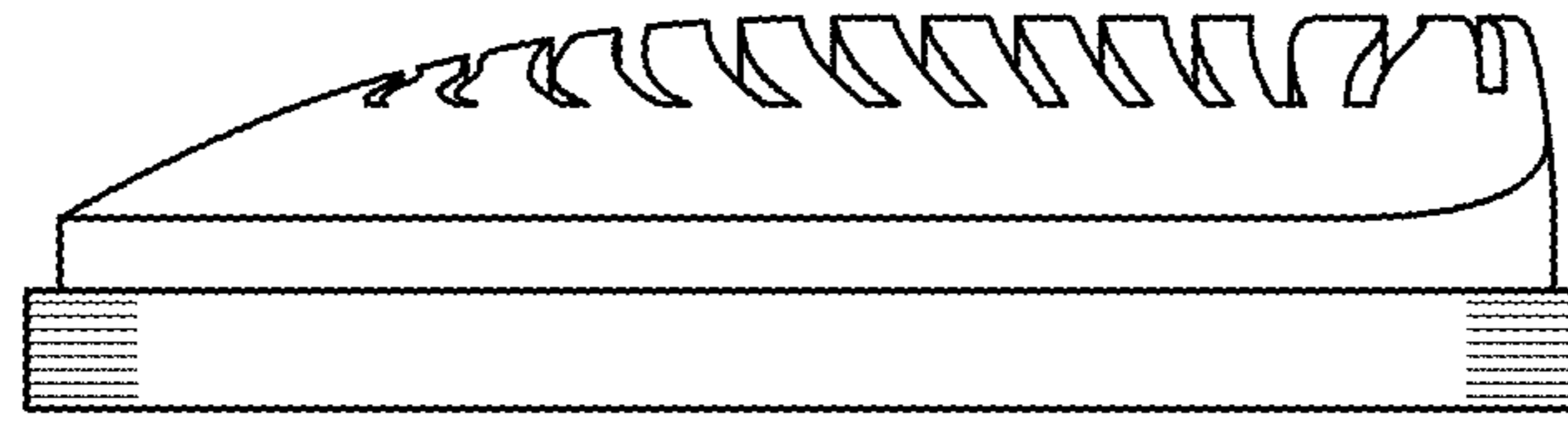

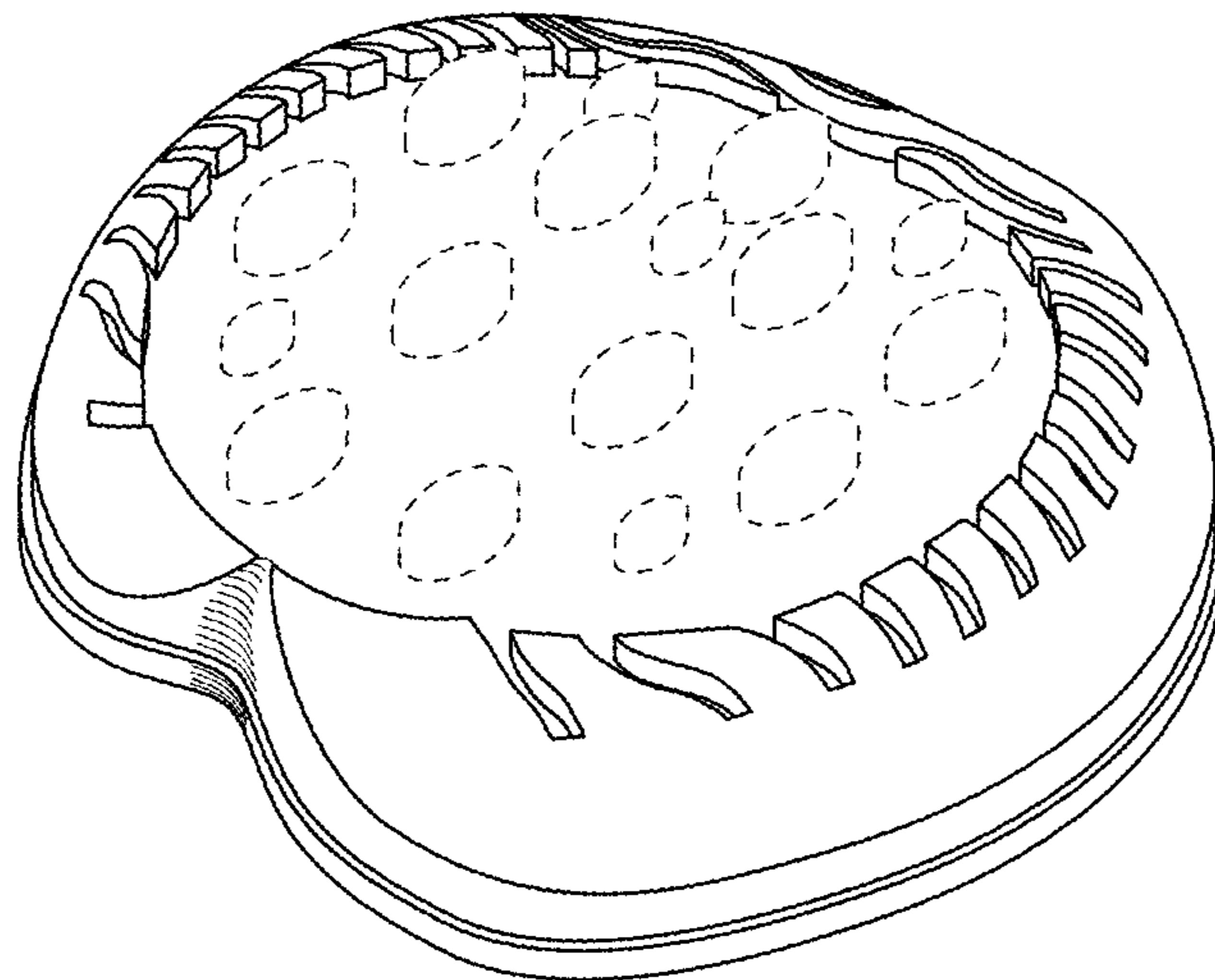
