The drawings only show the design on the left shoe; the right shoe is omitted as it is symmetrical to the left shoe.

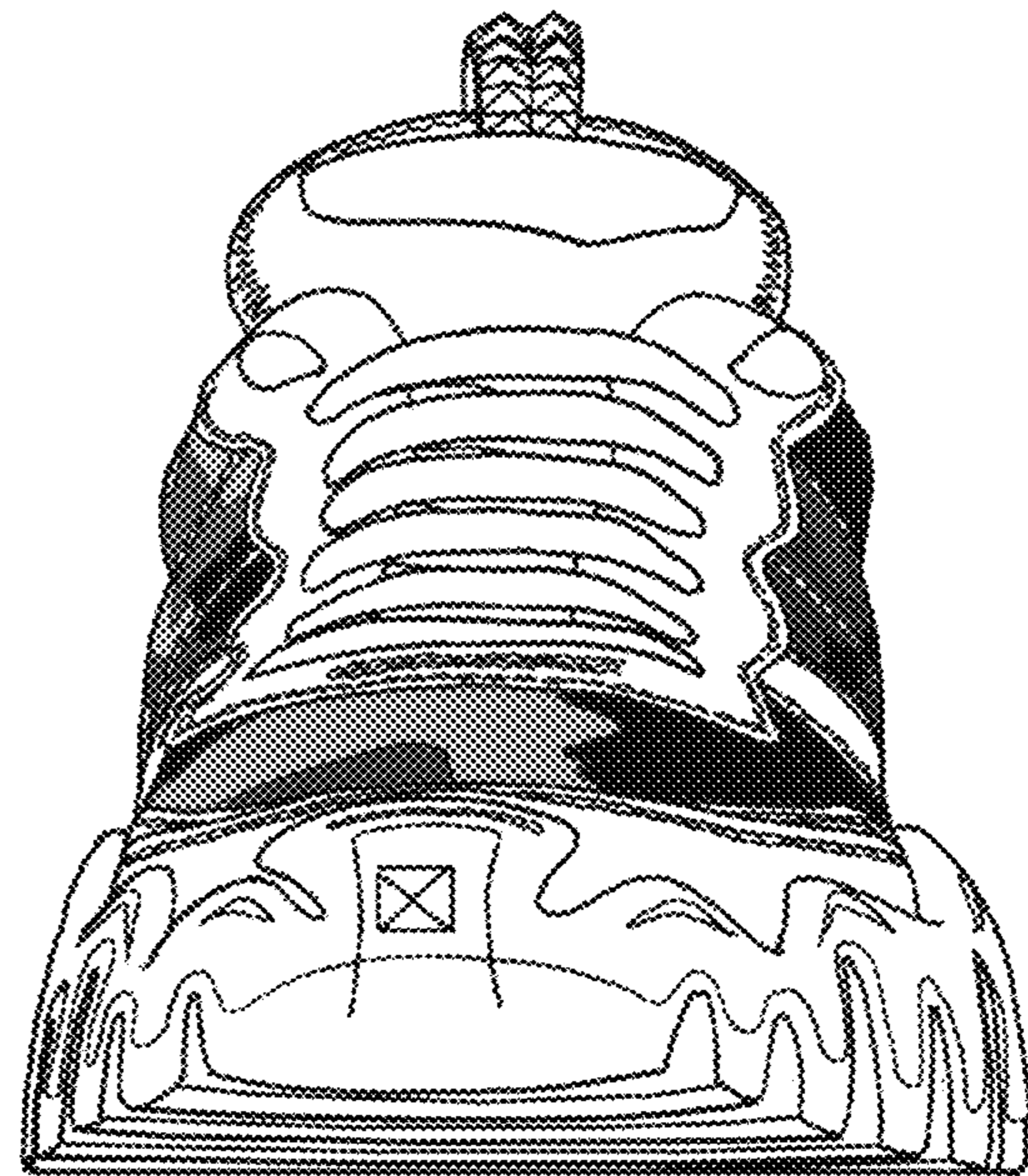

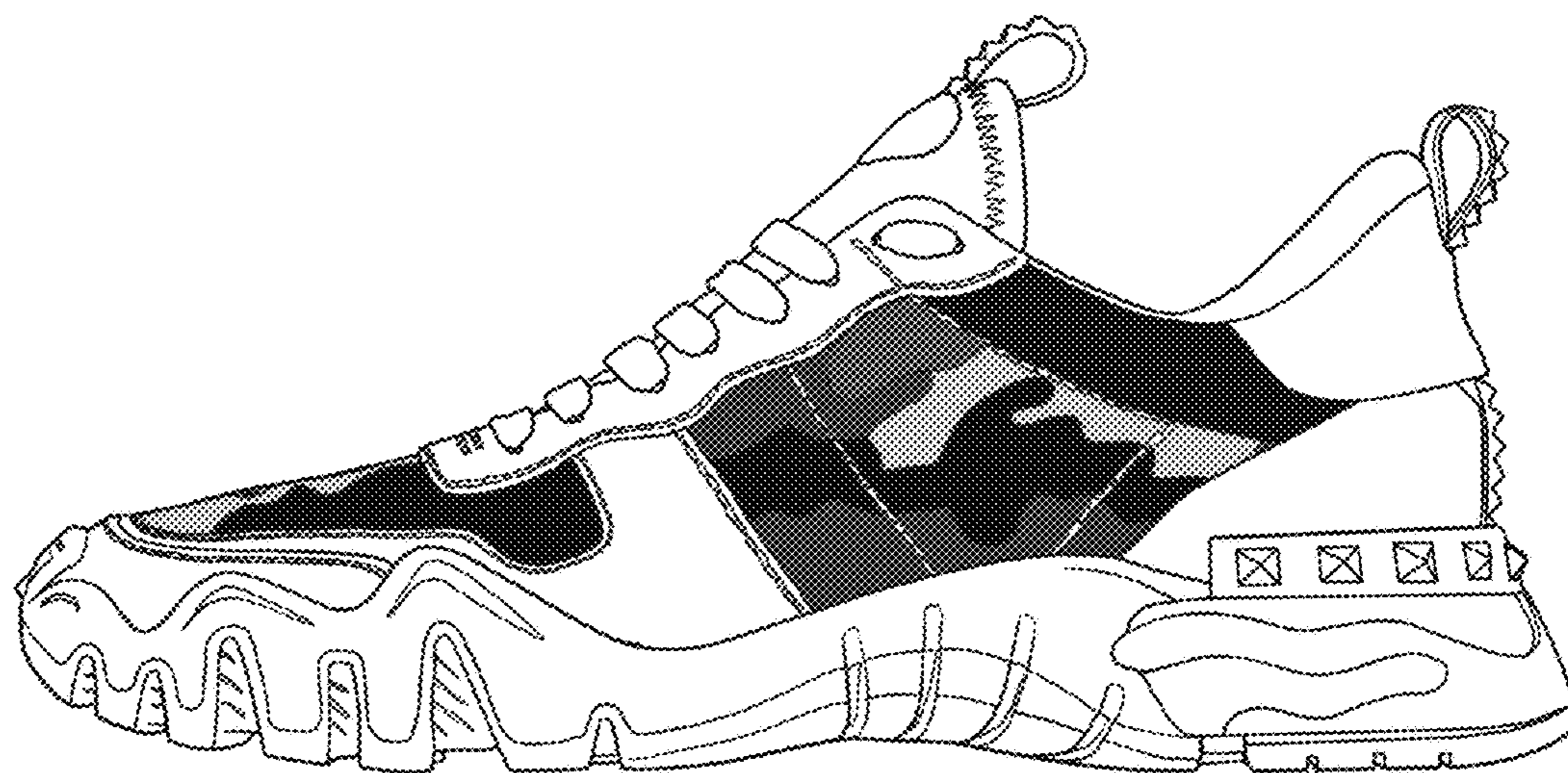

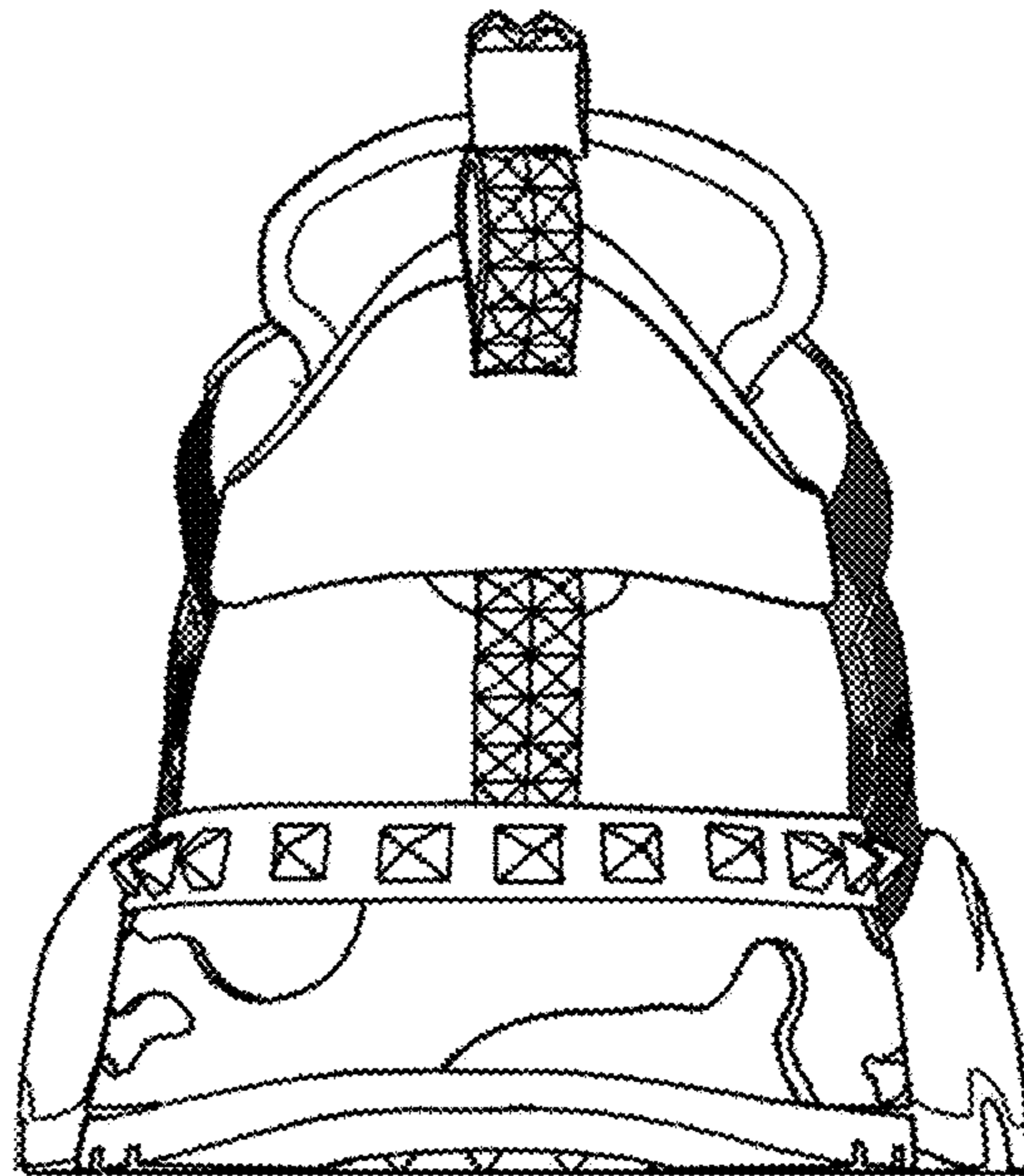

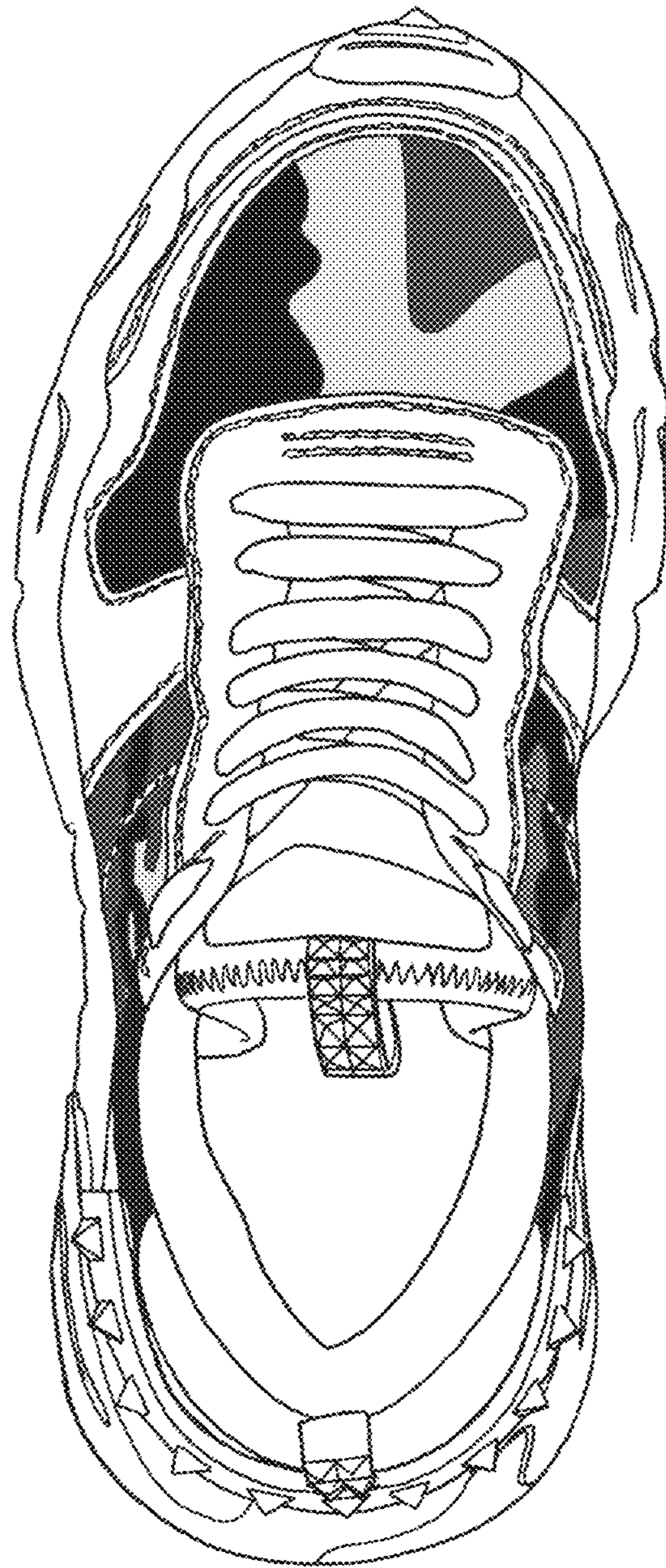

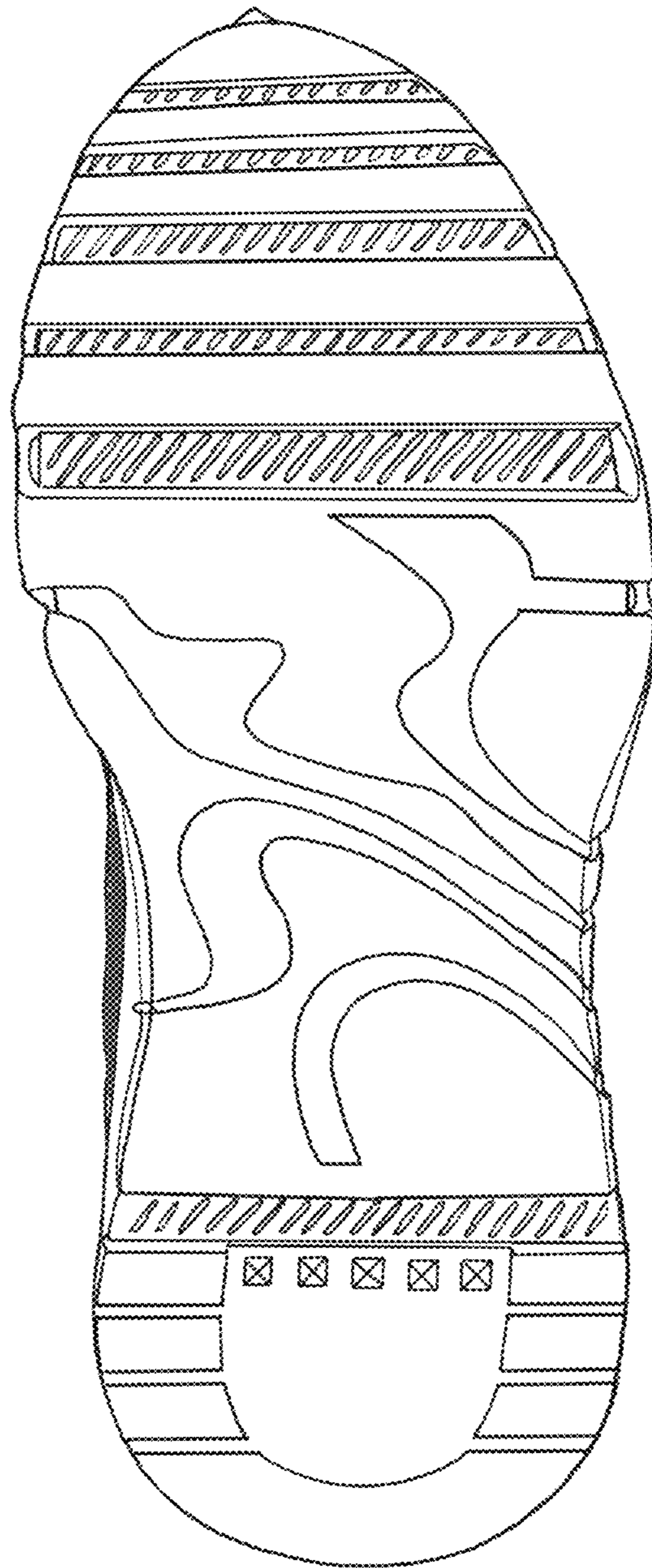

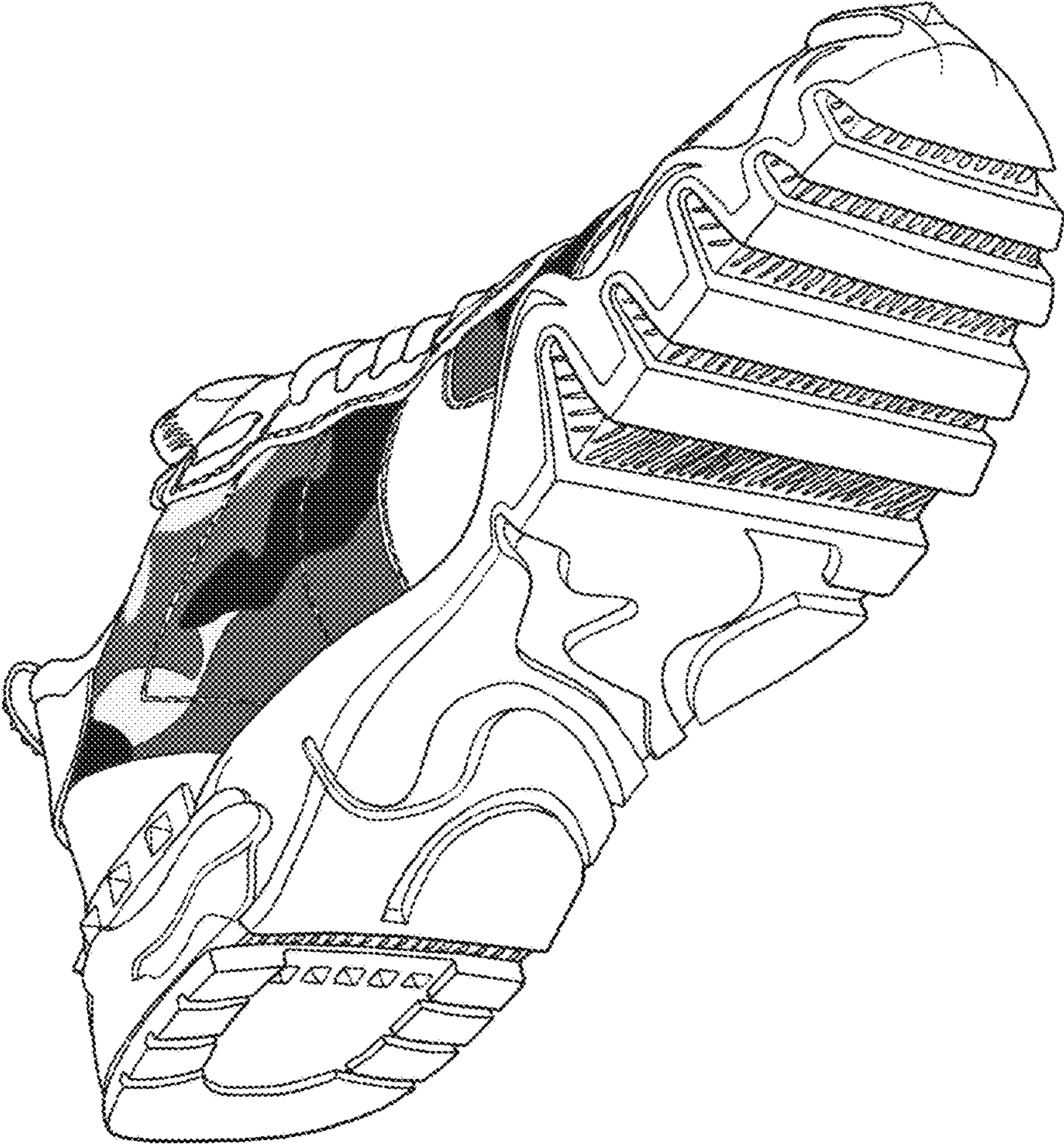
