(57) **CLAIM**

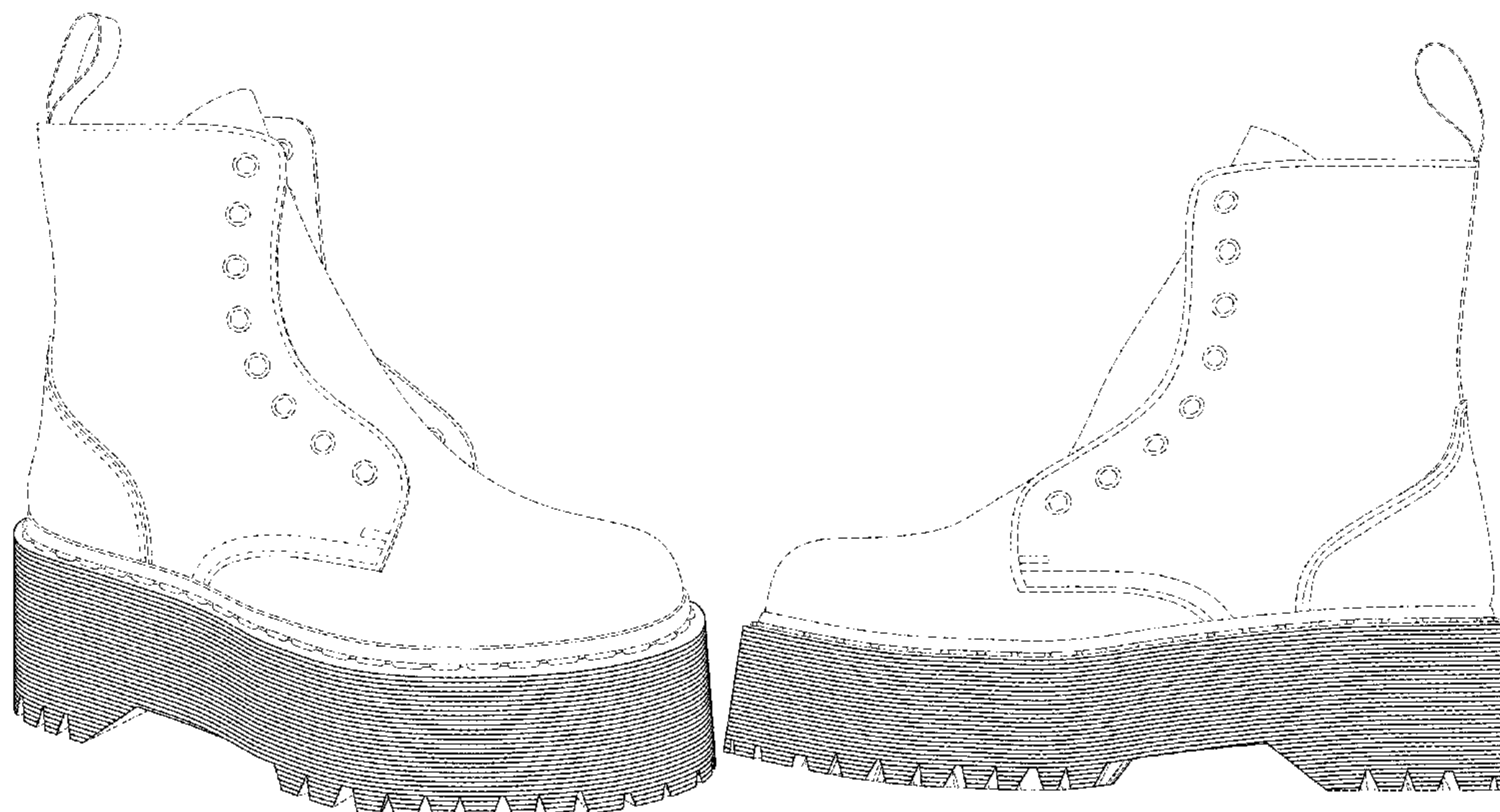
The ornamental design for a footwear sole, as shown and described.

DESCRIPTION

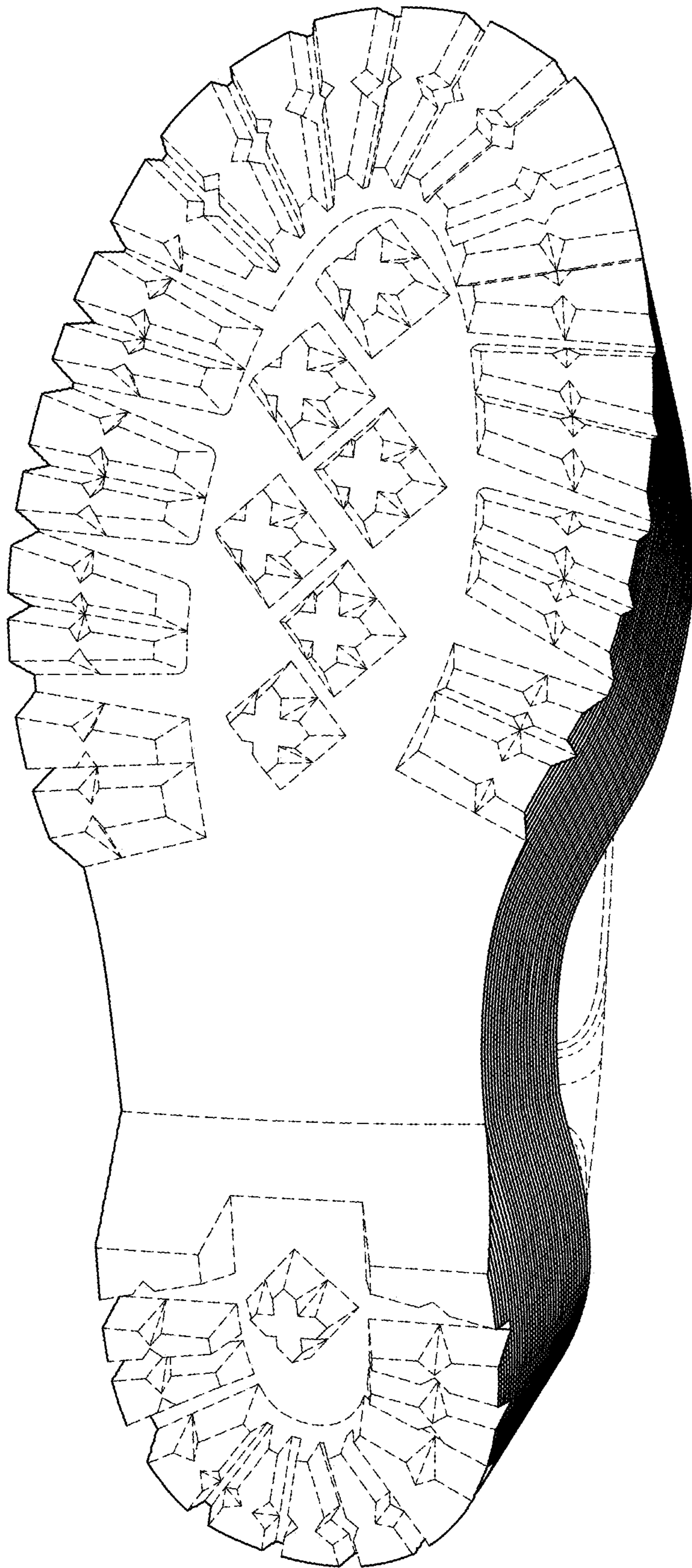

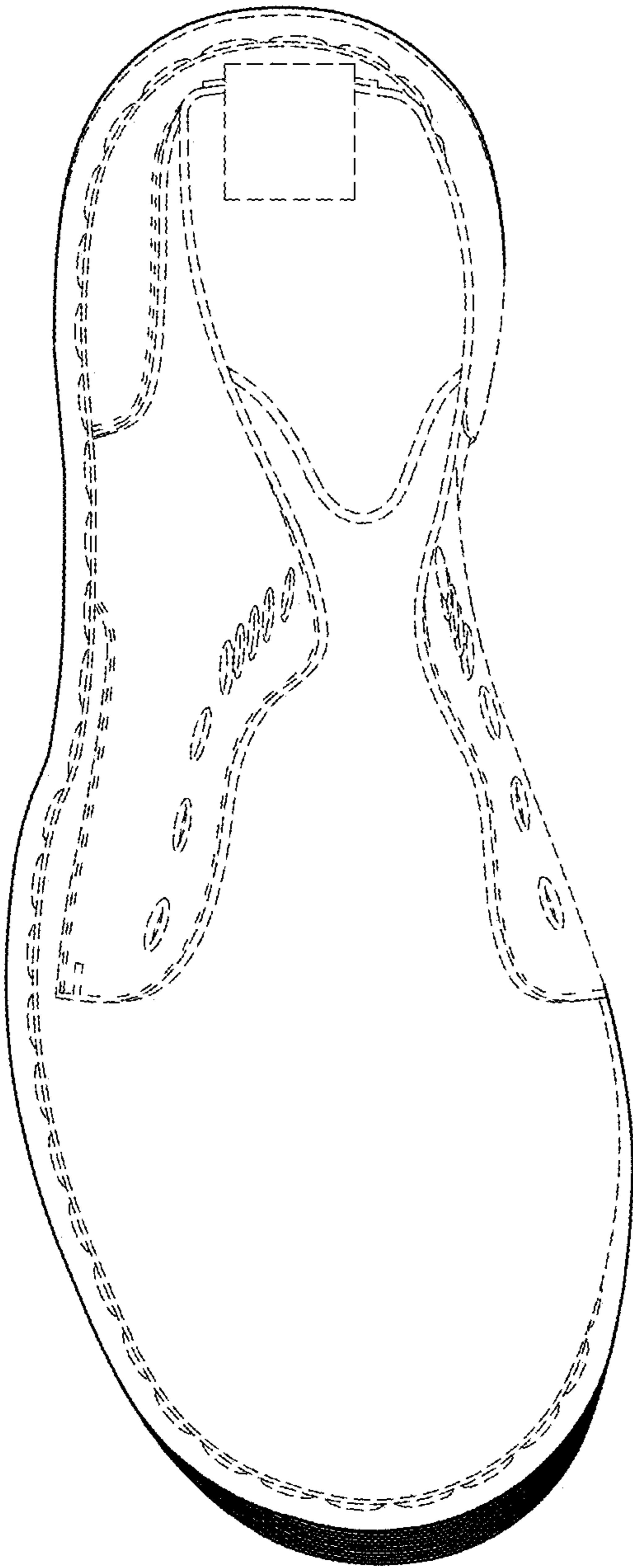

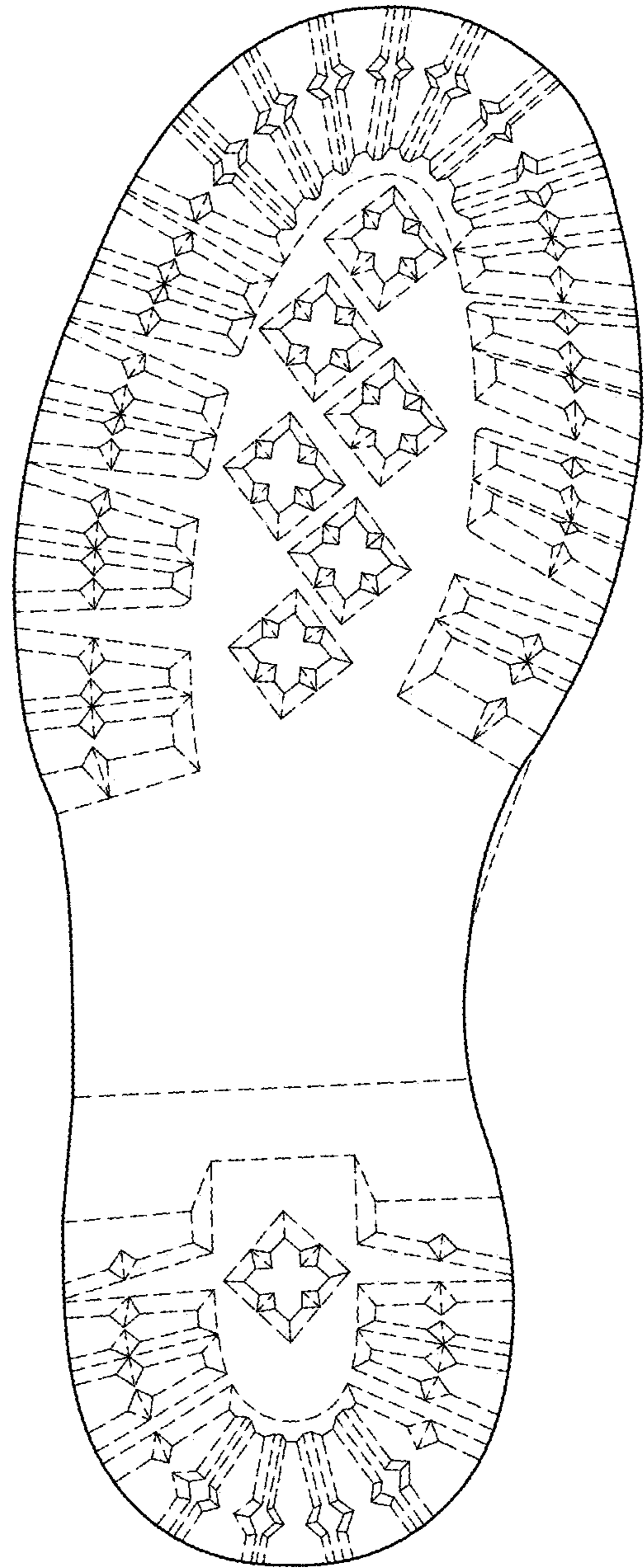

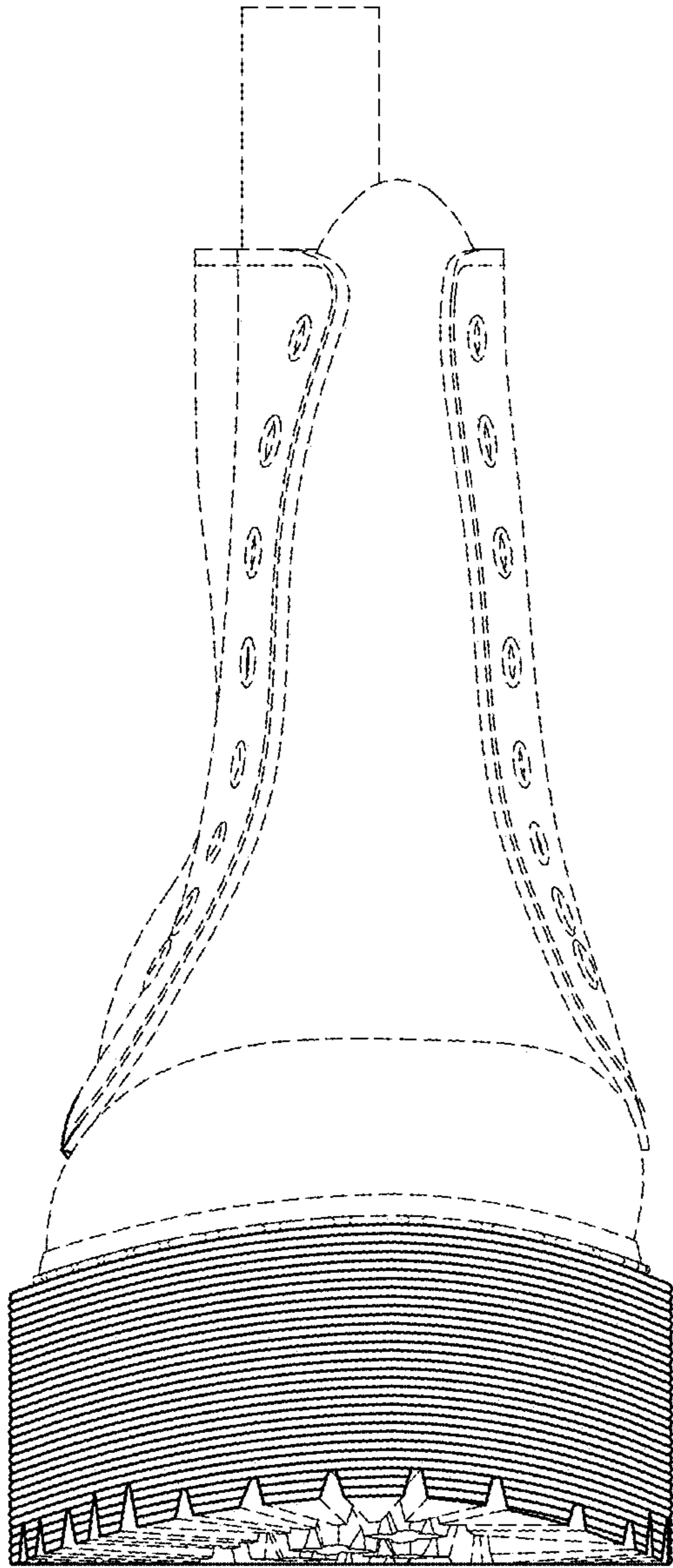

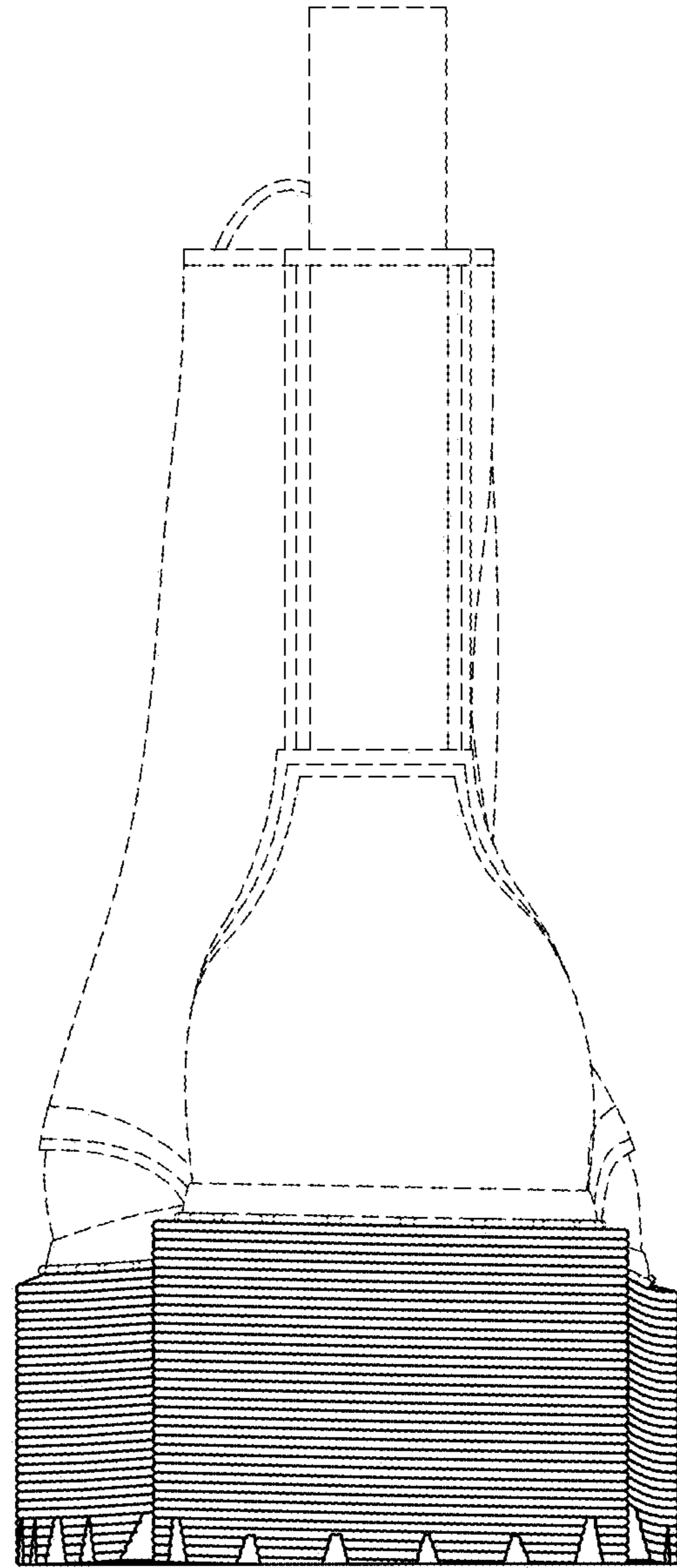
