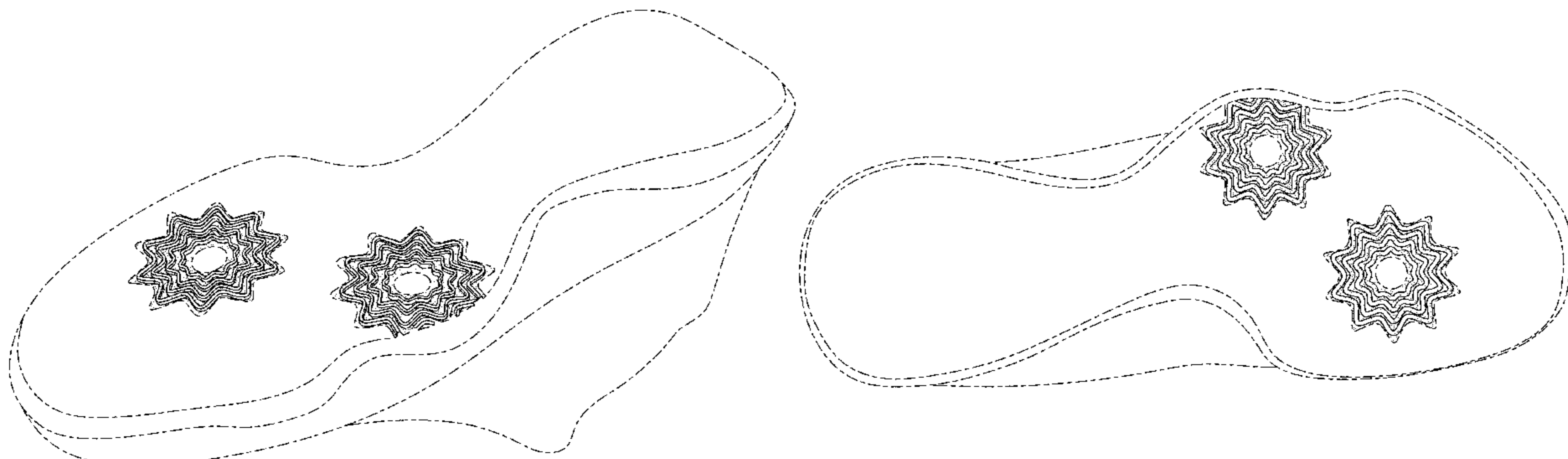
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design; and, FIG. 2 is a bottom view thereof. The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The broken line showing of the two unshaded circles within the shaded areas form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

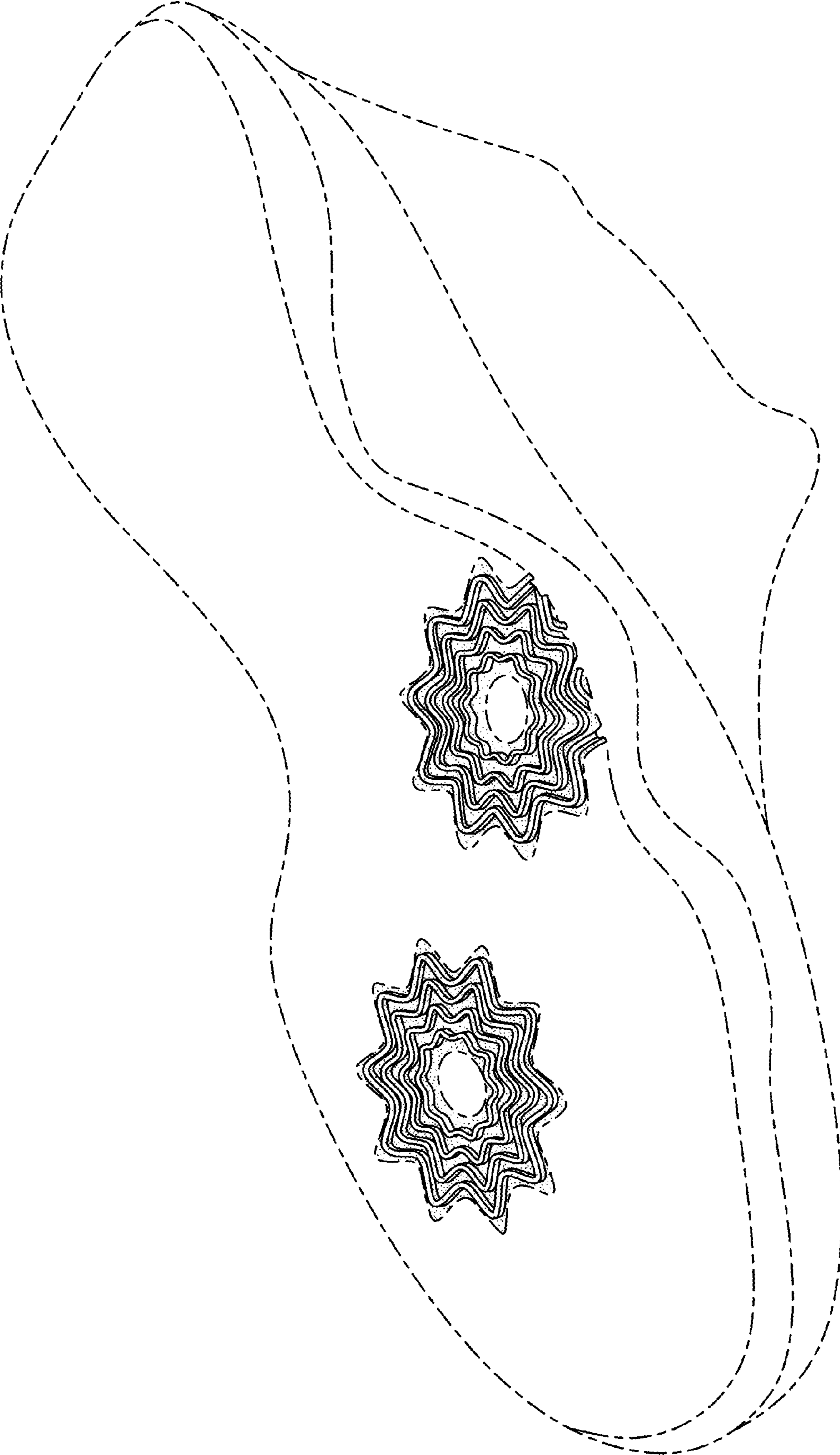

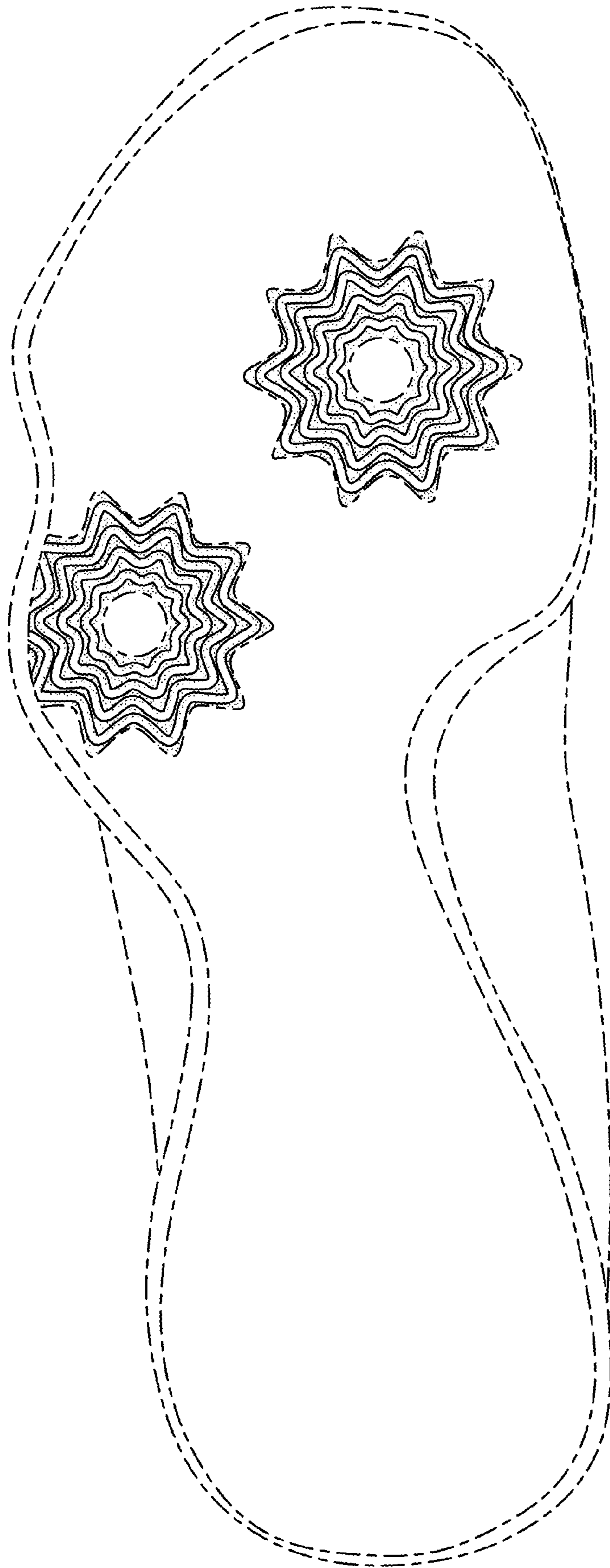
