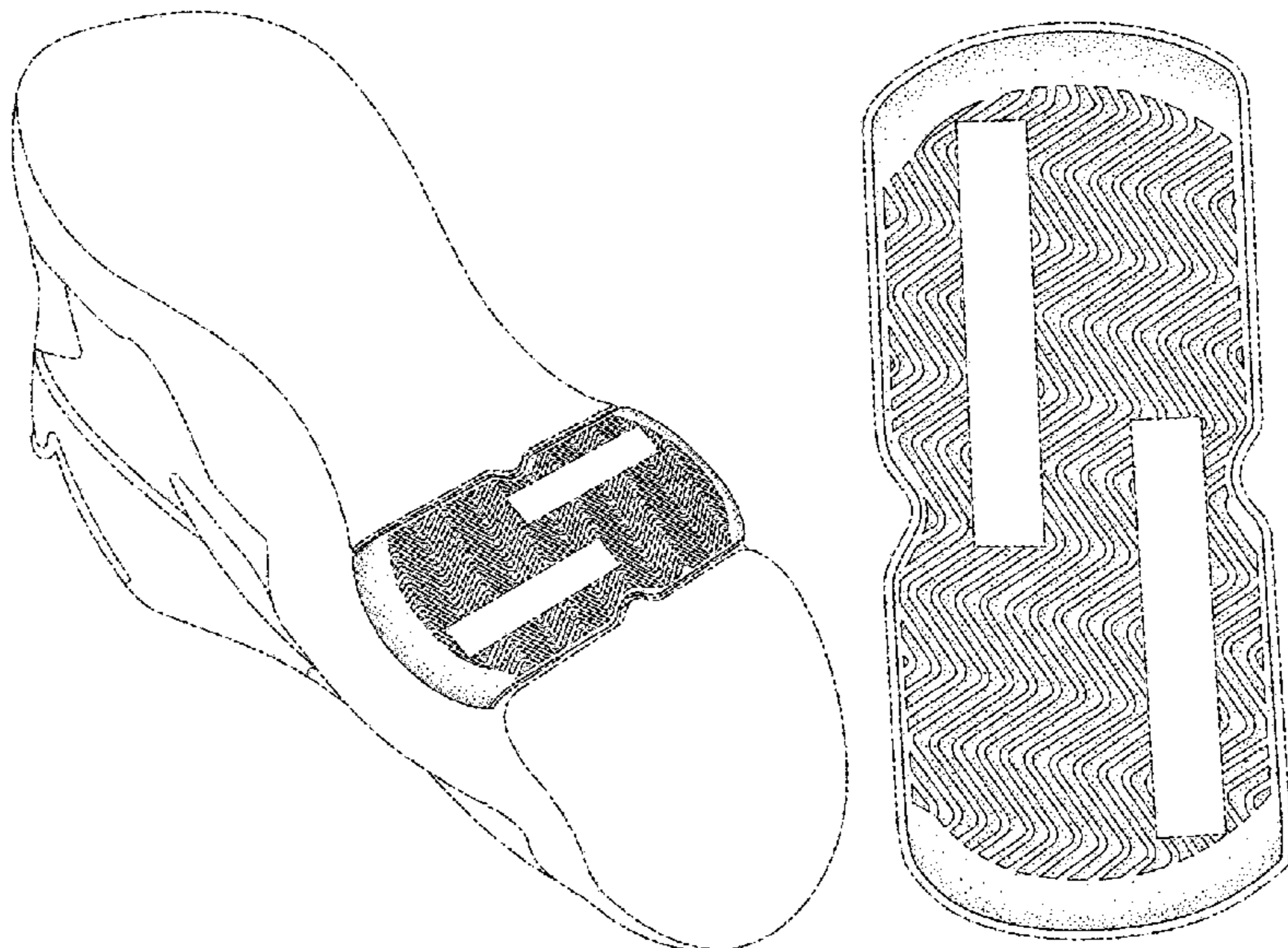
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a bottom rear perspective view thereof; and,
FIG. 4 is an enlarged view of the design as shown in FIG. 2 with environment removed for clarity purposes.
The broken line rectangles and the unshaded areas therein form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

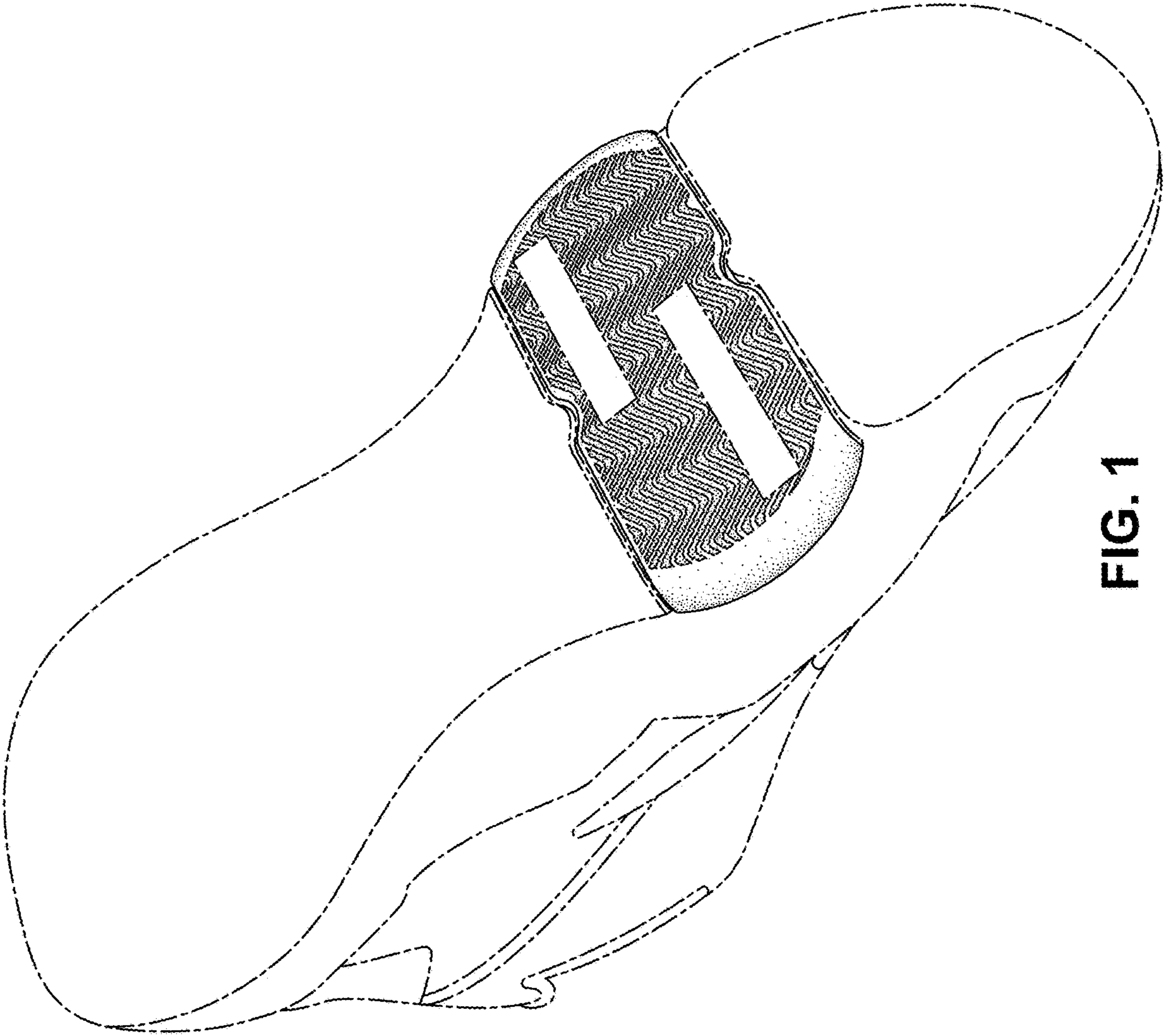

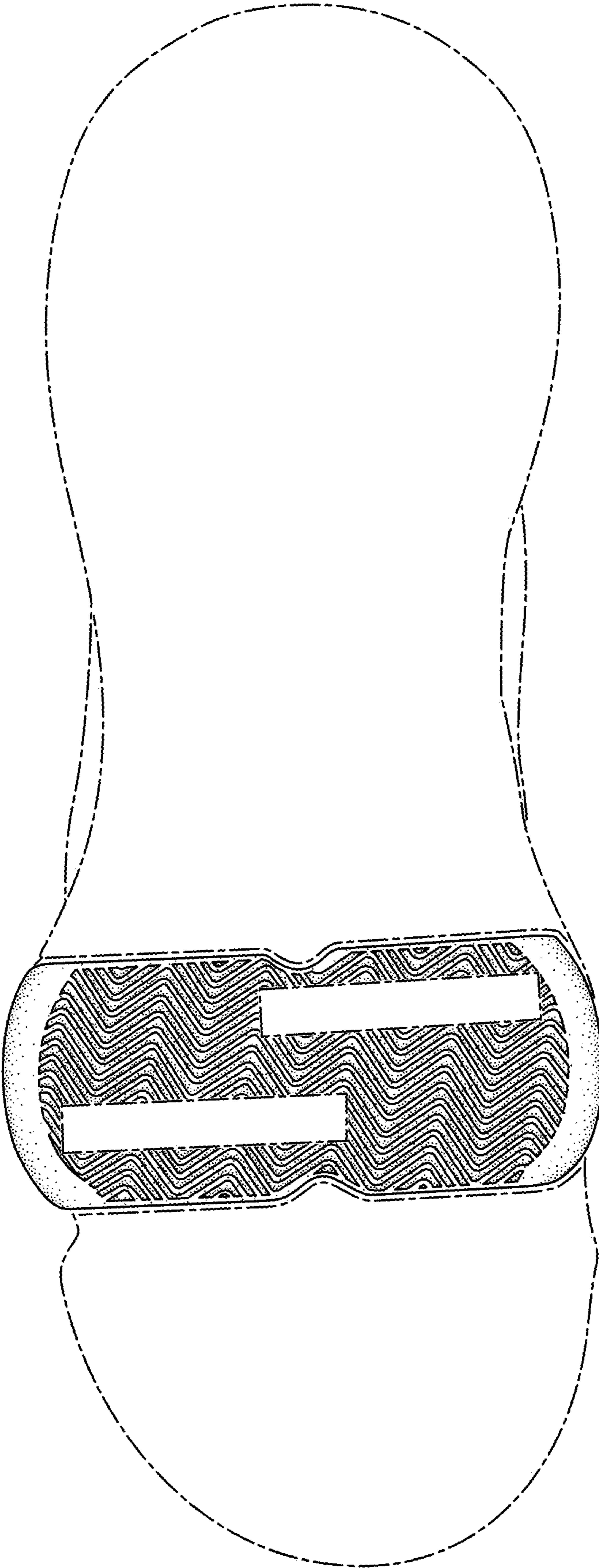

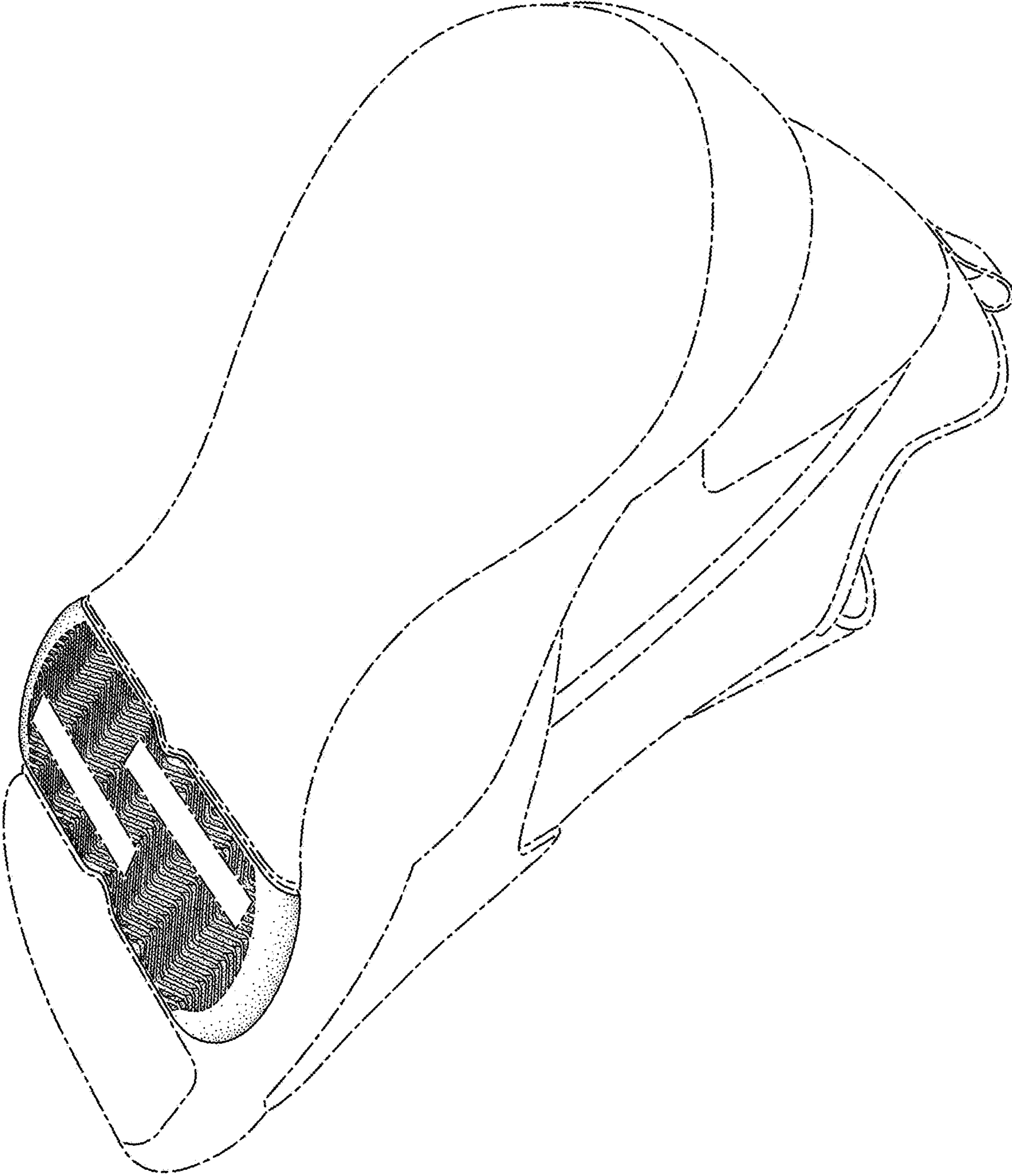
