FIG. 1 is a front view of a fabric with pattern according to a first embodiment of the claimed design;

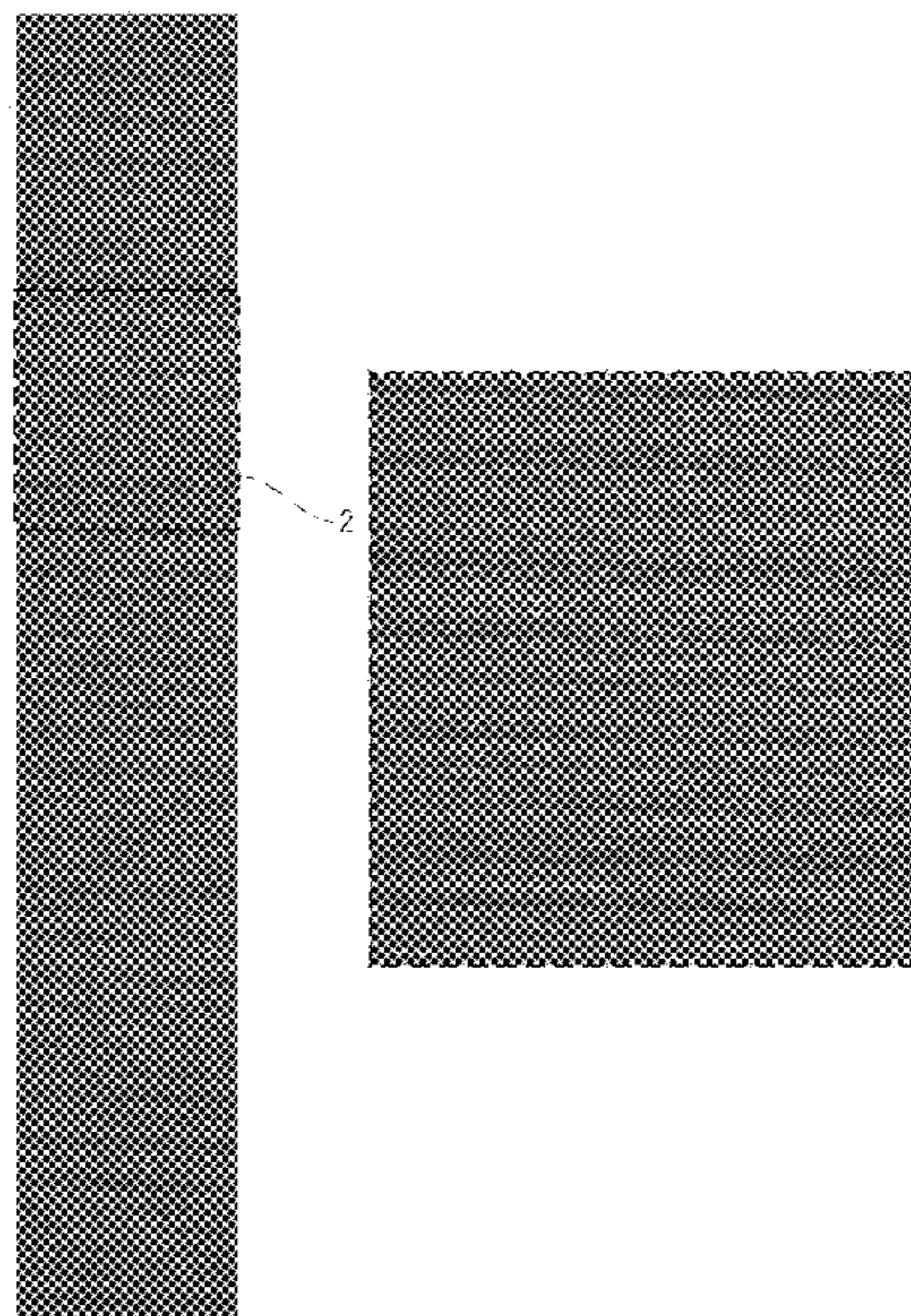
FIG. 2 is an enlarged detail view of area 2 circumscribed within FIG. 1;

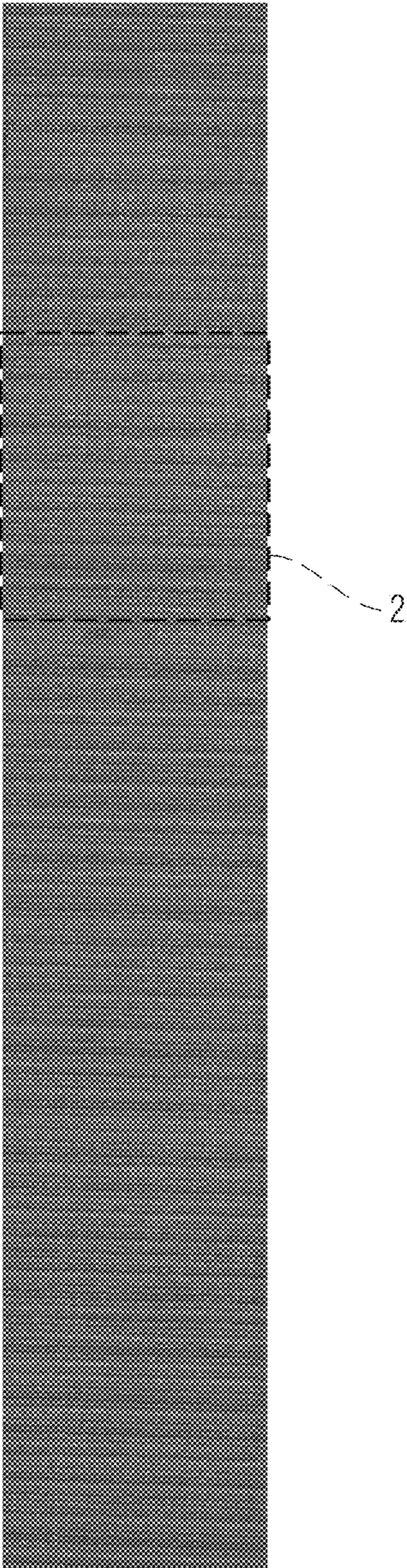

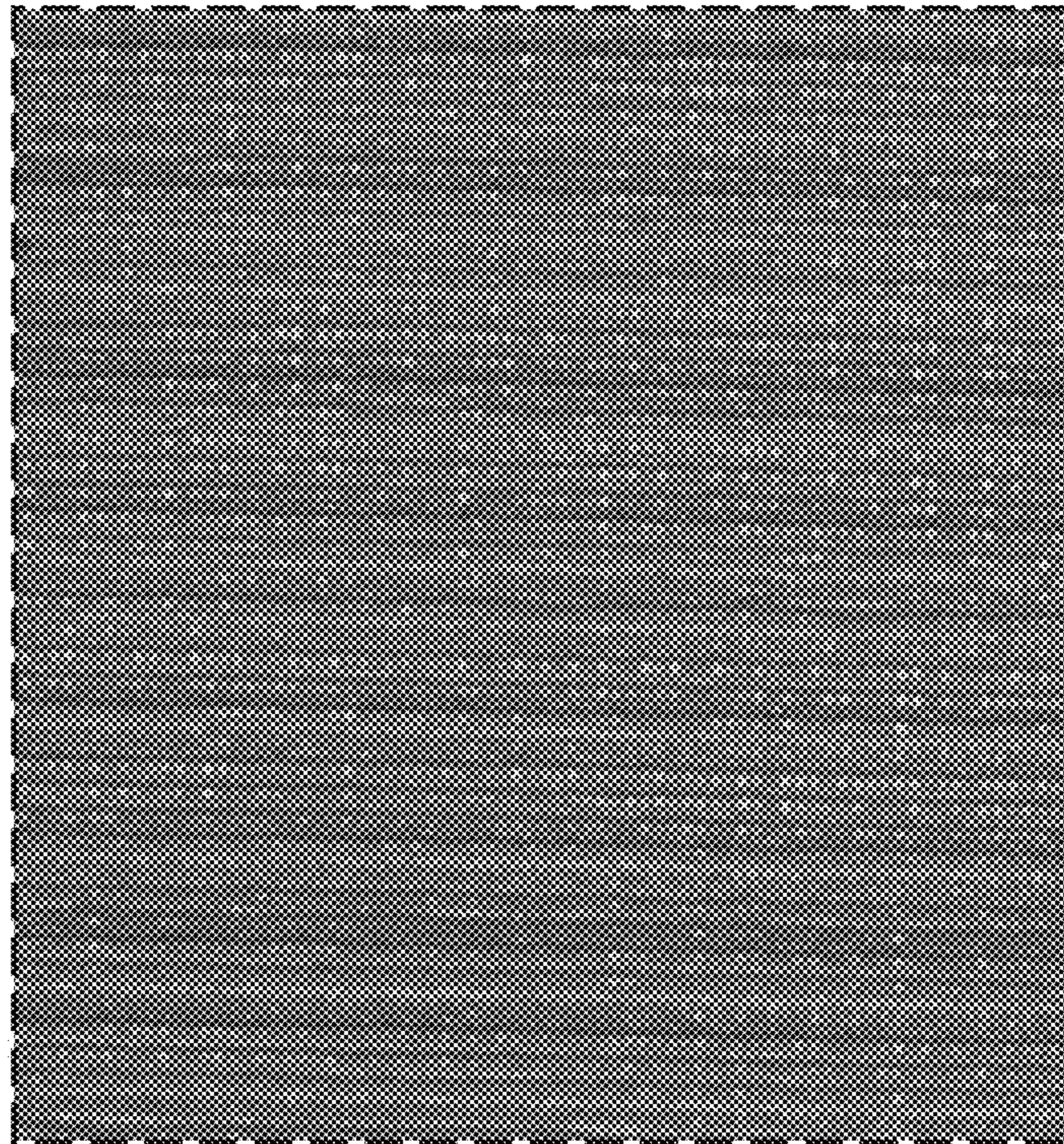

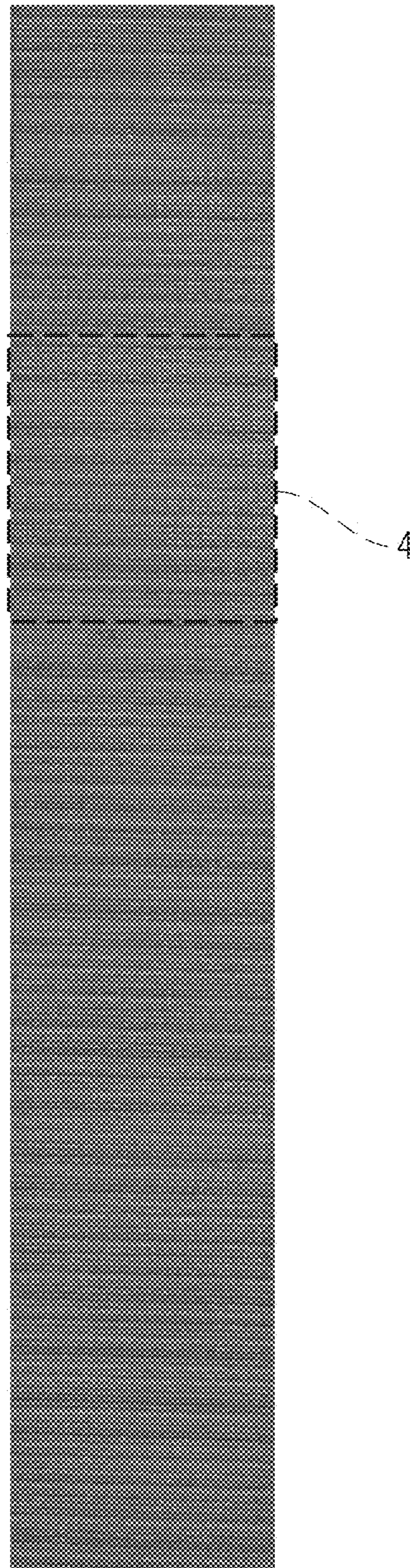

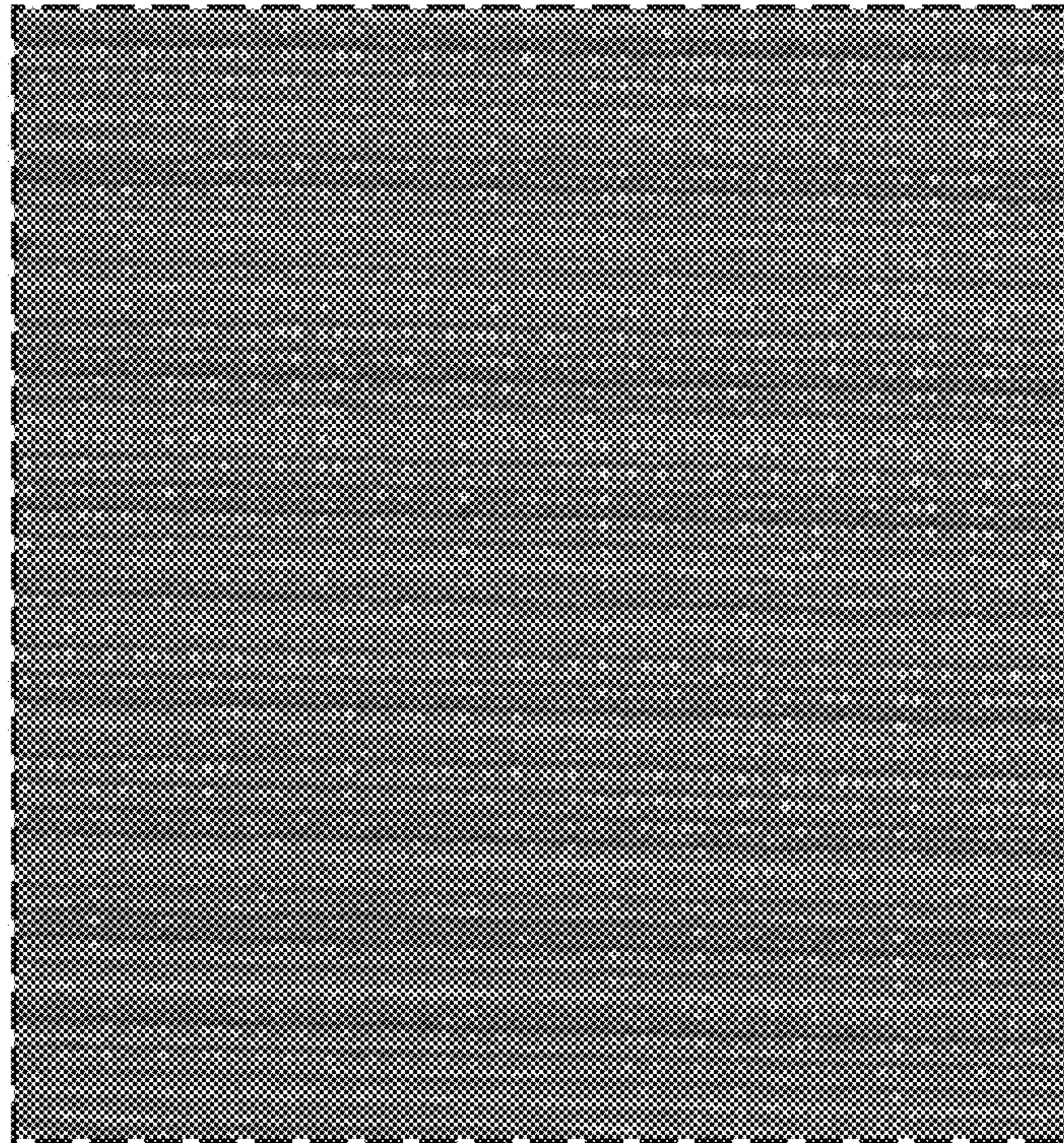
