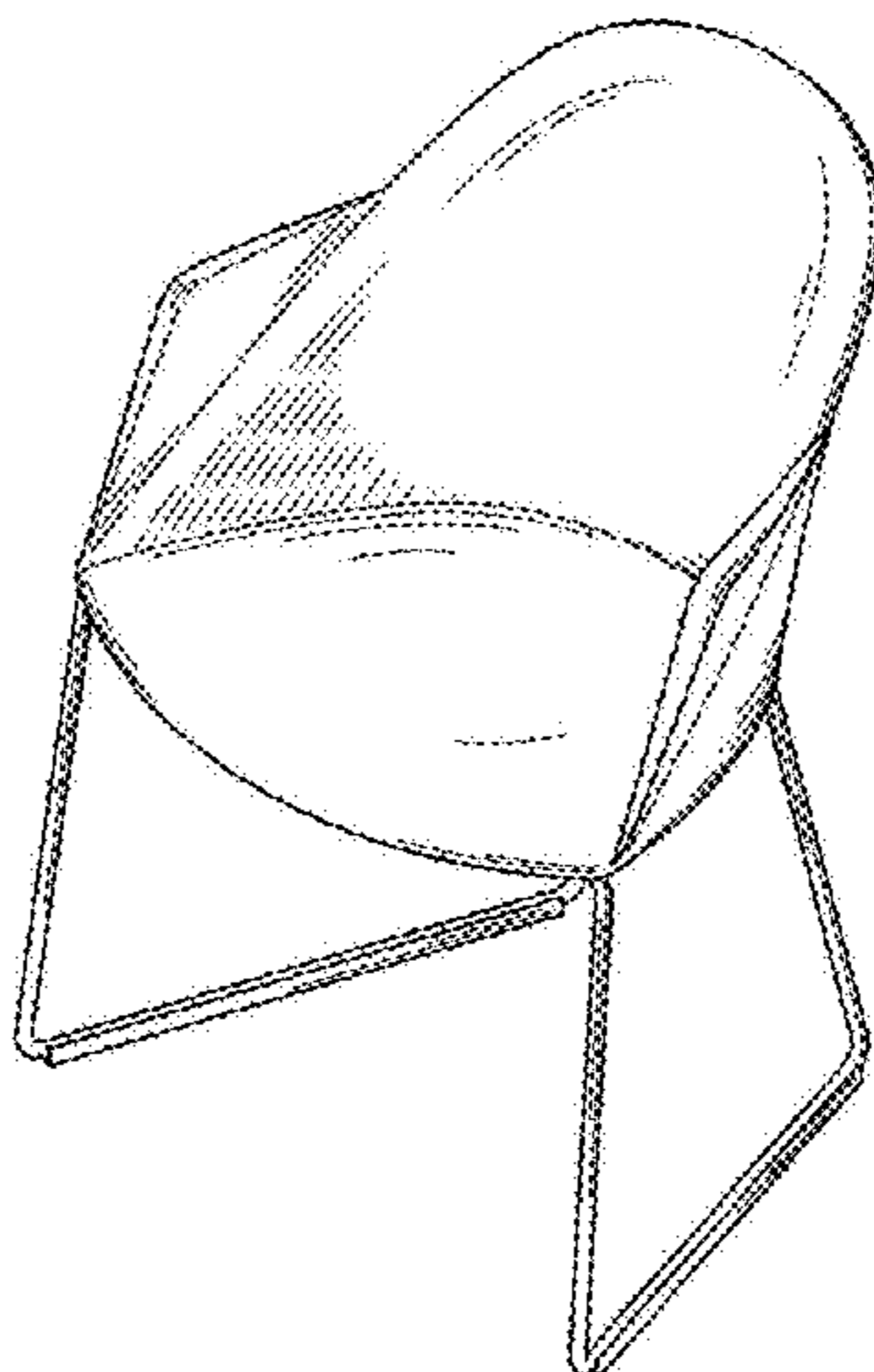
(57) **CLAIM**

The ornamental design for an armchair, as shown and described.

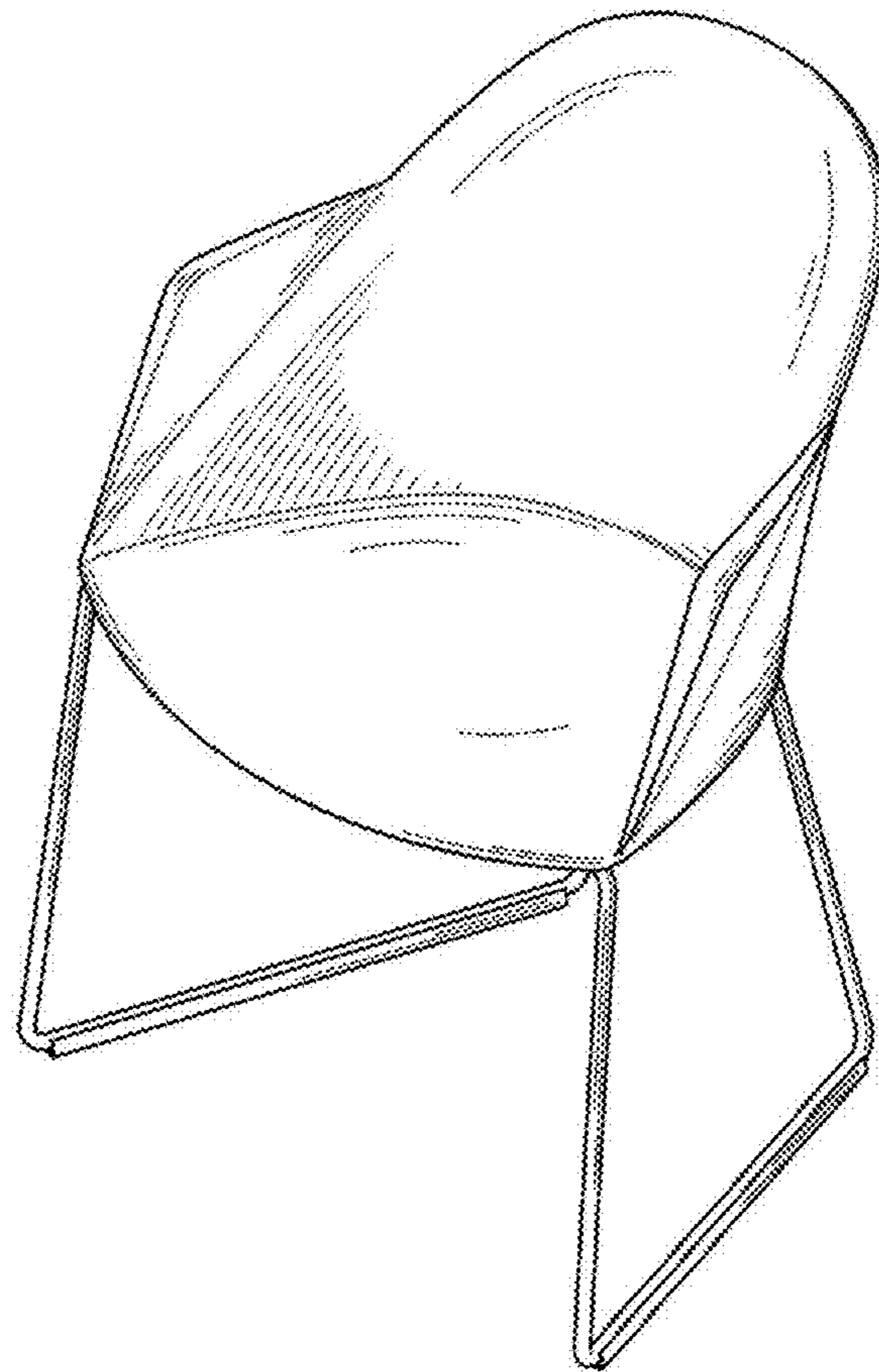
DESCRIPTION

The broken lines shown in the drawings of the armchair are for the purpose of illustrating environment and form no part of the claimed design.

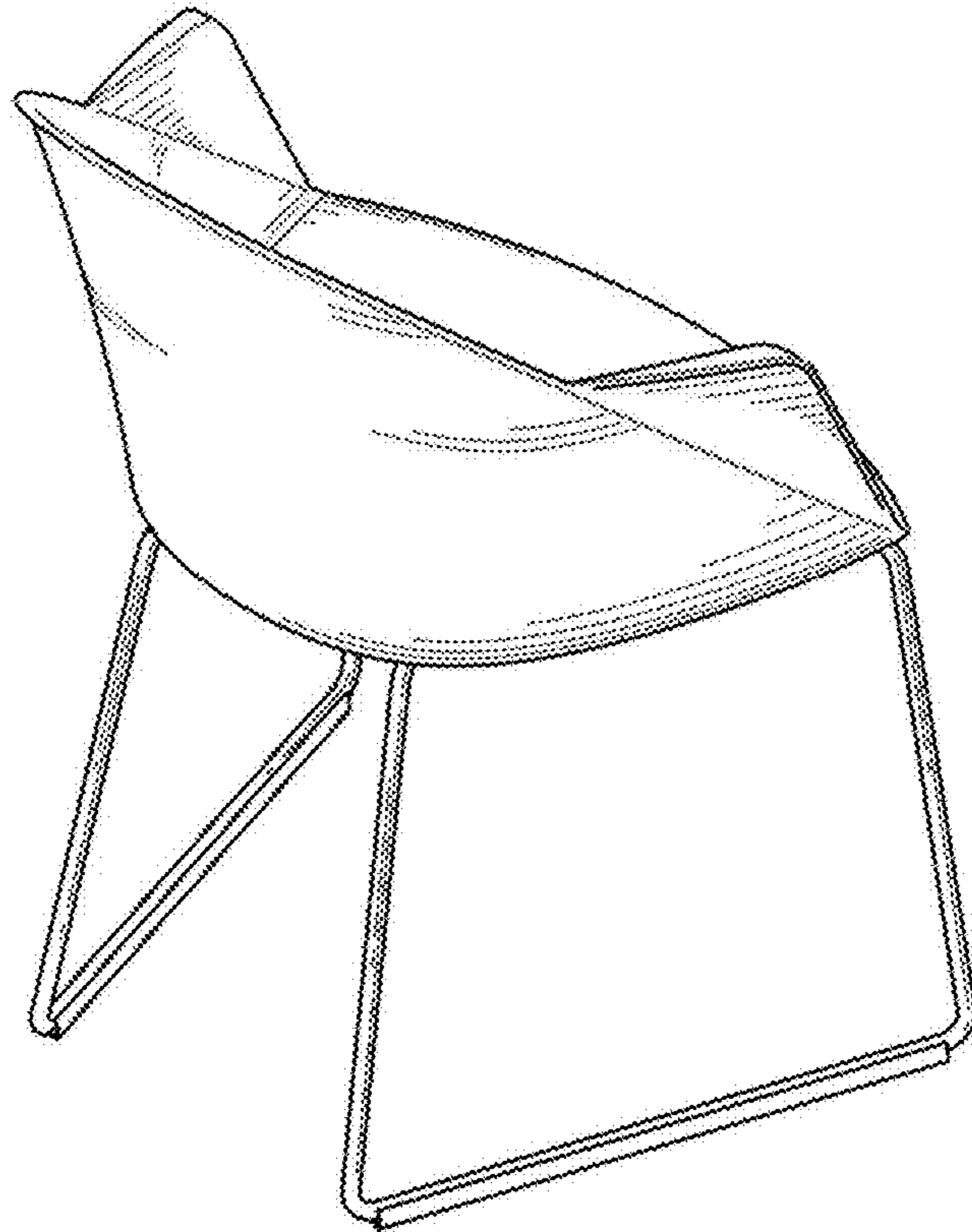

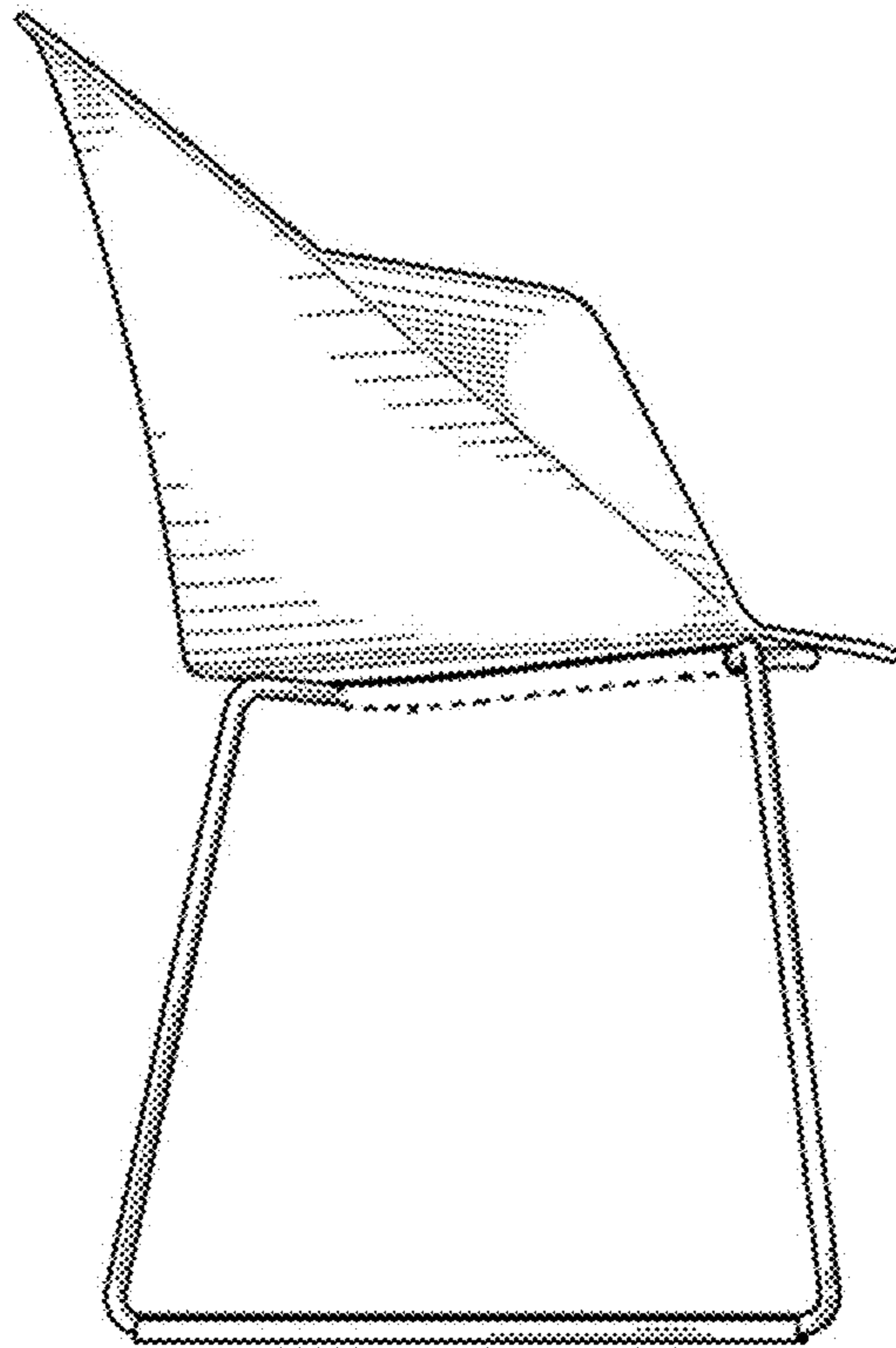

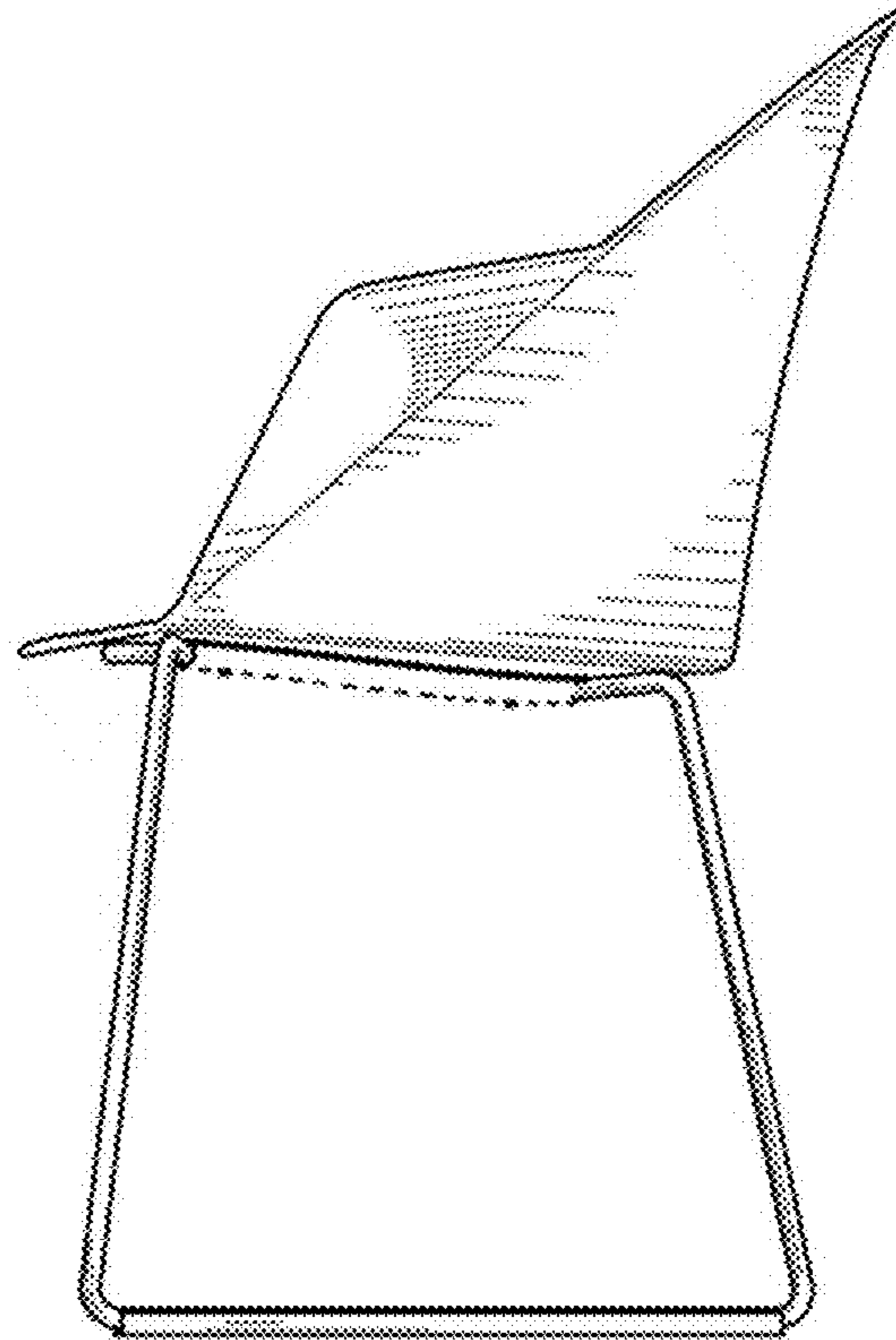

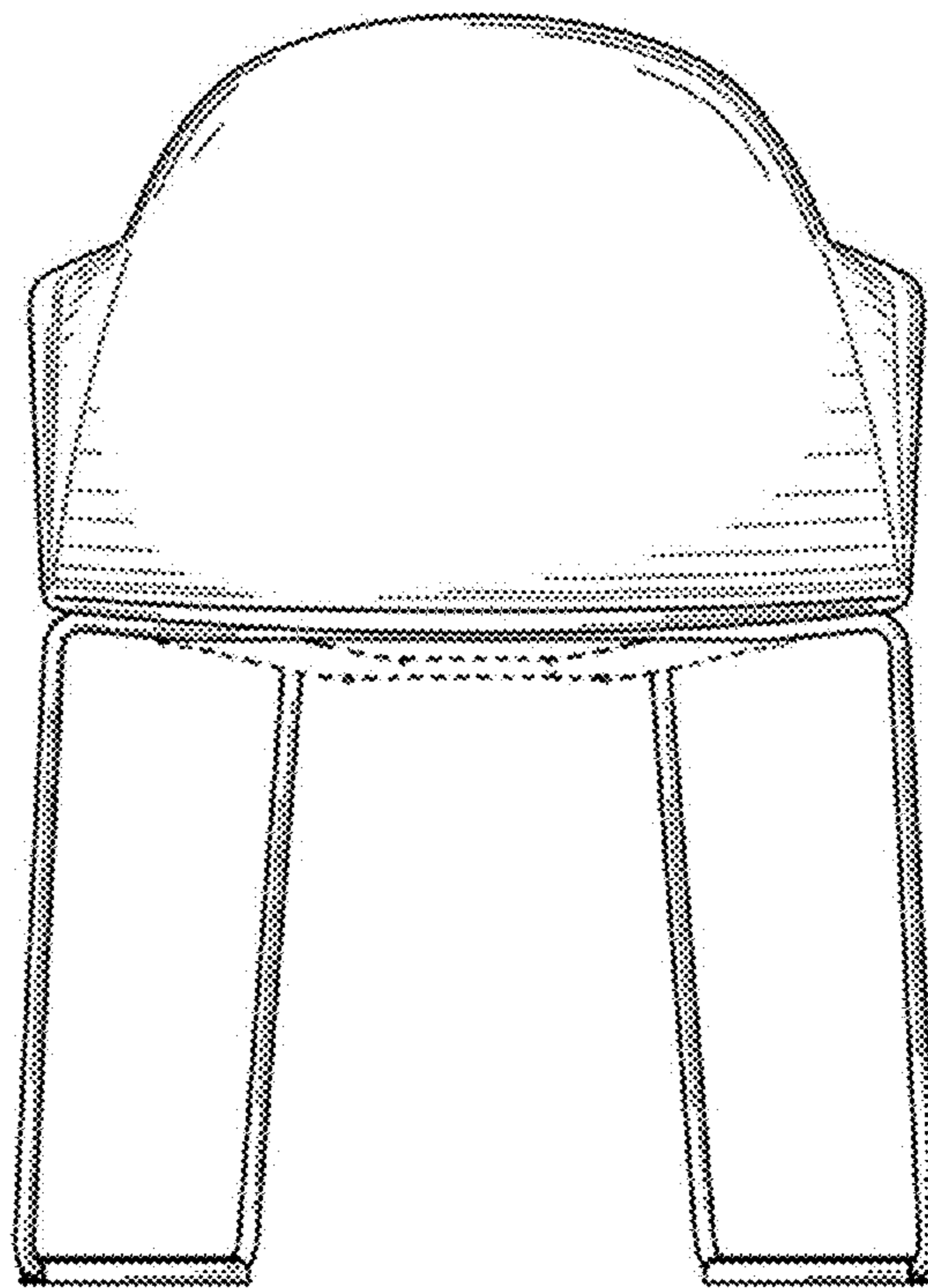

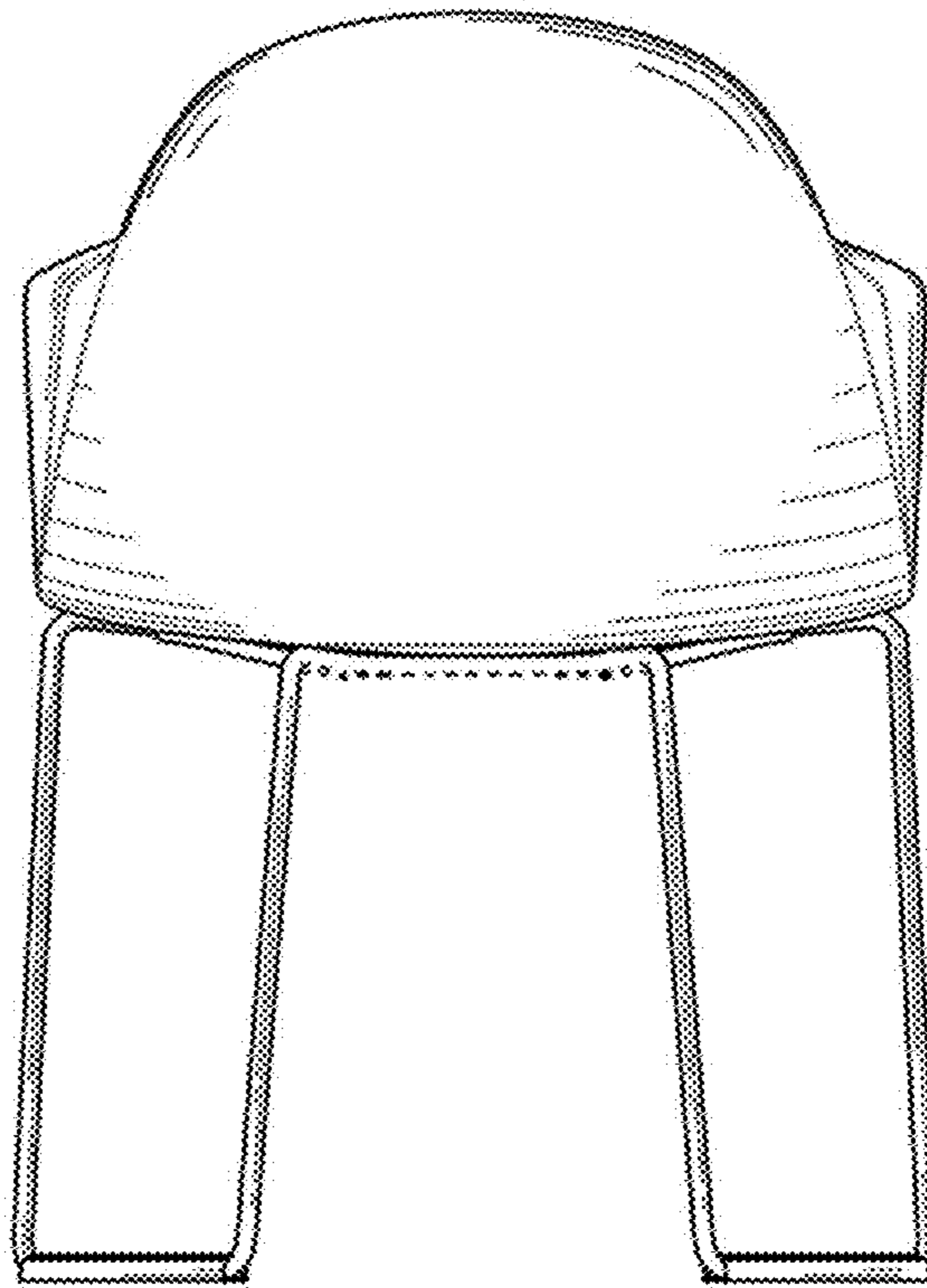
