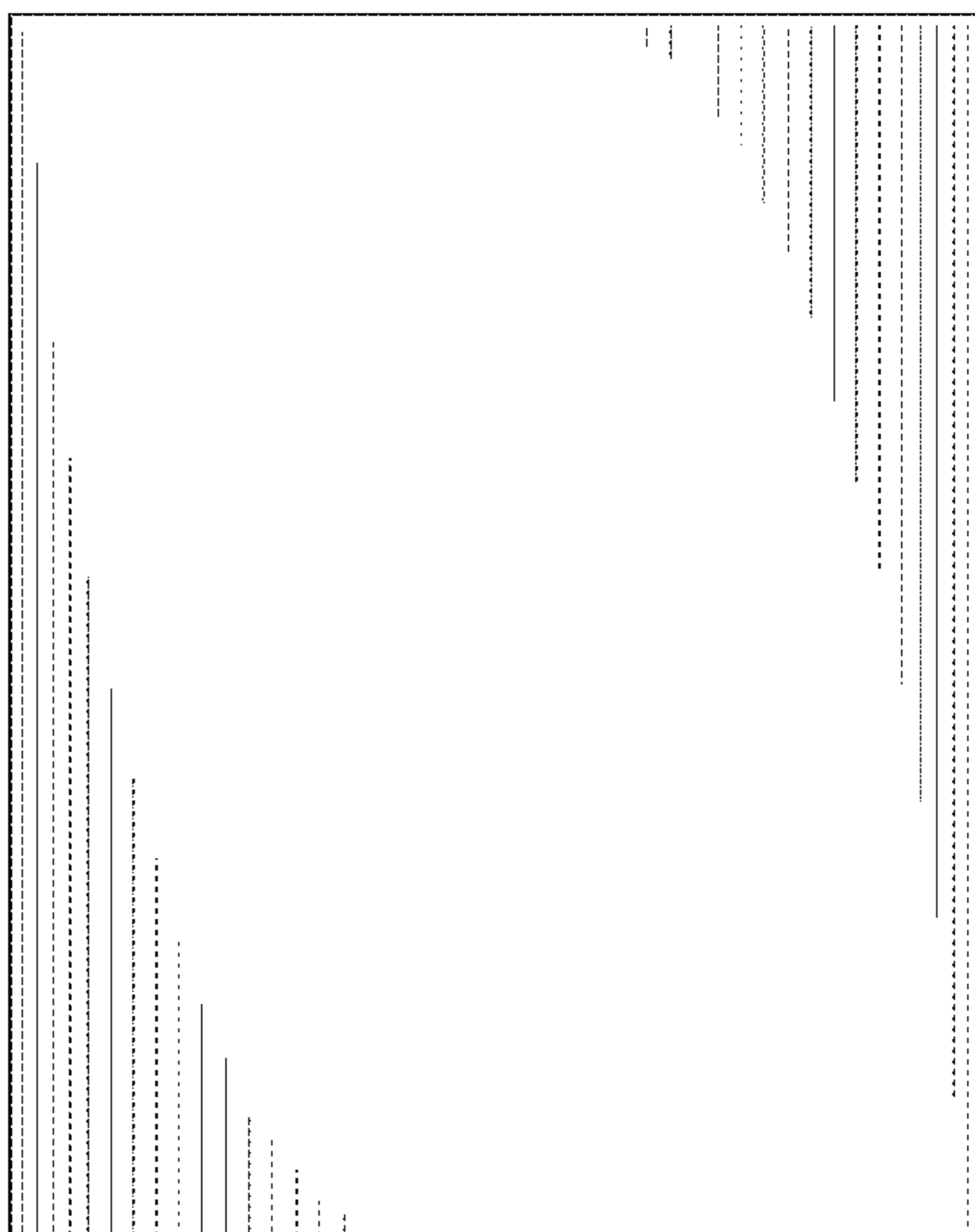
(57) **CLAIM**

FIG. 1 is a top view of a shelving unit showing our new design;

 FIG. 5 is a rear side view thereof;
 FIG. 6 is a front view thereof; and,

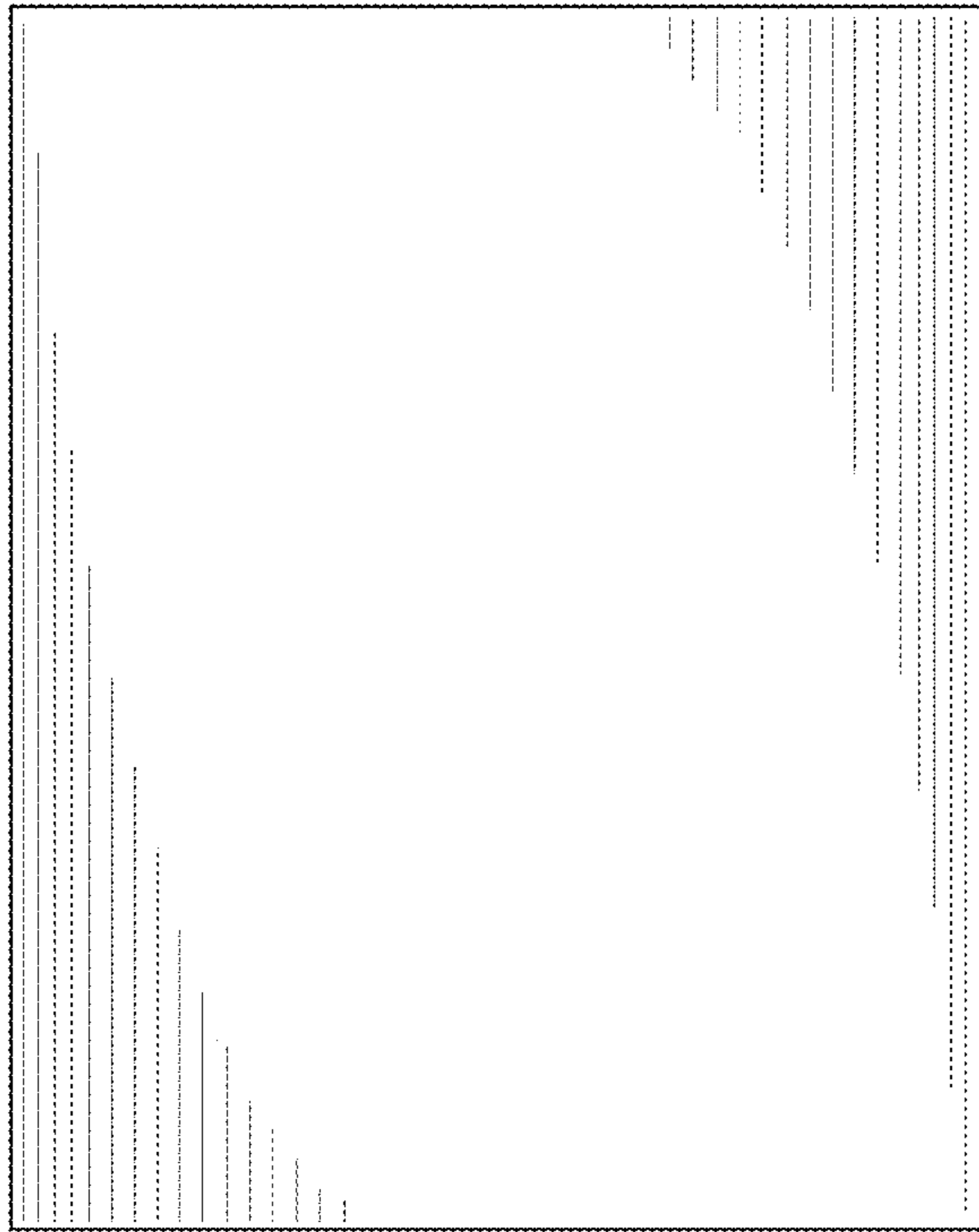

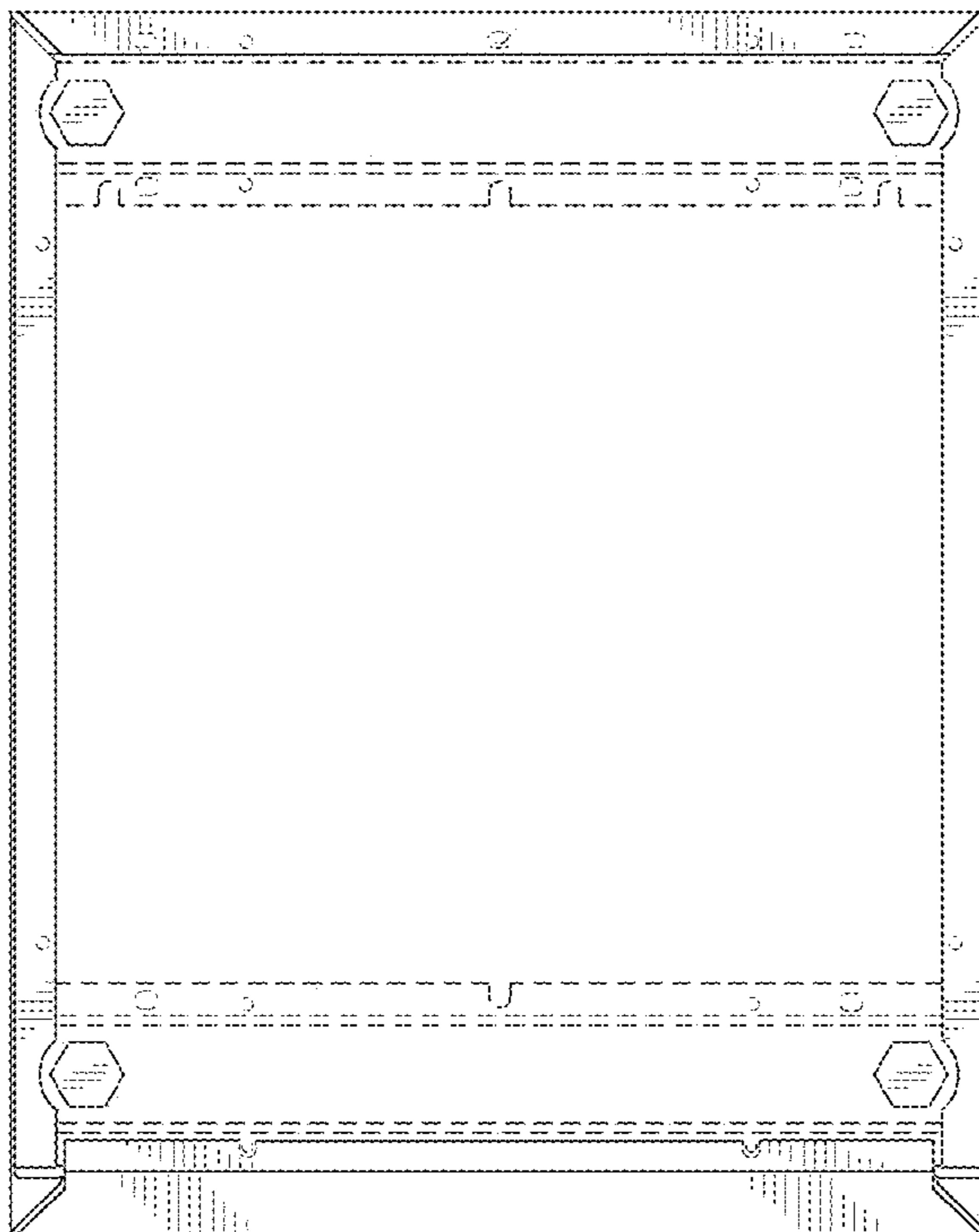

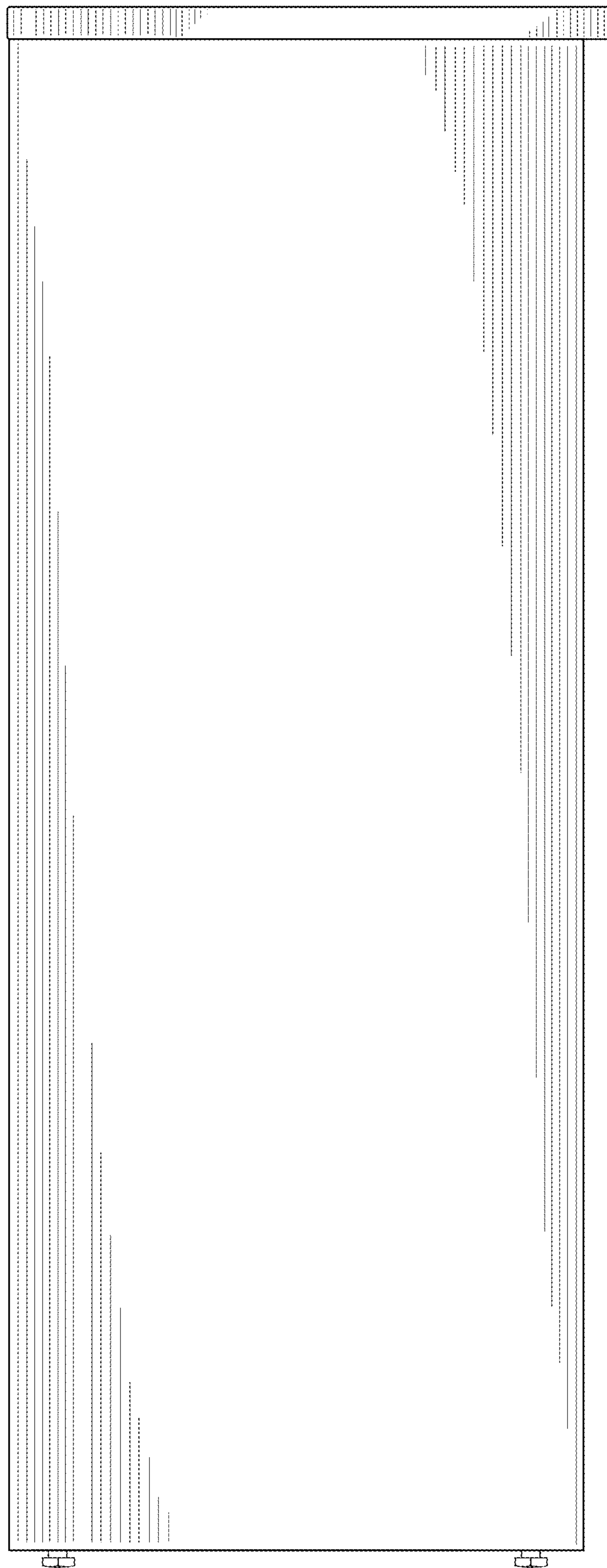

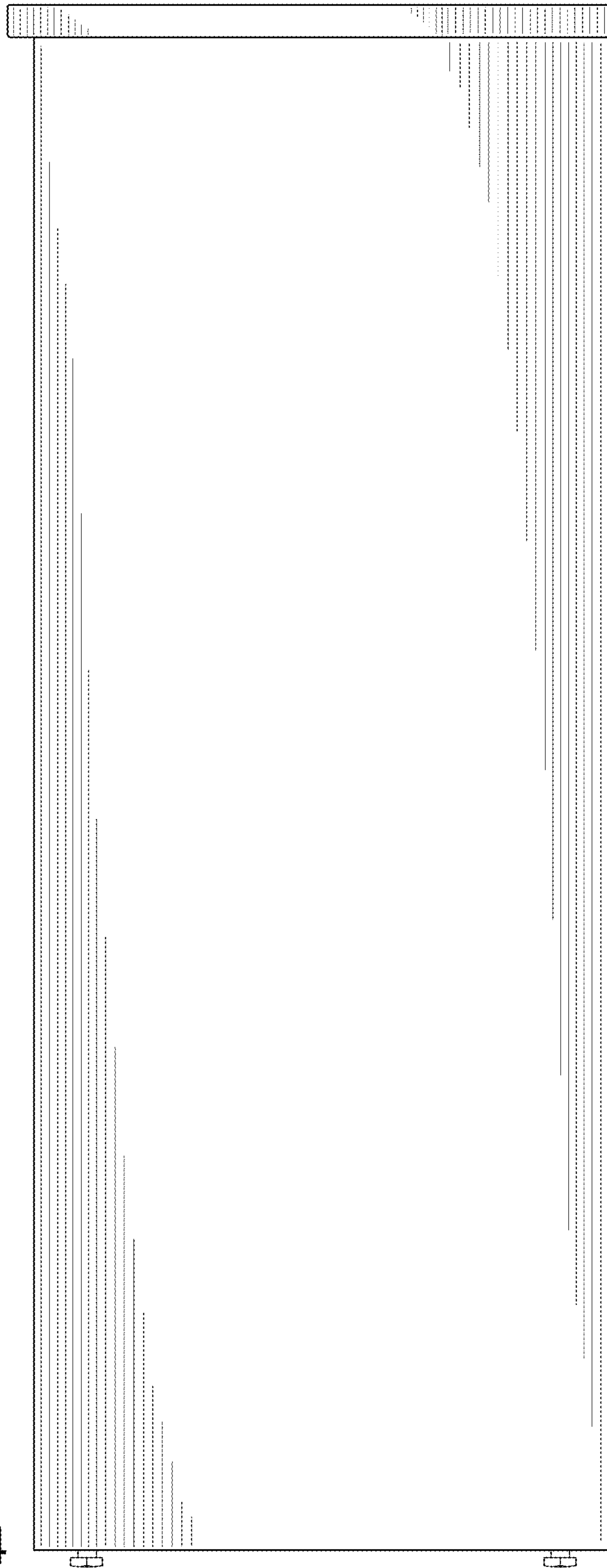

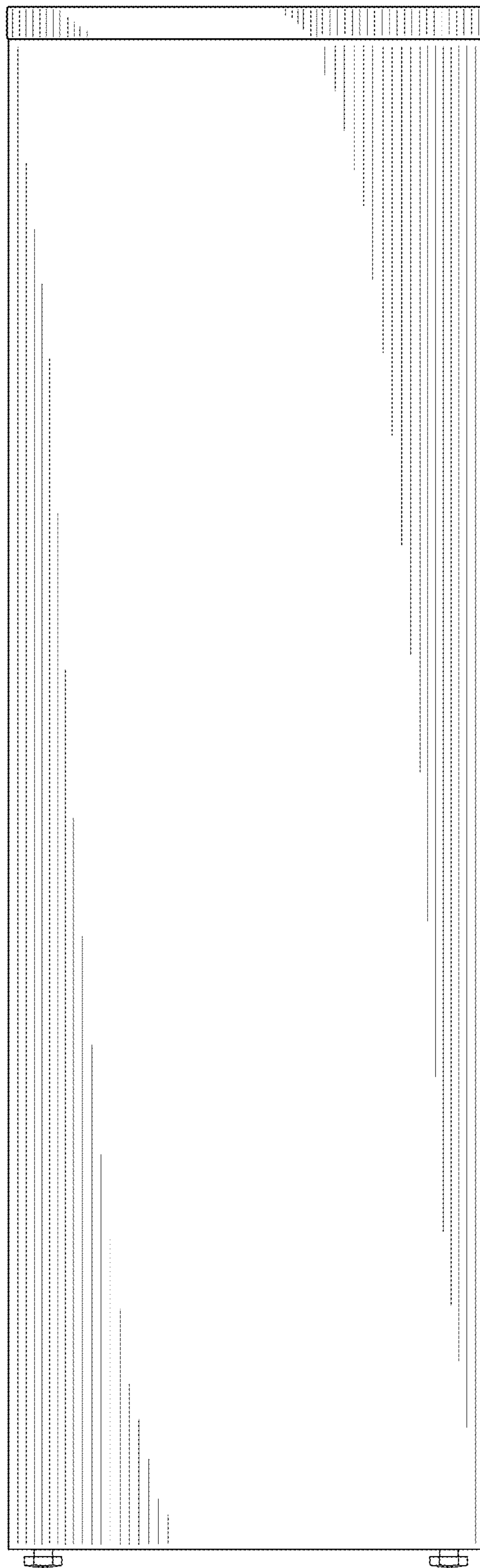

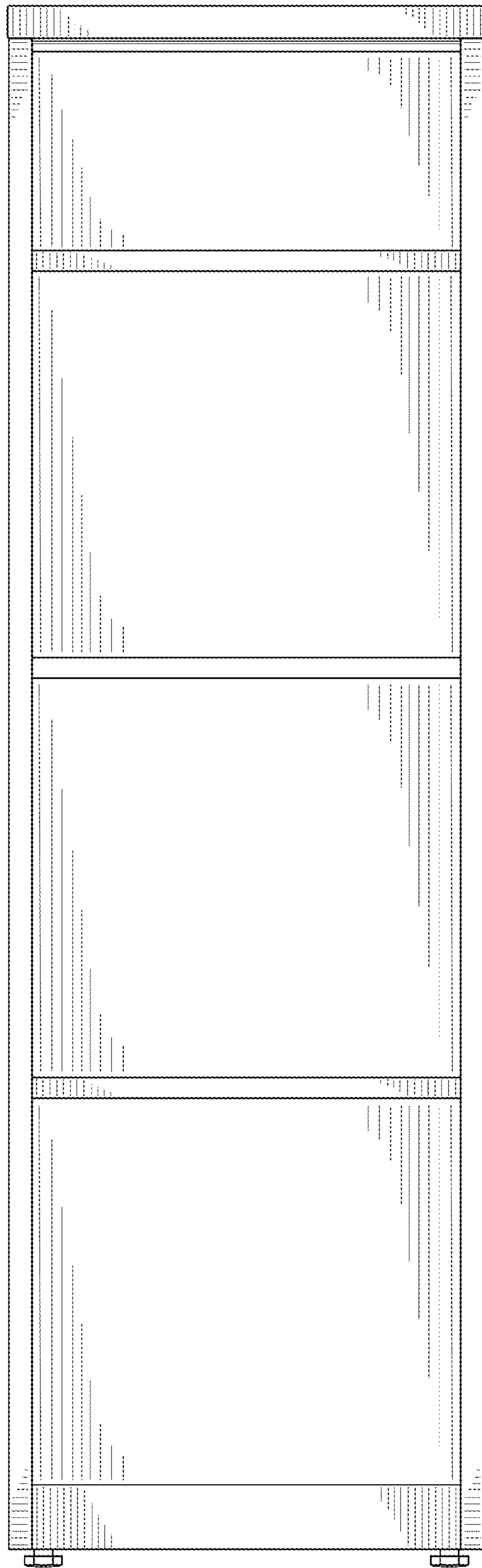

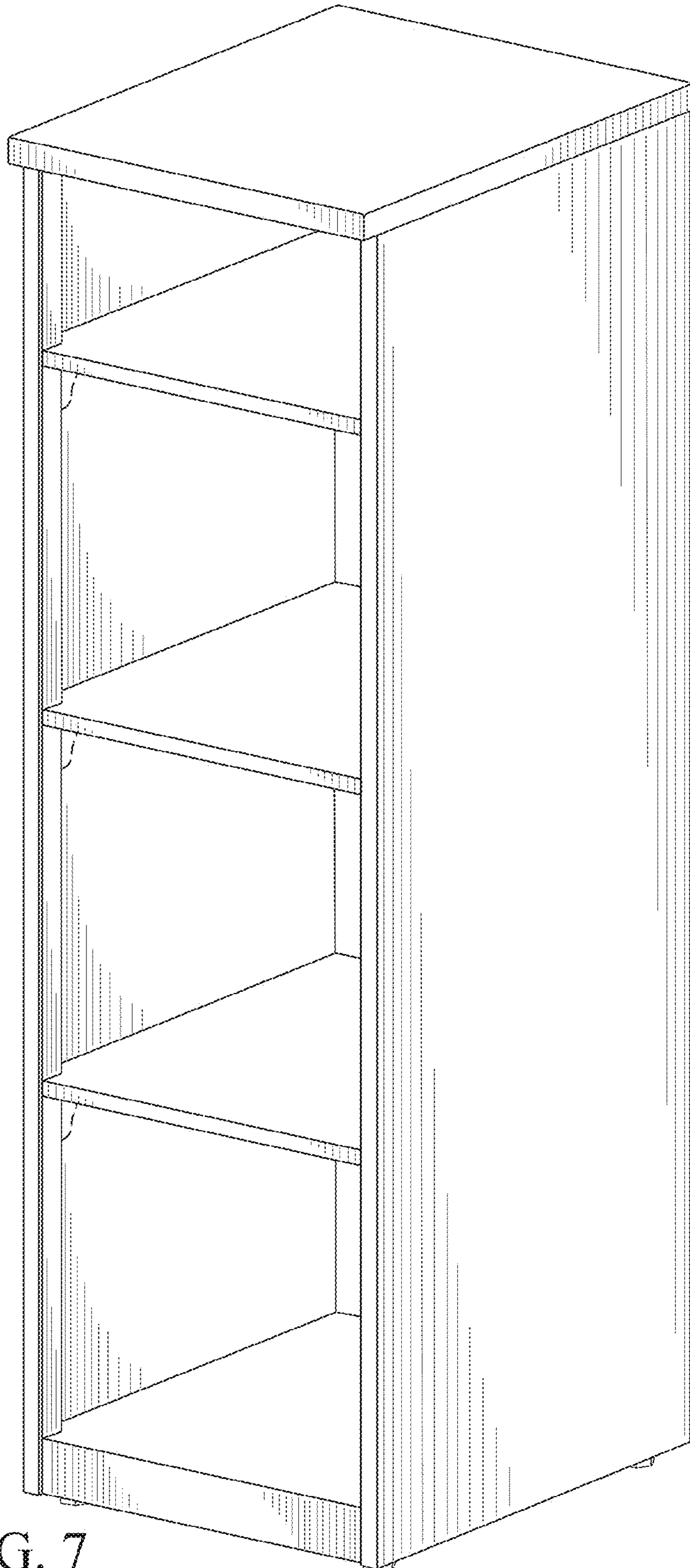
