DESCRIPTION

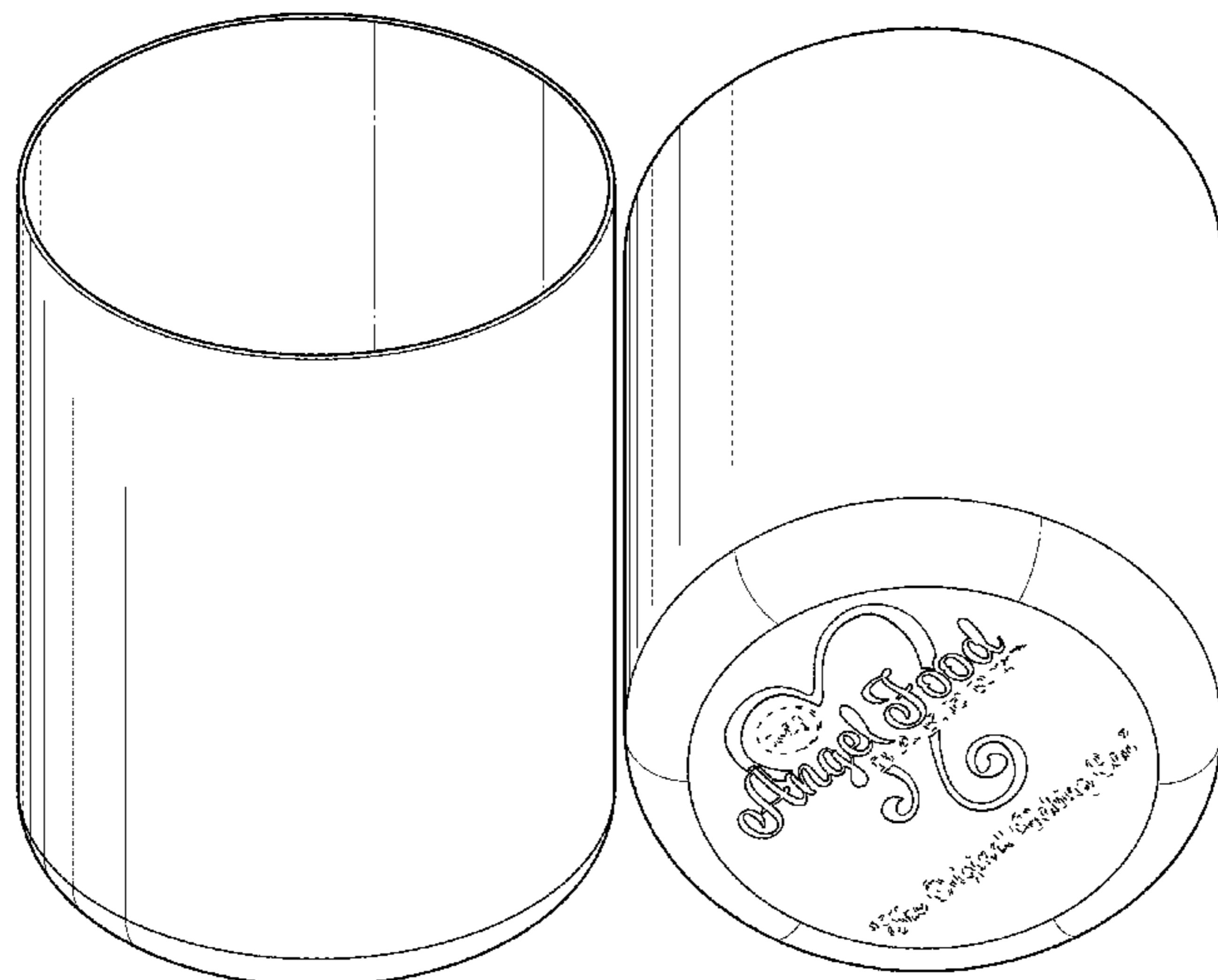
FIG. 1 is a top perspective view of a baking pan, according to my new design;

FIG. 3 is a first side elevational view of the baking pan of FIG. 1;
FIG. 4 is a second side elevational view of the baking pan of FIG. 1
FIG. 5 is a top view of the baking pan of FIG. 1;
FIG. 6 is a bottom view of the baking pan of FIG. 1; and,
FIG. 7 is a side cross-sectional view of the baking pan of FIG. 1 taken in the direction of line 7-7 in FIG. 3.

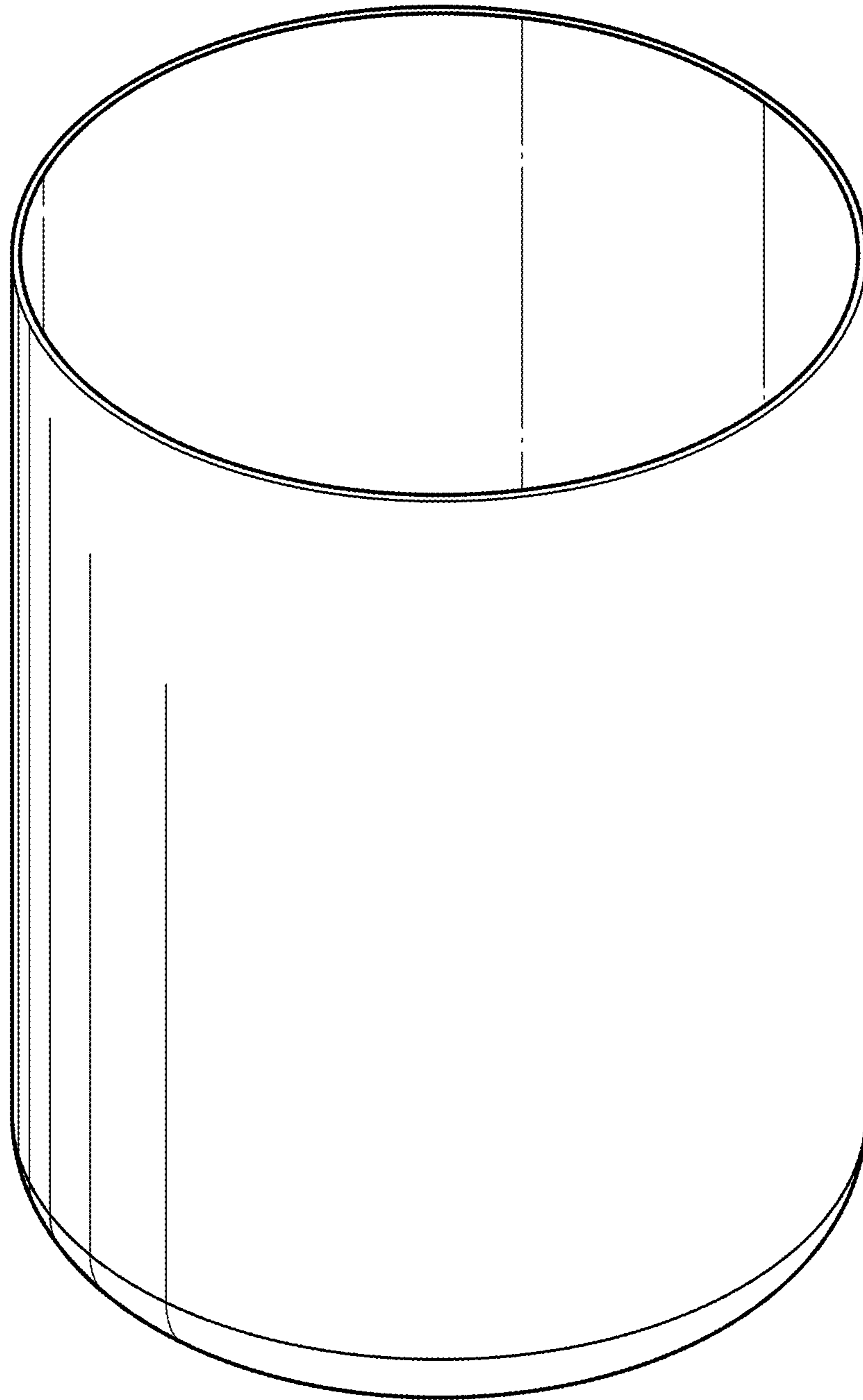

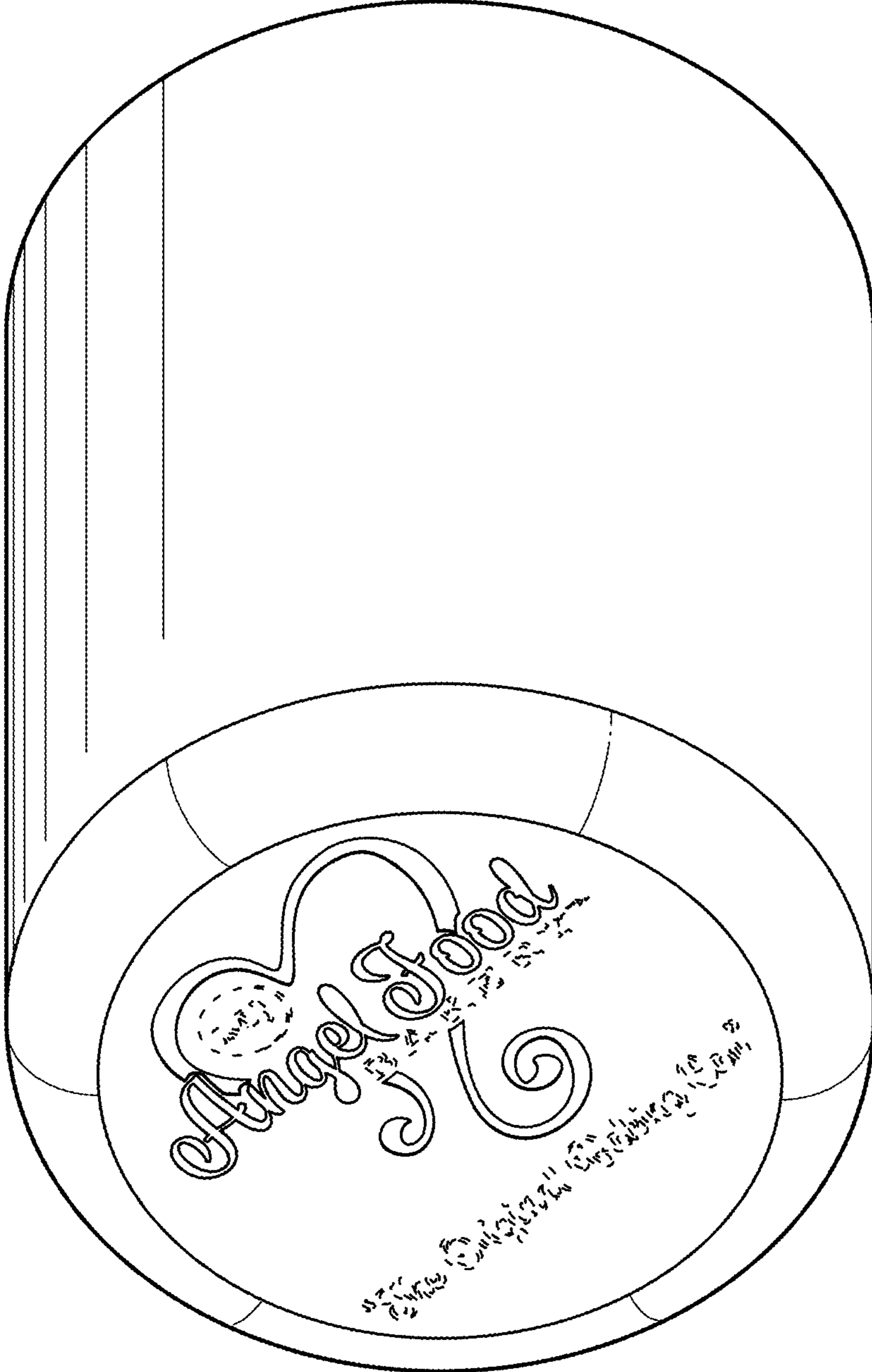

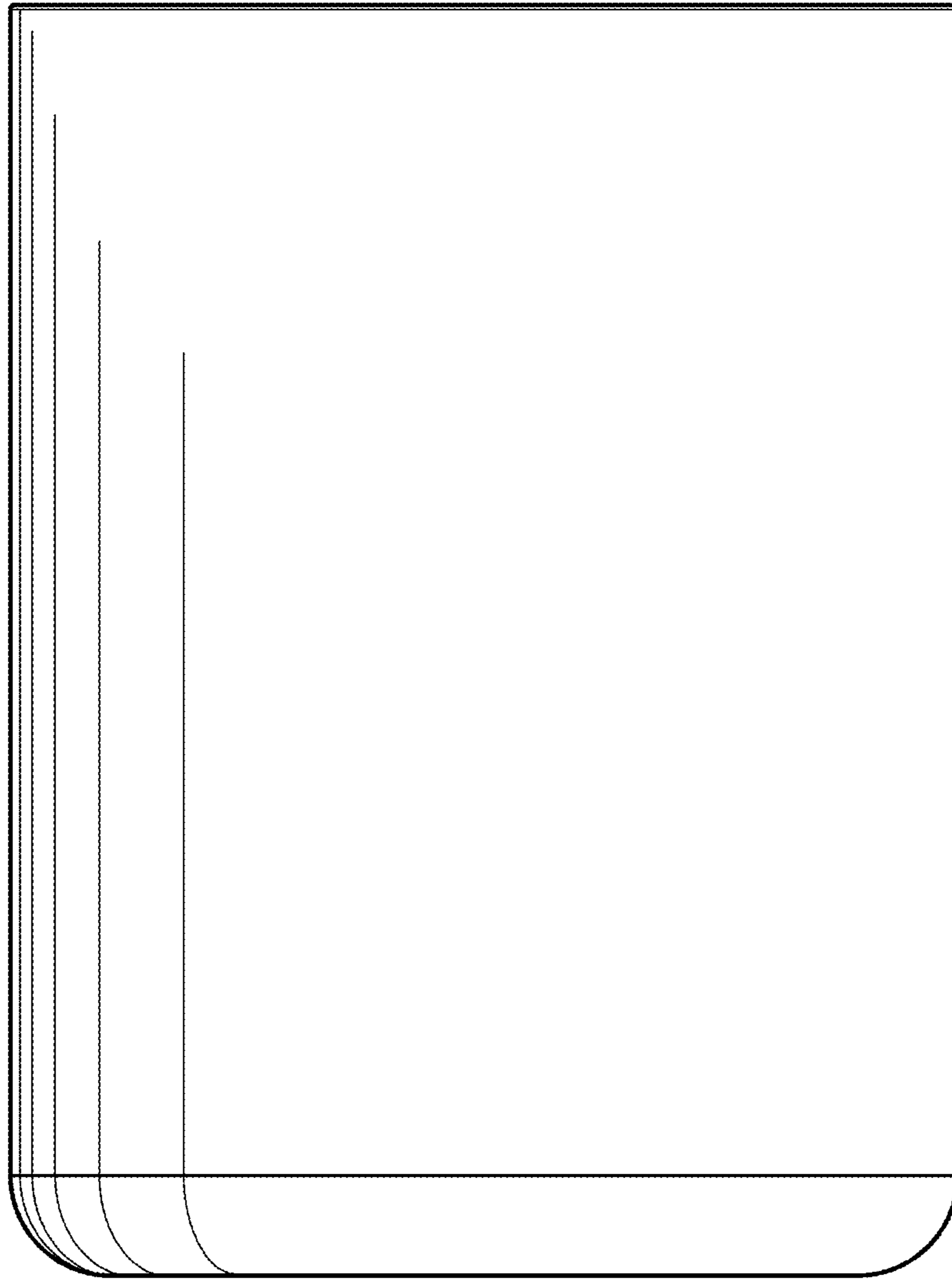

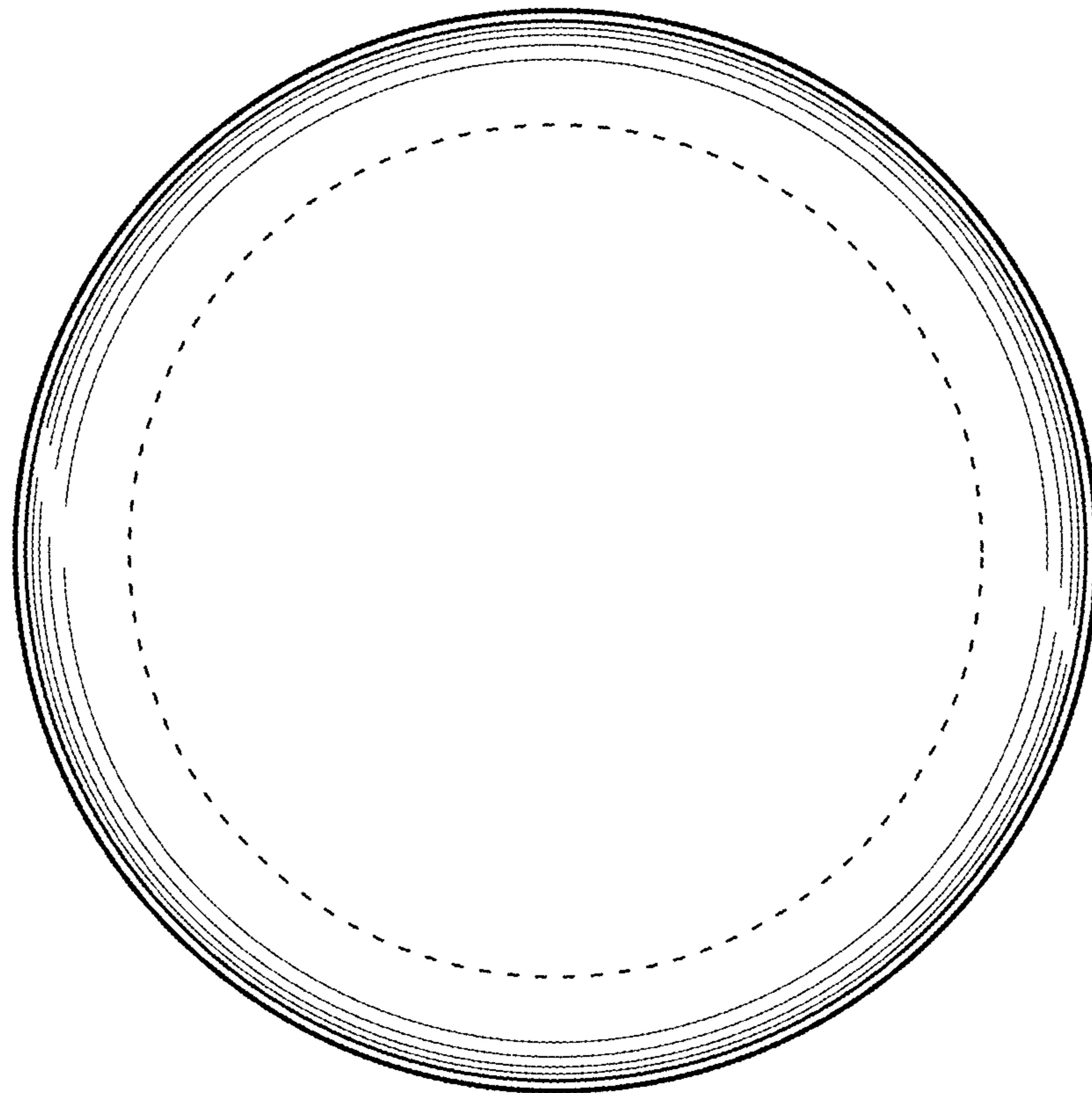

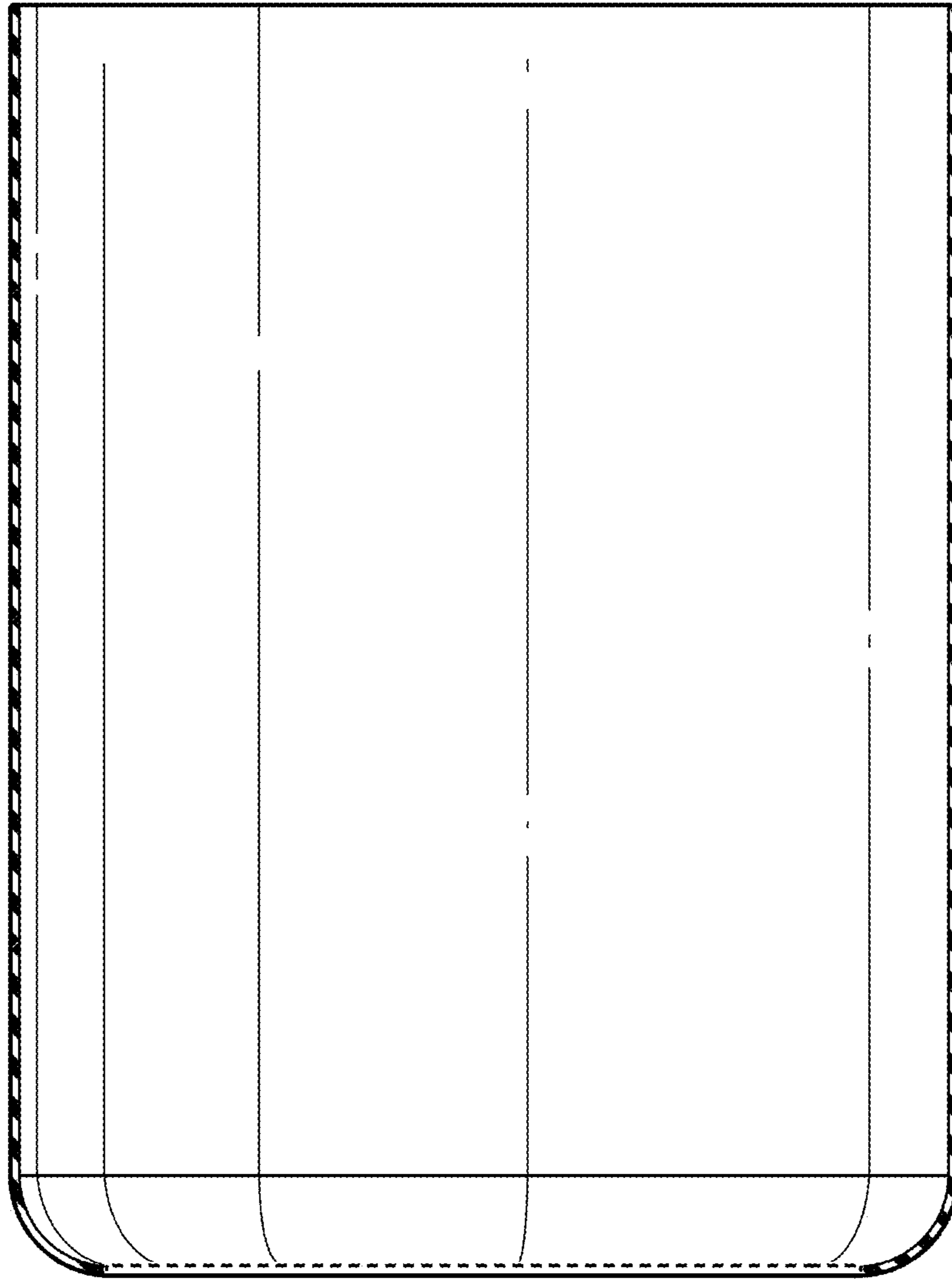
