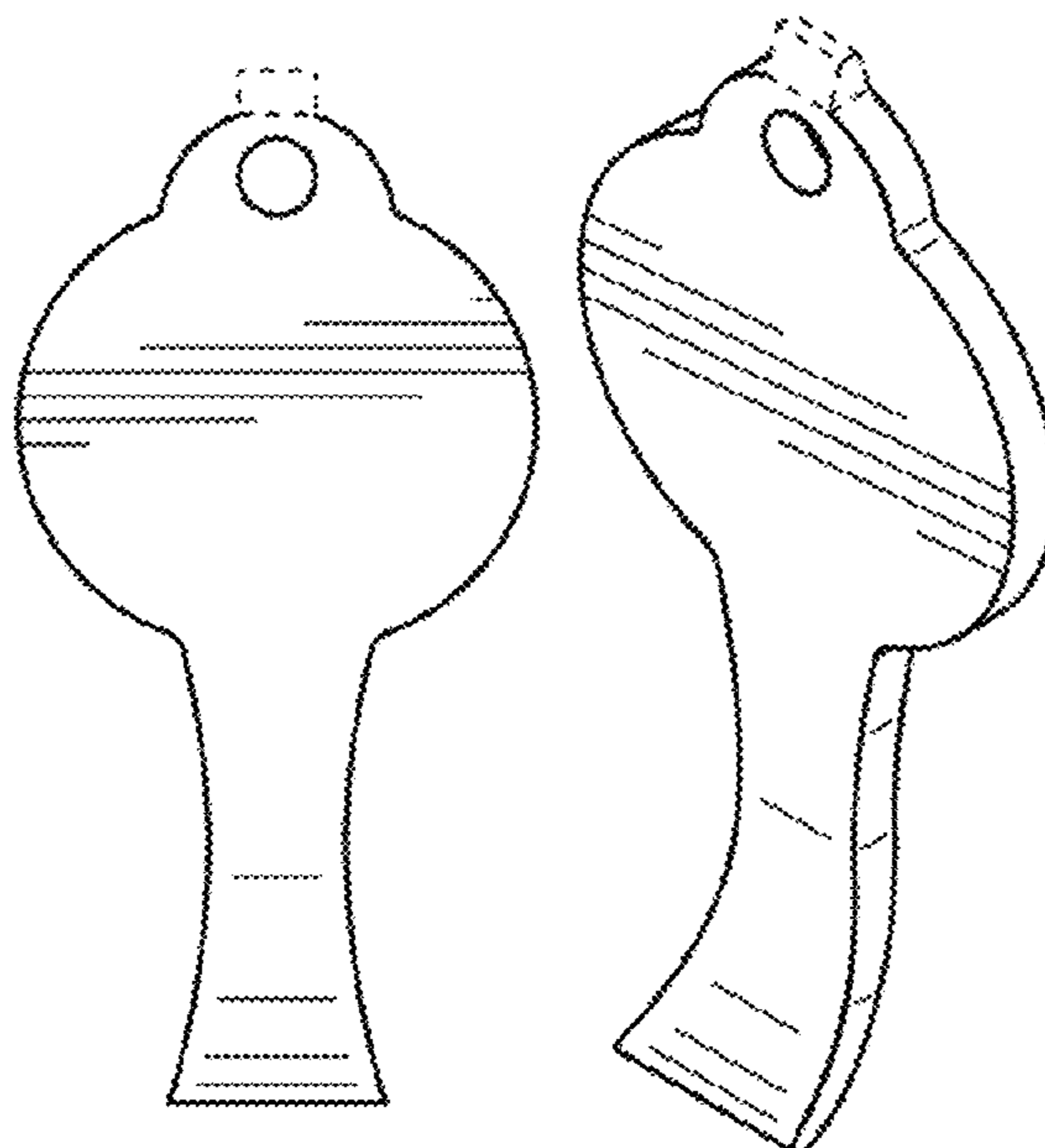
(57) **CLAIM**

The ornamental design for an opener, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an opener;
FIG. 2 is a right side view thereof, the left side view being a mirror image;
FIG. 3 is a top edge view thereof;
FIG. 4 is a lower edge view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is an isometric view thereof;
FIG. 7 showing the opener in a condition of use; and,
FIG. 8 is showing the opener in a condition of use.

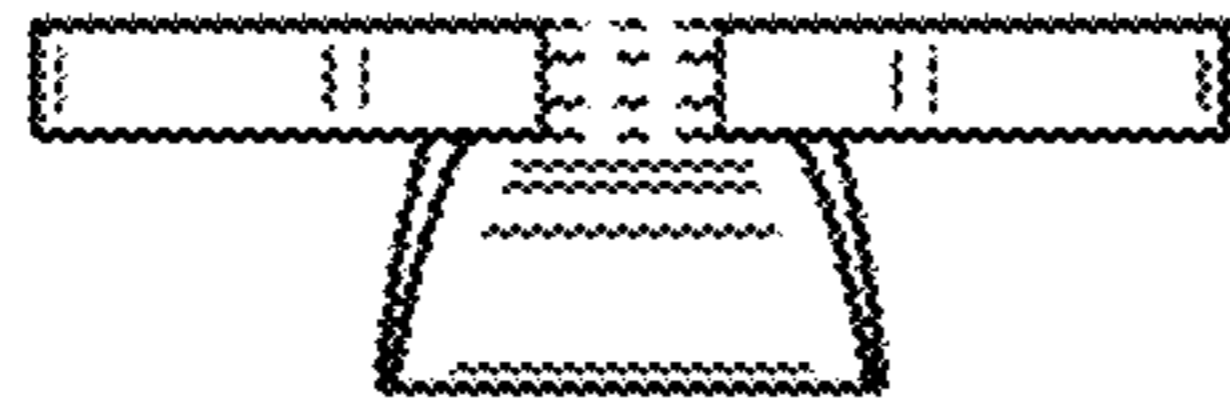

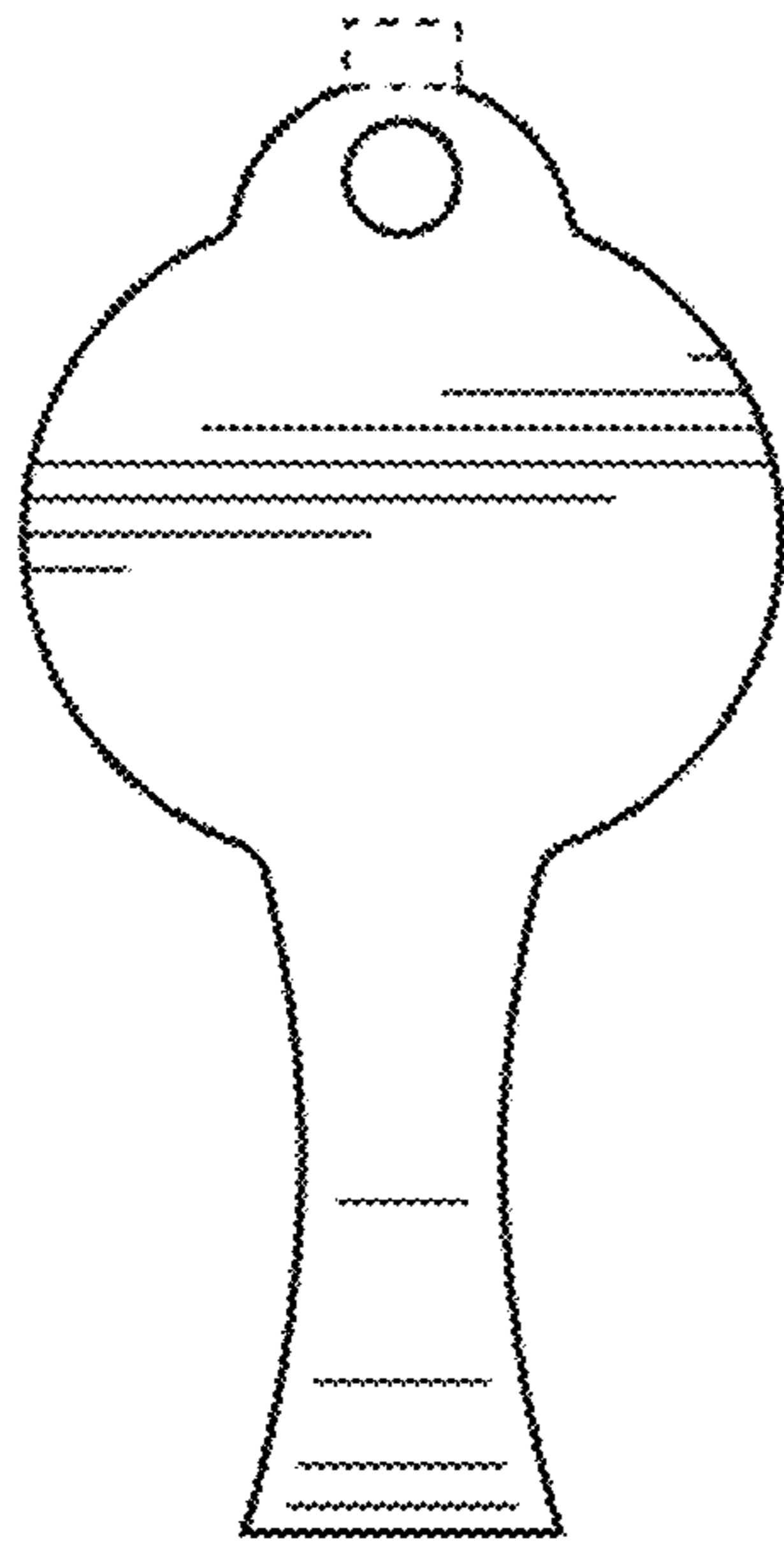

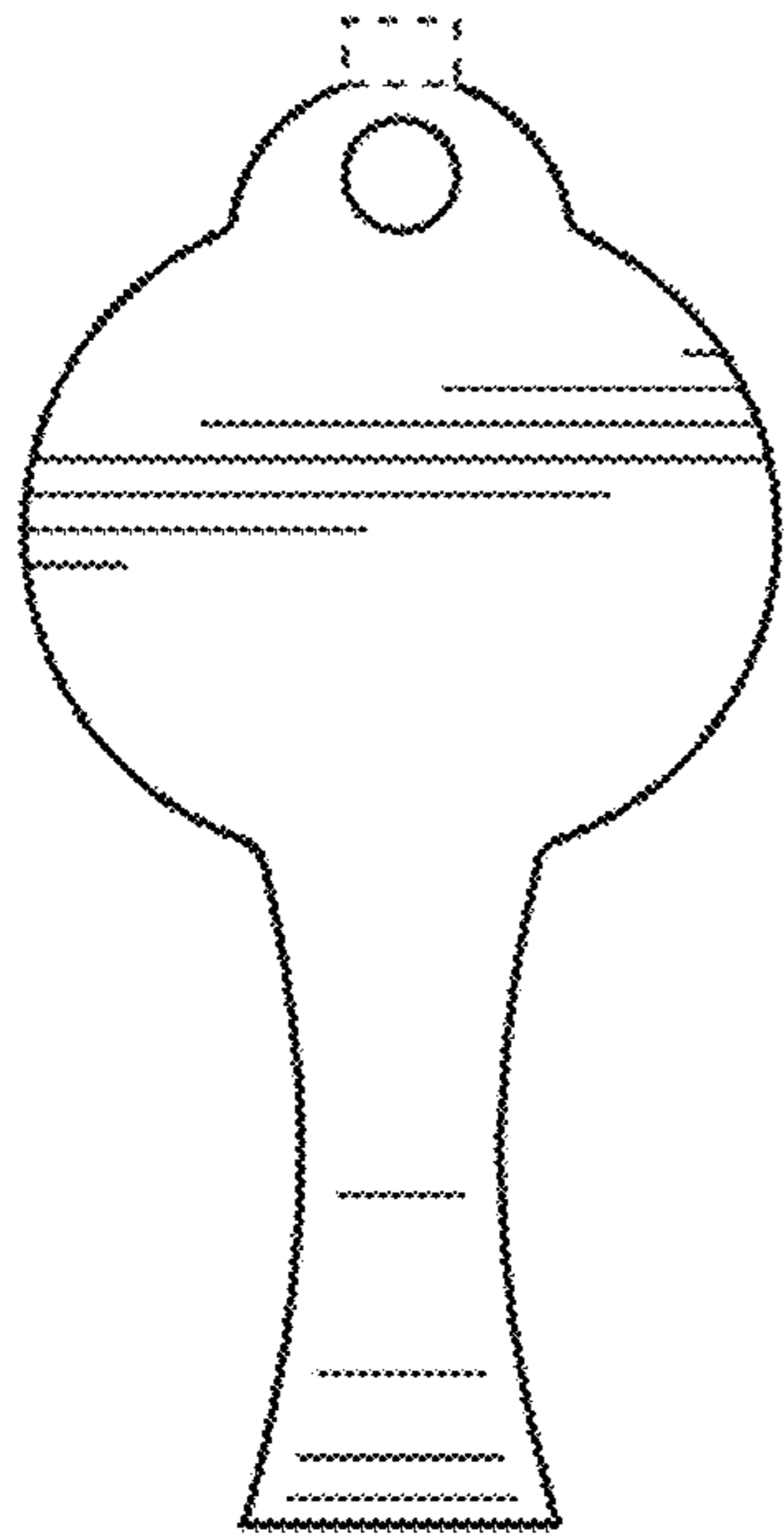

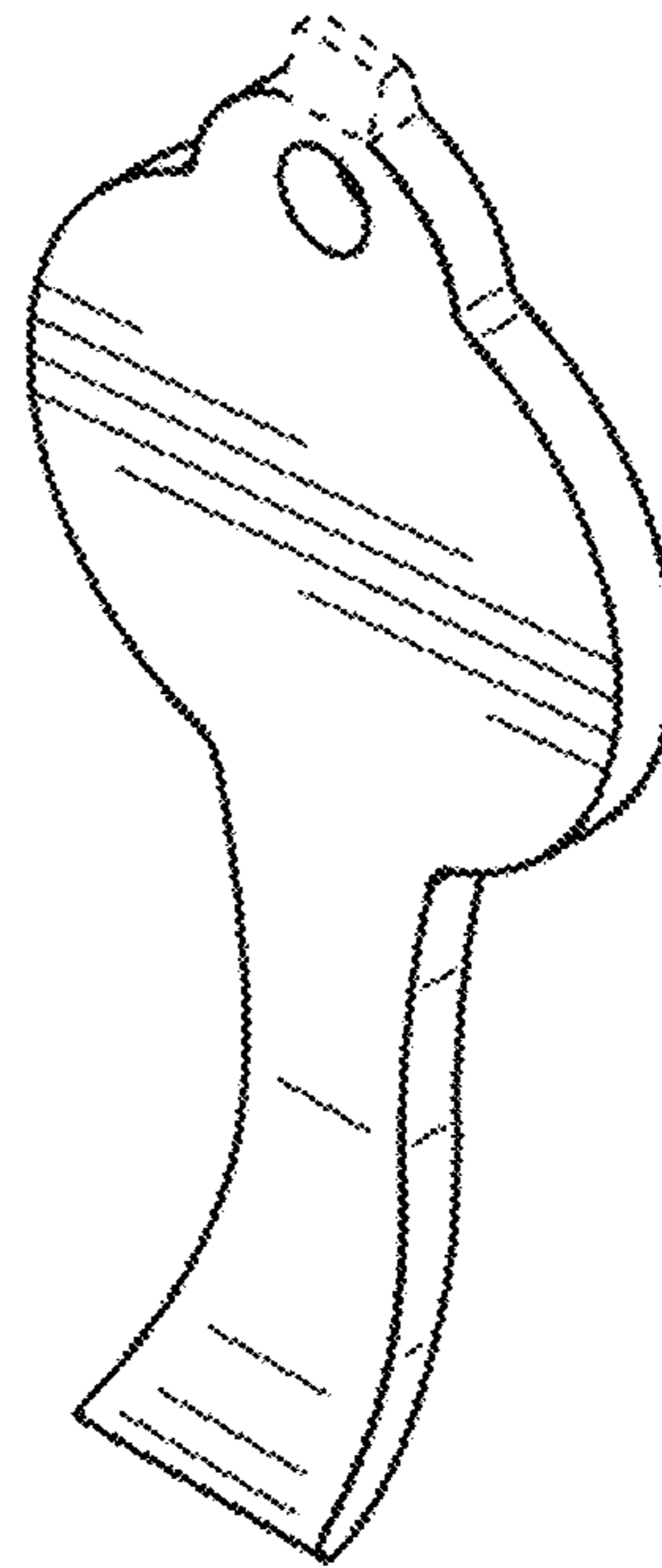
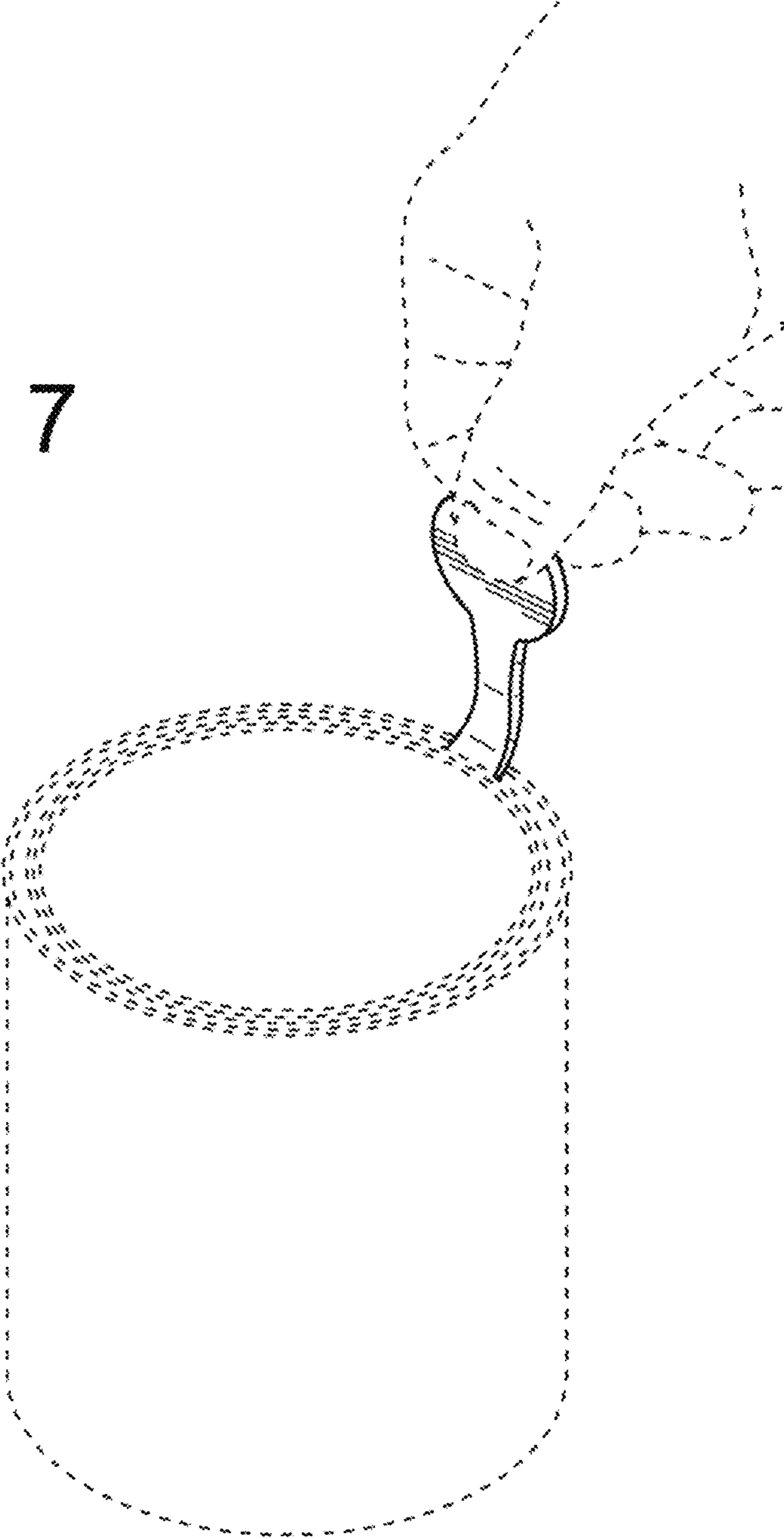

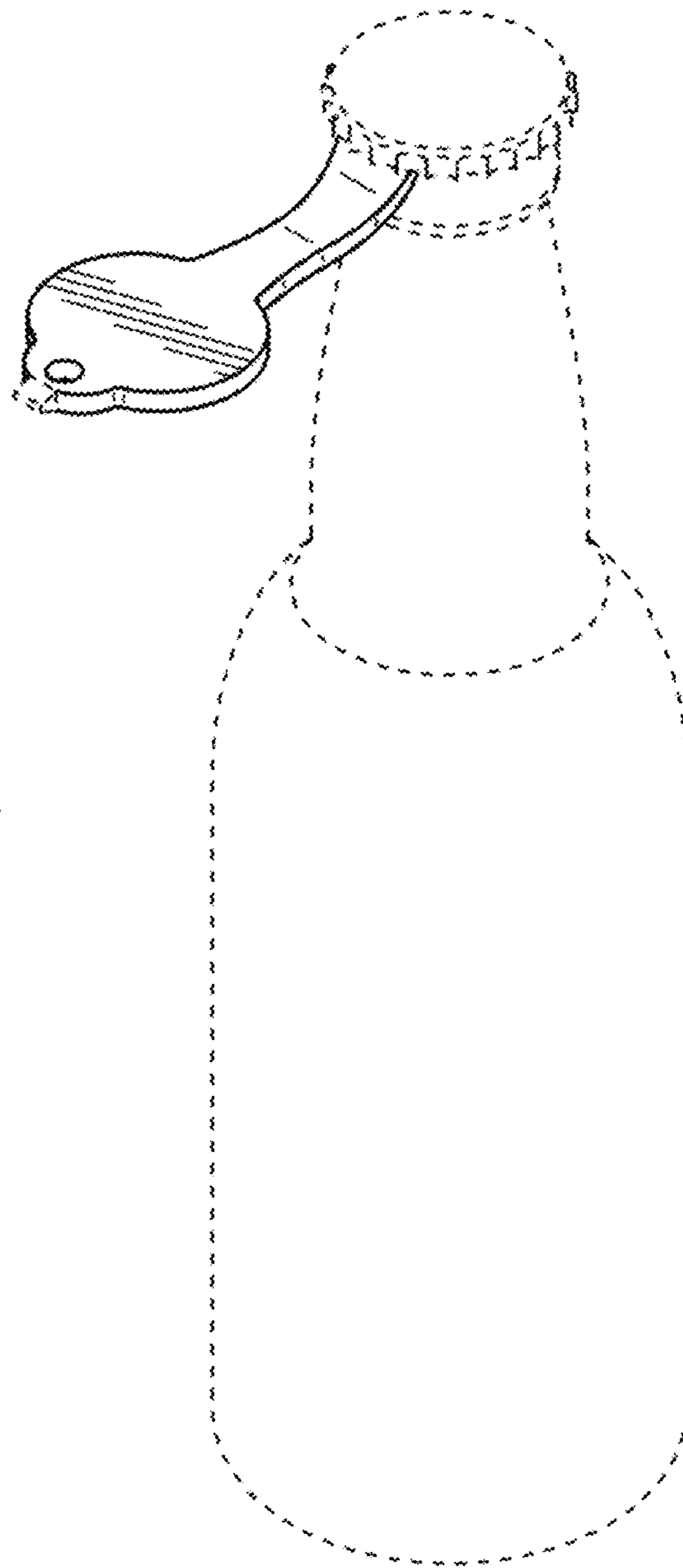
