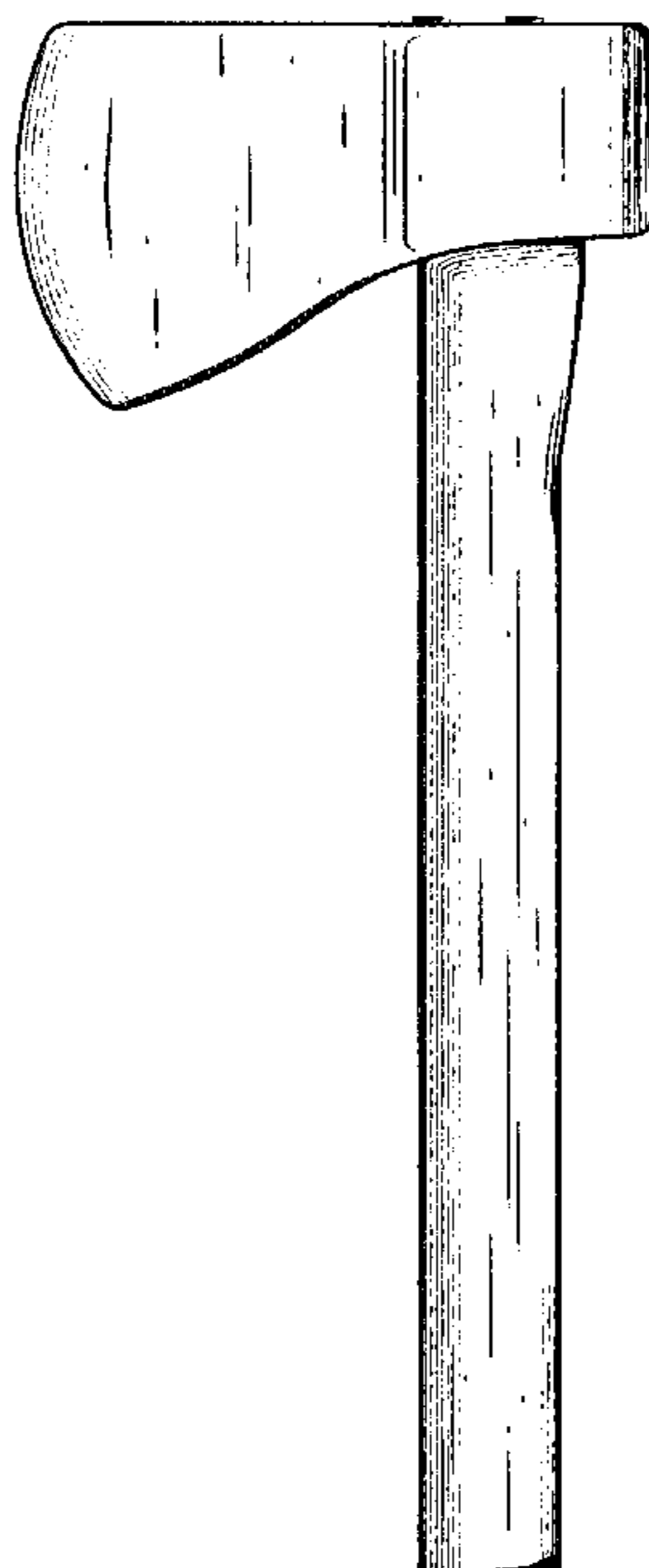
(57) **CLAIM**

I claim the ornamental design for a throwing axe assembly, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the throwing axe assembly, showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is an exploded perspective view thereof;
FIG. 7 is a top, rear perspective view thereof;
FIG. 8 is a bottom, side perspective view thereof; and,
FIG. 9 is a top, rear perspective view thereof.
The broken lines depict portions of the throwing axe assembly in which the design is embodied that are not considered part of the claimed design.

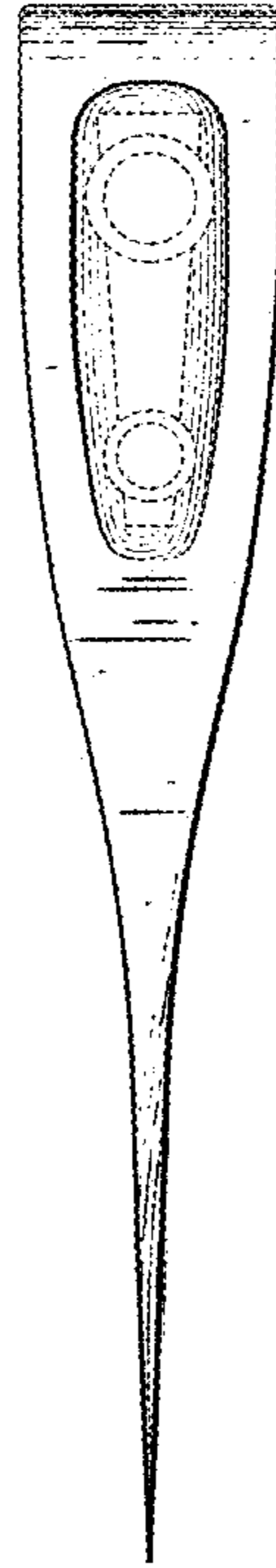

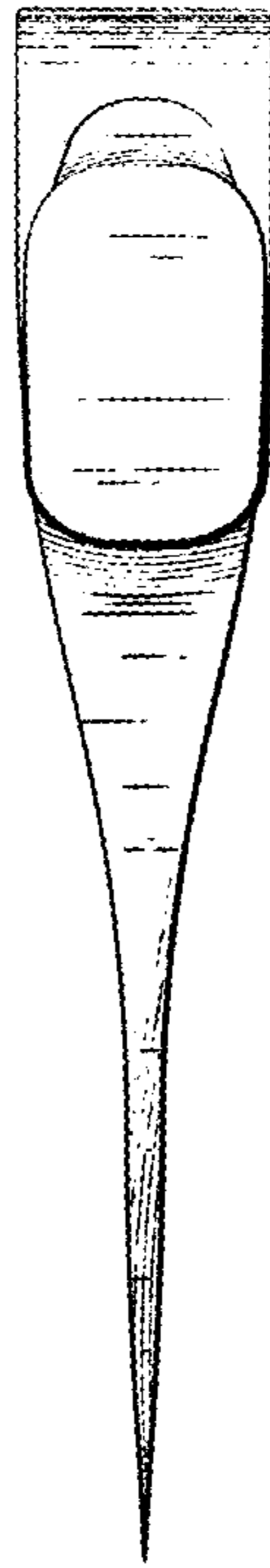

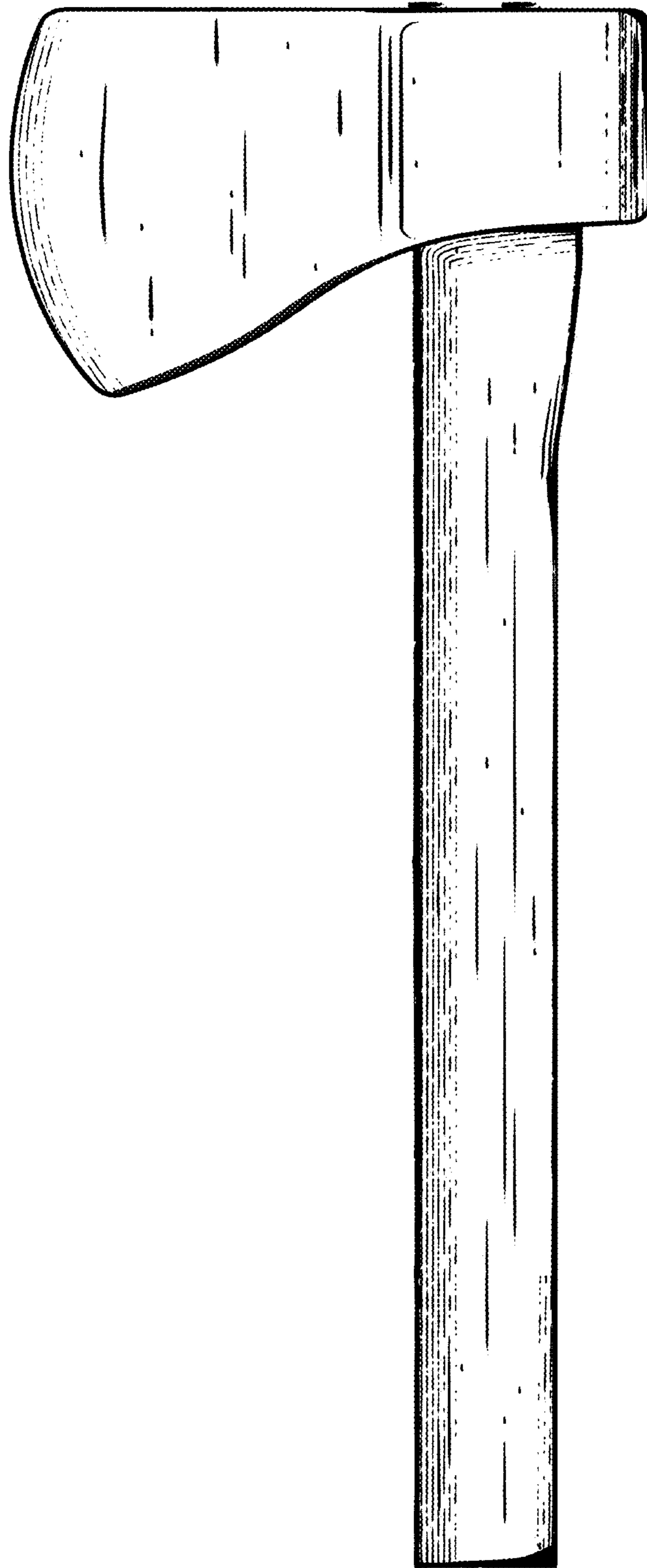

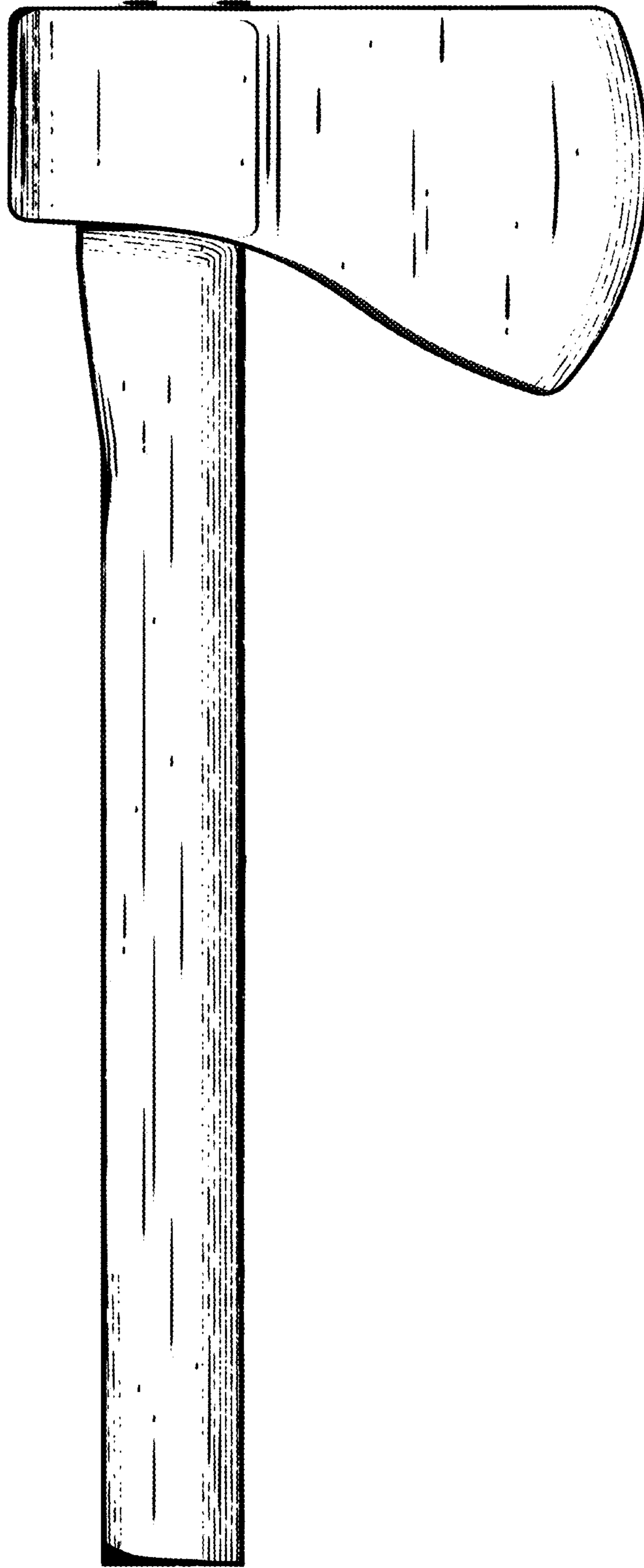

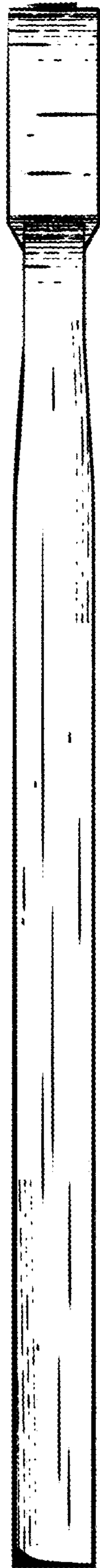

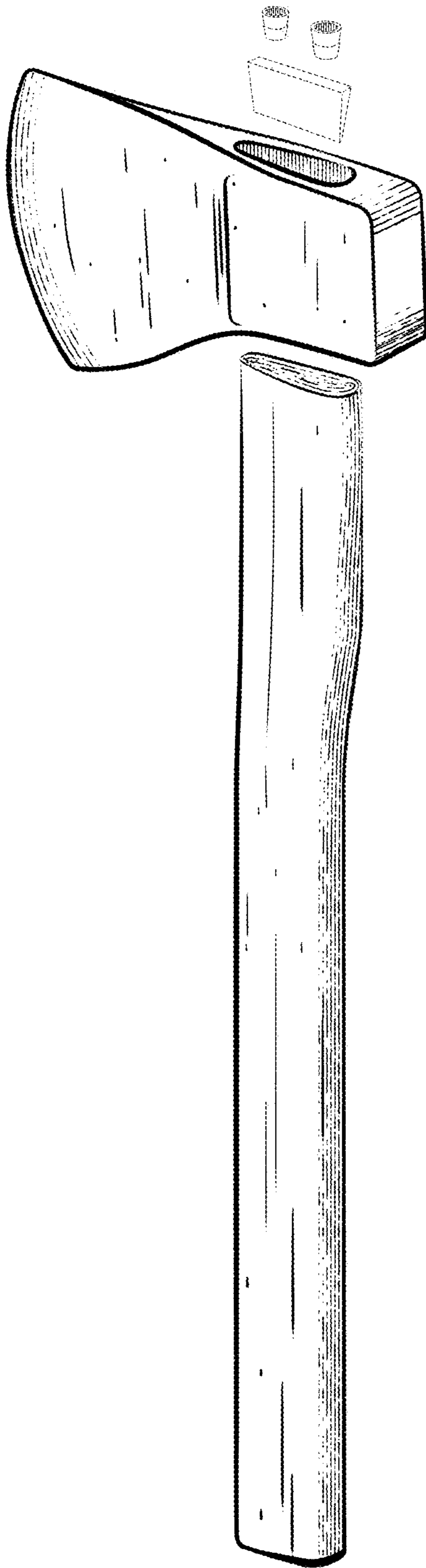

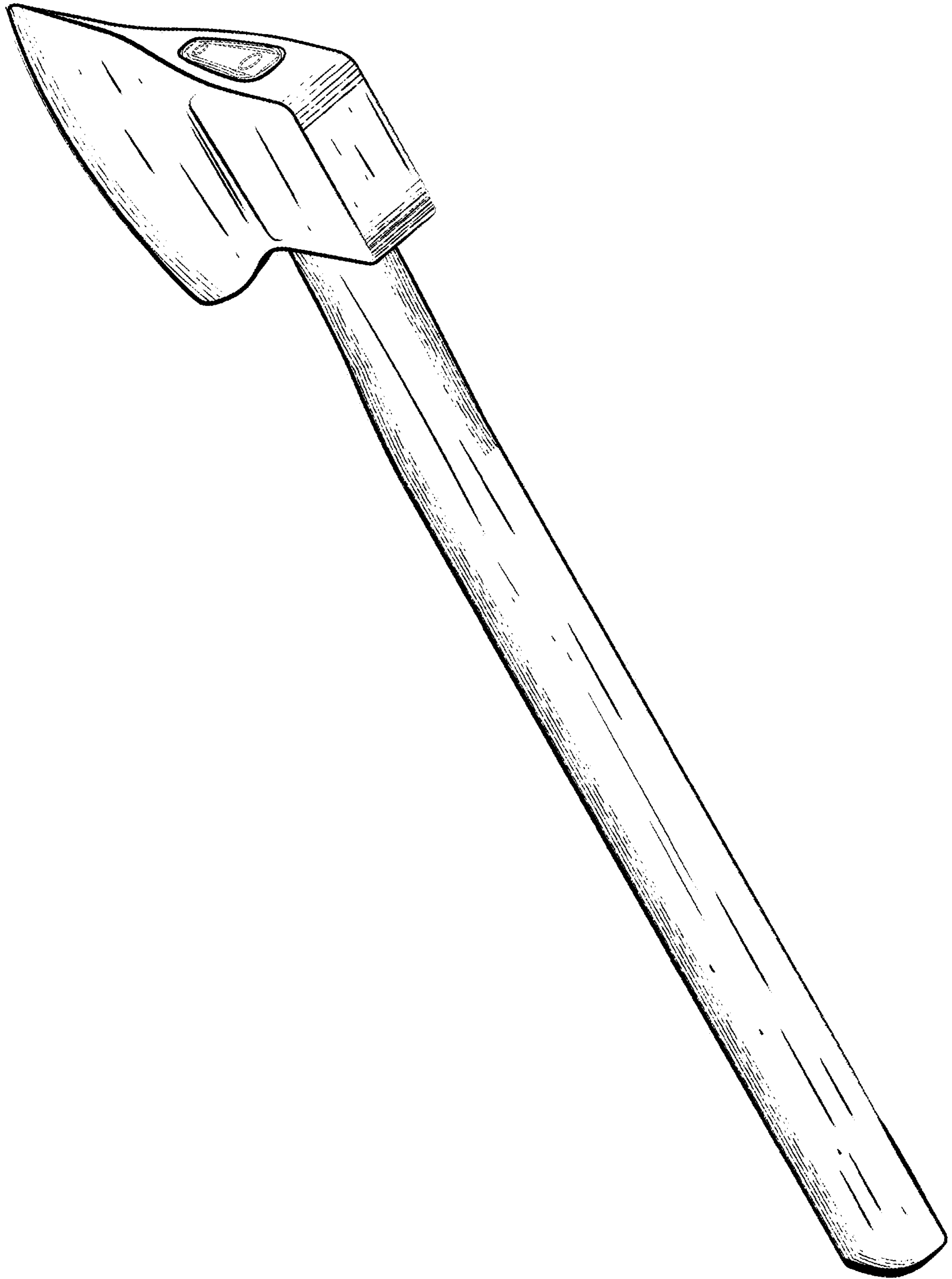

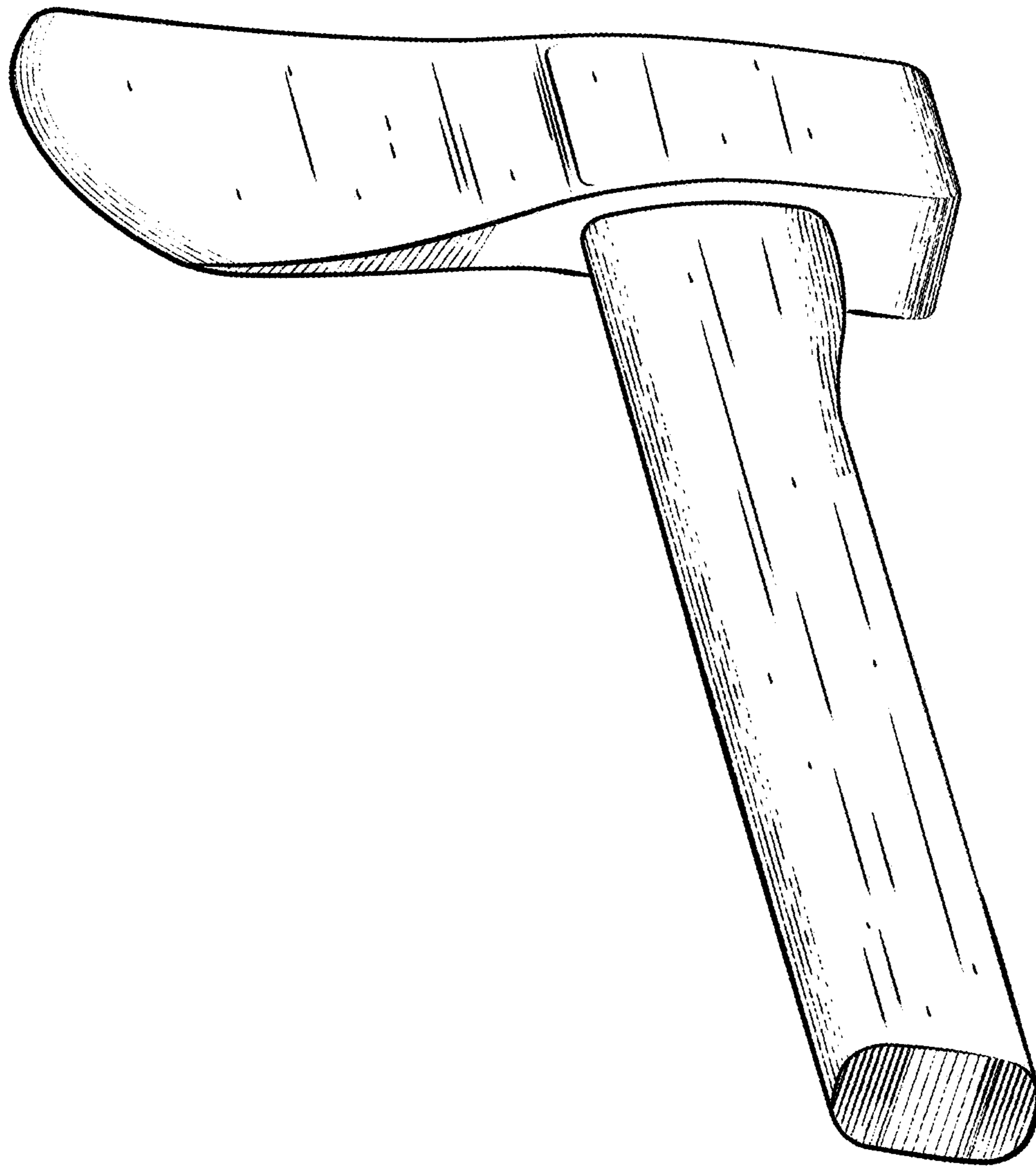

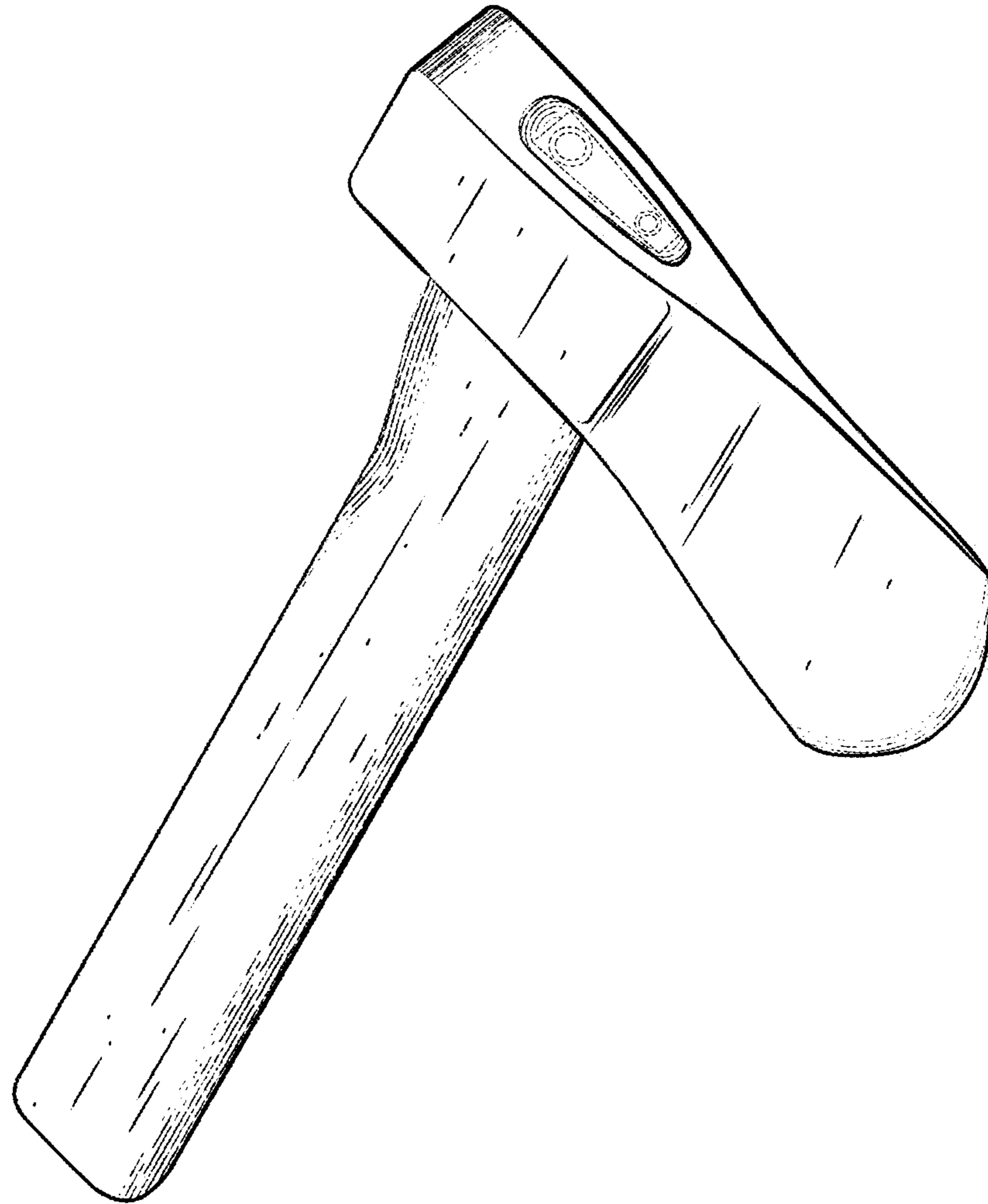
