**DESCRIPTION**

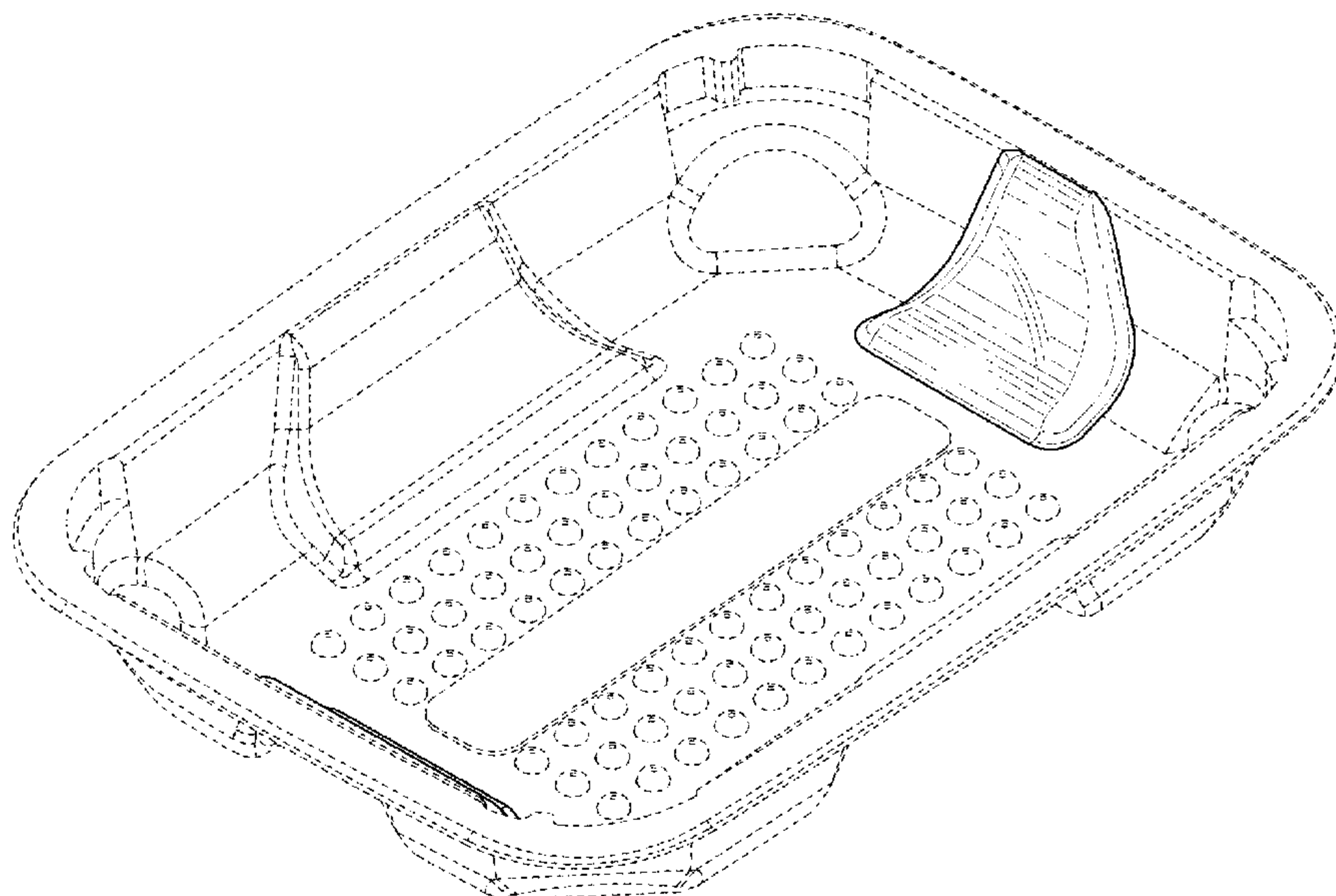
FIG. 1 is a top perspective view of a clear tray according to the new design.

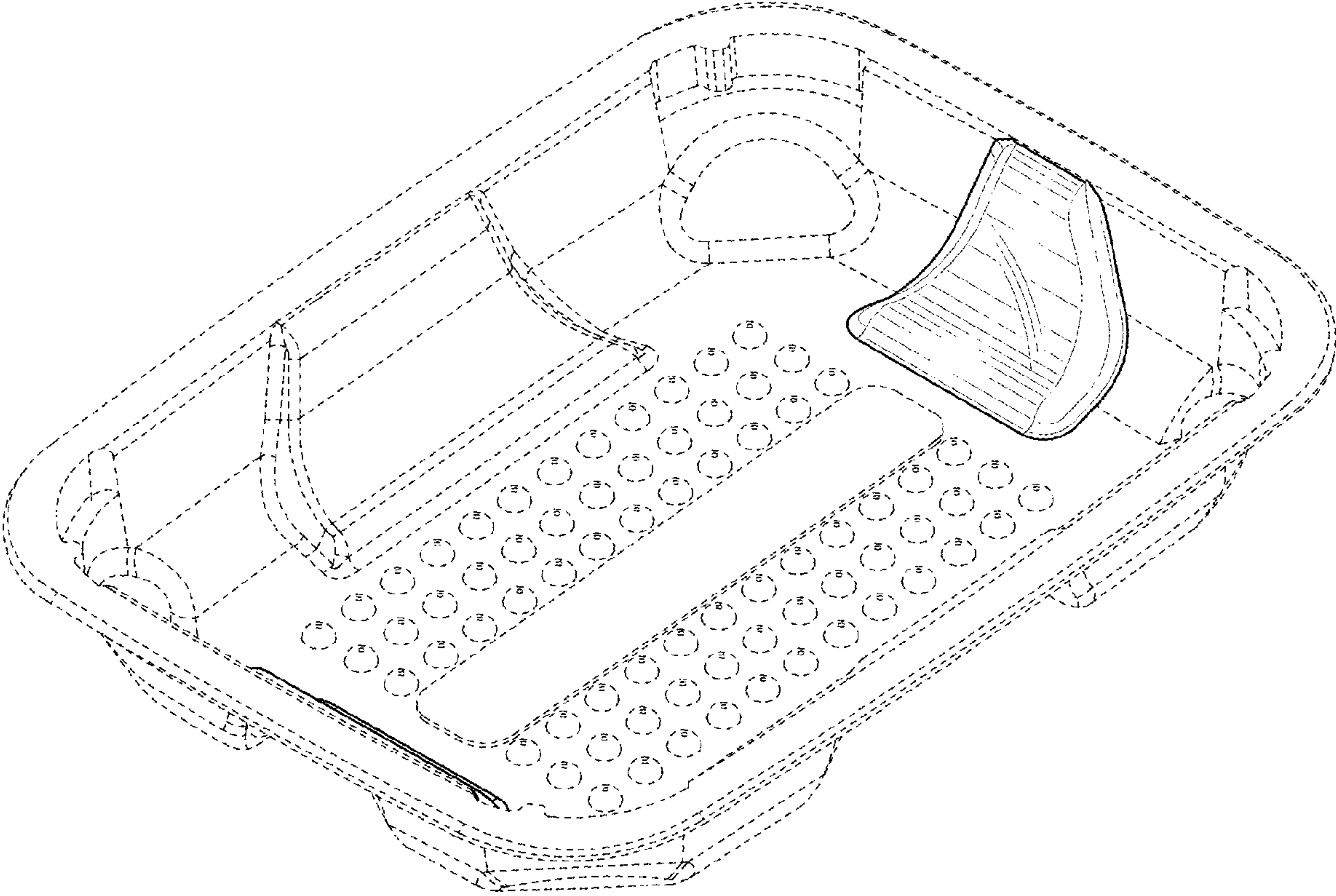

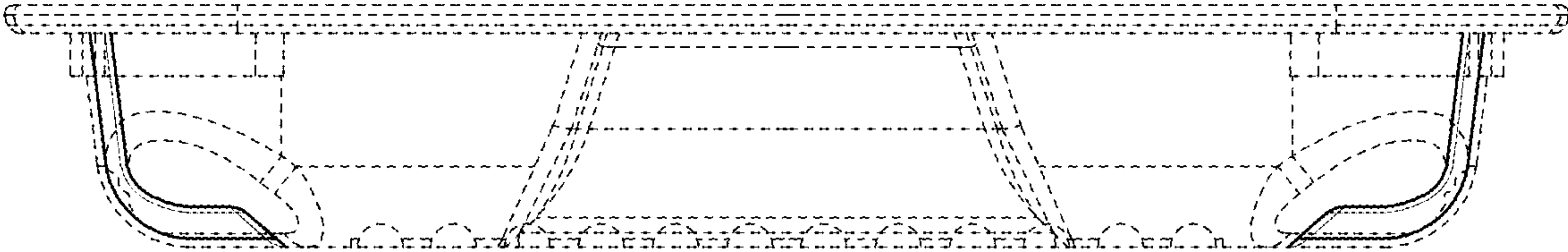

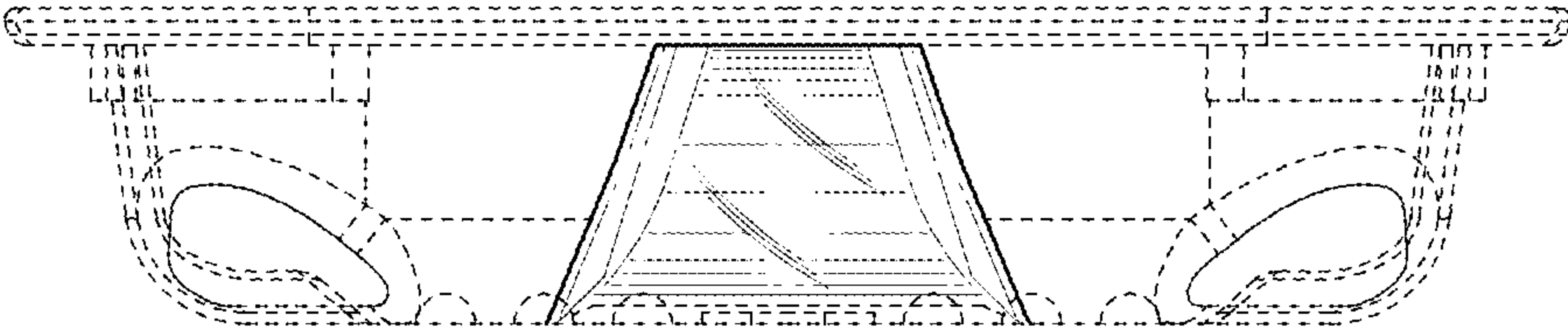

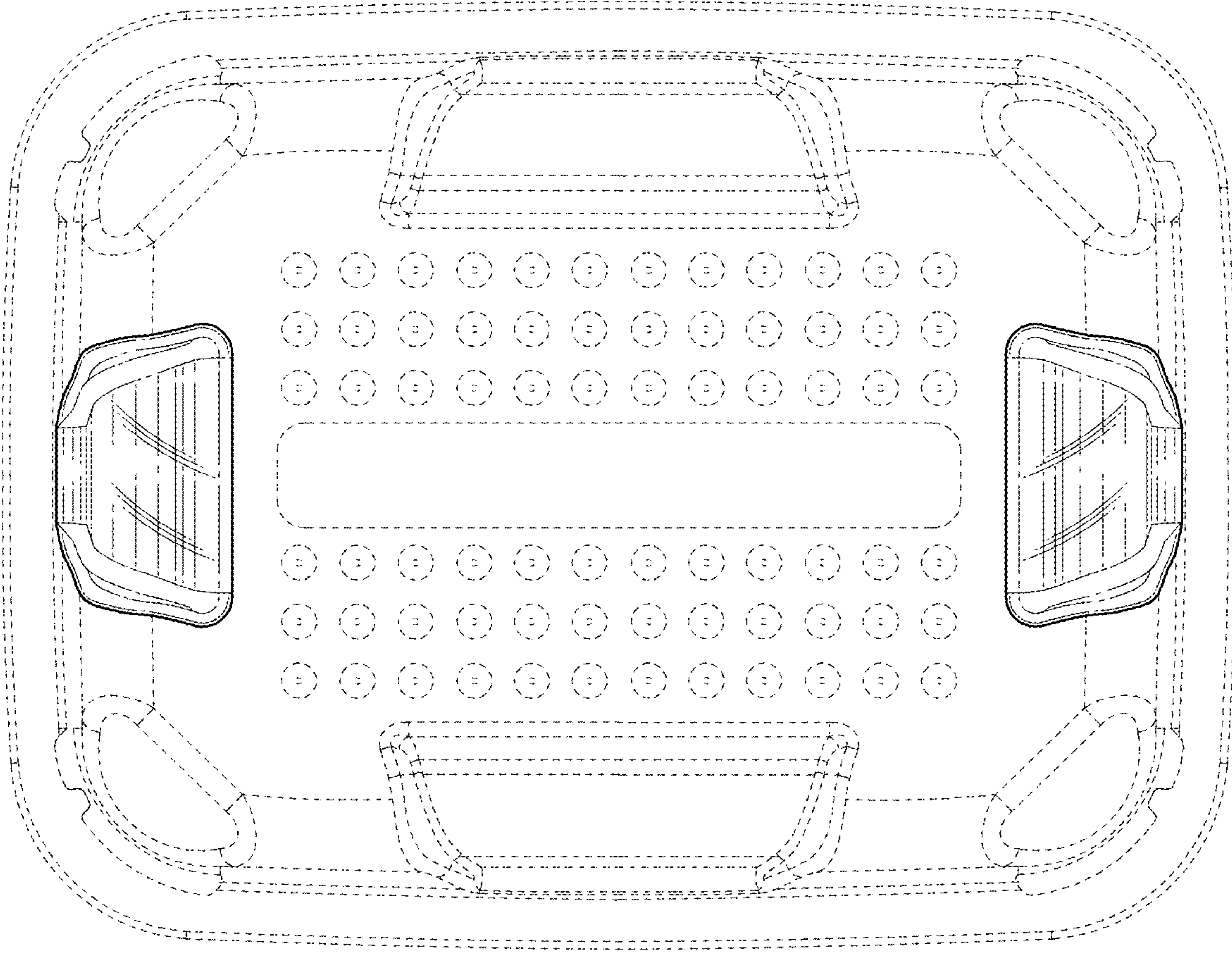

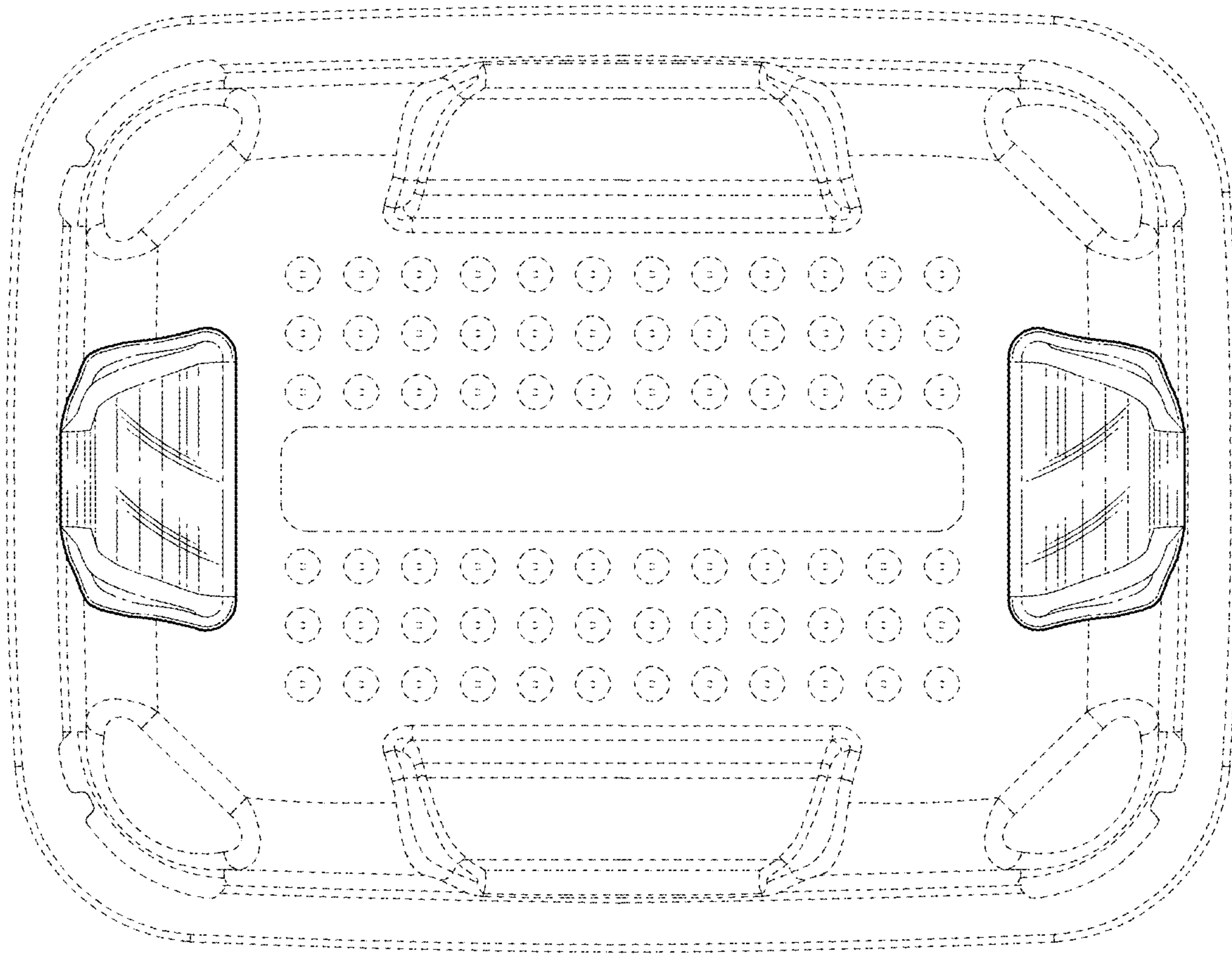
