DESCRIPTION

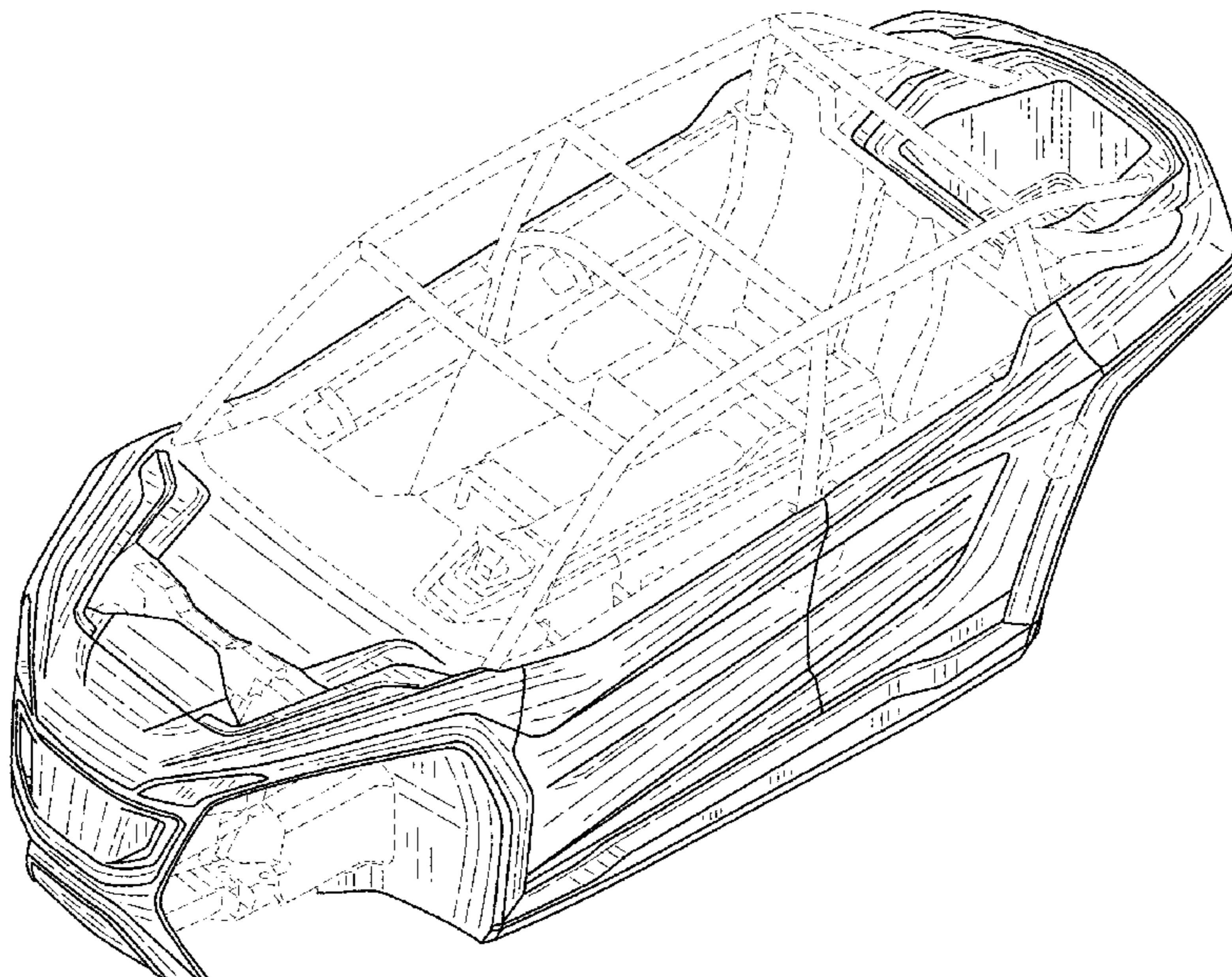
FIG. 1 is a top, front, and left side perspective view of an electric utility vehicle embodying our new design;

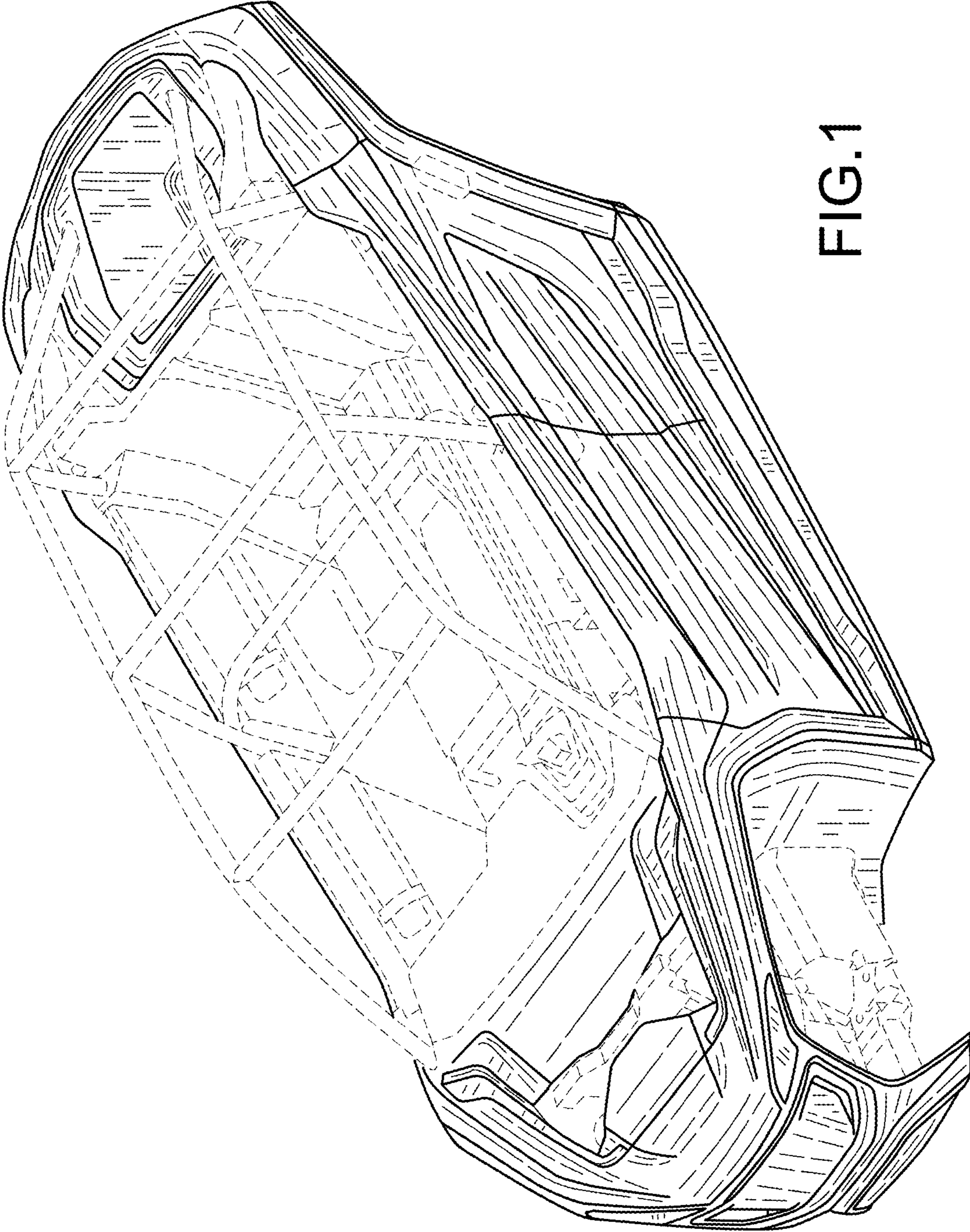

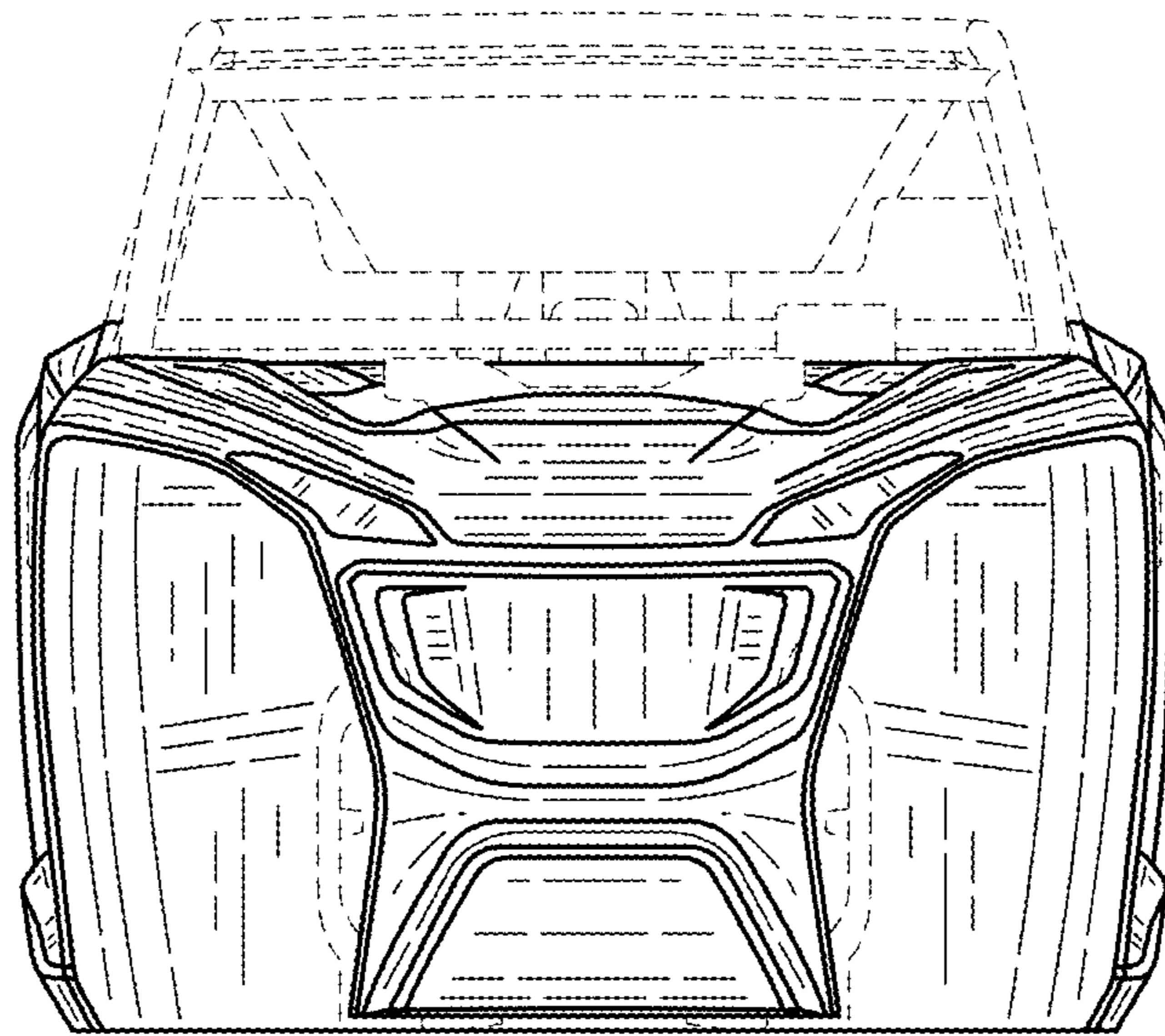

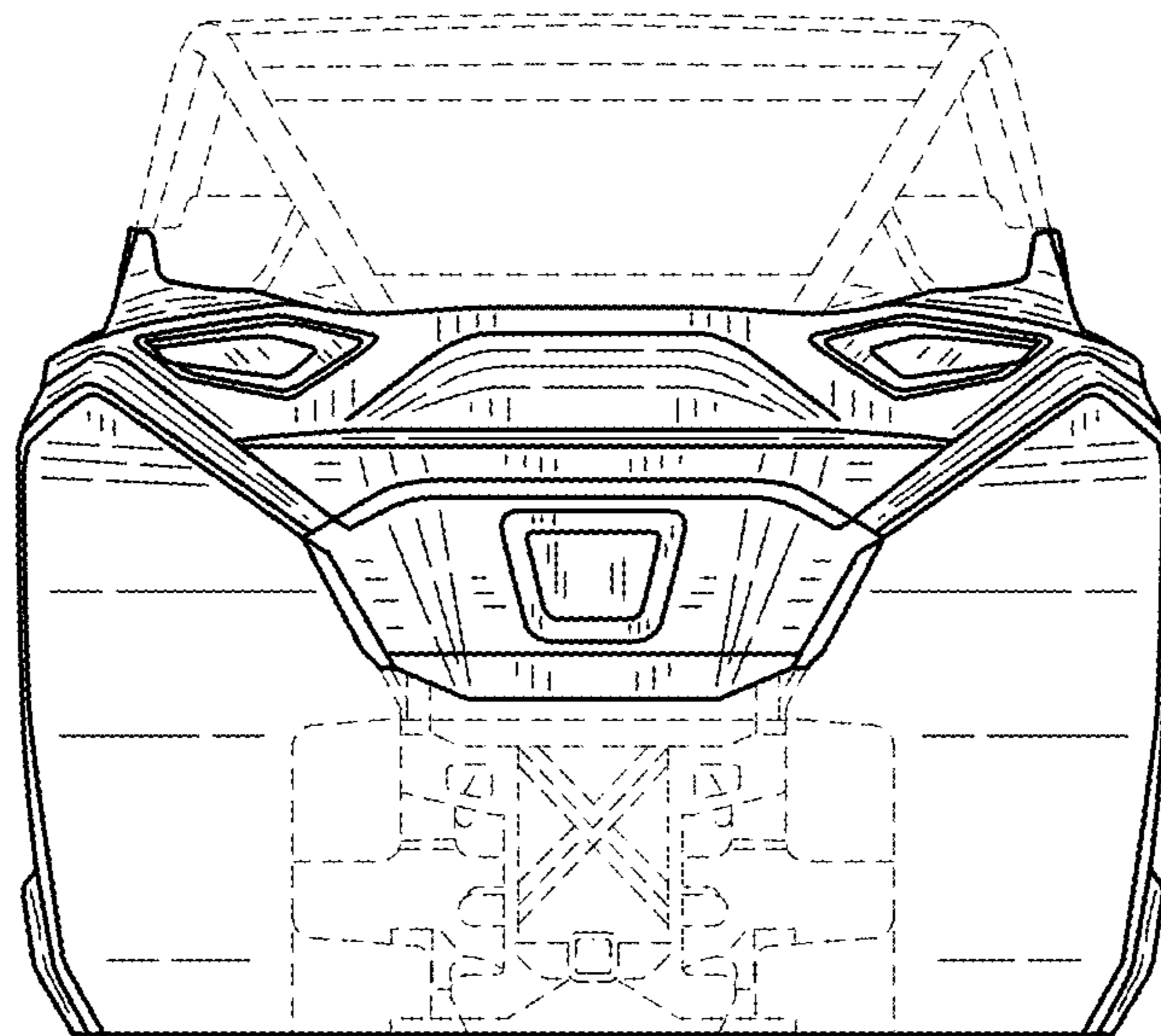

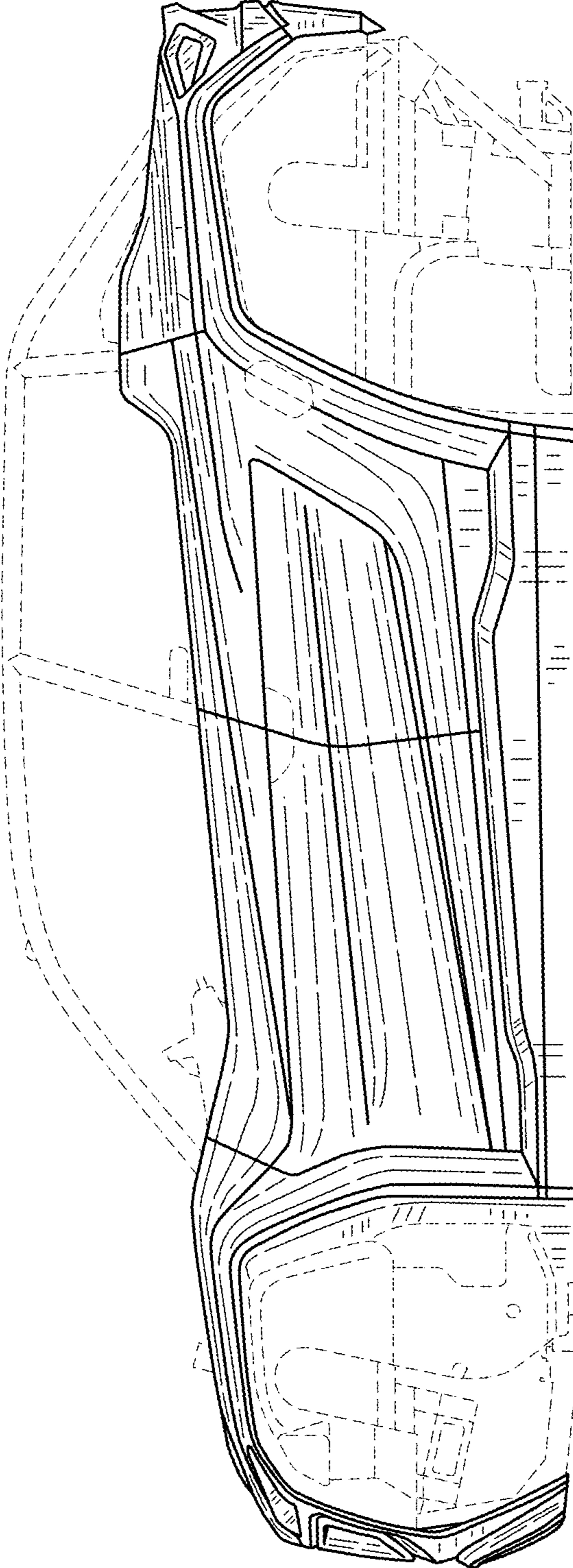

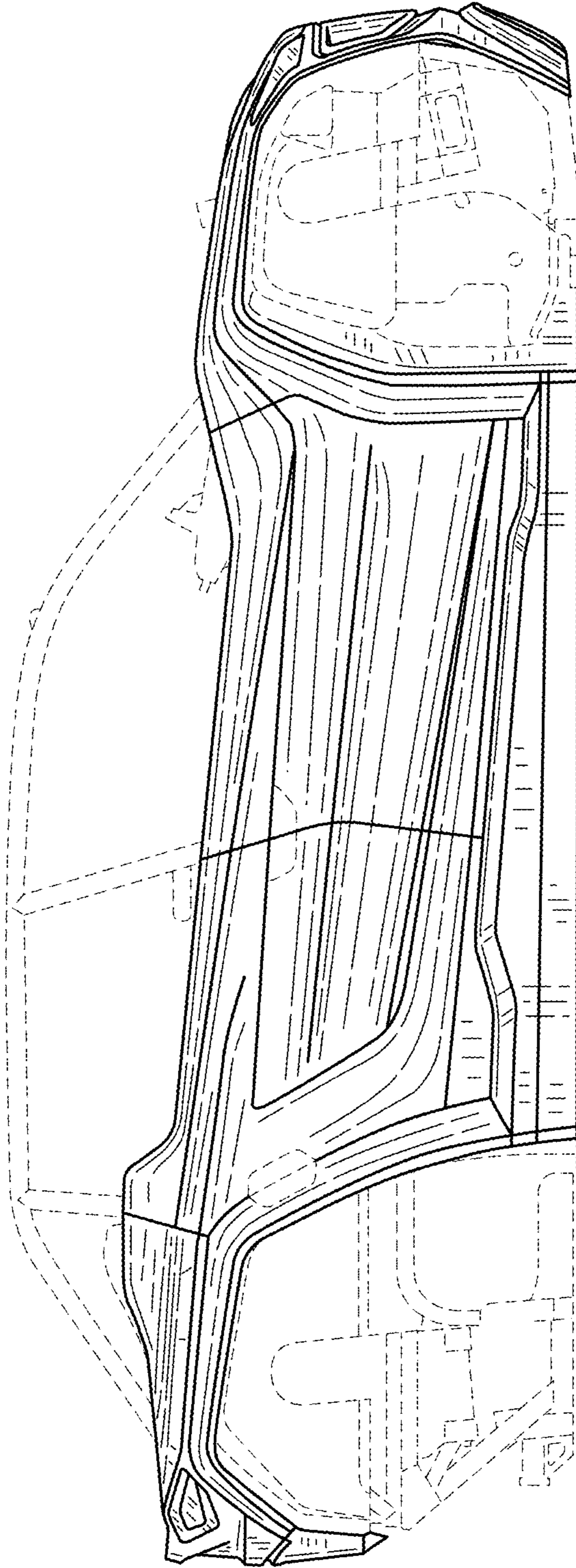

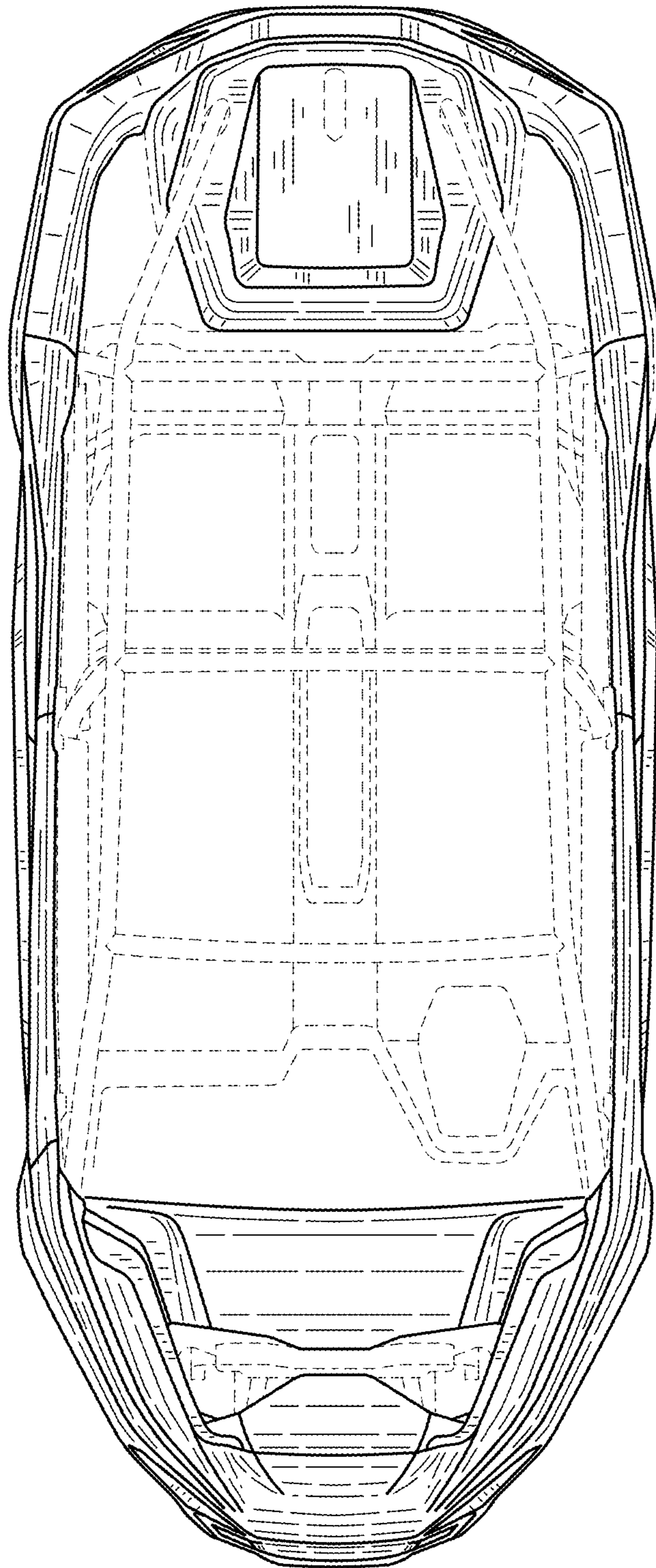

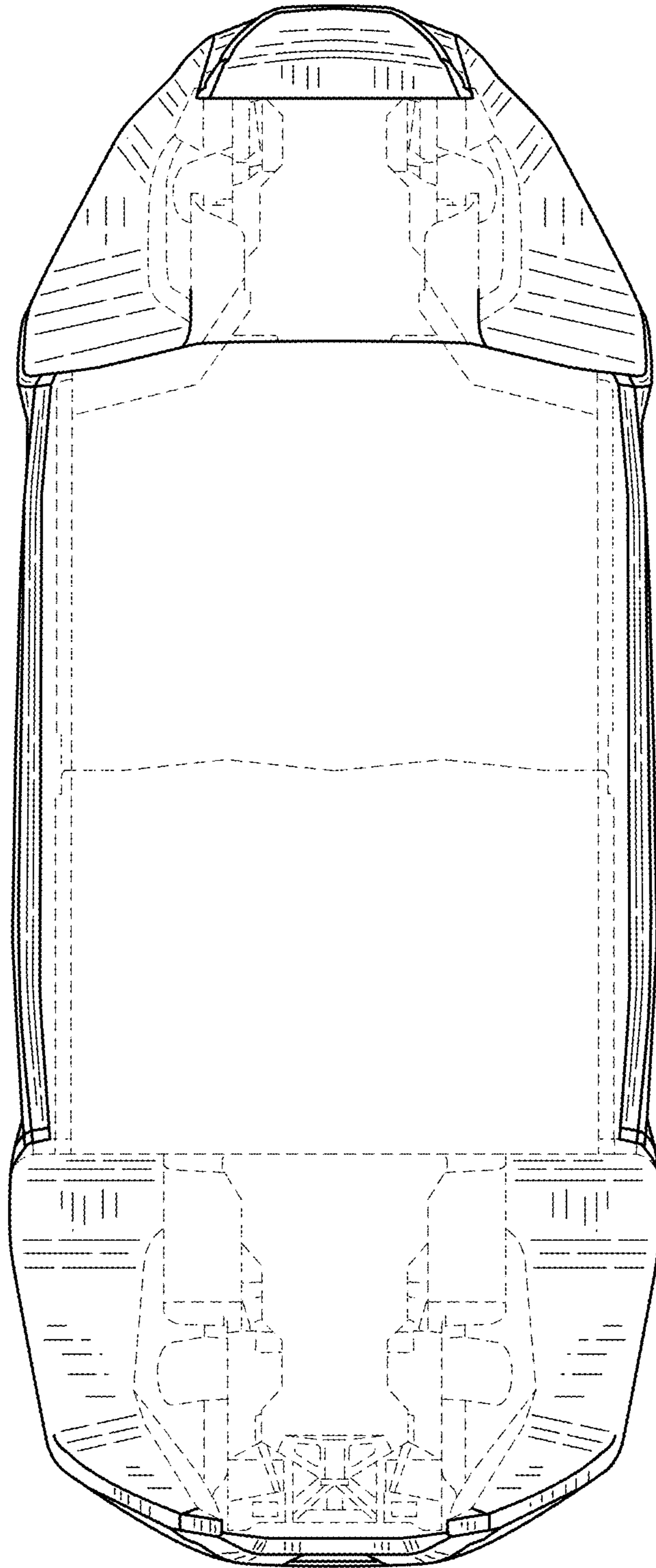
