DESCRIPTION

FIG. 1 is a front perspective view of a vehicle floor mat according to the present invention.

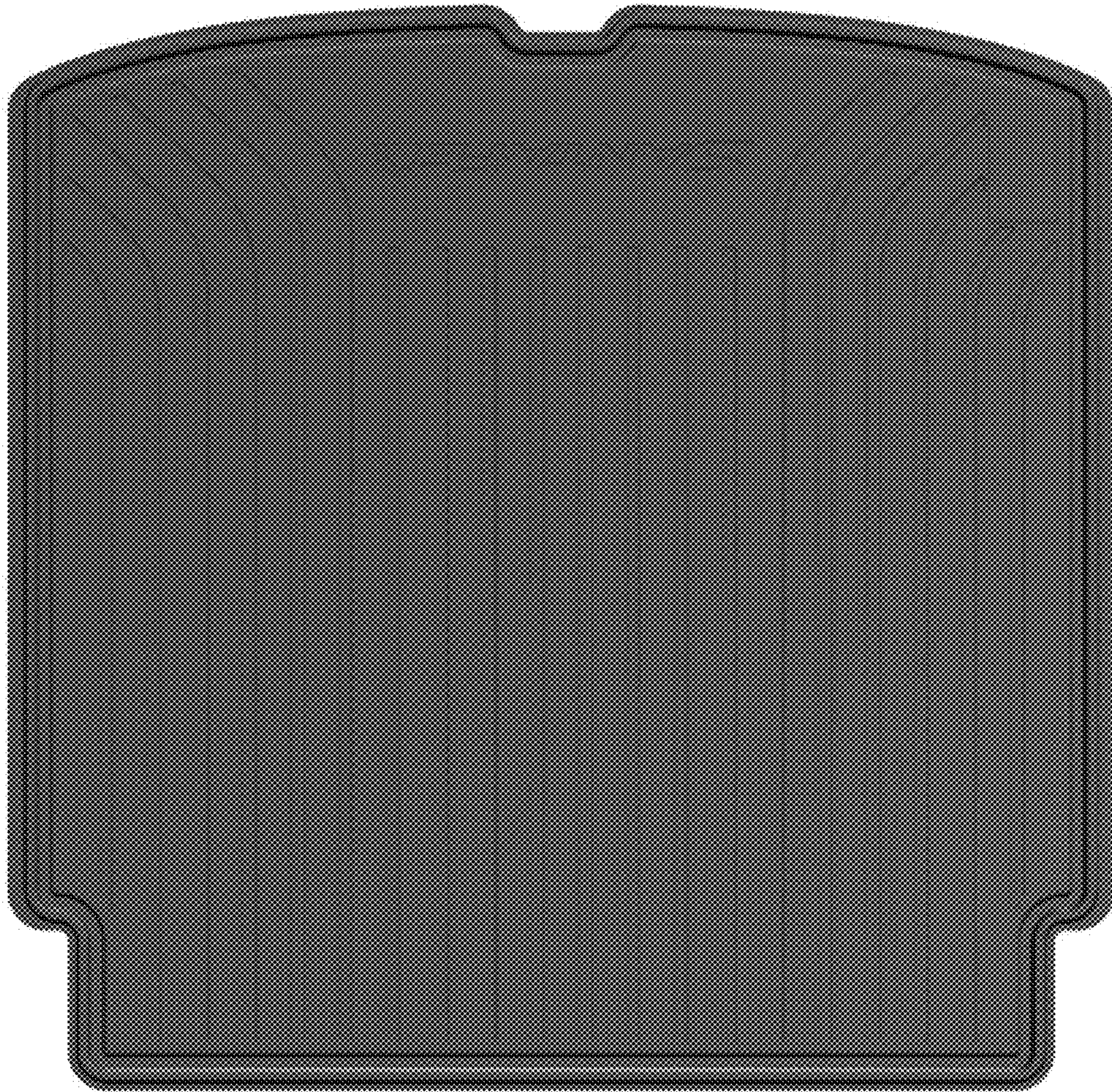
