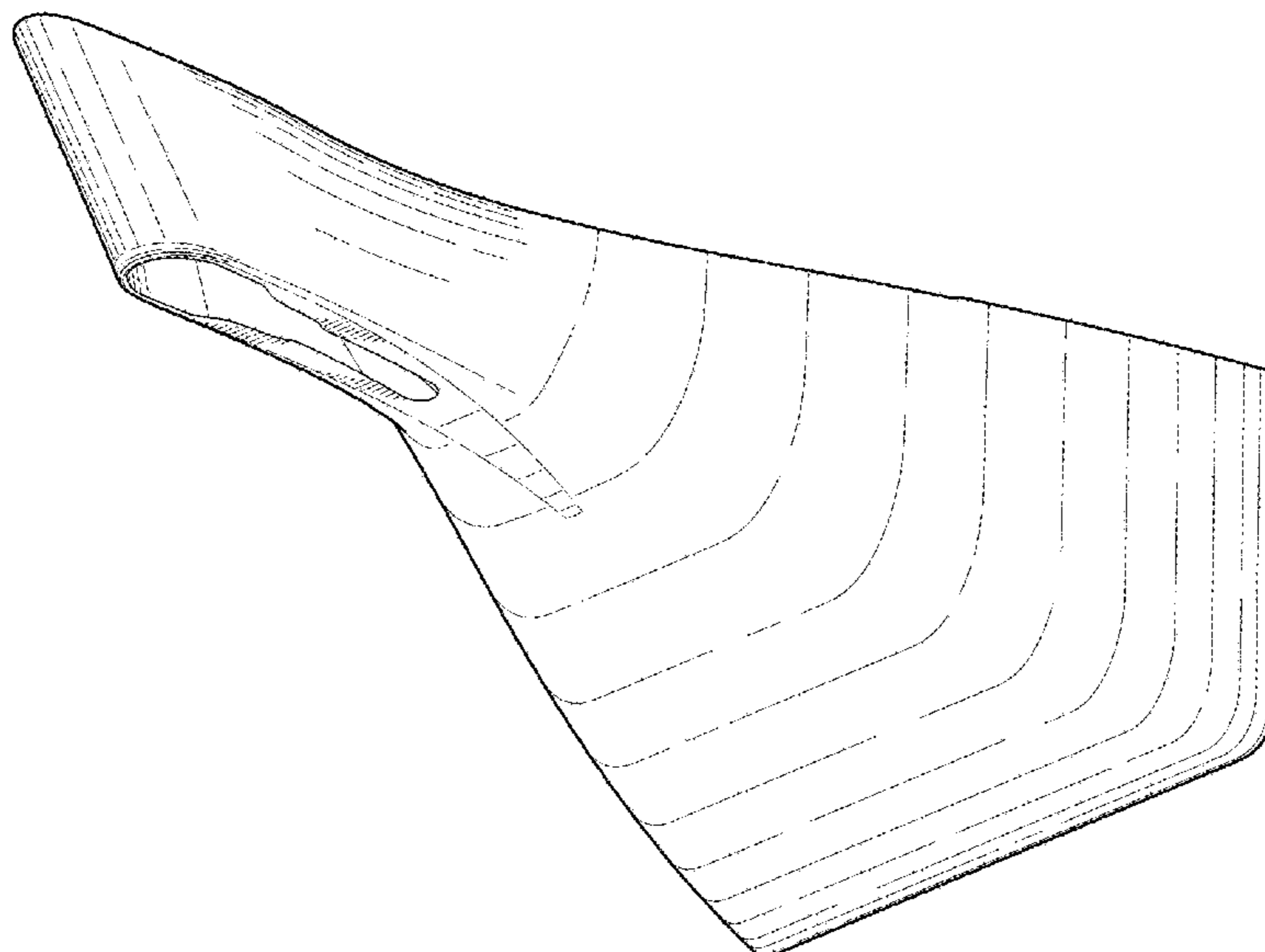
(57) **CLAIM**

The ornamental design for the cargo pod fairing, as shown and described.

DESCRIPTION

FIG. 1 is of a cargo pod fairing shown in an environment of use, in accordance with the present design;
 FIG. 2 is a lower-front-left perspective view of the cargo pod fairing shown in FIG. 1, removed from an environment of use for clarity of disclosure;
 FIG. 3 is an upper-front-left perspective view of the cargo pod fairing shown in FIG. 2;
 FIG. 4 is a front view of the cargo pod fairing shown in FIG. 2;
 FIG. 5 is a back view of the cargo pod fairing shown in FIG. 2;
 FIG. 6 is a top plan view of the cargo pod fairing shown in FIG. 2;
 FIG. 7 is a bottom plan view of the cargo pod fairing shown in FIG. 2;

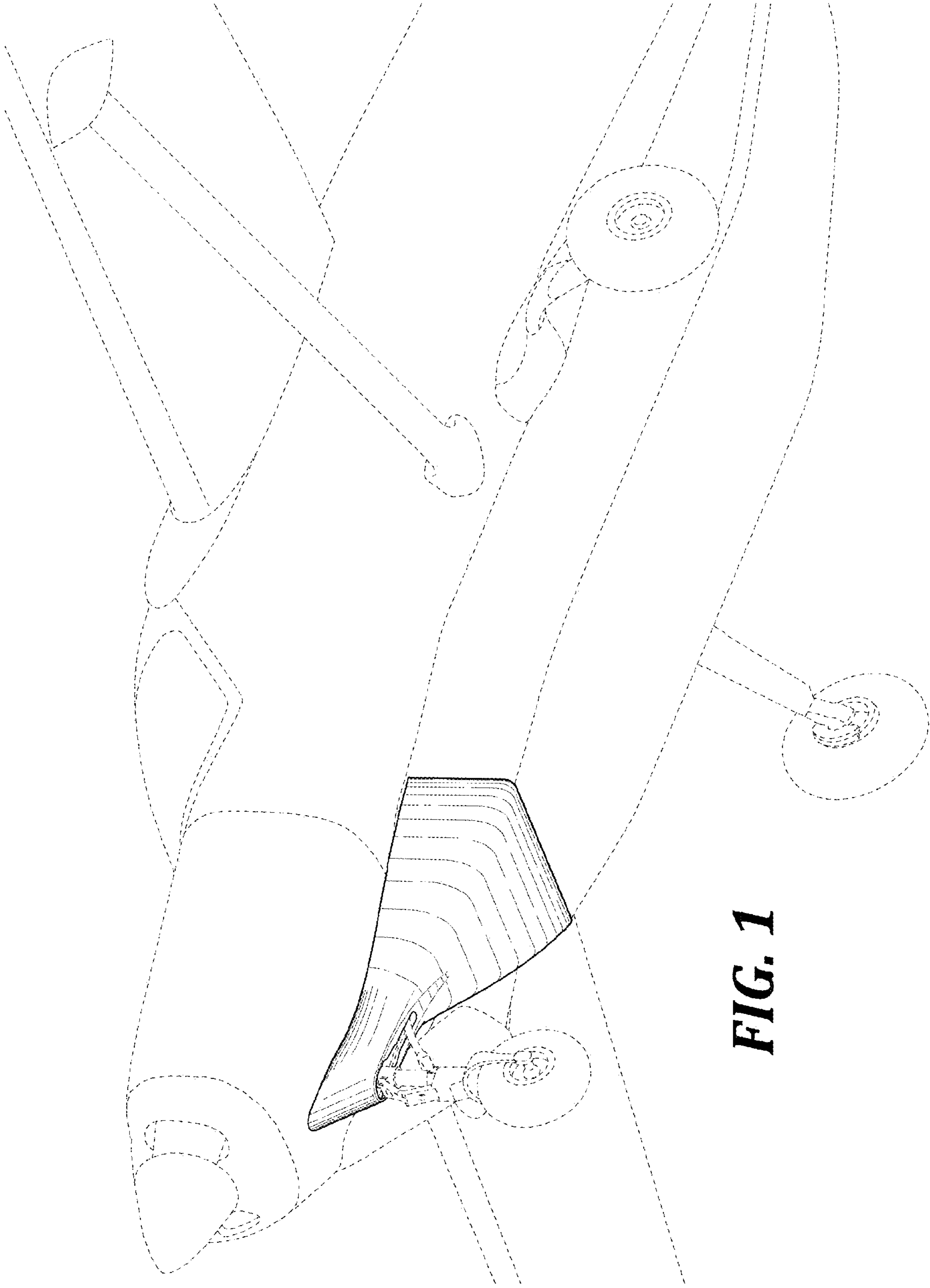

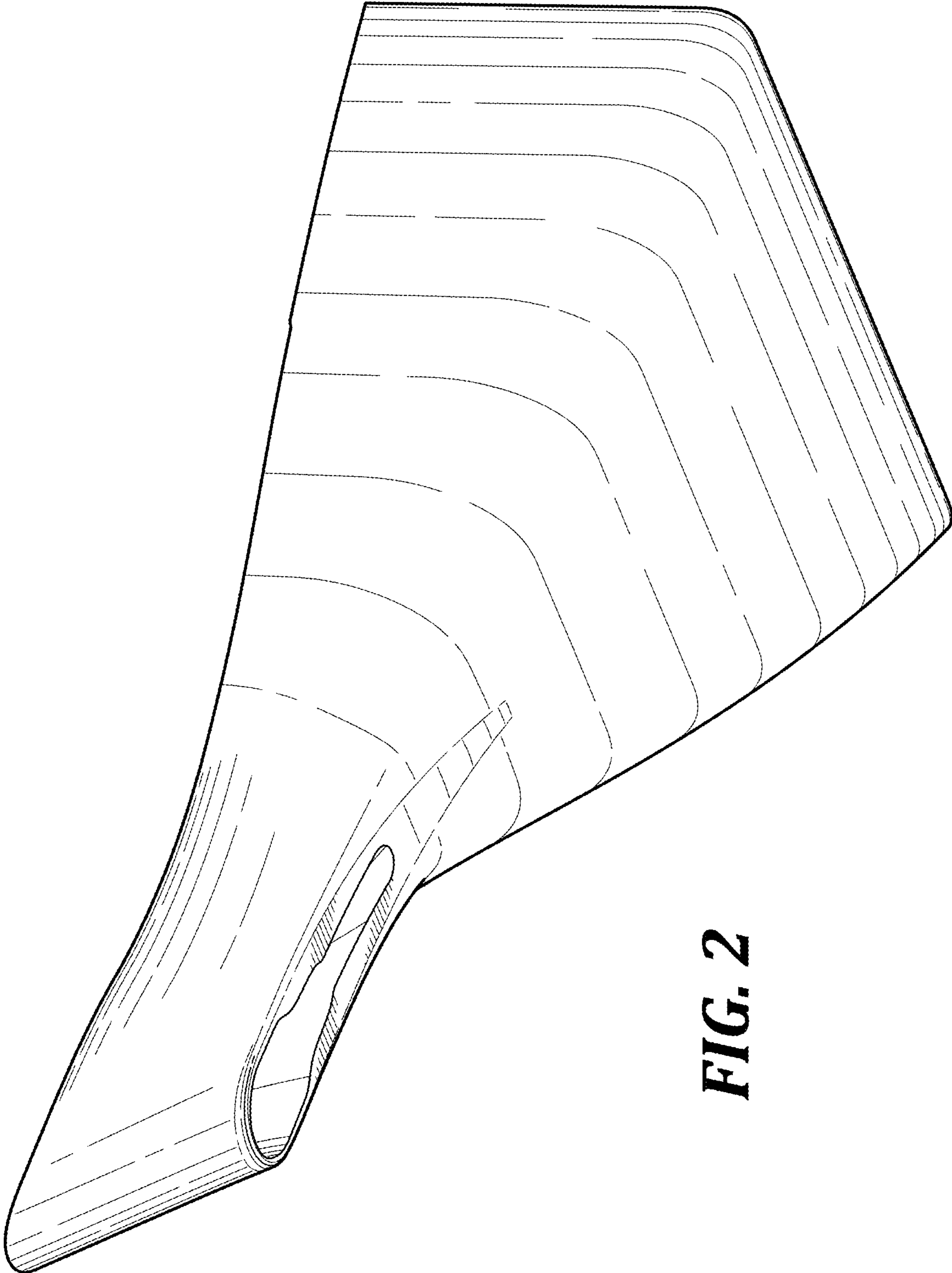

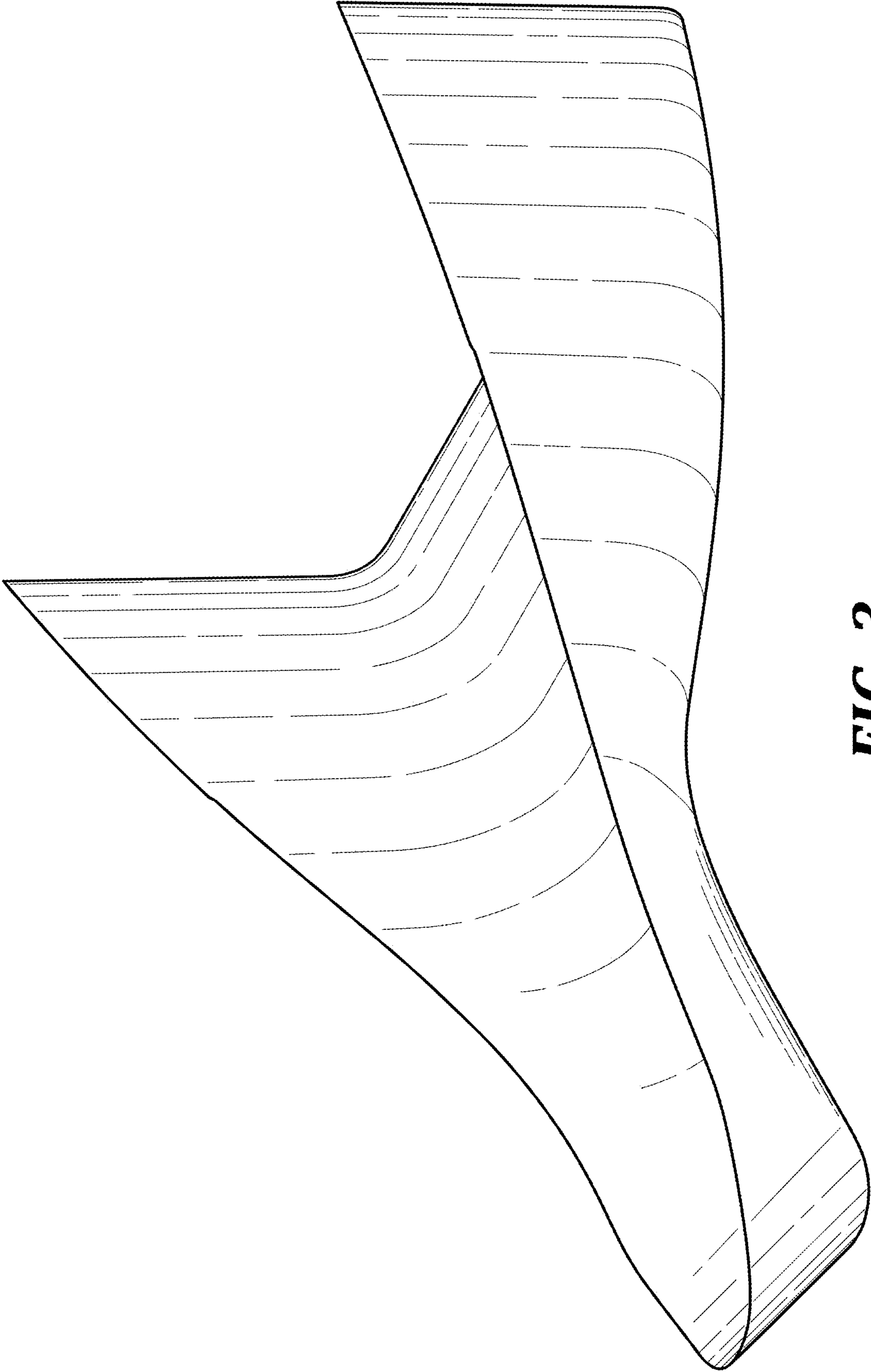

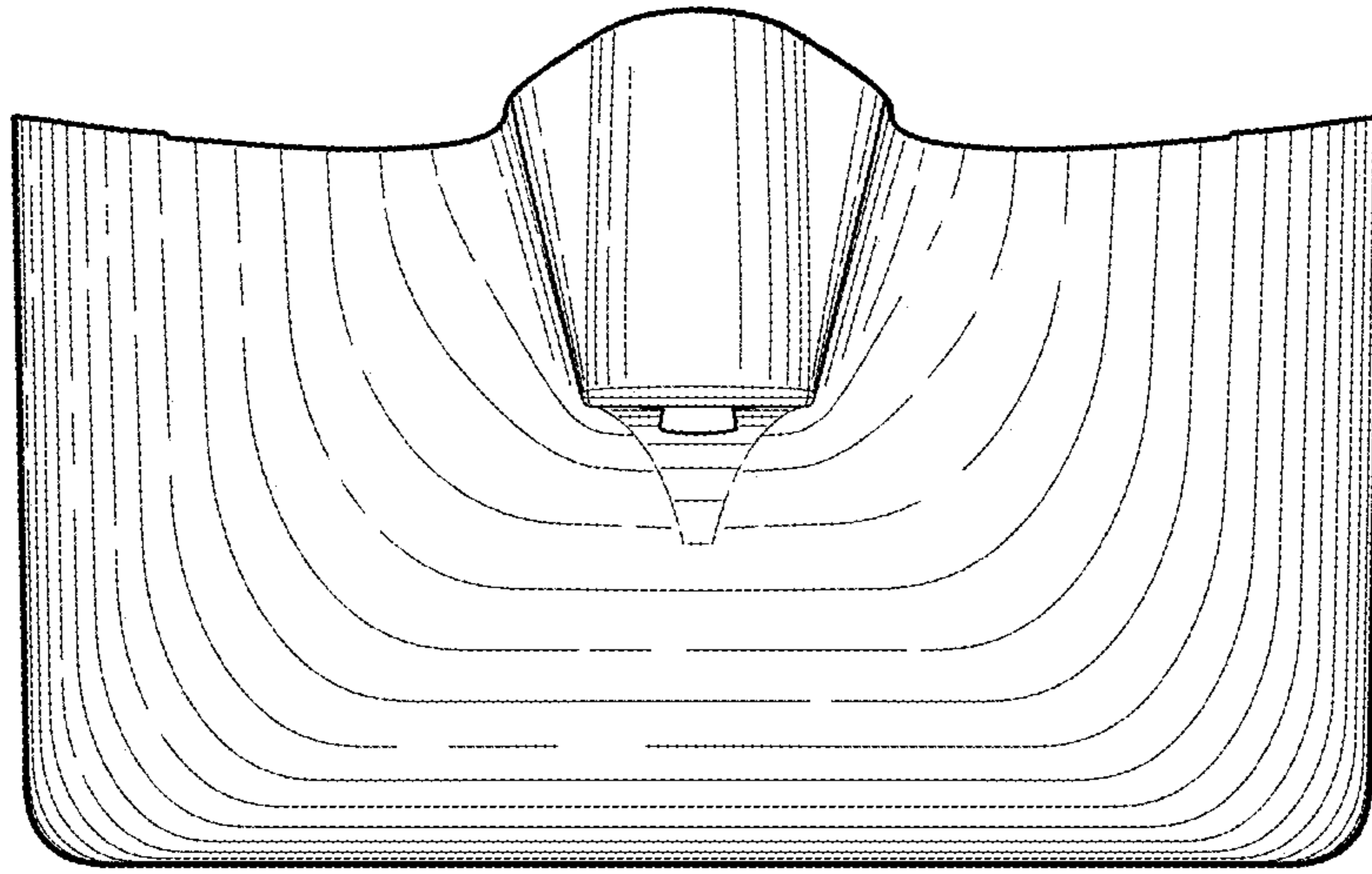

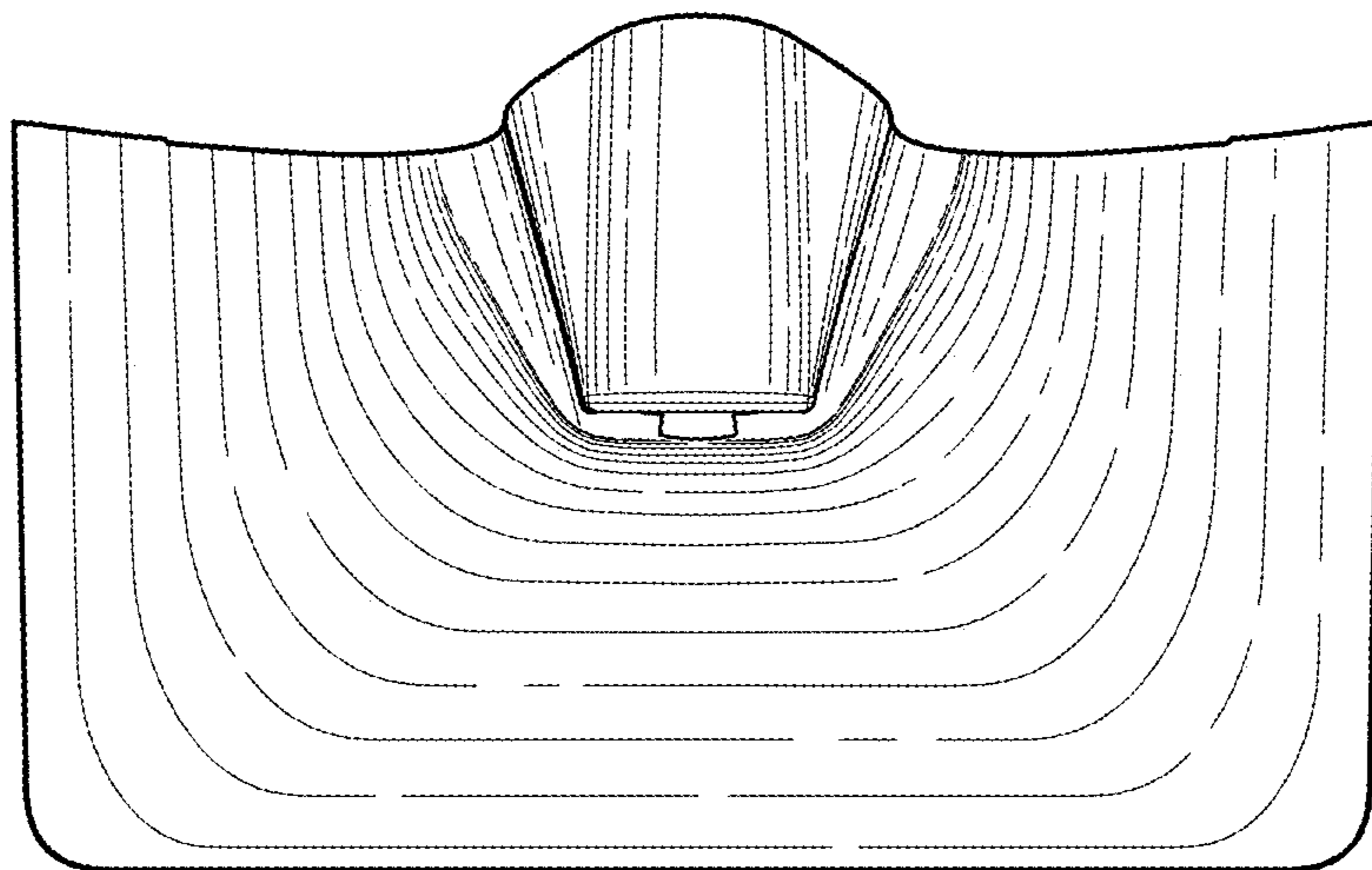

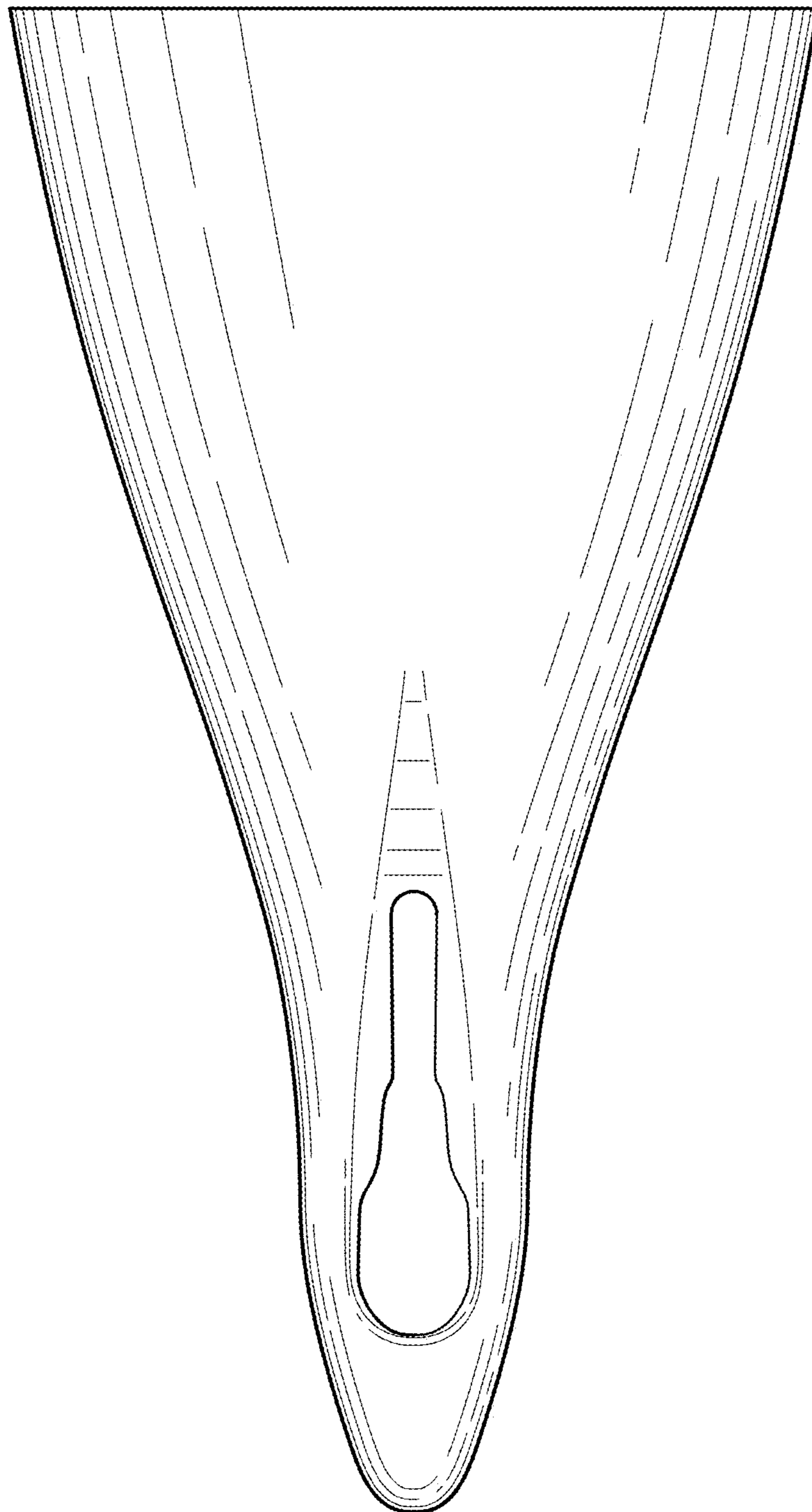

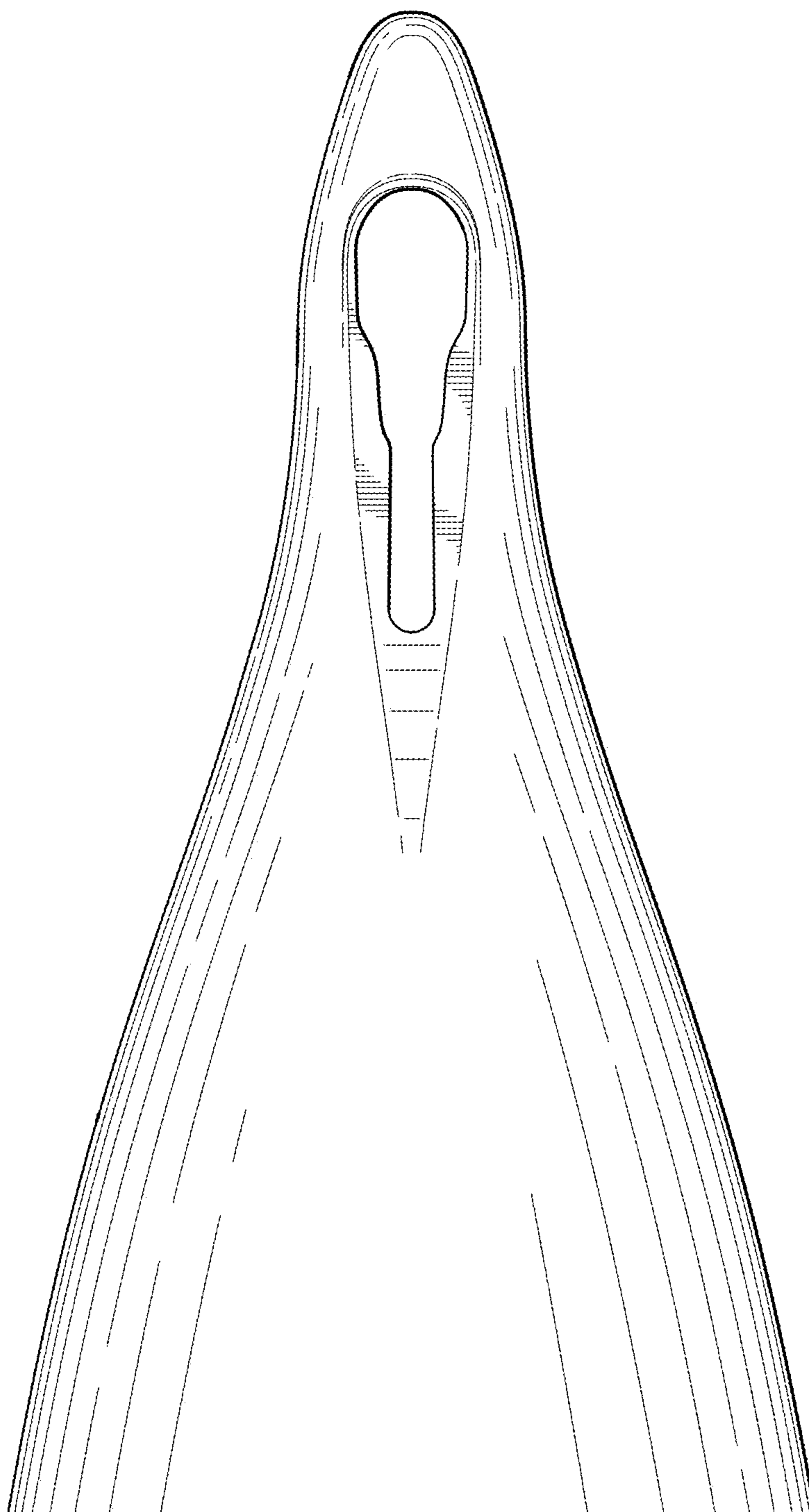

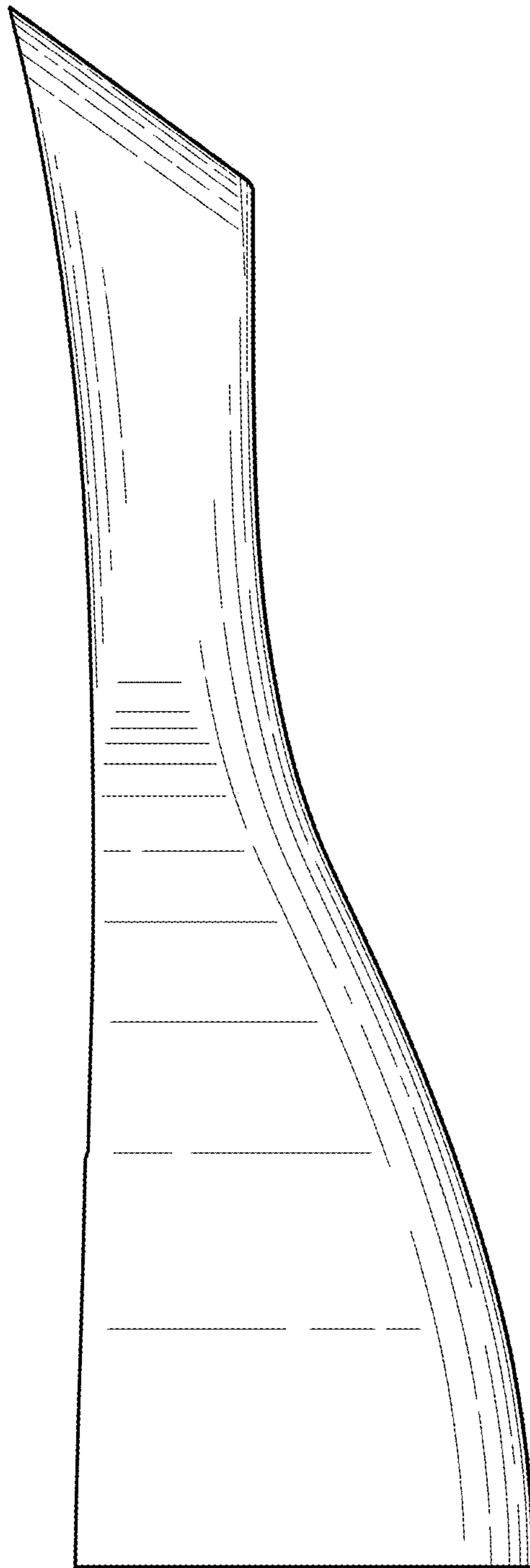

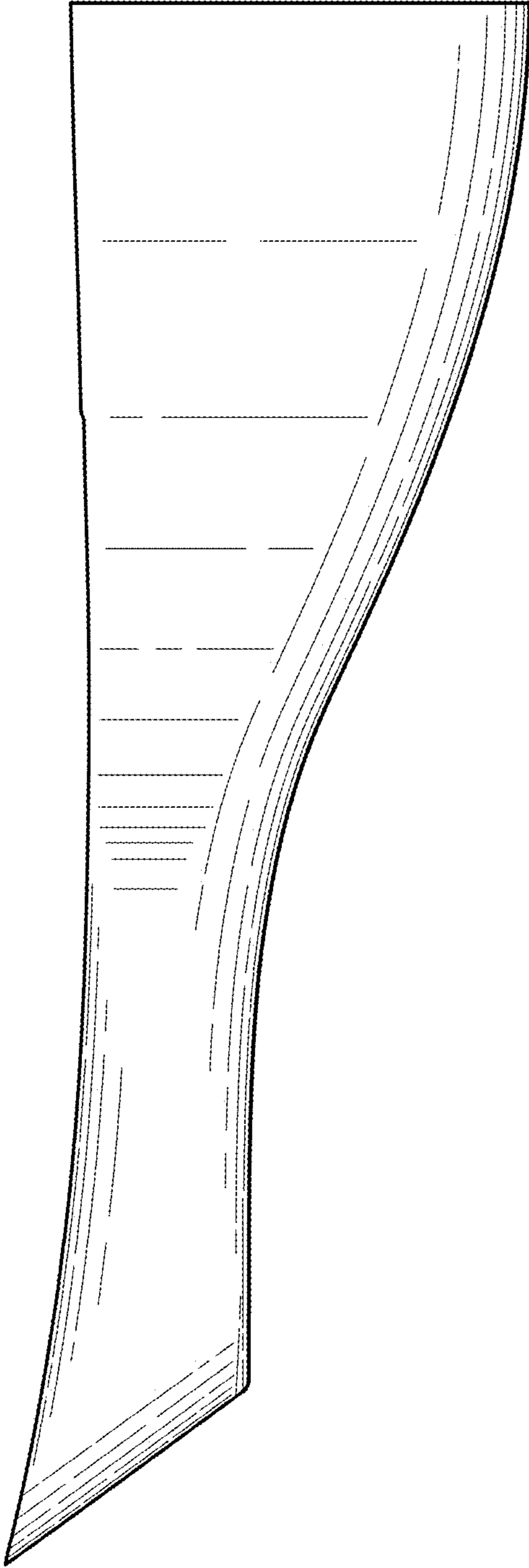
