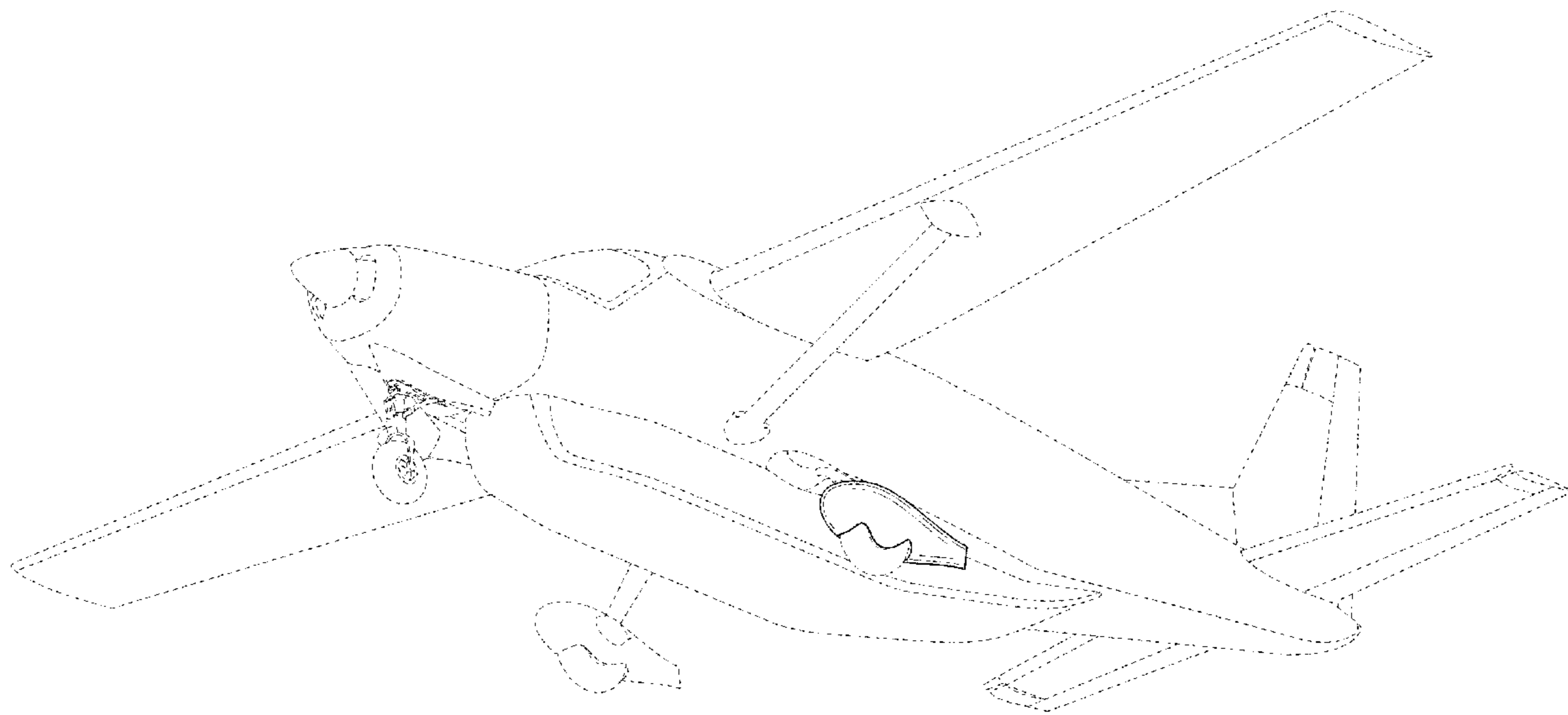
(57) **CLAIM**

DESCRIPTION

FIG. 1 is of a left wheel fairing shown in an environment of
use, in accordance with the present design;
FIG. 2 is a front view of the left wheel fairing shown in FIG.
1, removed from an environment of use for clarity of
disclosure;
FIG. 3 is a back view of the left wheel fairing shown in FIG.
2;

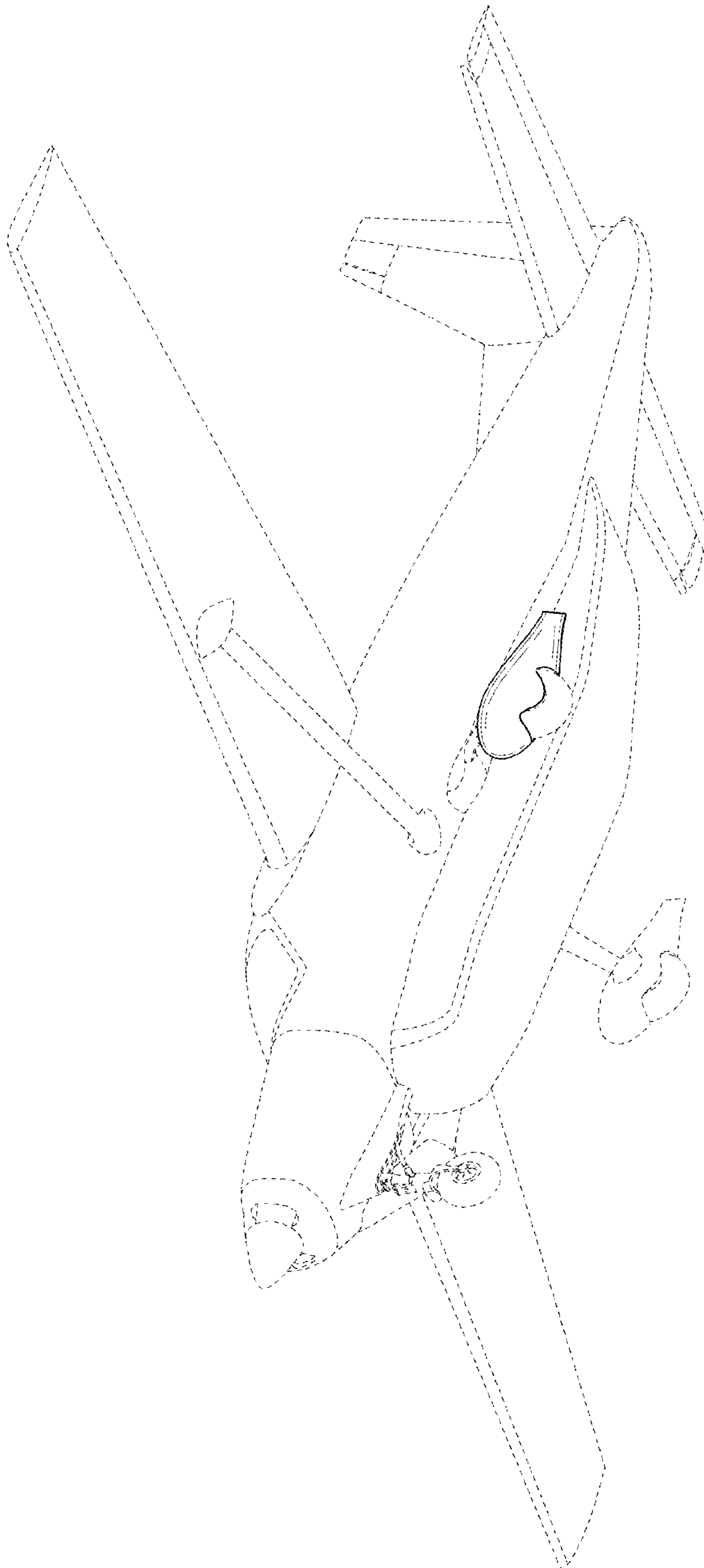

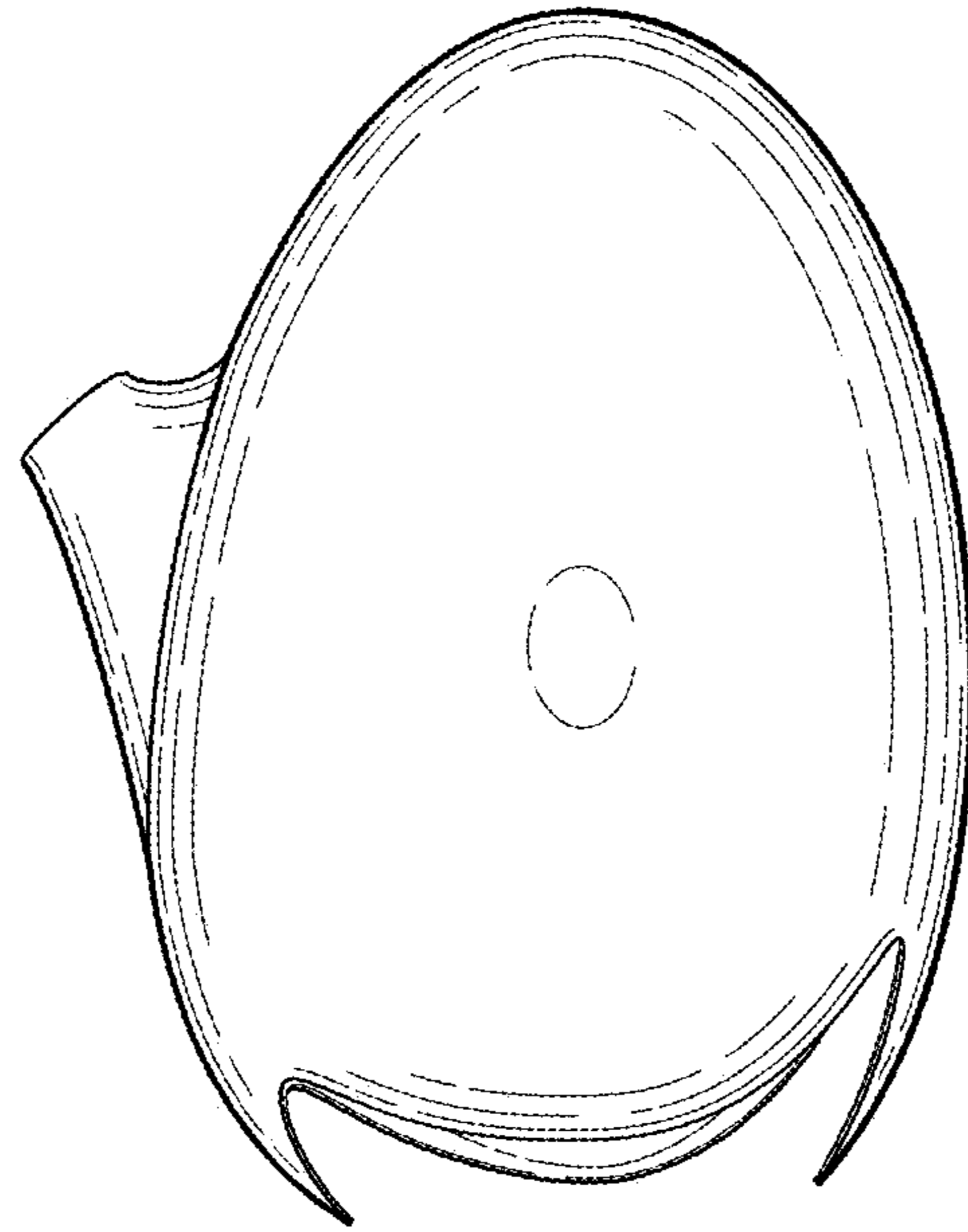

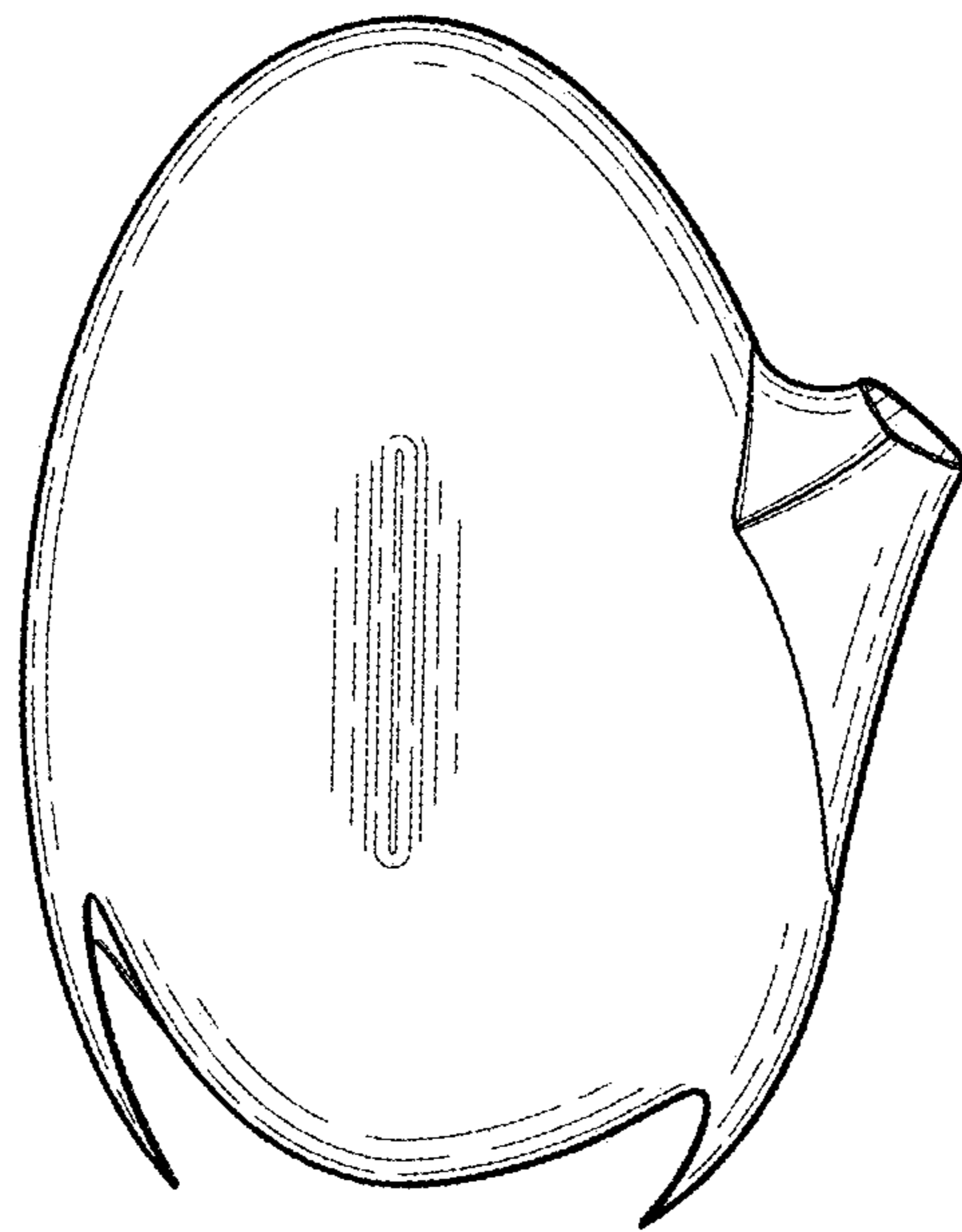

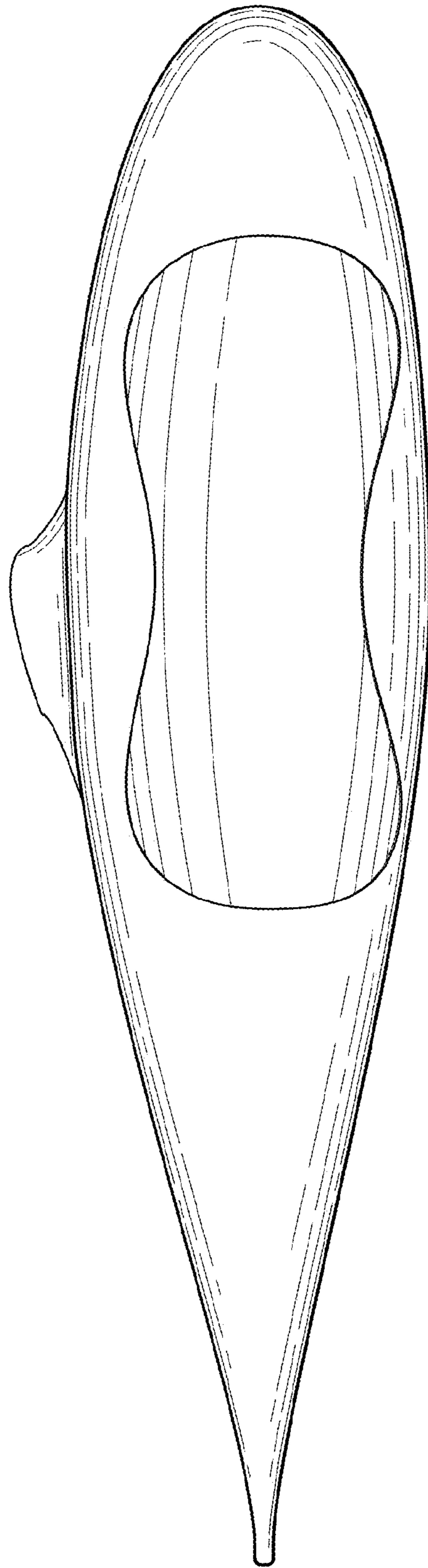

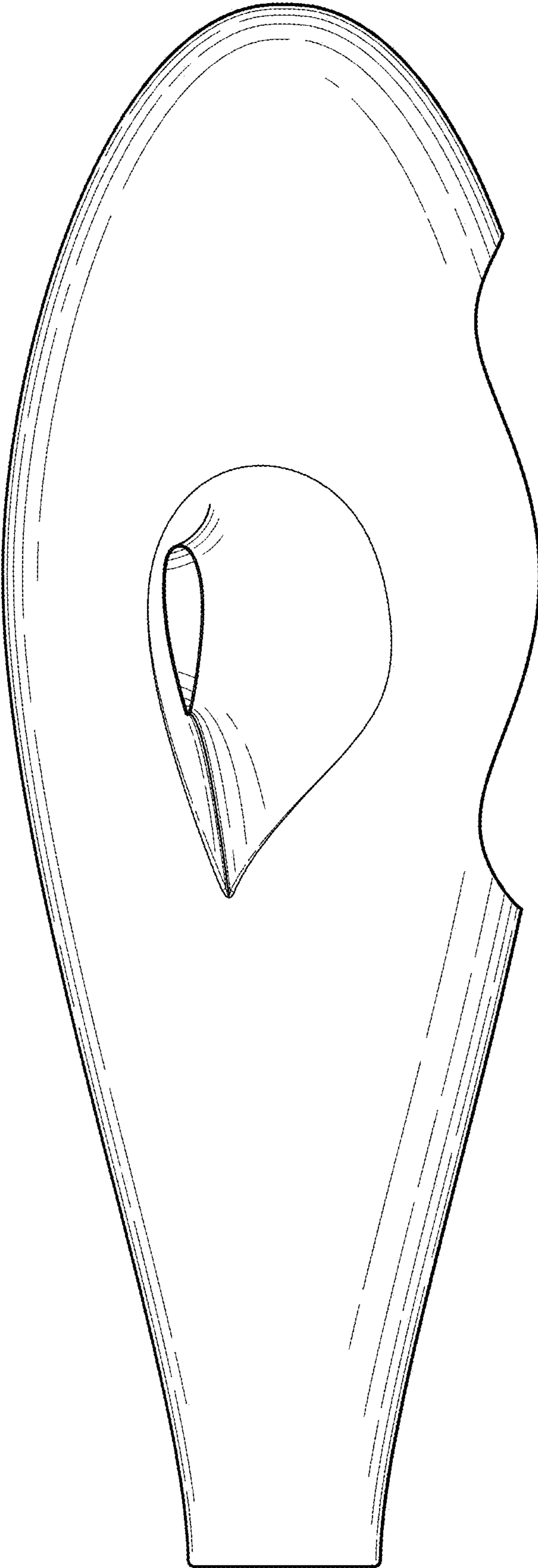

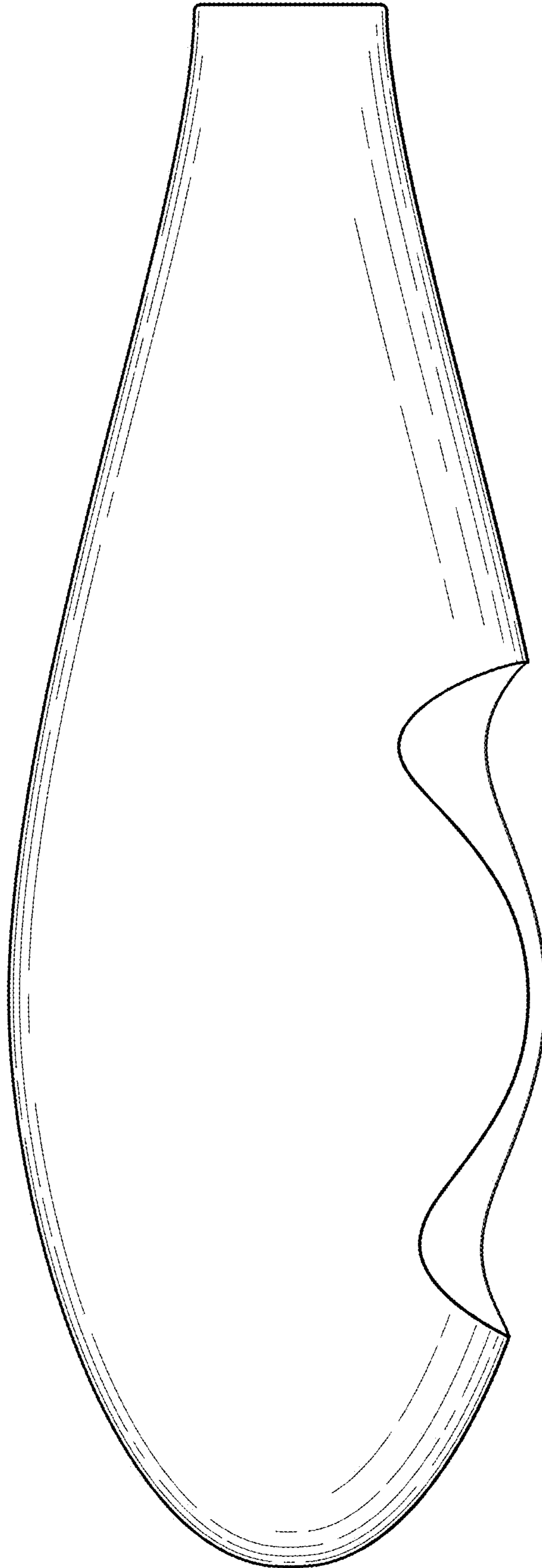
