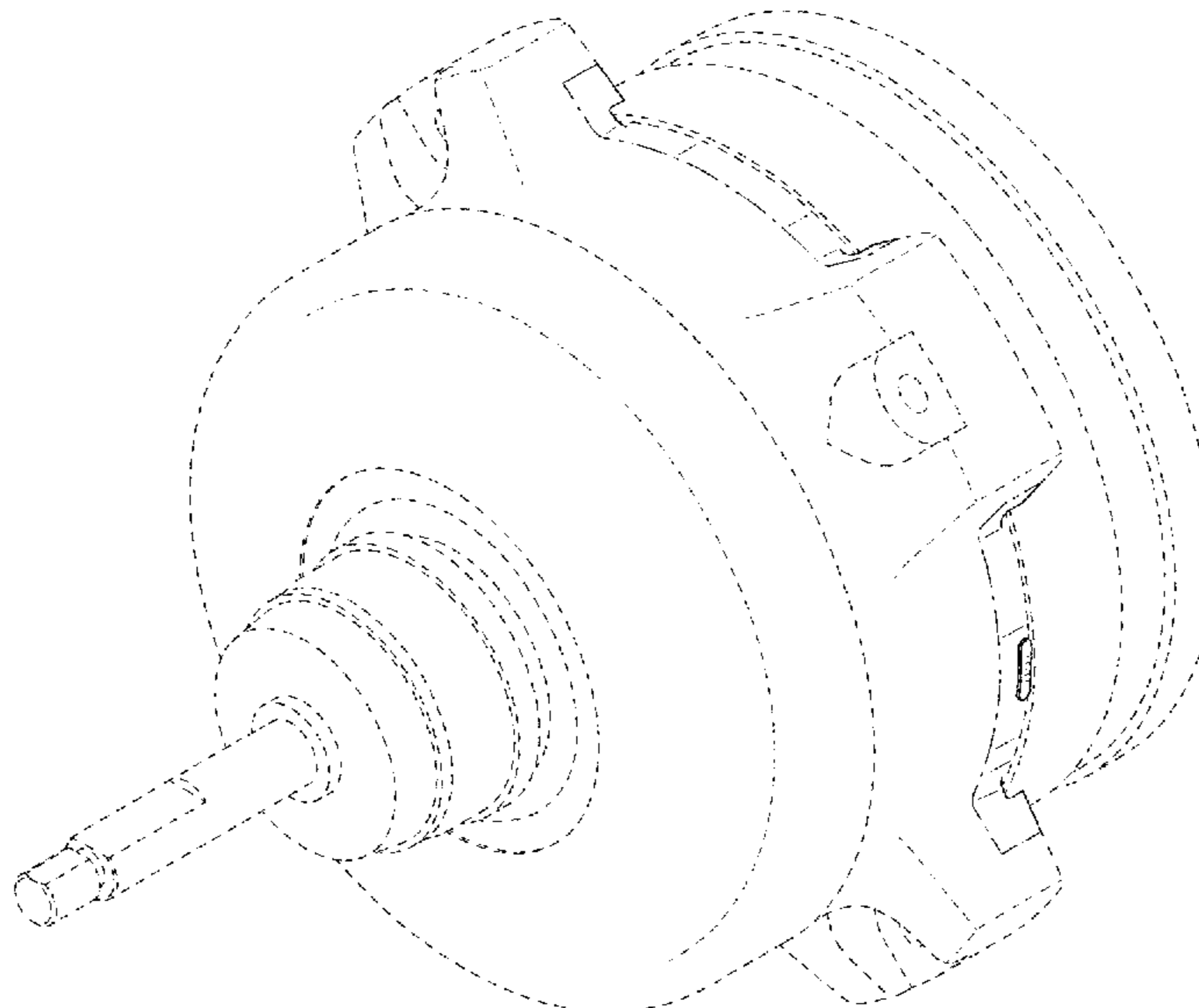
FIG. 10 is an end view of the sectioned part taken along the line 10-10 in FIG. 6;

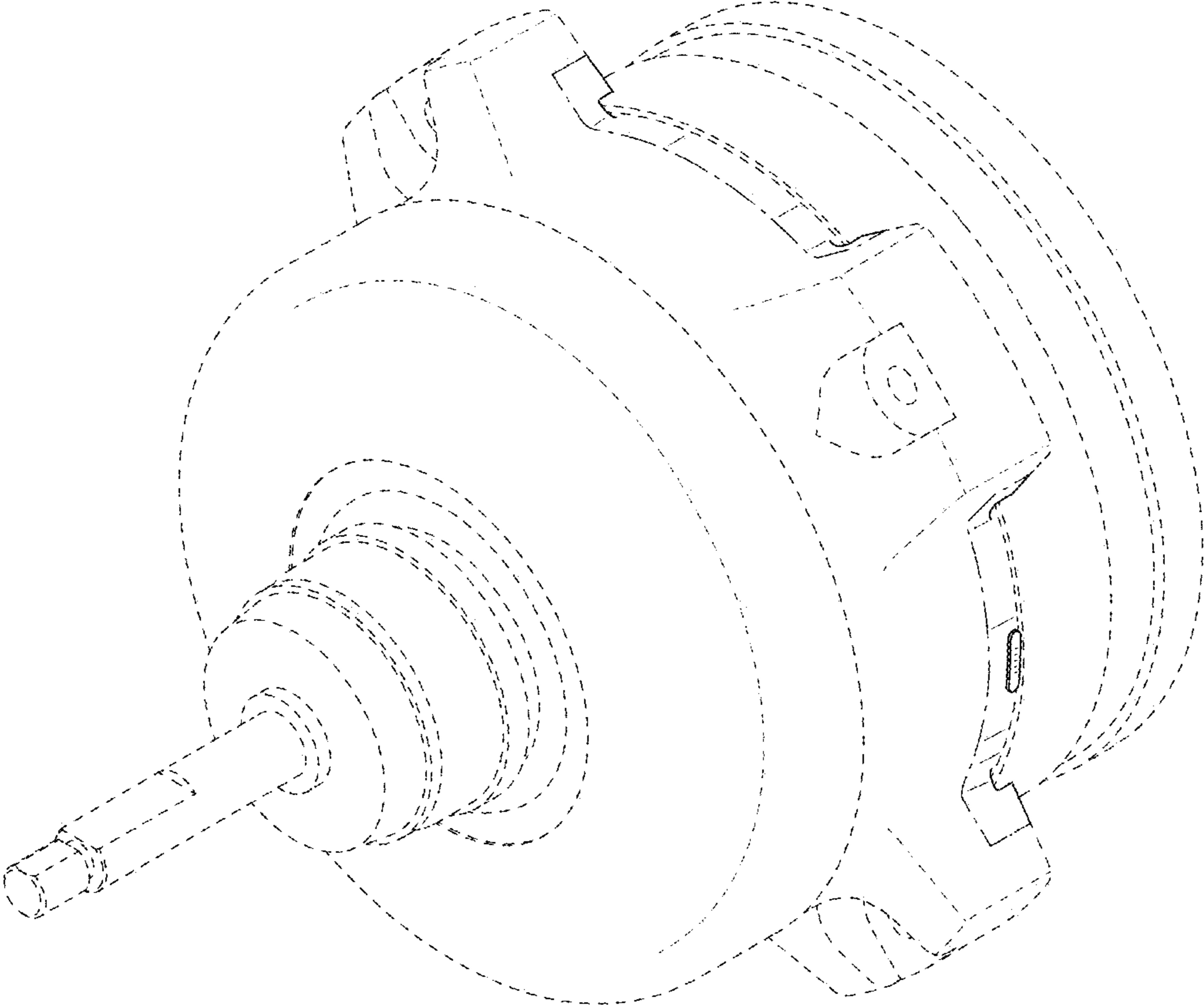

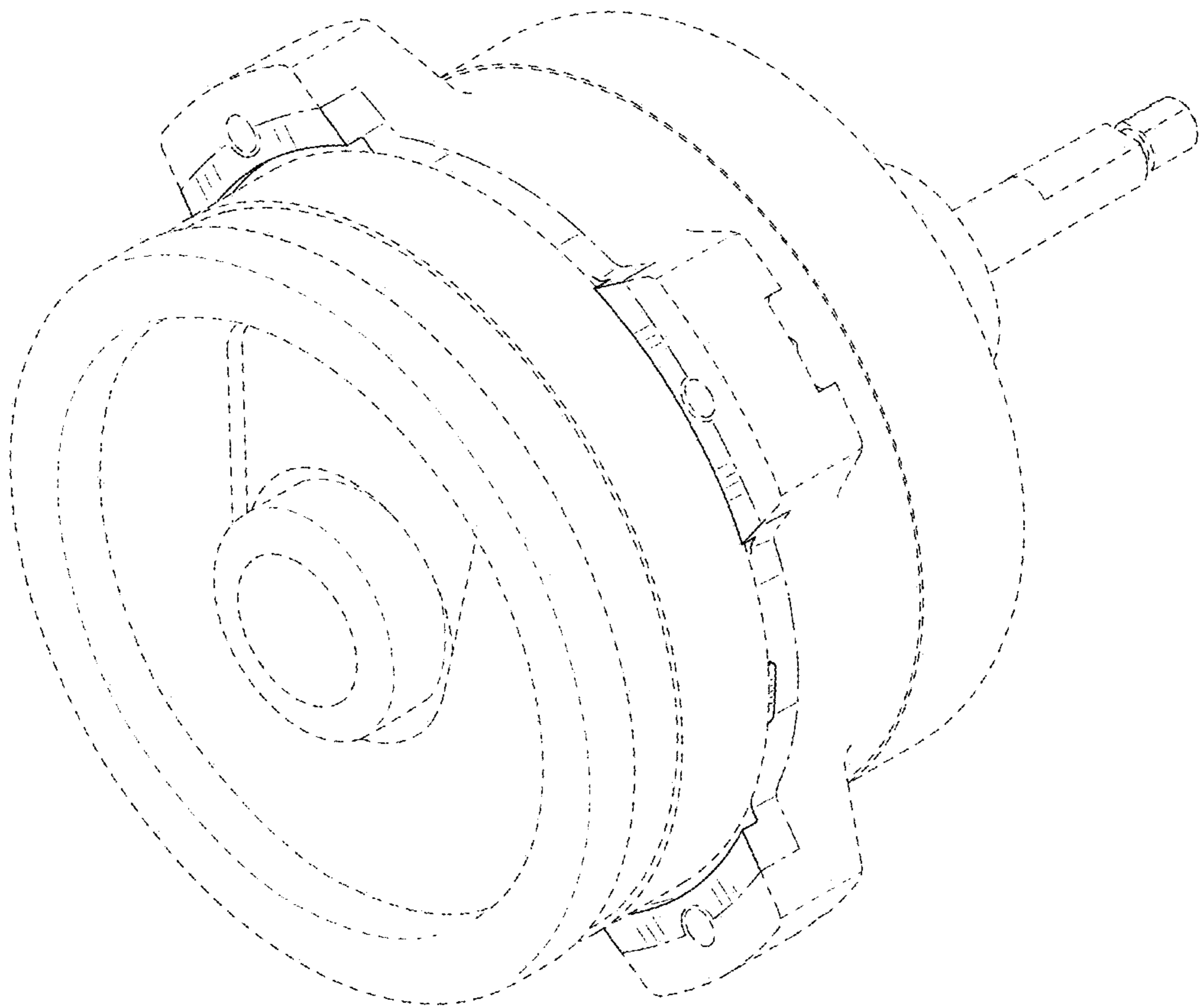

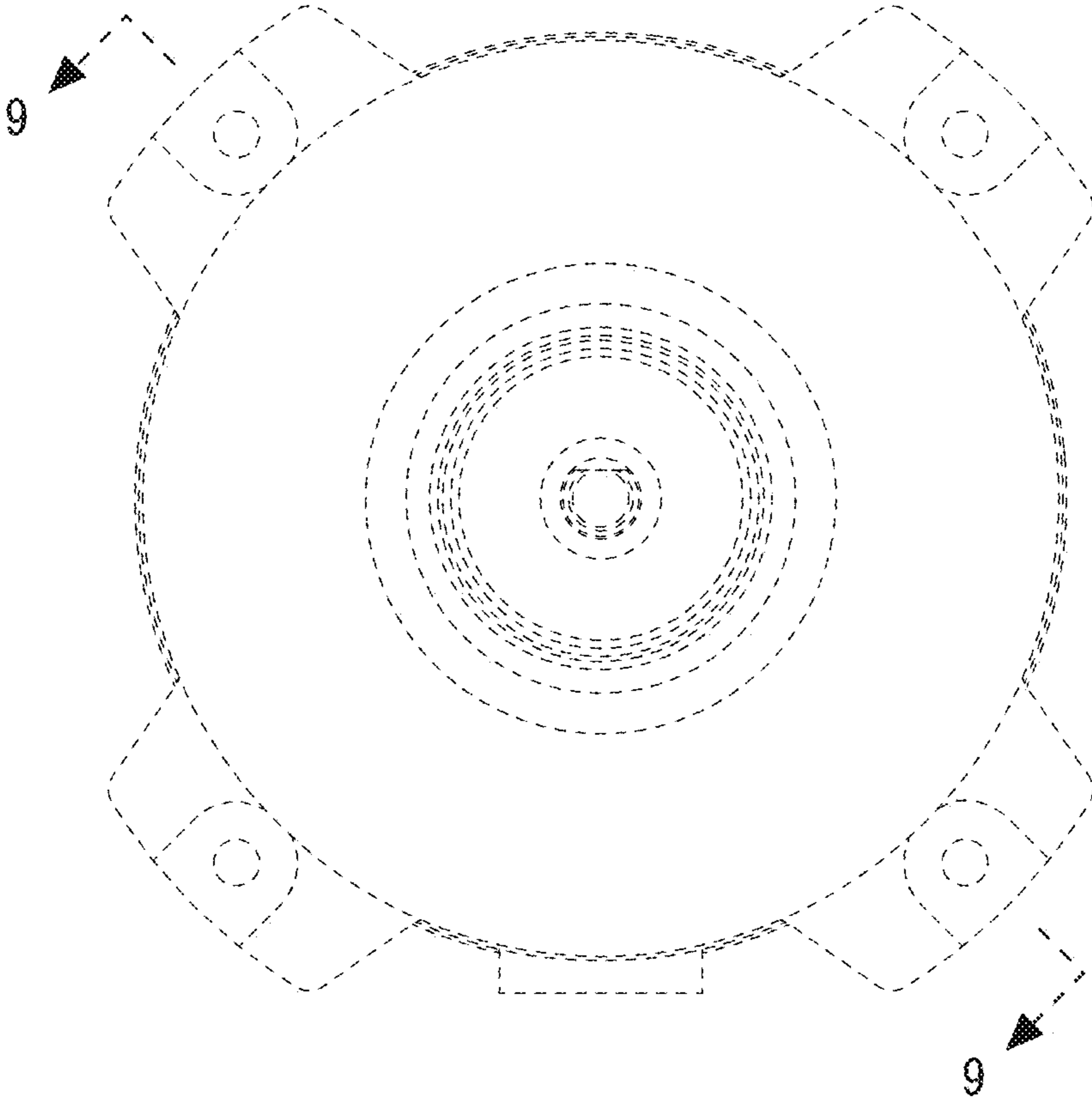

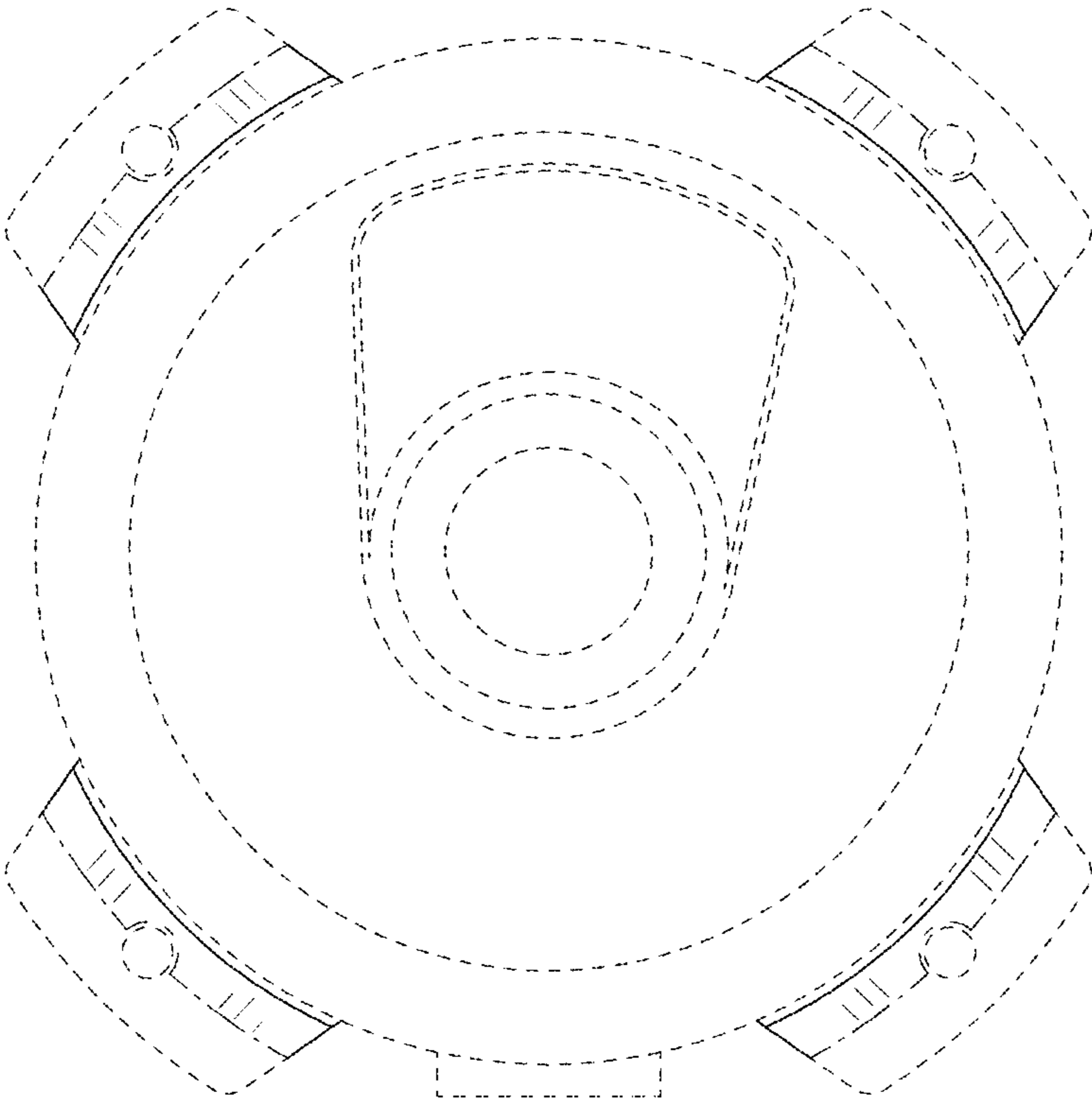

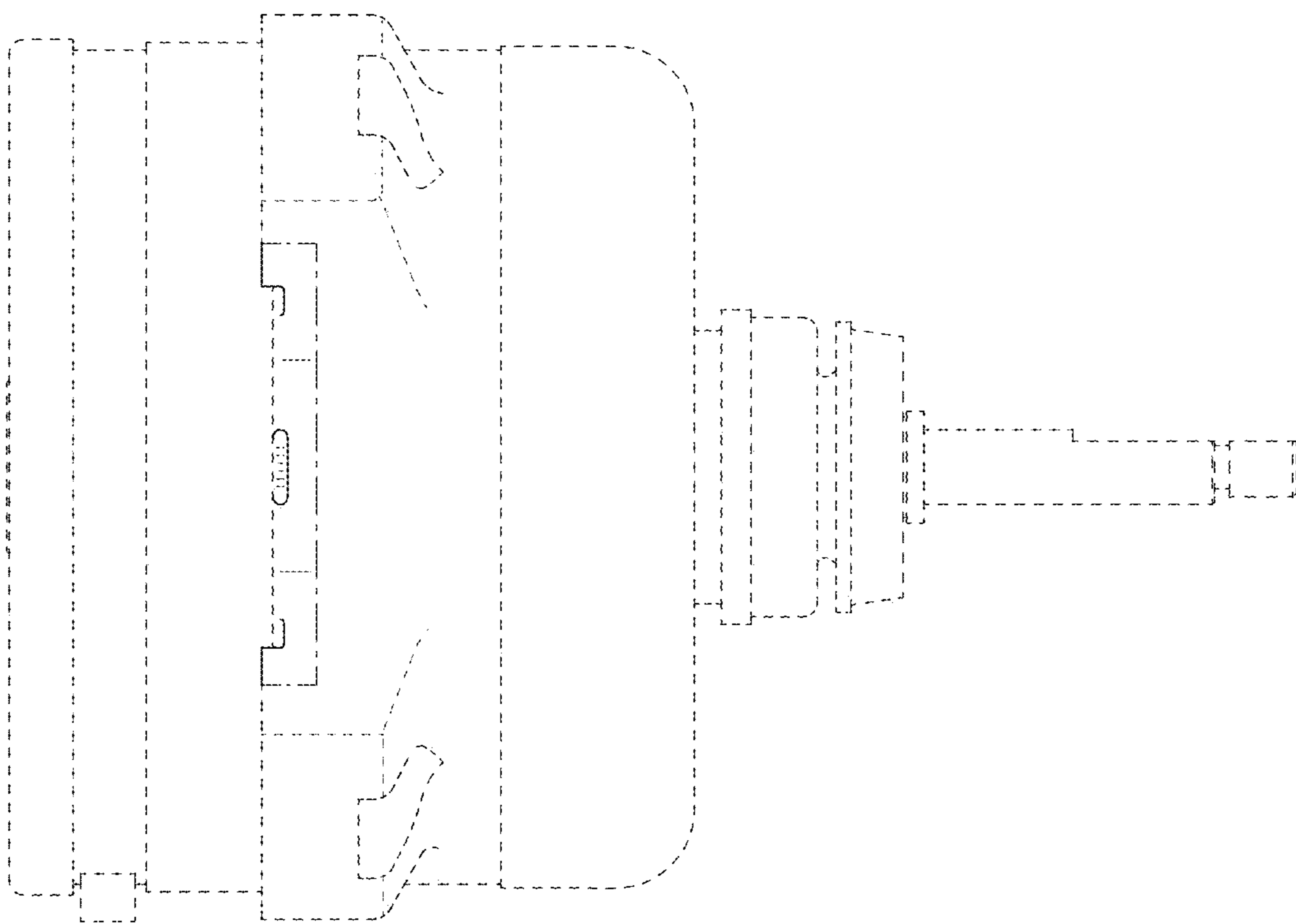

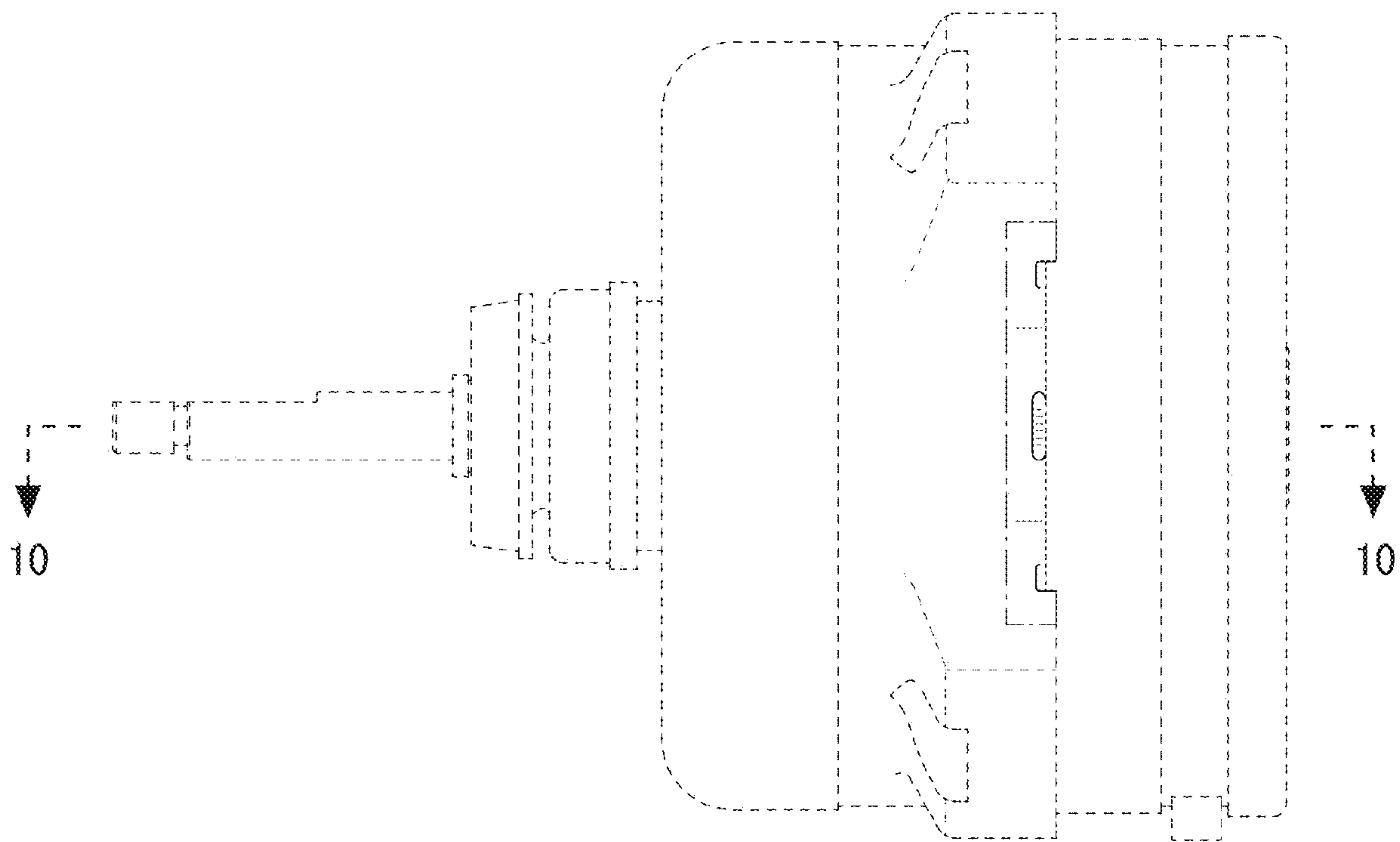

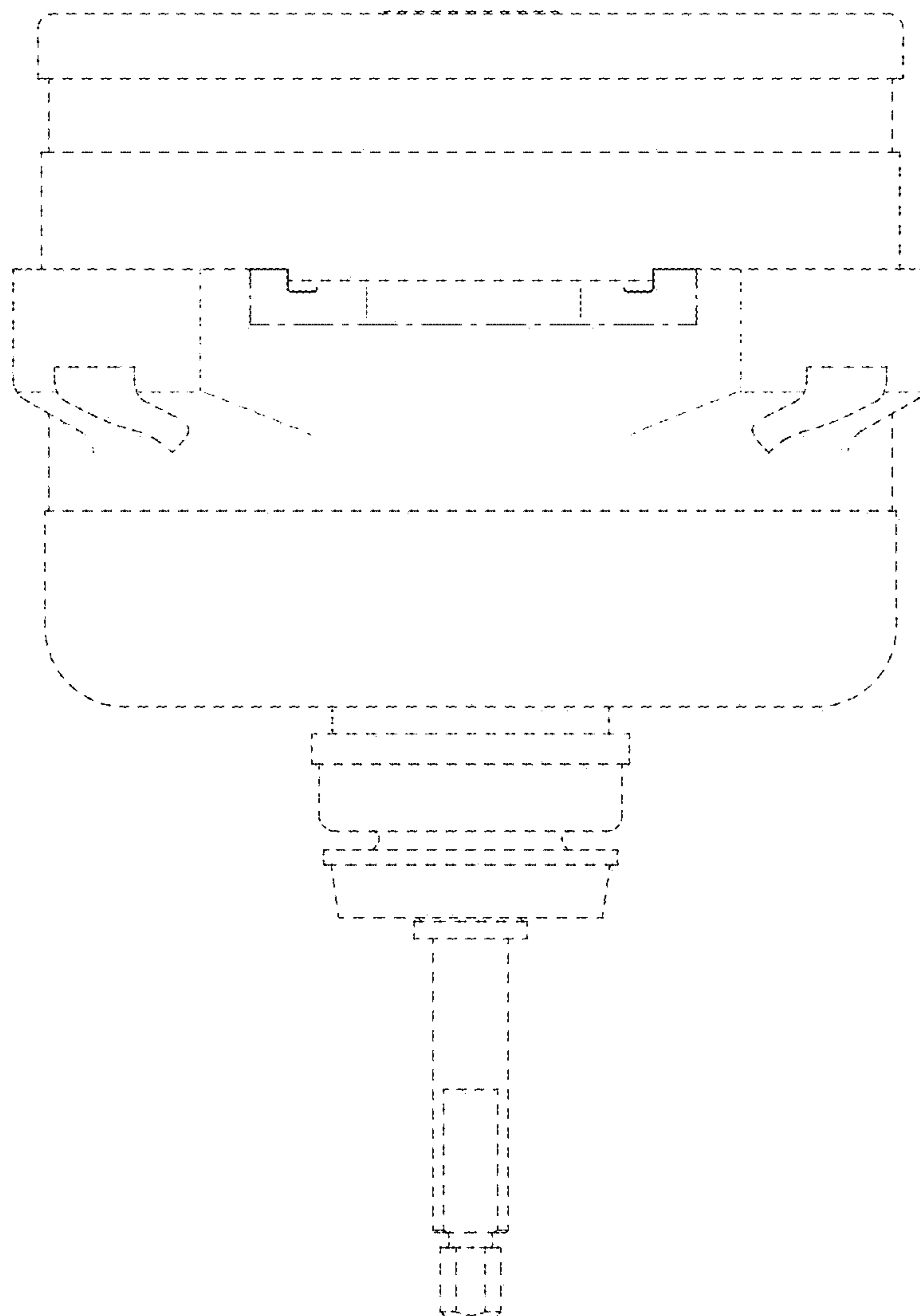

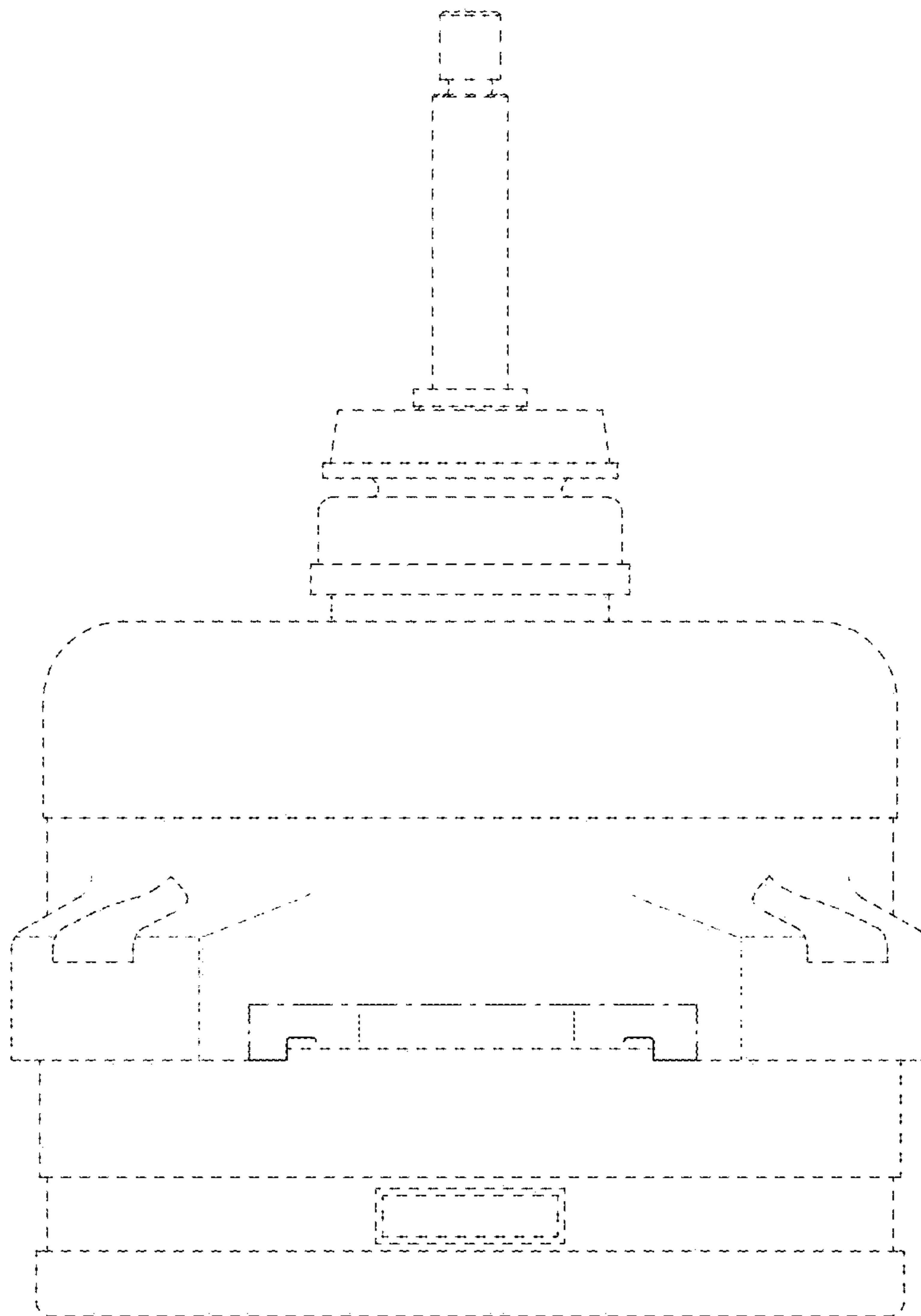

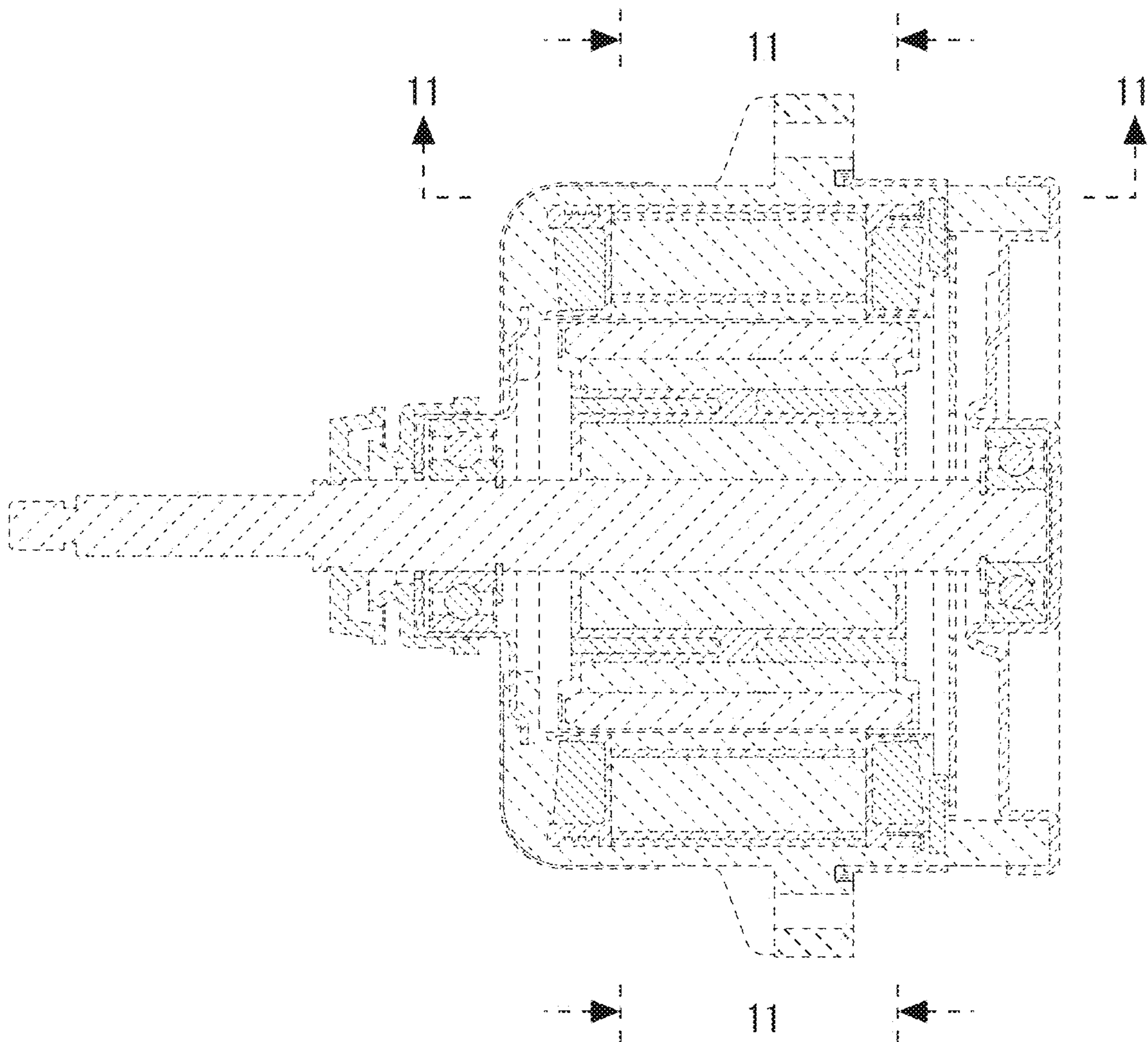

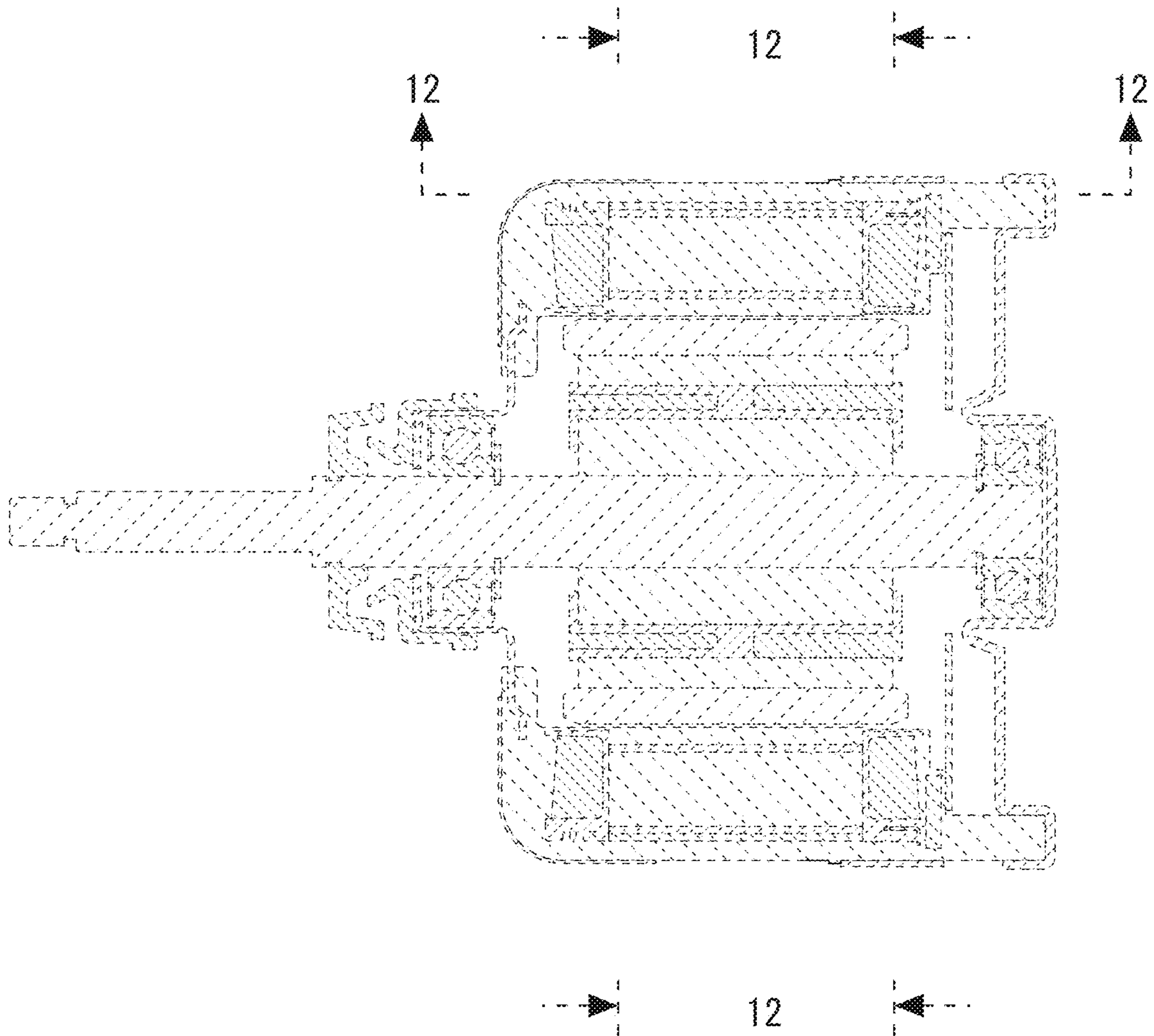

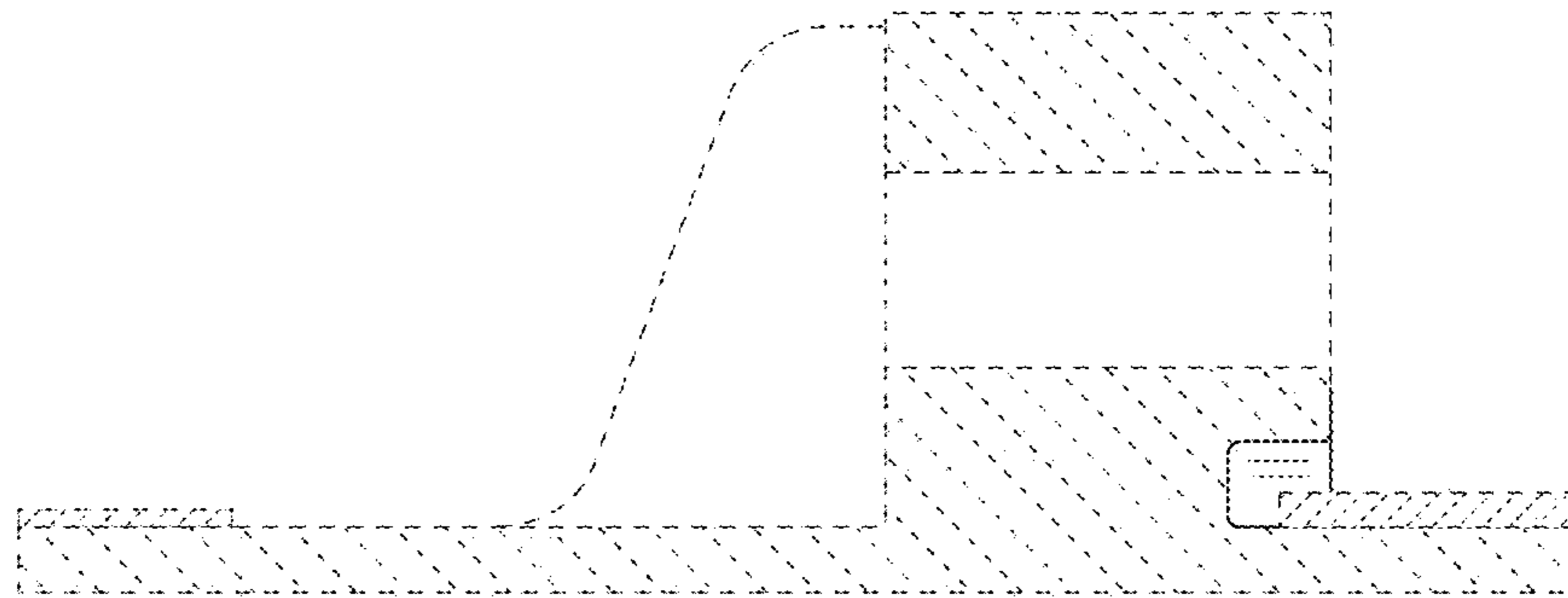
