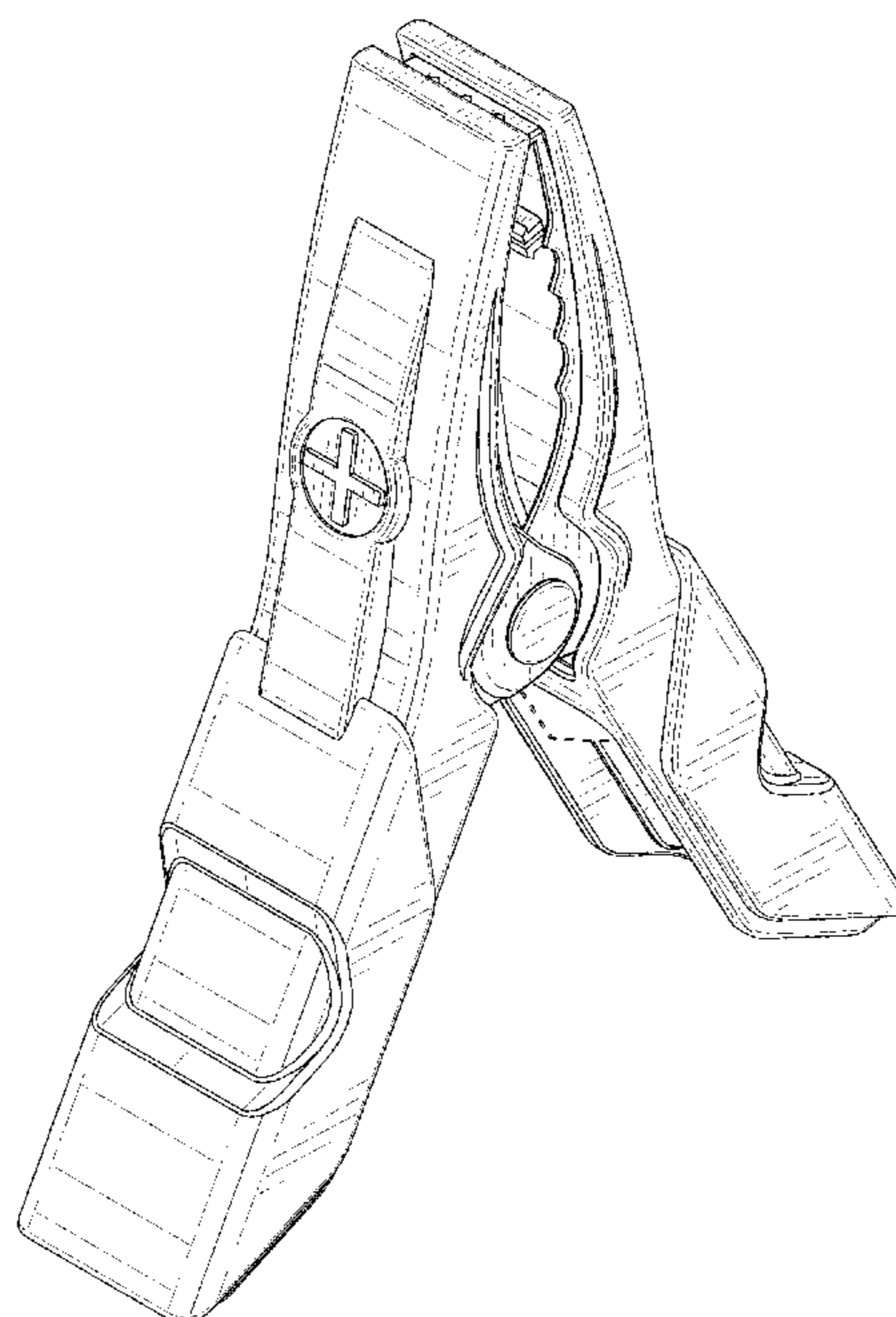

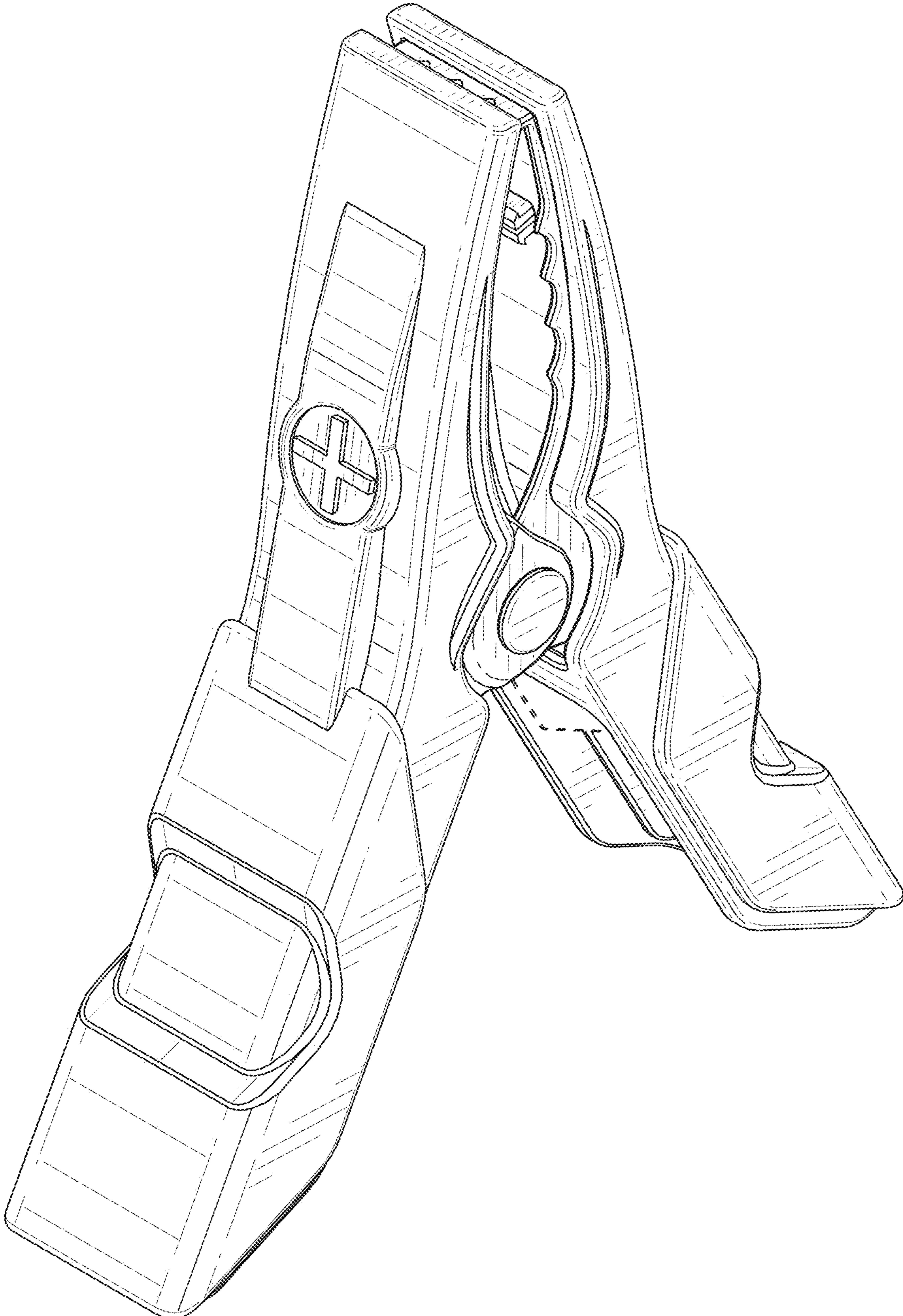
The ornamental design for a battery clamp, as shown and described.

**DESCRIPTION**

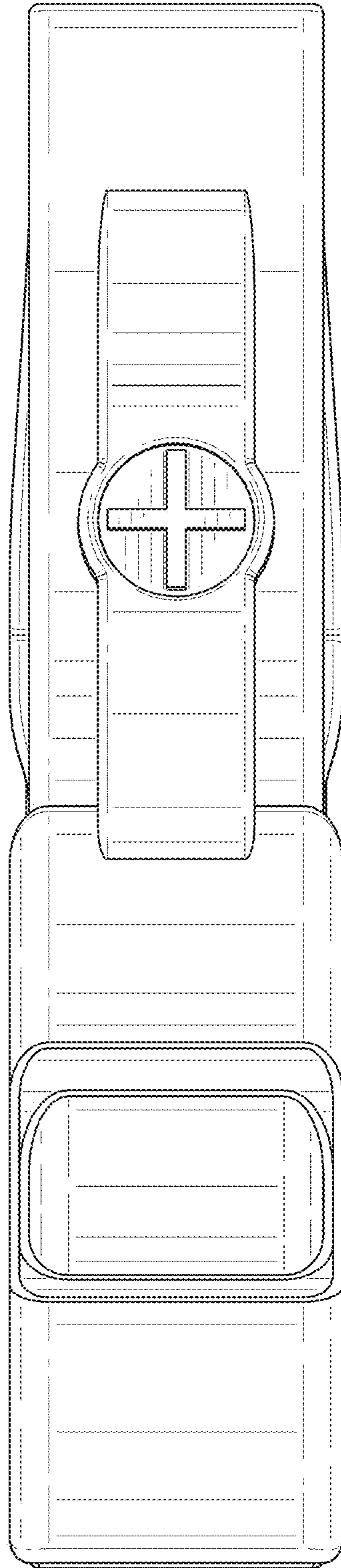
FIG. 1 is a front perspective view of a new design for a battery clamp;

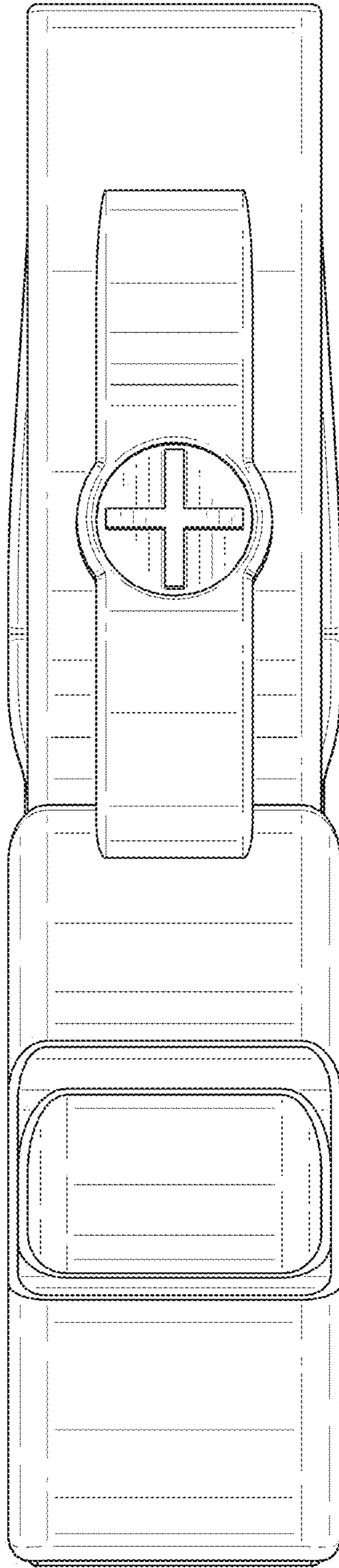




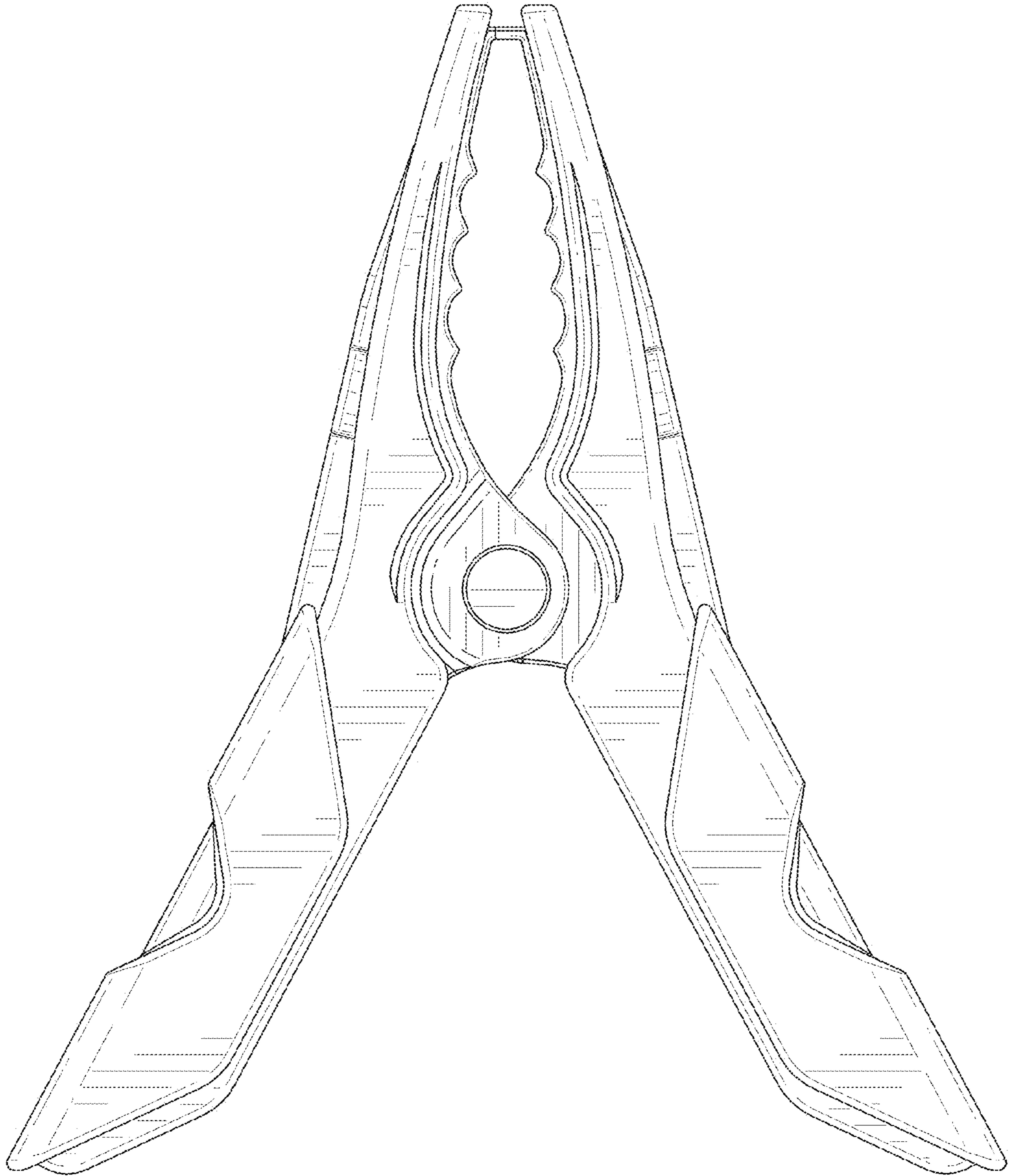

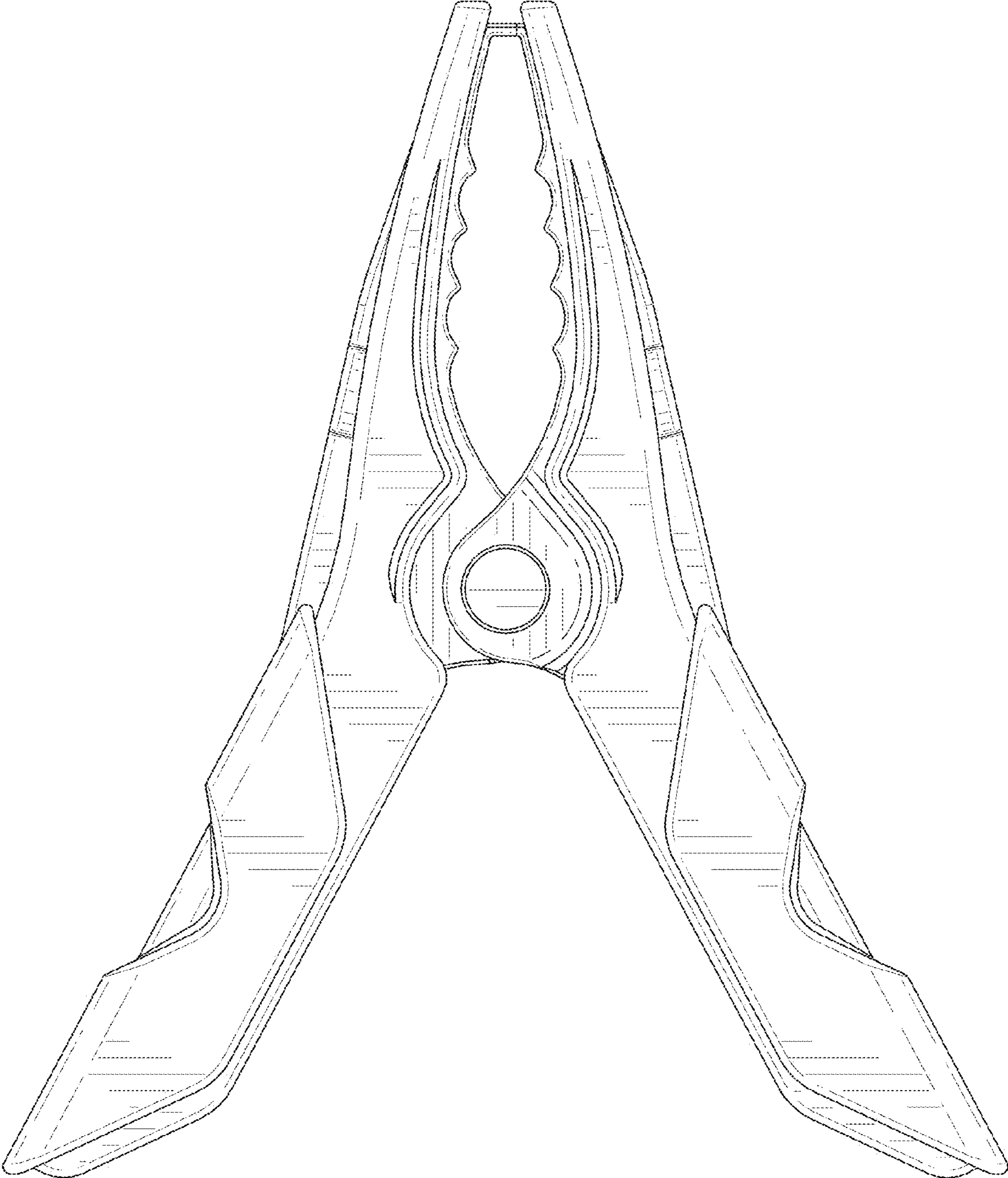

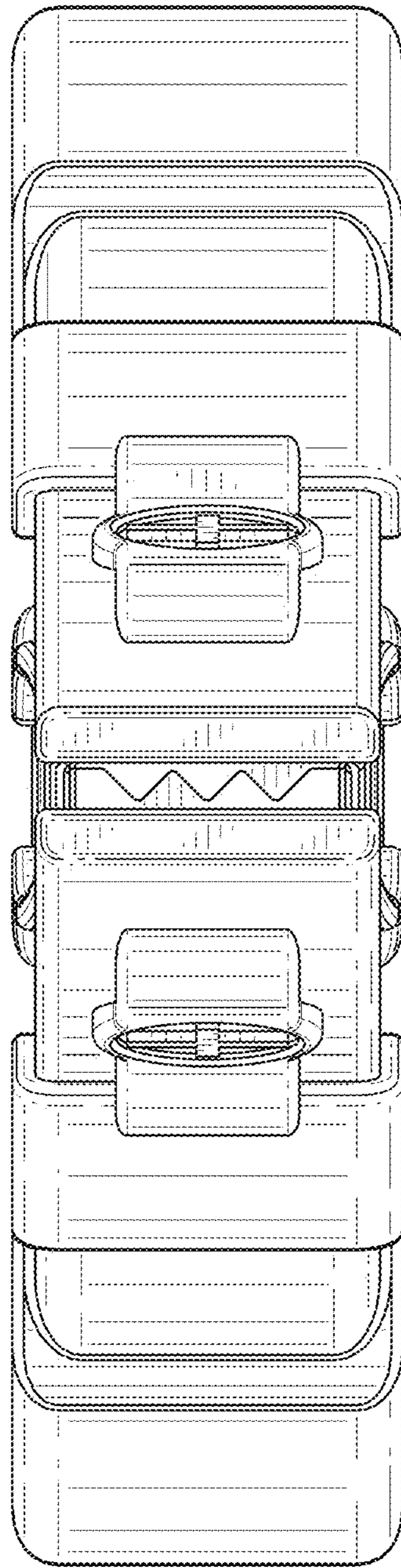

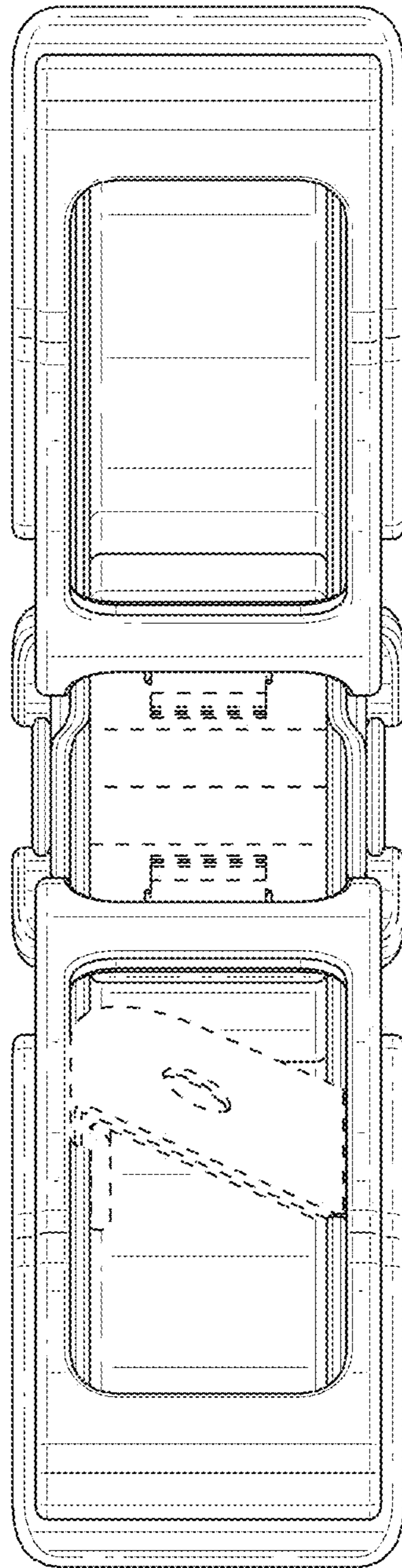
