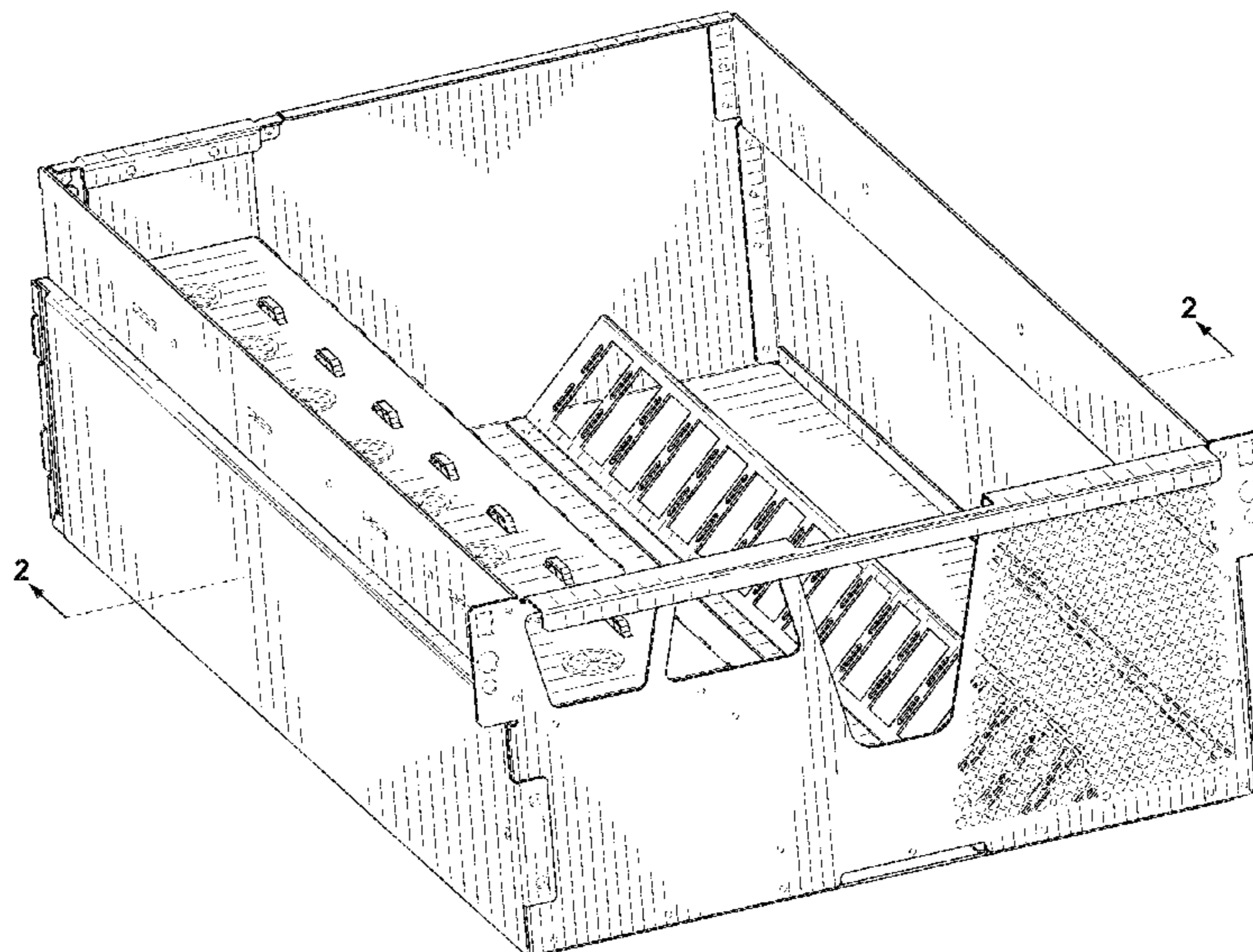
(57) **CLAIM**

The ornamental design for a server rack shelf, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left side perspective view of a server rack shelf showing our new design;  
FIG. 2 is a cross sectional front left side perspective view thereof taken along section line 2-2 from FIG. 1;  
FIG. 3 front right side perspective view thereof;  
FIG. 4 is a cross sectional front right side perspective view thereof taken along section line 4-4 from FIG. 3;  
FIG. 5 is another front right side perspective view thereof taken from an elevated perspective;  
FIG. 6 is a rear left side perspective view thereof;  
FIG. 7 is a cross sectional rear left side perspective view thereof taken along section line 7-7 from FIG. 6;  
FIG. 8 is a rear right side perspective view thereof;  
FIG. 9 is a cross sectional rear right side perspective view thereof taken along section line 9-9 from FIG. 8;  
FIG. 10 is a front view thereof;  
FIG. 11 is a rear view thereof;  
FIG. 12 is a left side view thereof;  
FIG. 13 is a right side view thereof;  
FIG. 14 is a top plan view thereof;  
FIG. 15 is a bottom plan view thereof;  
FIG. 16 is a right side front perspective view thereof;  
FIG. 17 cross sectional right side front perspective view thereof taken along line 17-17 from FIG. 16;  
FIG. 18 is a left side front perspective view thereof;  
FIG. 19 is a cross sectional left side front perspective view thereof taken along line 19-19 from FIG. 18;  
FIG. 20 is a front right perspective view thereof; and,  
FIG. 21 is a cross sectional front right perspective view thereof taken along line 21-21 from FIG. 20.

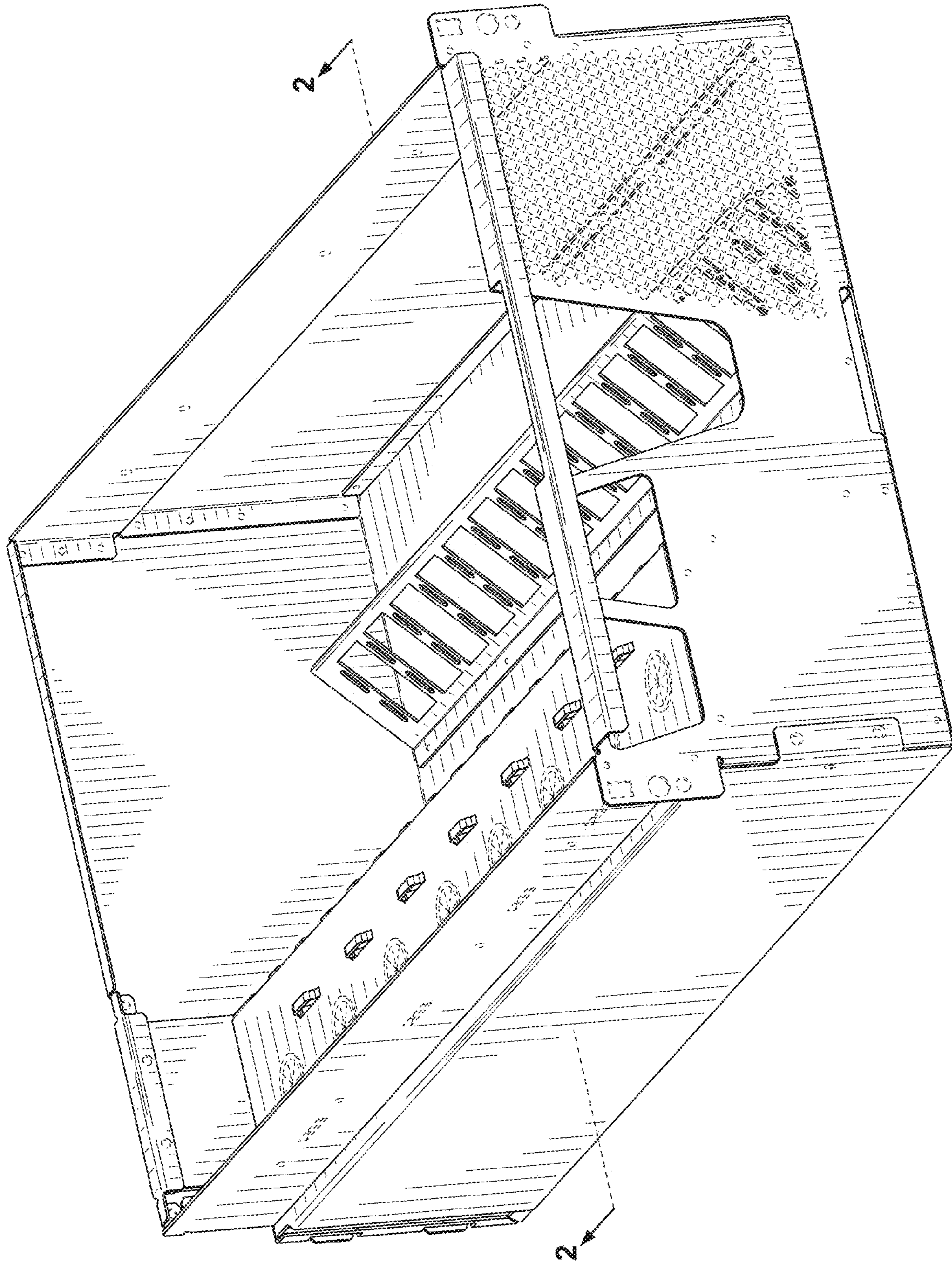

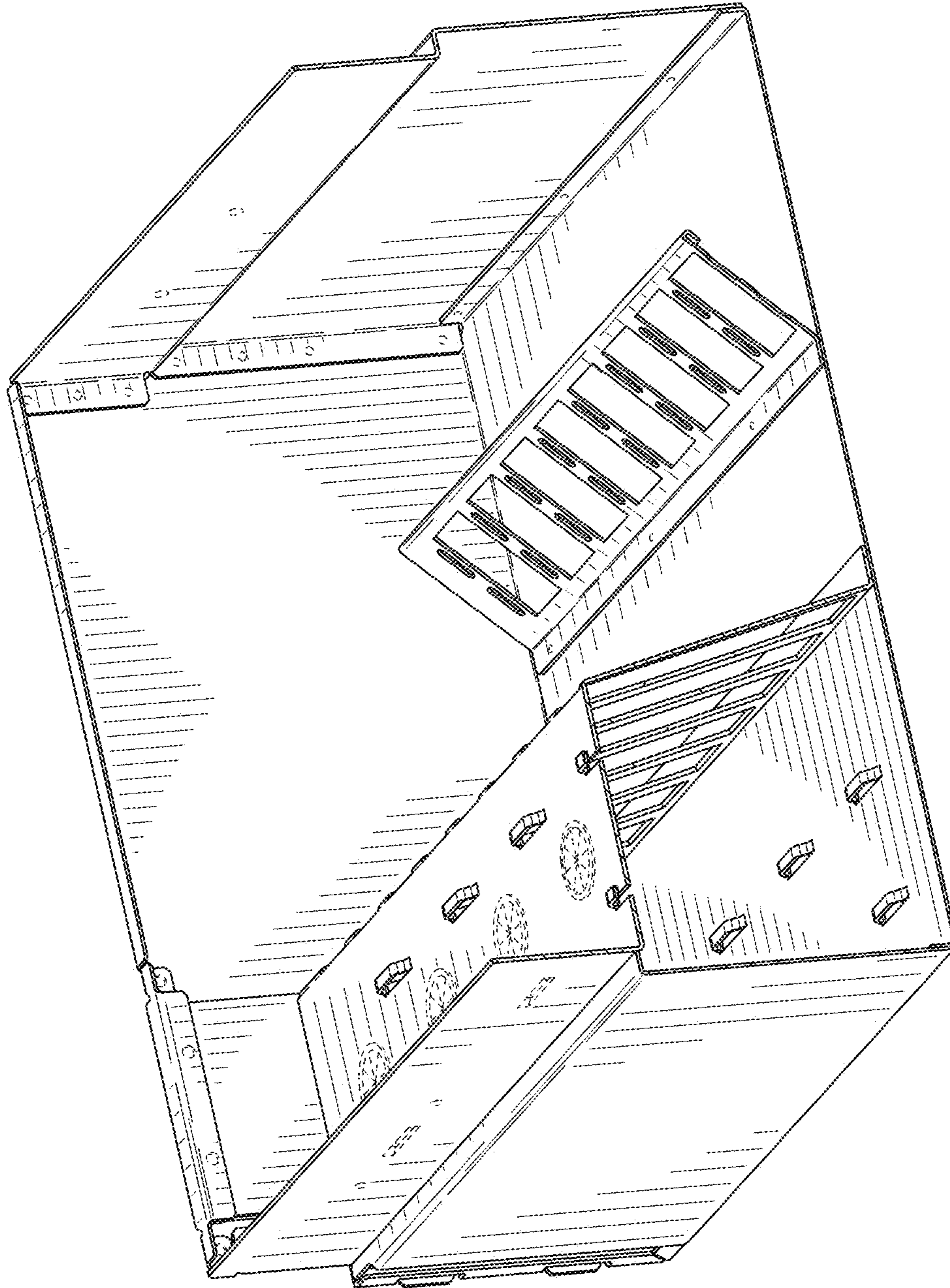

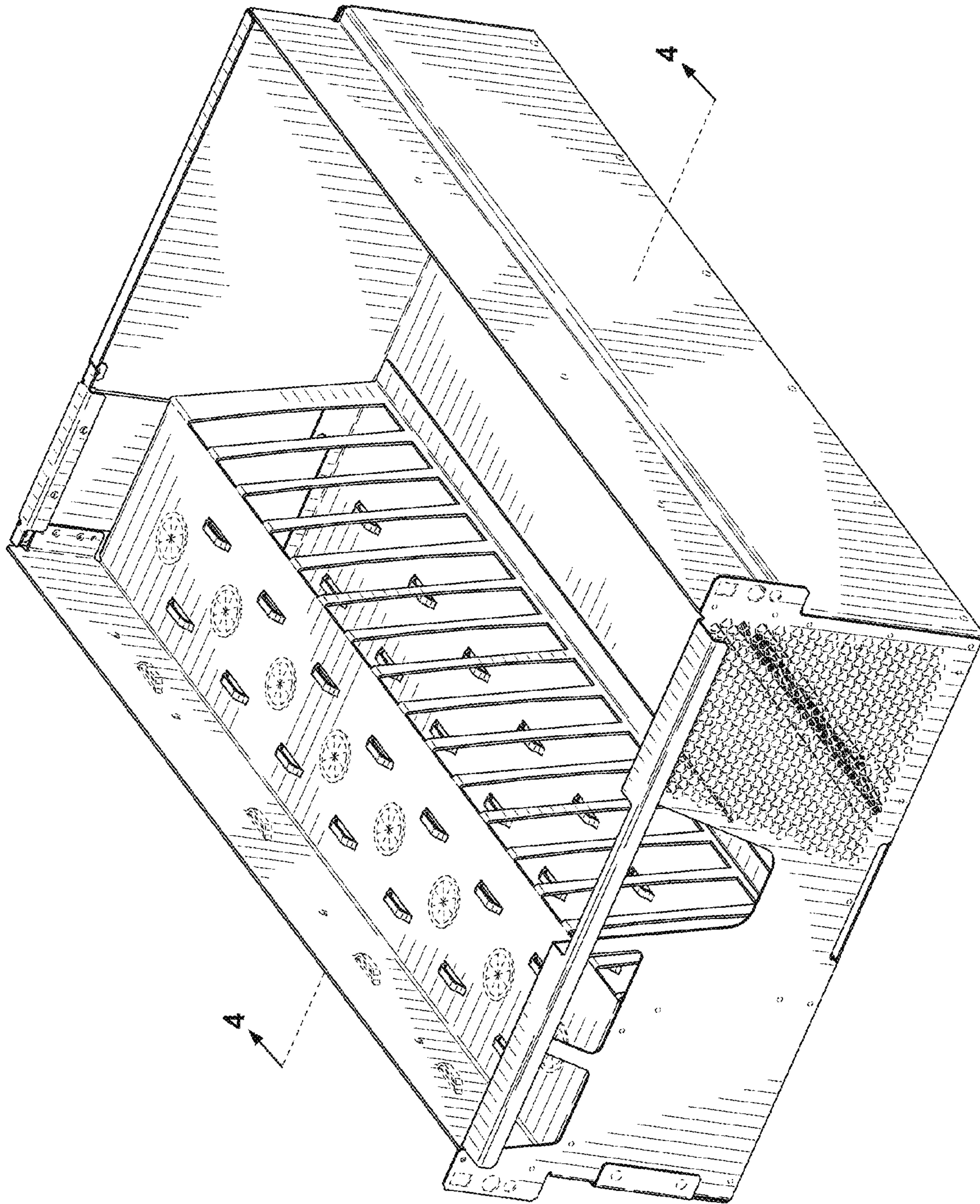

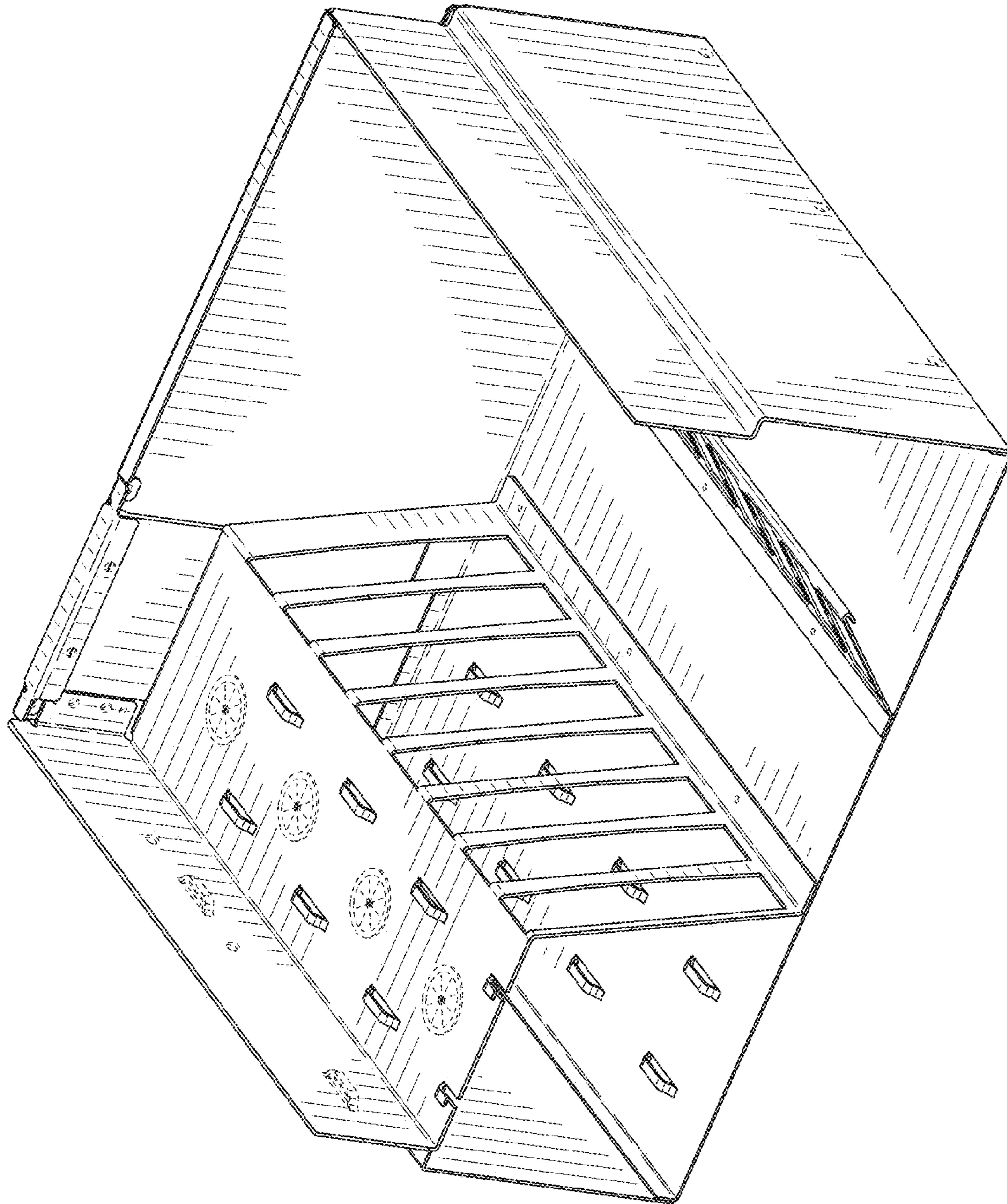

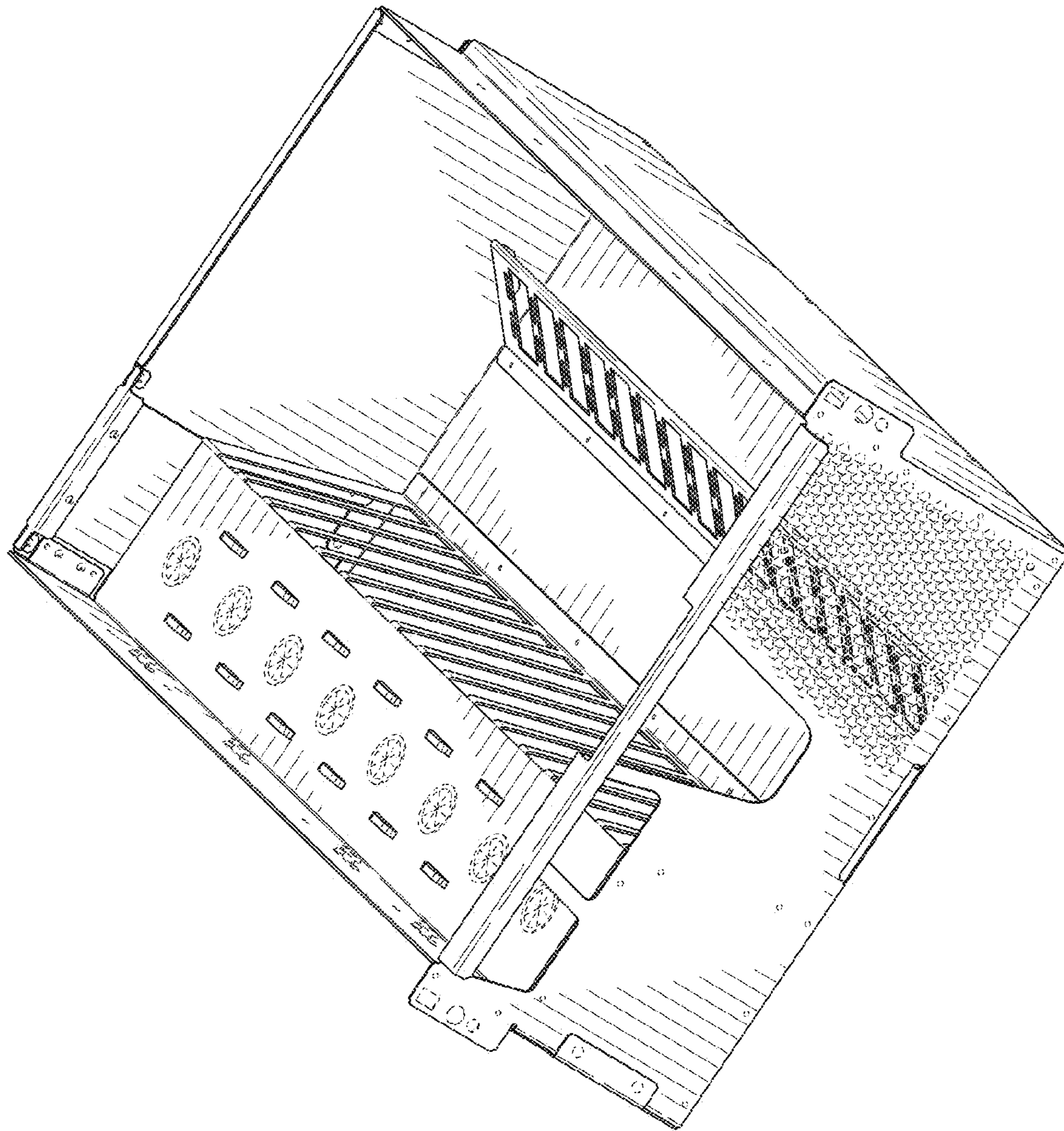

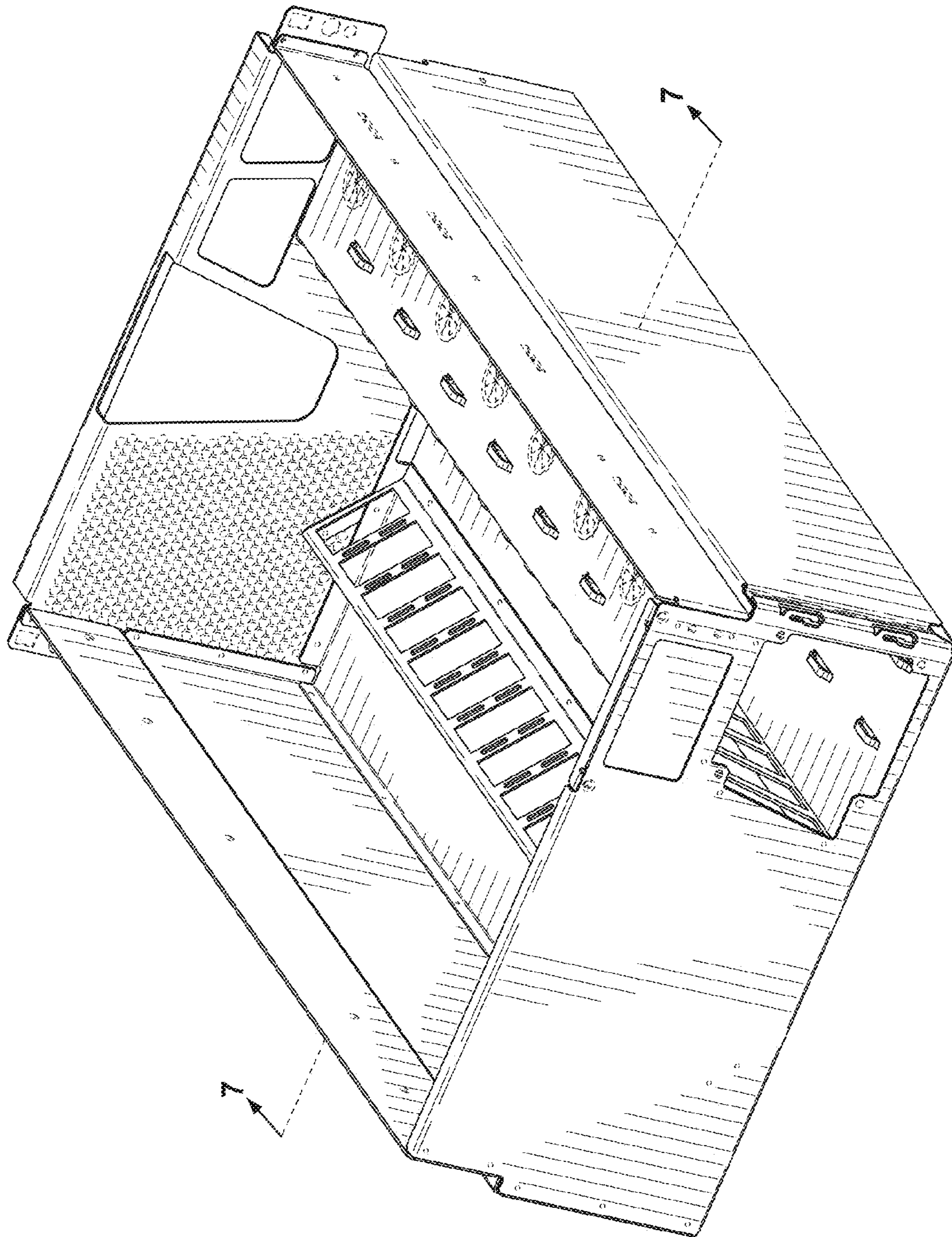

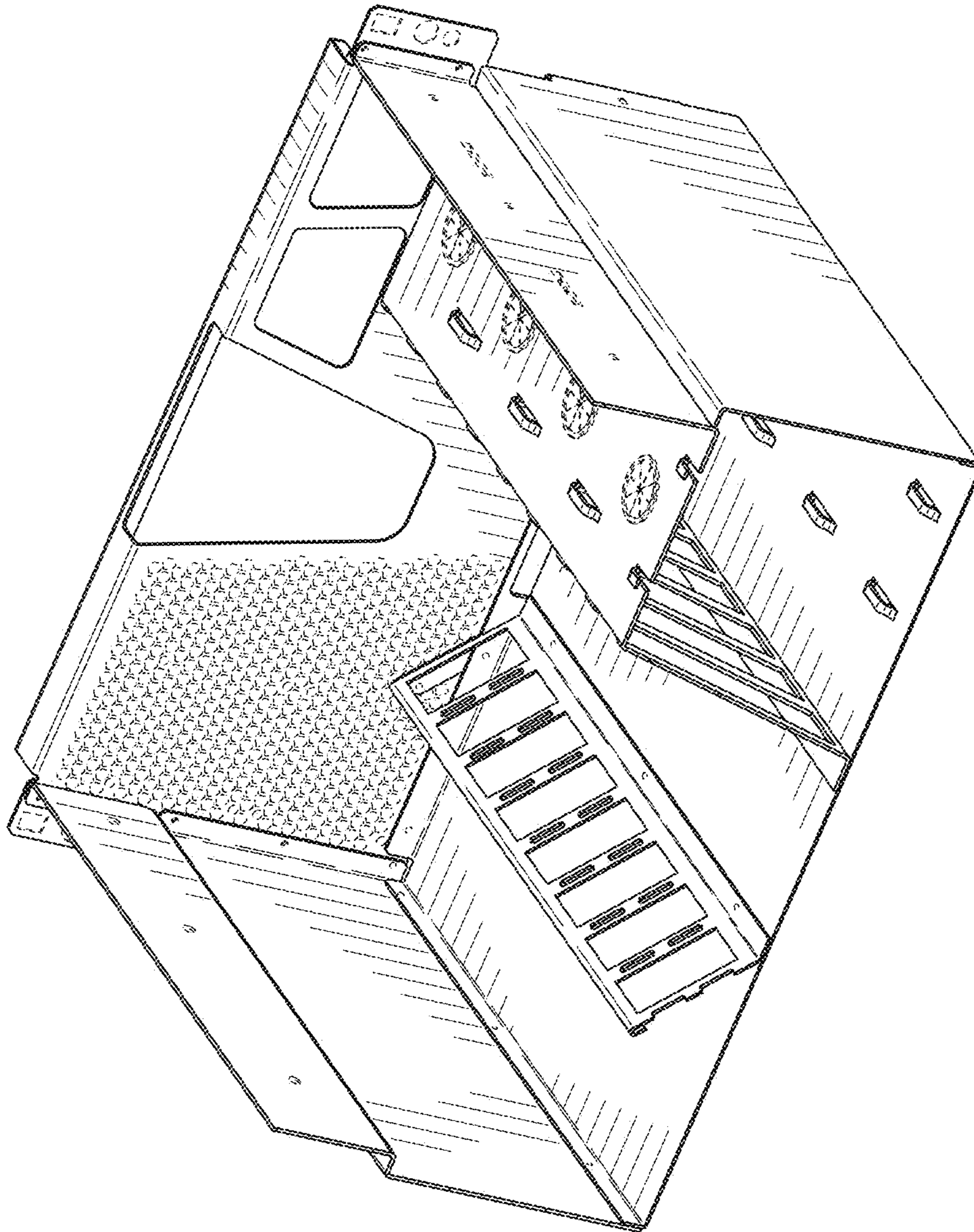

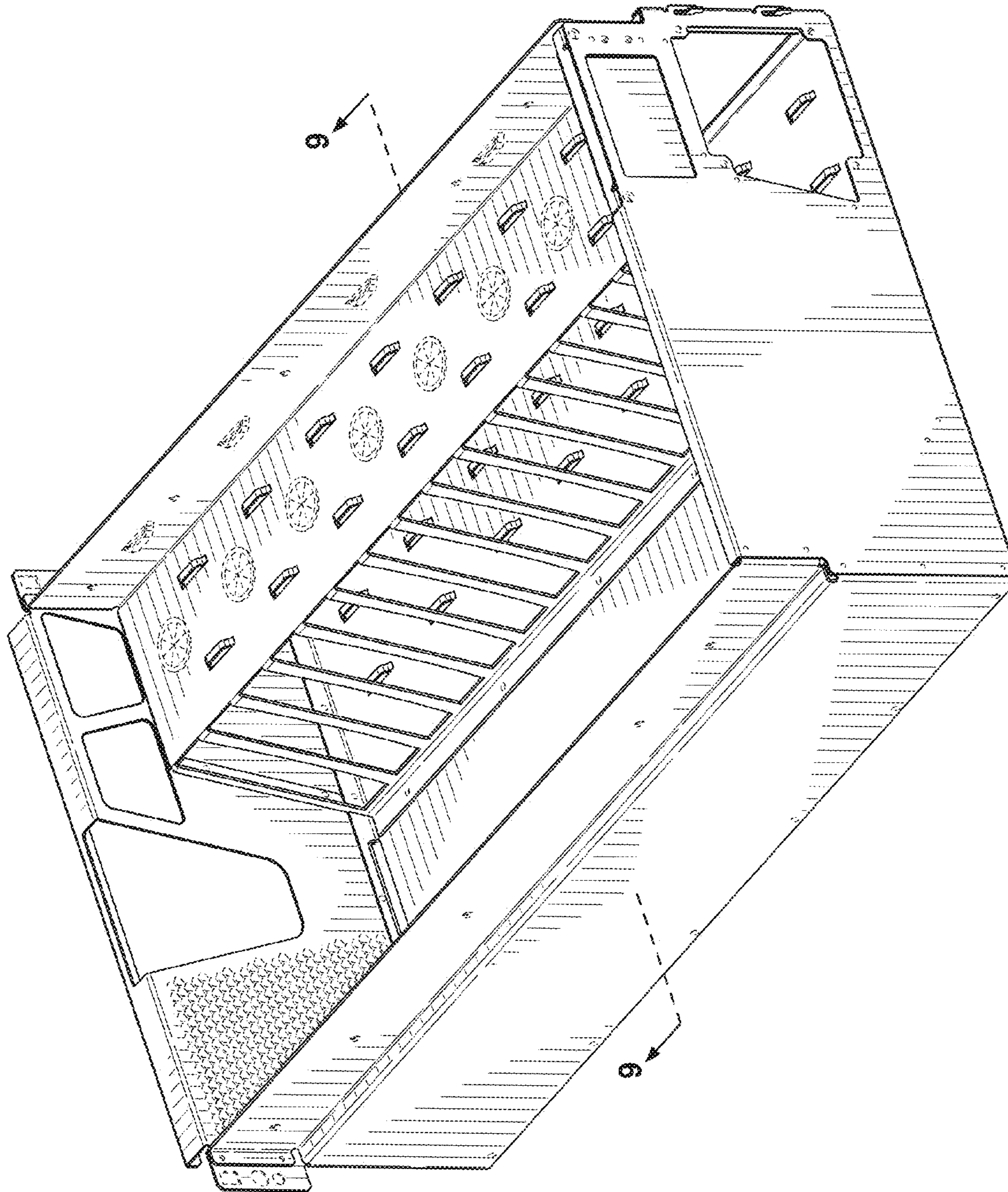

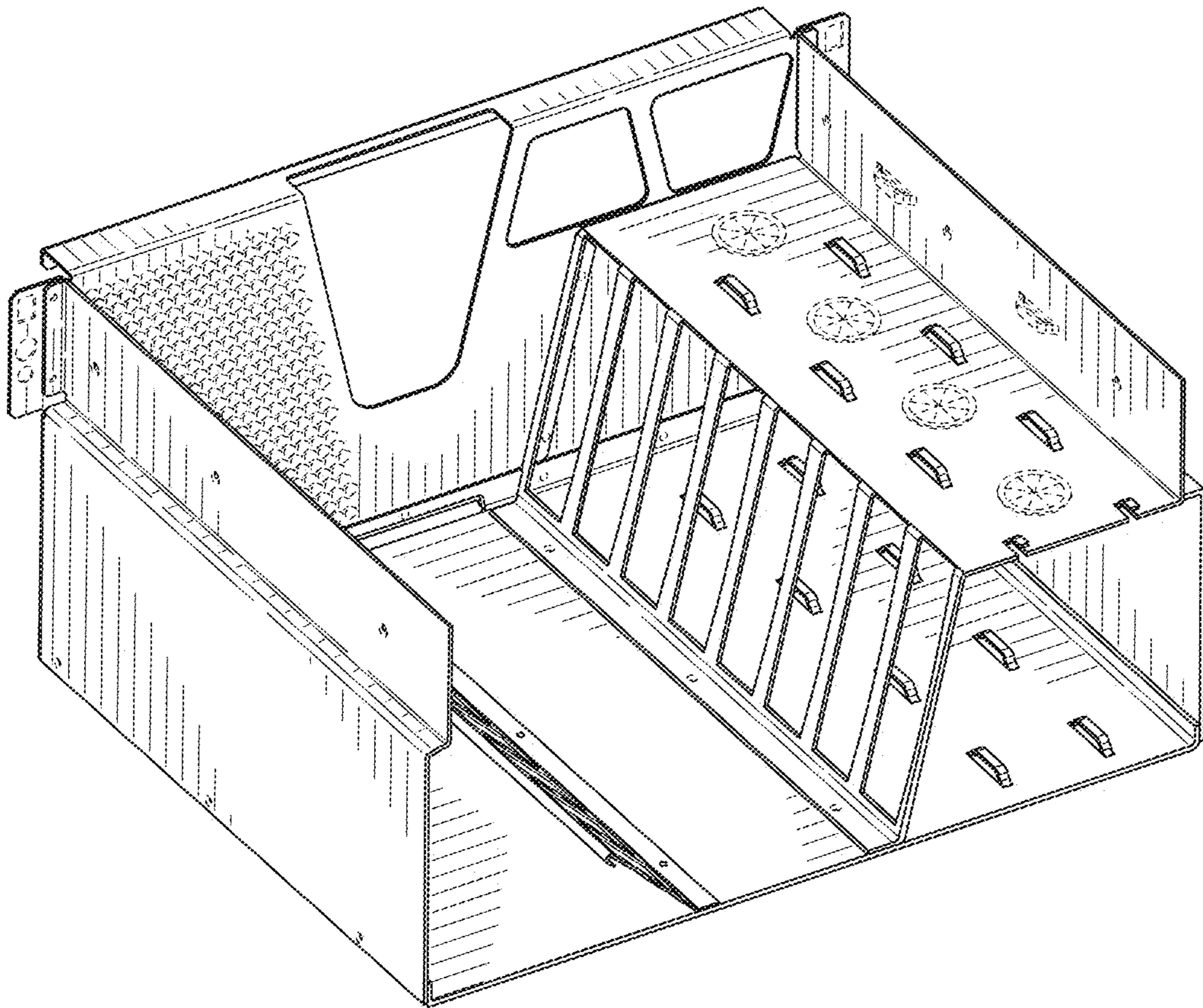

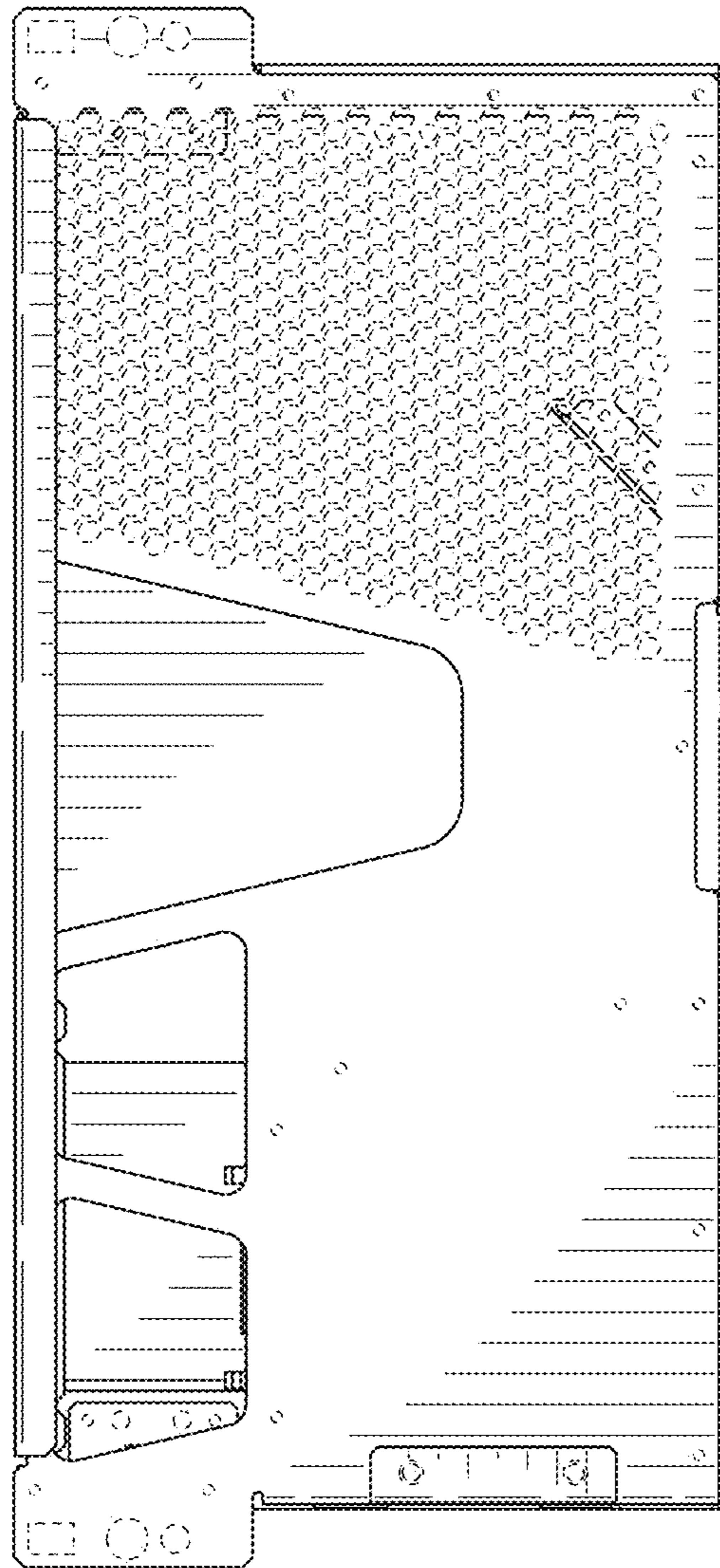

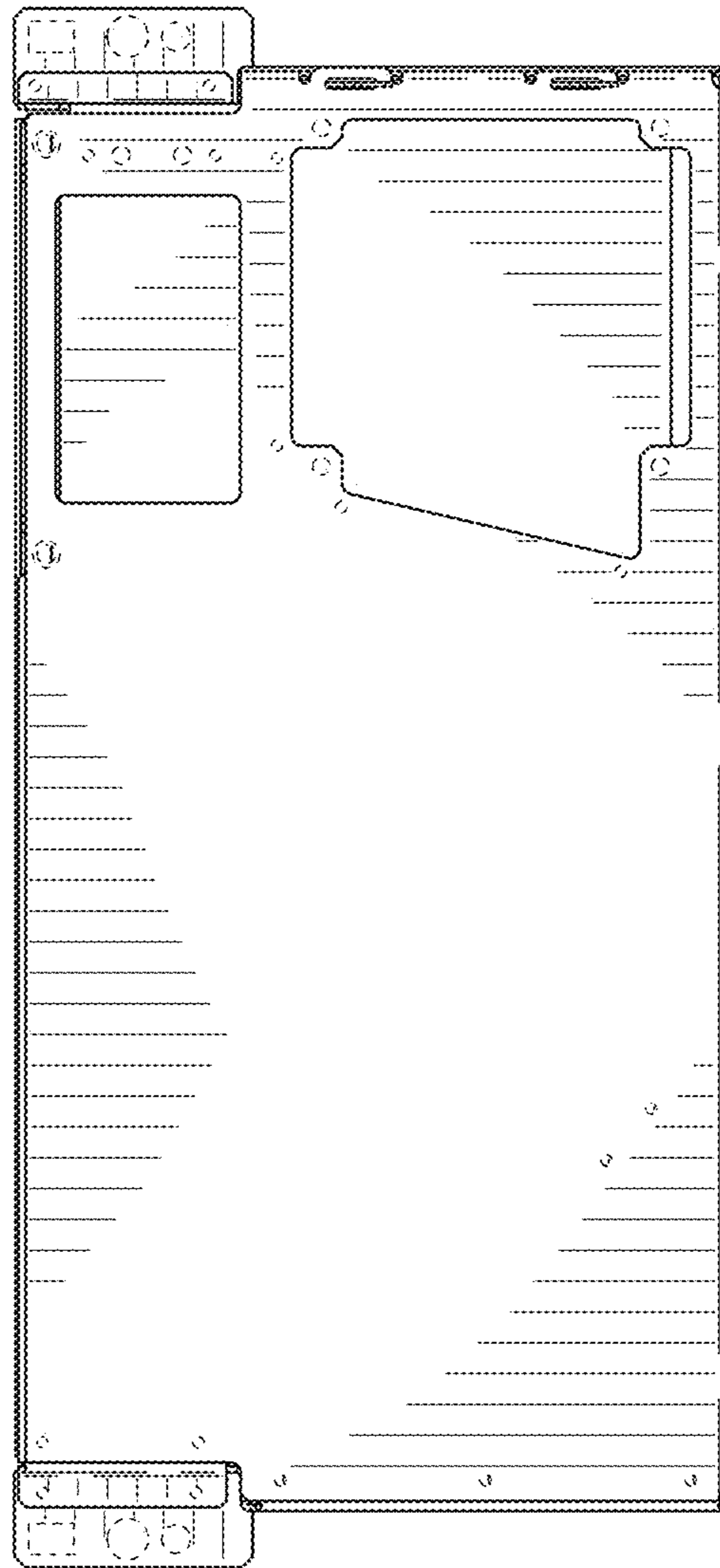

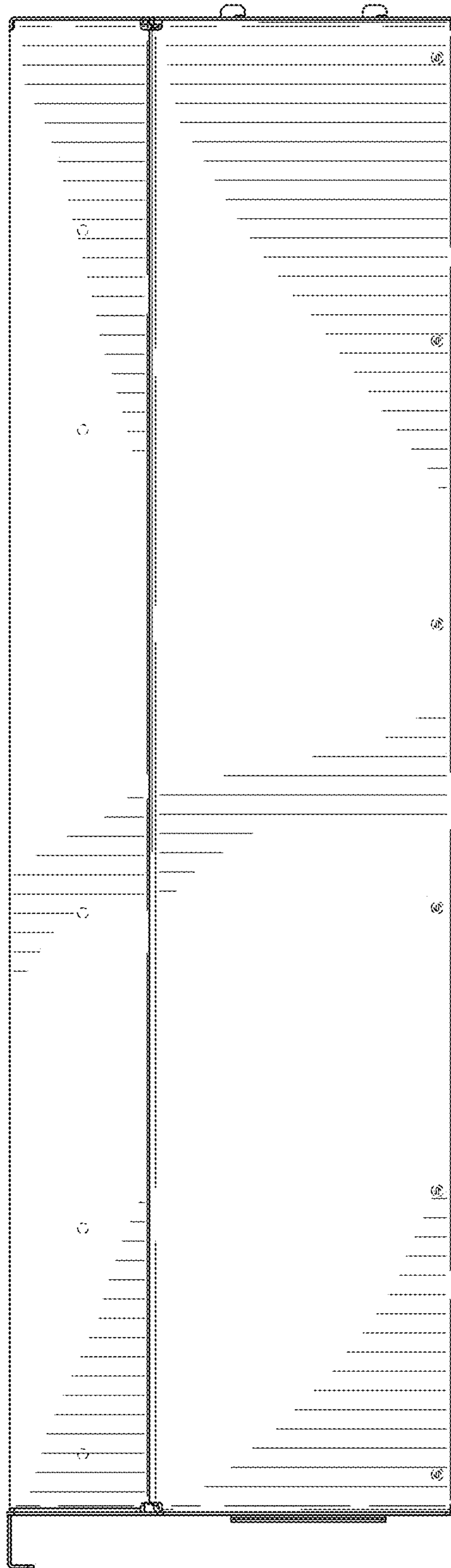

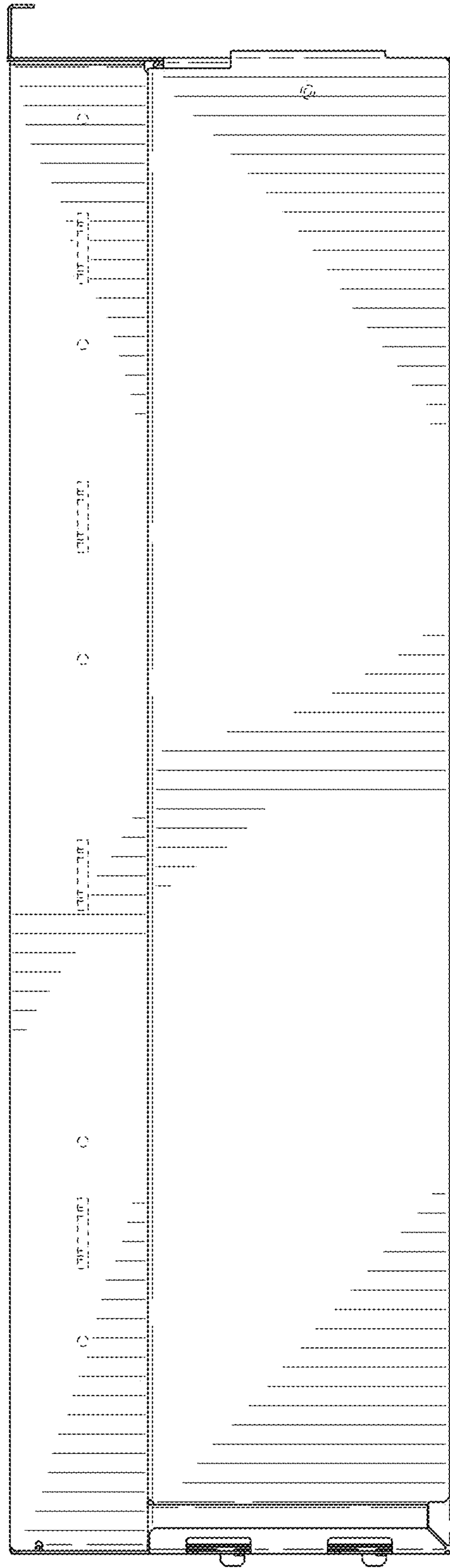

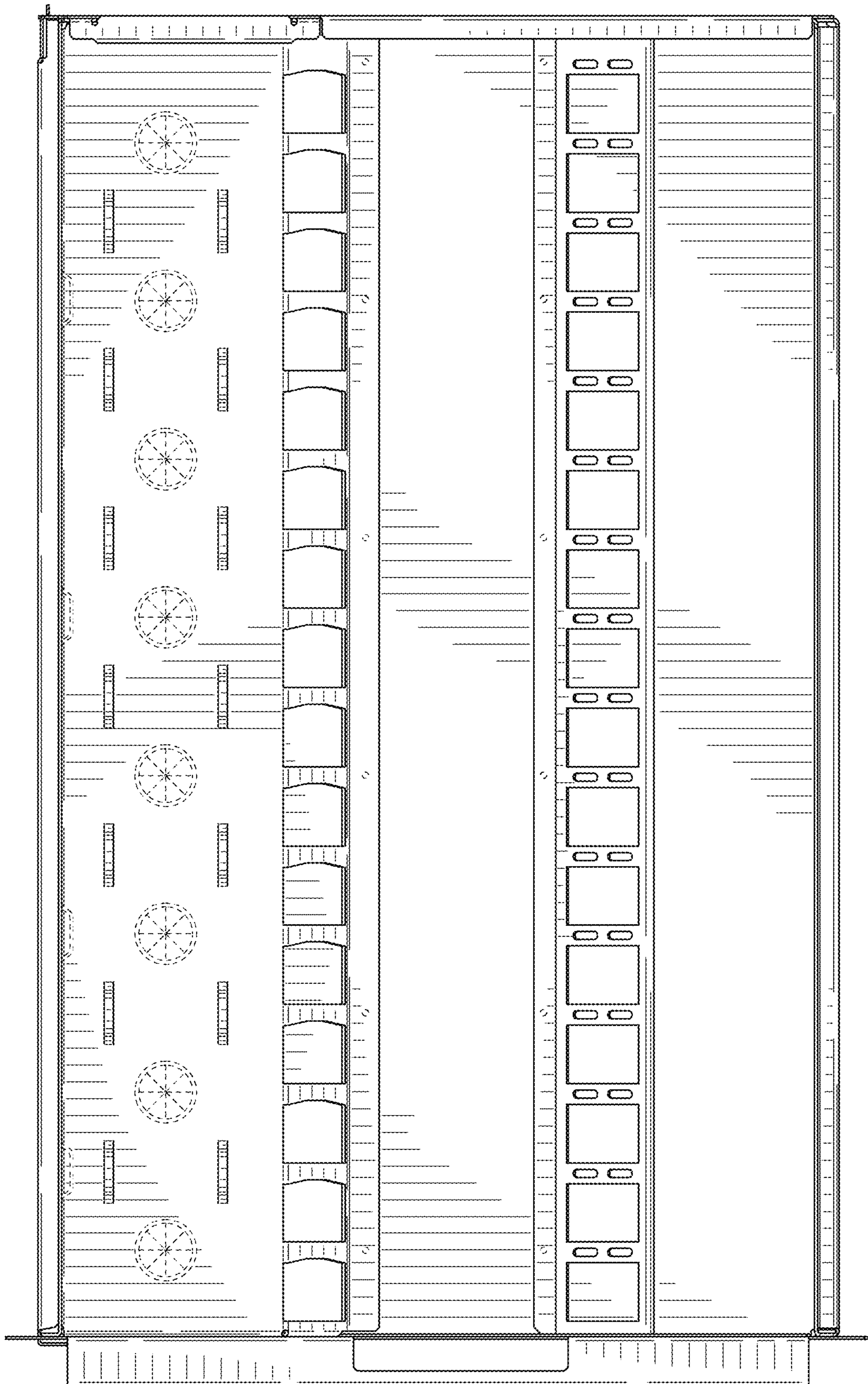

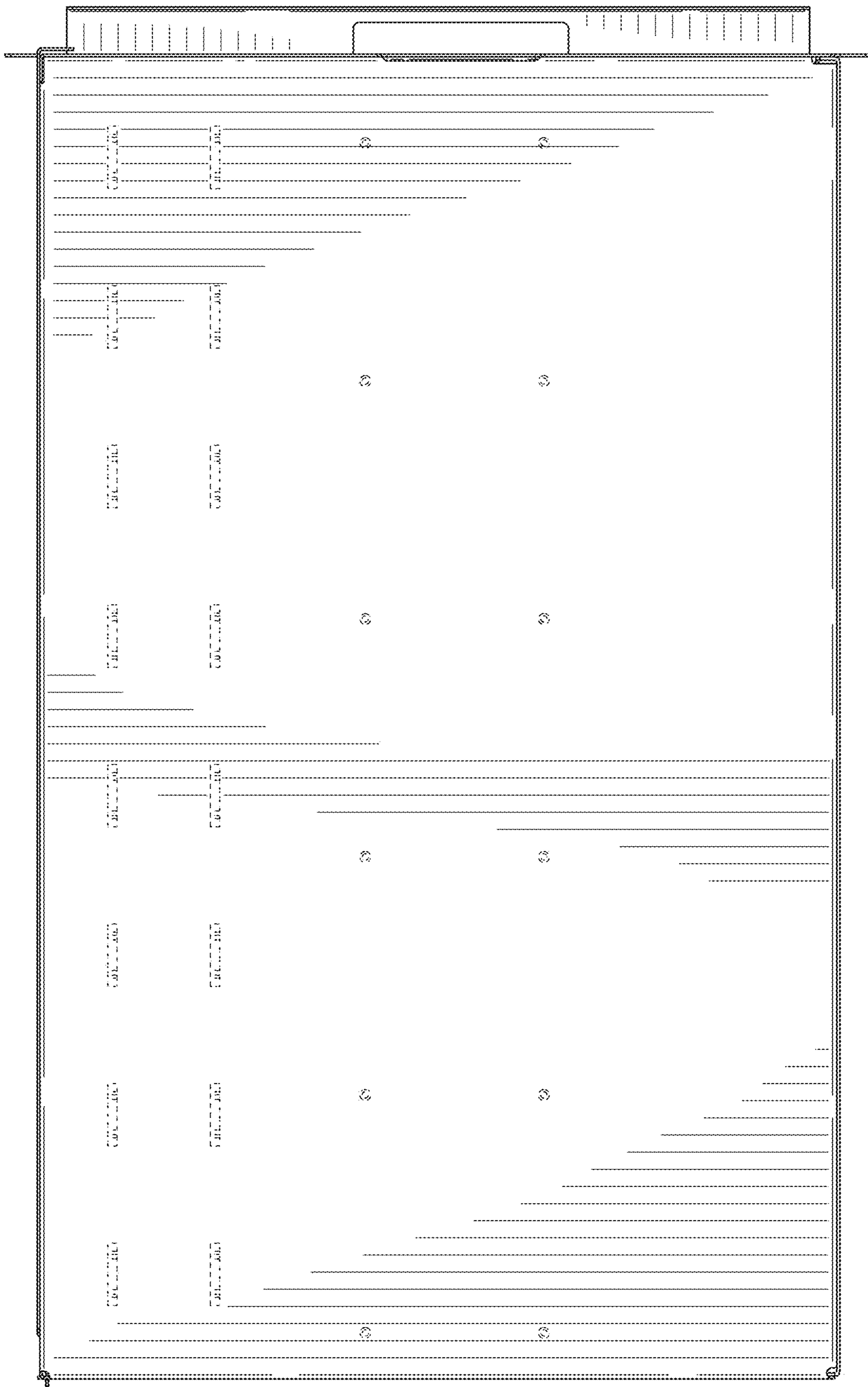

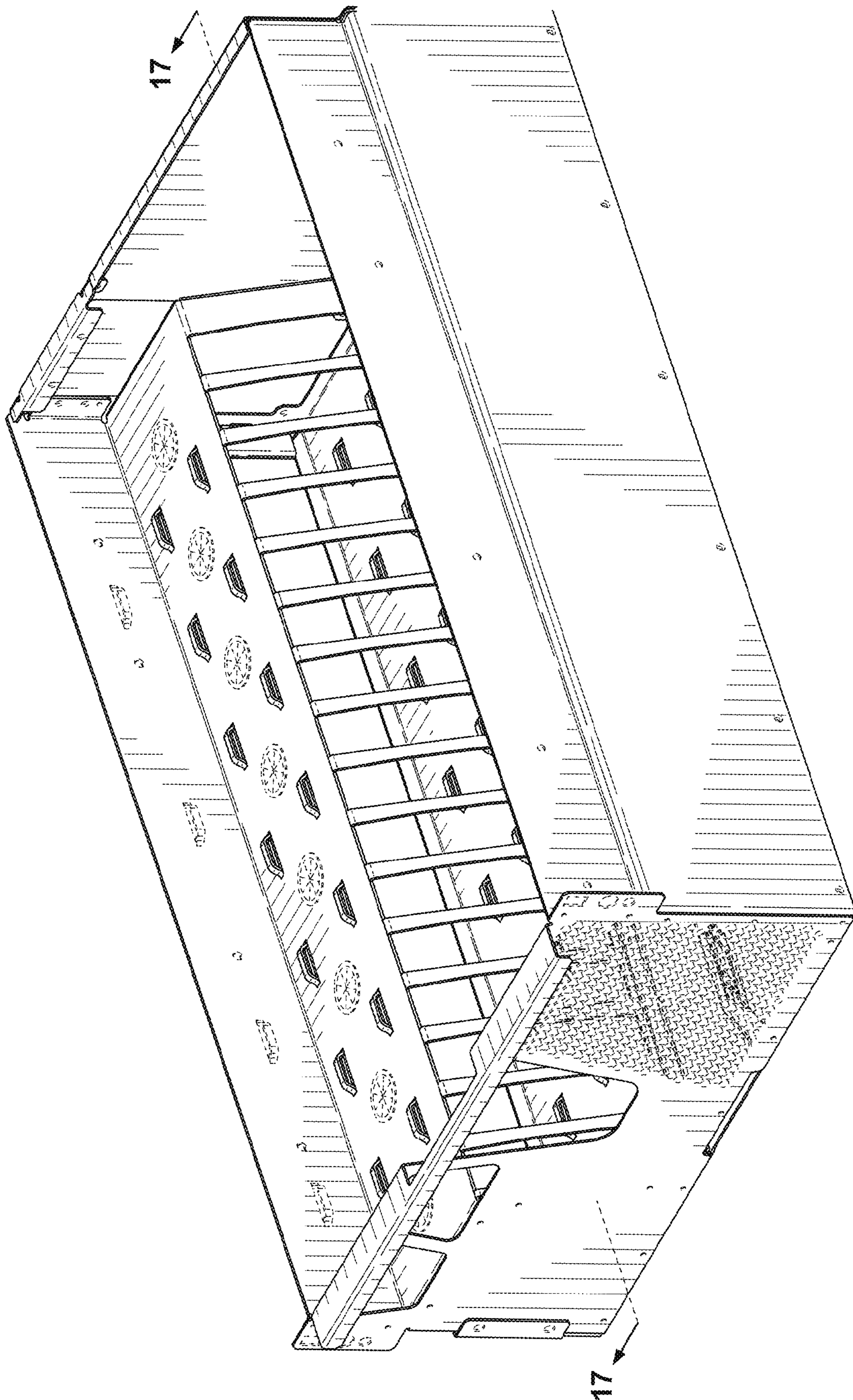

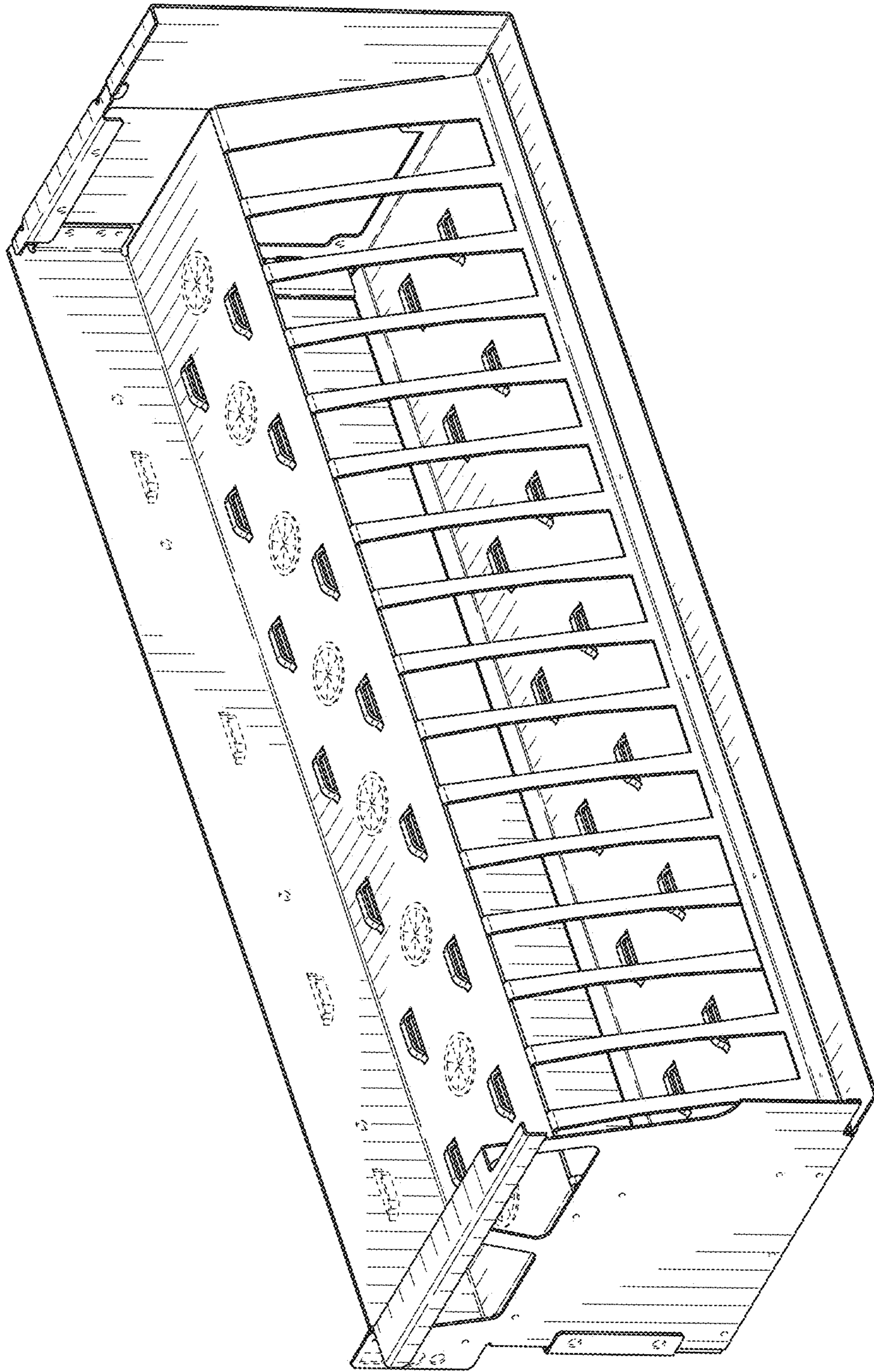

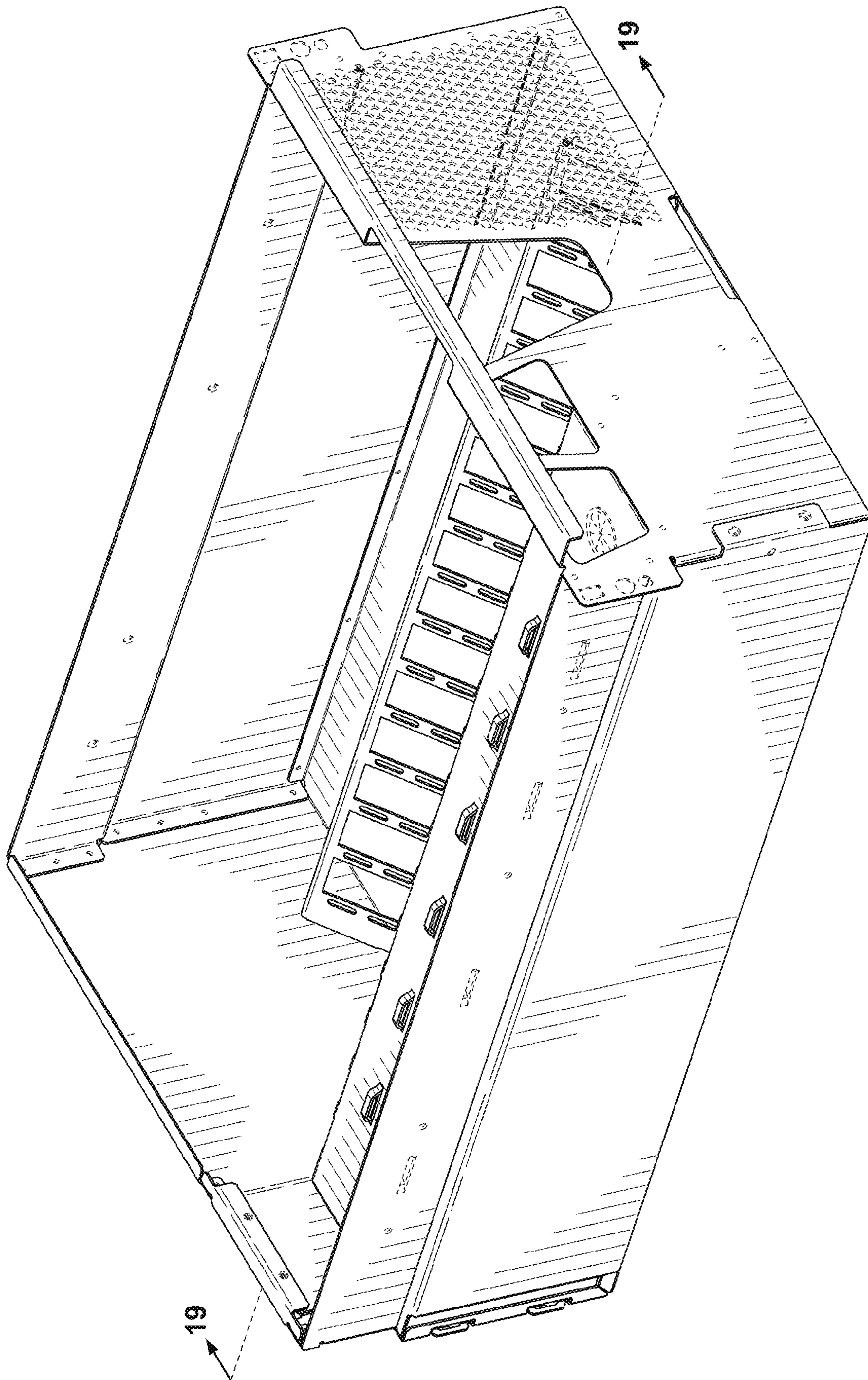

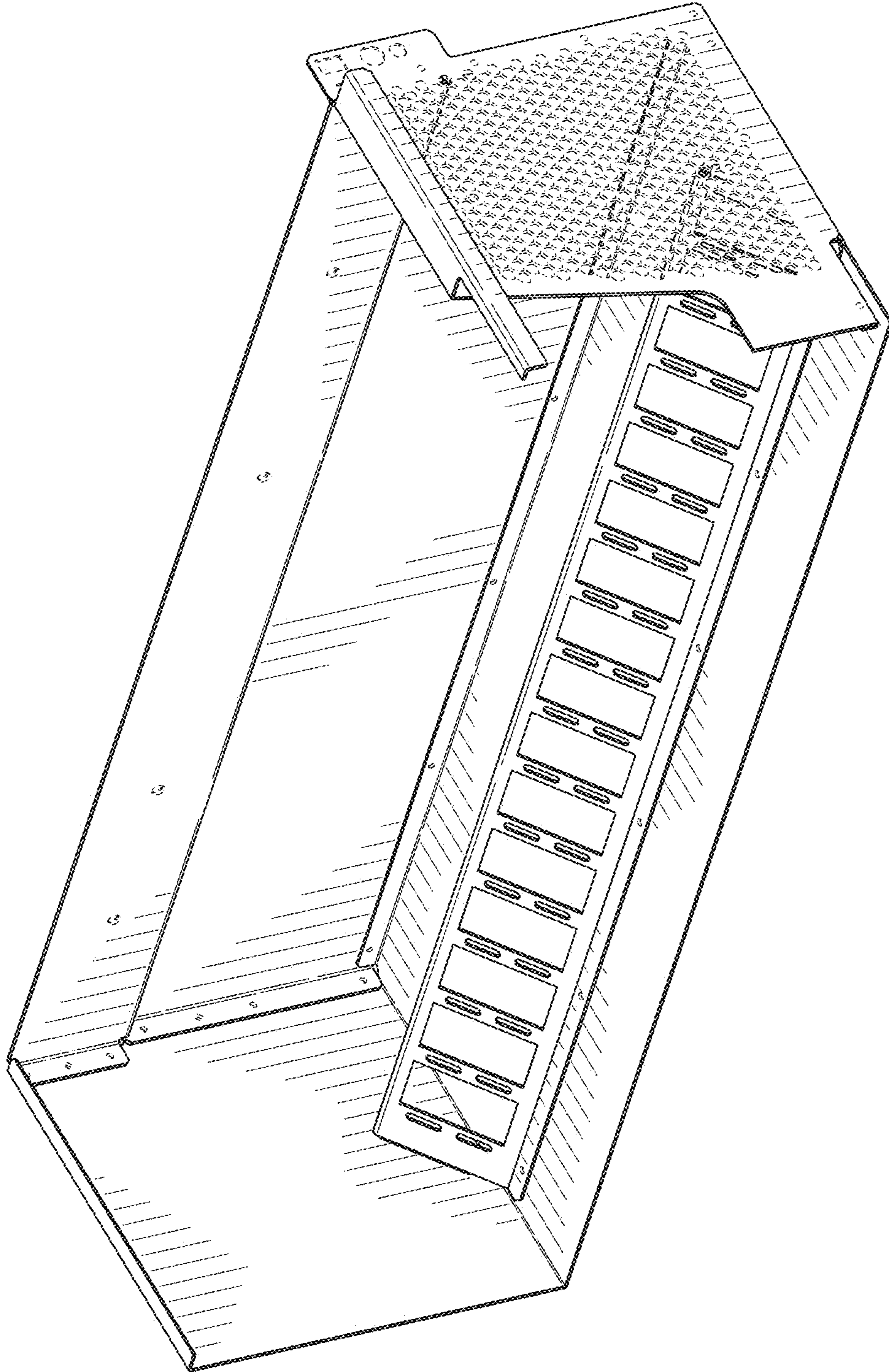

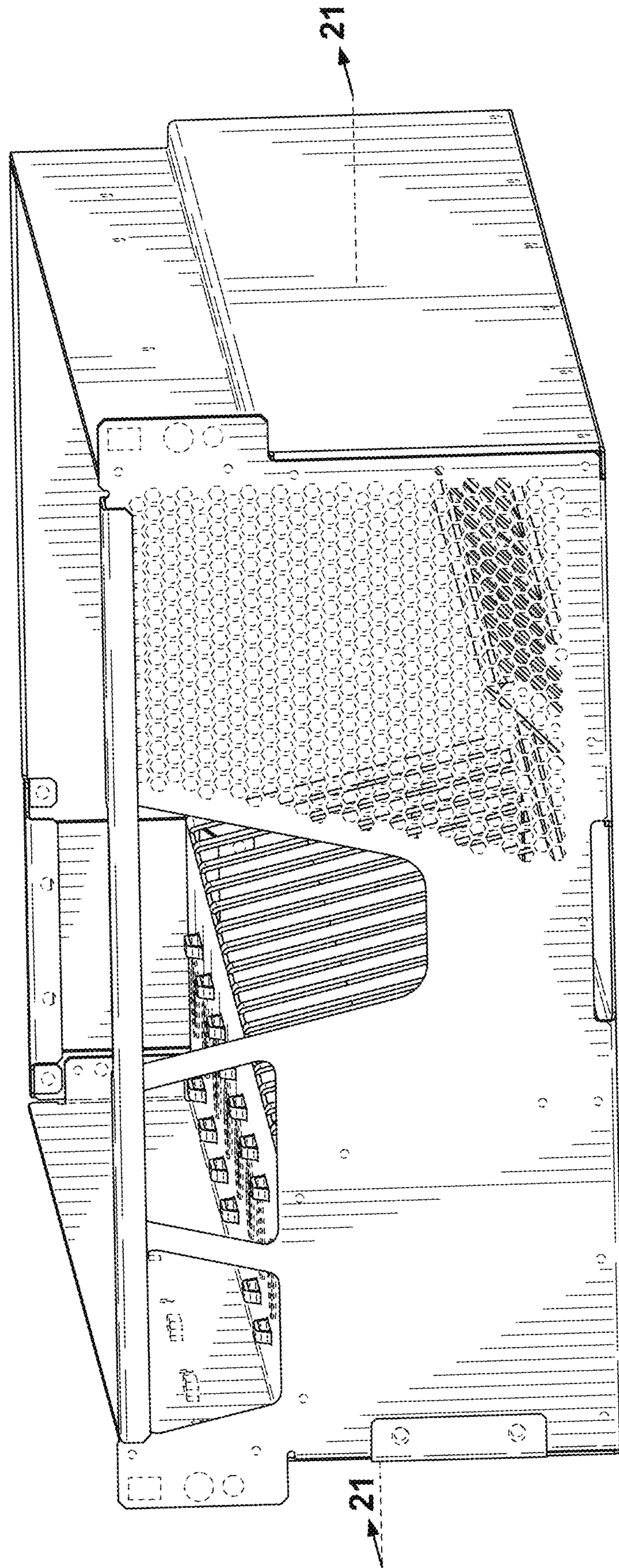

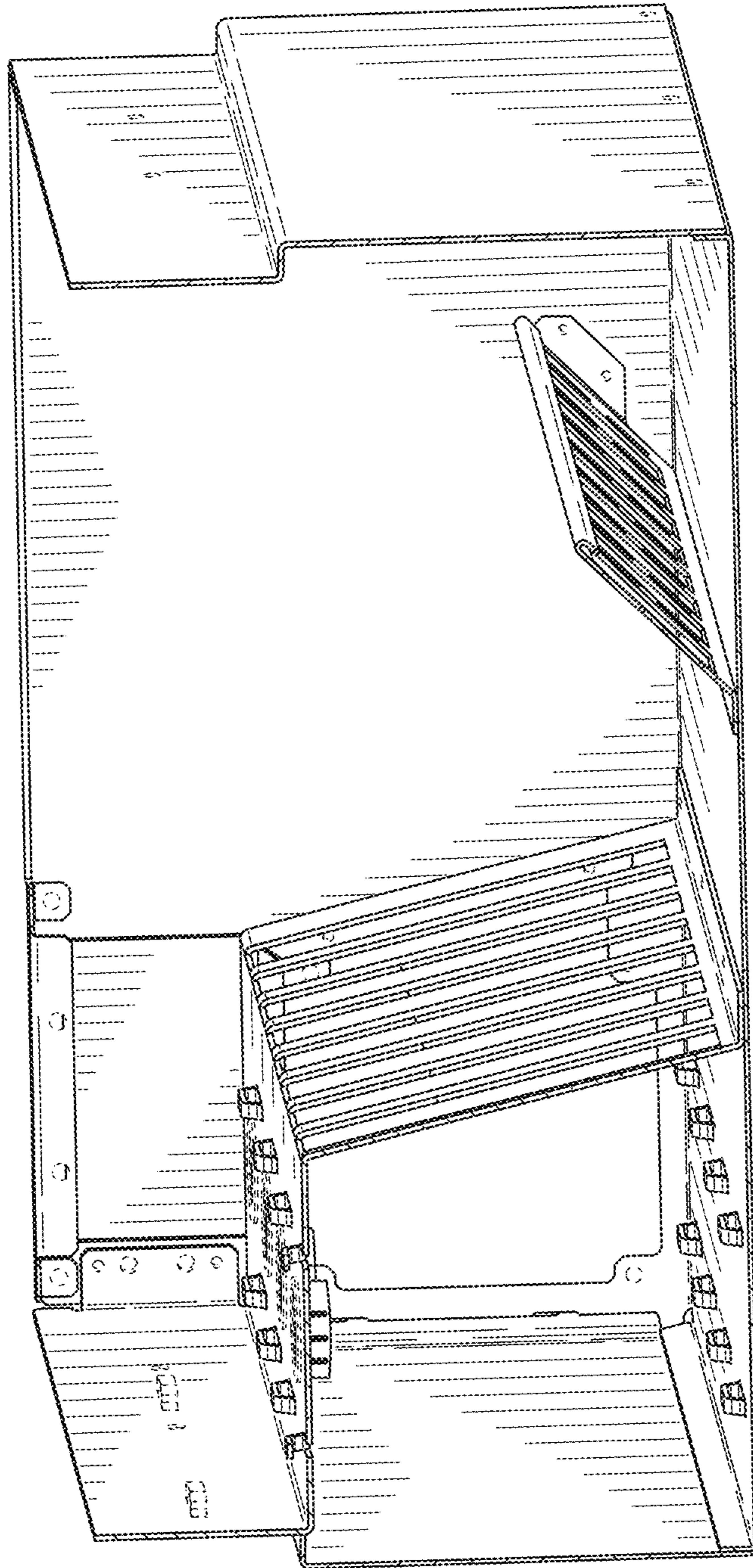
