(57) **CLAIM**

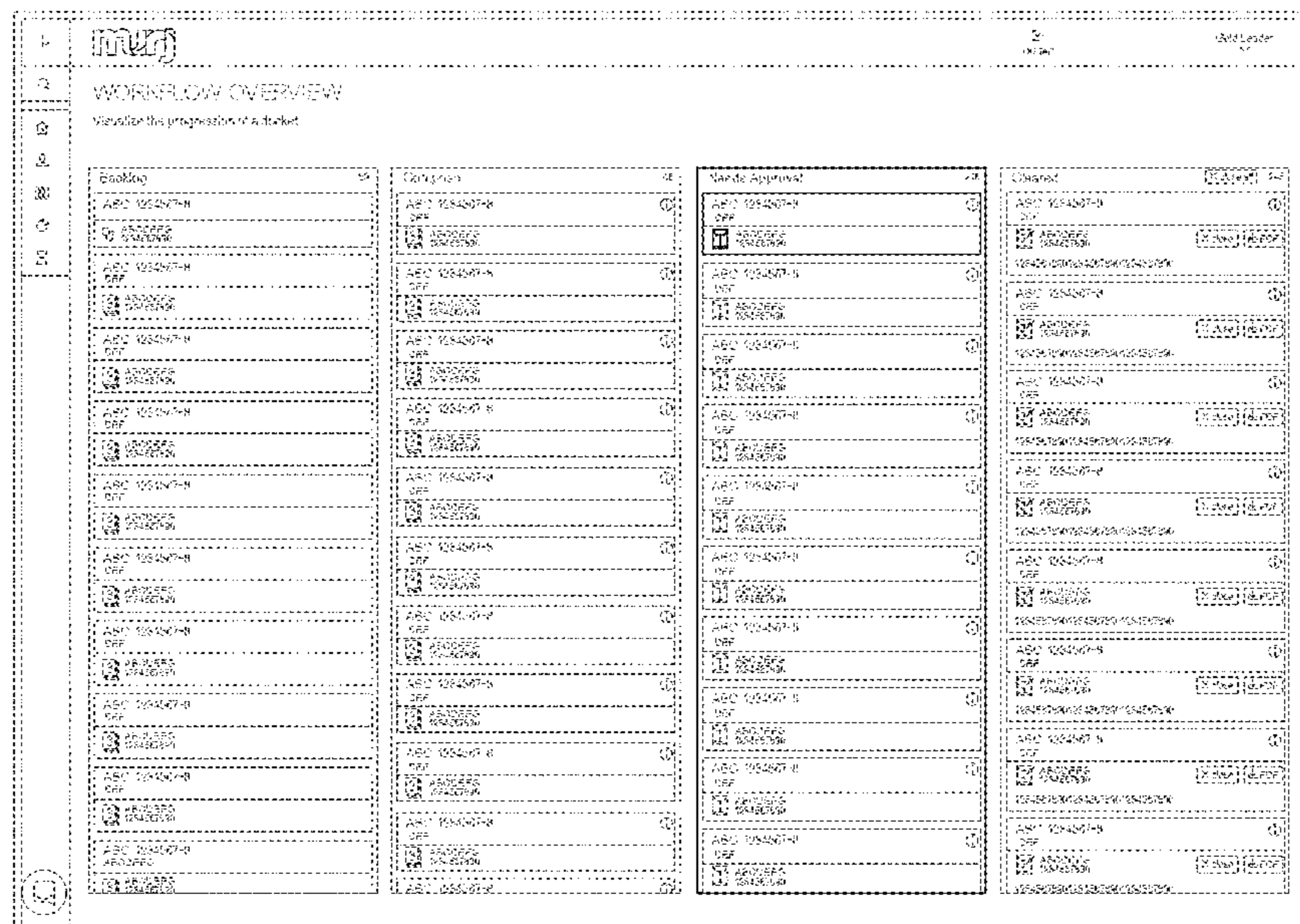
The ornamental design for a display screen or portion thereof with graphical user interface for a health management application, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface for a health management application showing our new design; and,

FIG. 2 is a front view of a second embodiment thereof. The outermost broken lines show a display screen or portion thereof and form no part of the claimed design. The other broken lines show portions of the graphical user interface and form no part of the claimed design.

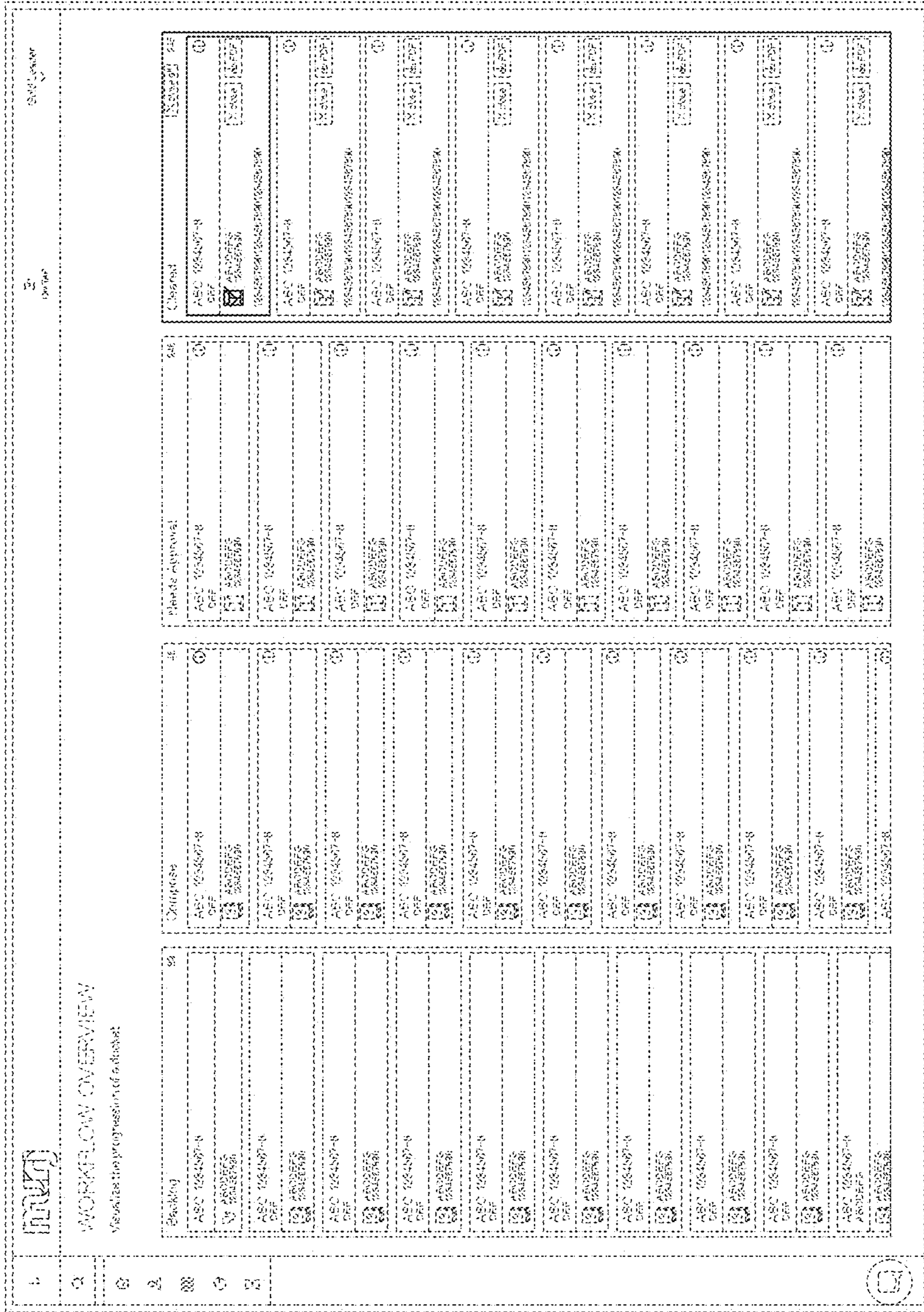
