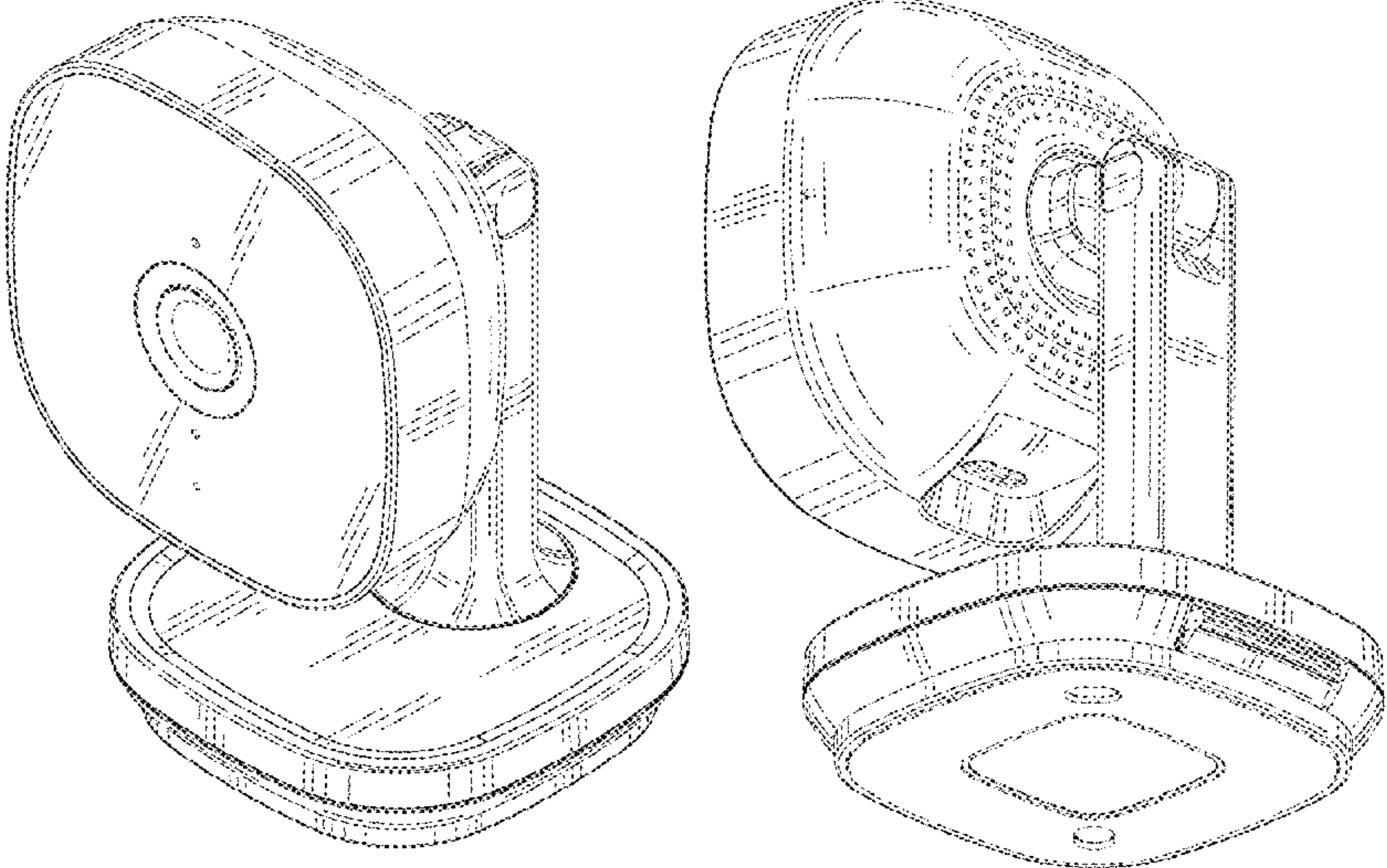
CLAIM

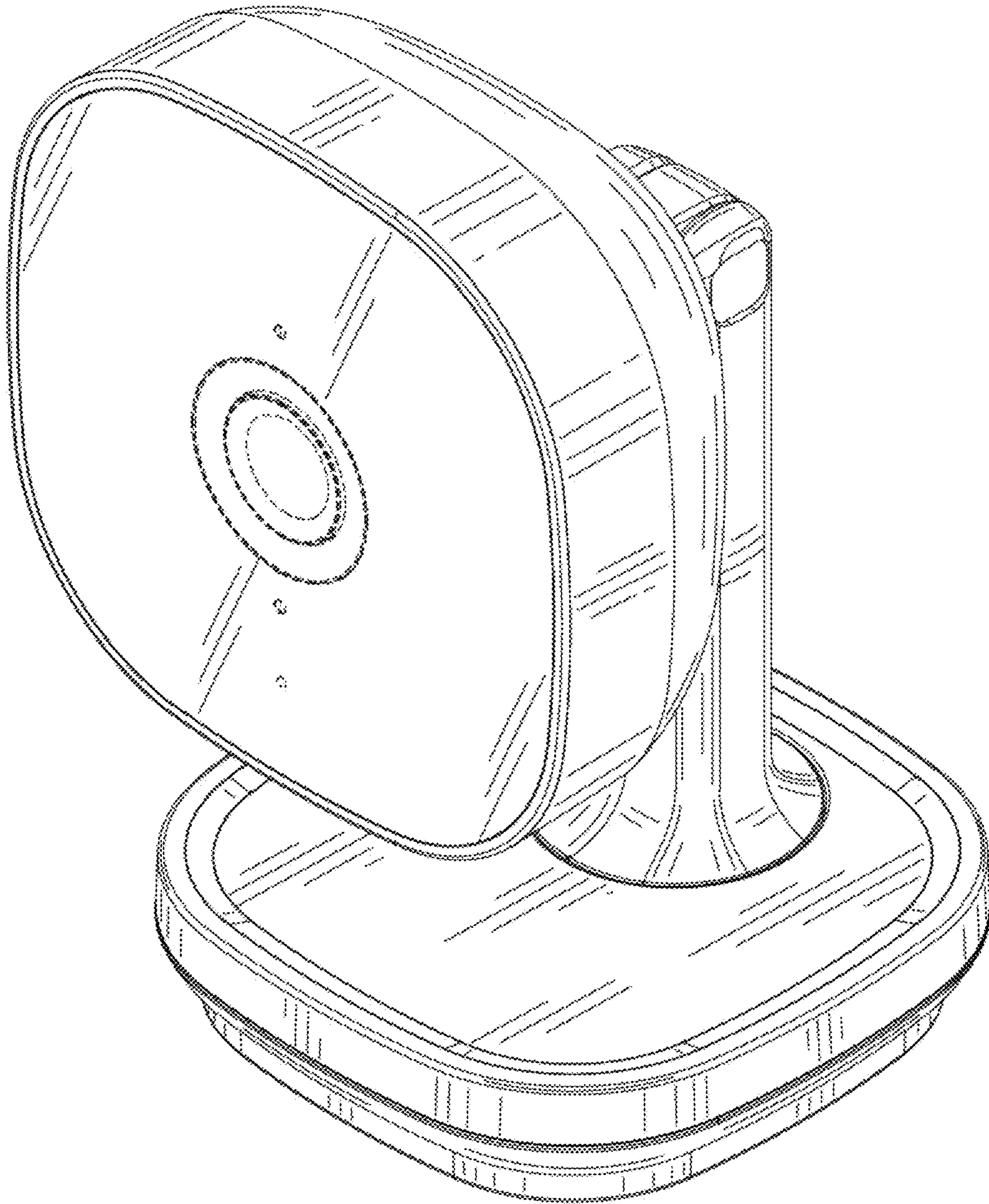

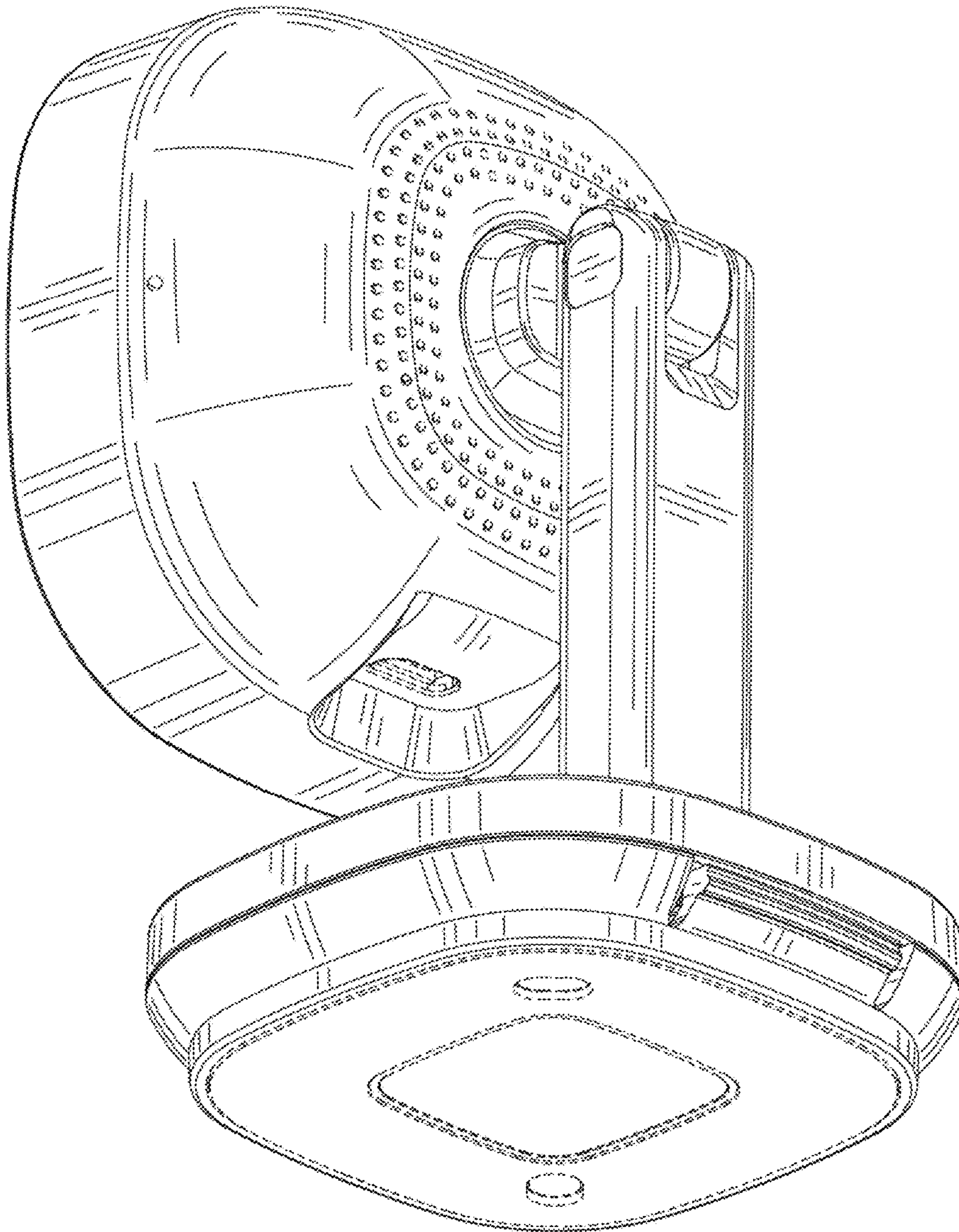

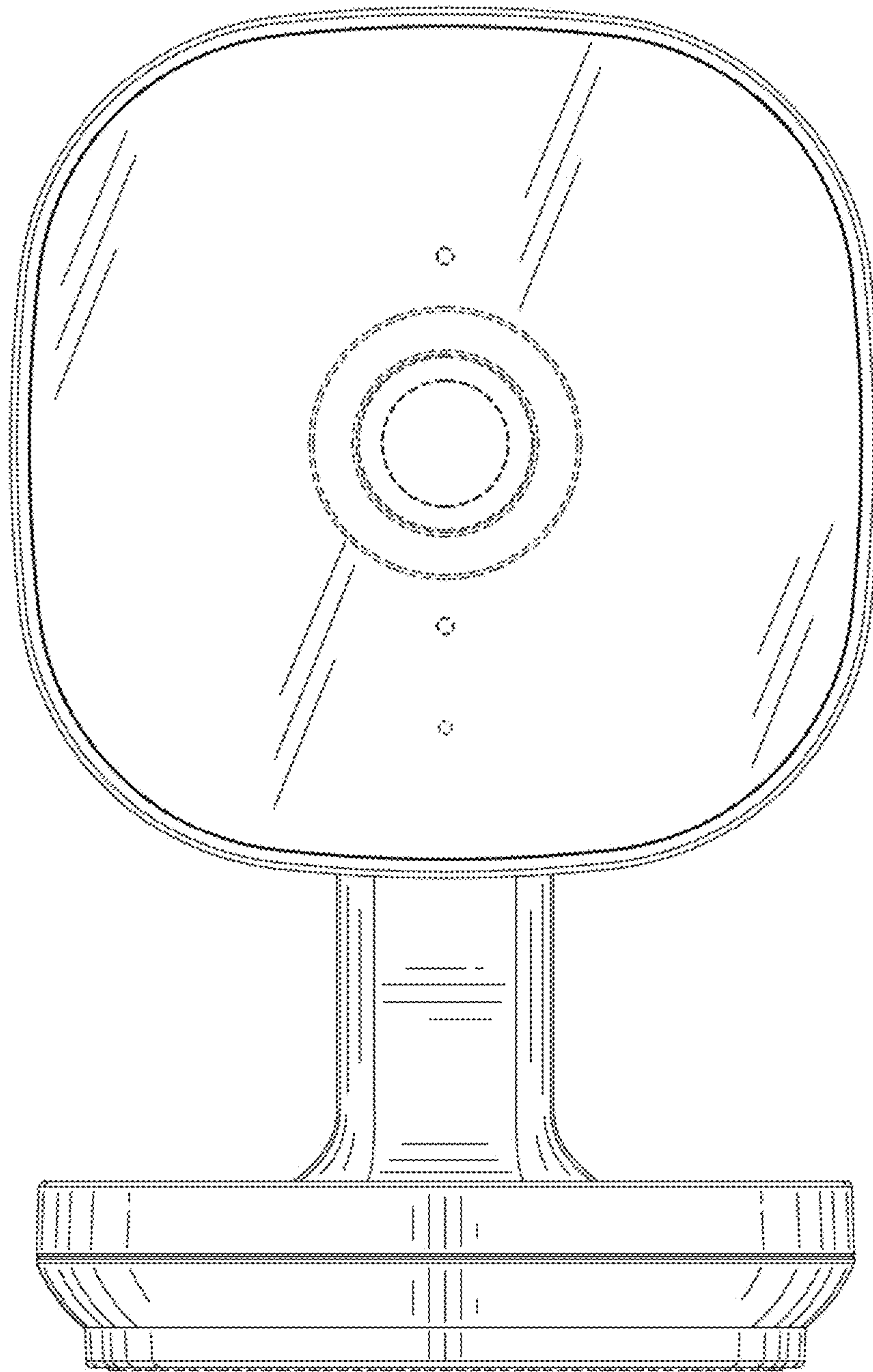

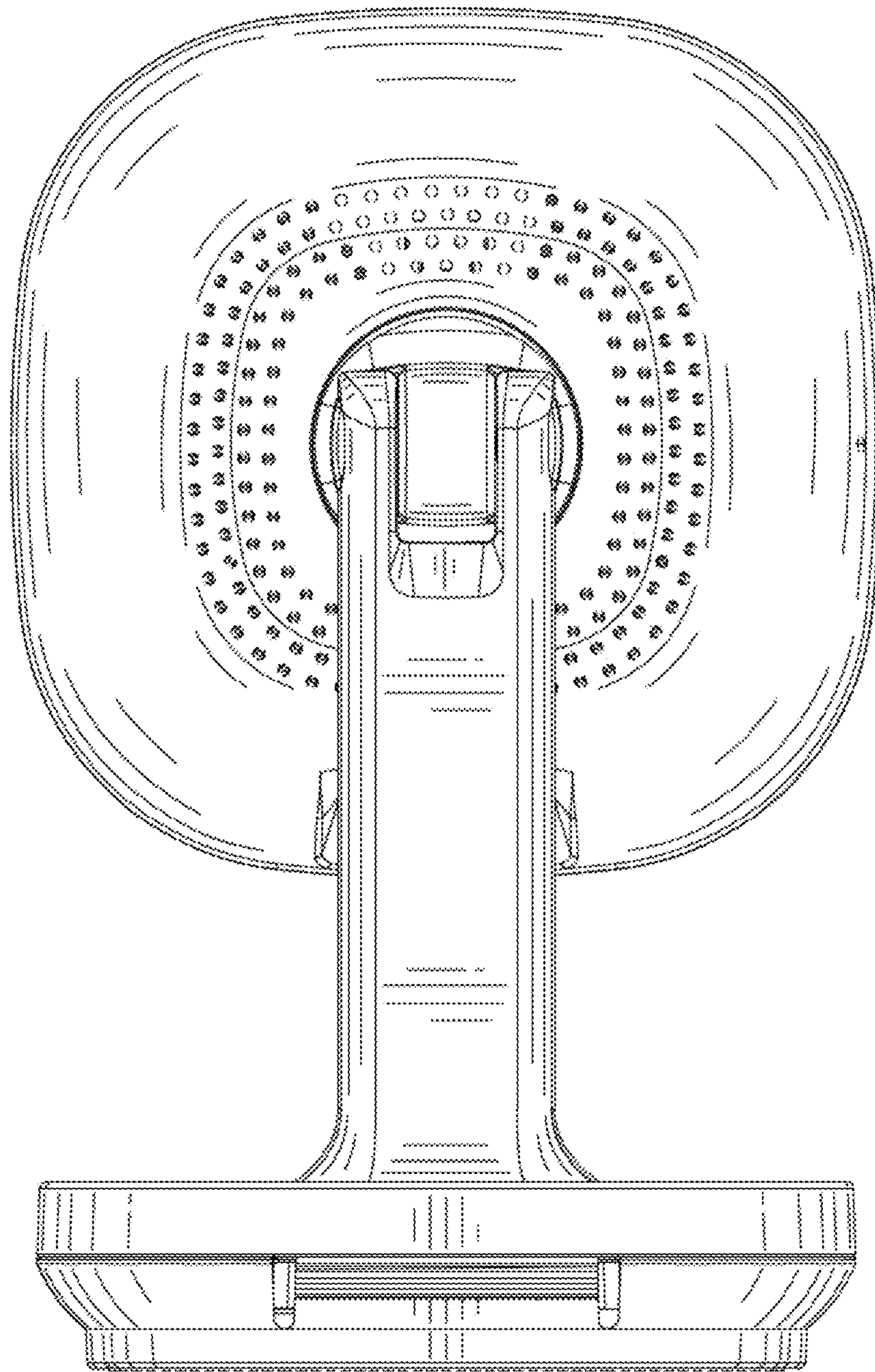

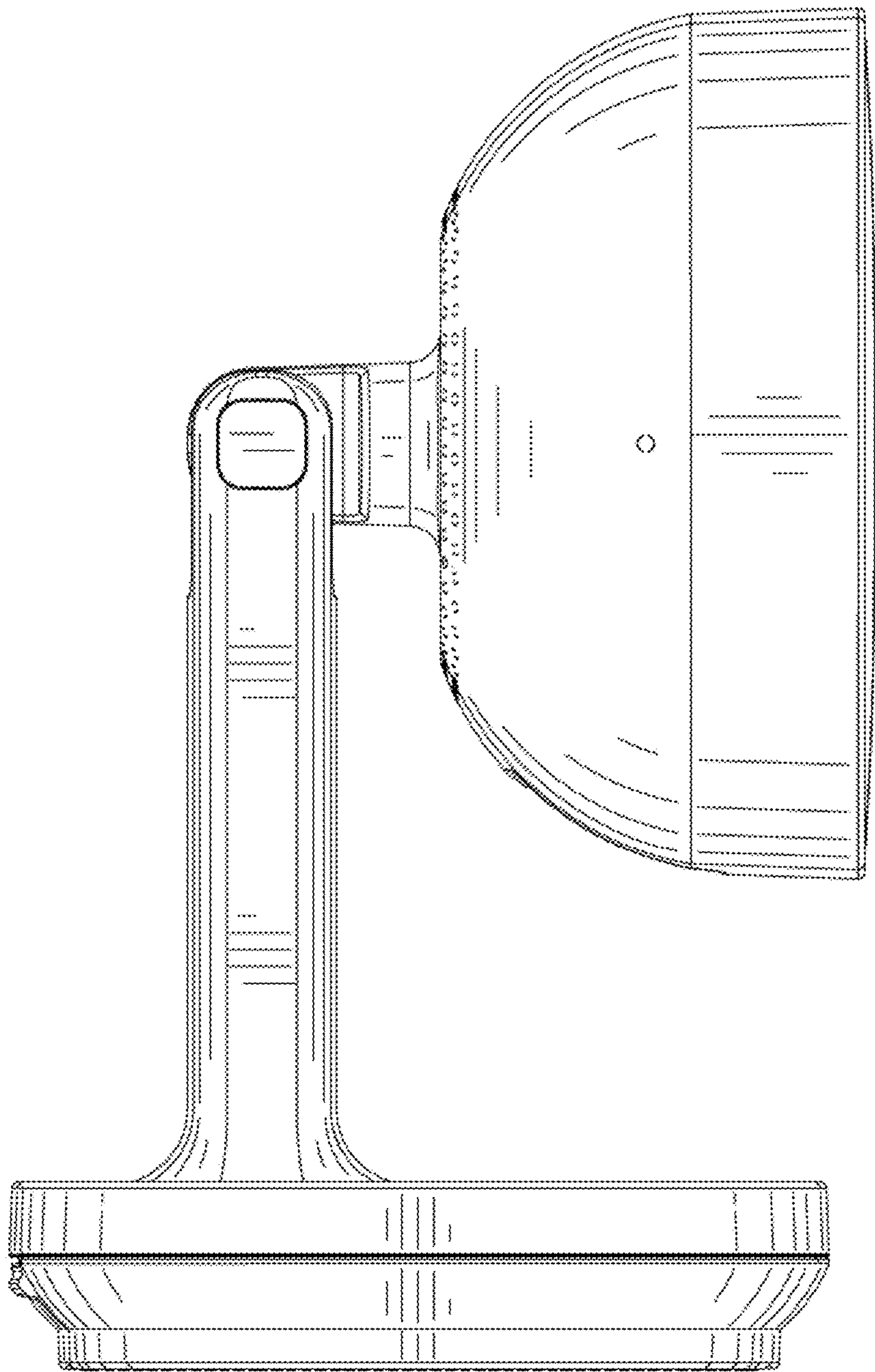

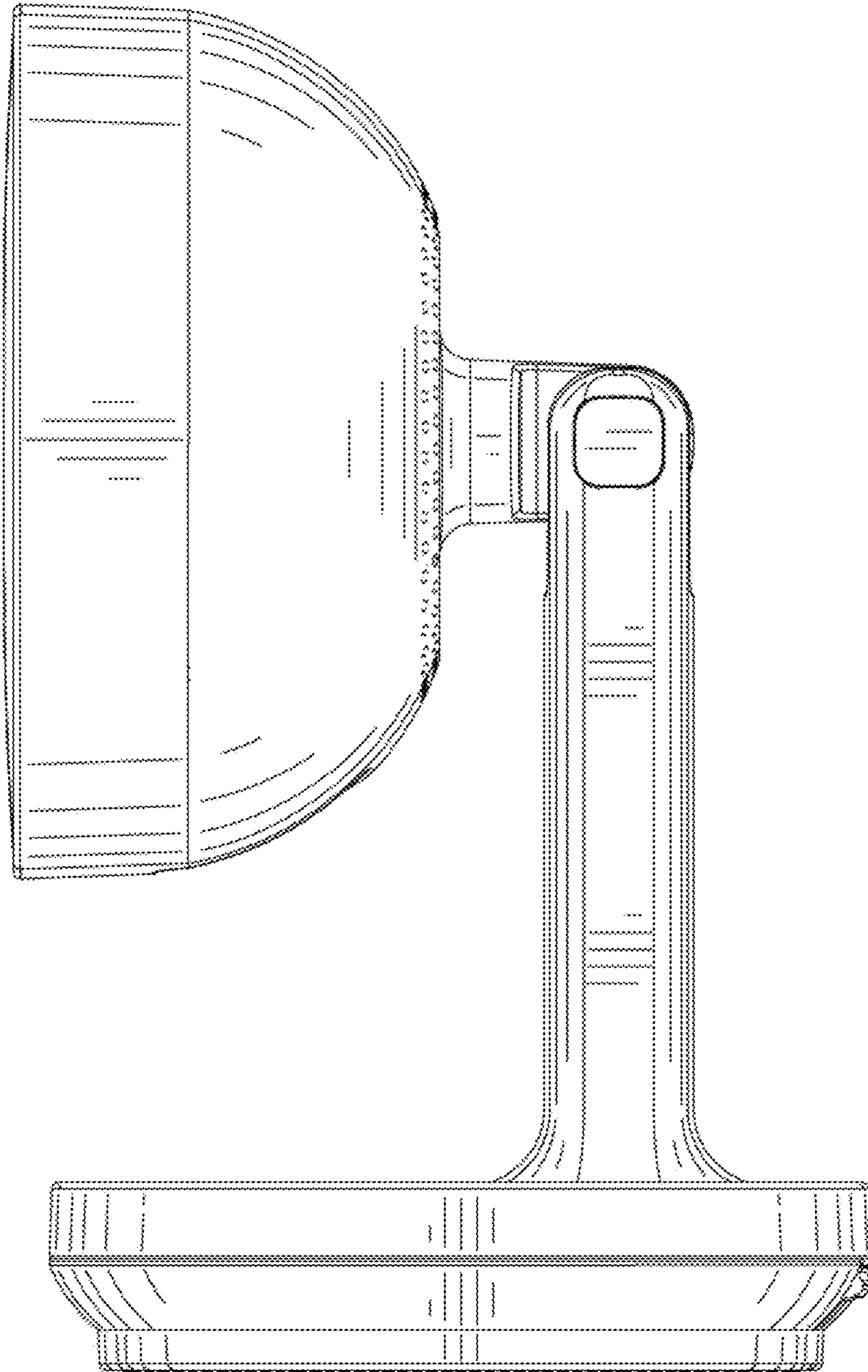

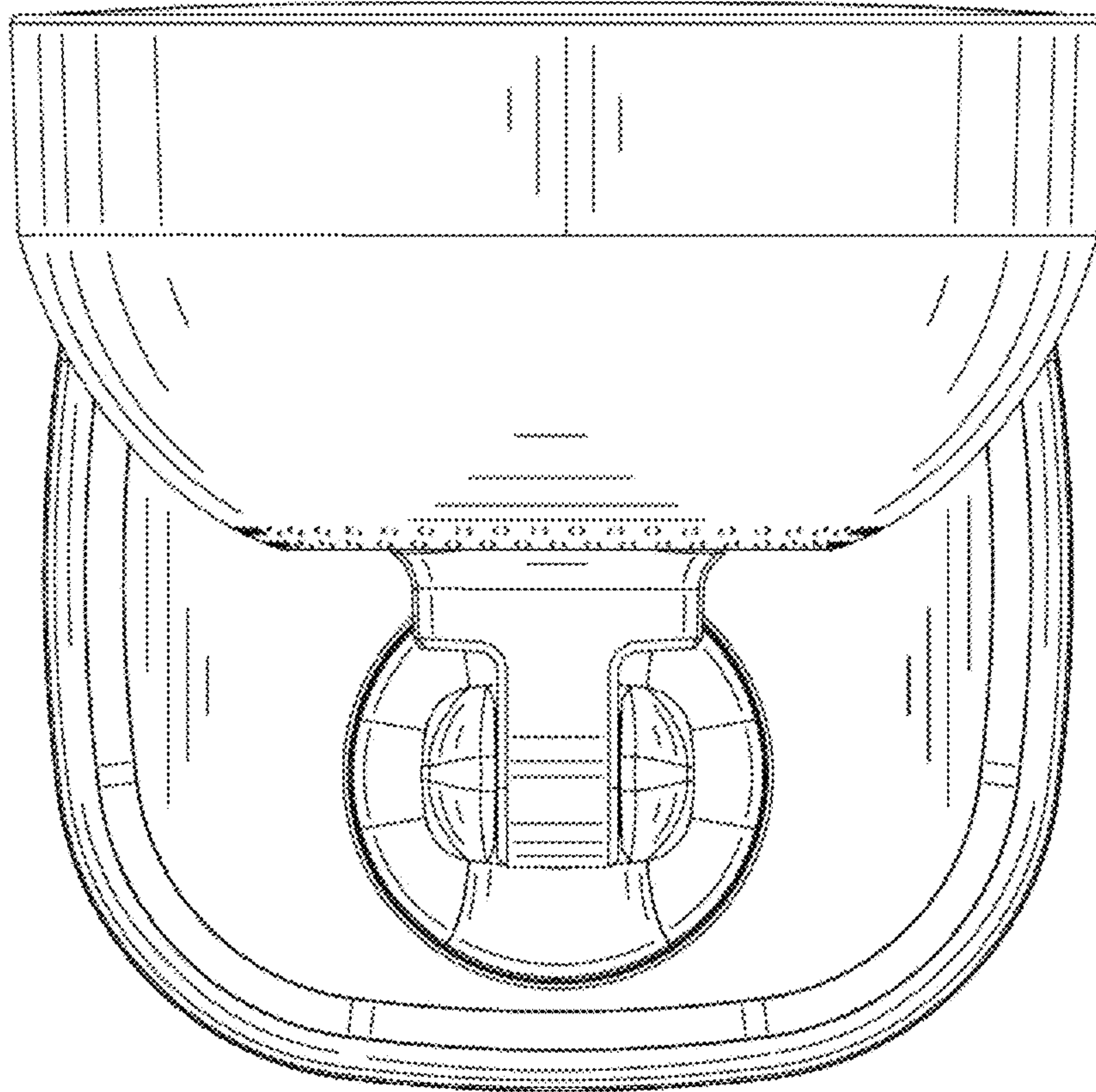

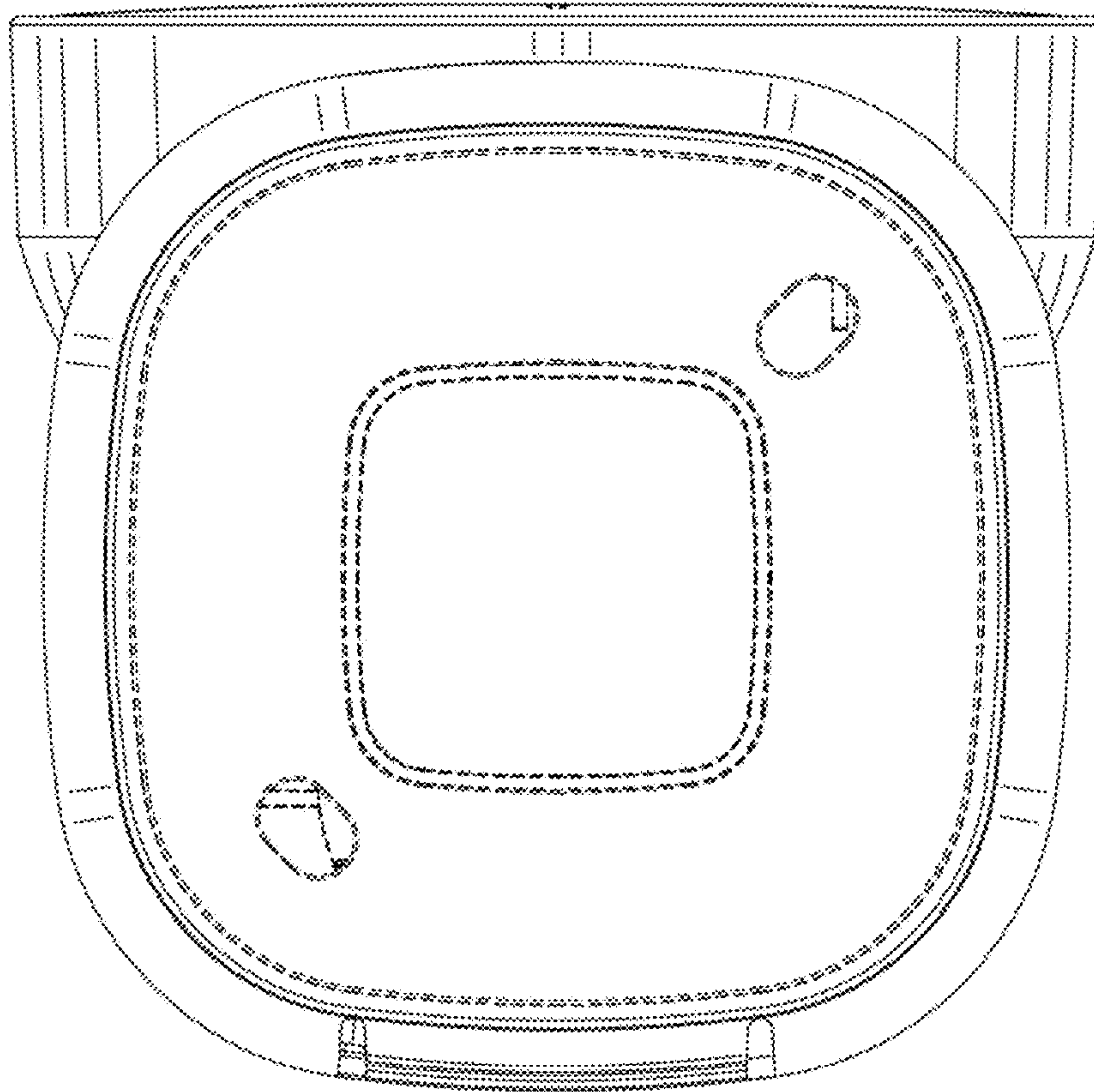
