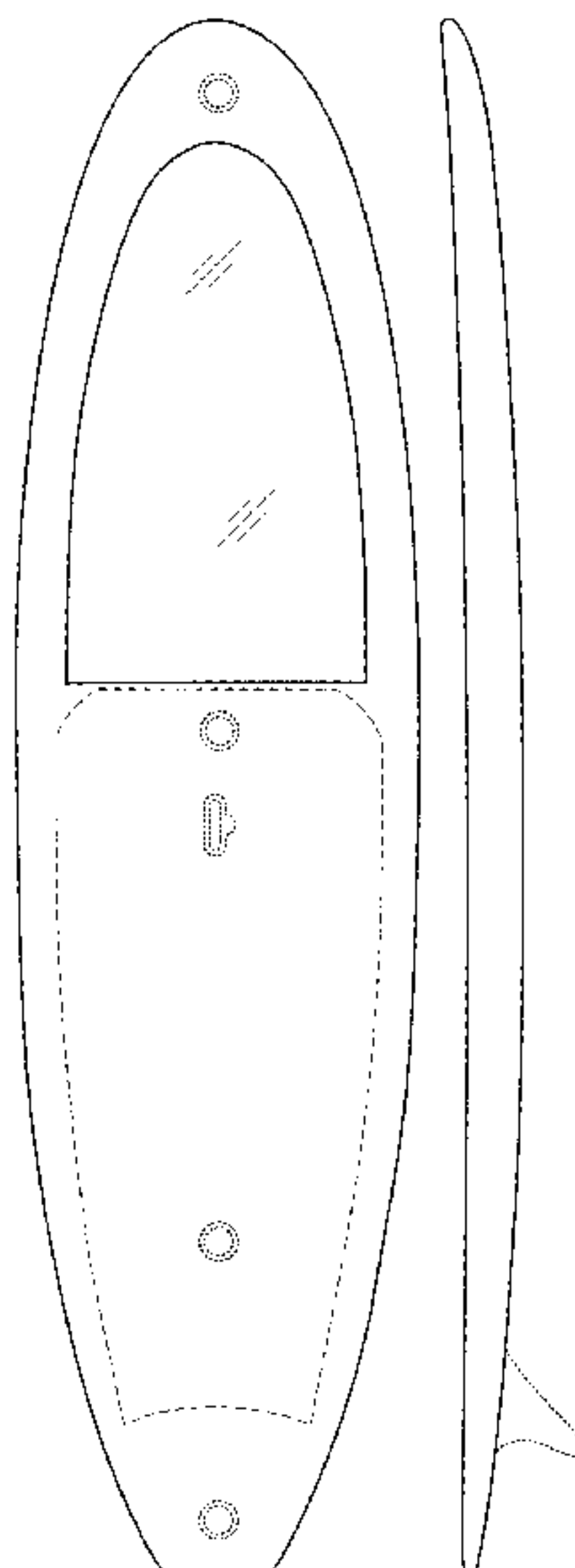
(57) **CLAIM**

The ornamental design for a stand up paddle board with transparent viewing window, as shown.

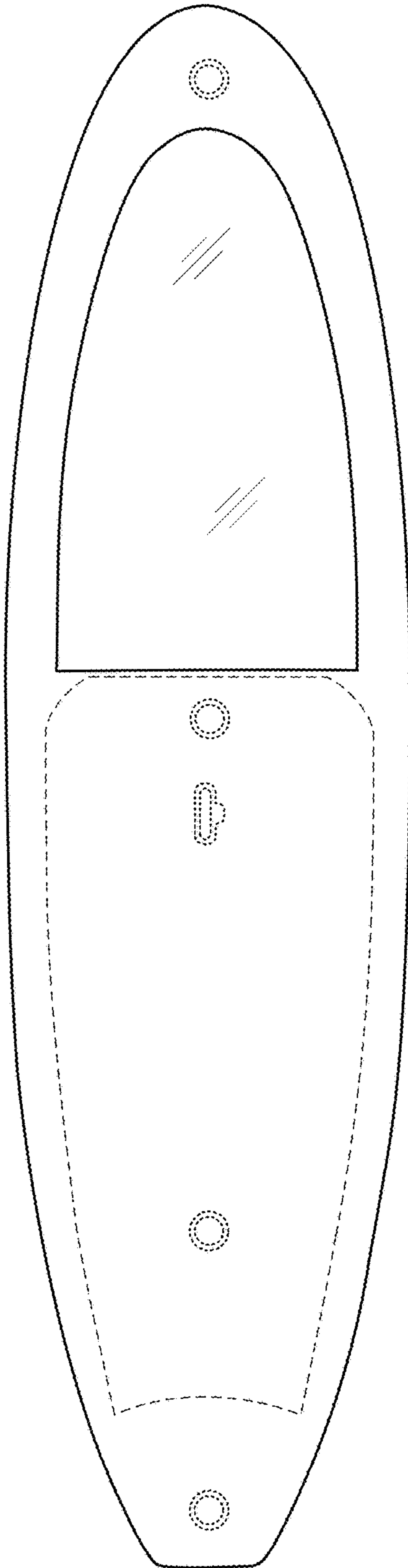

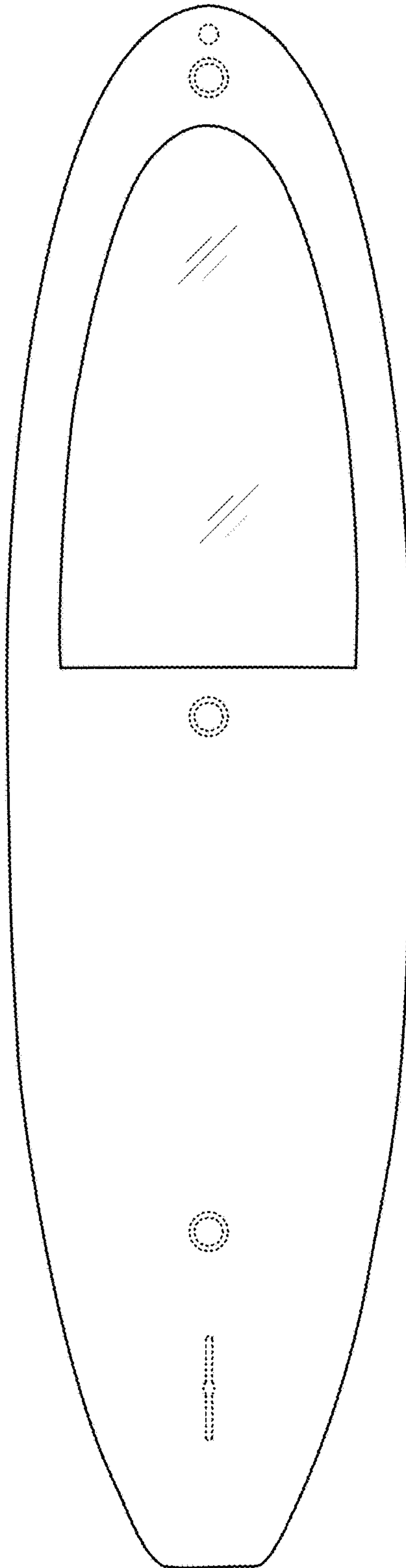

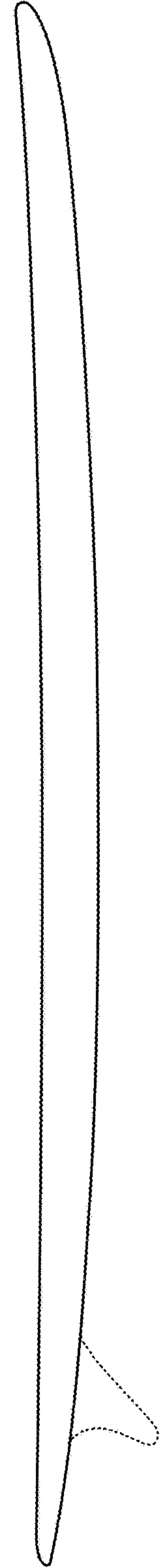
