**DESCRIPTION**

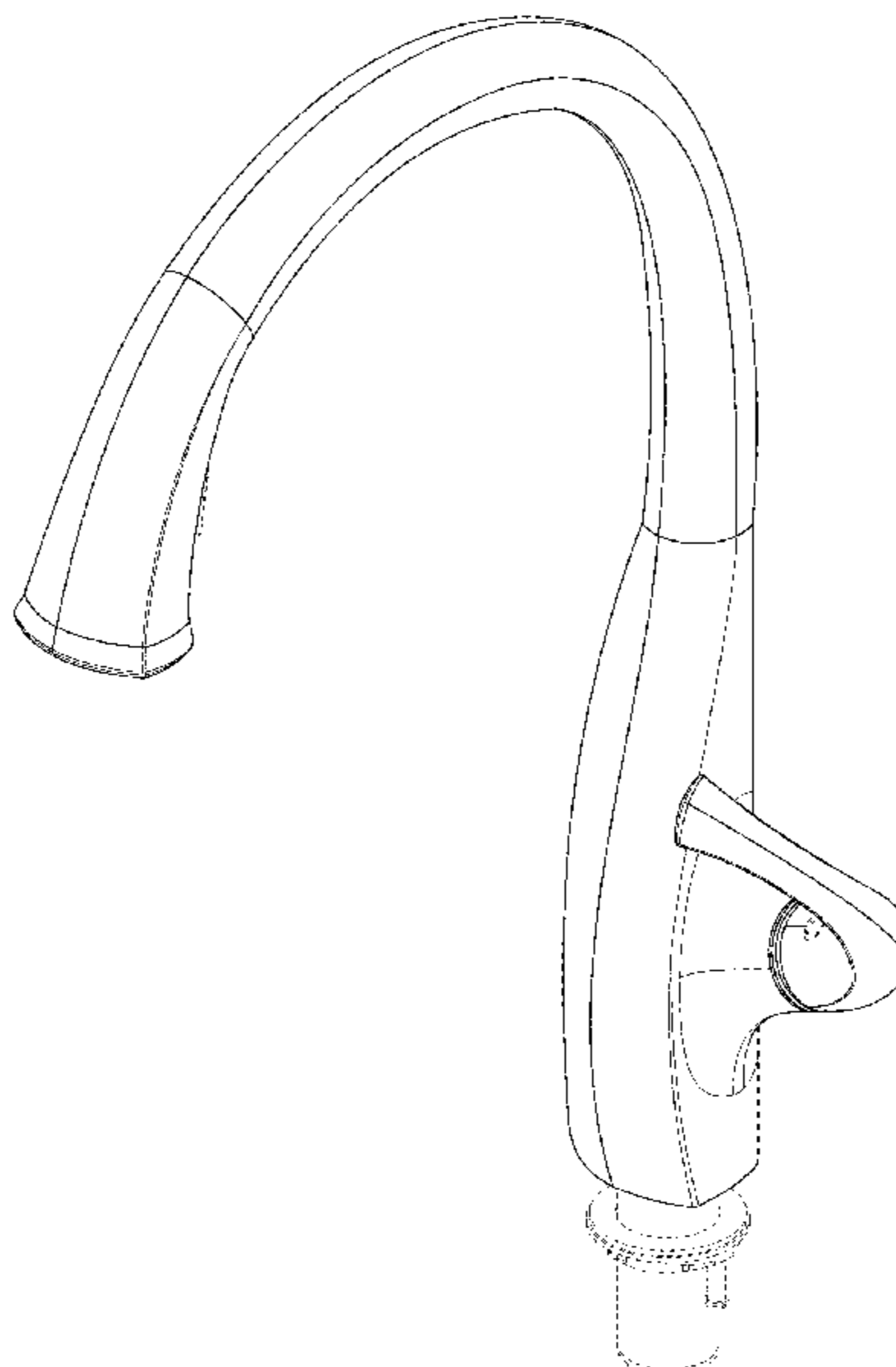
FIG. 1 is a front perspective view of a faucet in accordance with the present design;

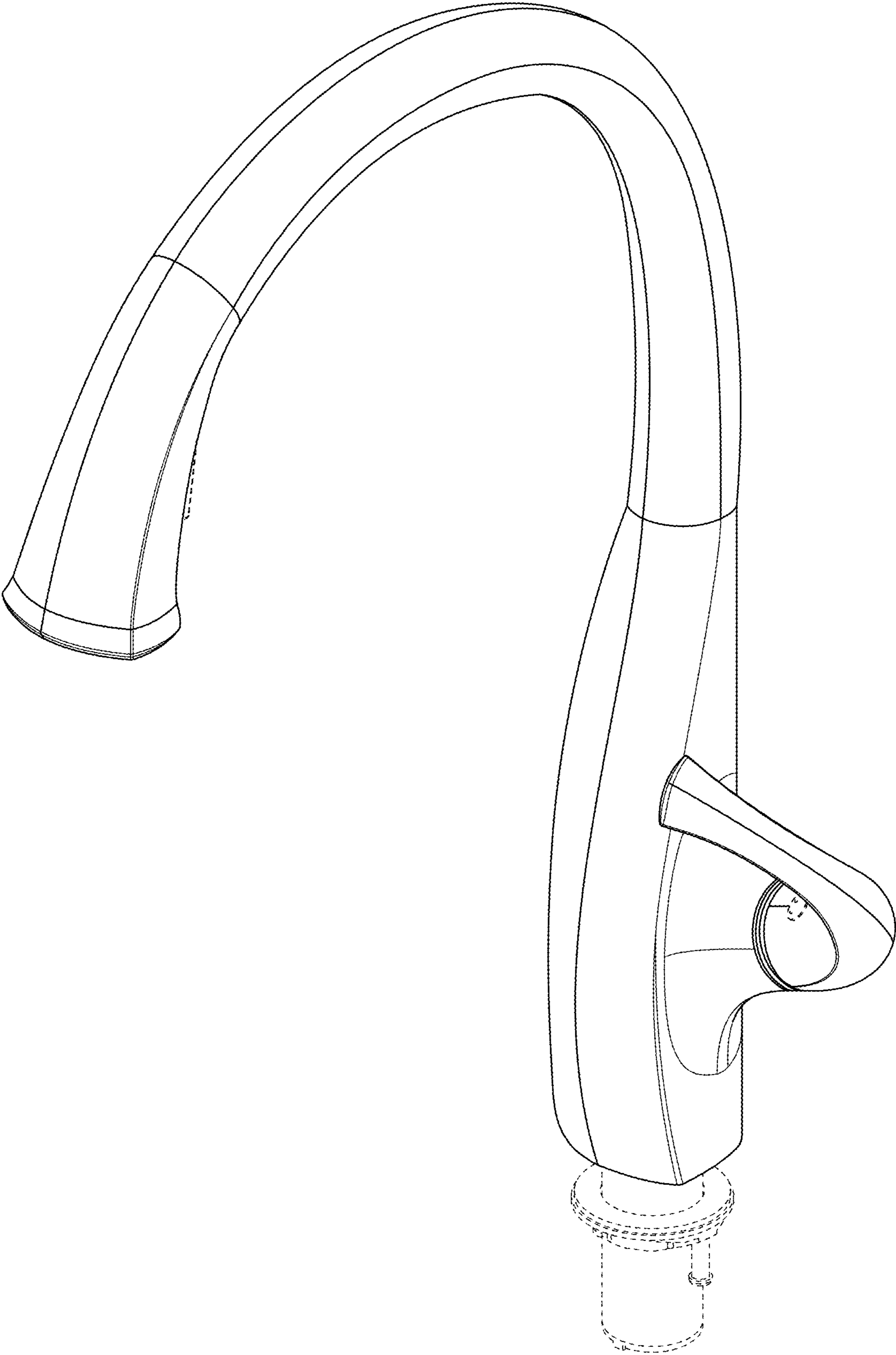

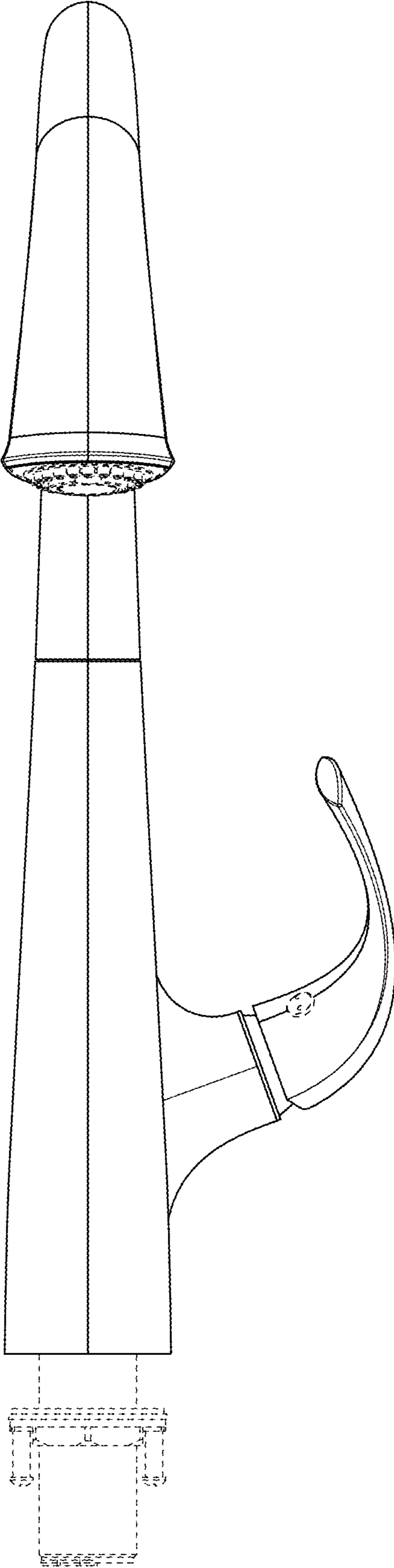

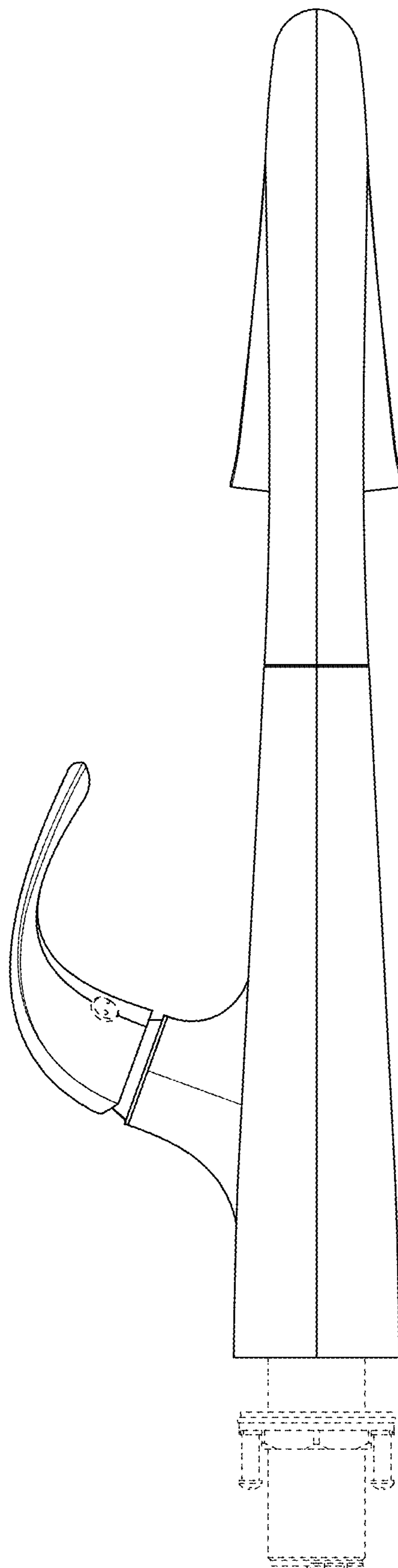

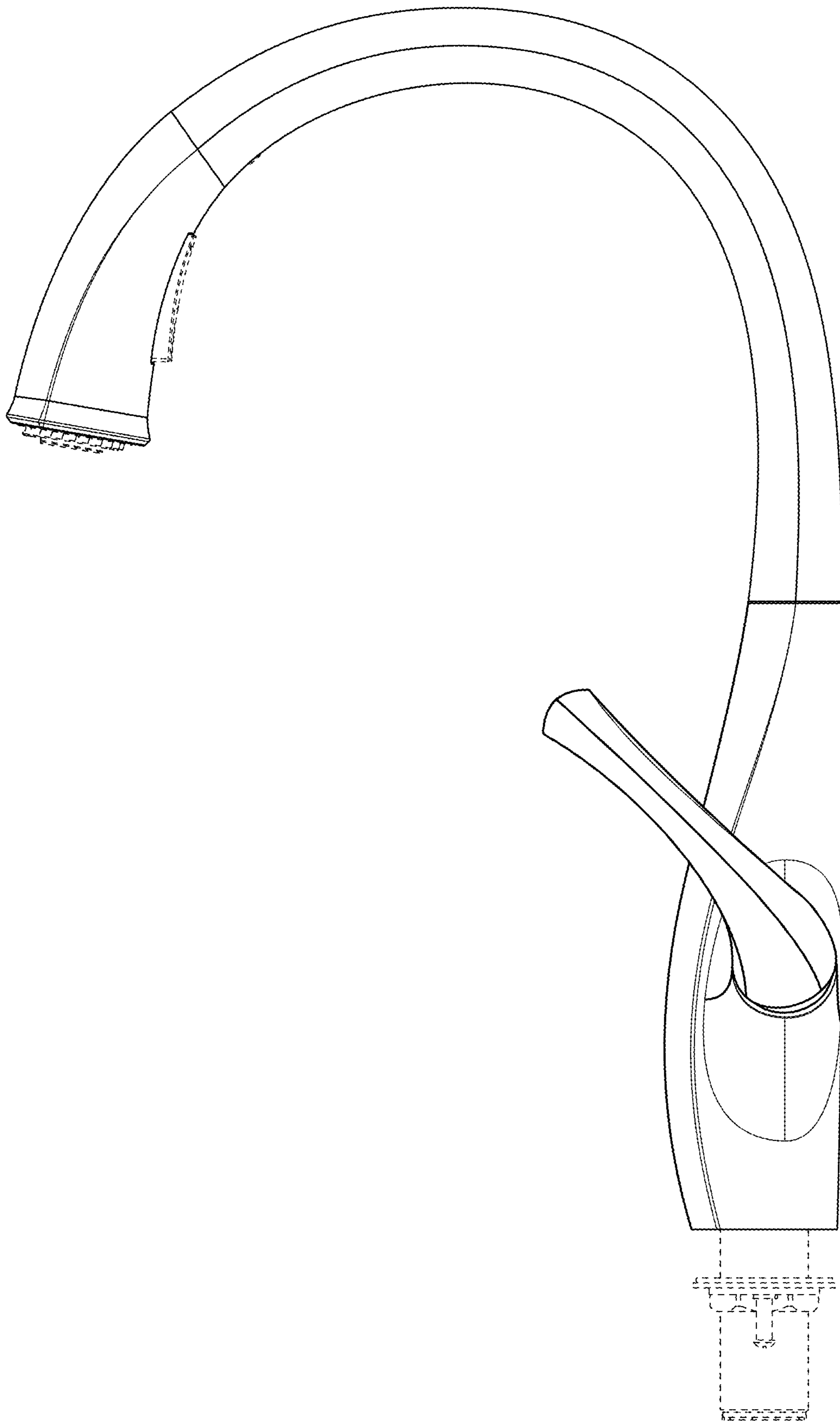

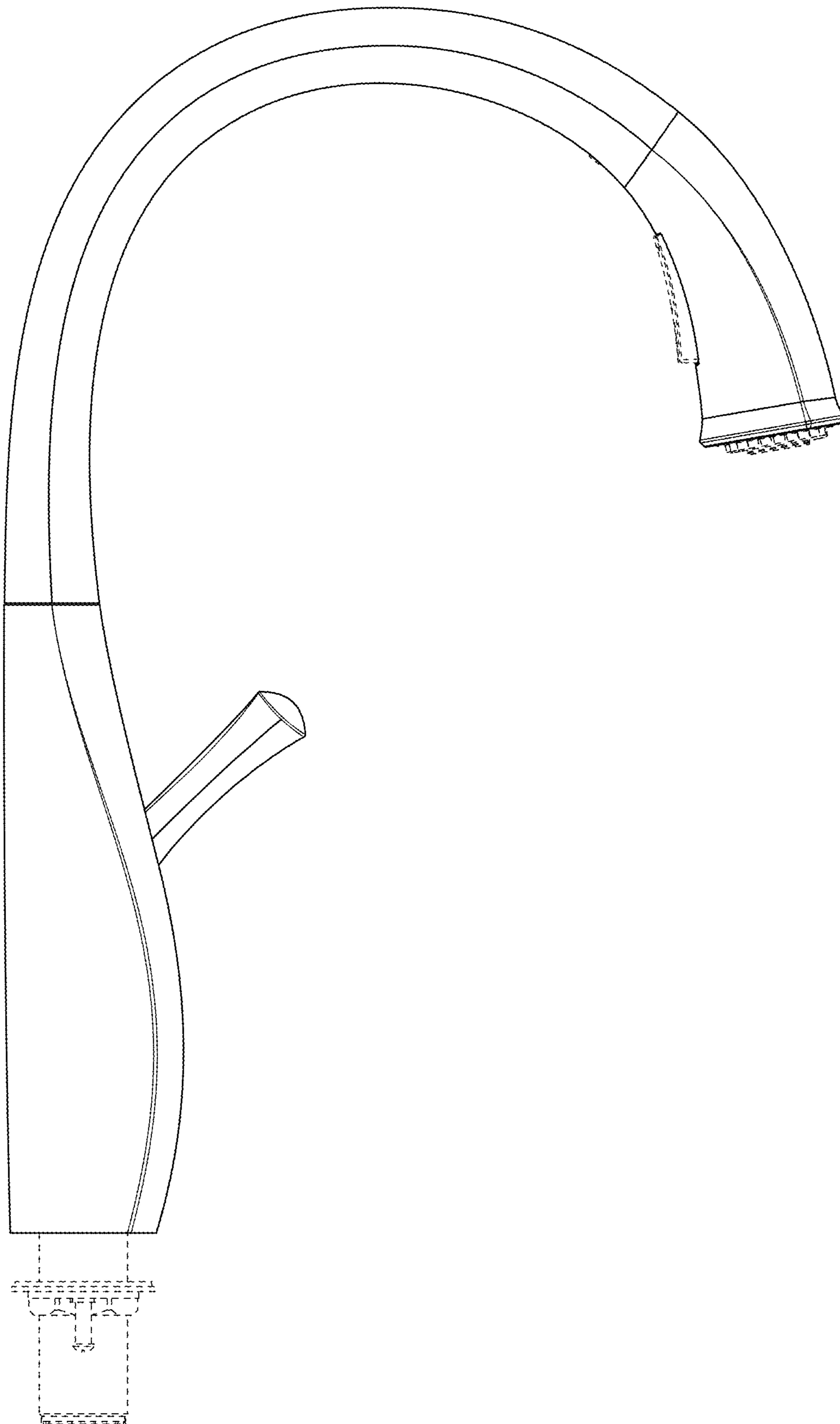

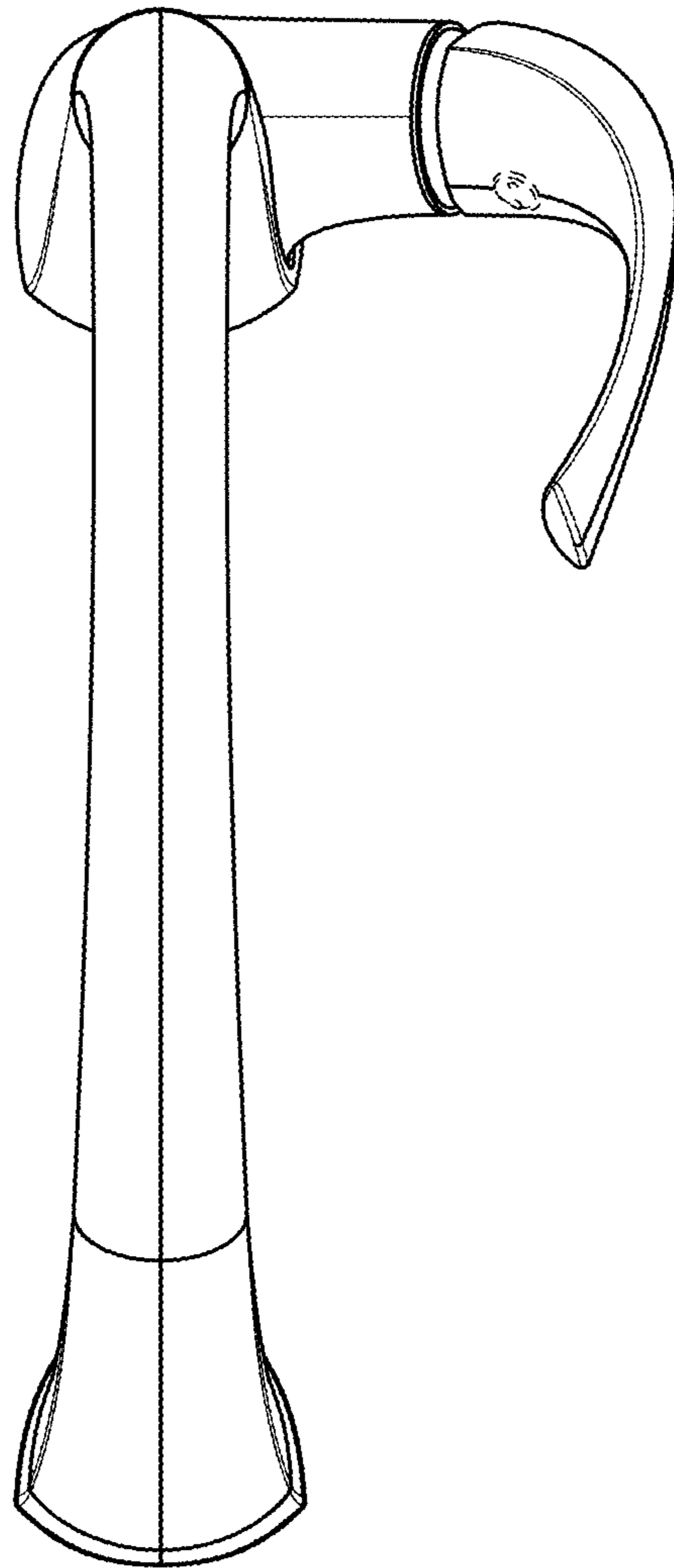

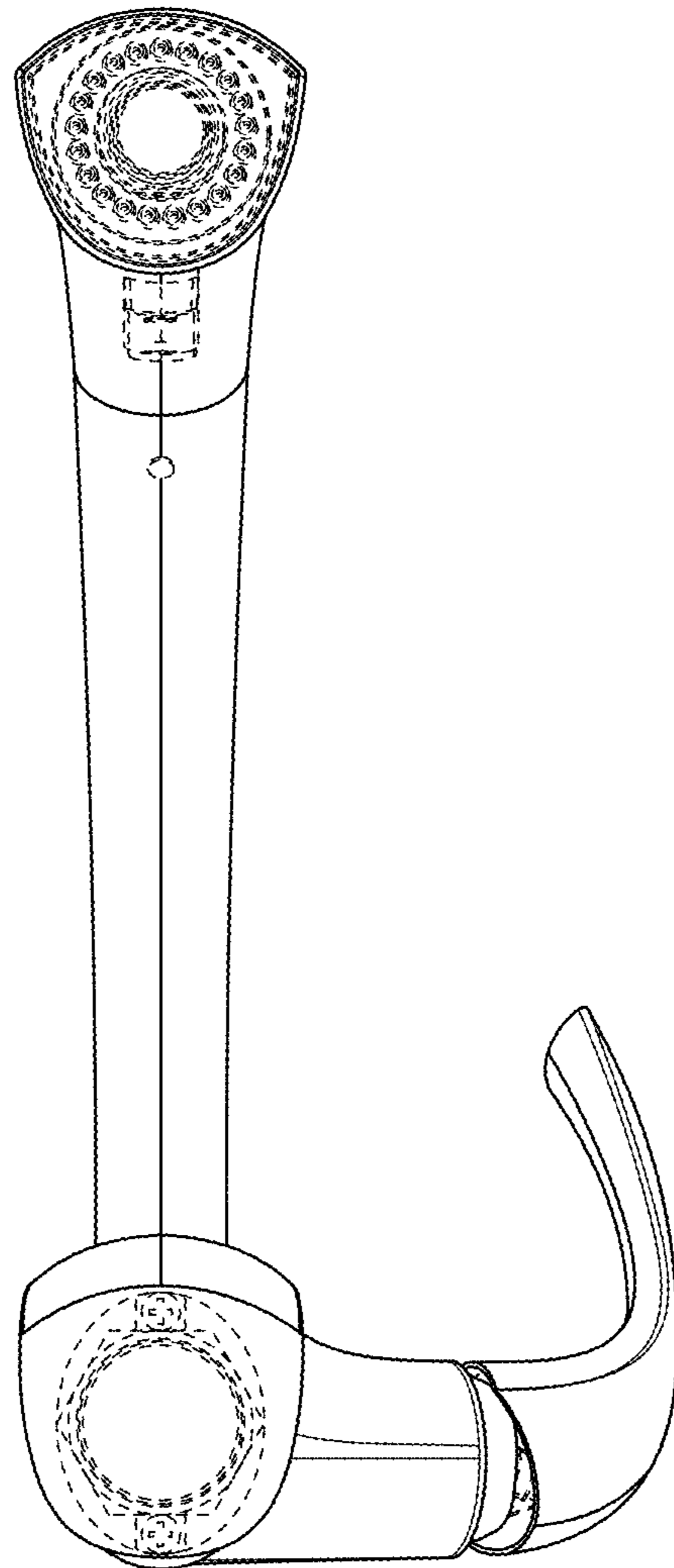

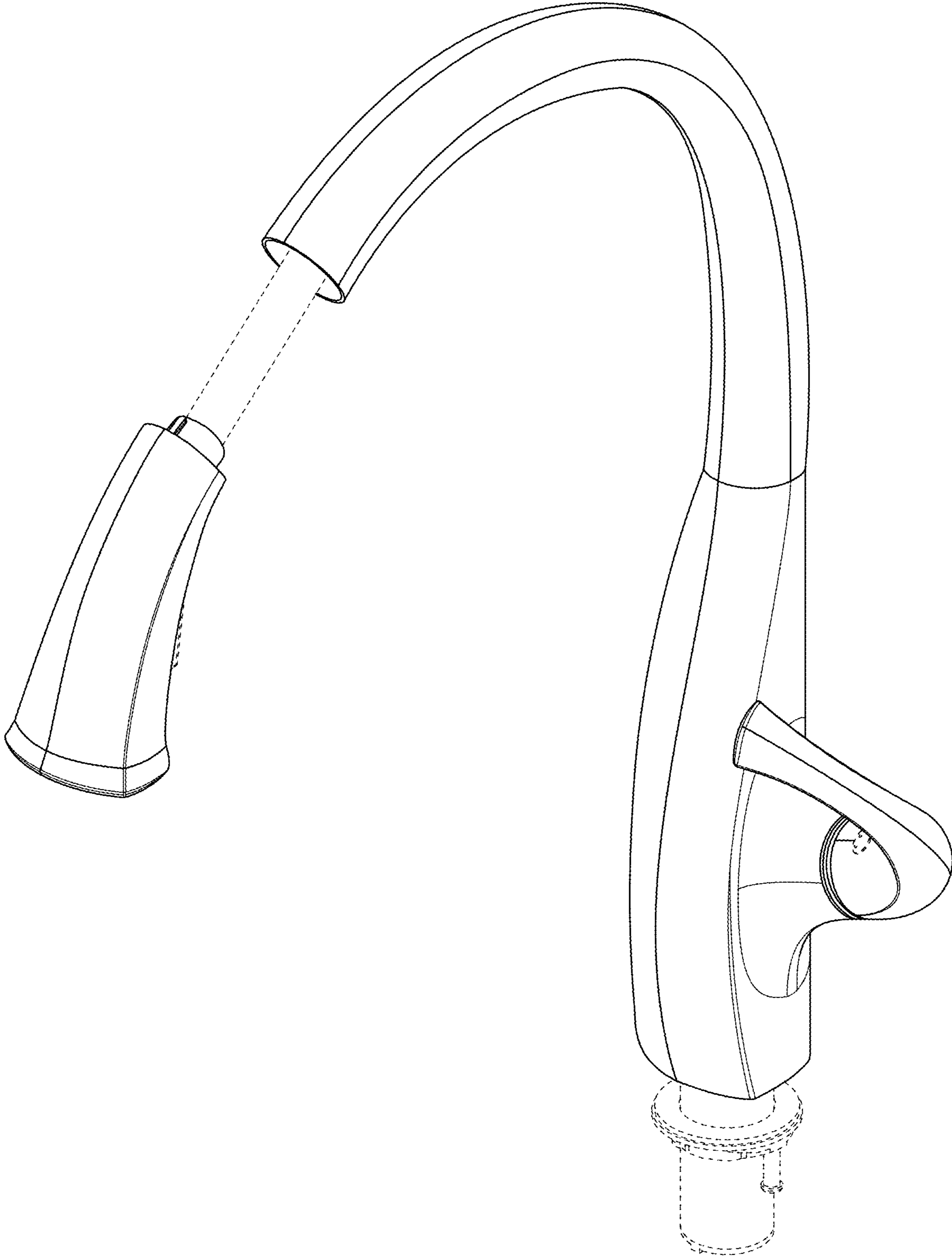
