DESCRIPTION

FIG. 7 is a top view of the fire pit boot.

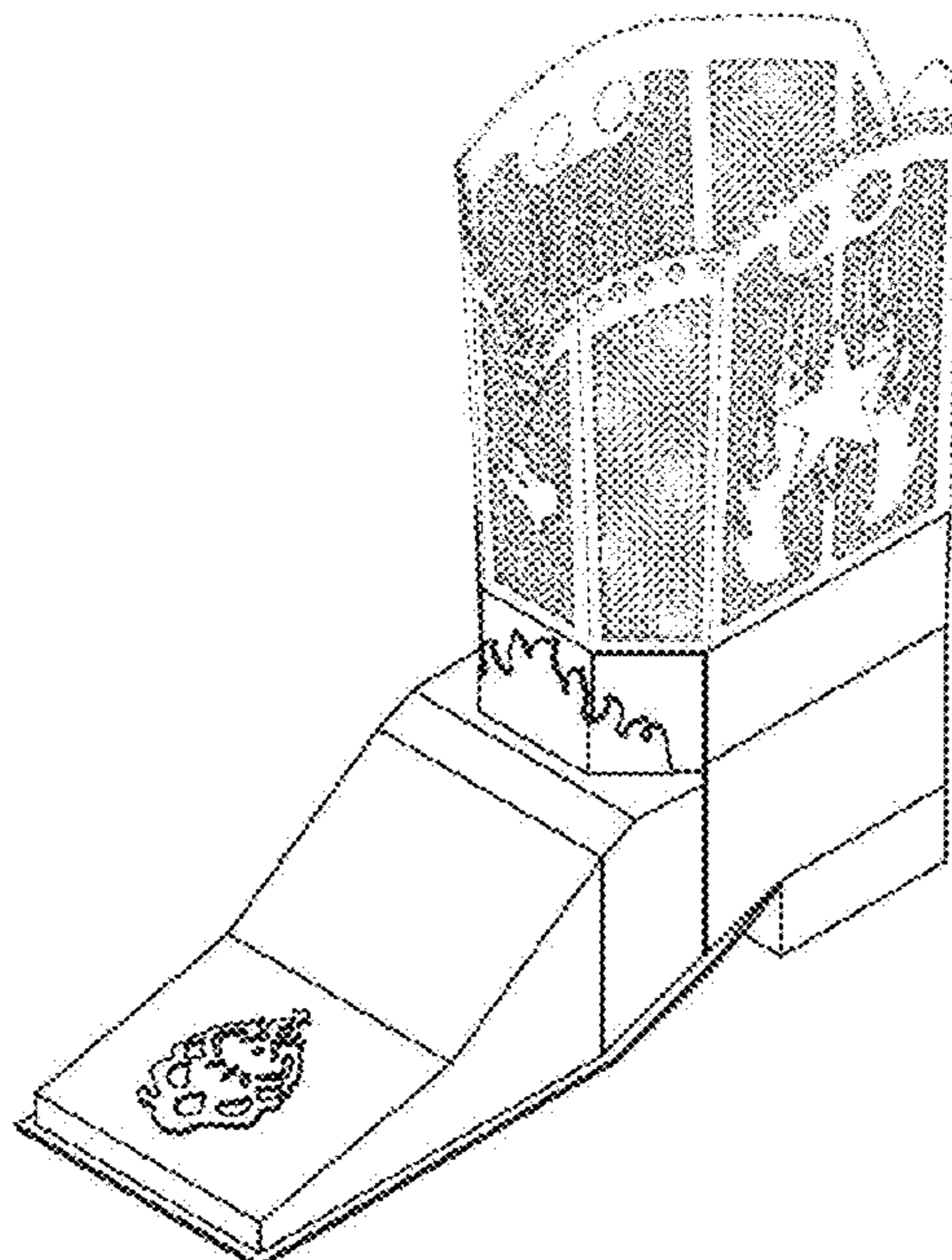
The broken lines depict portions of the fire pit boot that form no part of the claimed design.

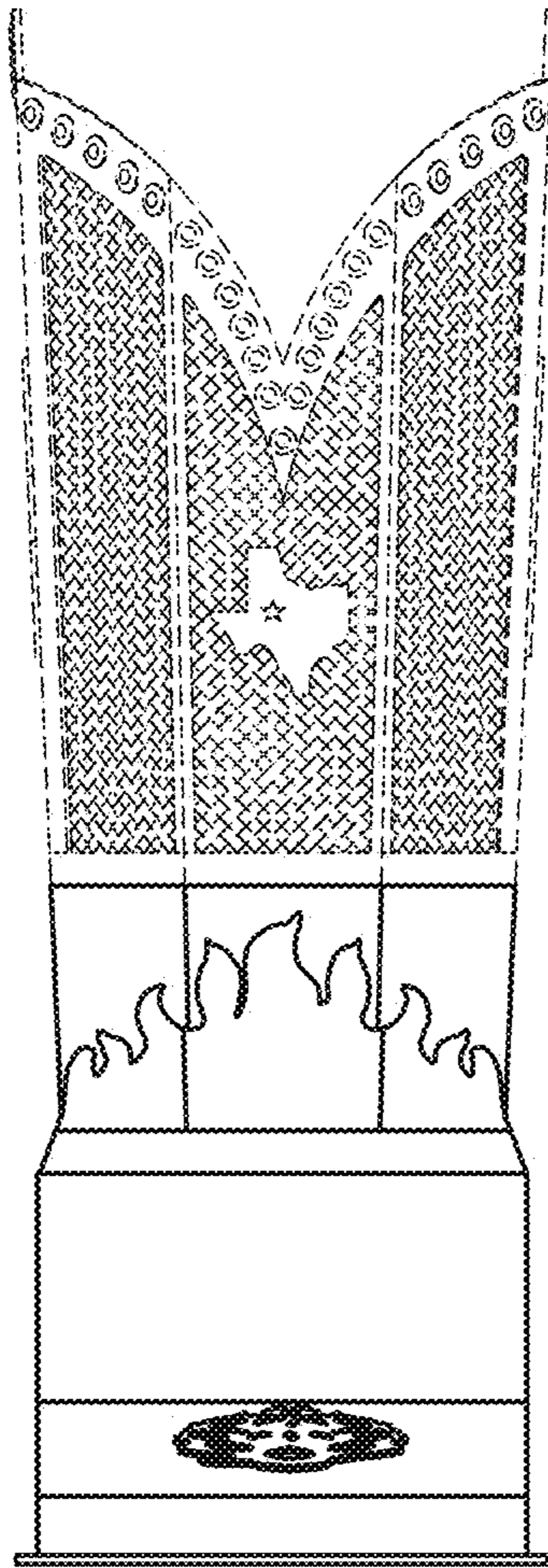

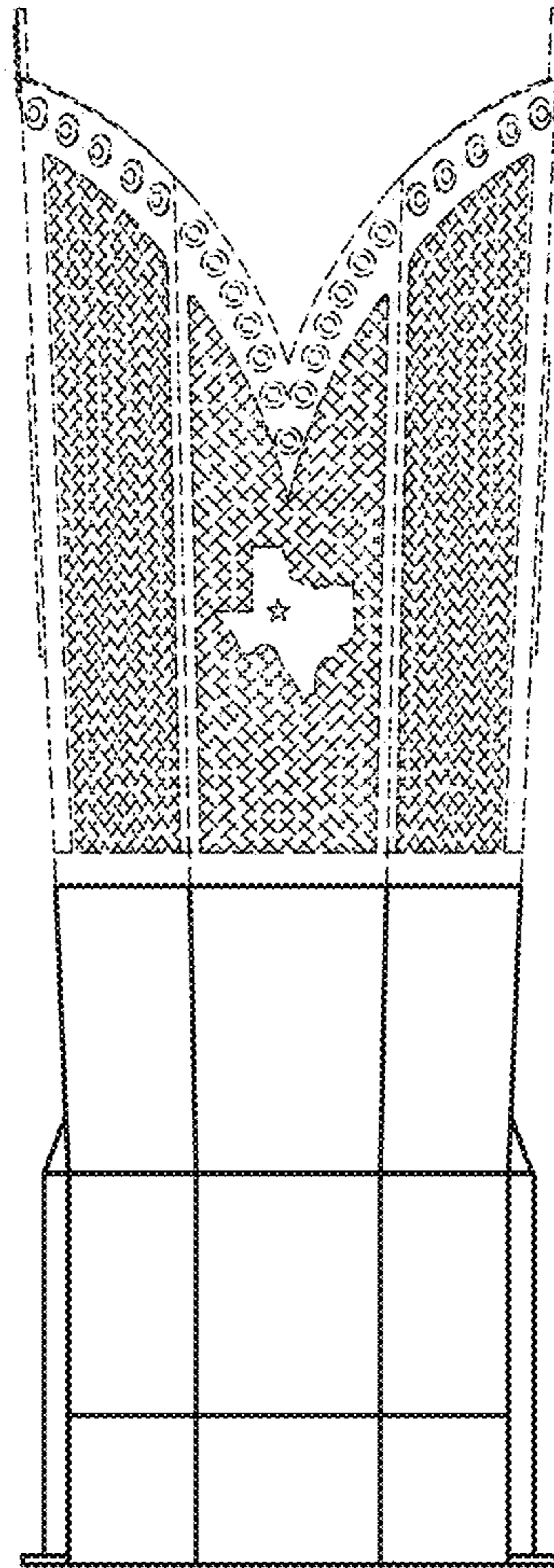

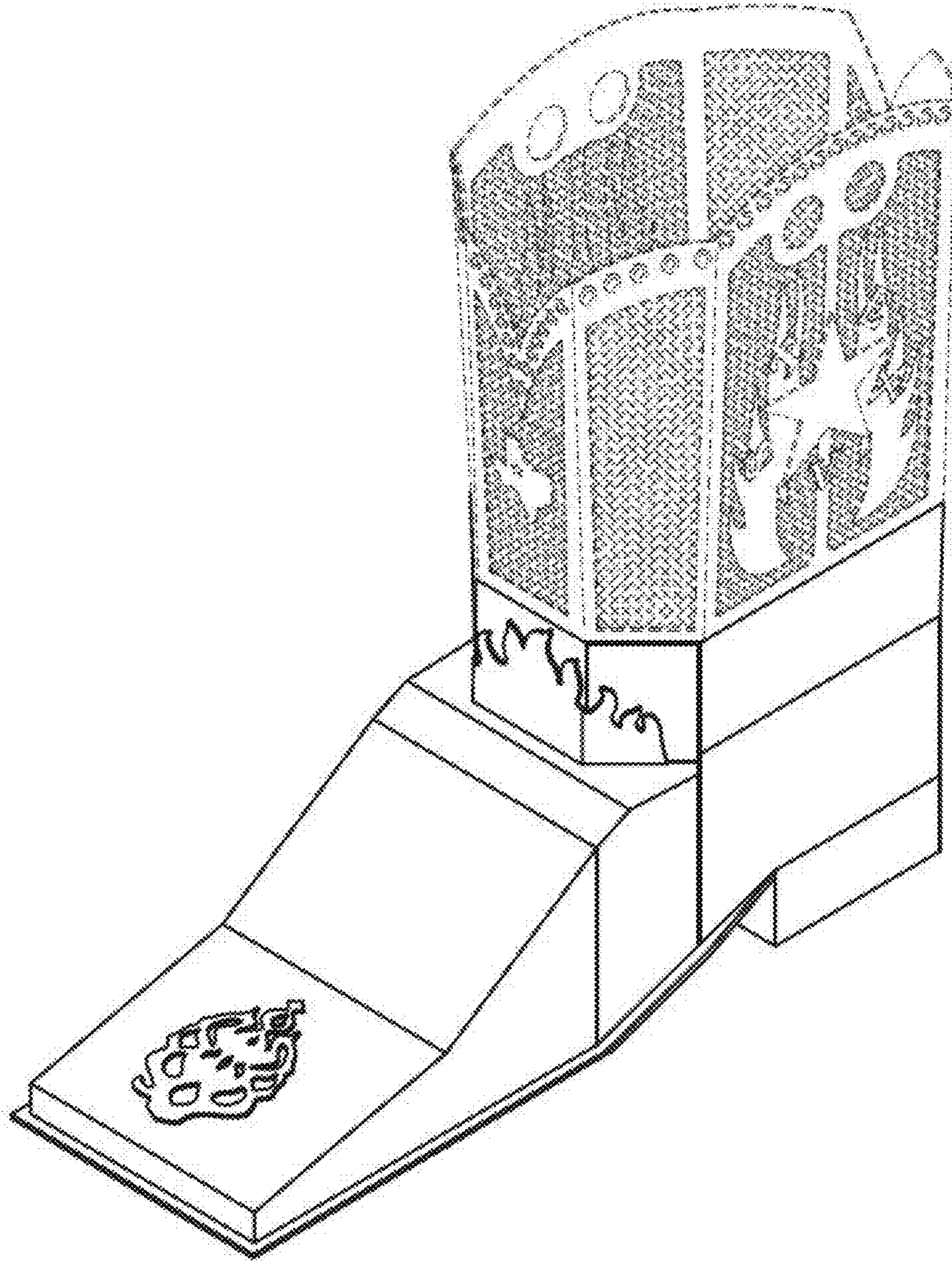

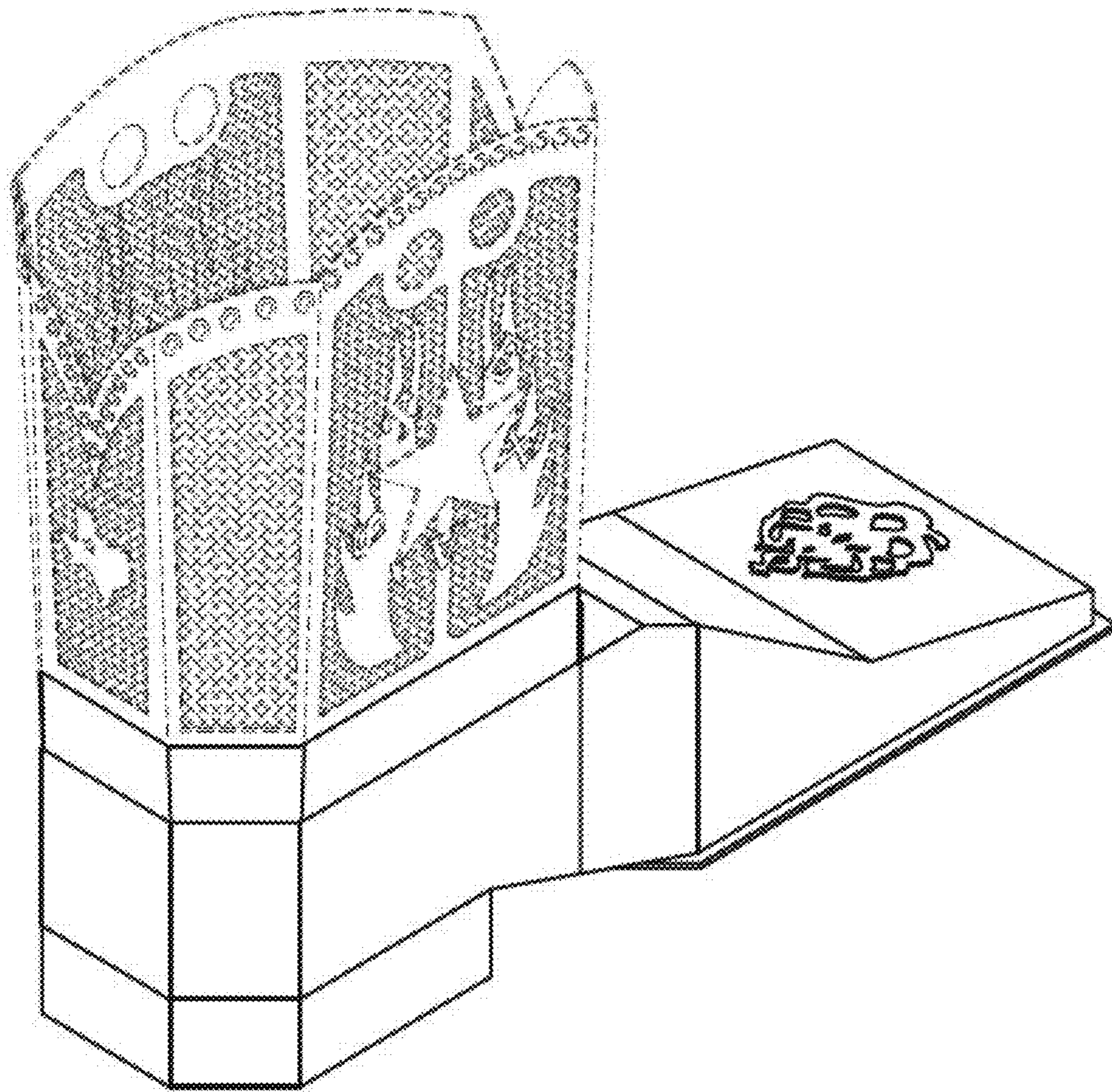

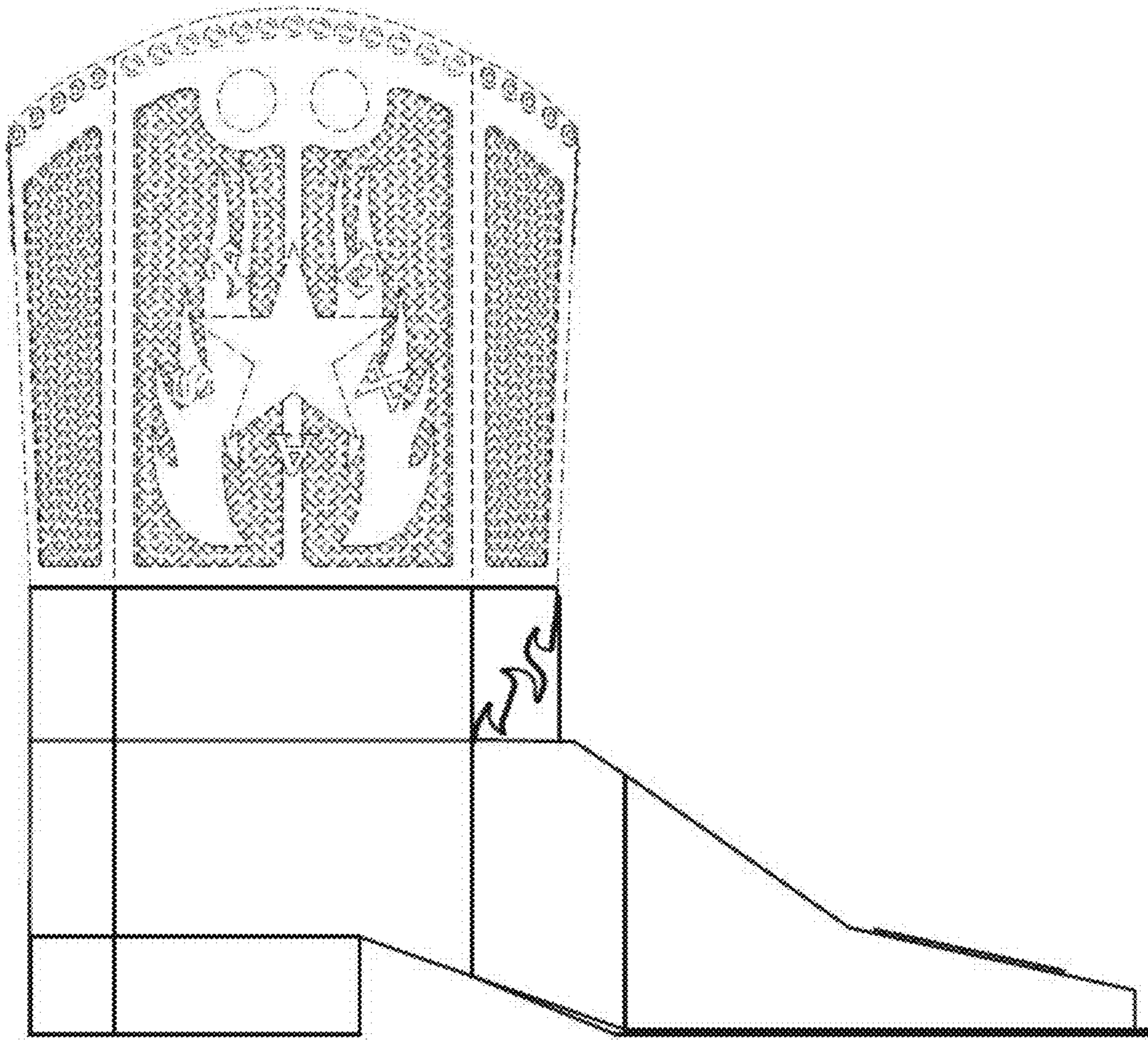

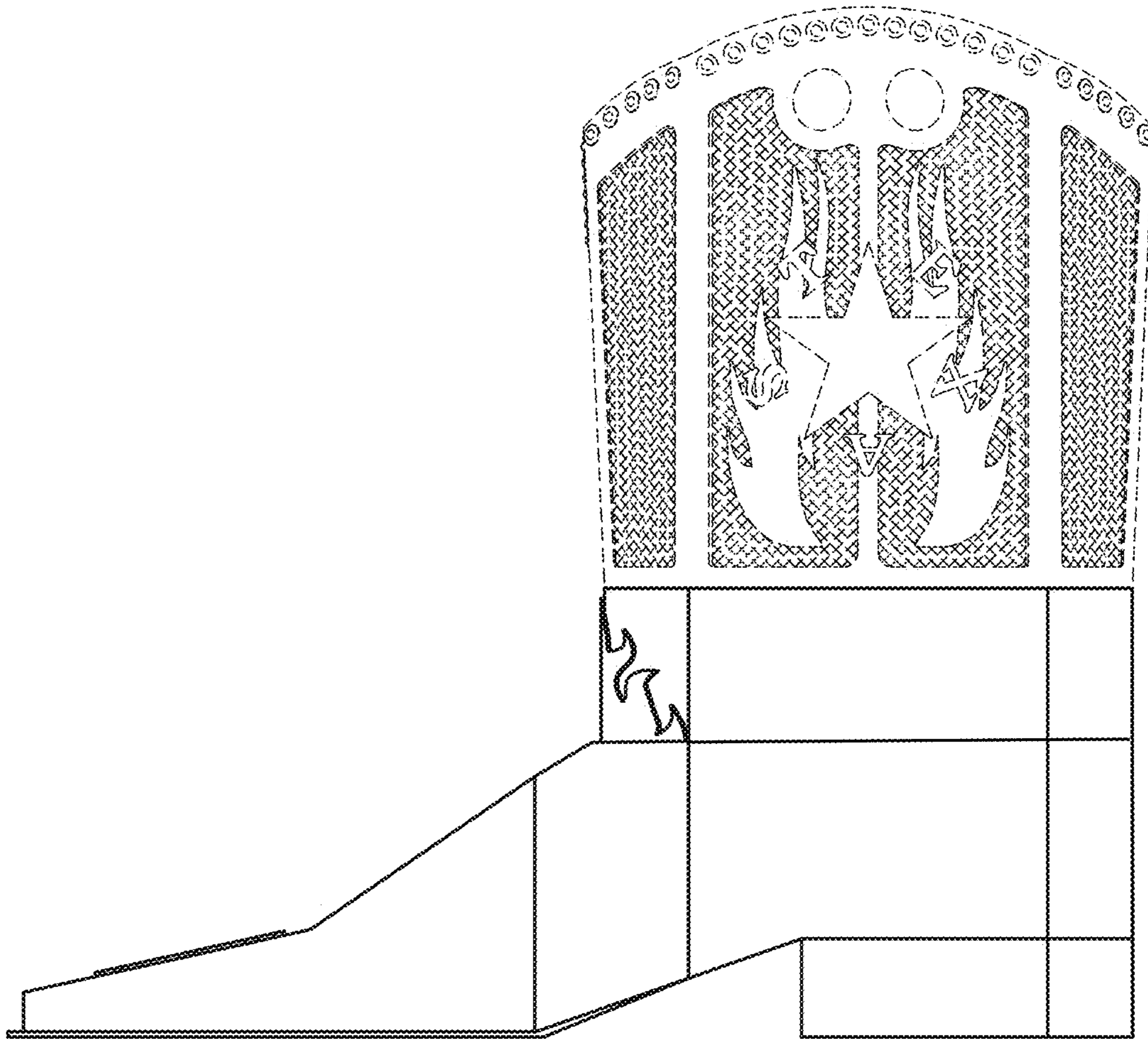

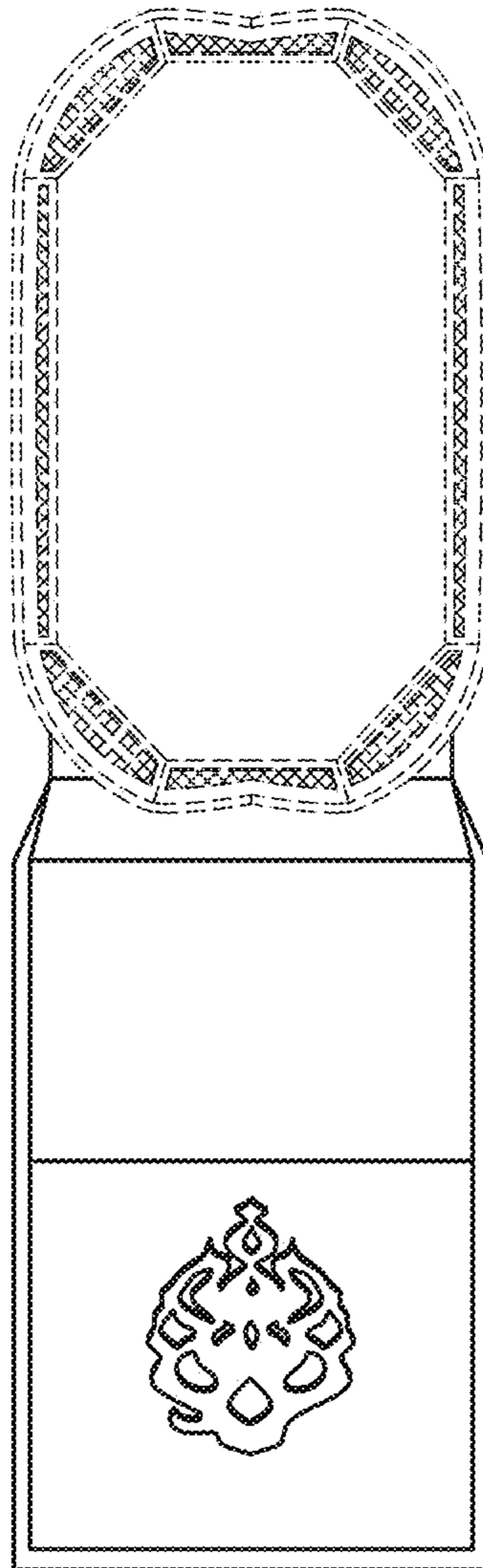
